(57) **CLAIM**

I claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 8 is a cross-sectional view thereof taken along line "8-8" of FIG. 3.

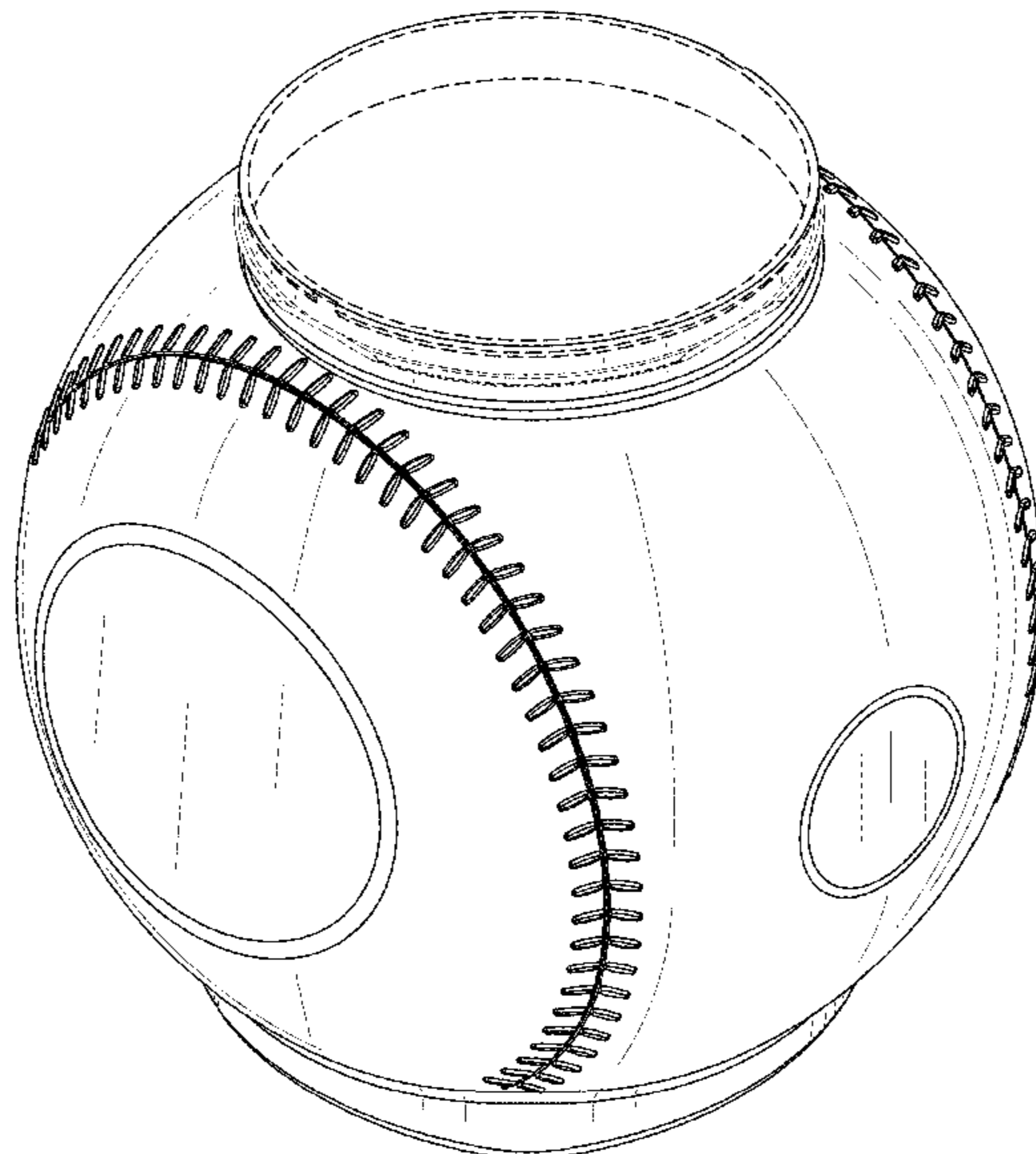
In these drawings, the solid lines illustrate the claimed ornamental design, whereas the broken lines illustrate portions of the container that form no part of the claimed design.

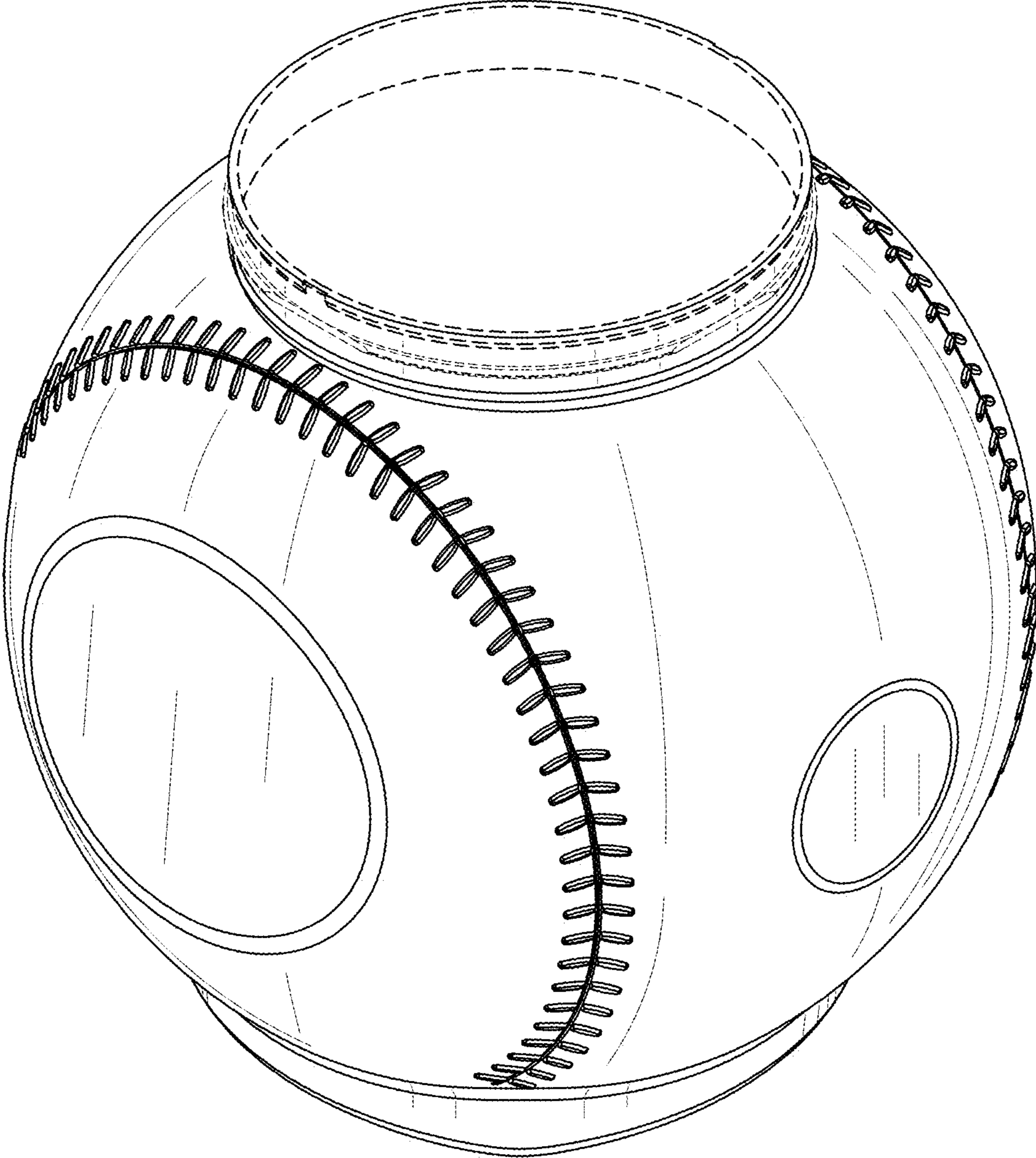

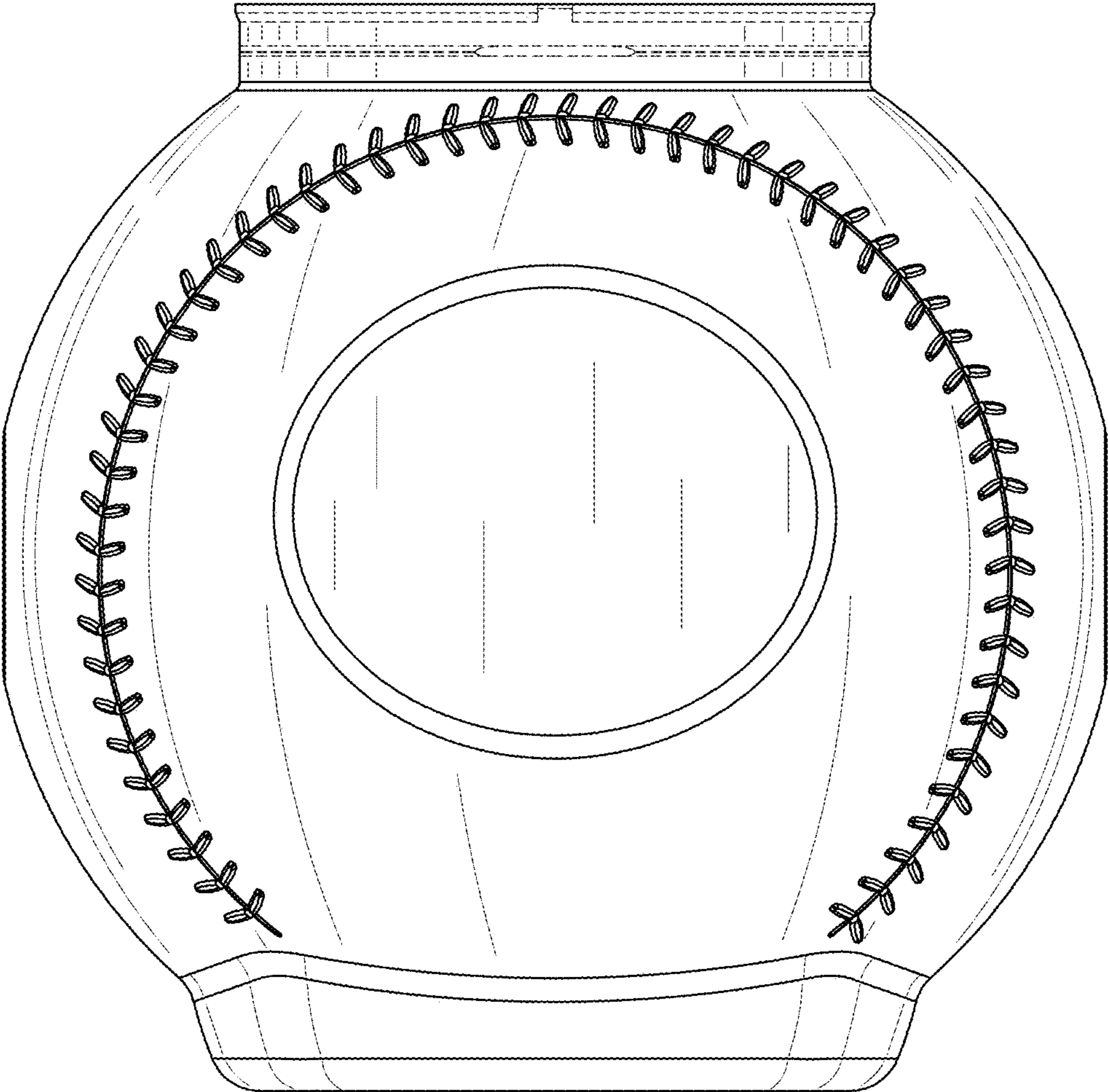

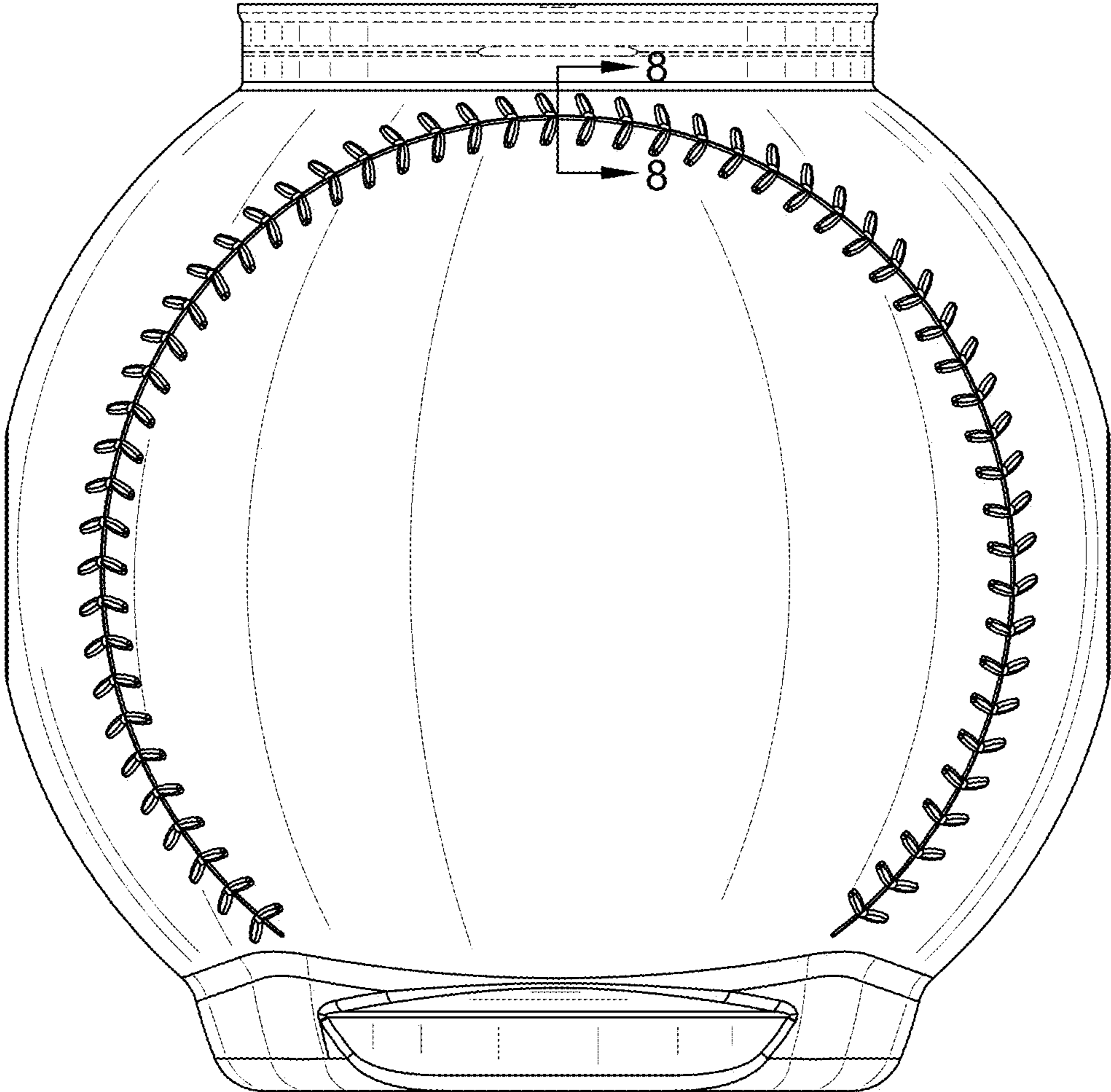

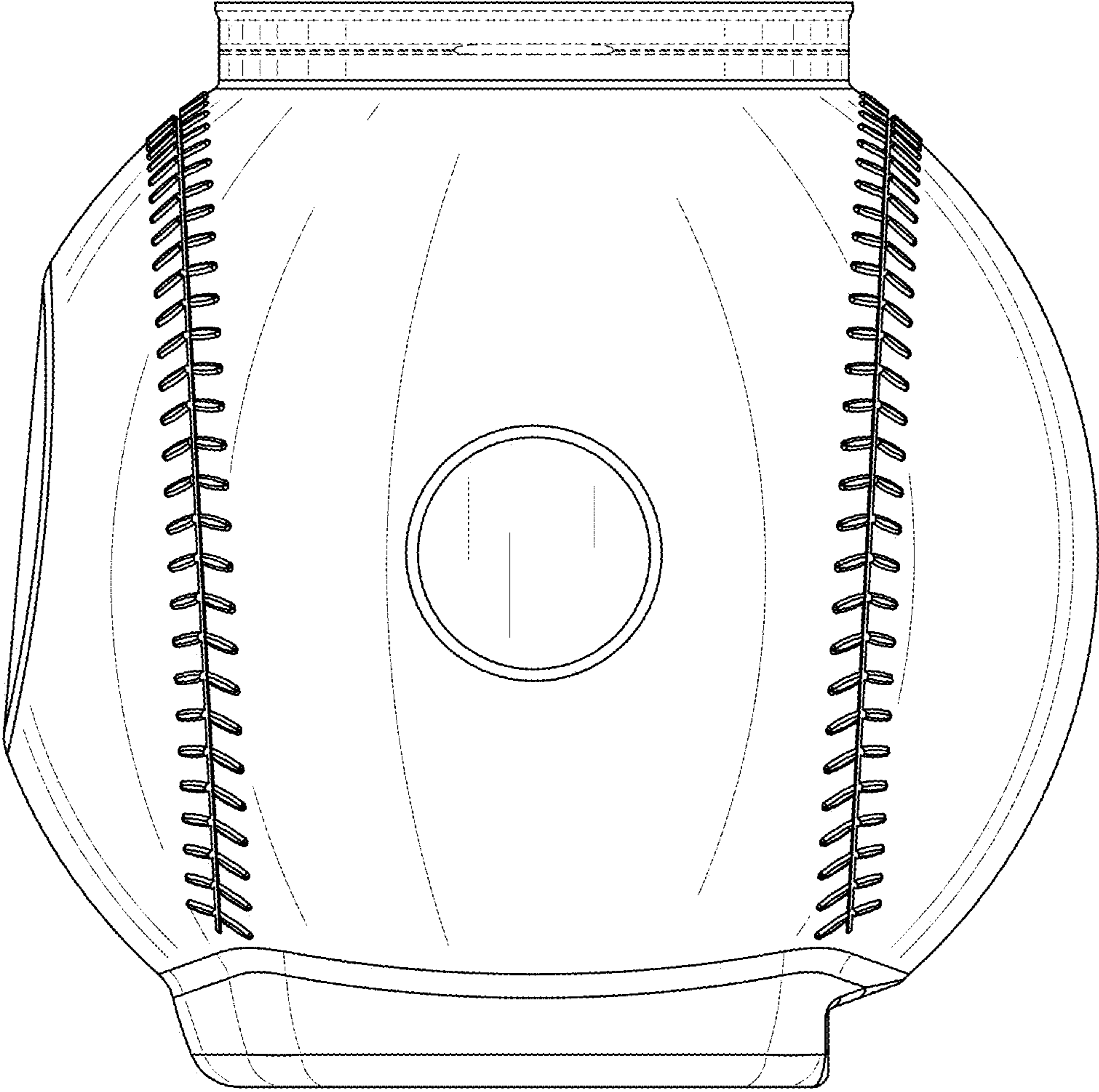

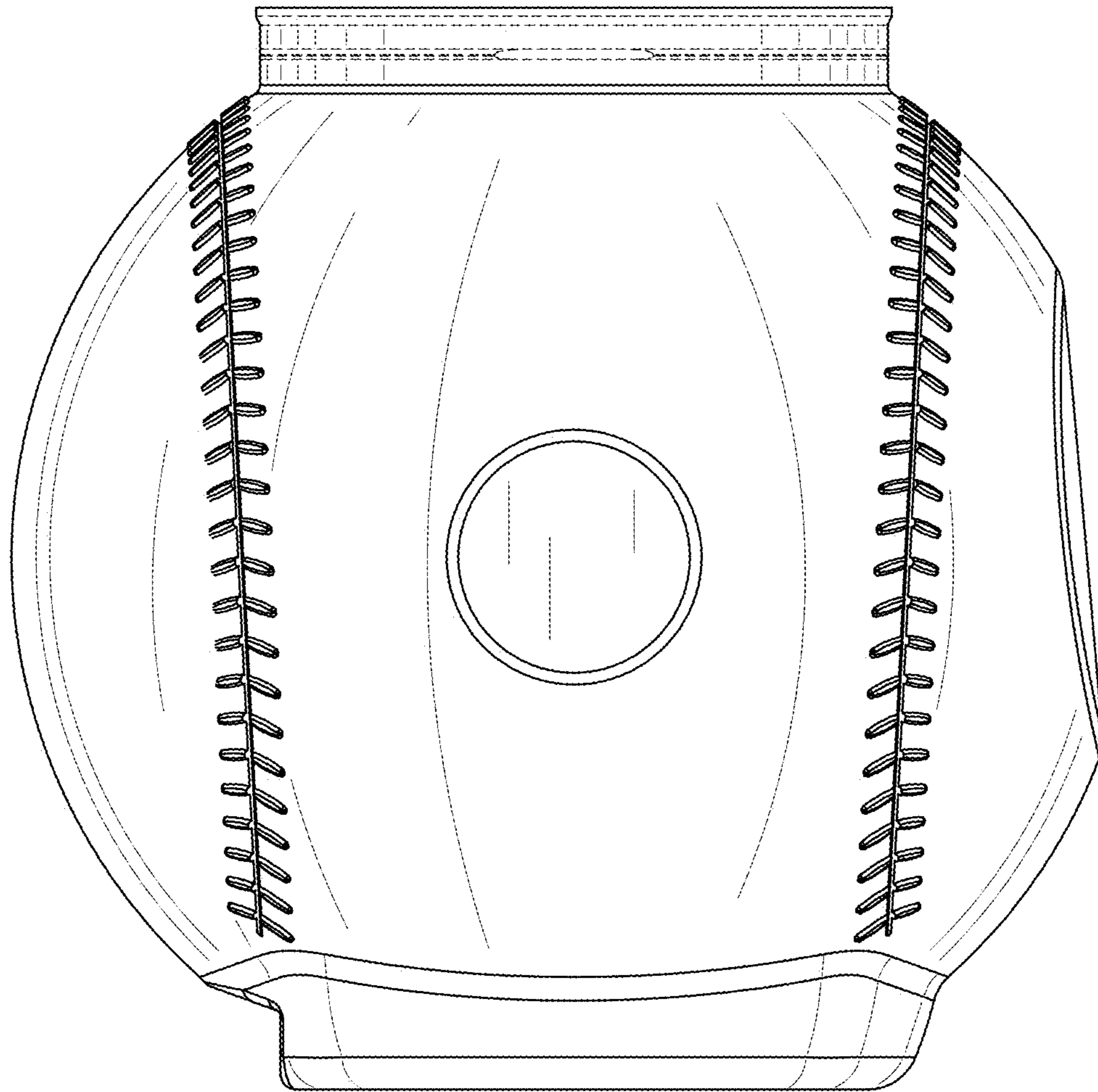

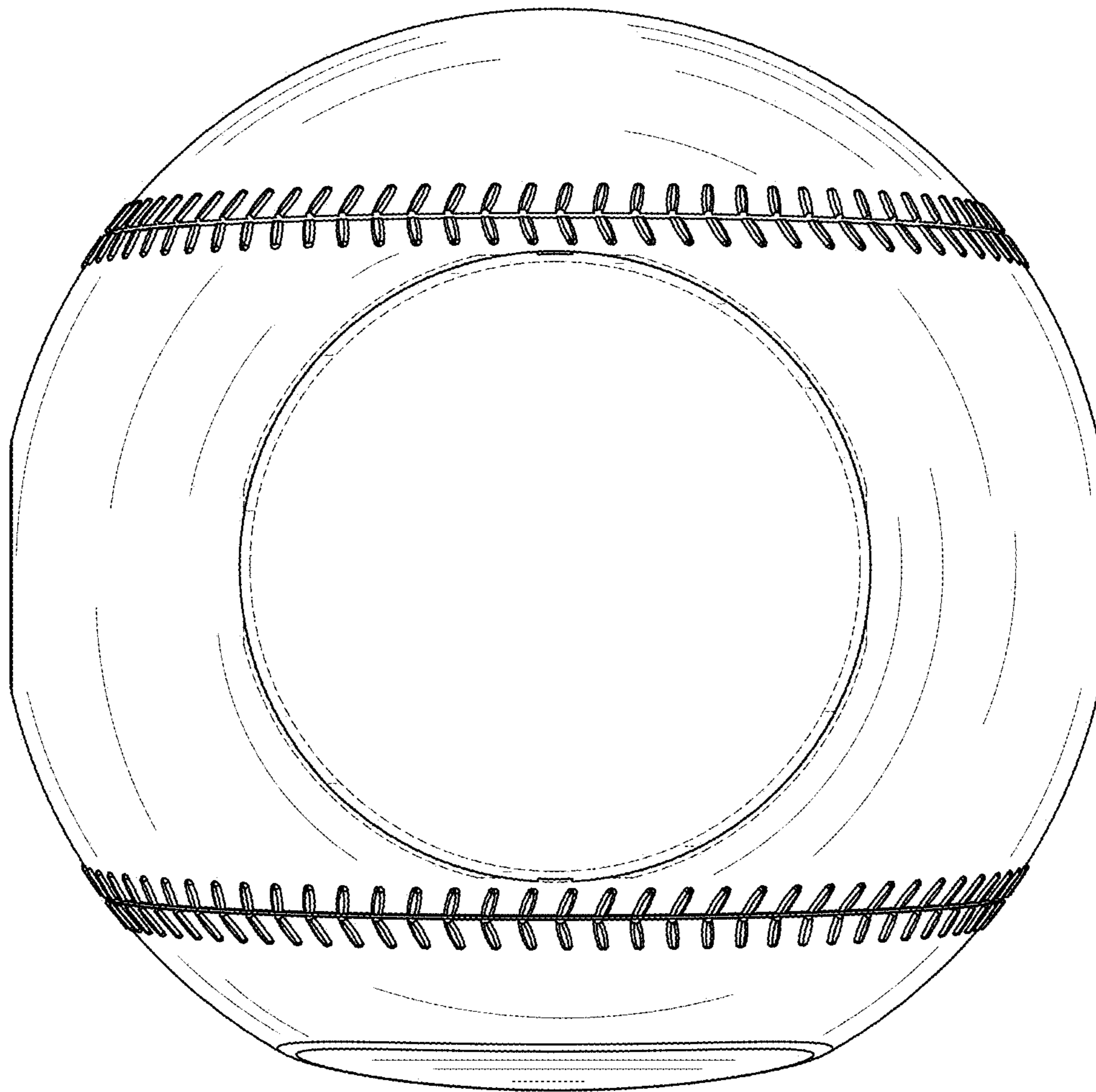

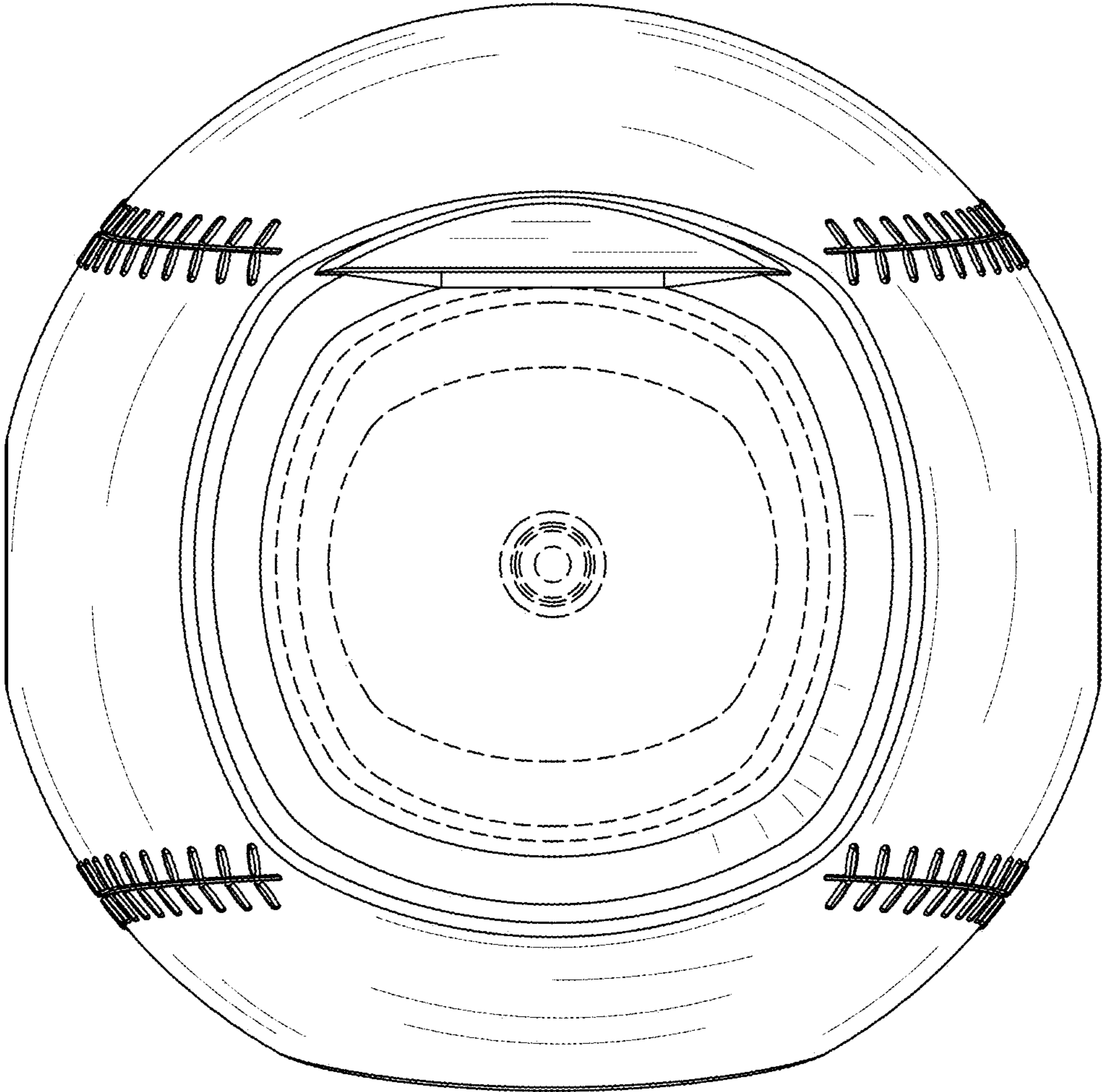

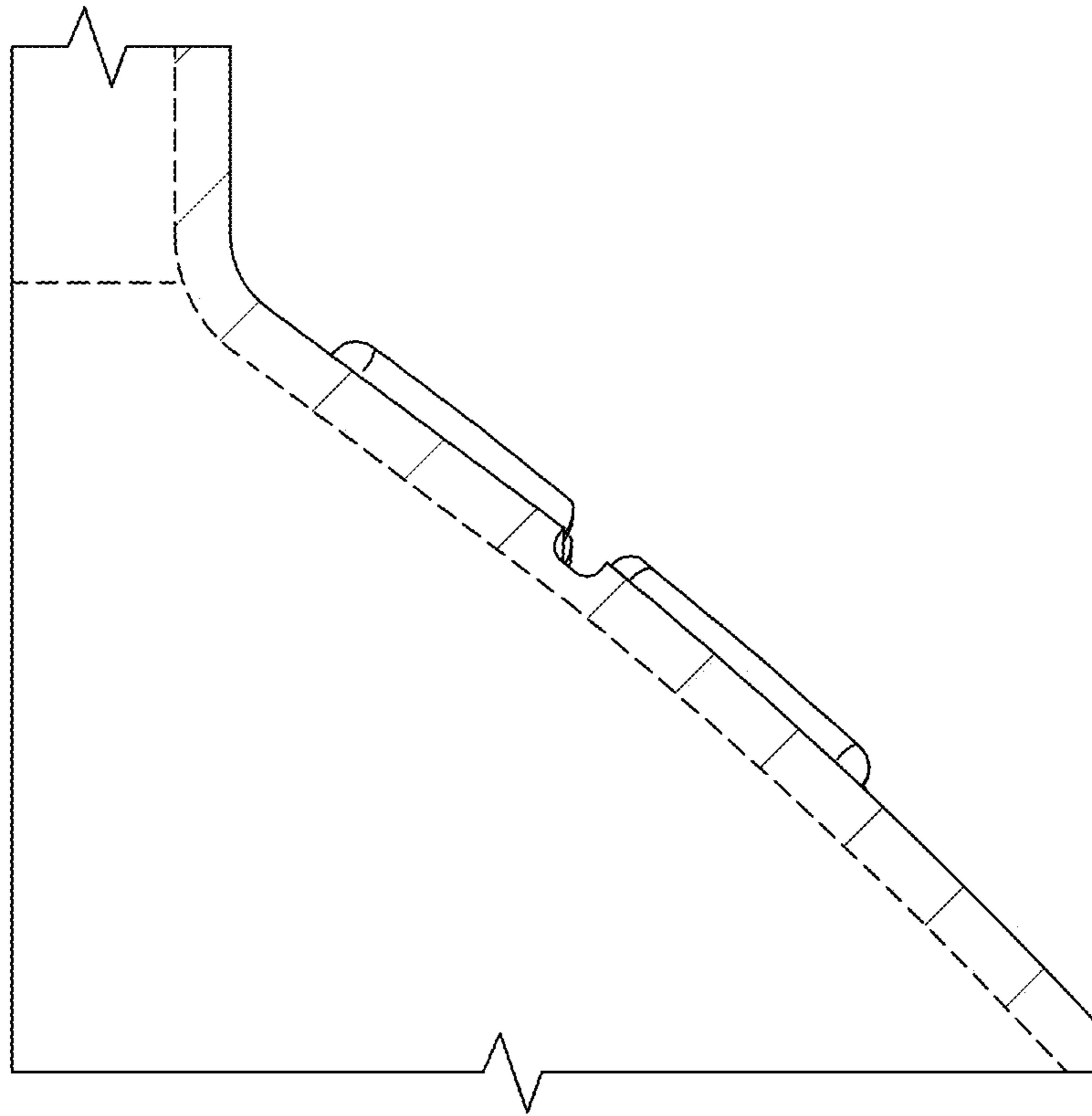
