**DESCRIPTION**

1. Buckle

FIG. 1.1 is a perspective view of a buckle according to our new design.

FIG. 1.2 is a front view thereof.

FIG. 1.3 is a rear view thereof.

FIG. 1.4 is a left side view thereof.


FIG. 1.5 is a right side view thereof.












