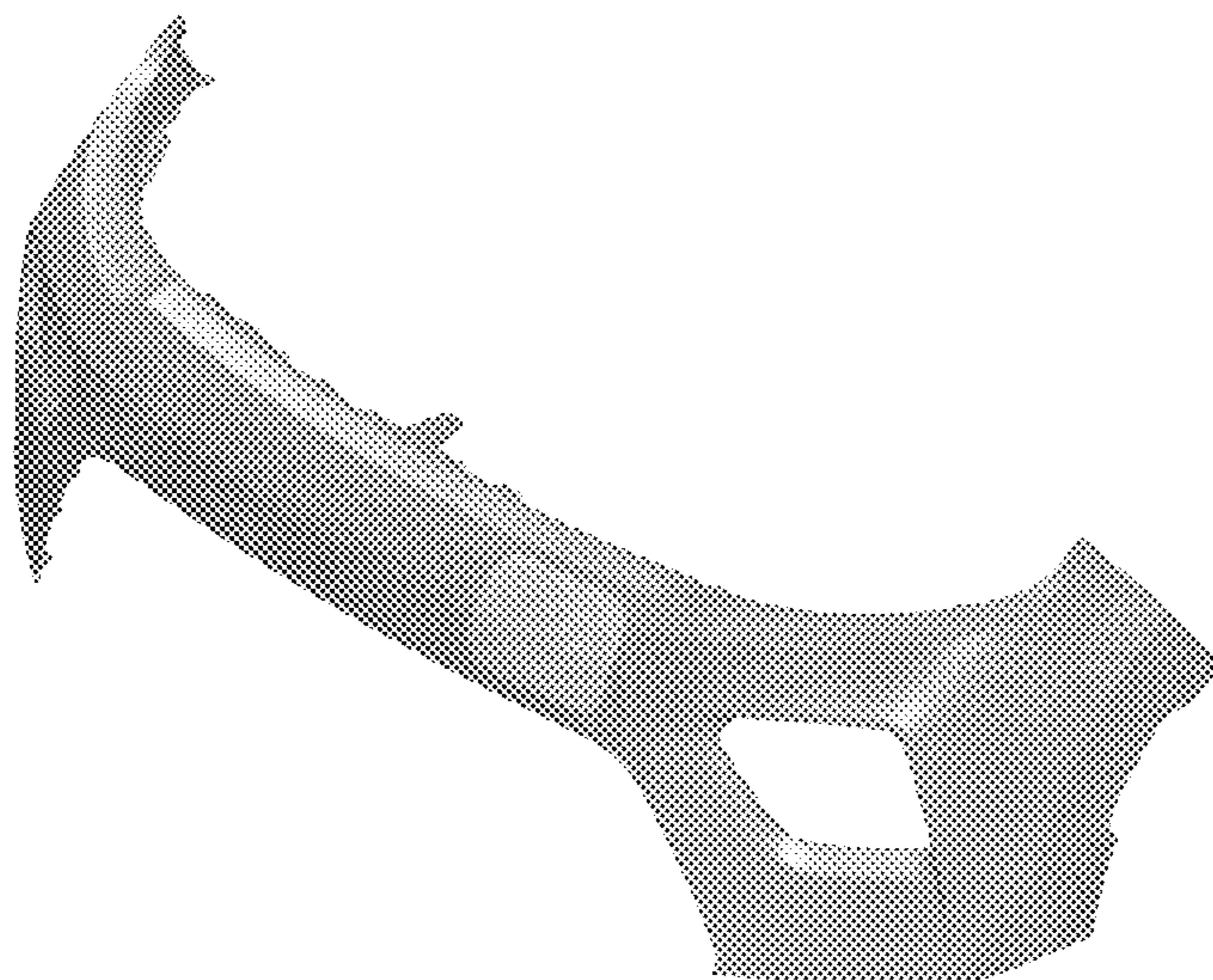

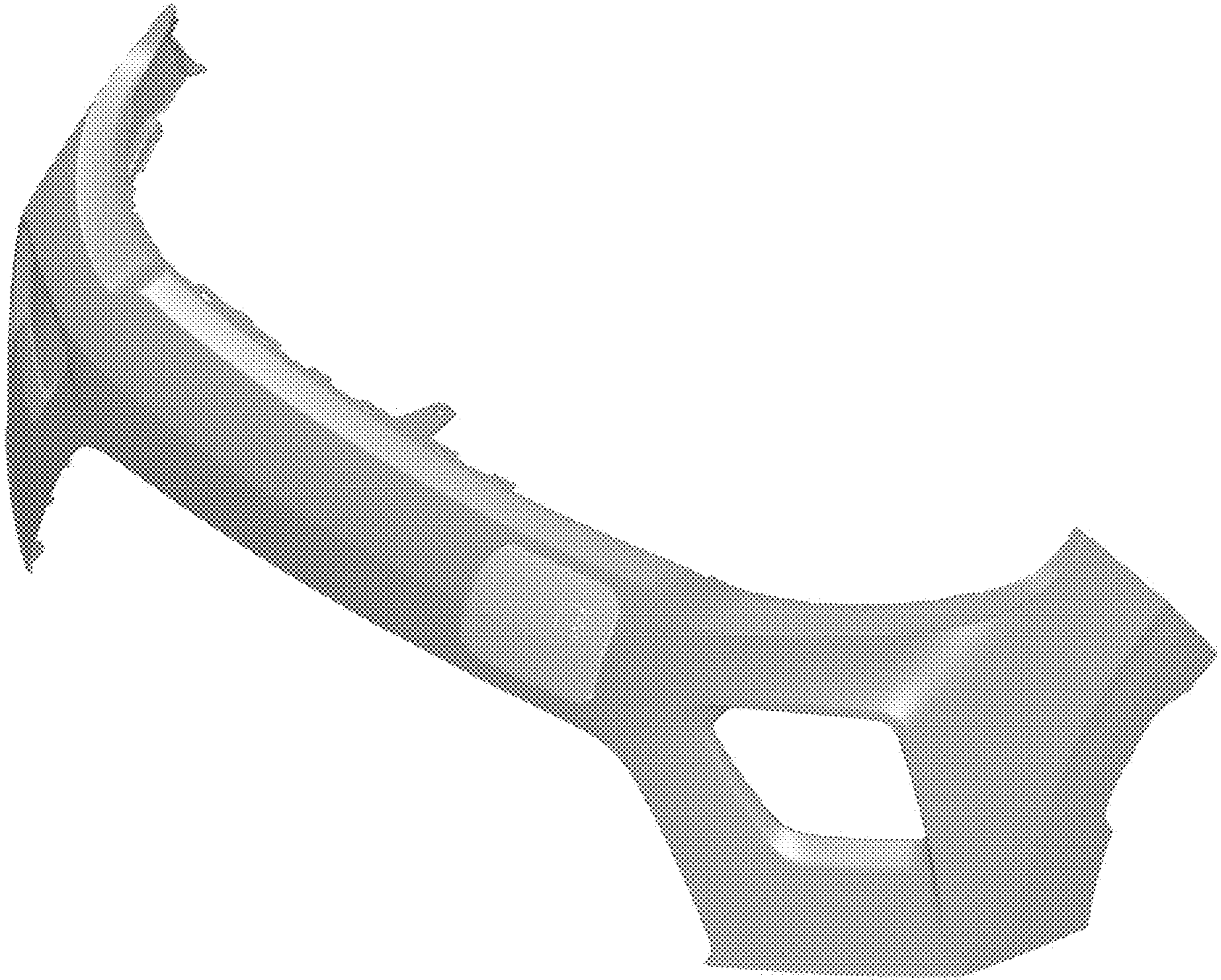
(57) **CLAIM**

1.7 is a bottom plan view thereof.

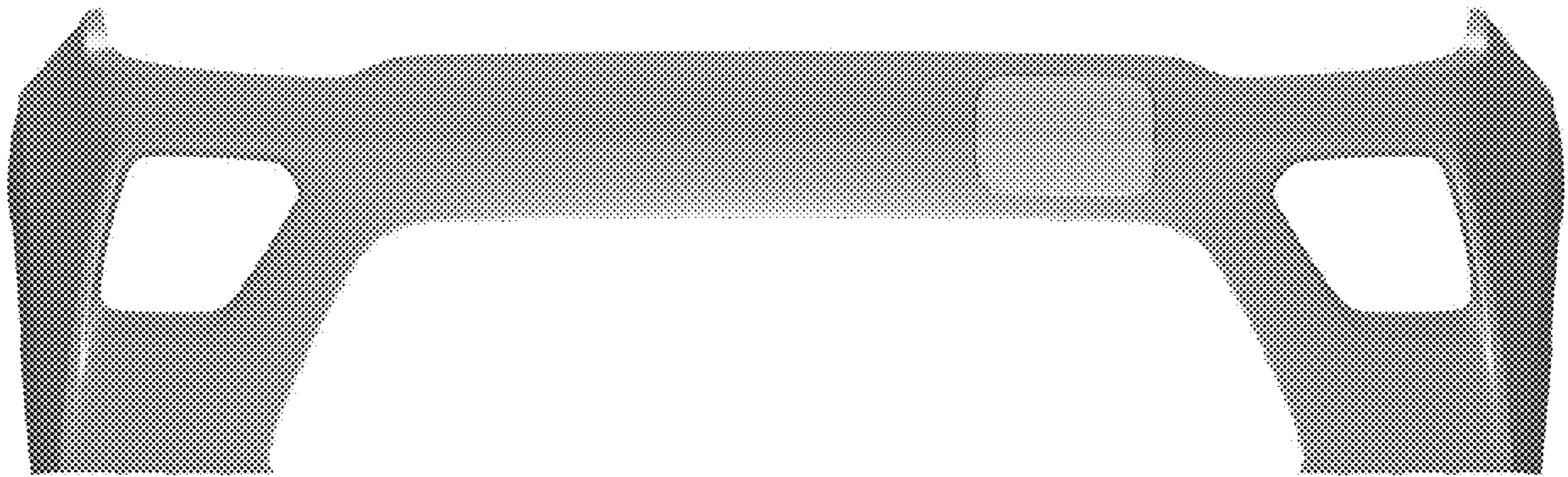

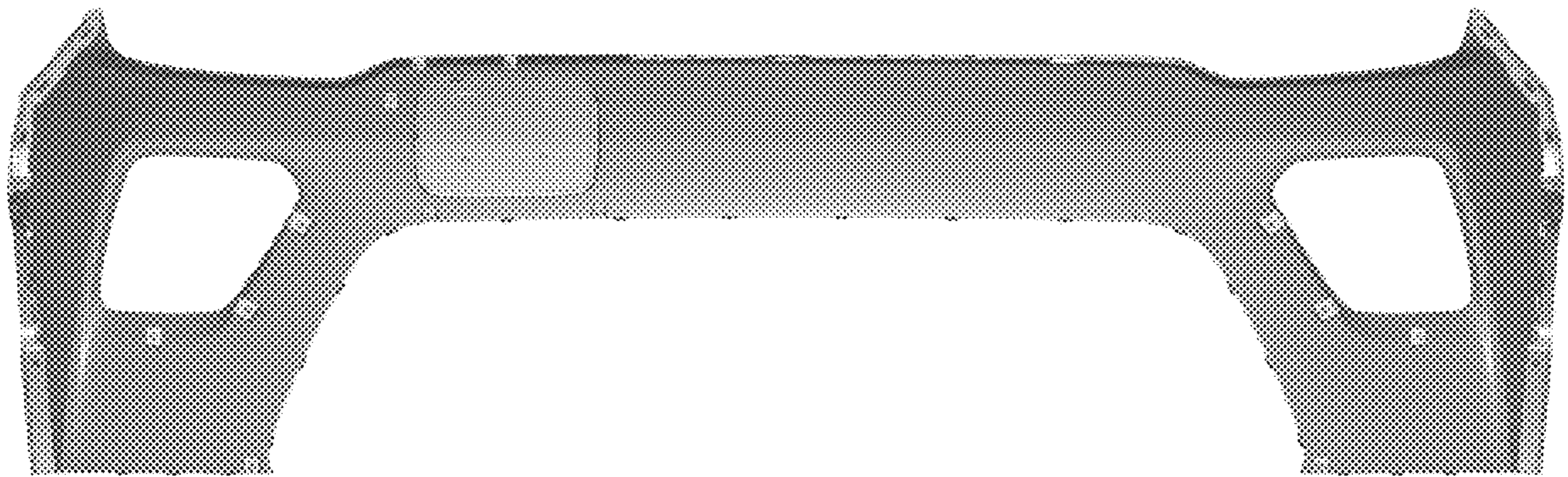

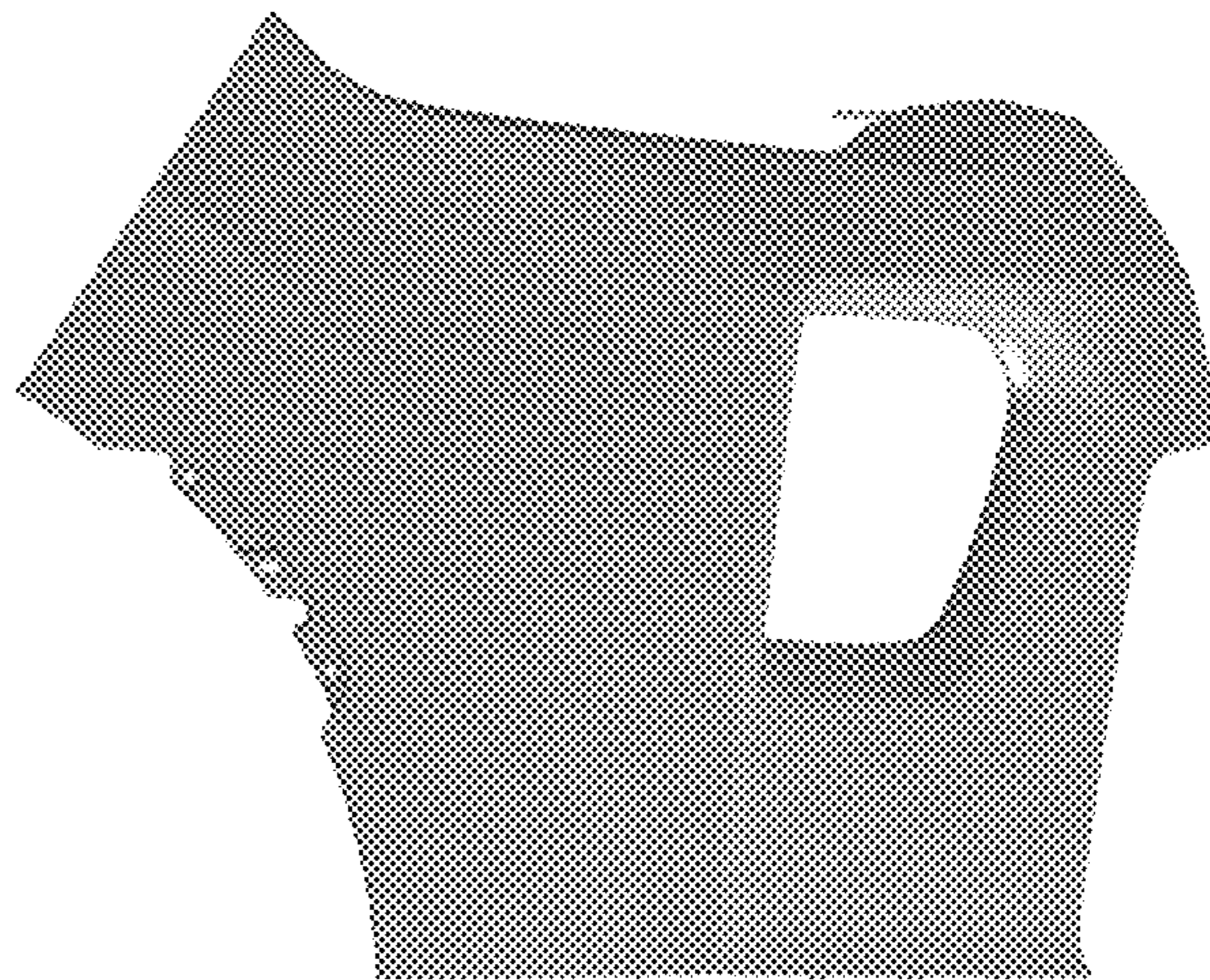

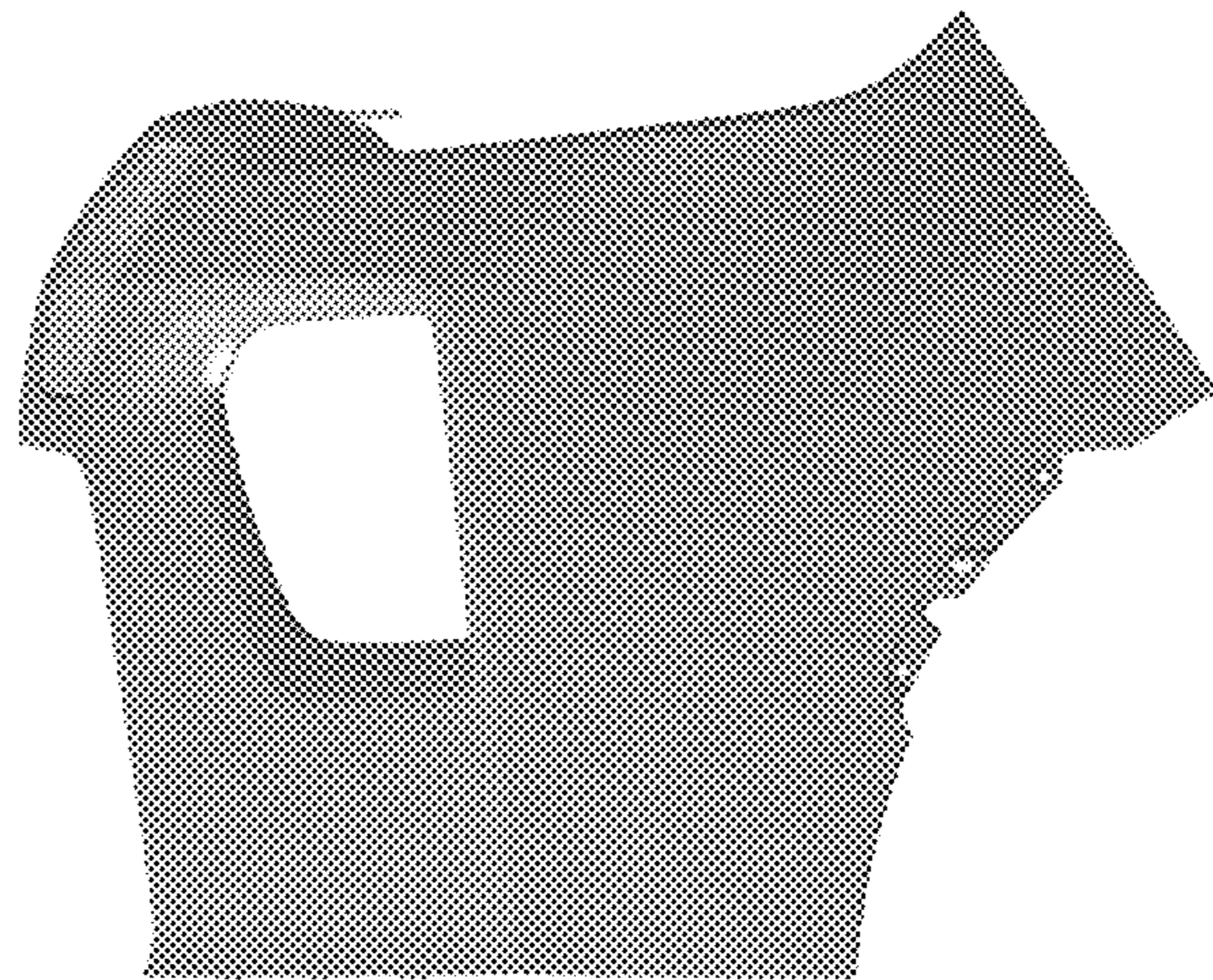

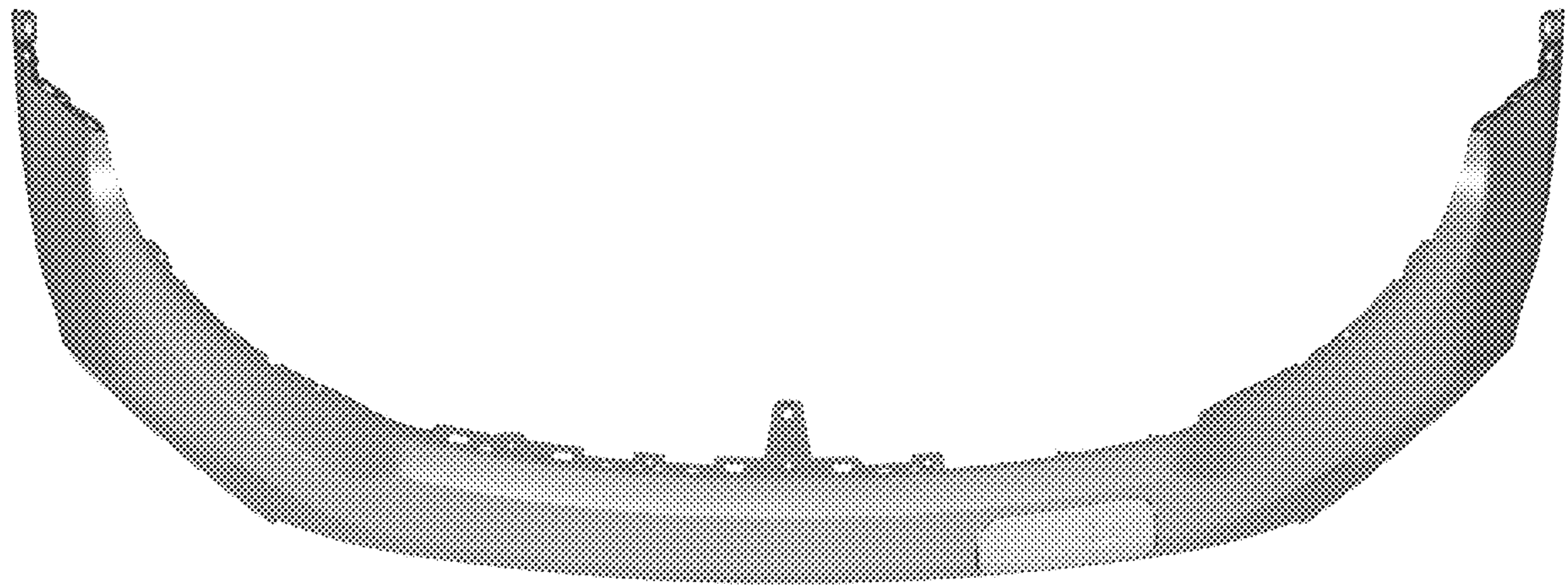
