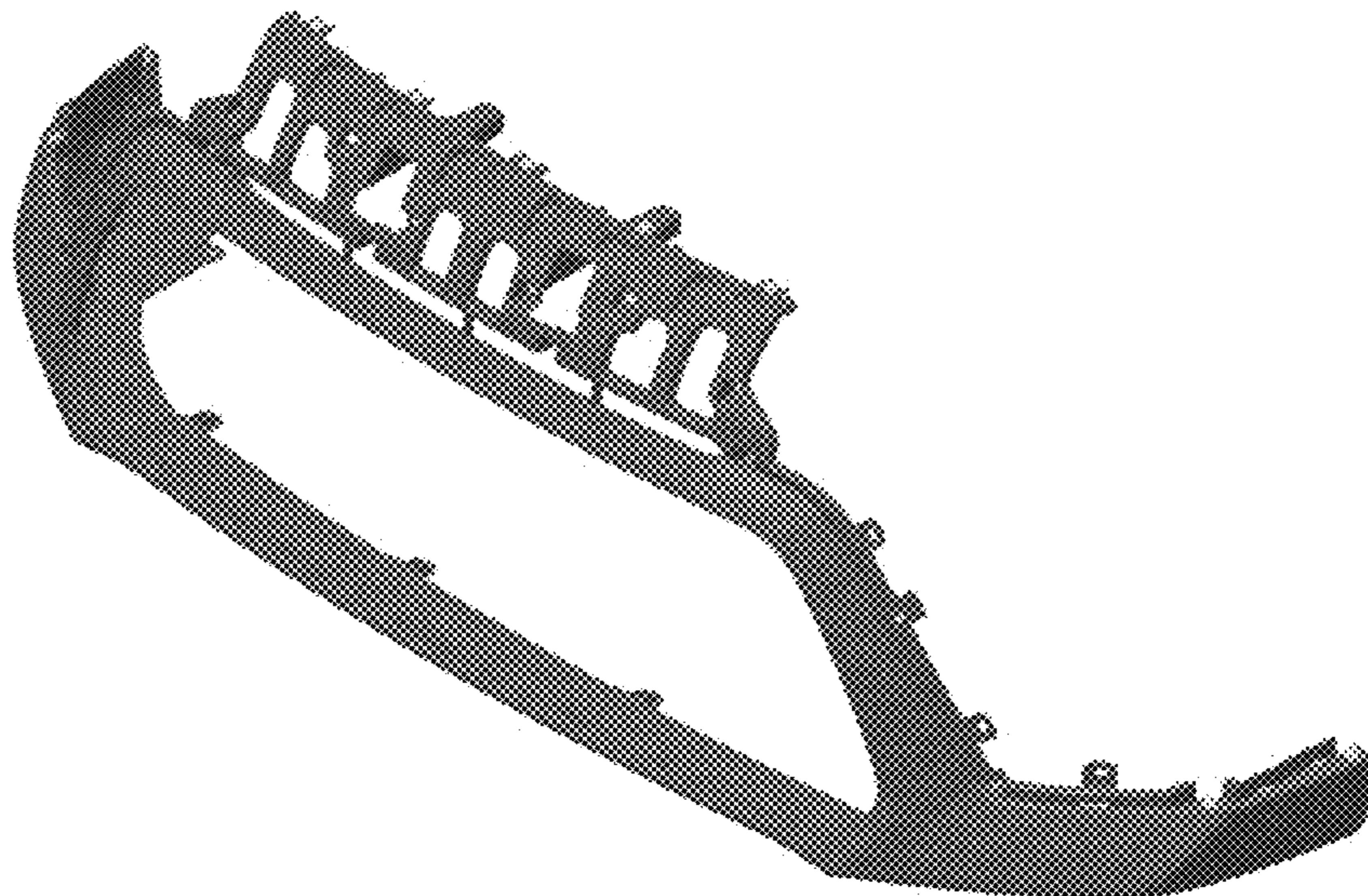
(57) **CLAIM**

**1.1** is a top, front, and left side perspective view of an front bumper lower cover for an automobile showing our new design;  
**1.2** is a front elevation view thereof;  
**1.3** is a rear elevation view thereof;  
**1.4** is a right side elevation view thereof;  
**1.5** is a left side elevation view thereof;  
**1.6** is a top plan view thereof; and

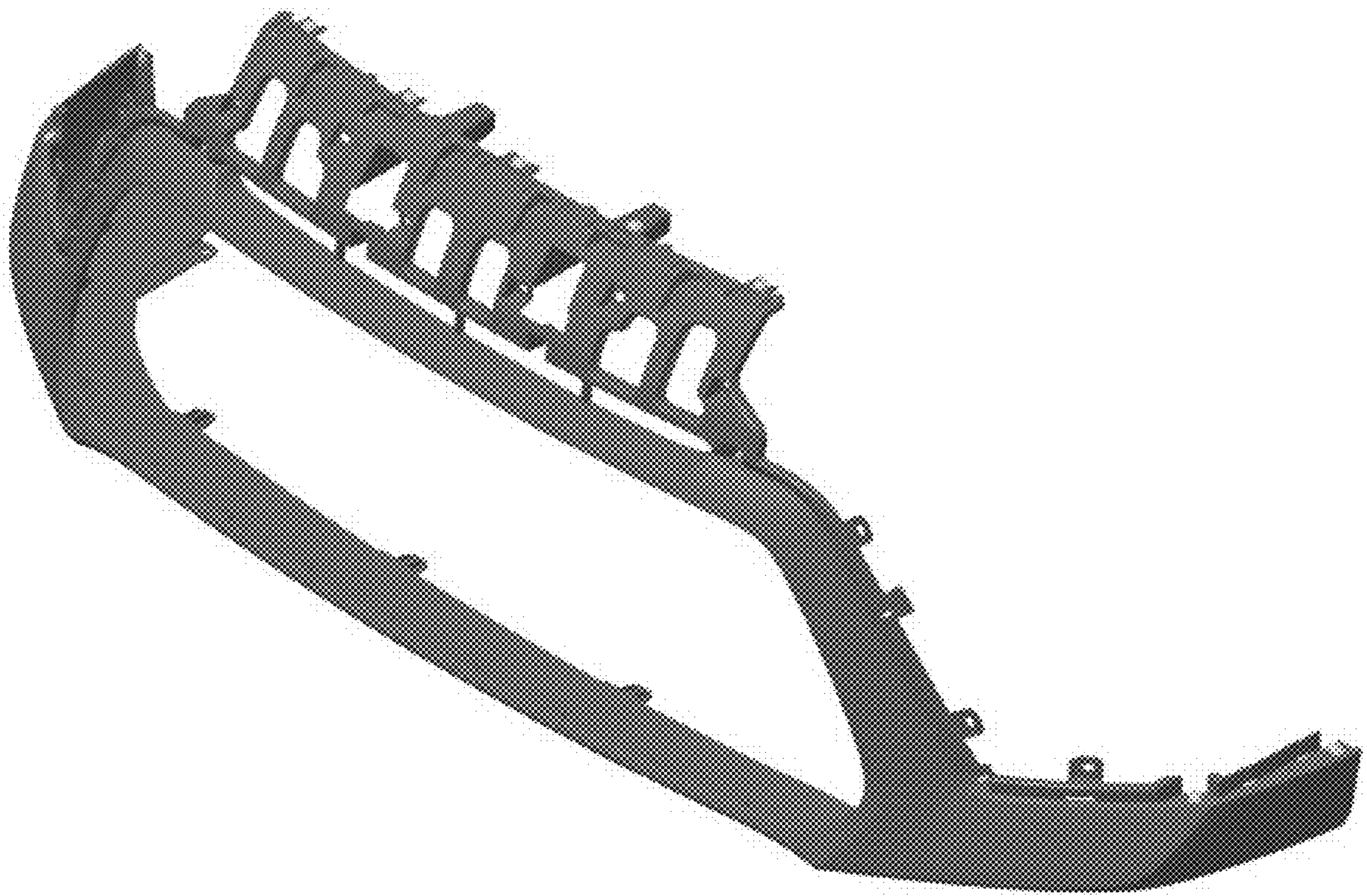

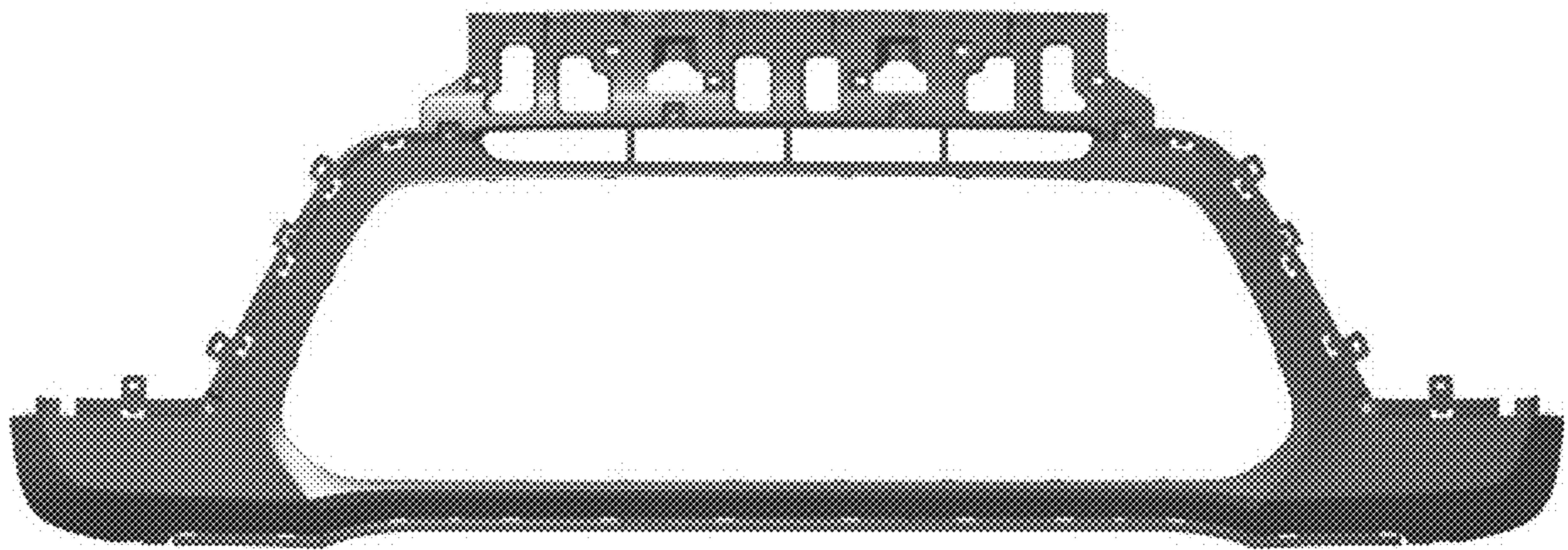

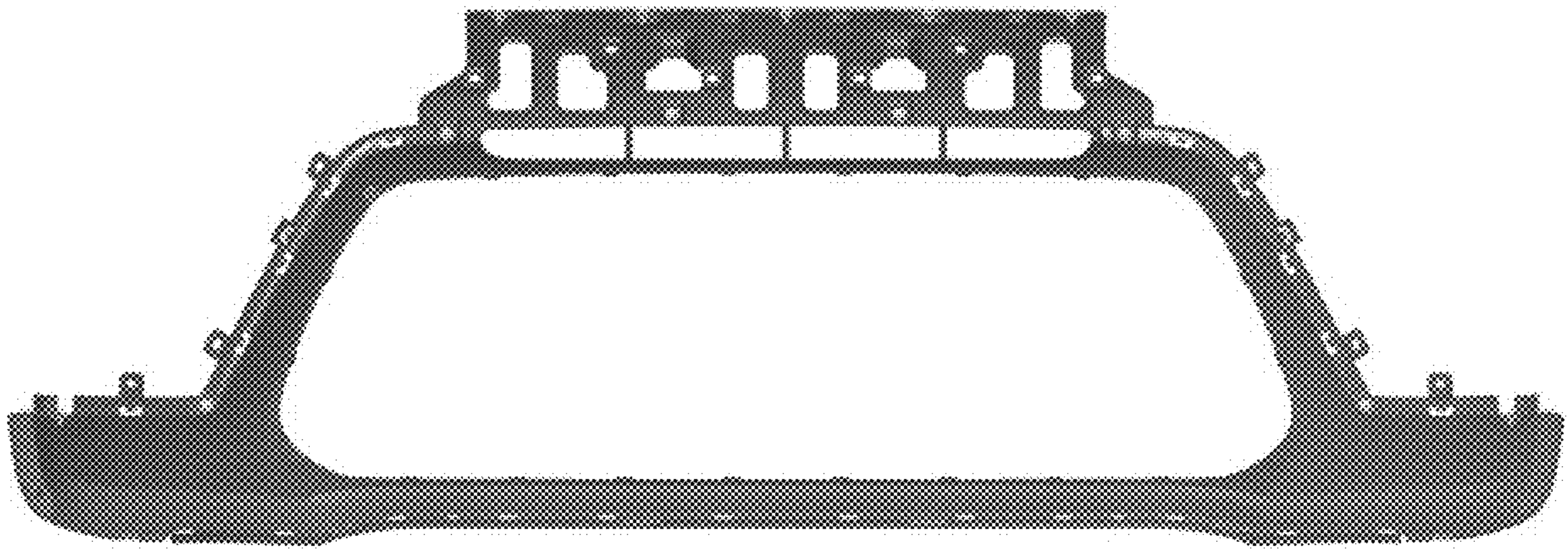

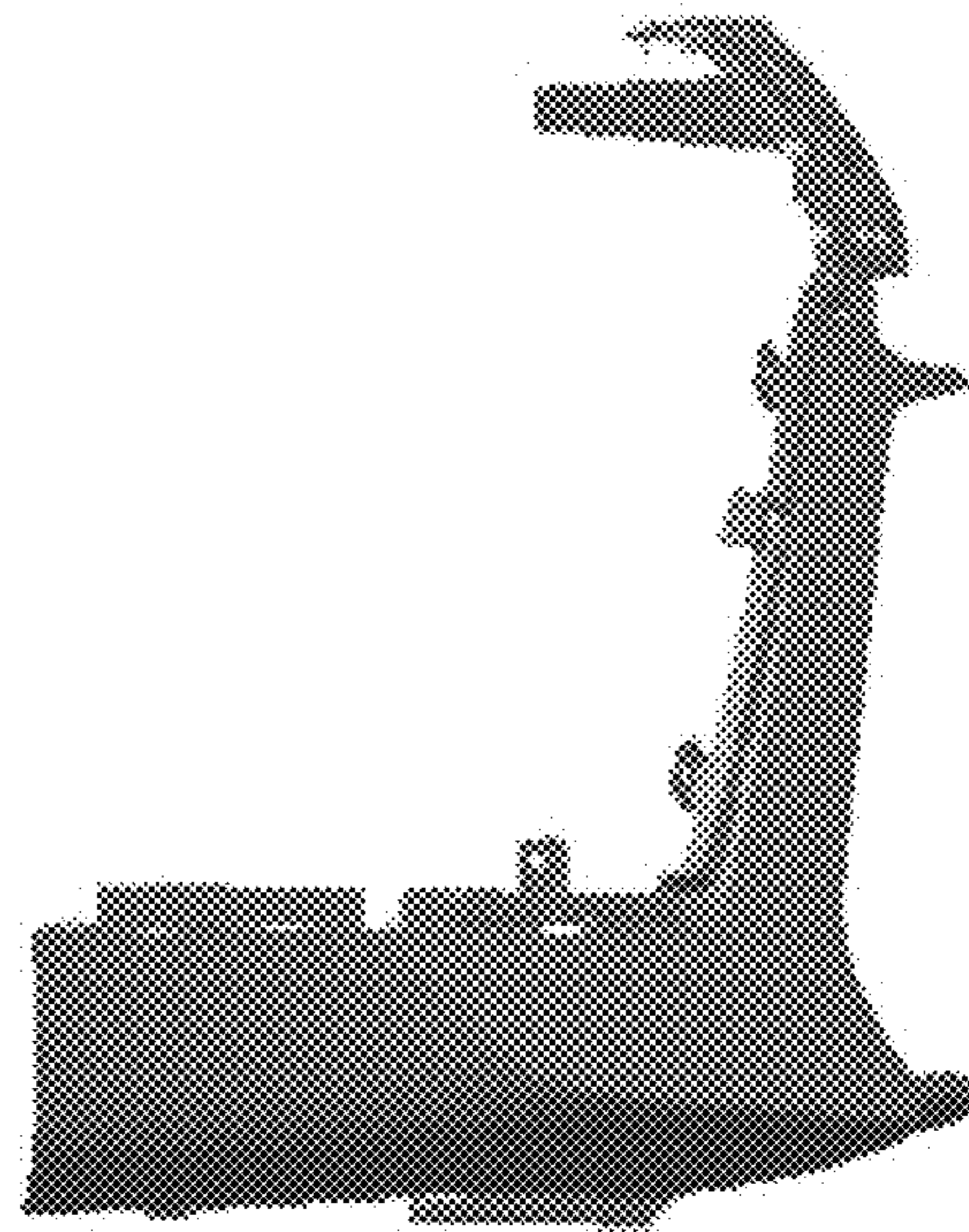

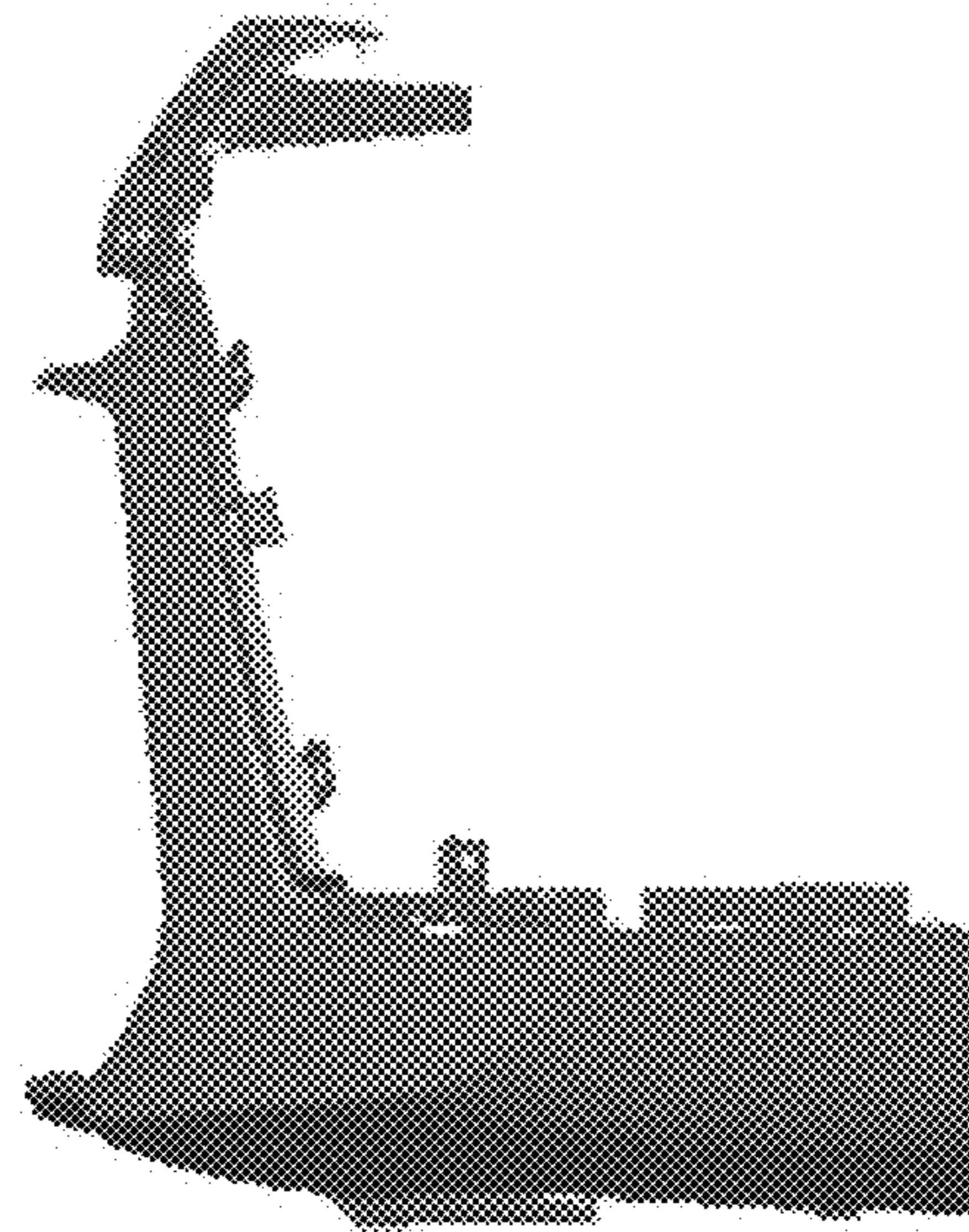

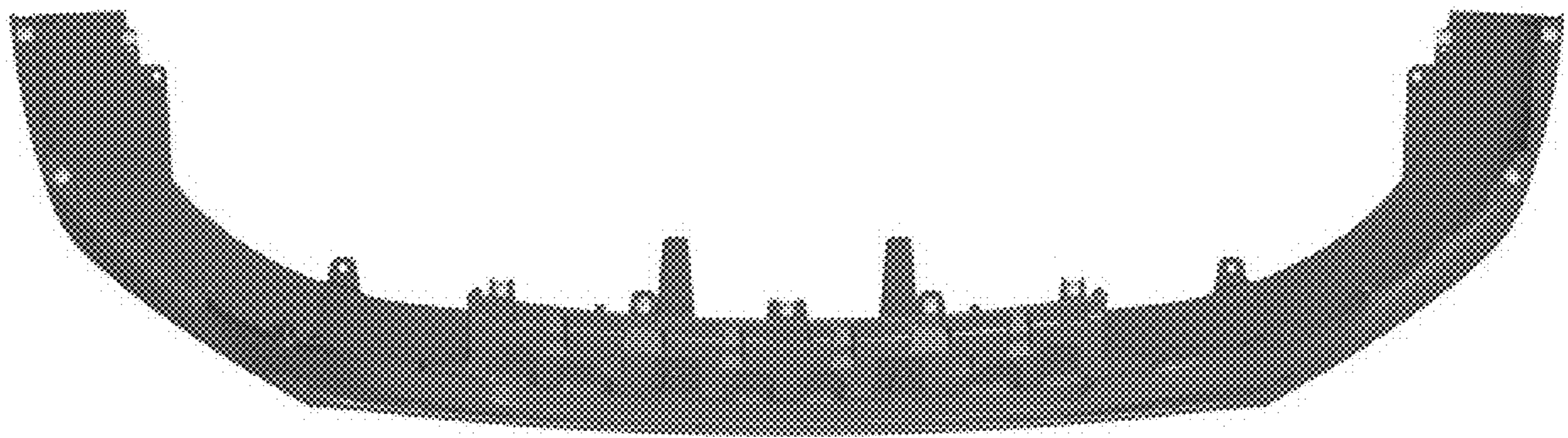
