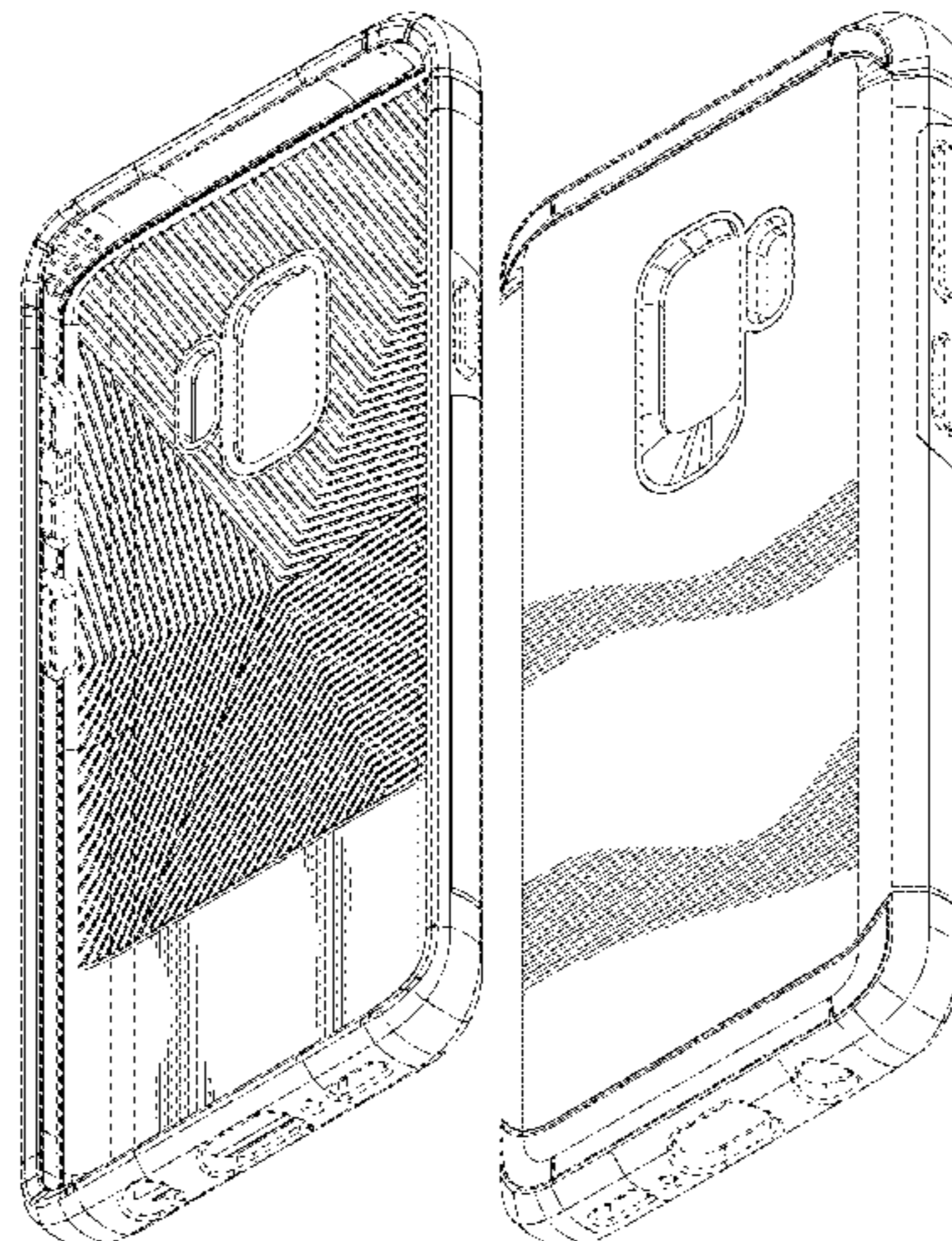

DESCRIPTION

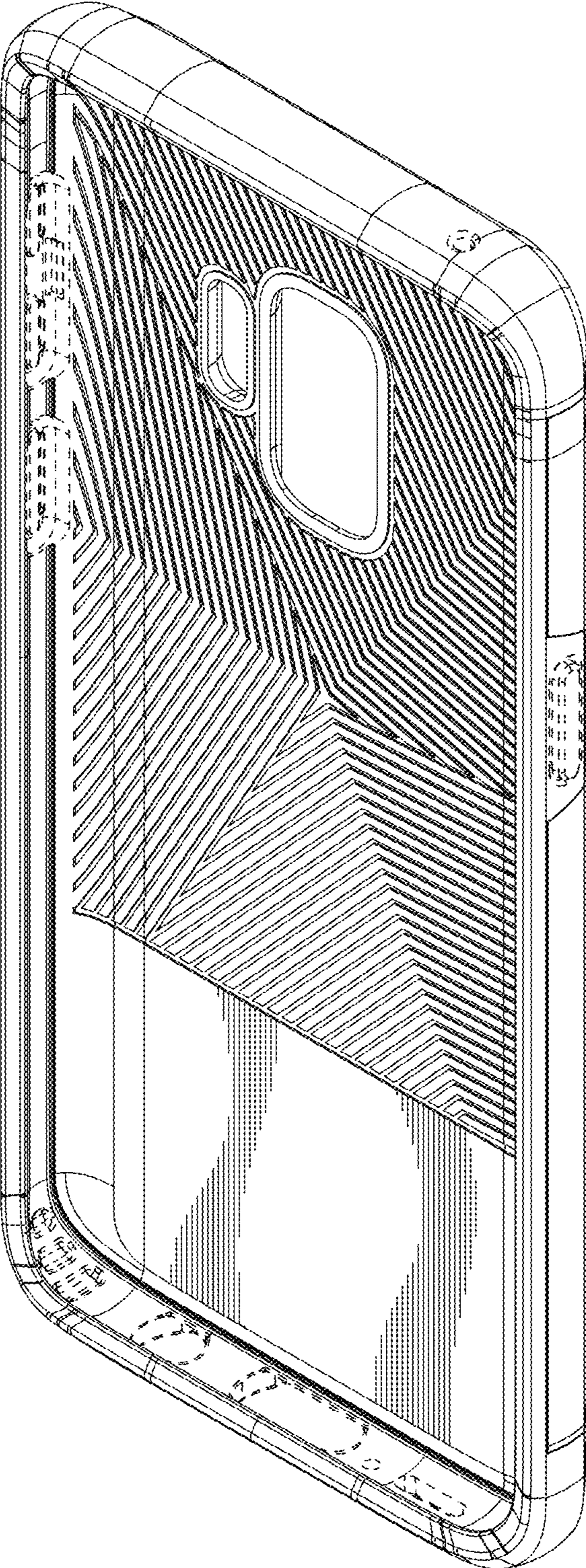

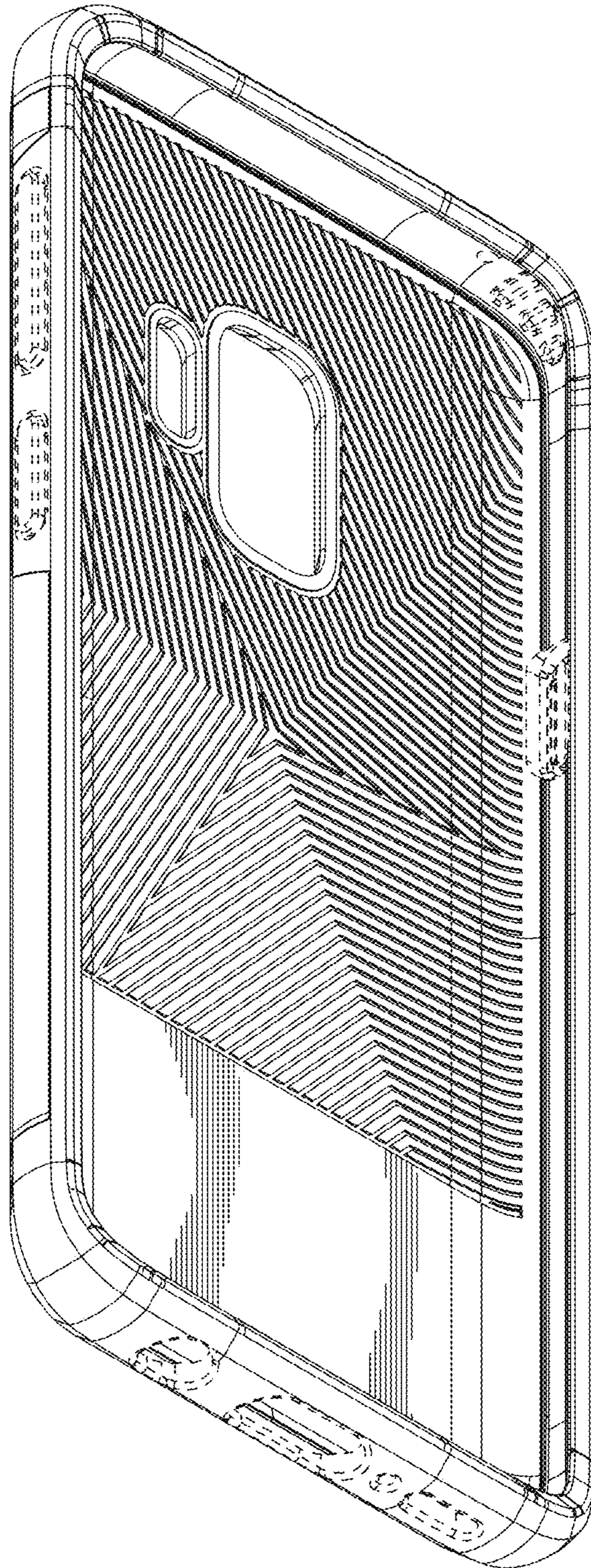

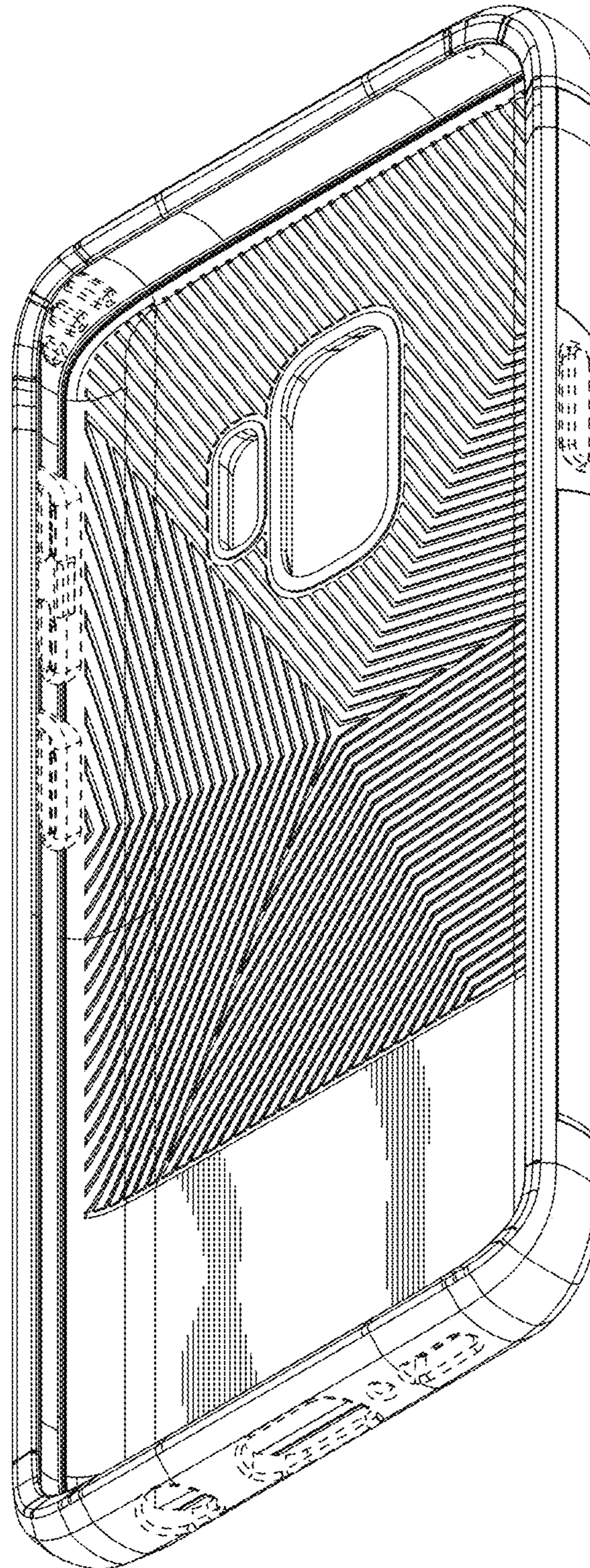

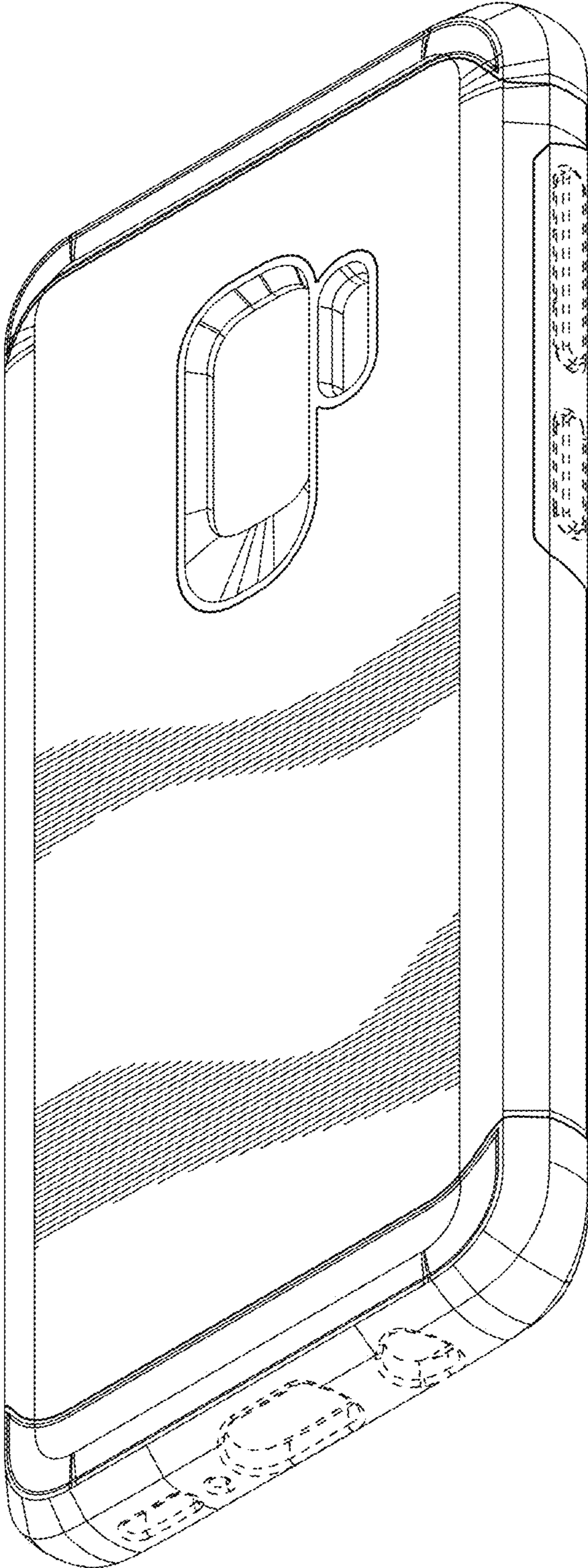

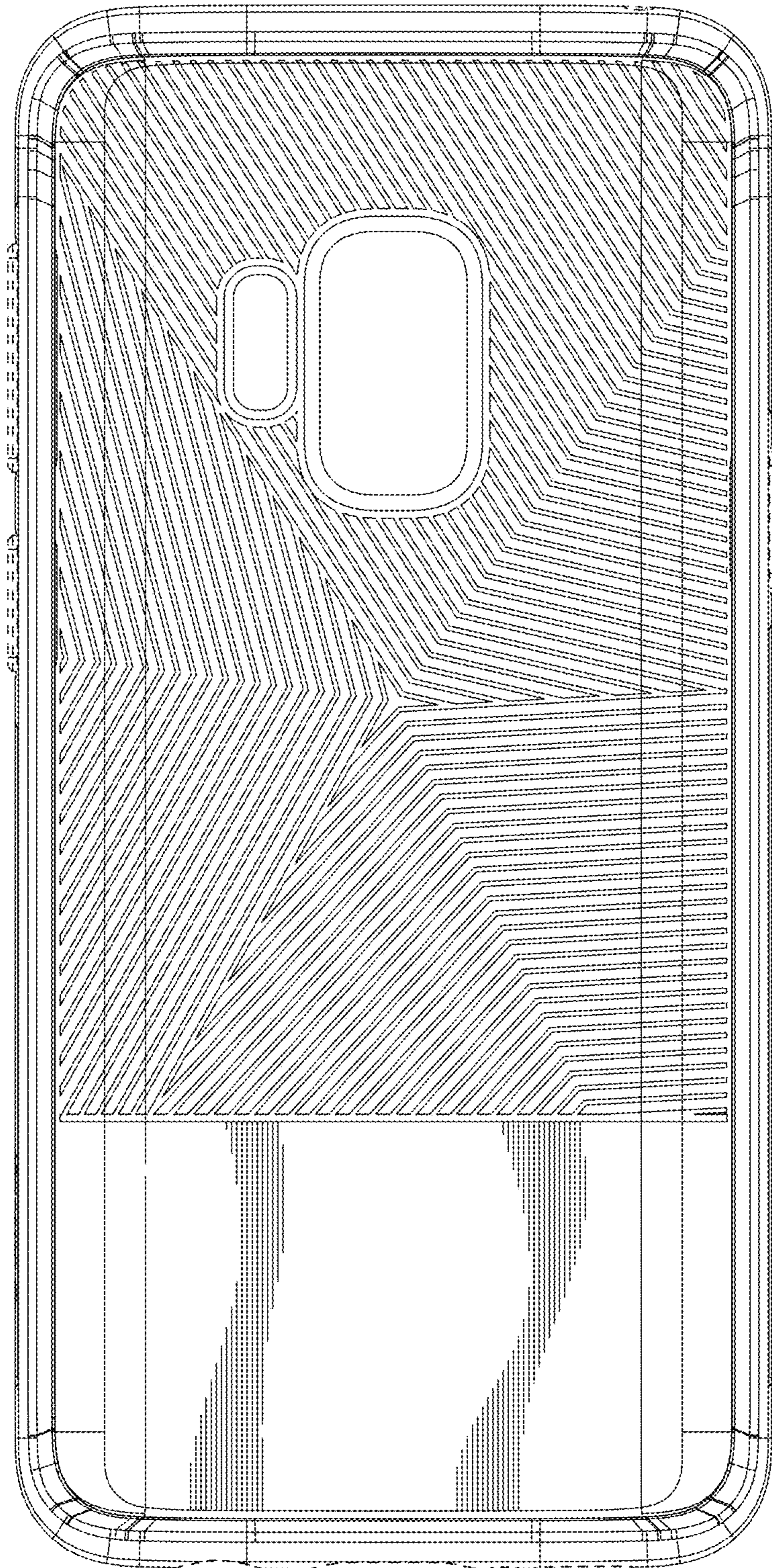

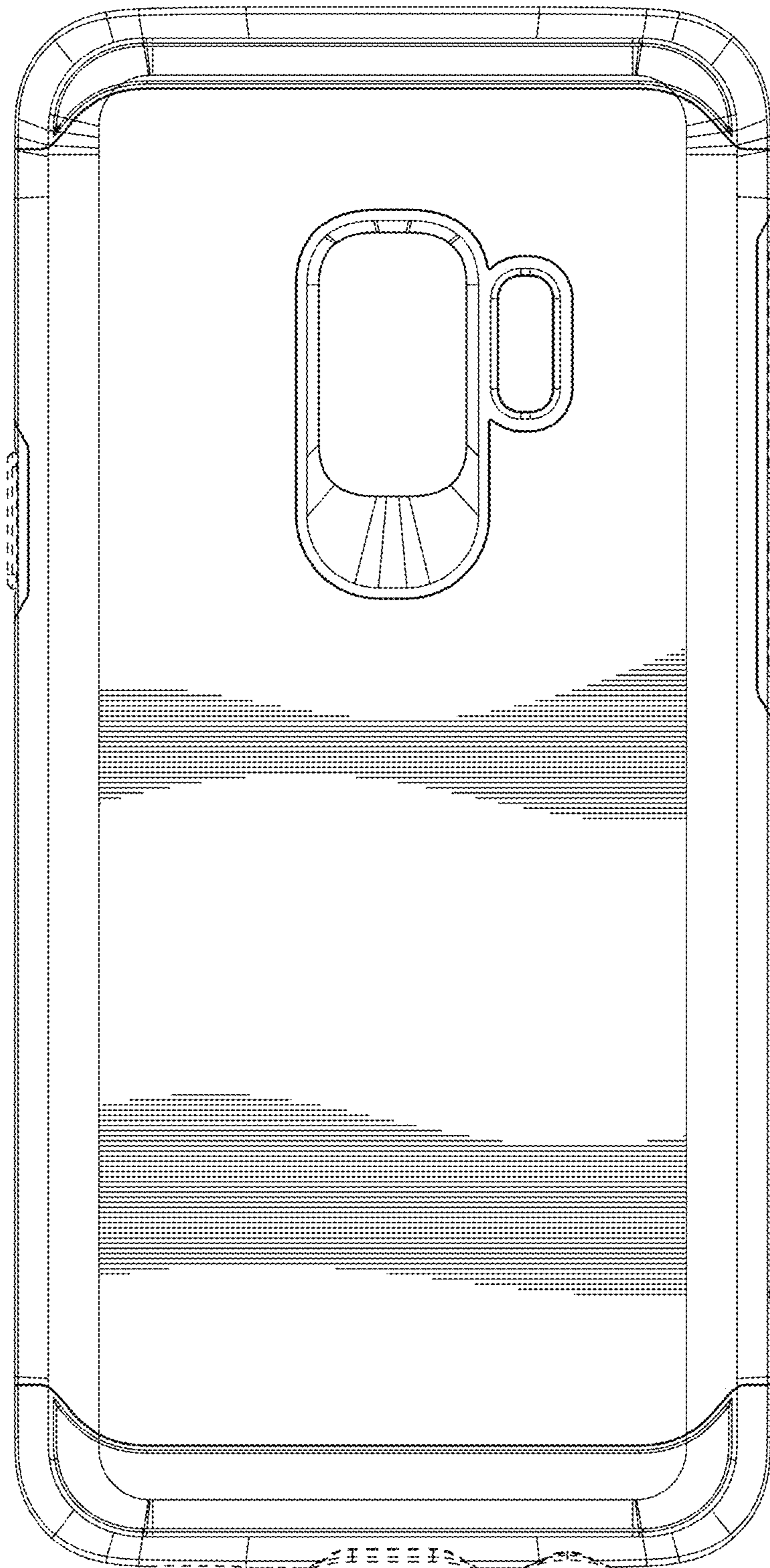

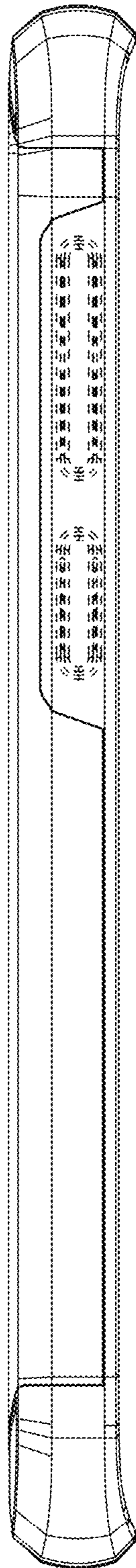

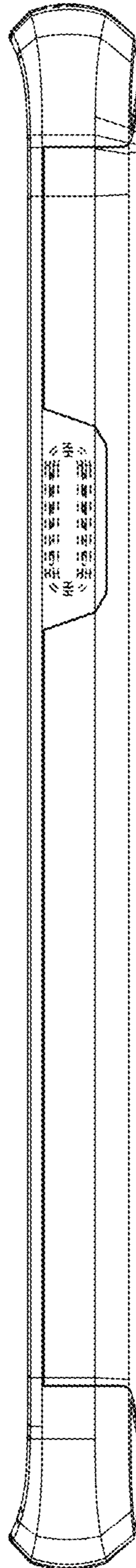

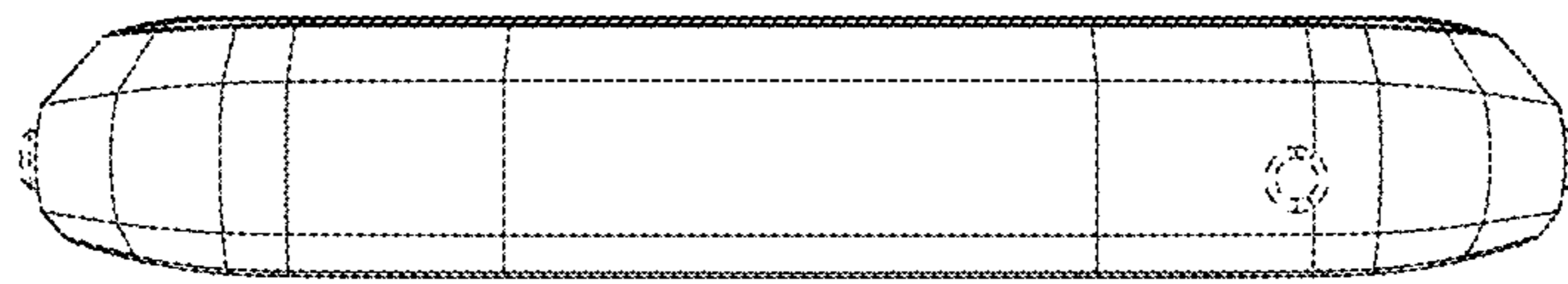

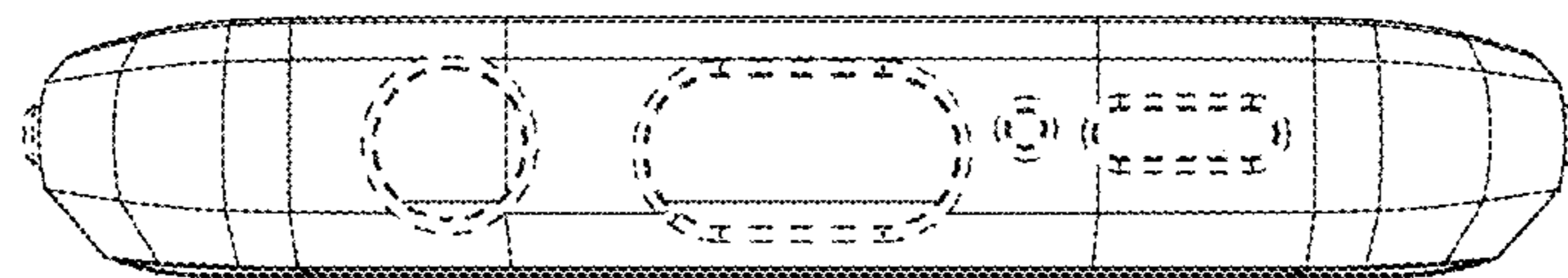

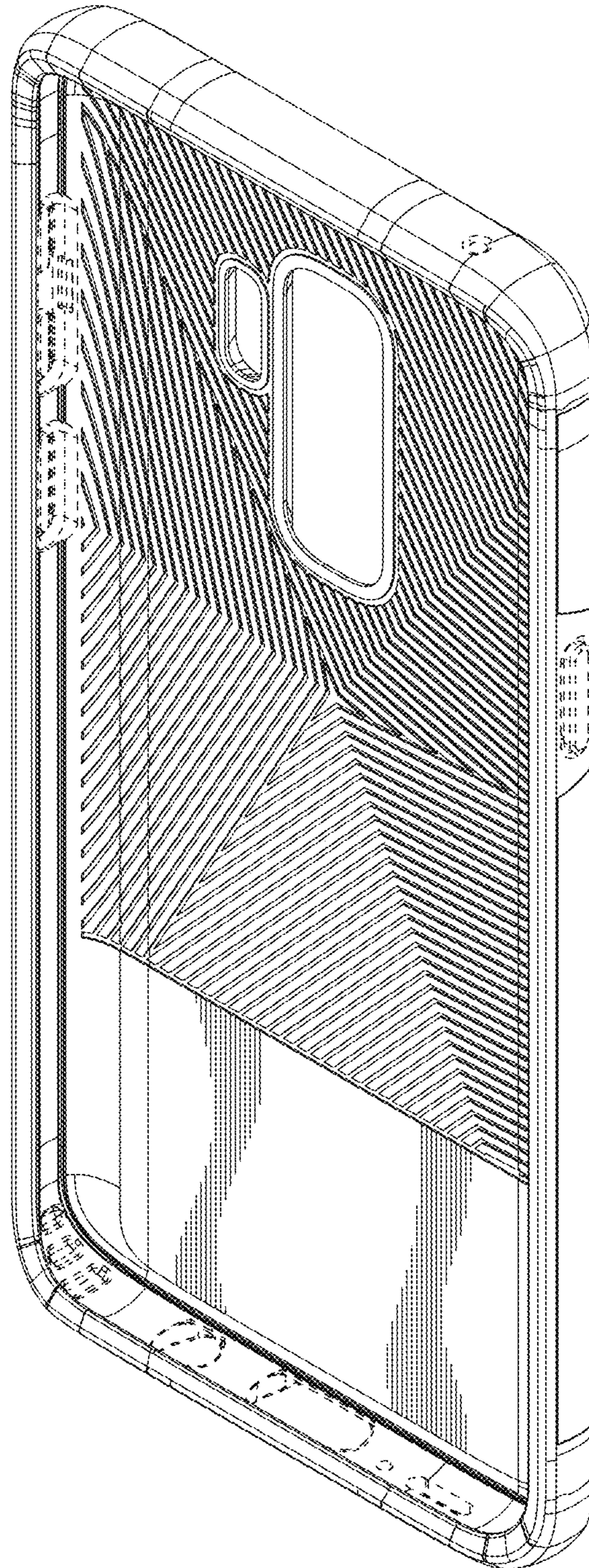

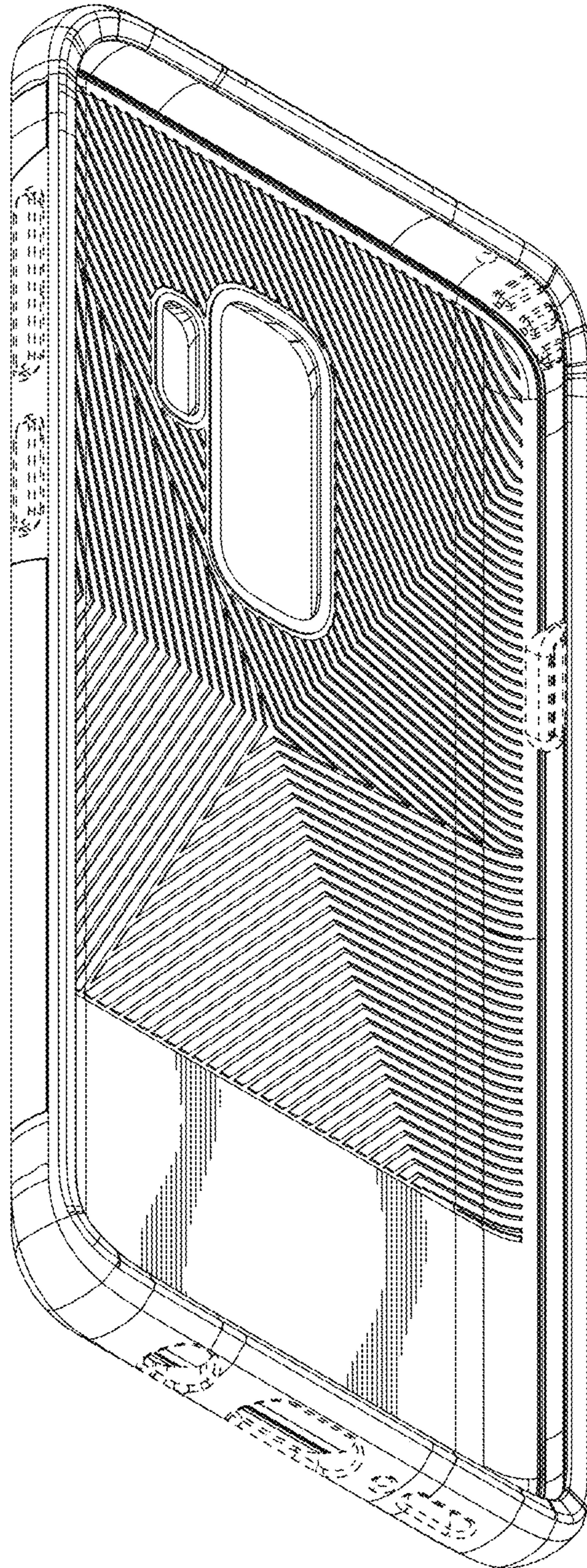

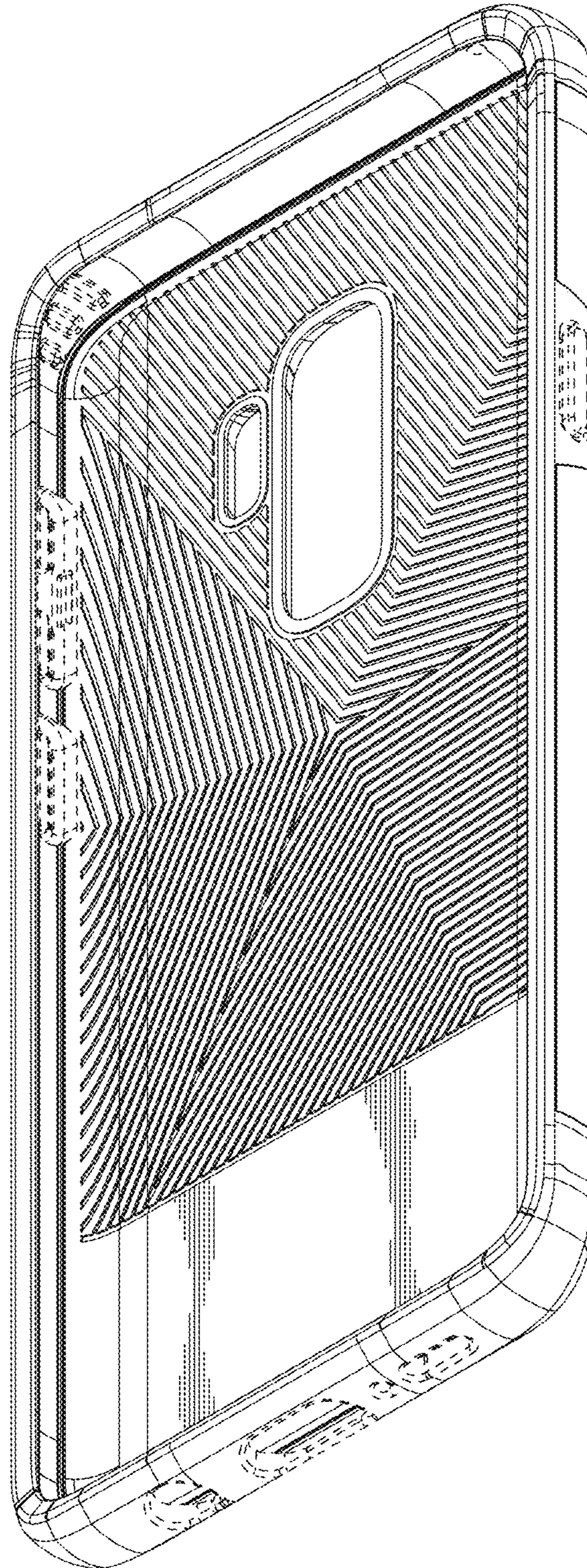

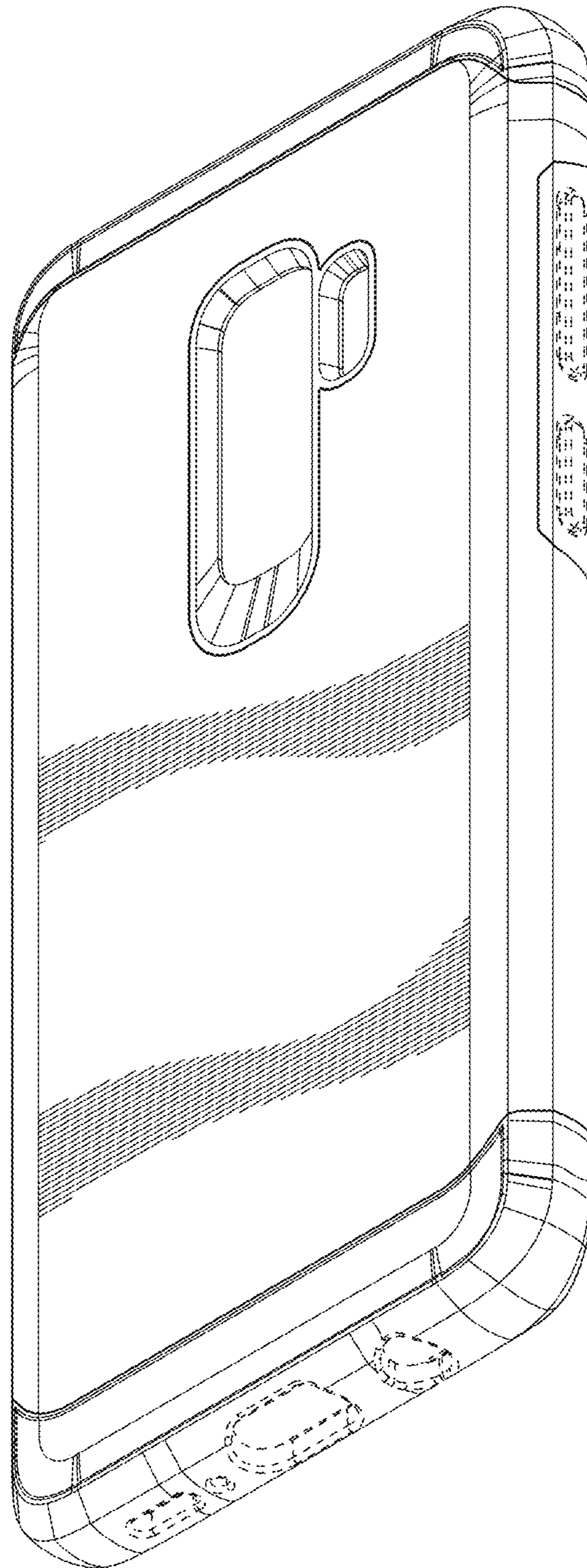

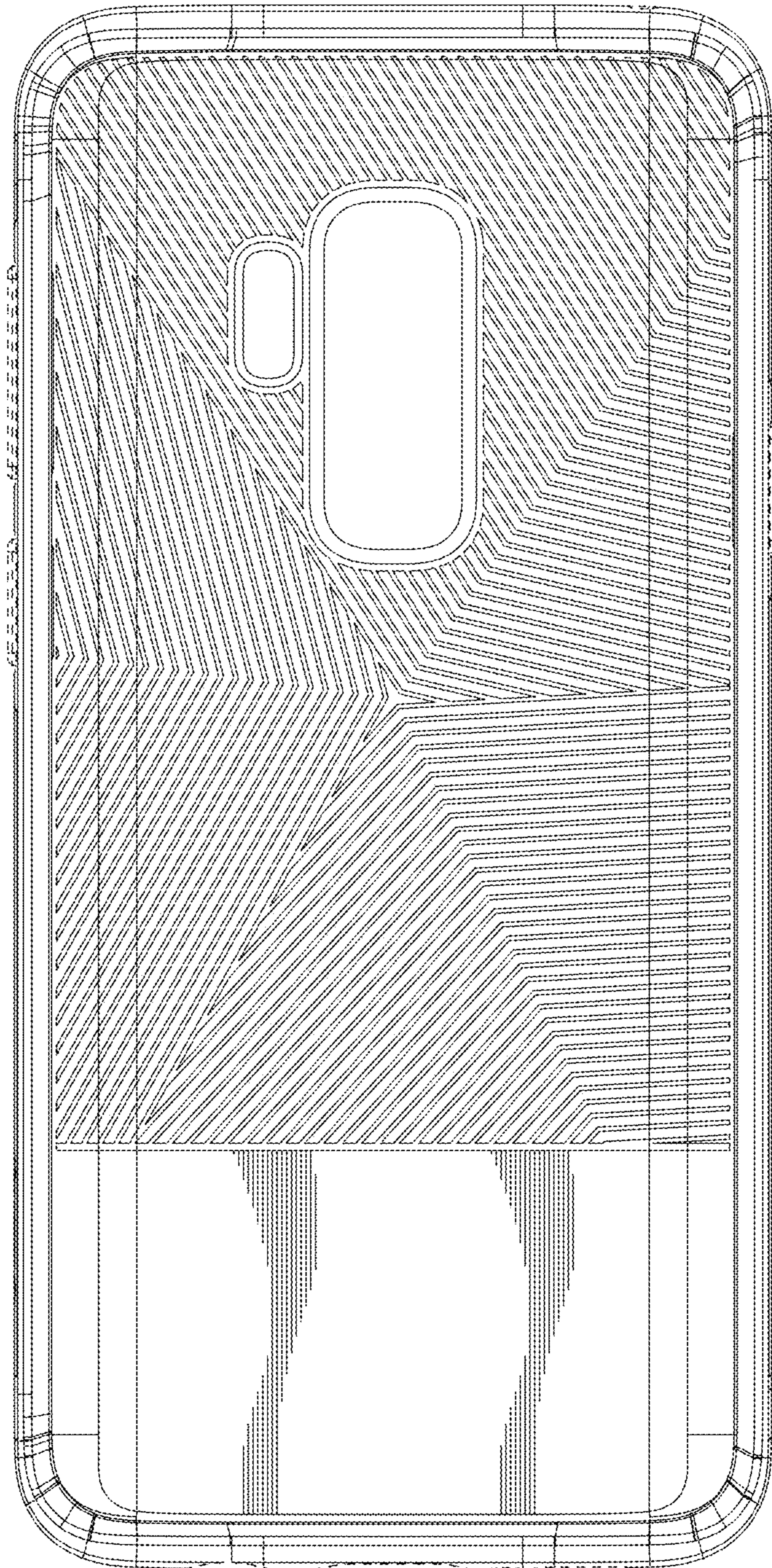

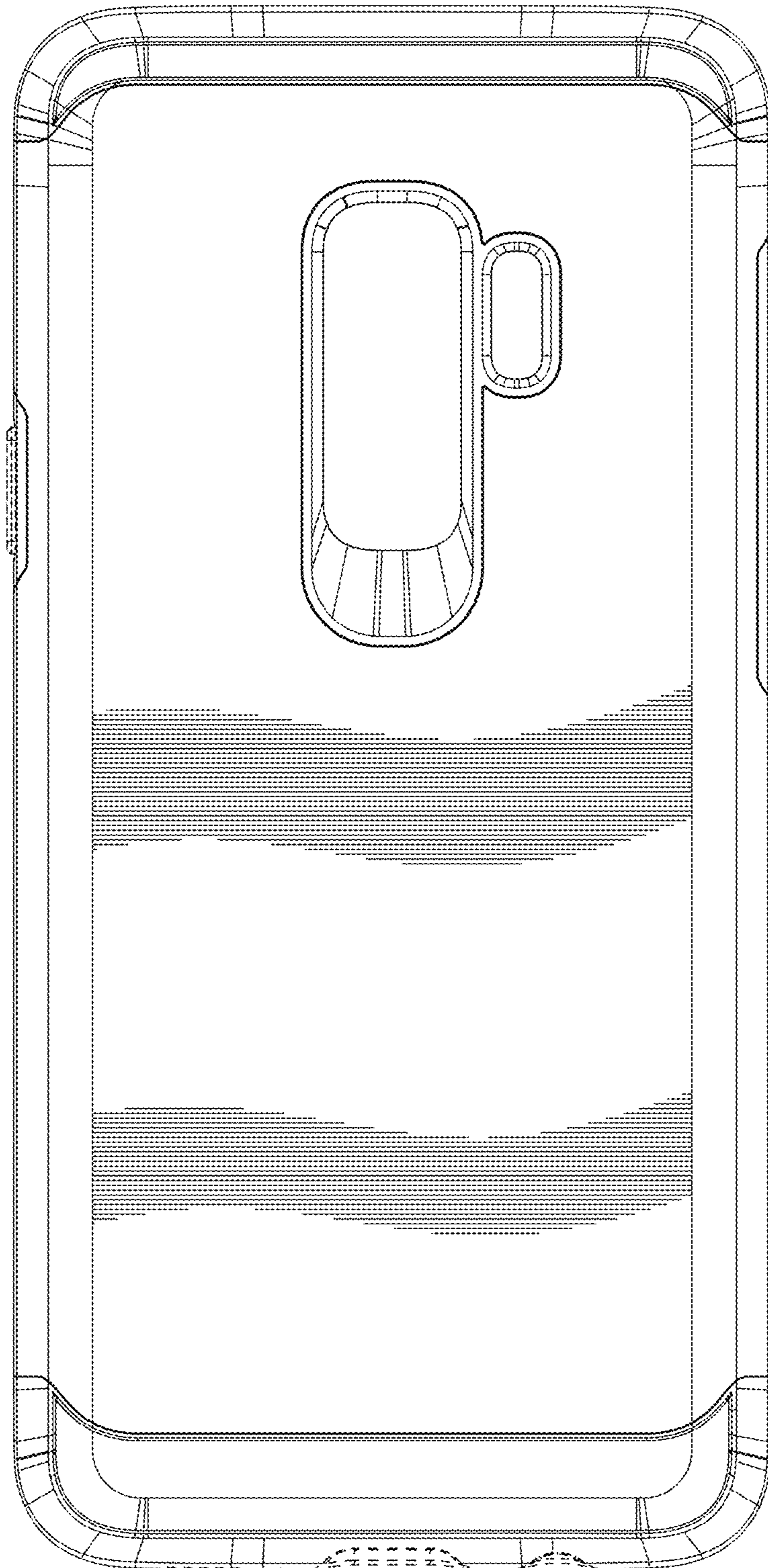

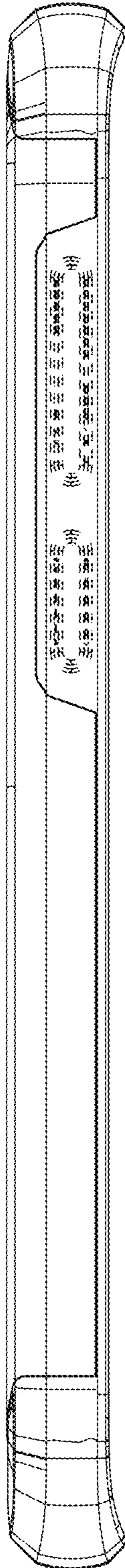

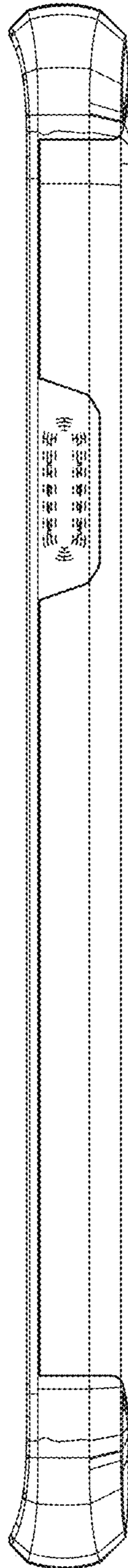

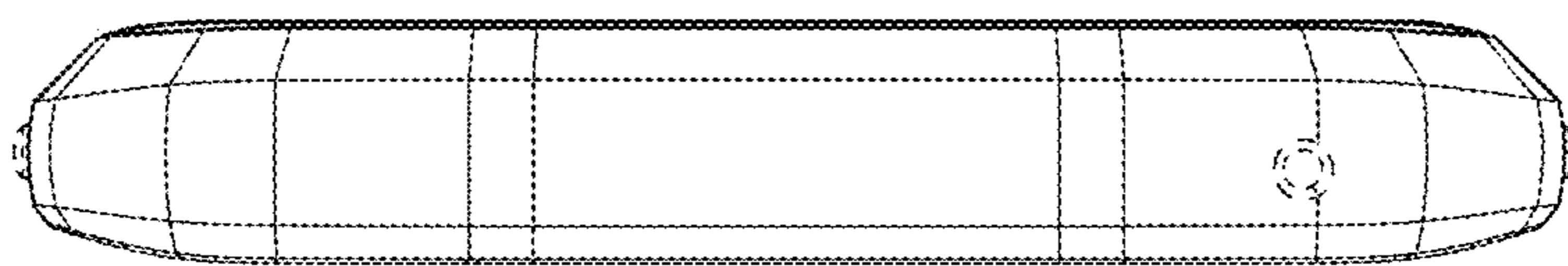
