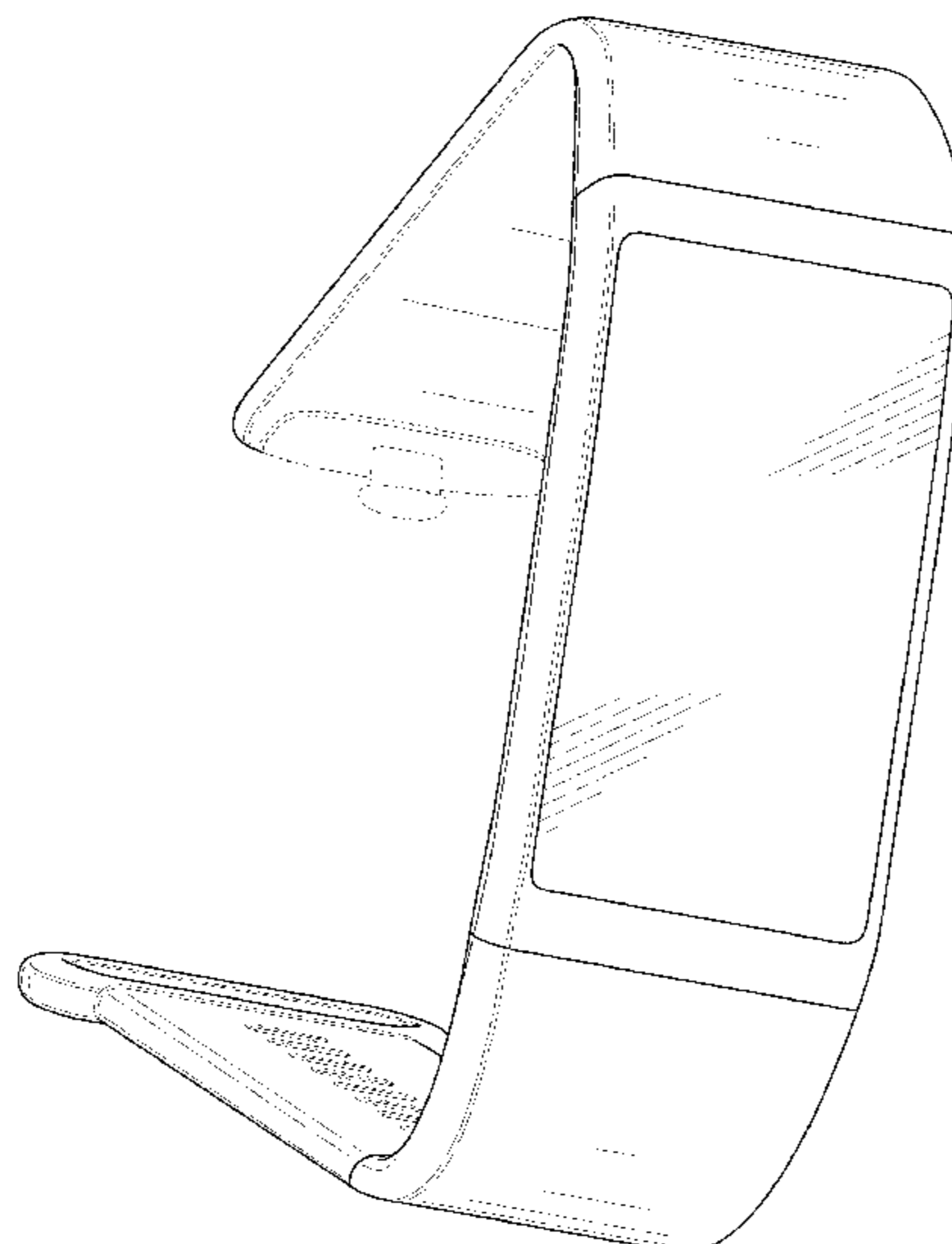
The ornamental design for a wristband, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view of the wristband showing our new design.
FIG. 2 is a front view of the wristband of FIG. 1.
FIG. 3 is a rear view of the wristband of FIG. 1.
FIG. 4 is a left side view of the wristband of FIG. 1.
FIG. 5 is a right side view of the wristband of FIG. 1.
FIG. 6 is a top view of the wristband of FIG. 1.
FIG. 7 is a bottom view of the wristband of FIG. 1; and, FIG. 8 is a rear, right perspective view of the wristband of FIG. 1.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken line shown in FIGS. 1-8 show portions of the wristband that form no part of the claimed design. The shade lines in the figures show contour and not surface ornamentation. The shade lines form no part of the claimed design.

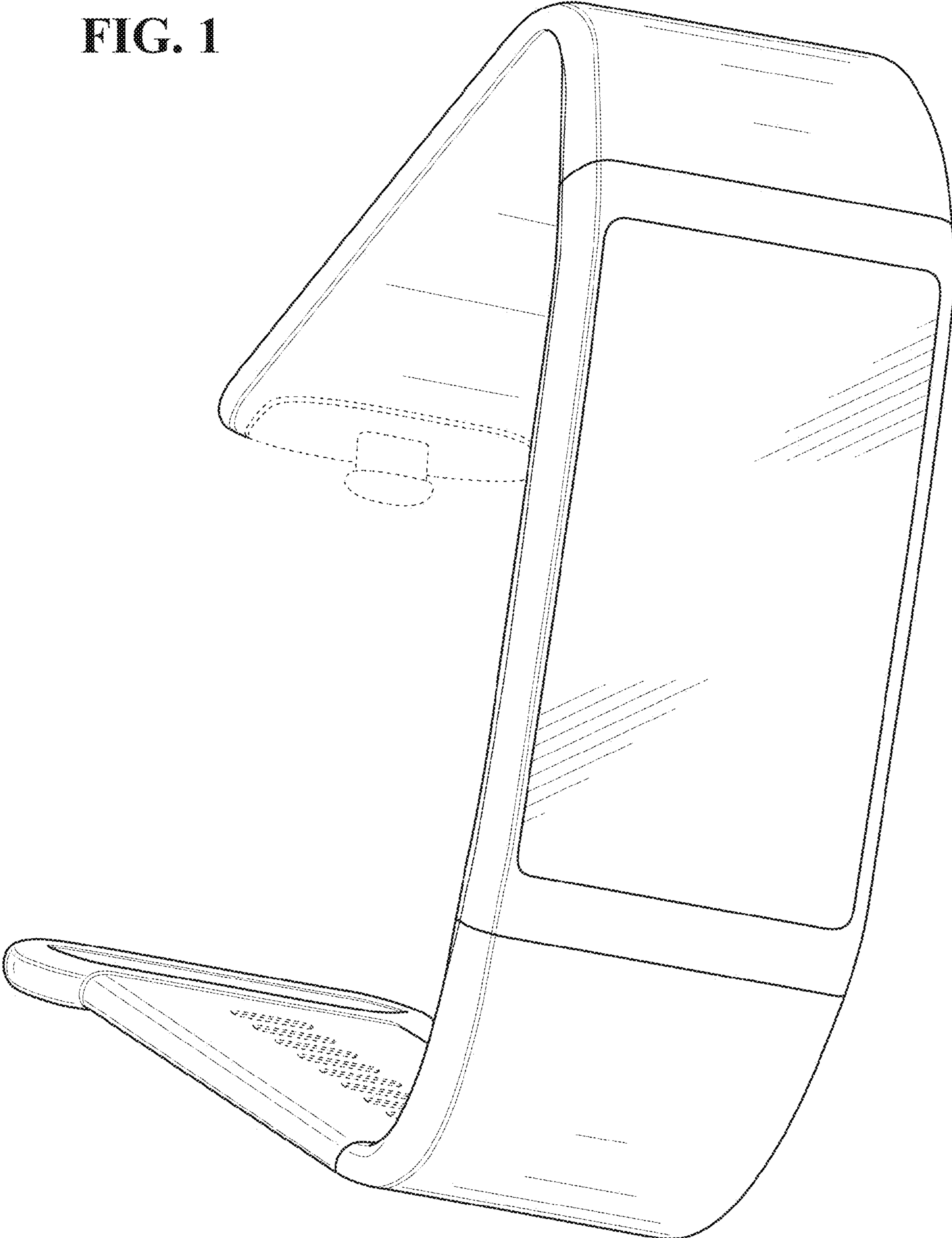

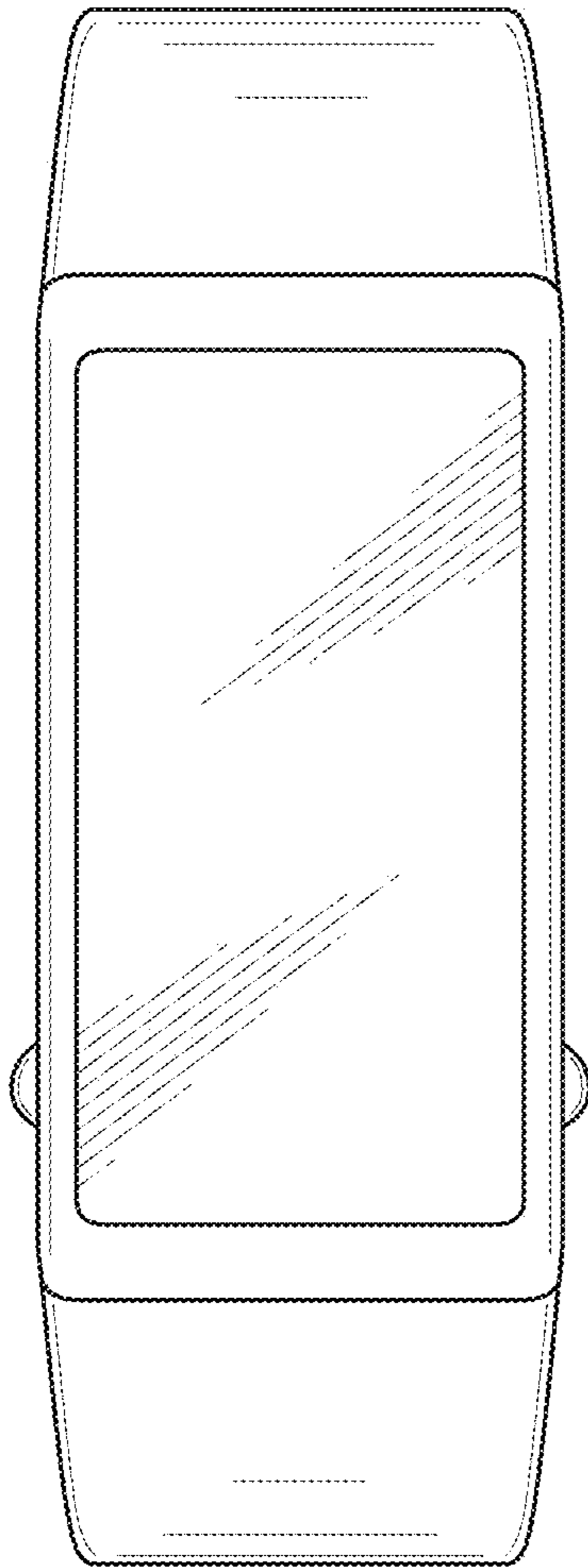

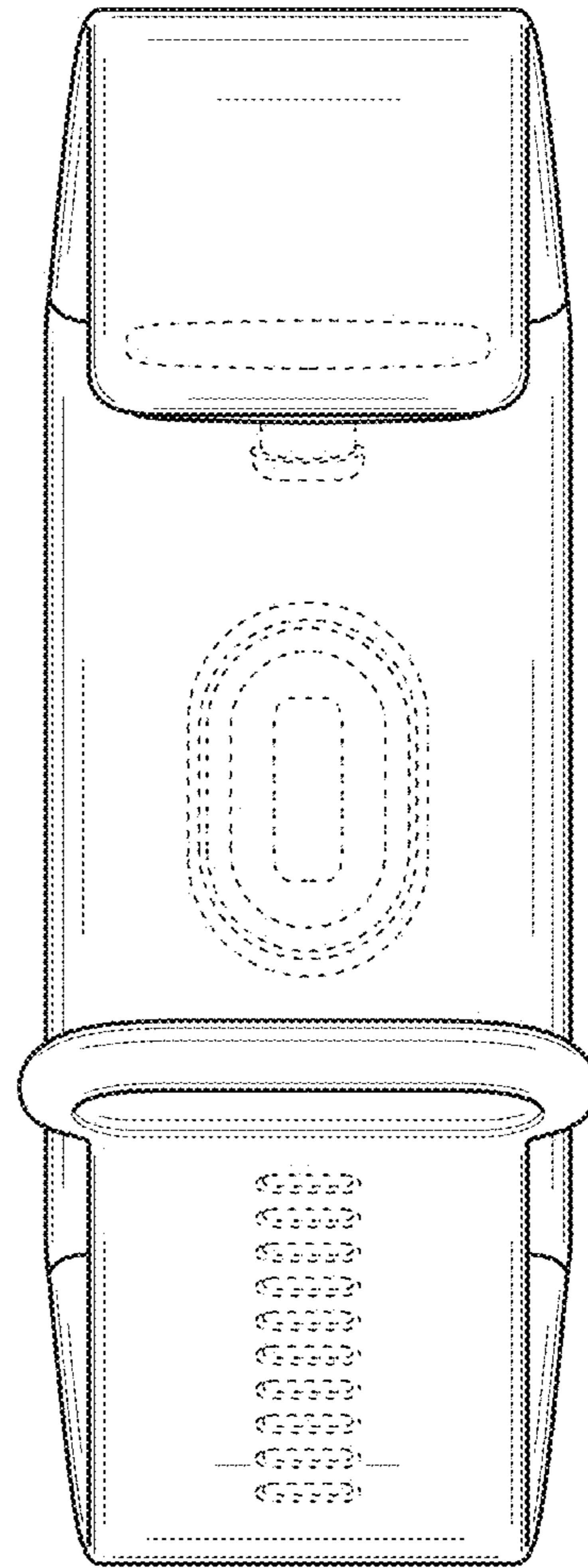

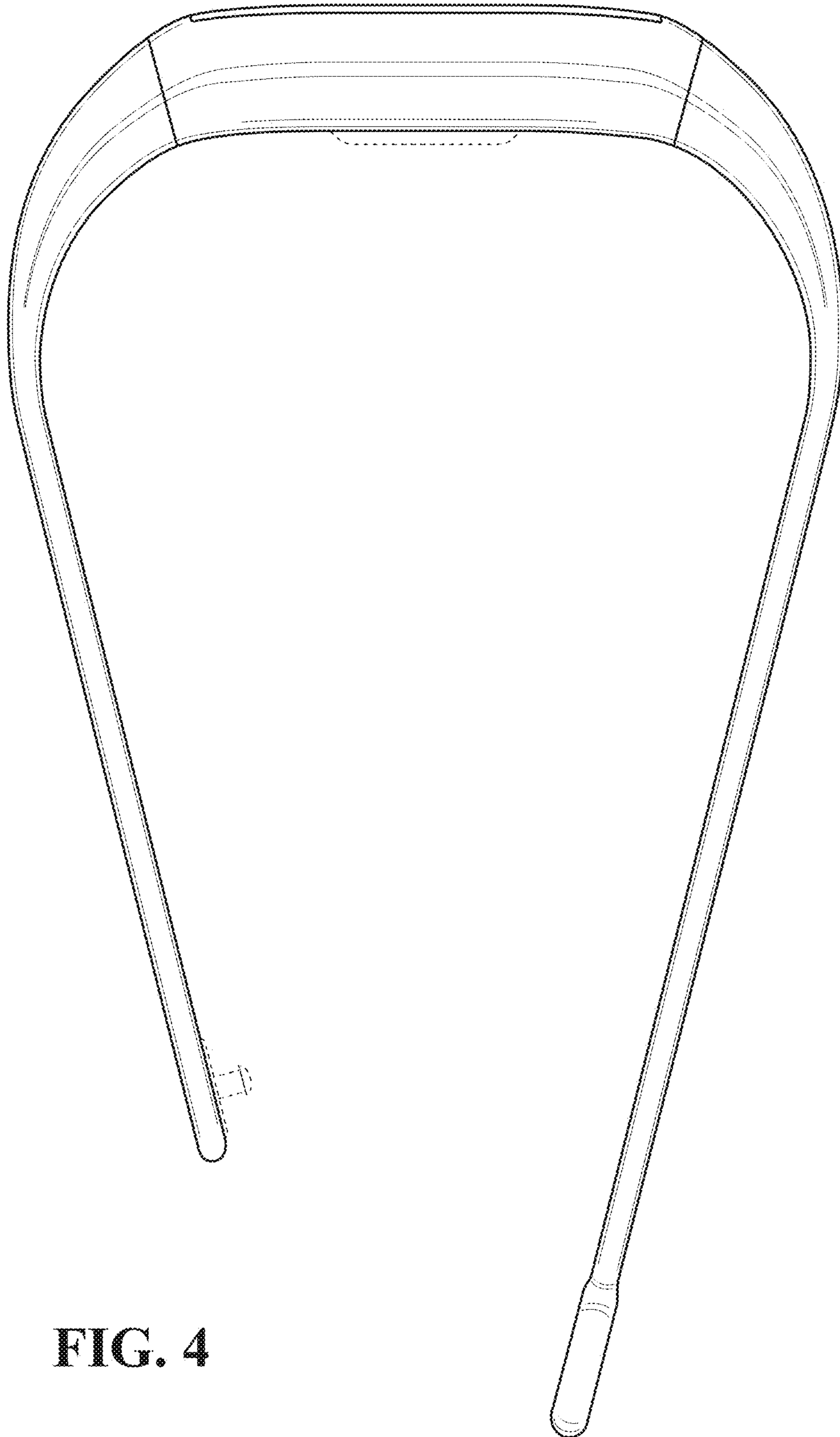
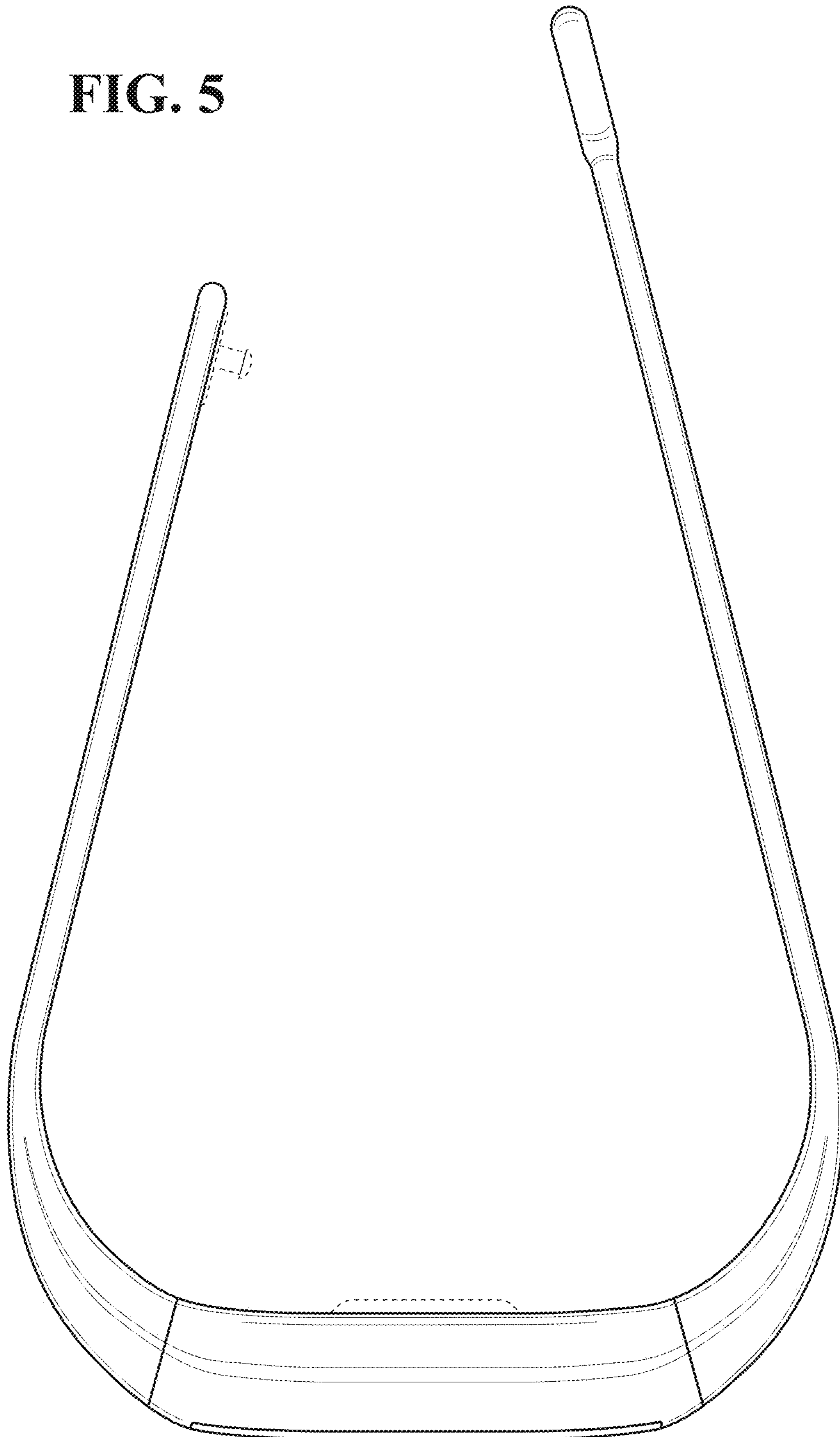

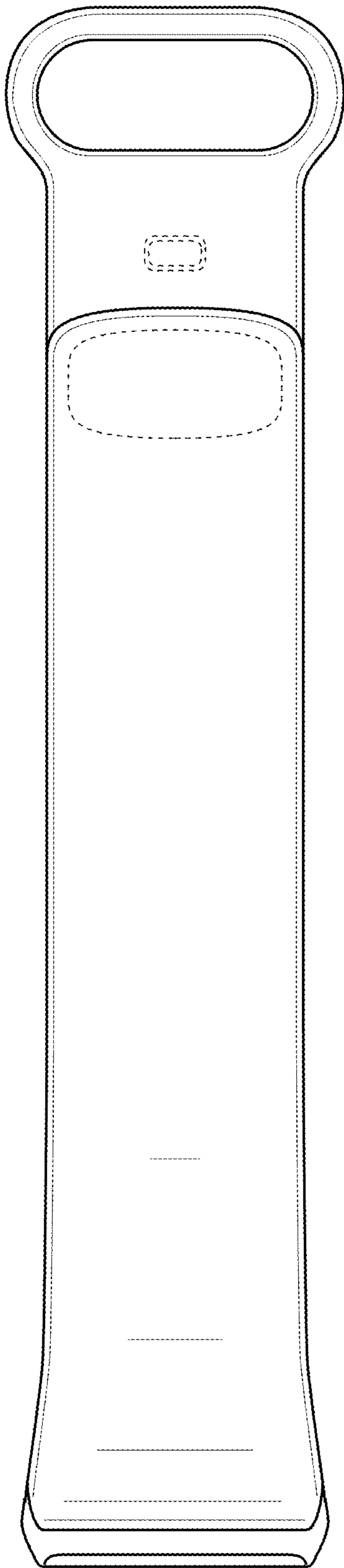

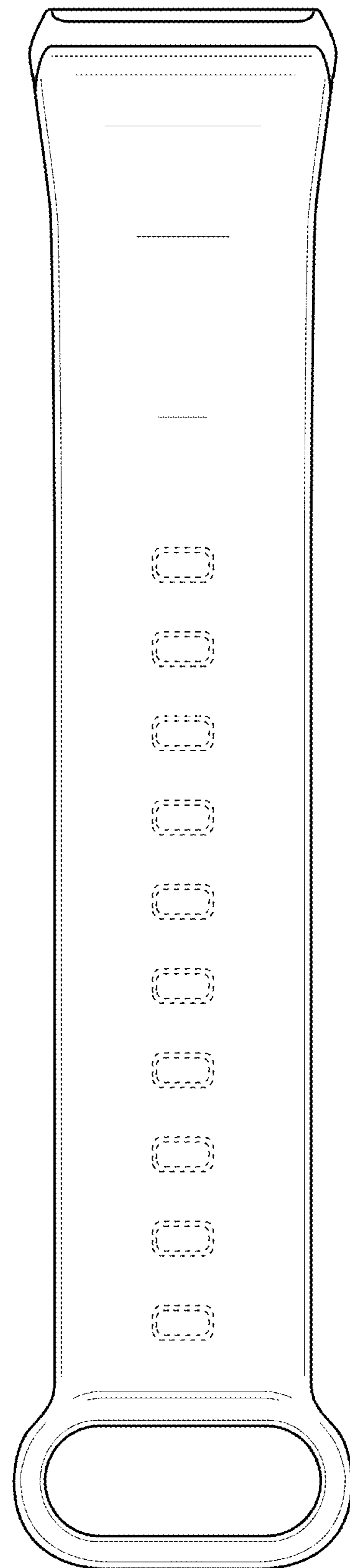

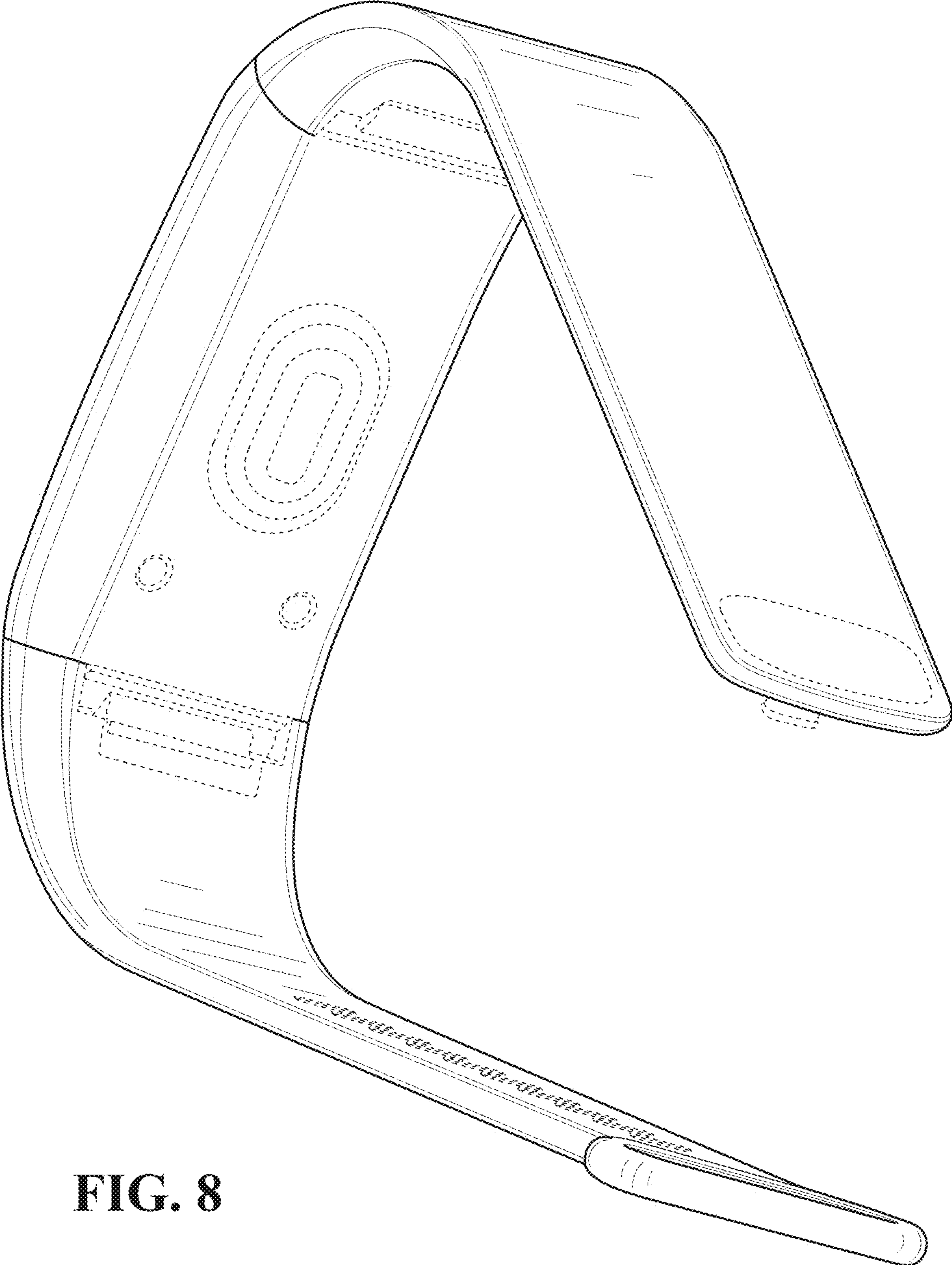
