The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

FIG. 6 is a second image thereof;

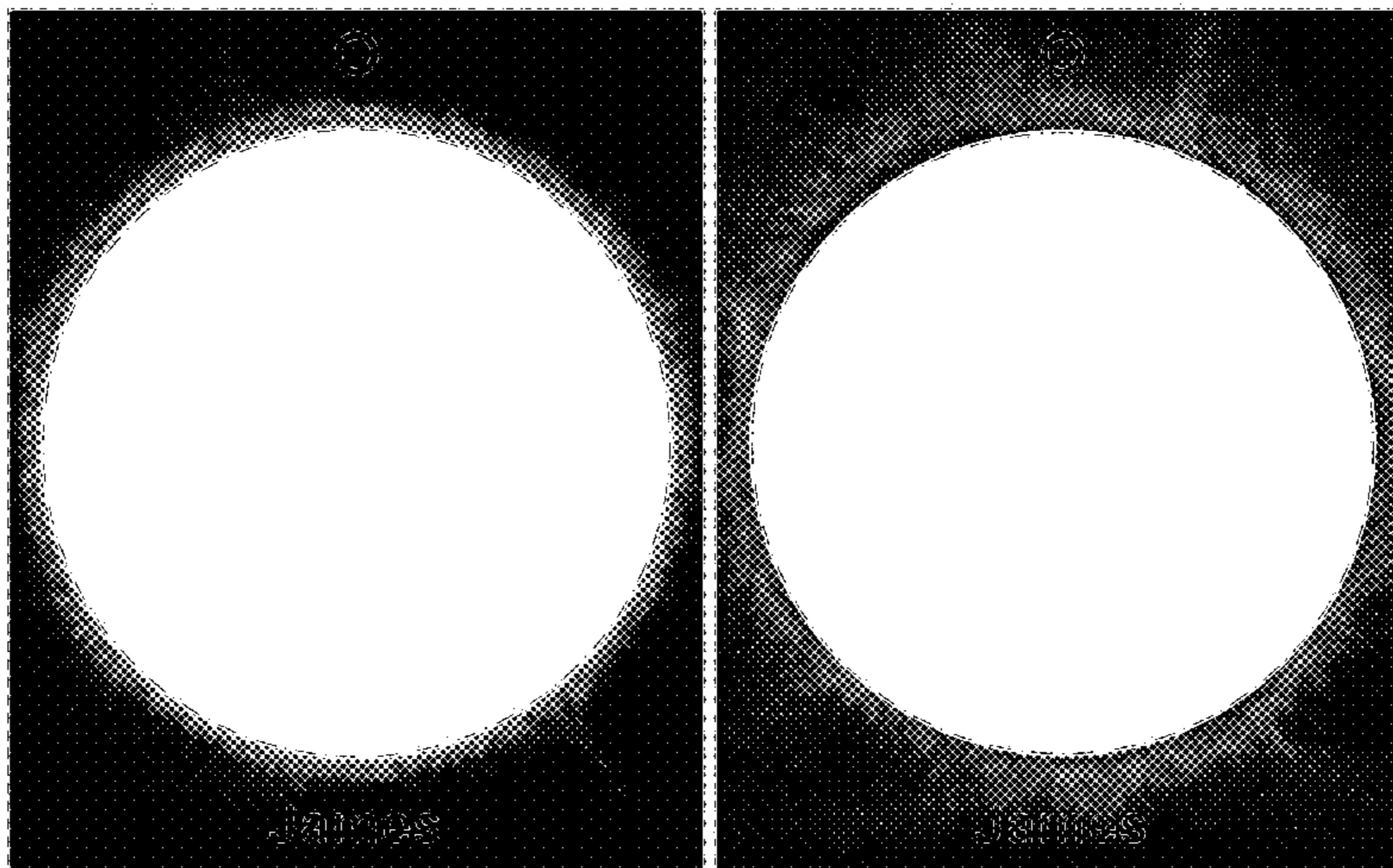
FIG. 7 is a third image thereof; and,

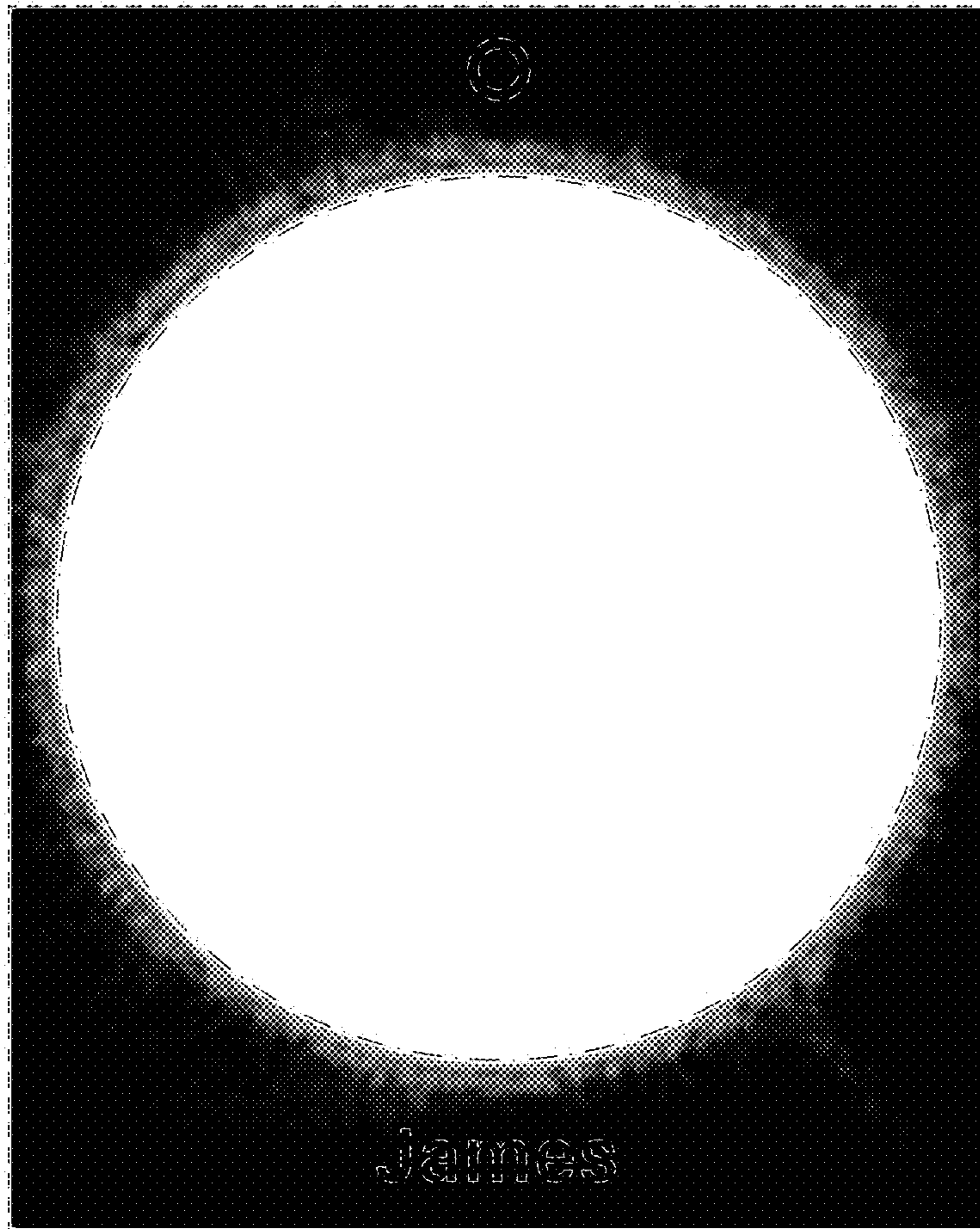

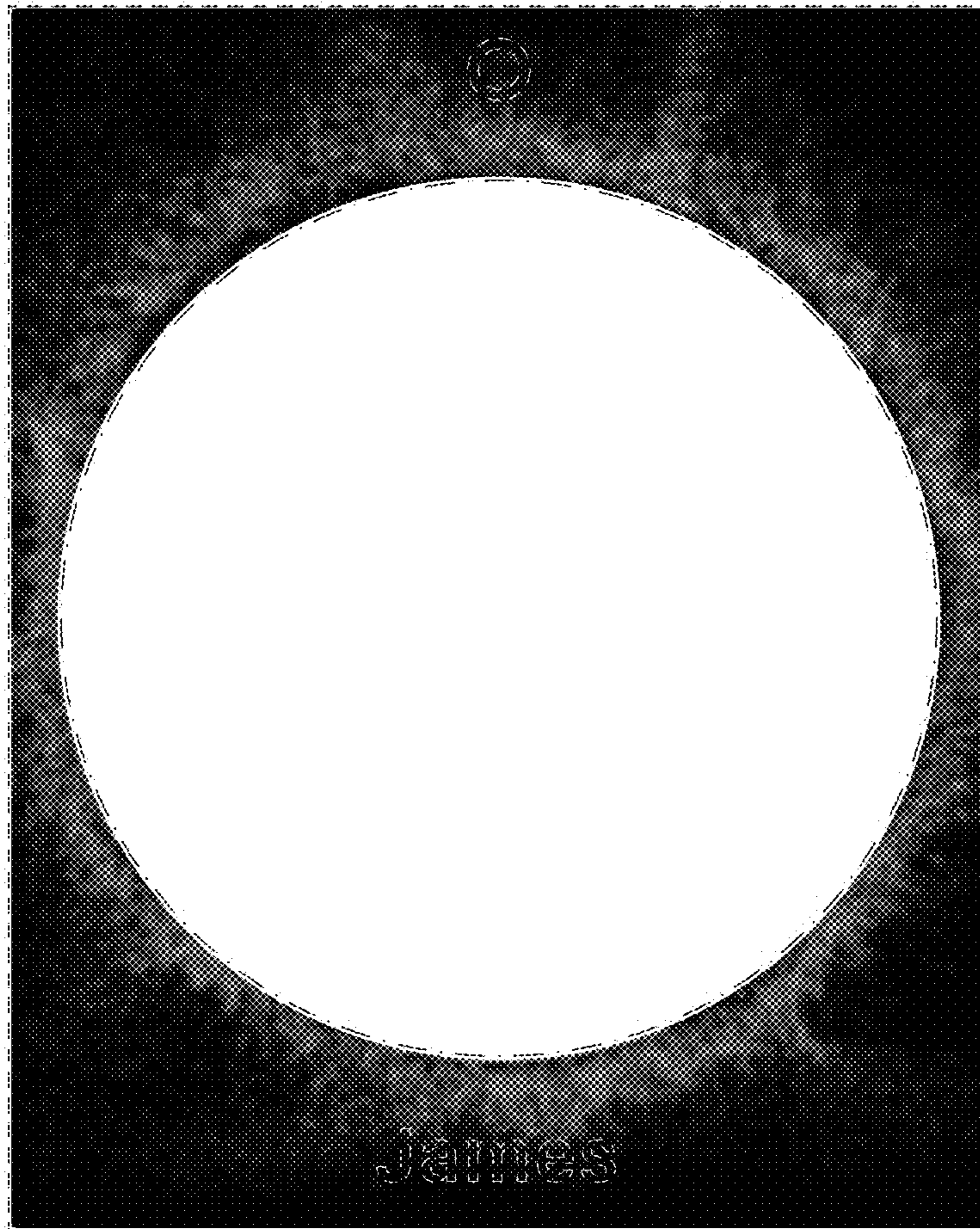

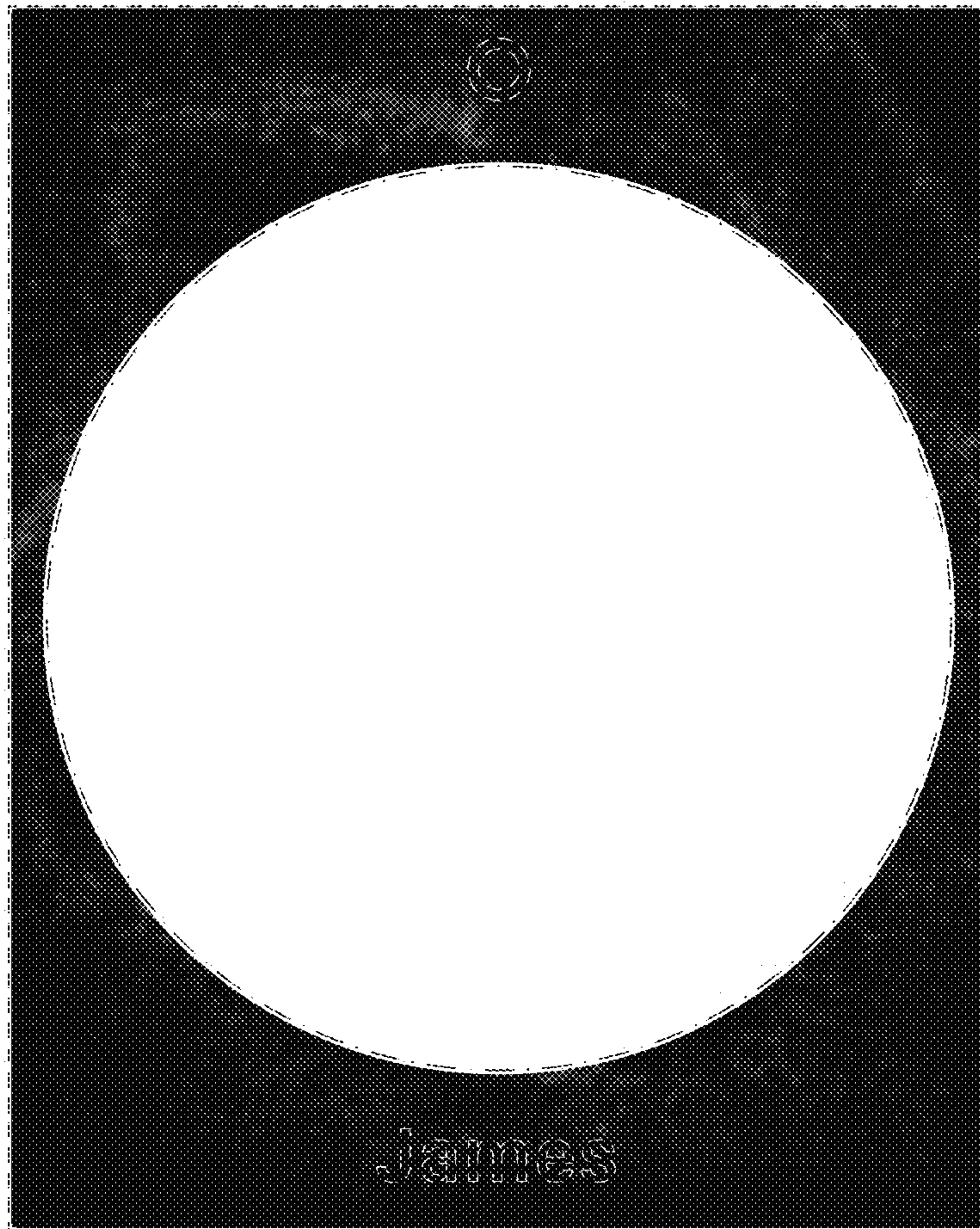

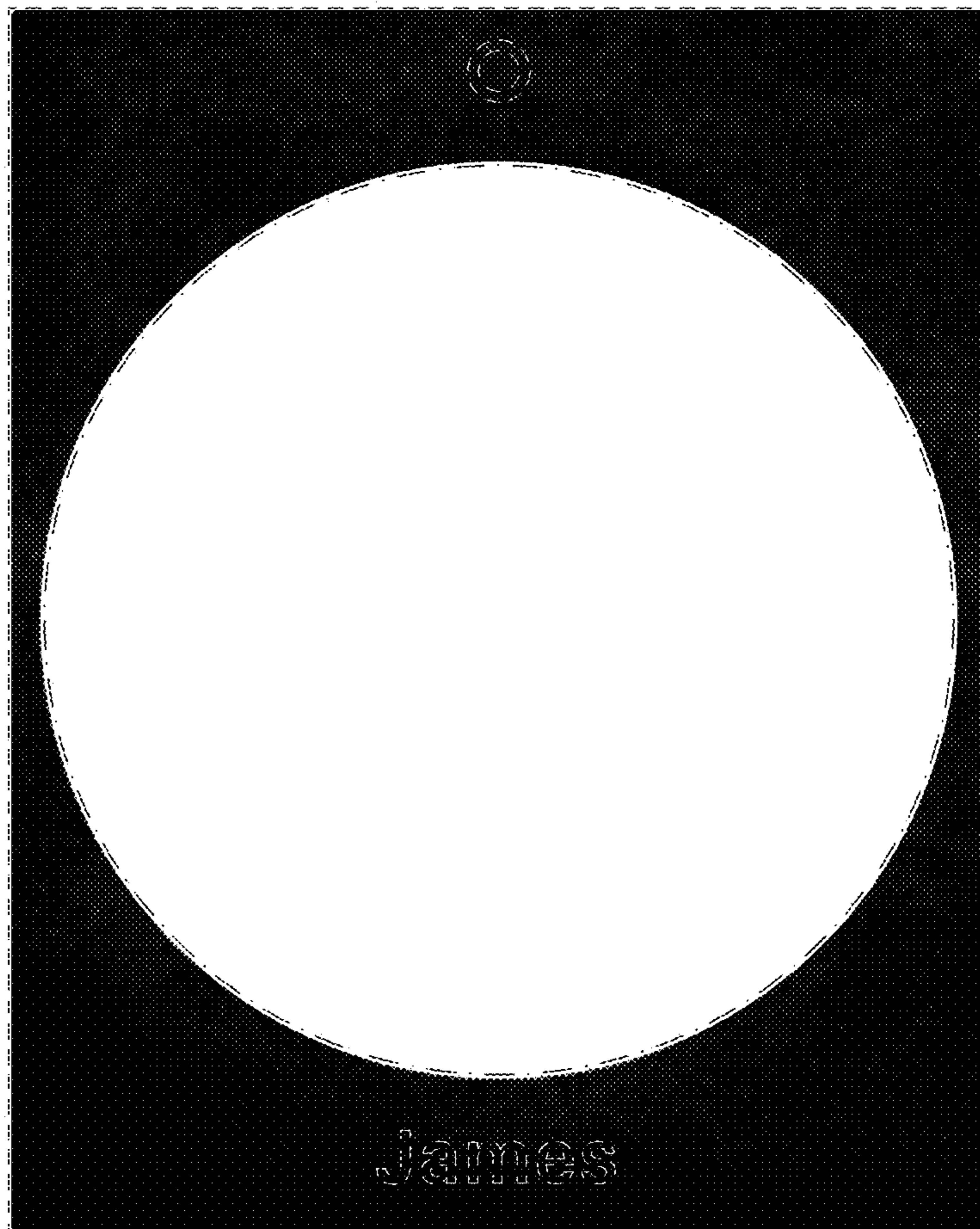

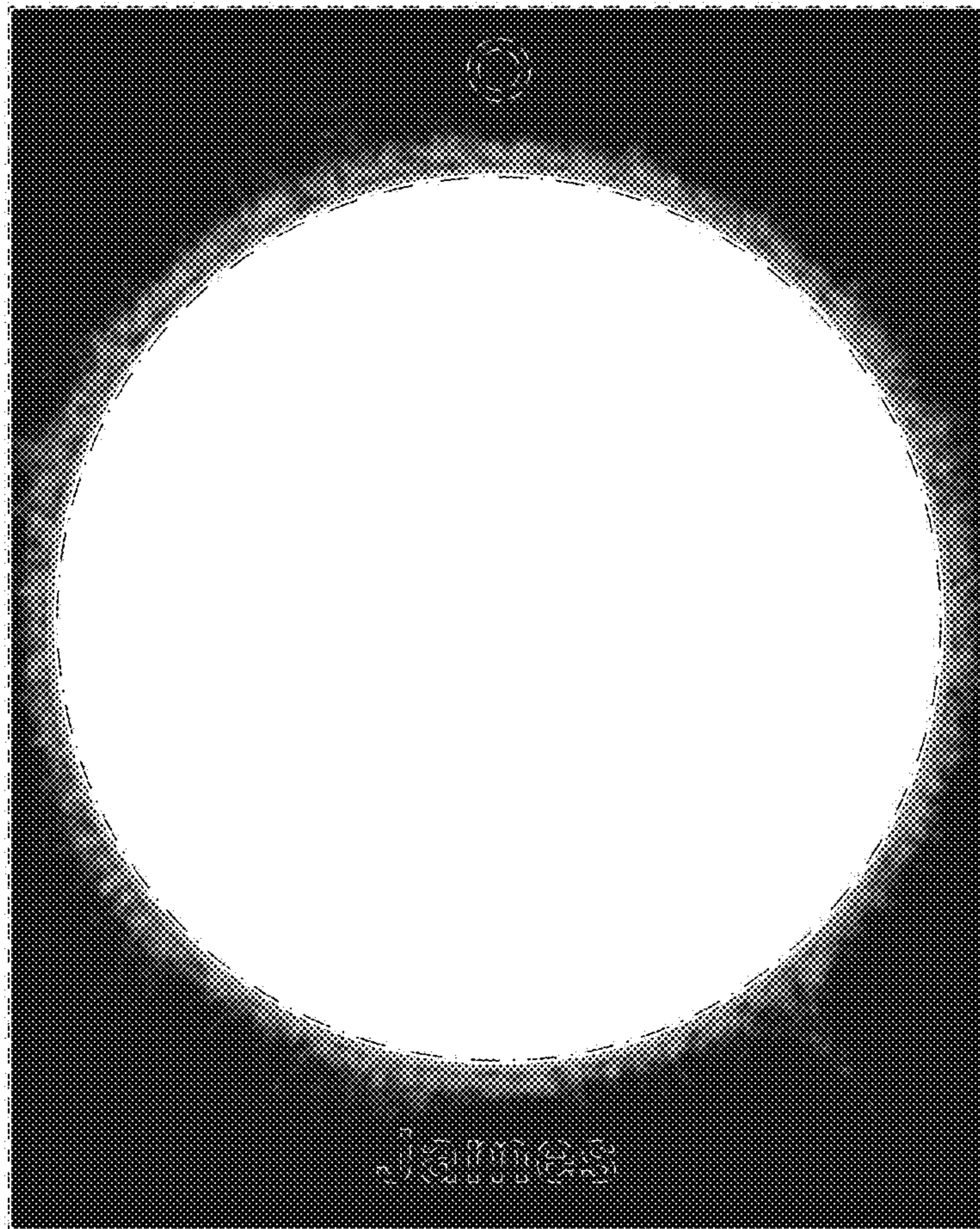

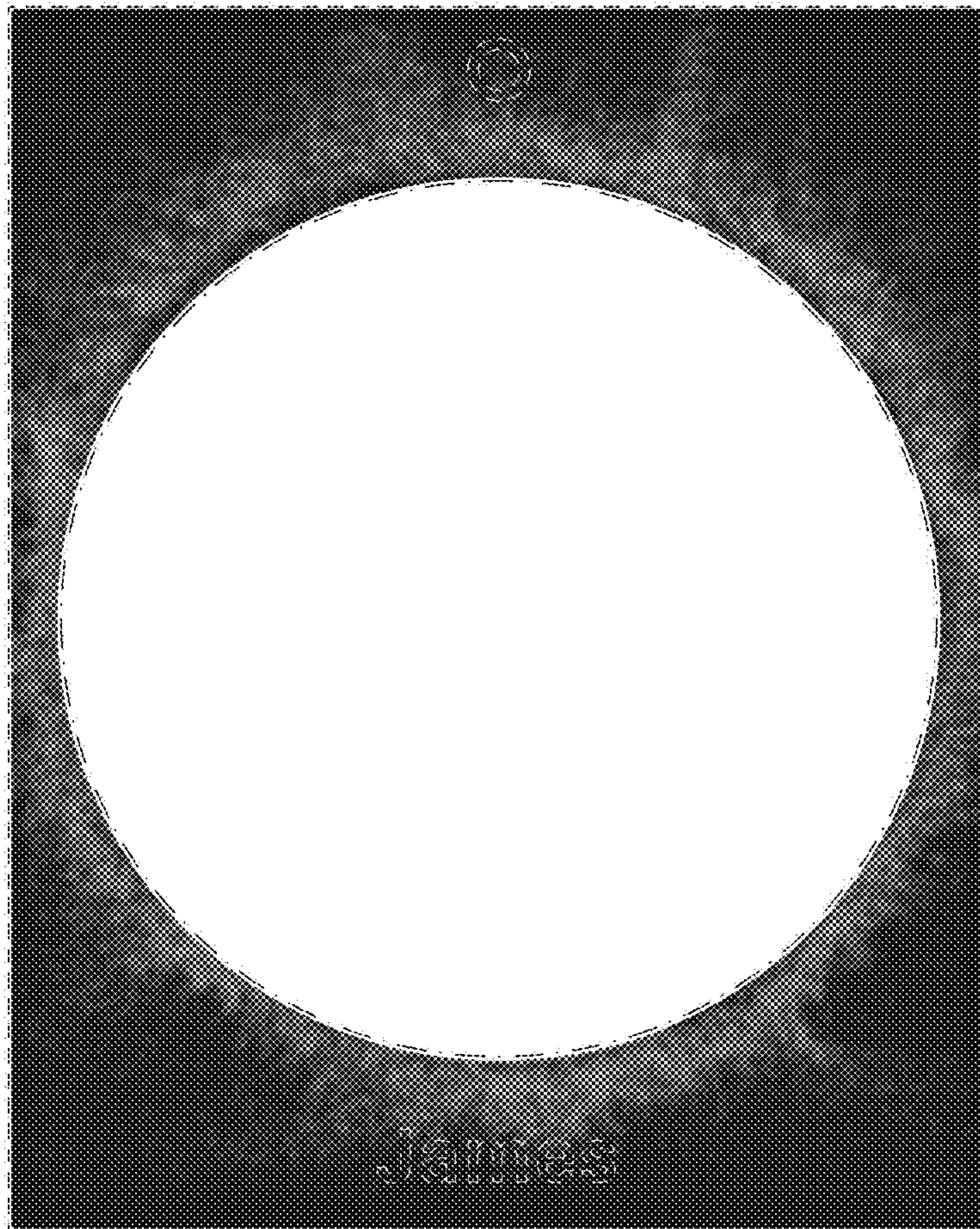

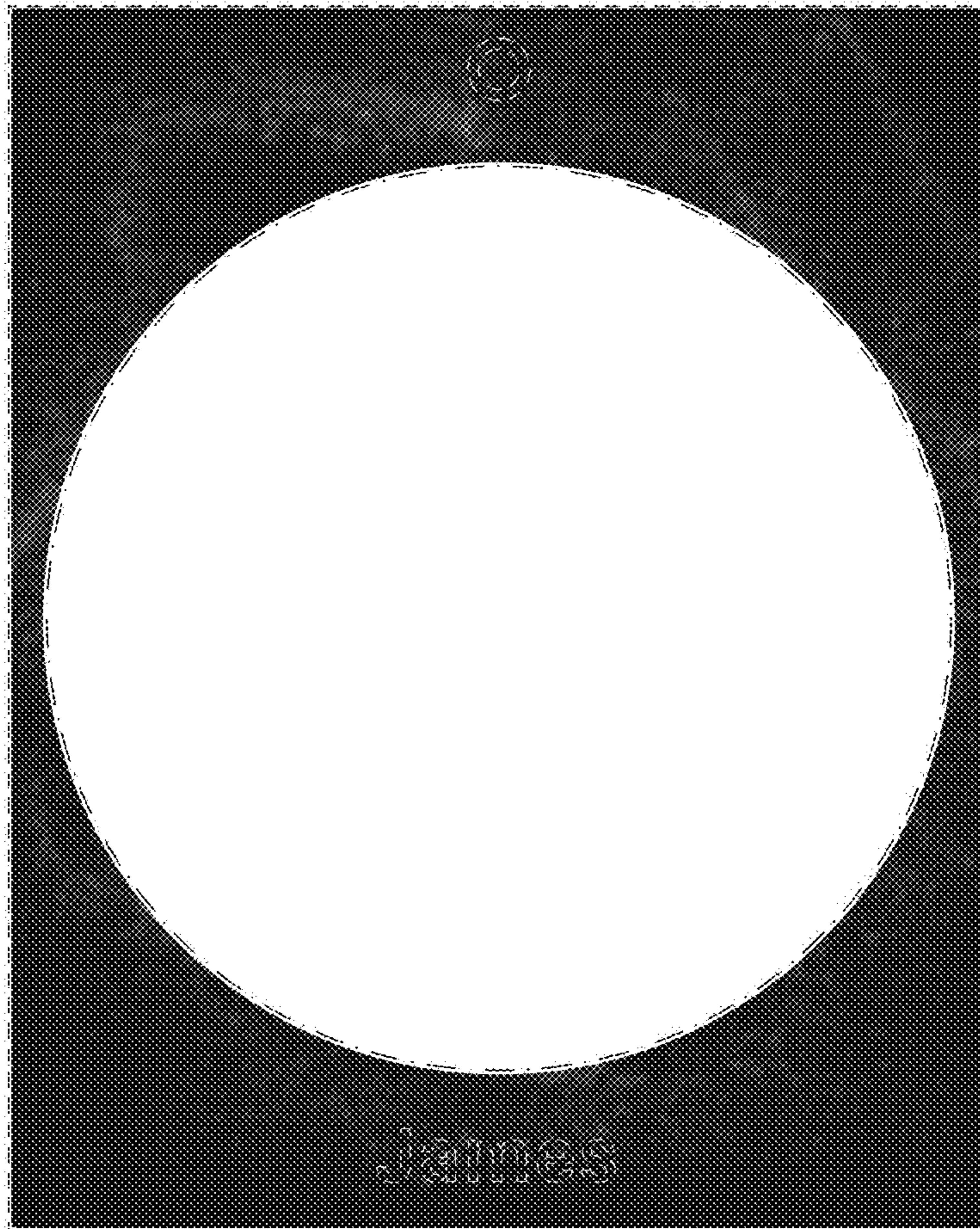

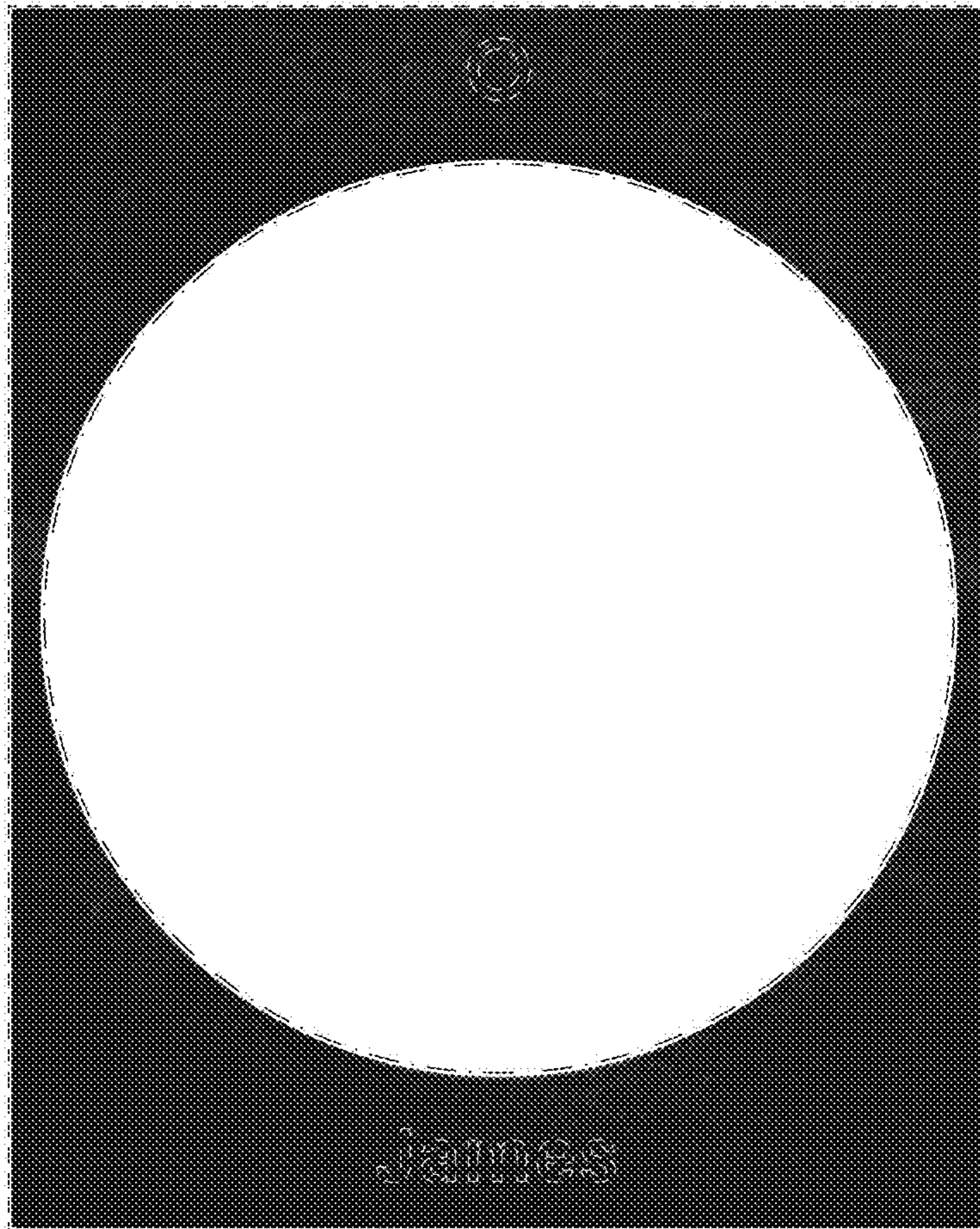
