thereof.

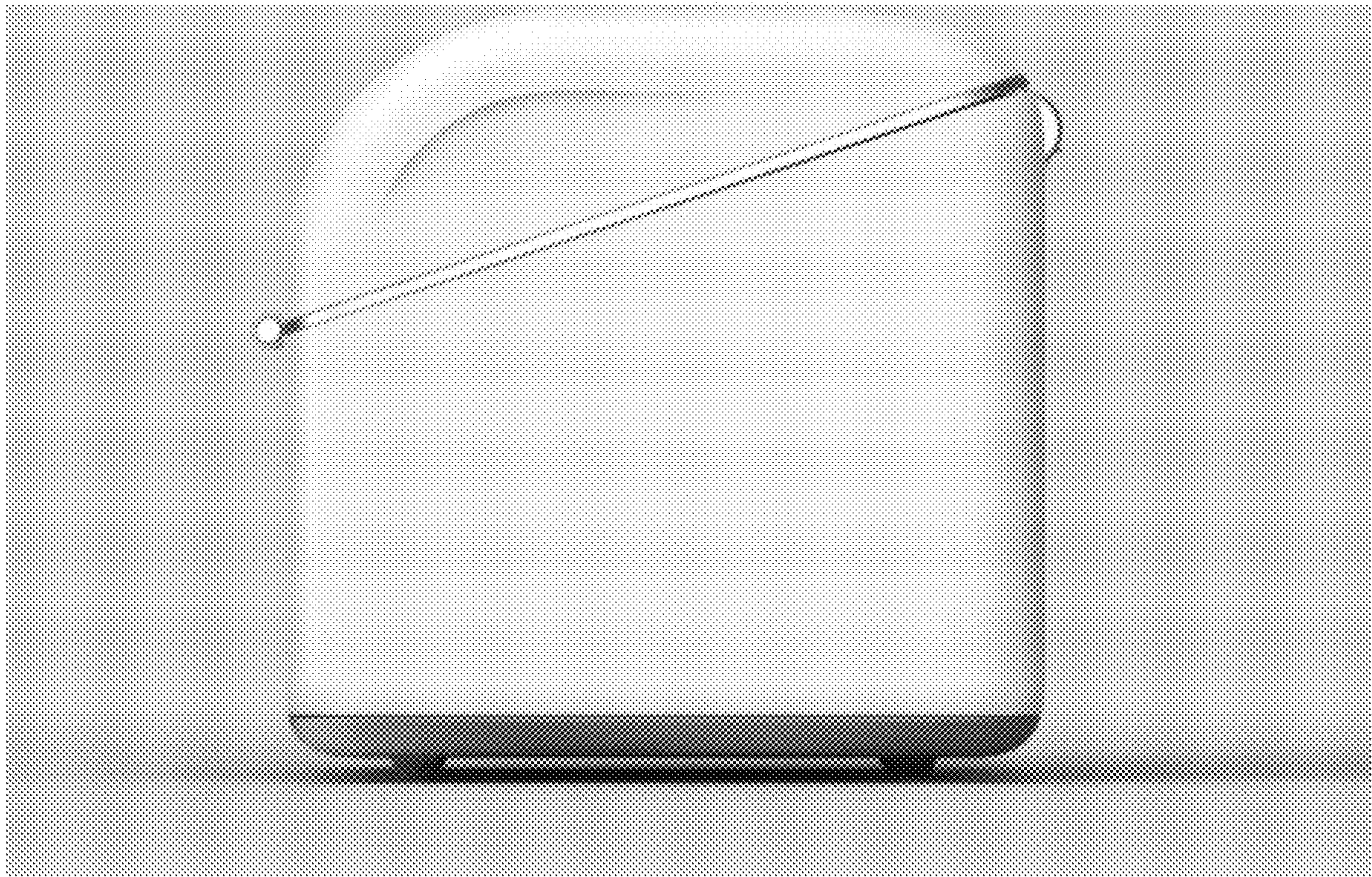

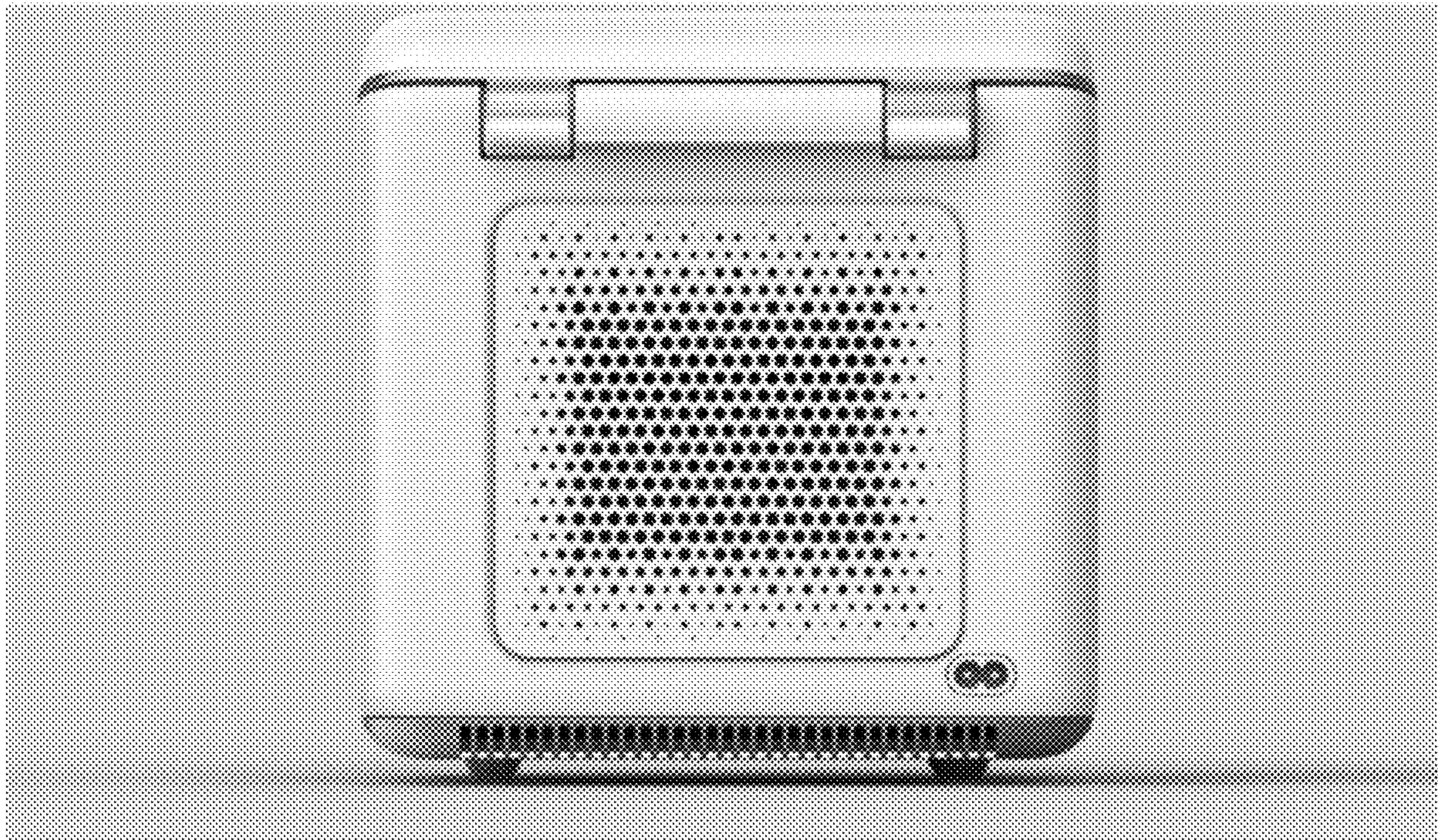

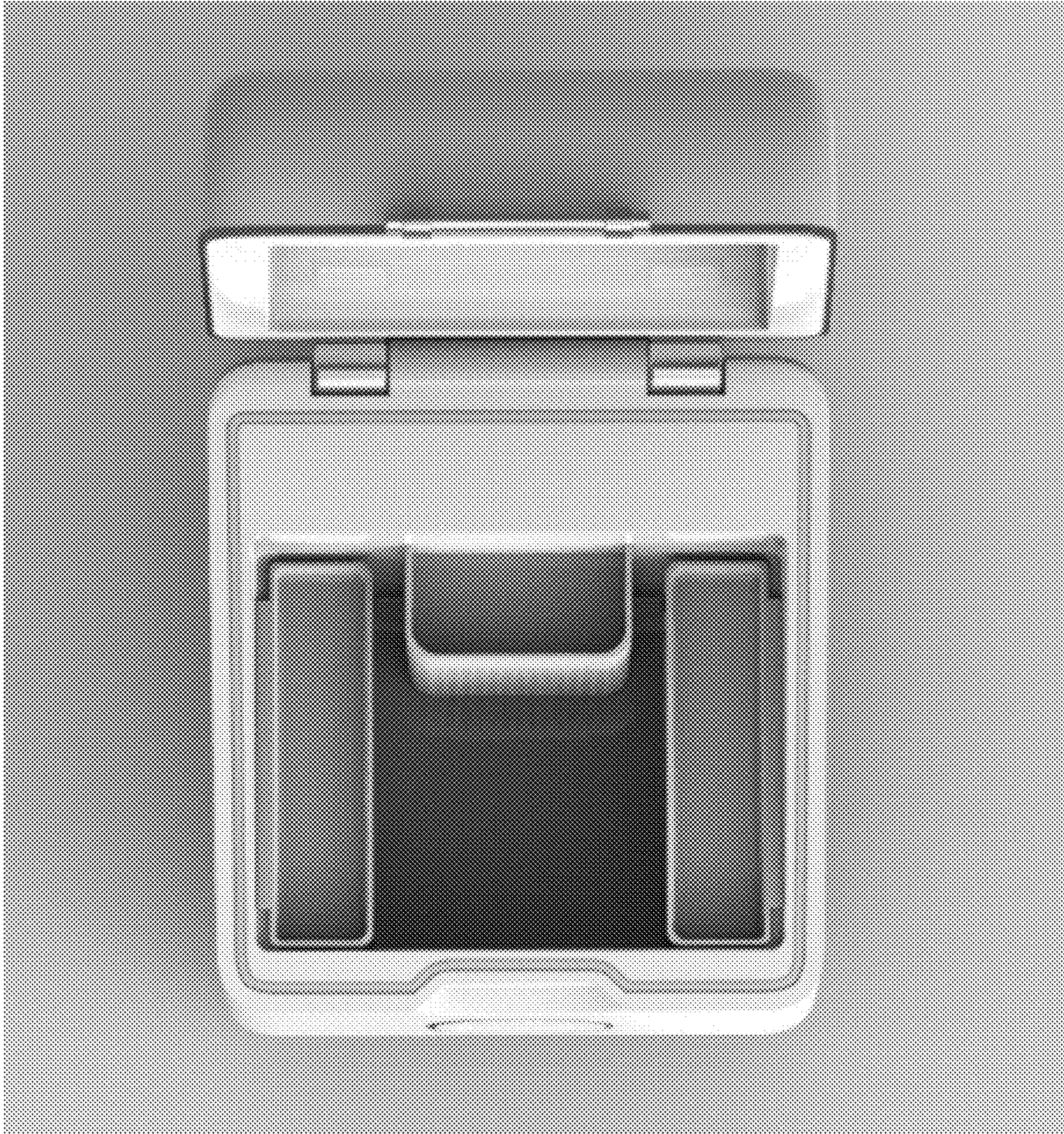
