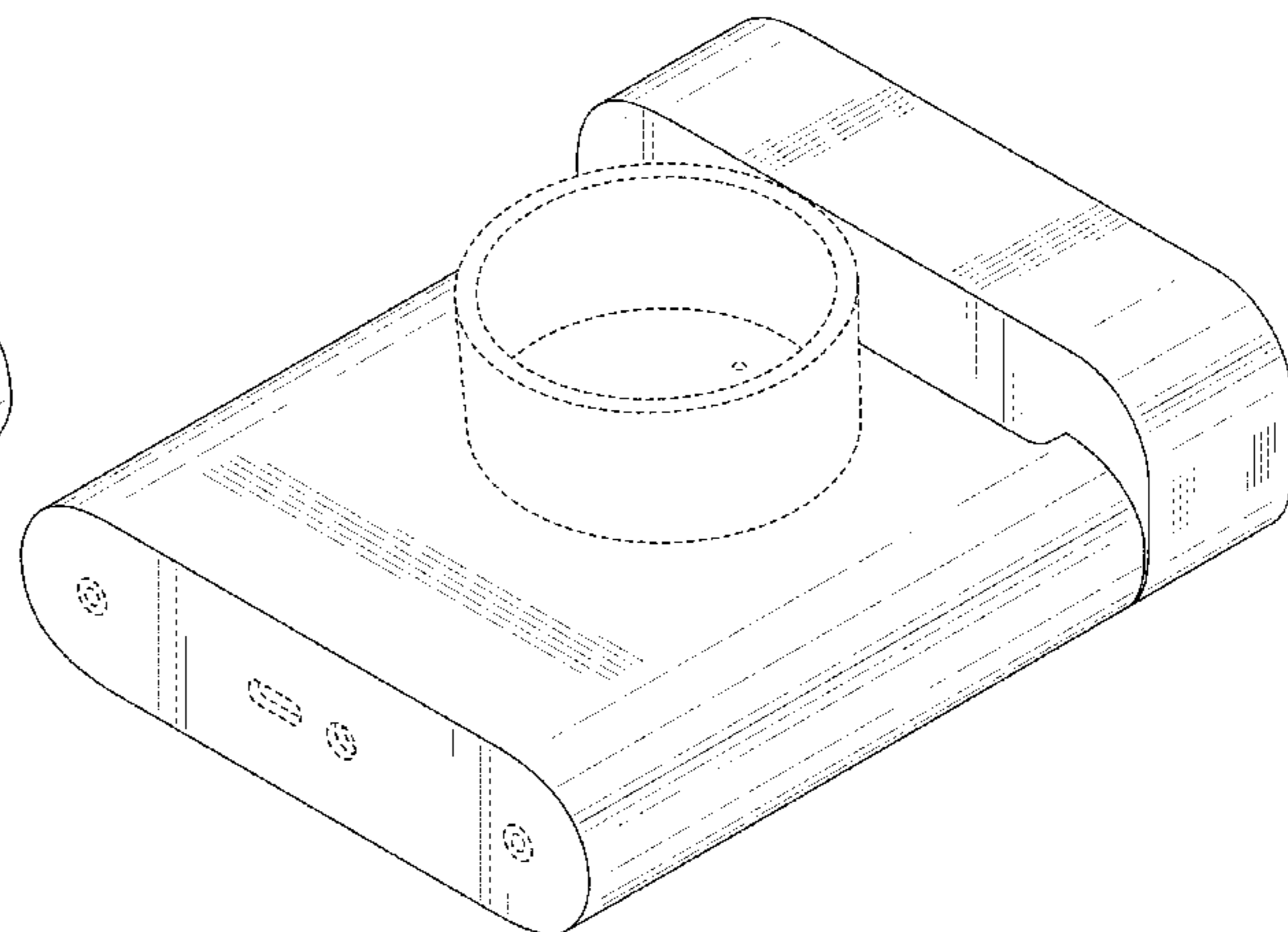
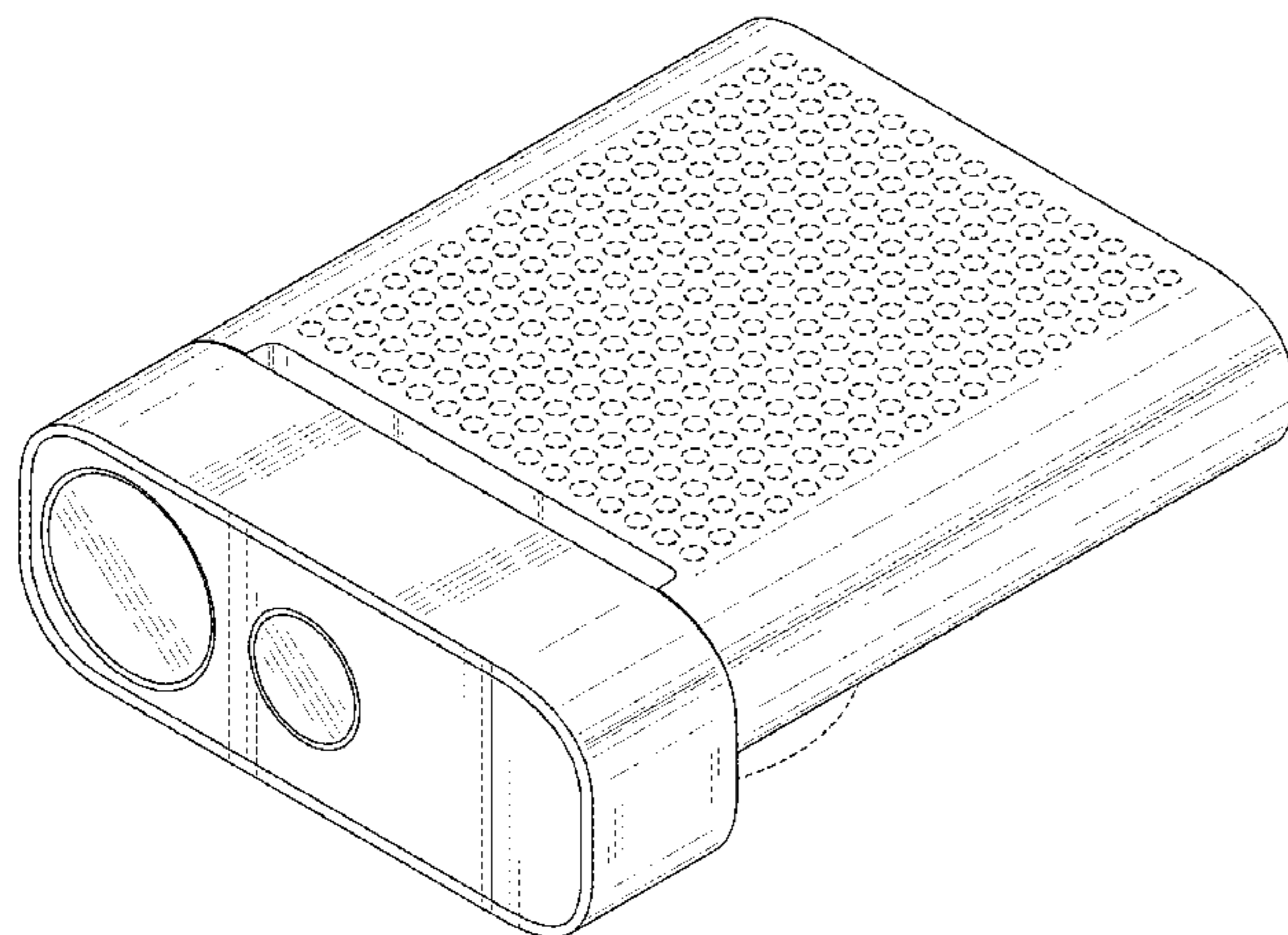
The ornamental design for a camera, as shown and described.

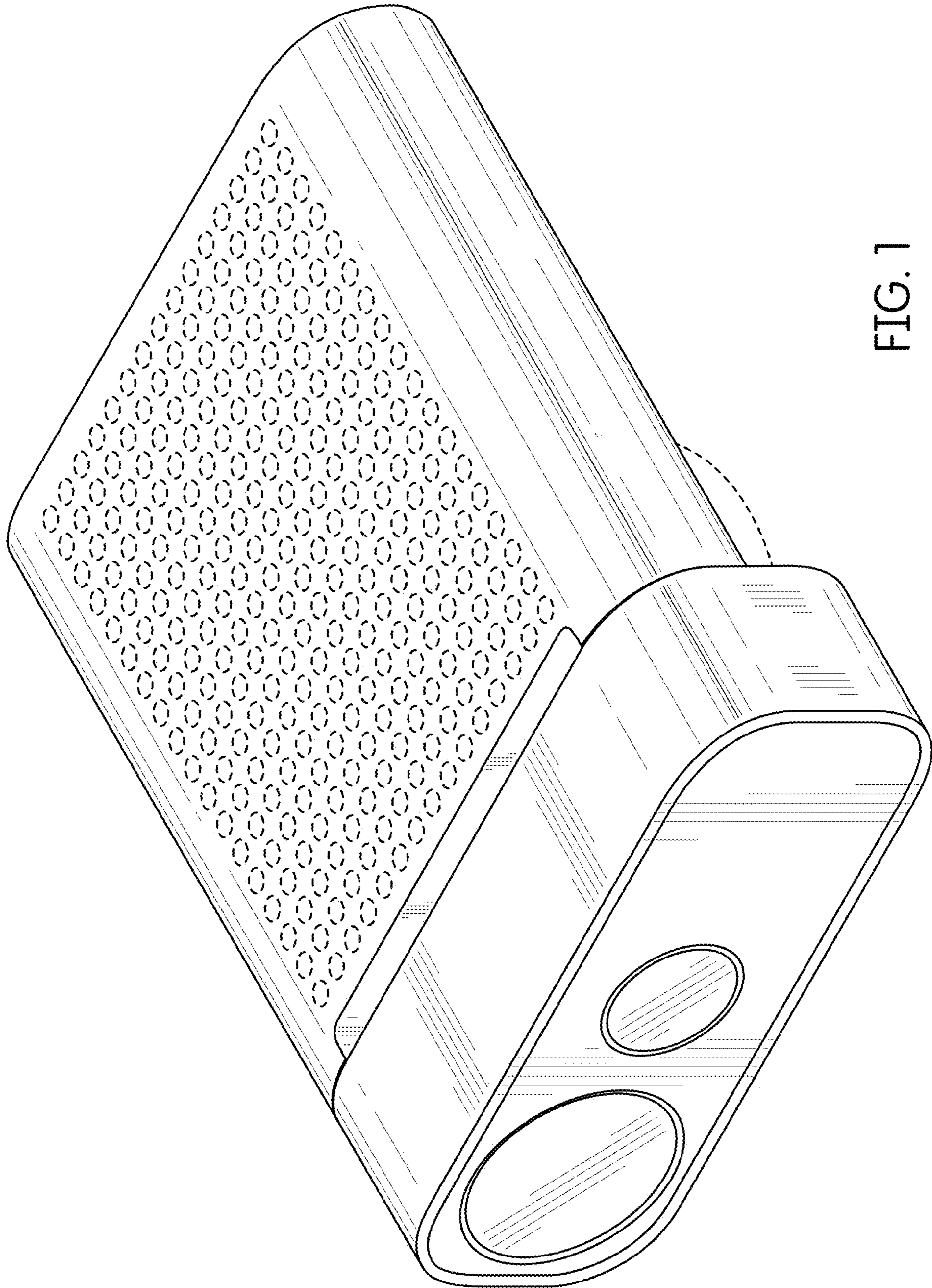

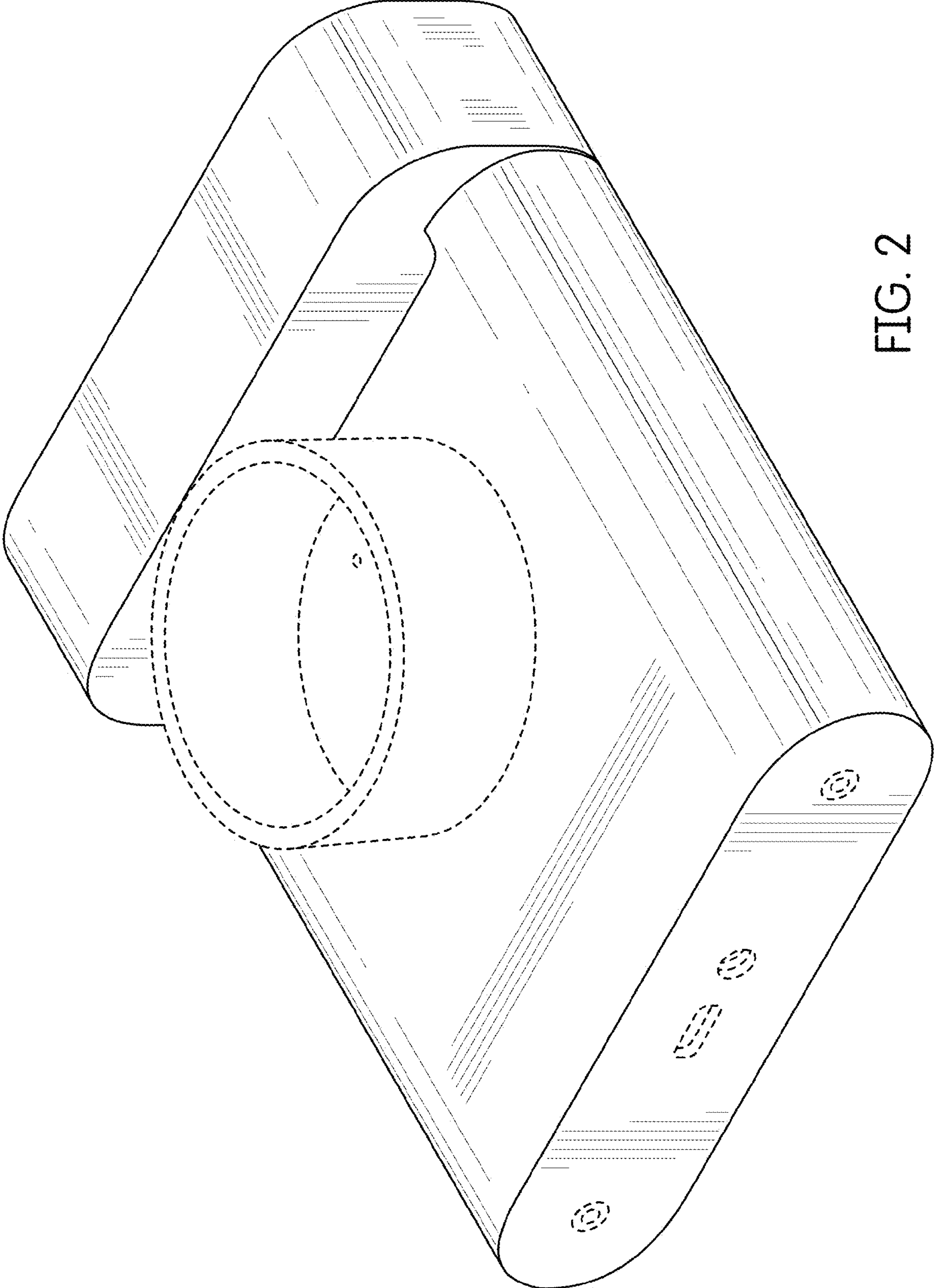

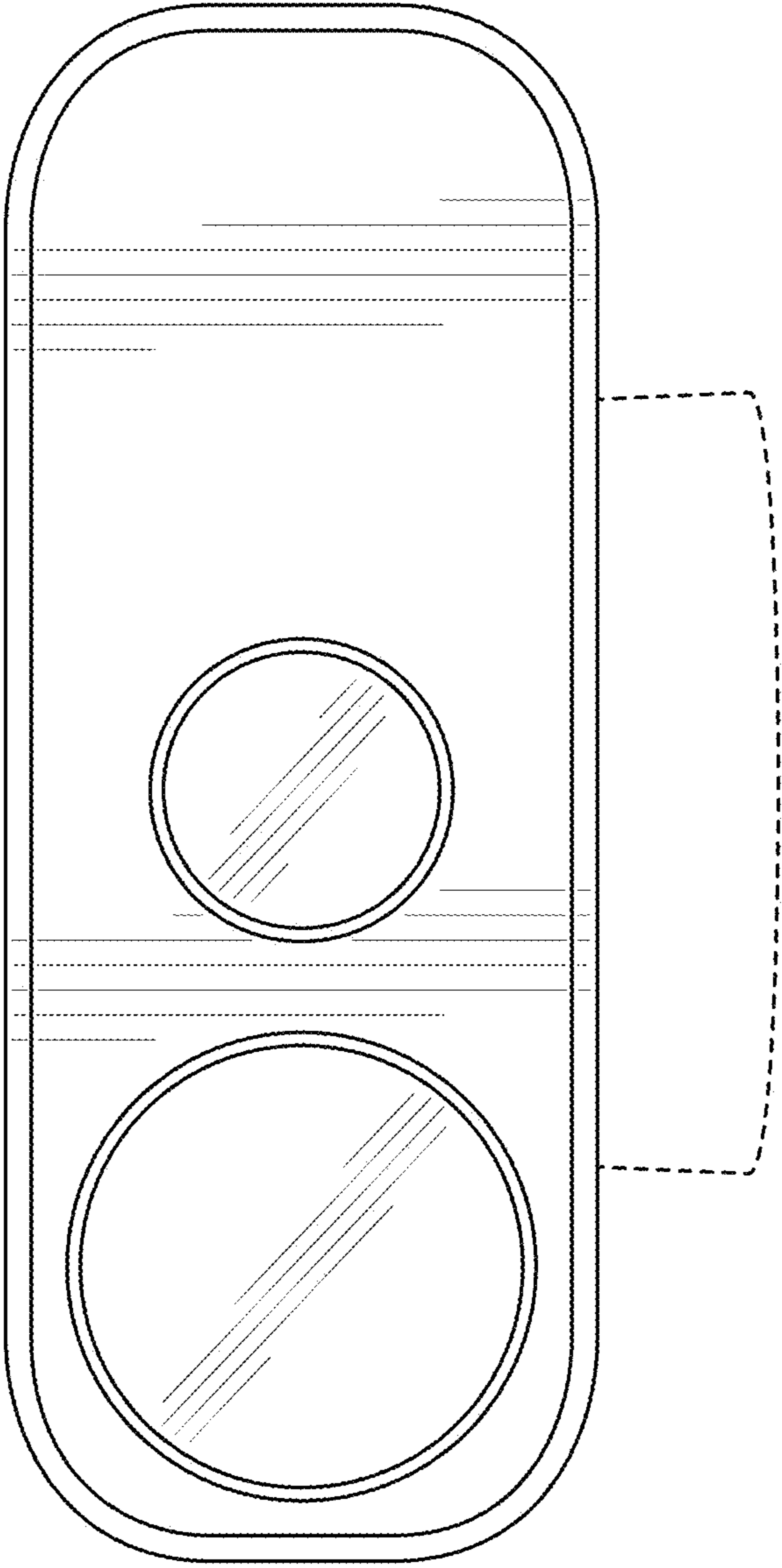

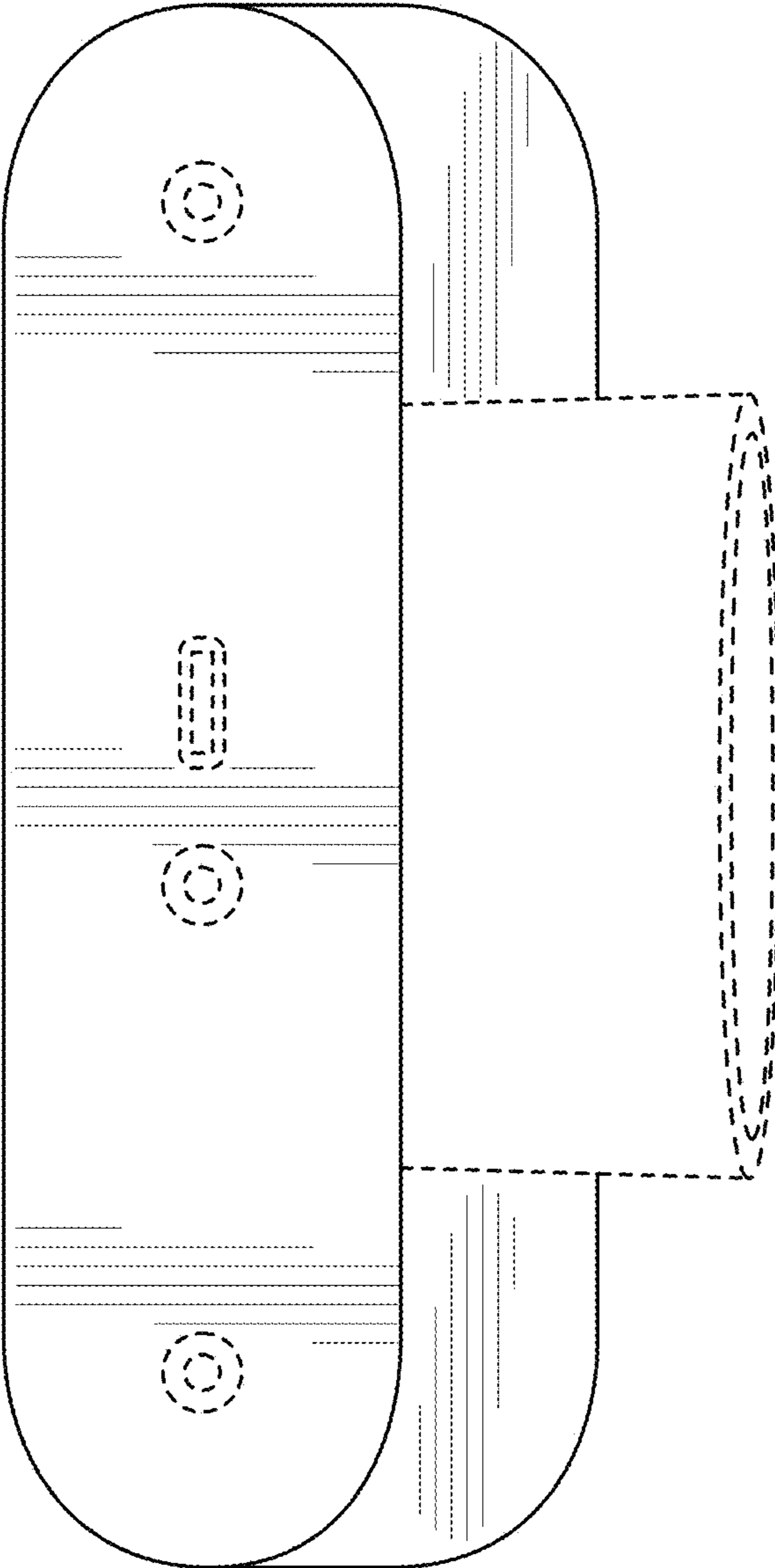

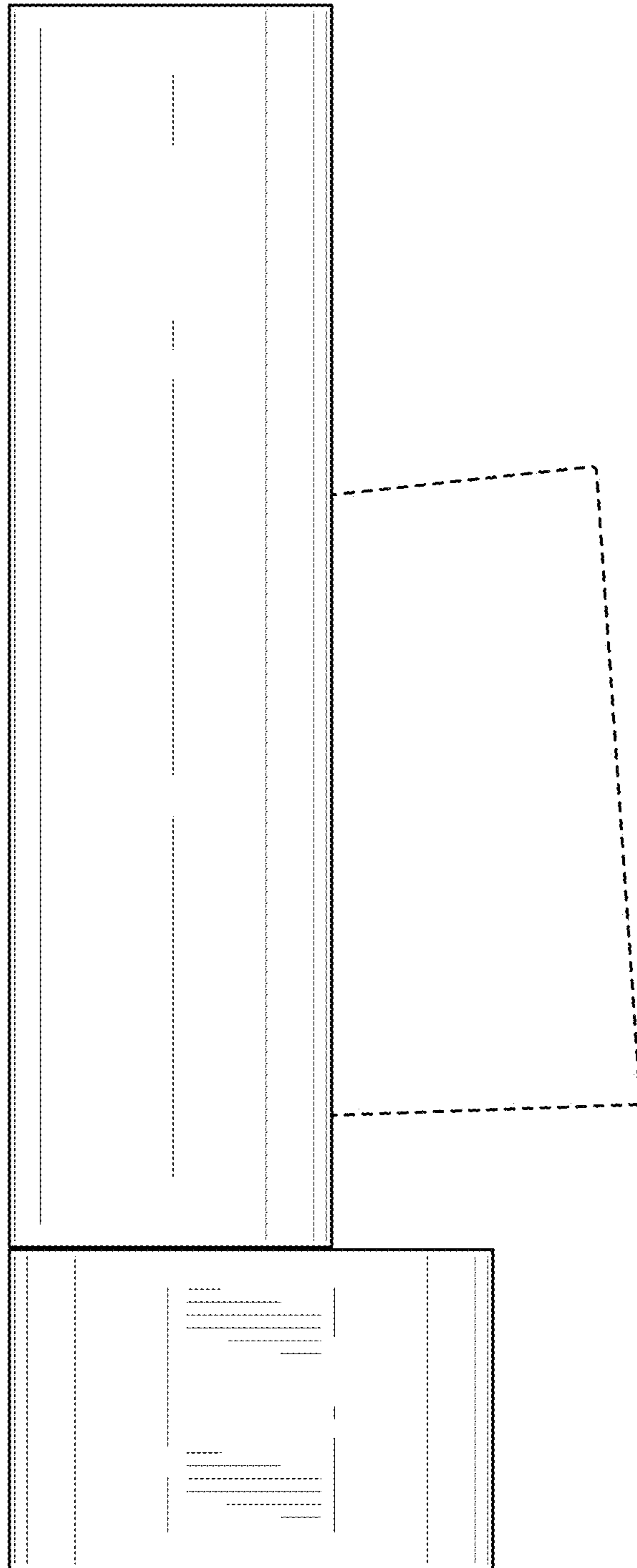

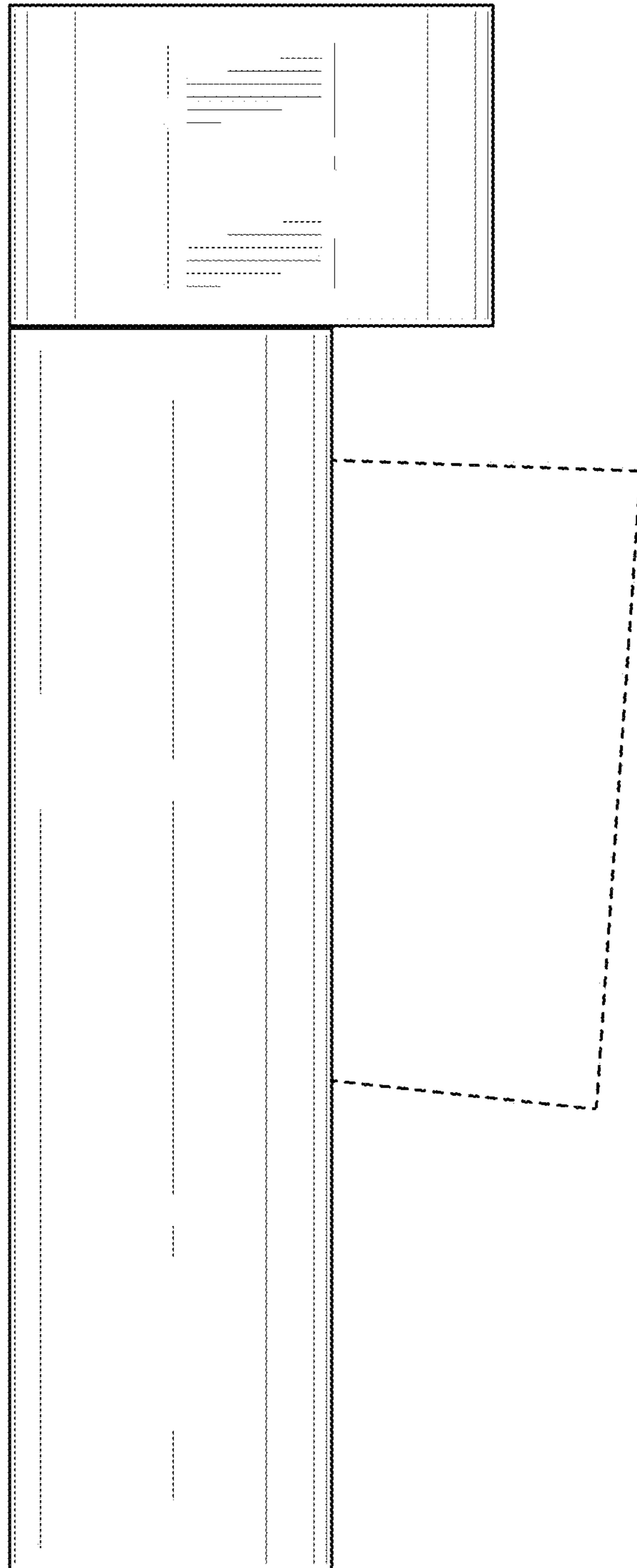

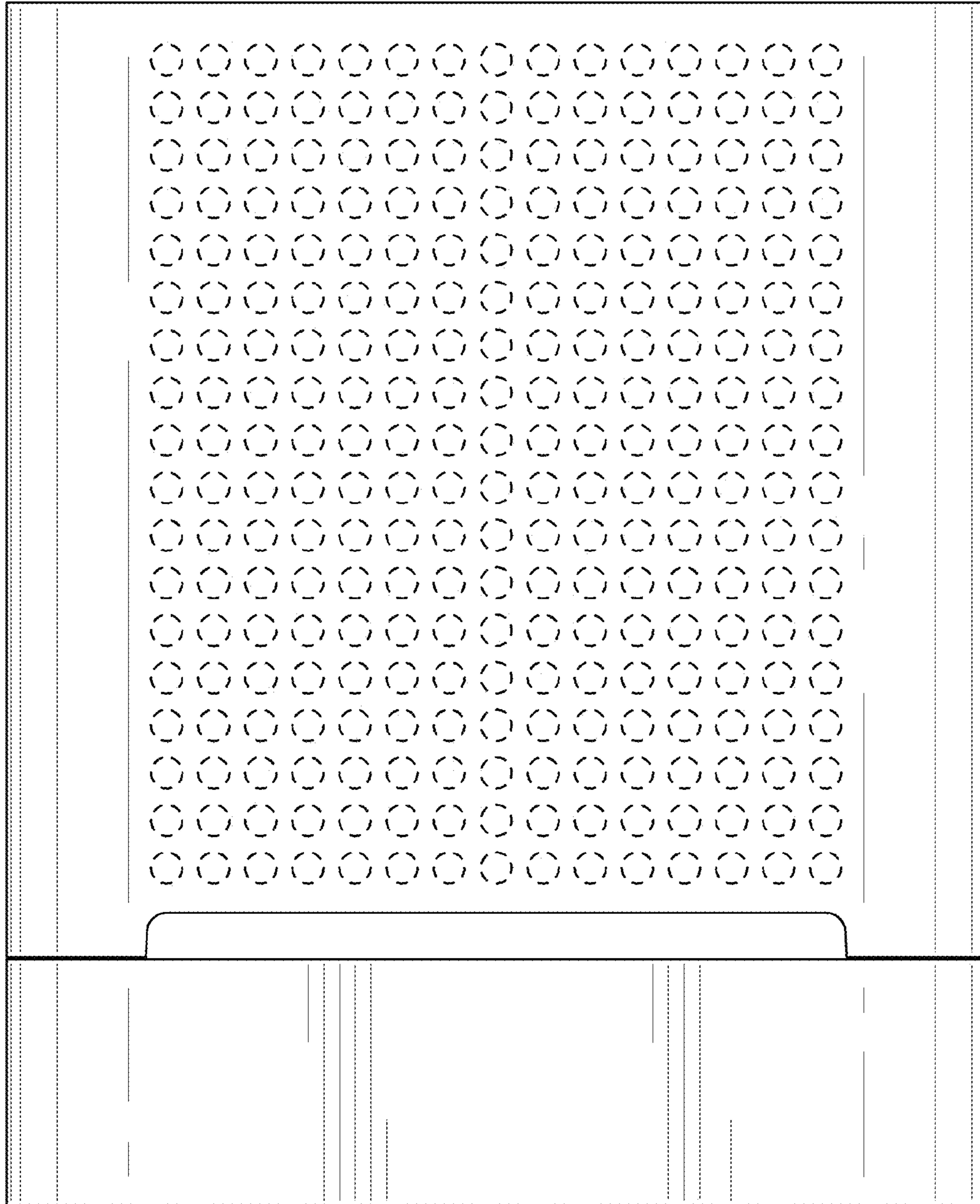

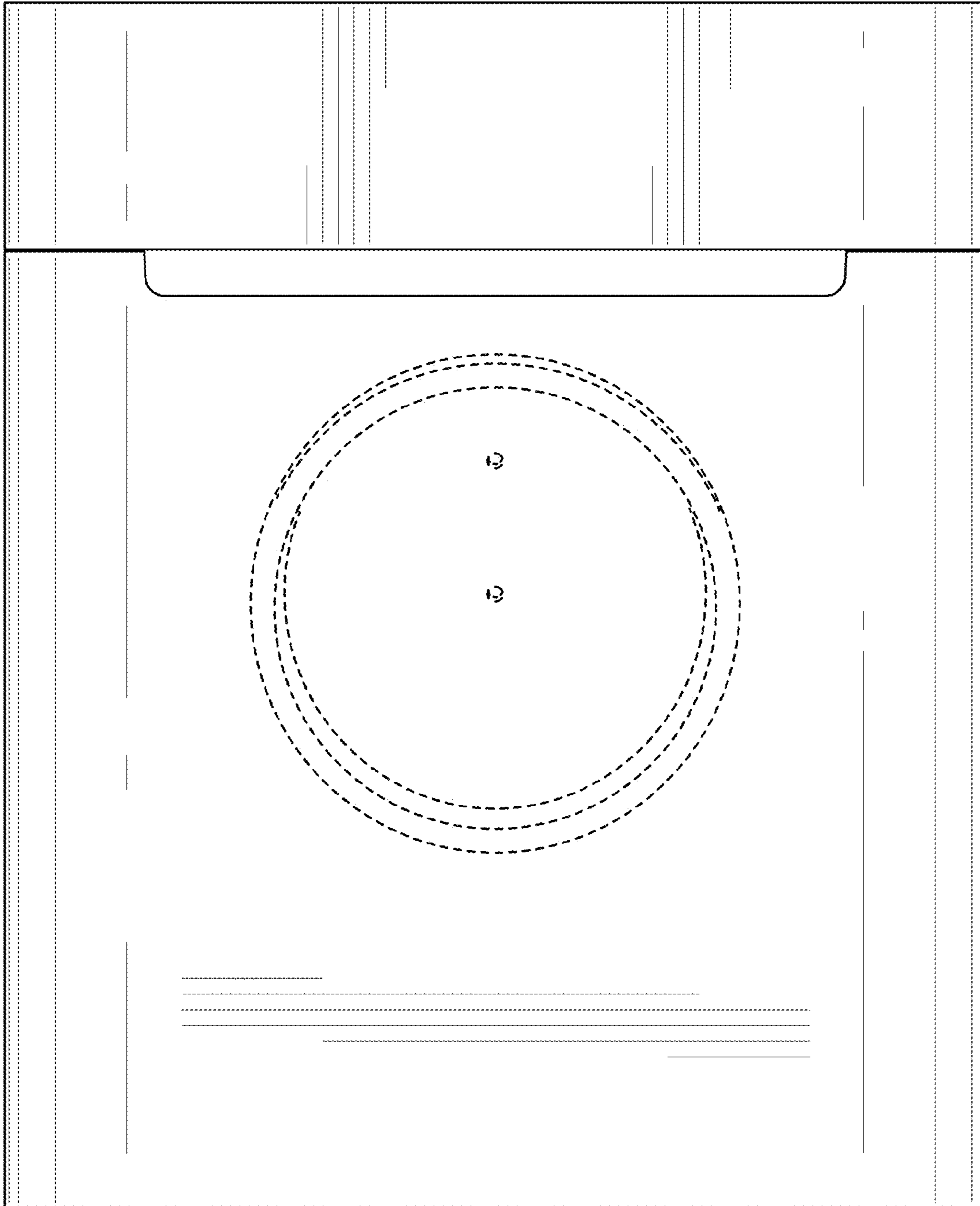
