FIG. 7 is a perspective view a day box shown separately for completeness of illustration;

FIG. 8 is an alternative perspective view thereof;

FIG. 10 is an enlarged perspective view of the month box shown separately for completeness of illustration, showing sliders displayed with remaining sliders stored behind;

FIG. 11 is a front view of the month box sliders shown in FIG. 10;

FIG. 12 is a front view of the year number sliders shown in FIG. 10; and,

FIG. 13 is a rear view of FIG. 11, displaying academia subjects.

The broken lines illustrate portions of the customized storage calendar that form no part of the claimed design.

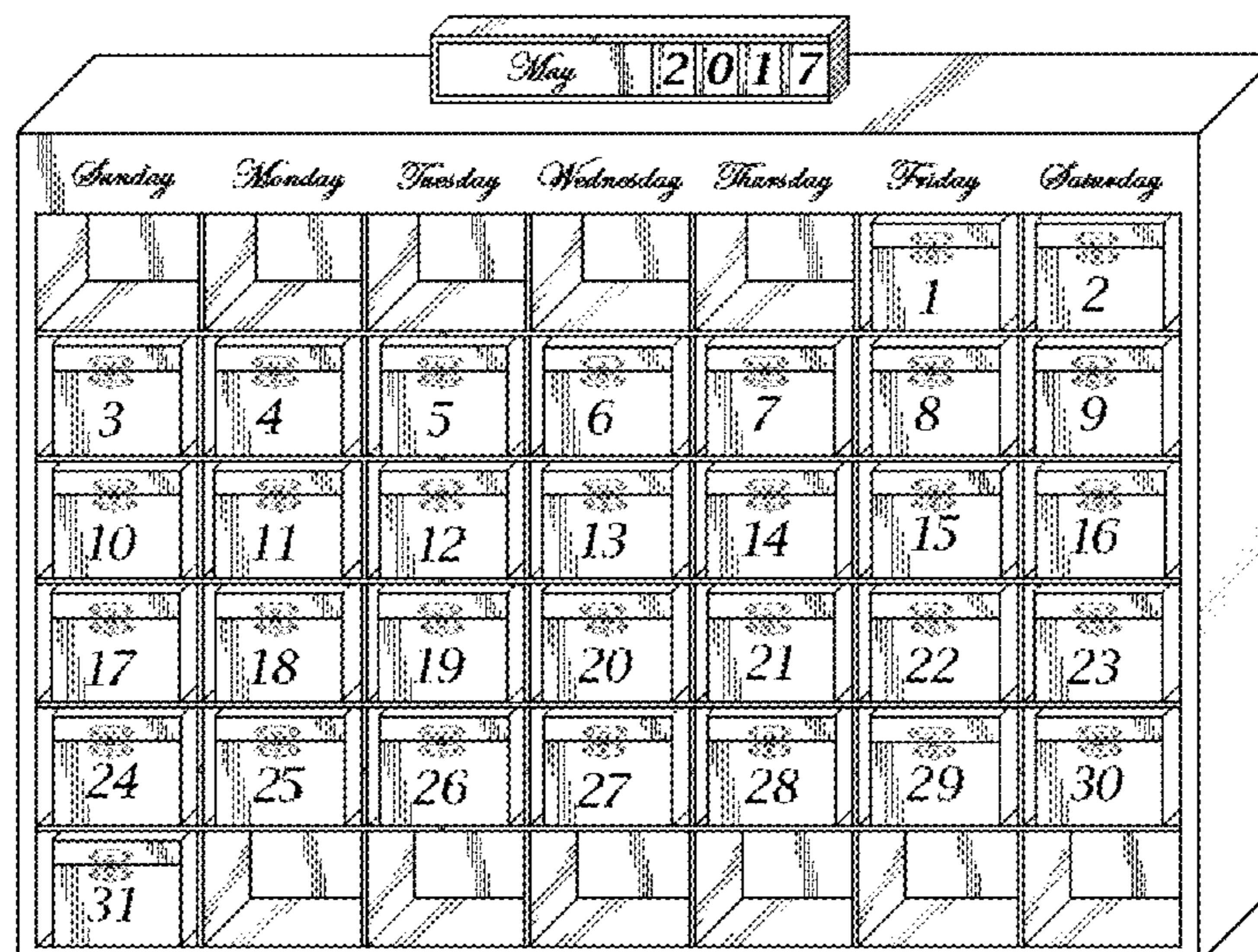
The bottom view of the customizable storage calendar is flat and unornamented.

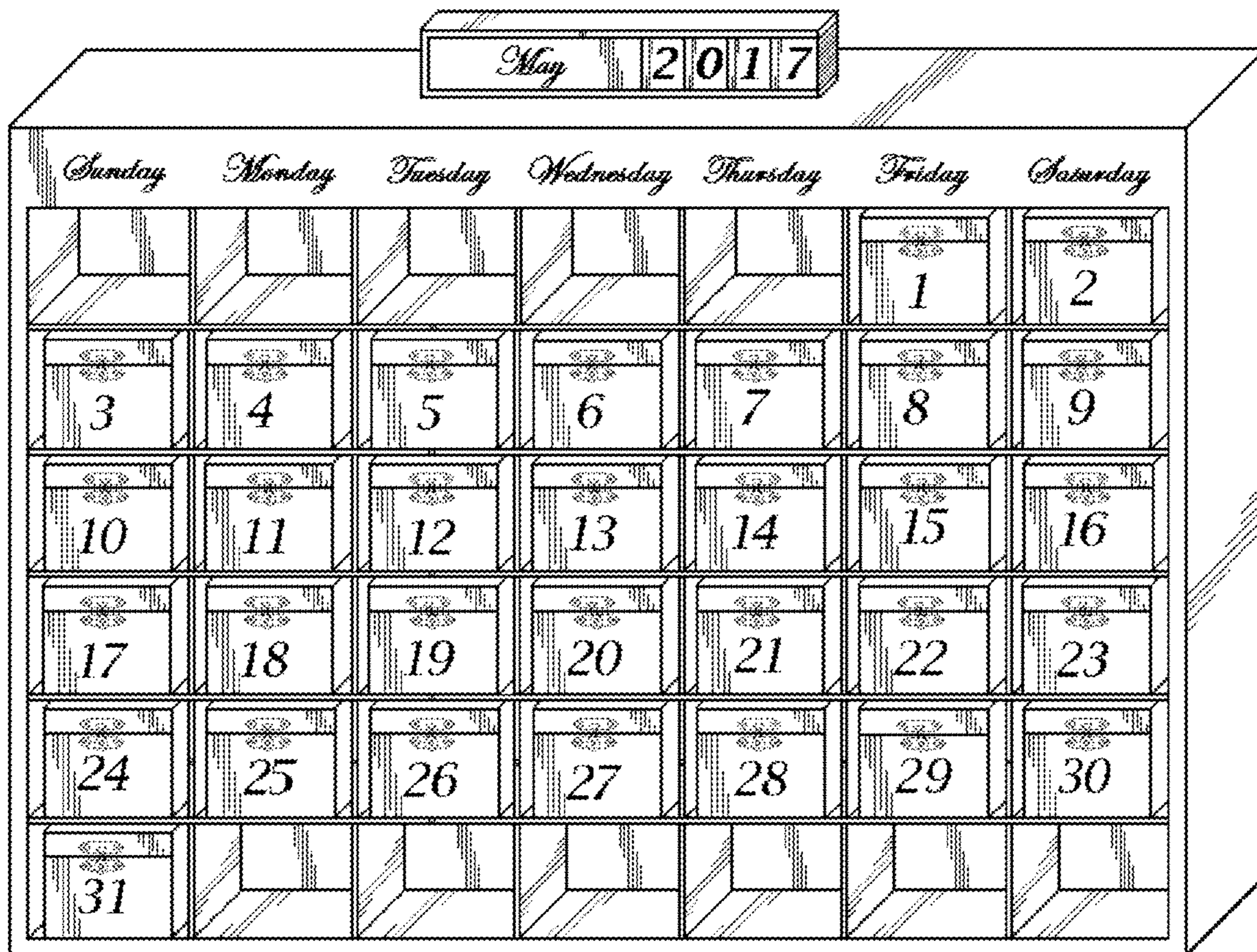

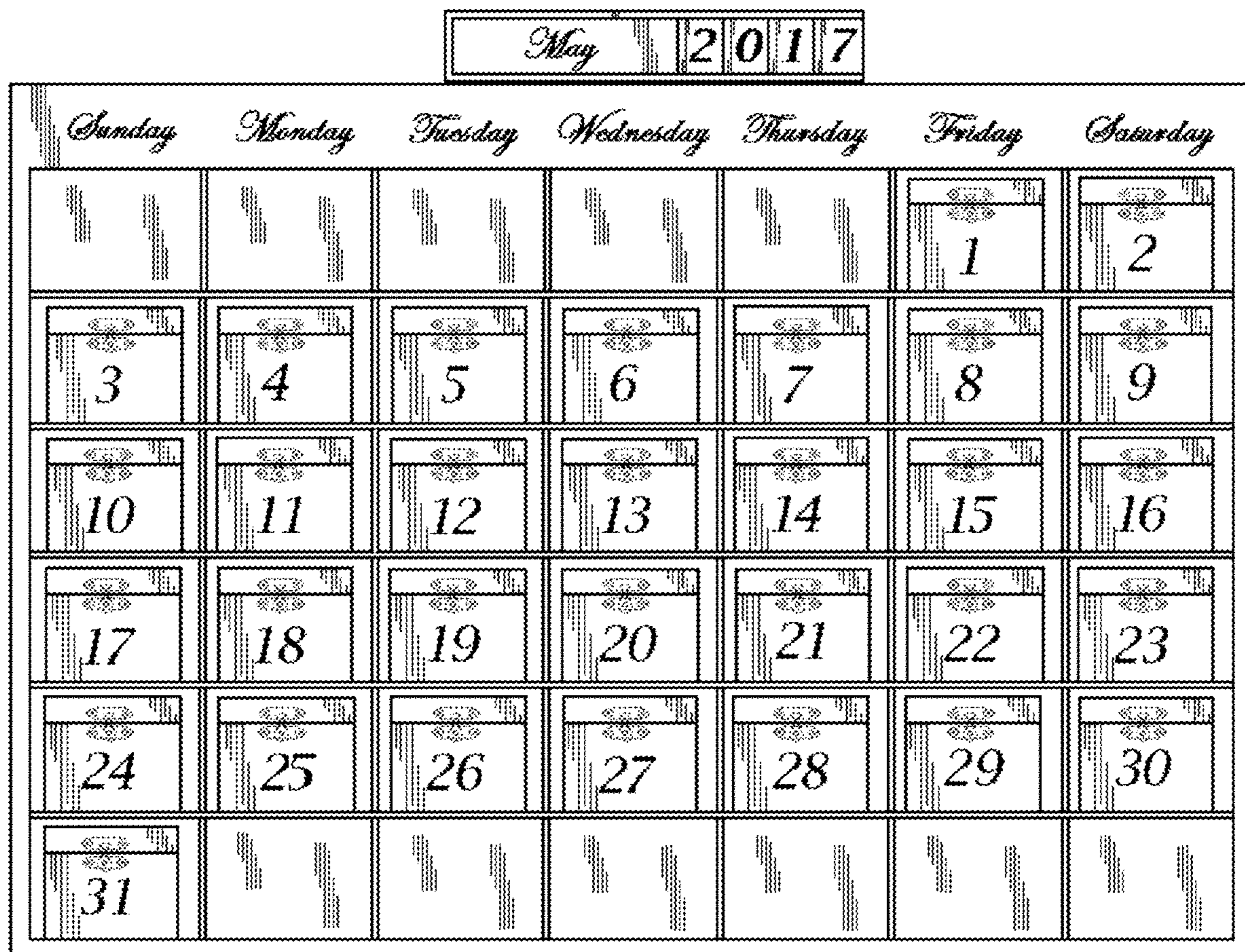

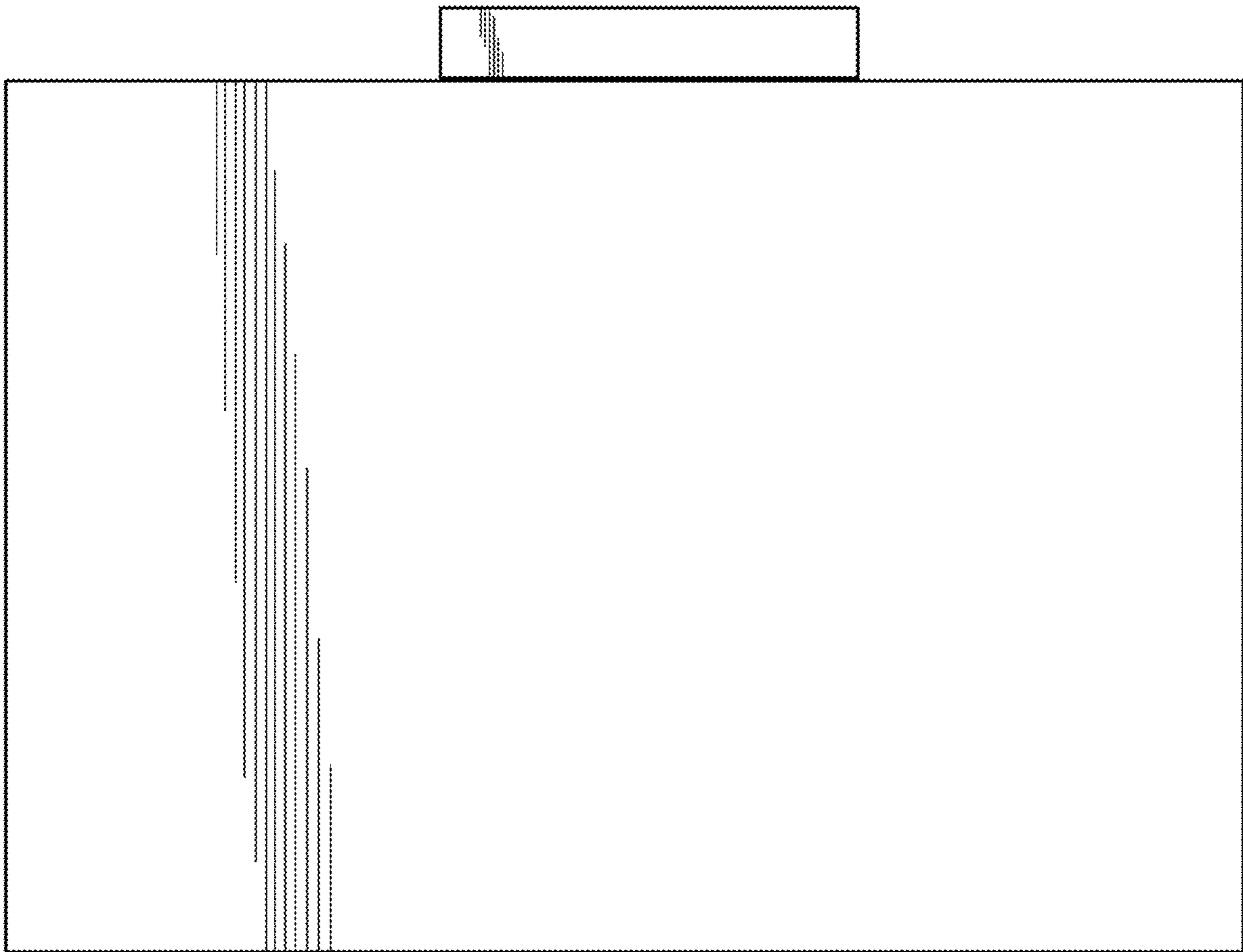

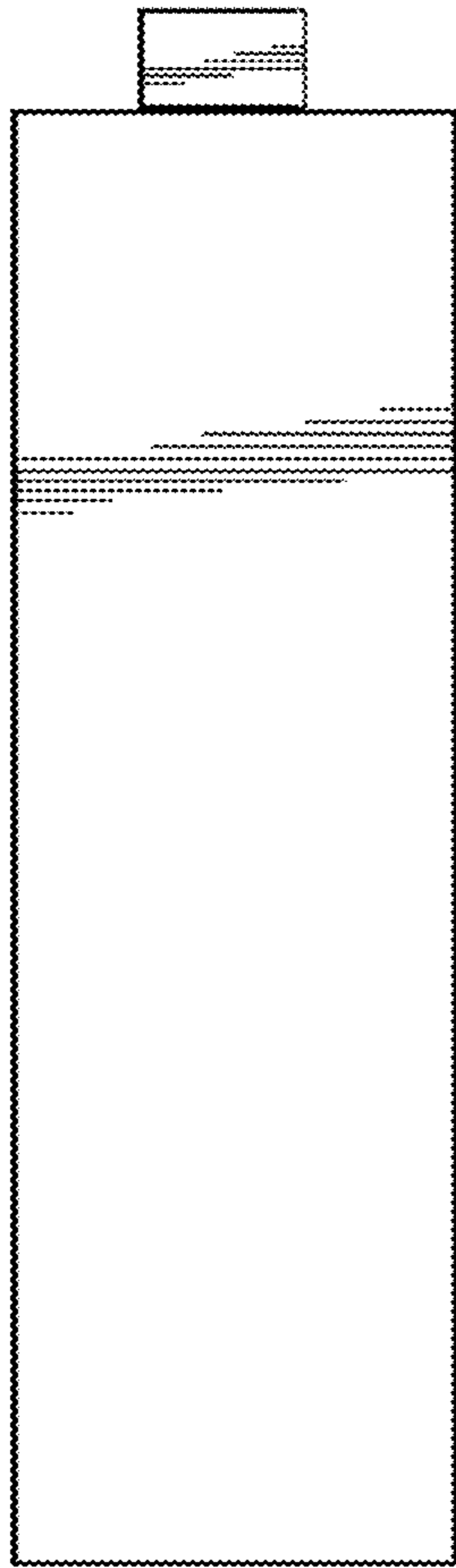

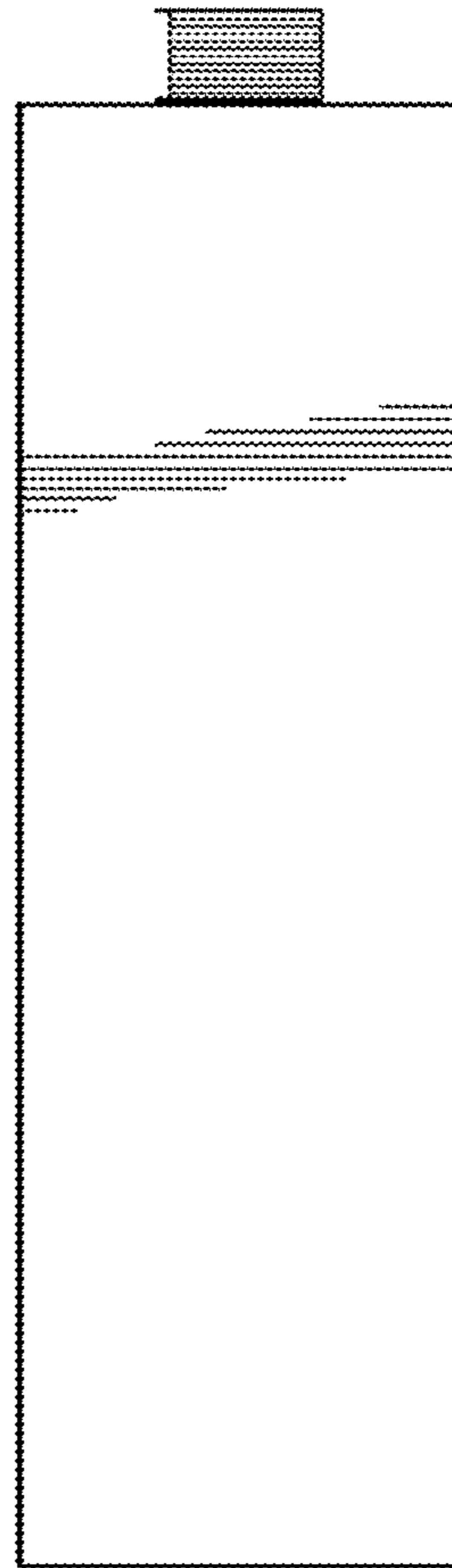

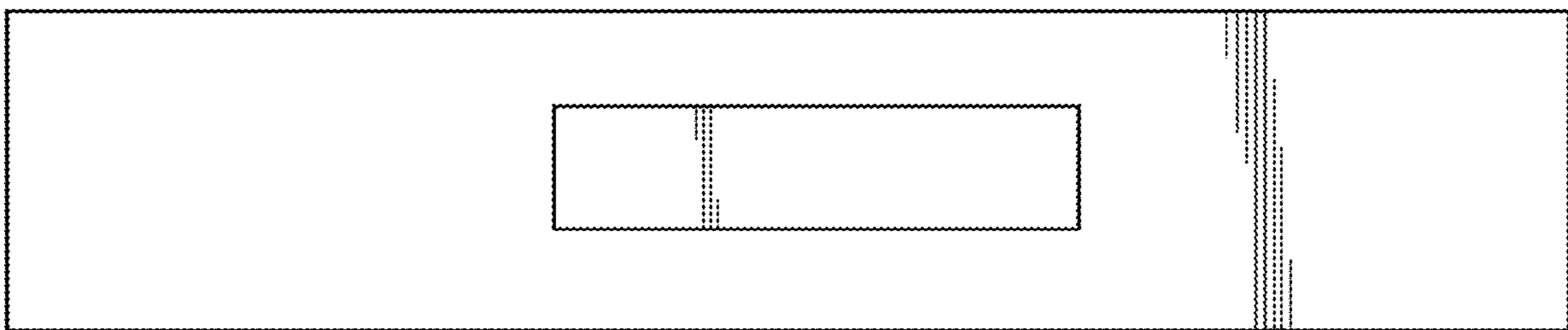

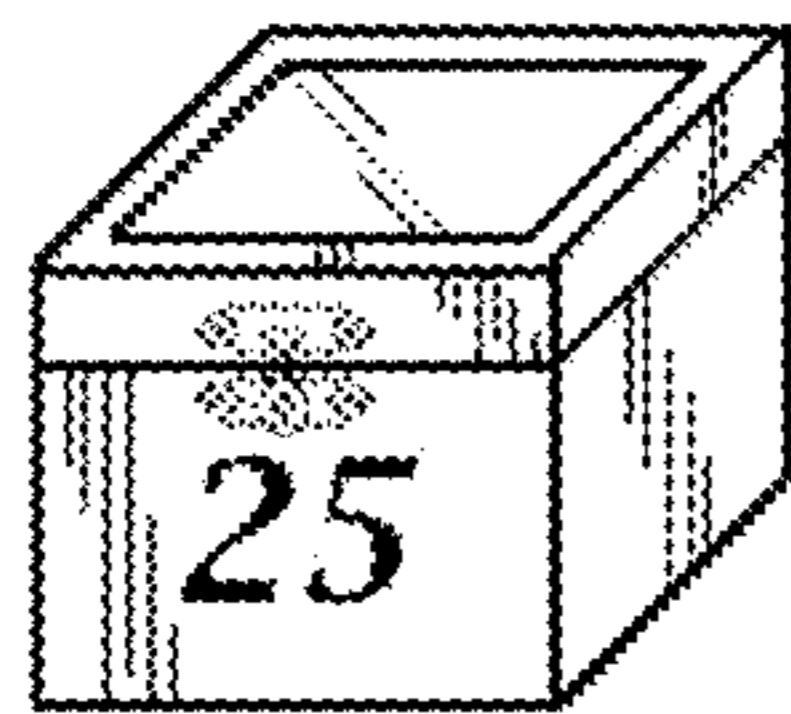

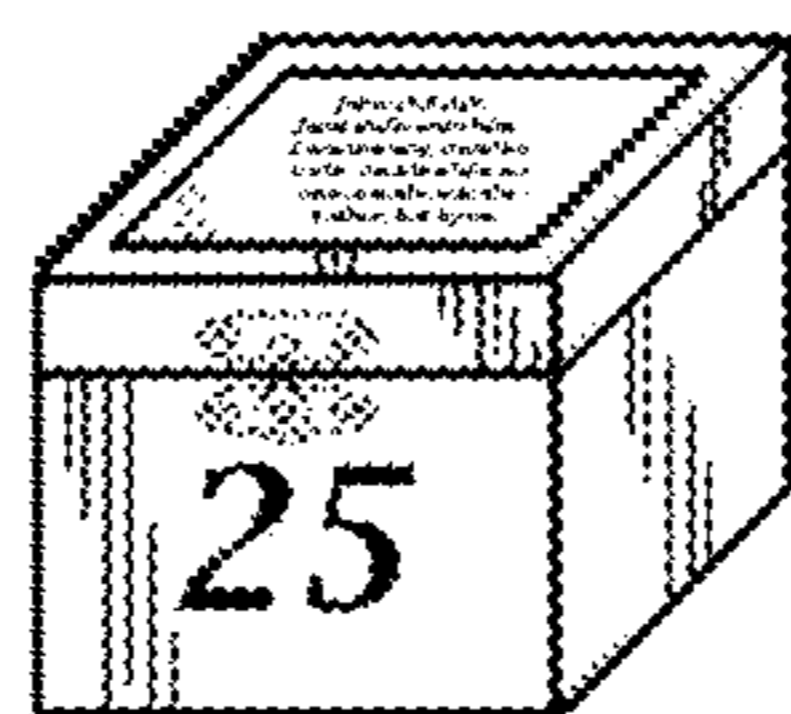

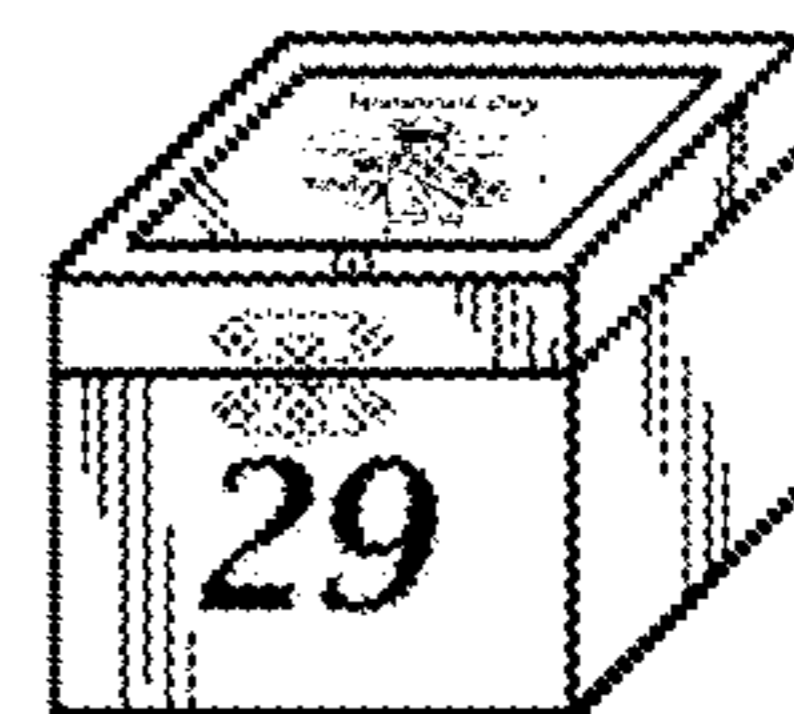

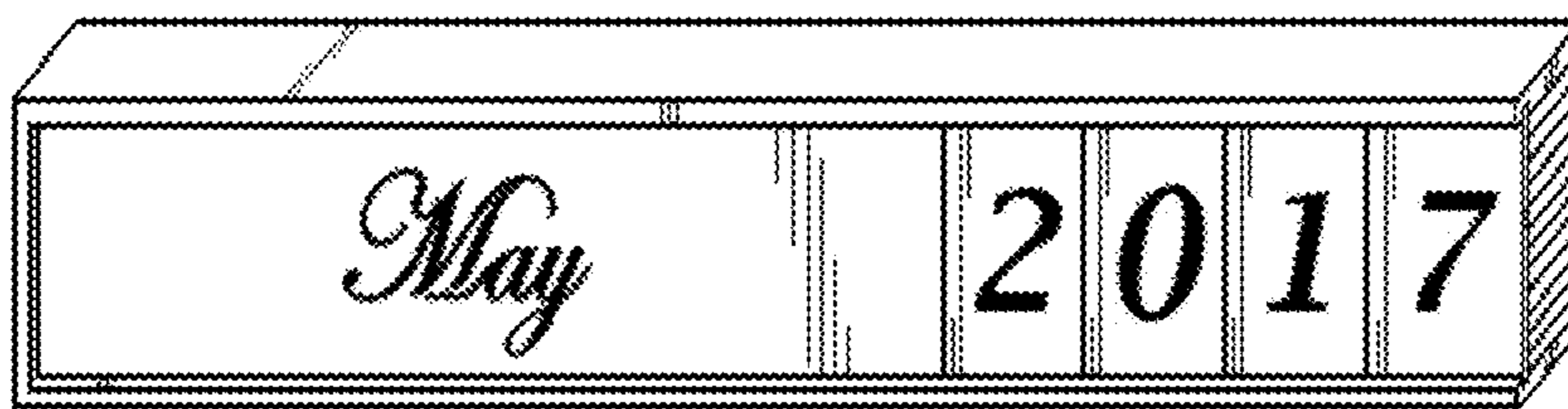

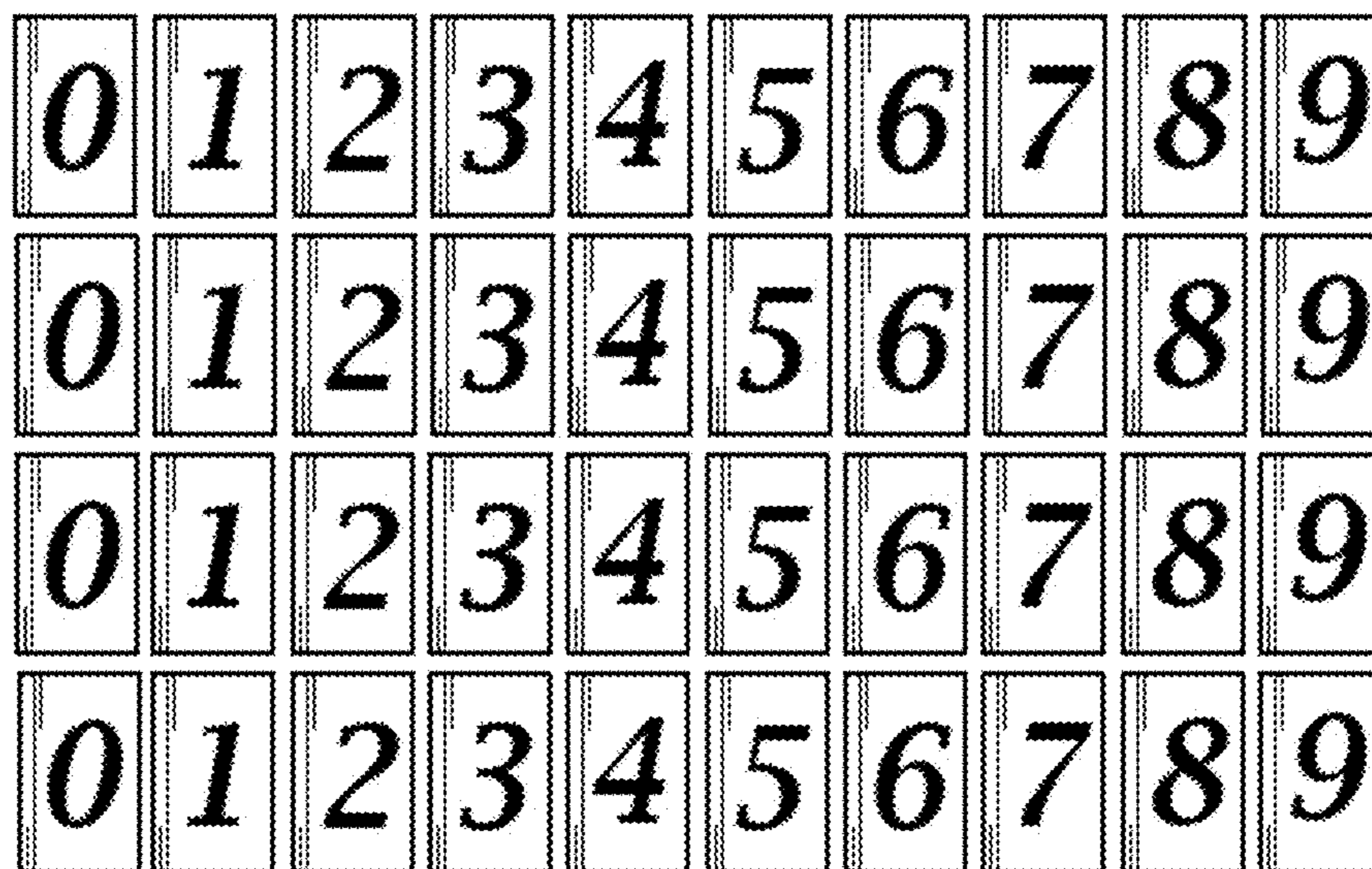

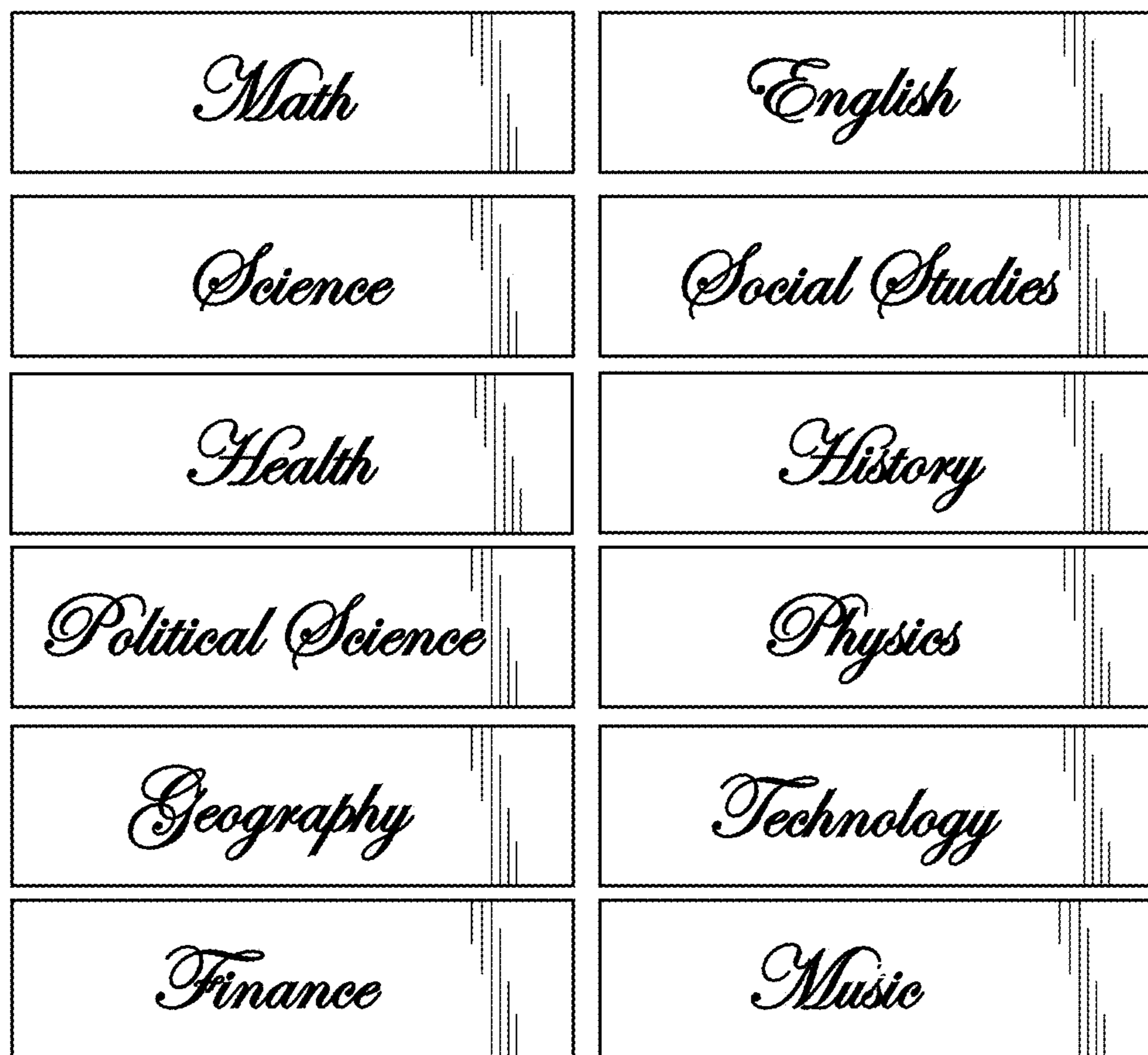
