(57) **CLAIM**

I claim the ornamental design for a faucet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the claimed design;

FIG. 2 is a side view of the embodiment of FIG. 1;

FIG. 3 is another side view of the embodiment of FIG. 1;

FIG. 4 is a front view of the embodiment of FIG. 1;

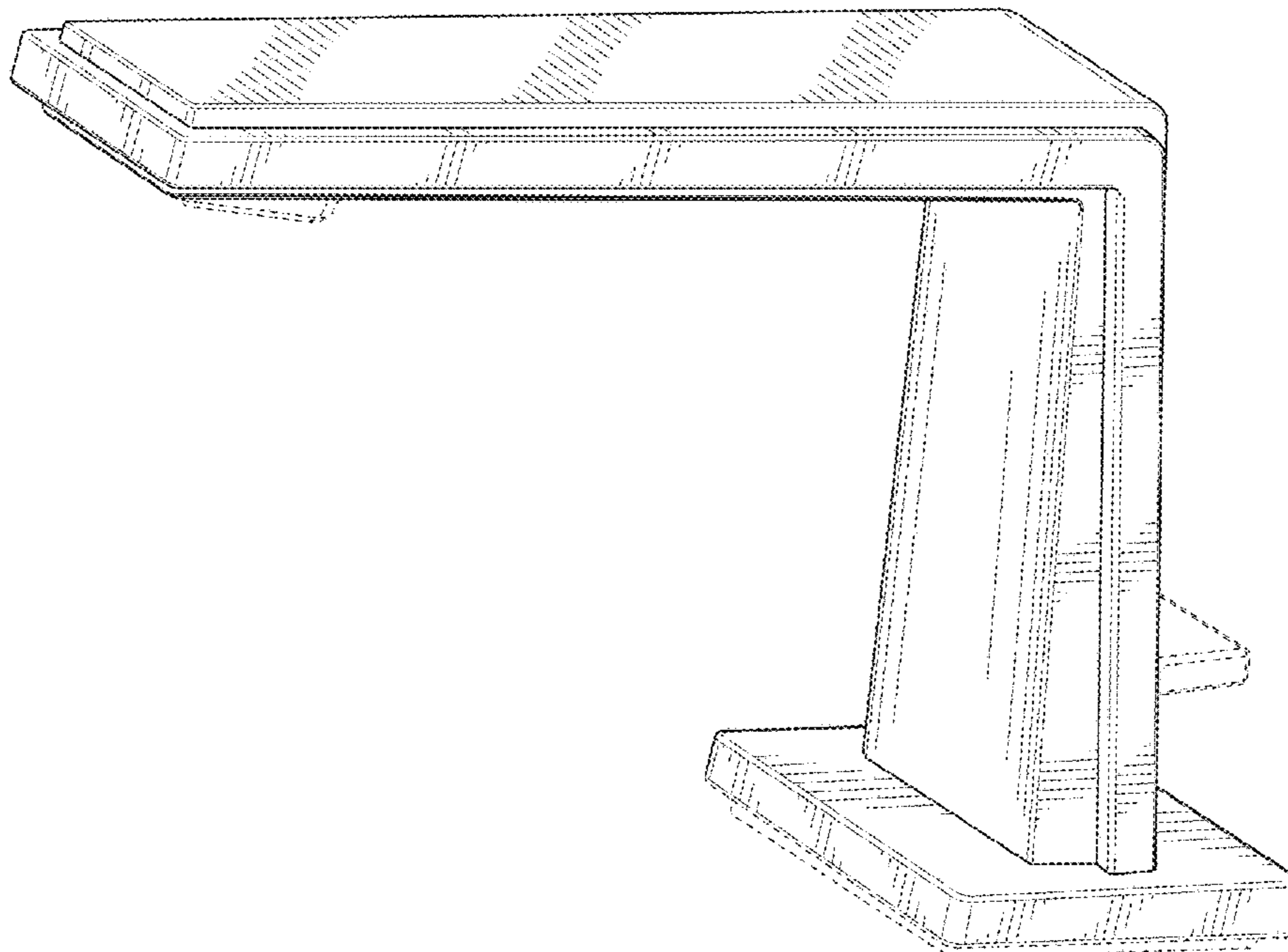
FIG. 5 is a rear view of the embodiment of FIG. 1;

FIG. 6 is a top view of the embodiment of FIG. 1; and,

FIG. 7 is a bottom view of the embodiment of FIG. 1.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design. Broken lines formed of unequal length dashes (i.e., dash-dot) define bounds of the claimed design. Break lines having a jagged element are not part of the claimed design and show that differing lengths (e.g., longer, shorter, etc.) of any portion (e.g., feature) split by a break line are possible.

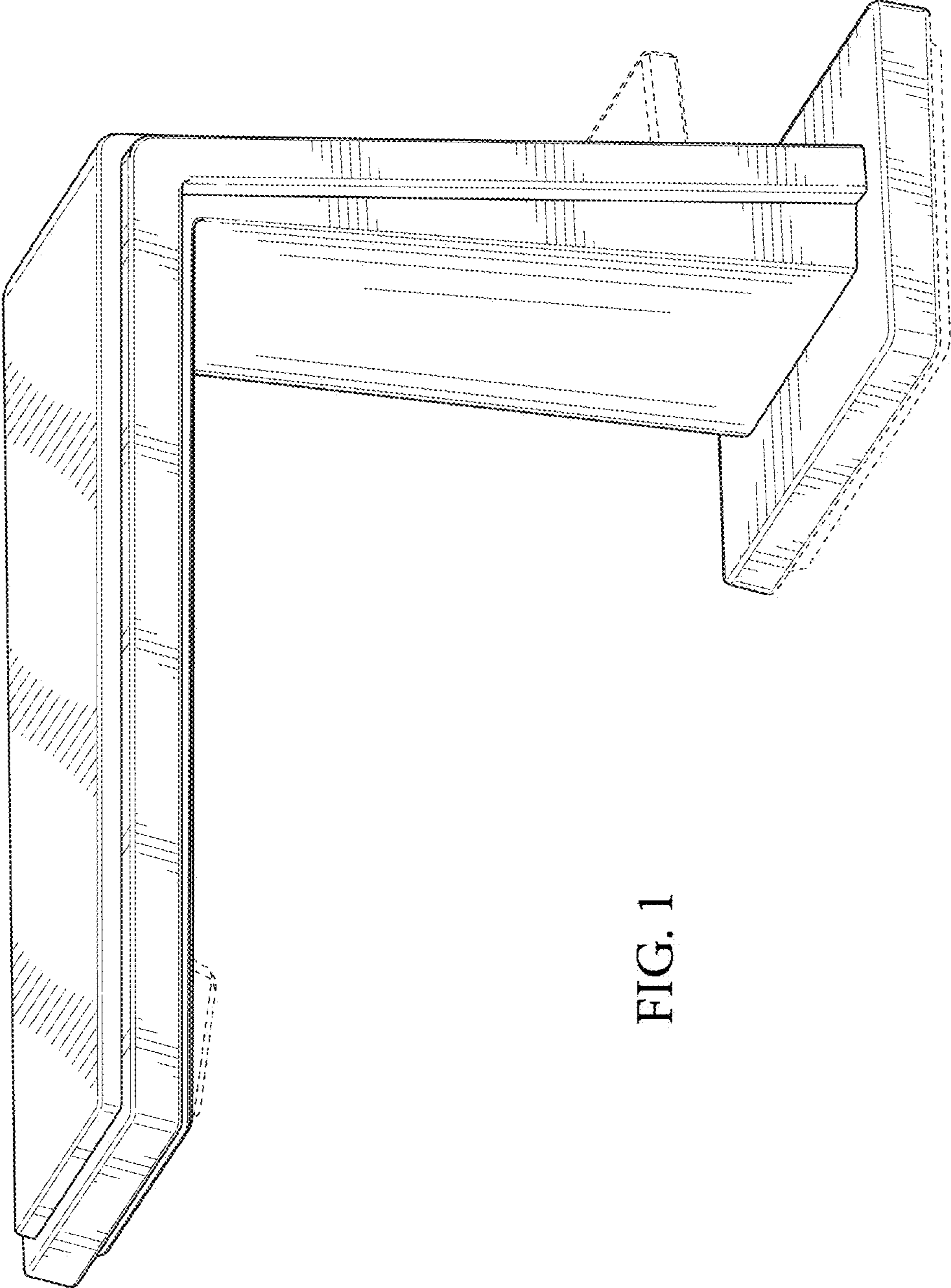

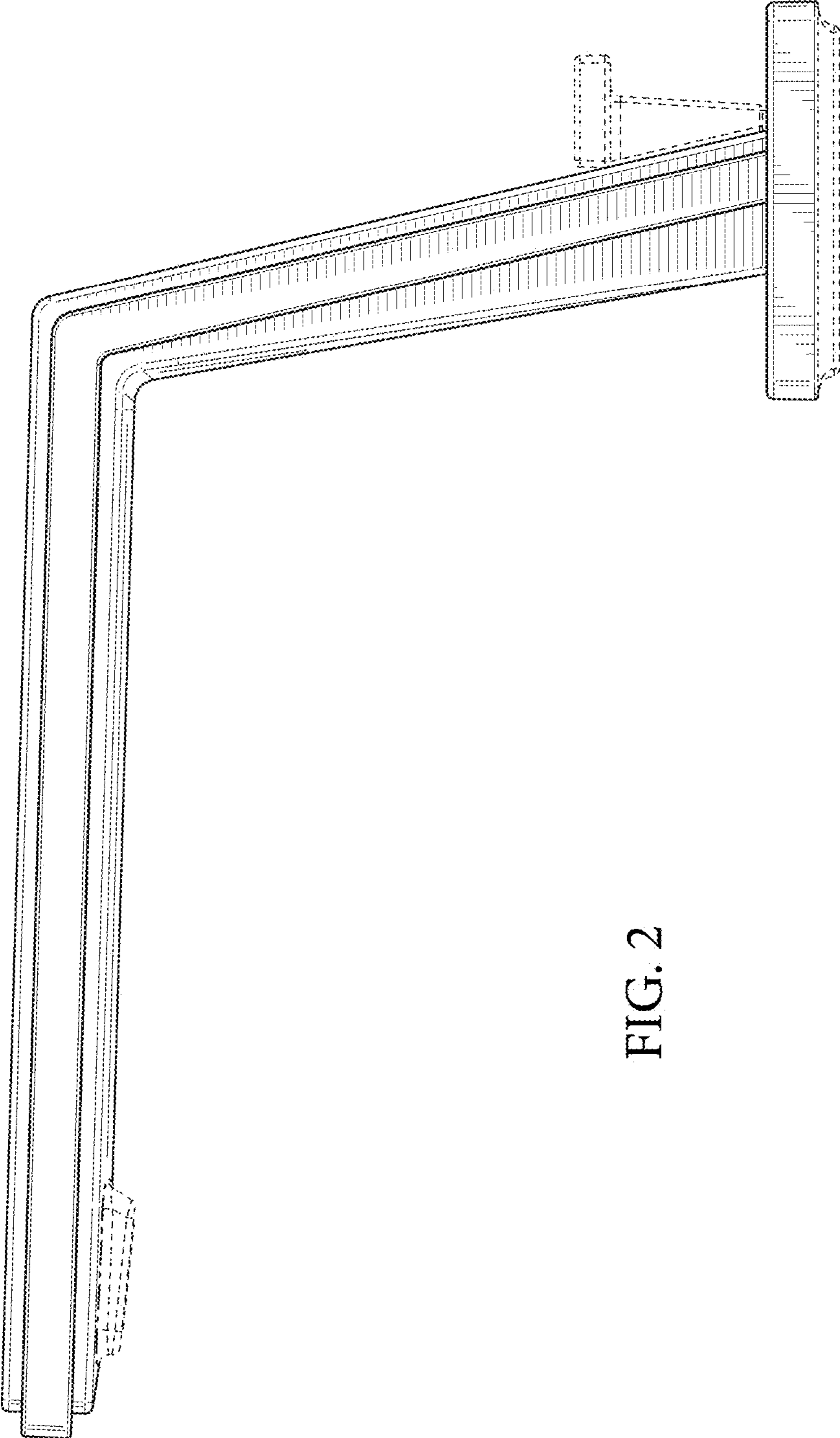

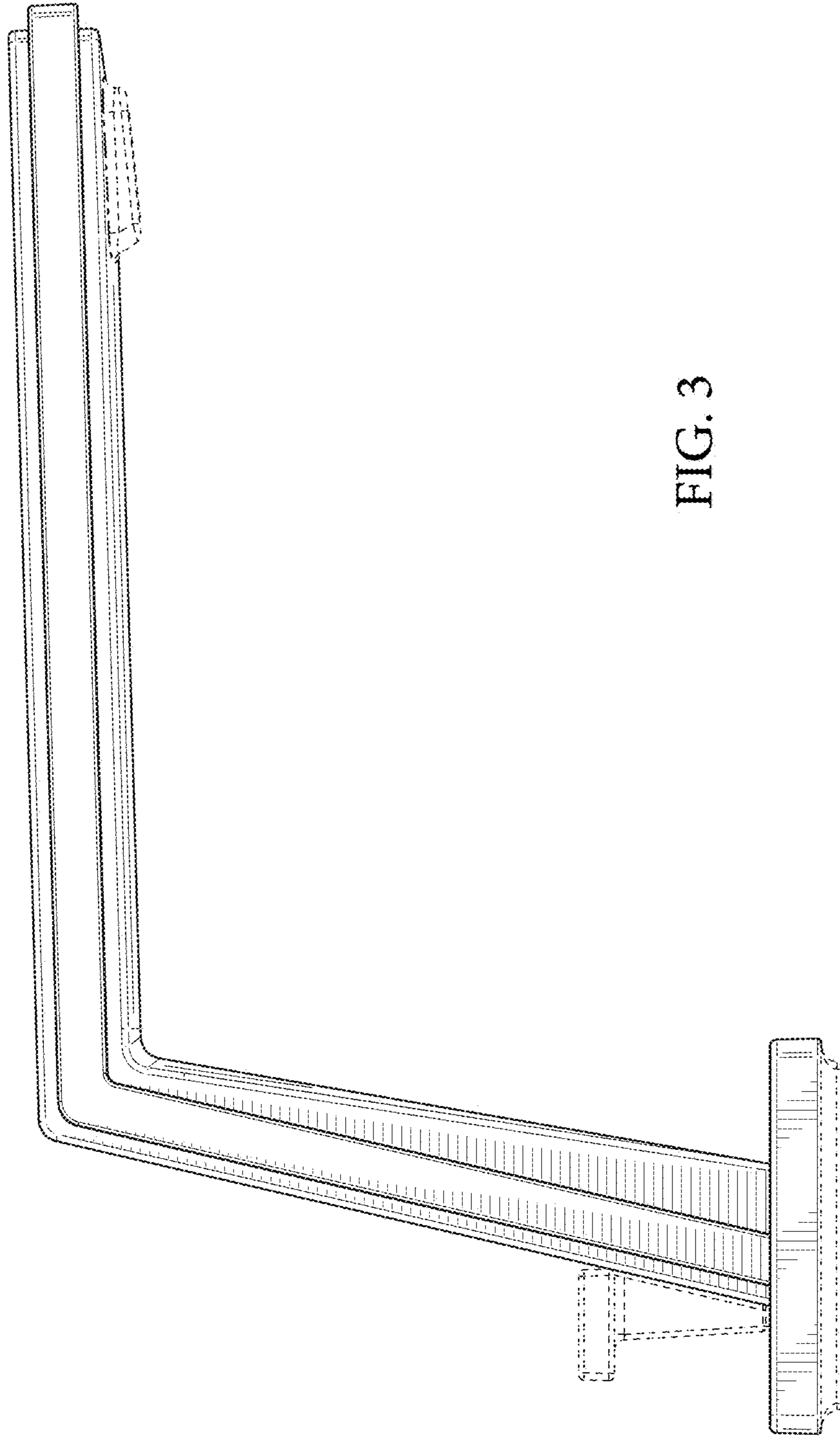

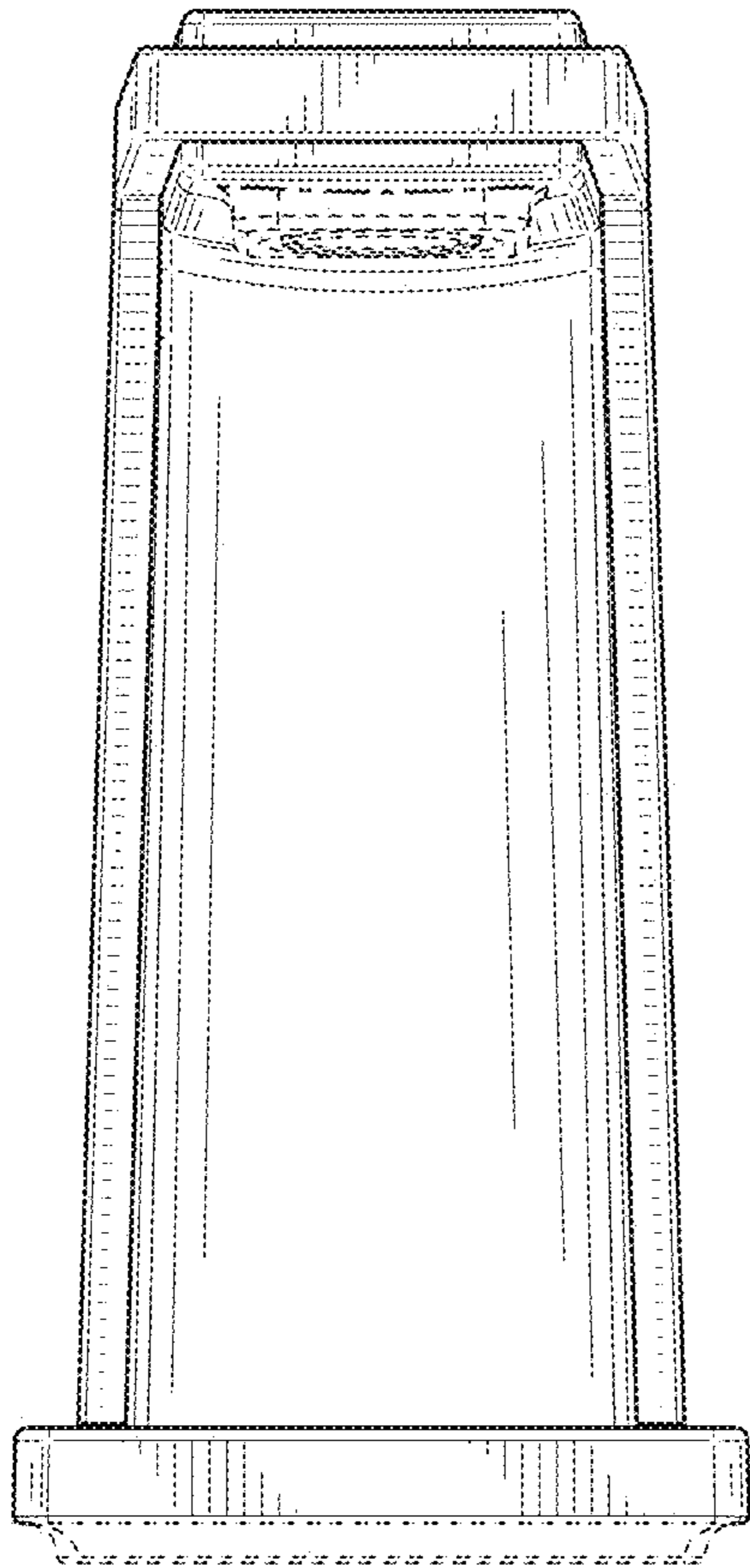

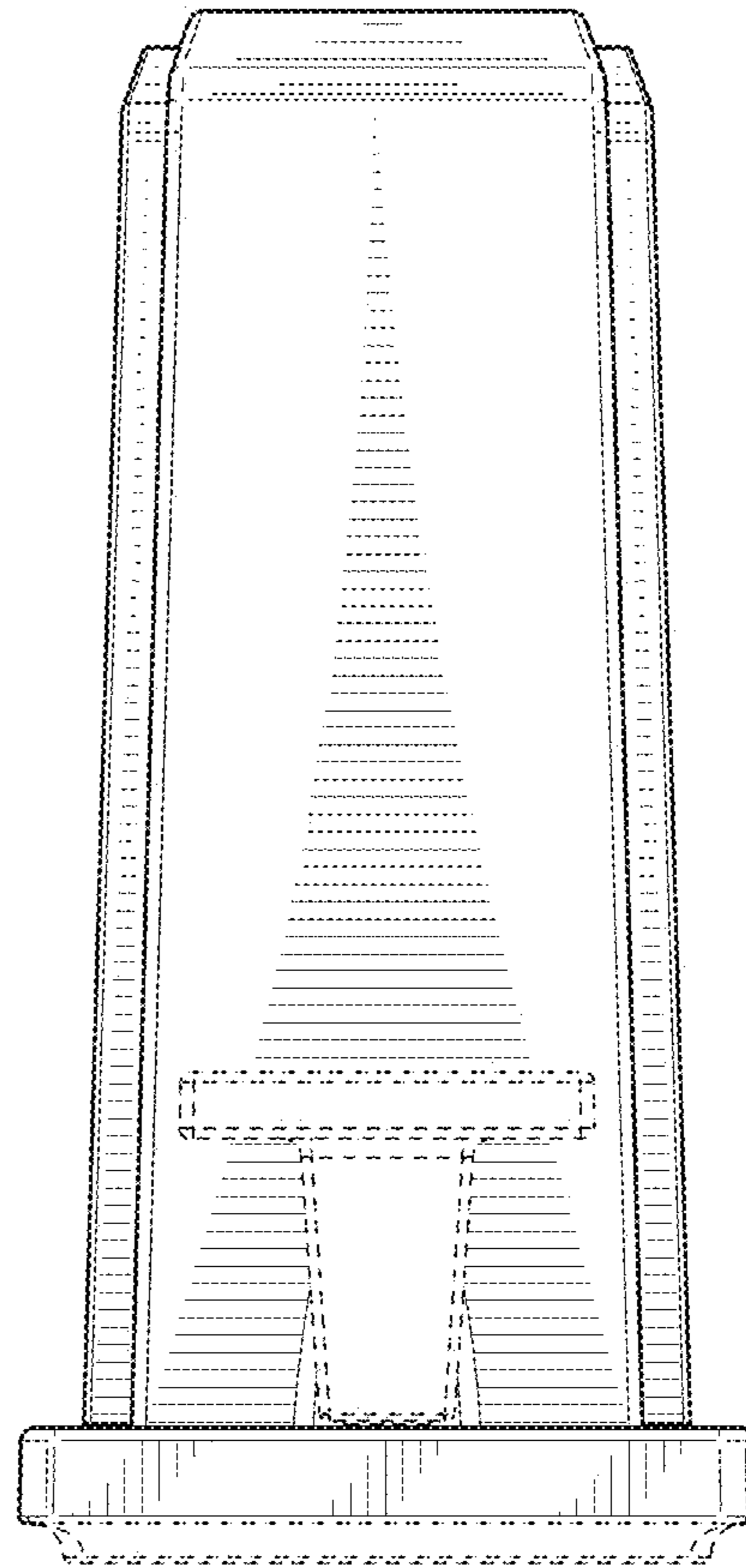

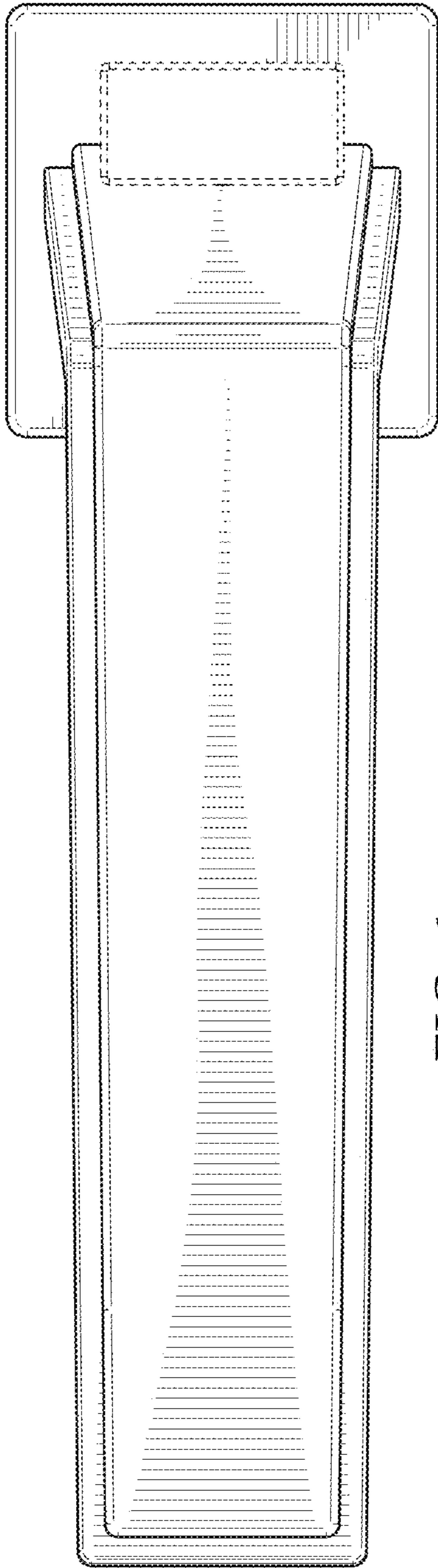

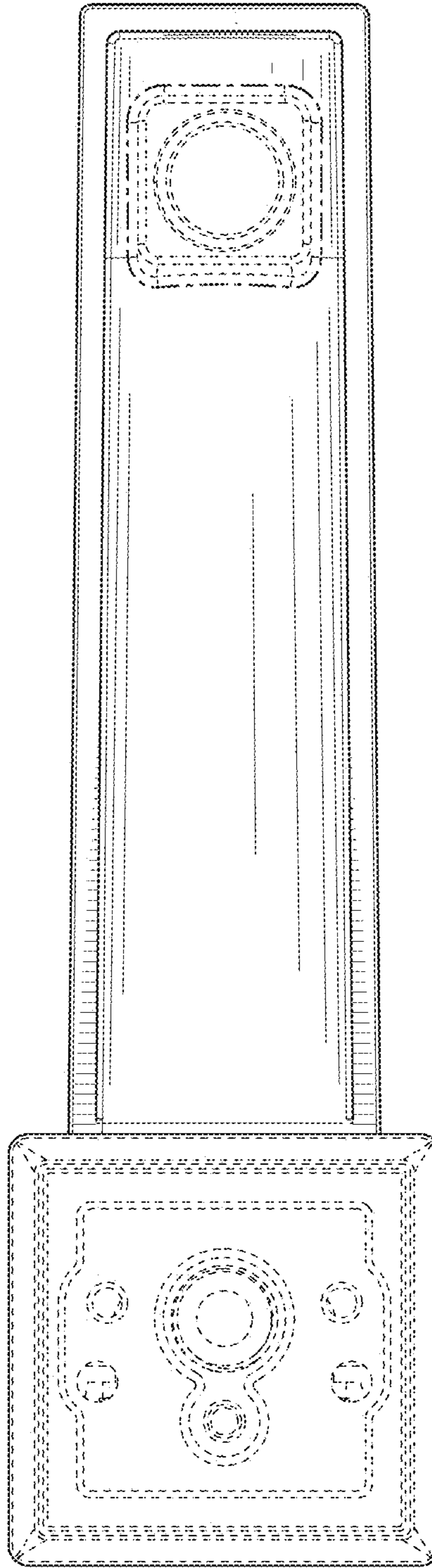
