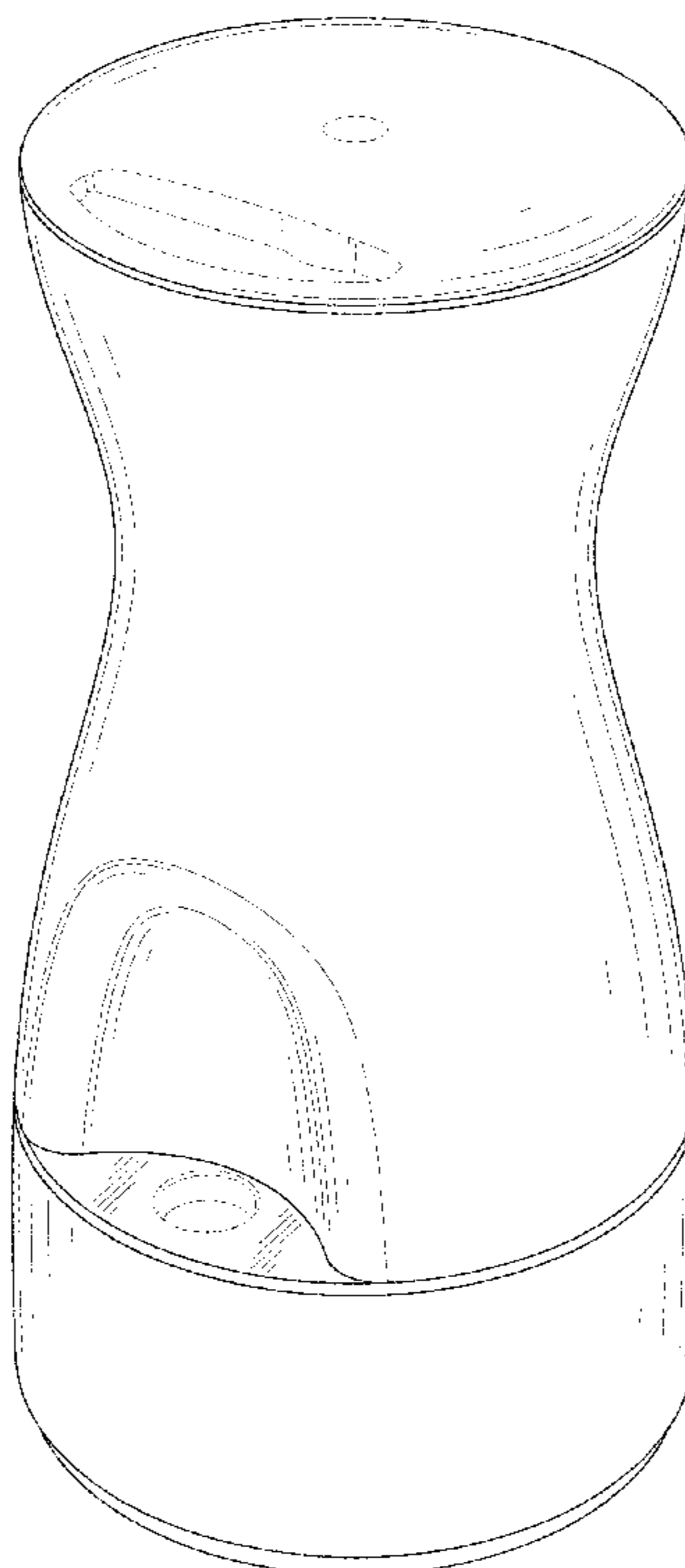
The ornamental design for an aroma apparatus, as shown and described.

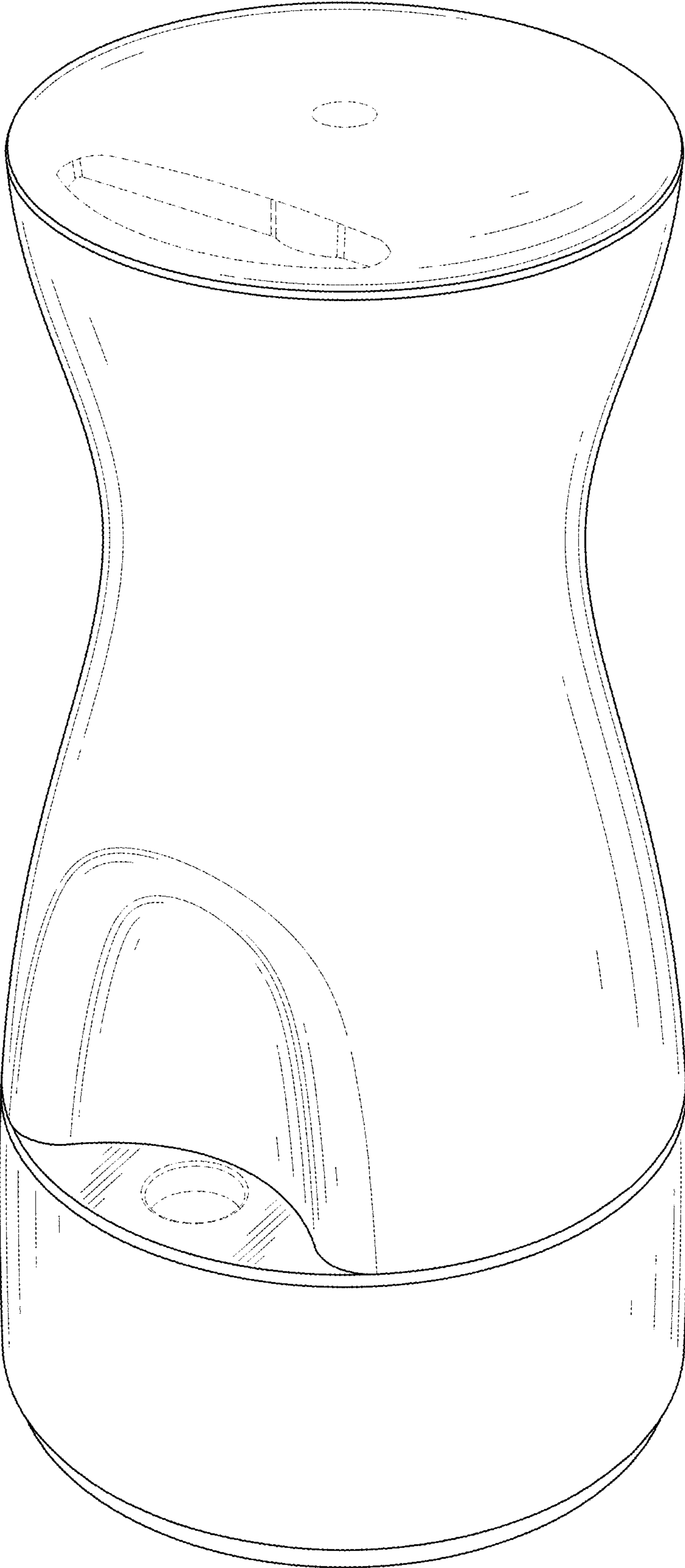

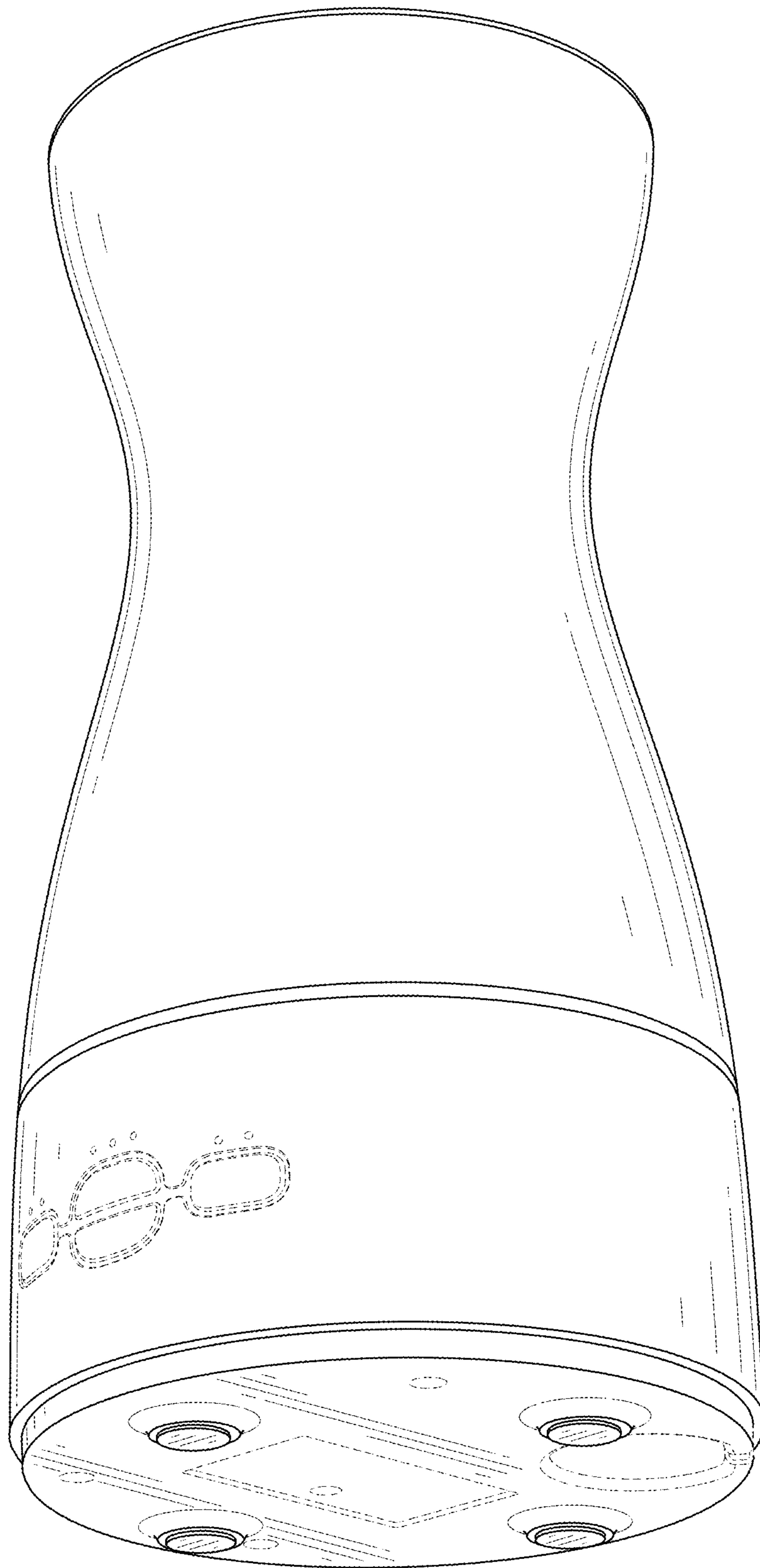

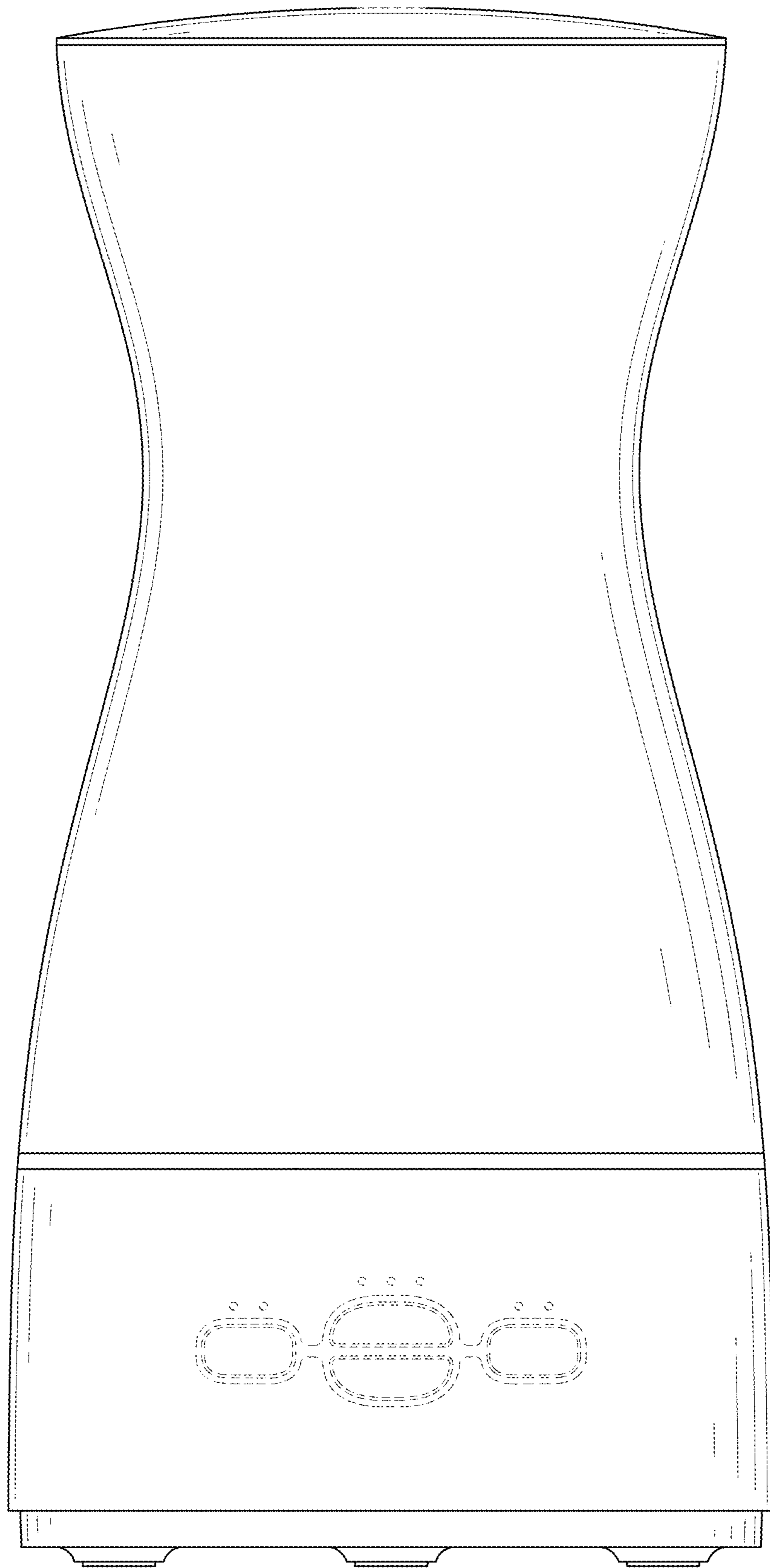

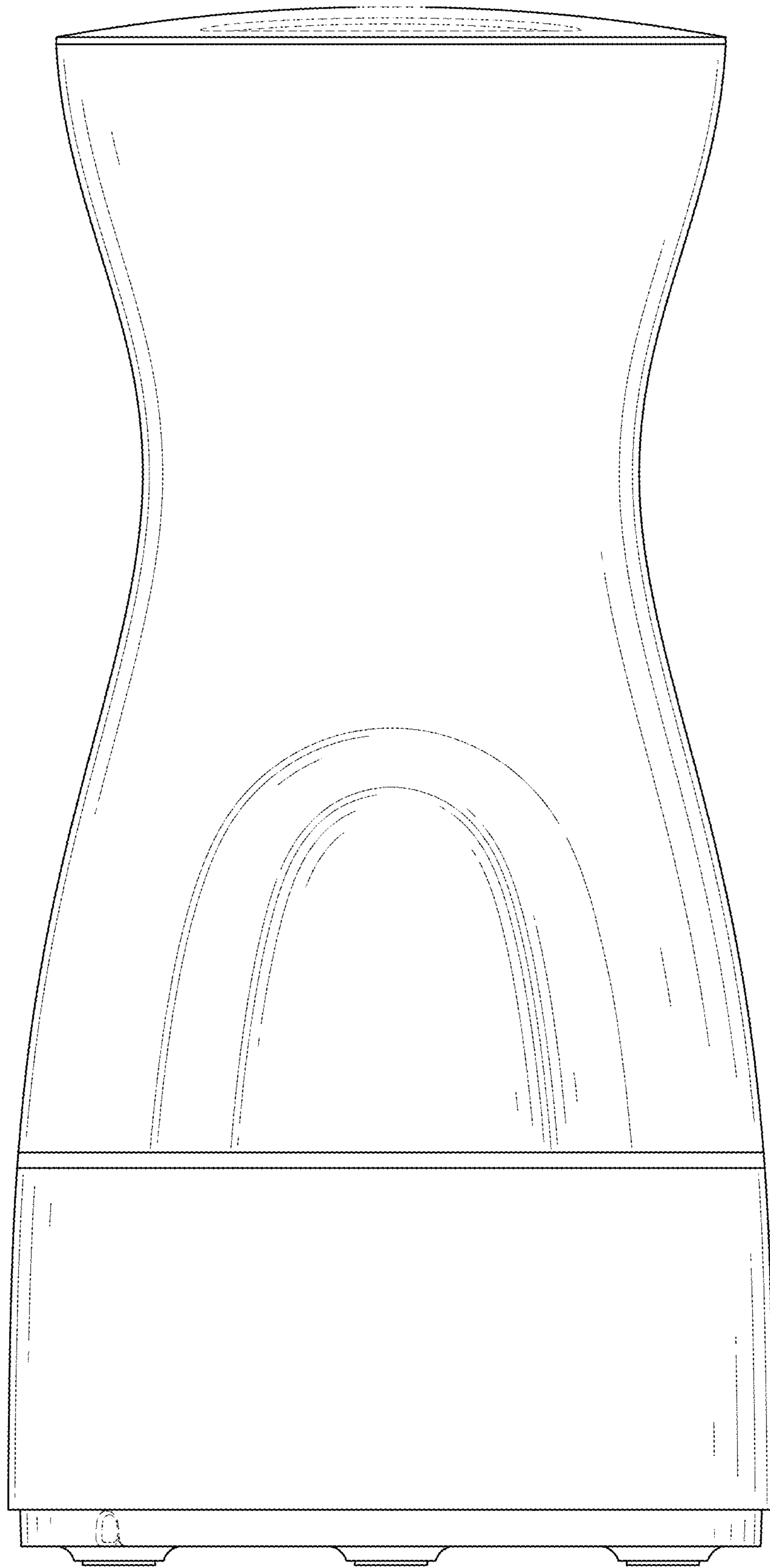

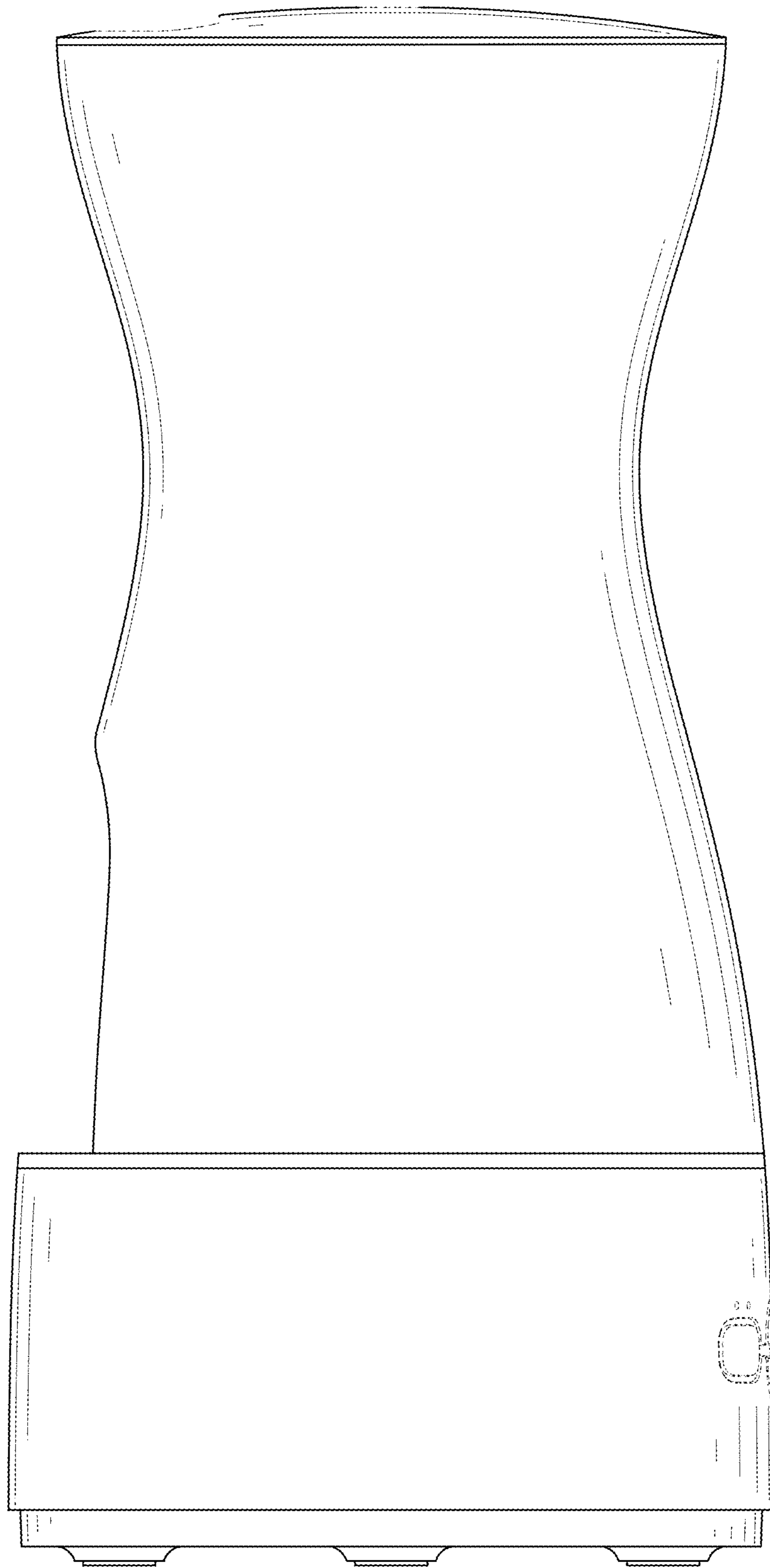

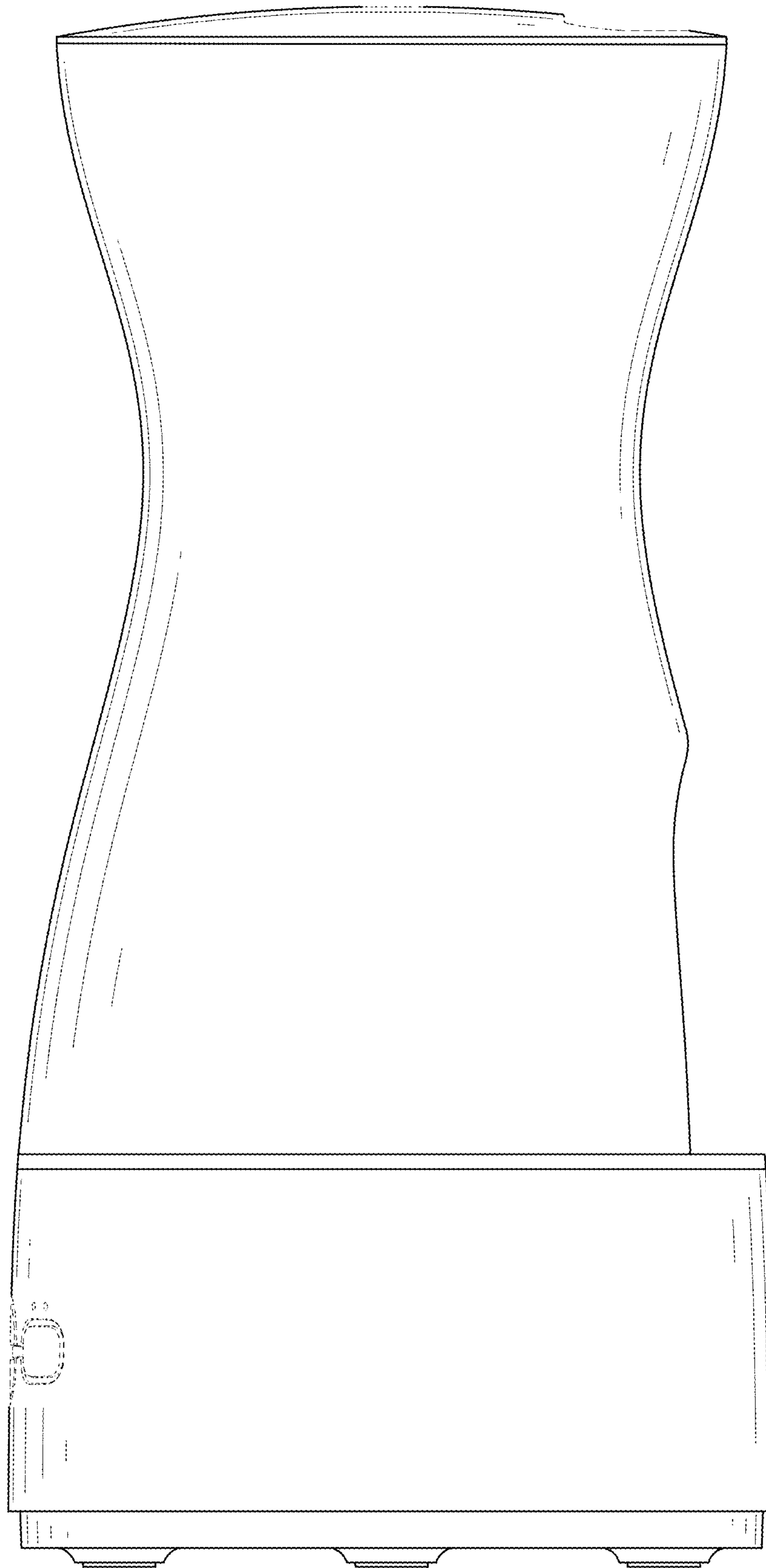

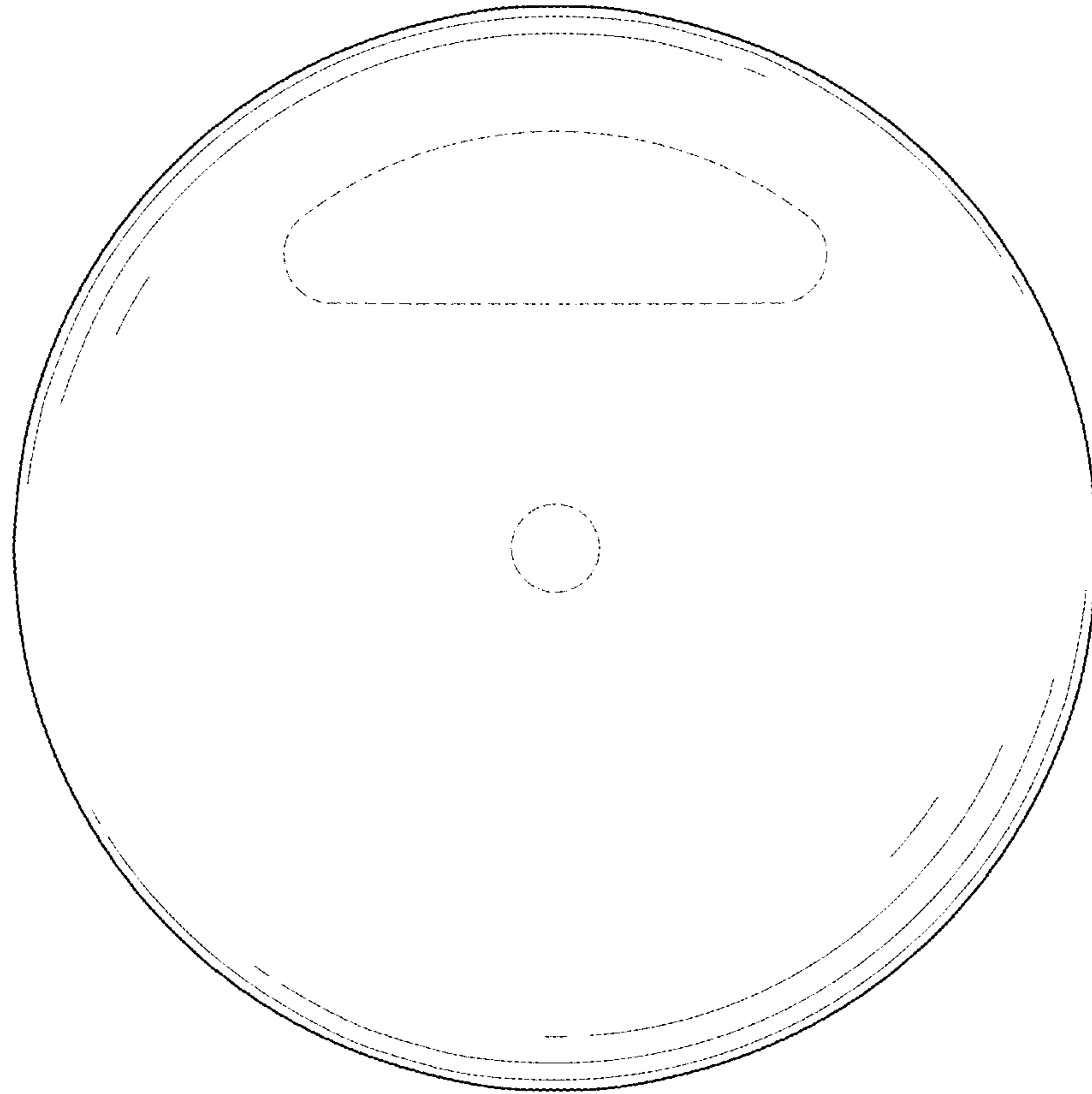

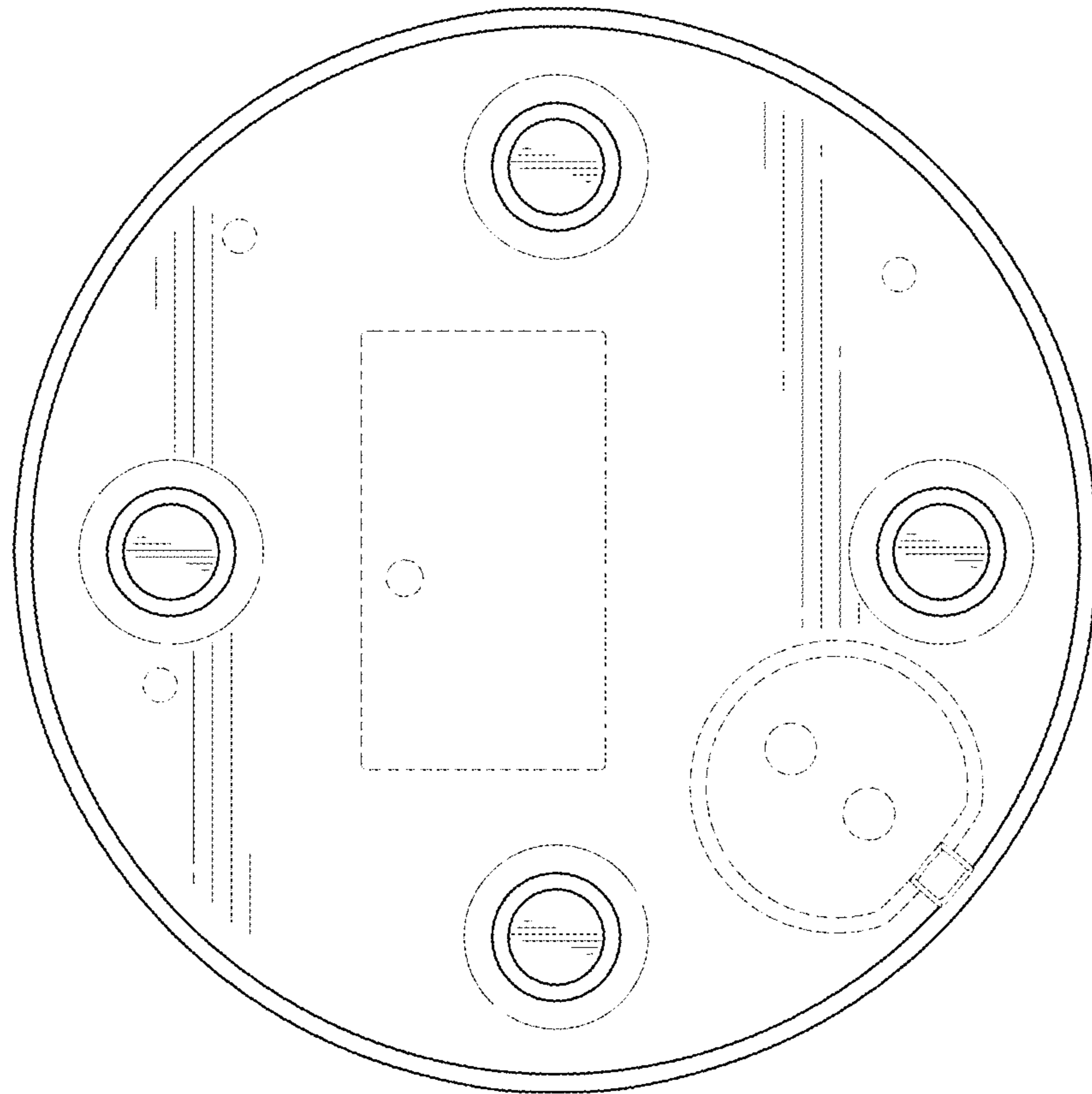
