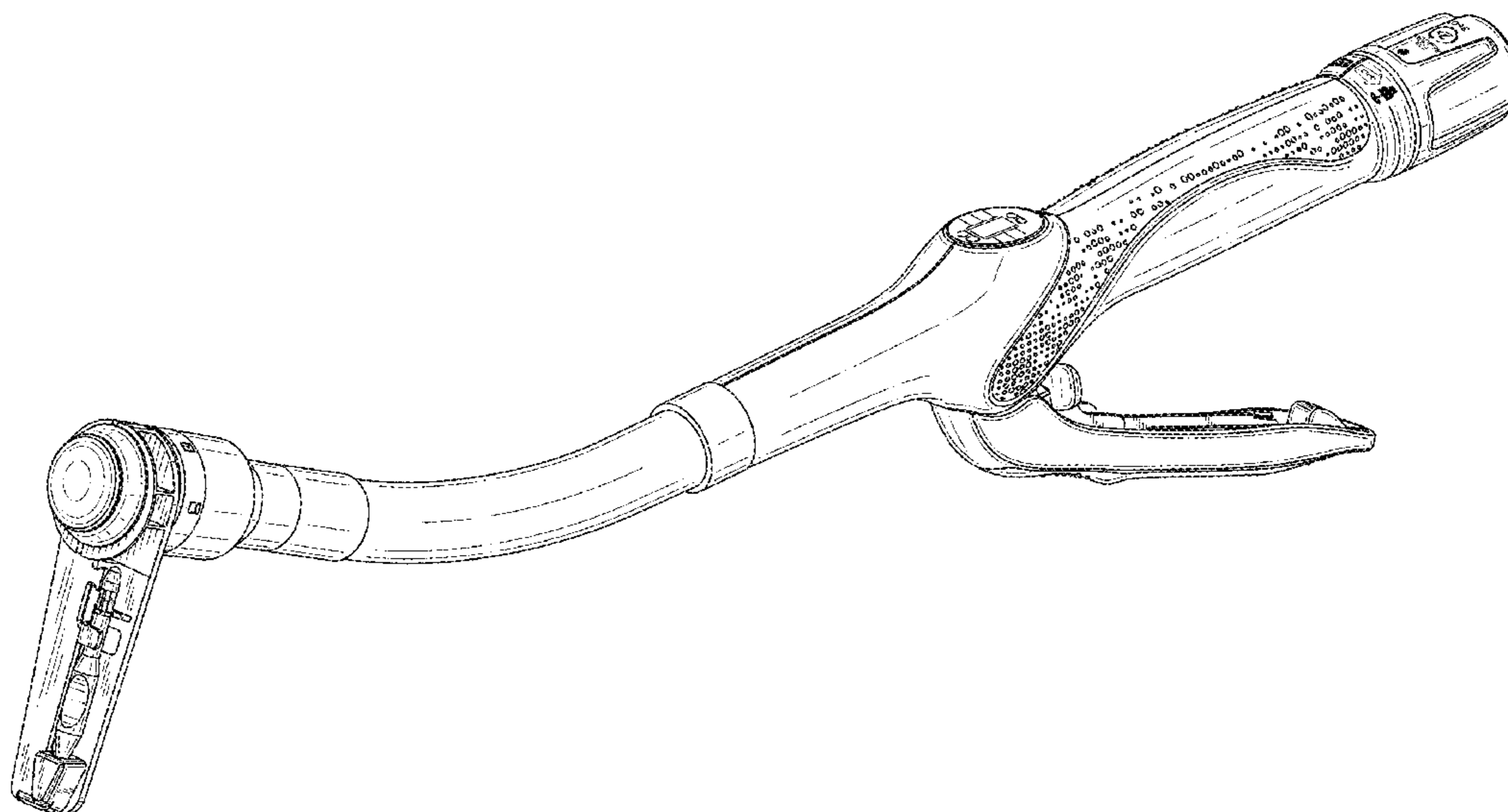
(57) **CLAIM**

The ornamental design for a surgical stapler, as shown and described.

**DESCRIPTION**

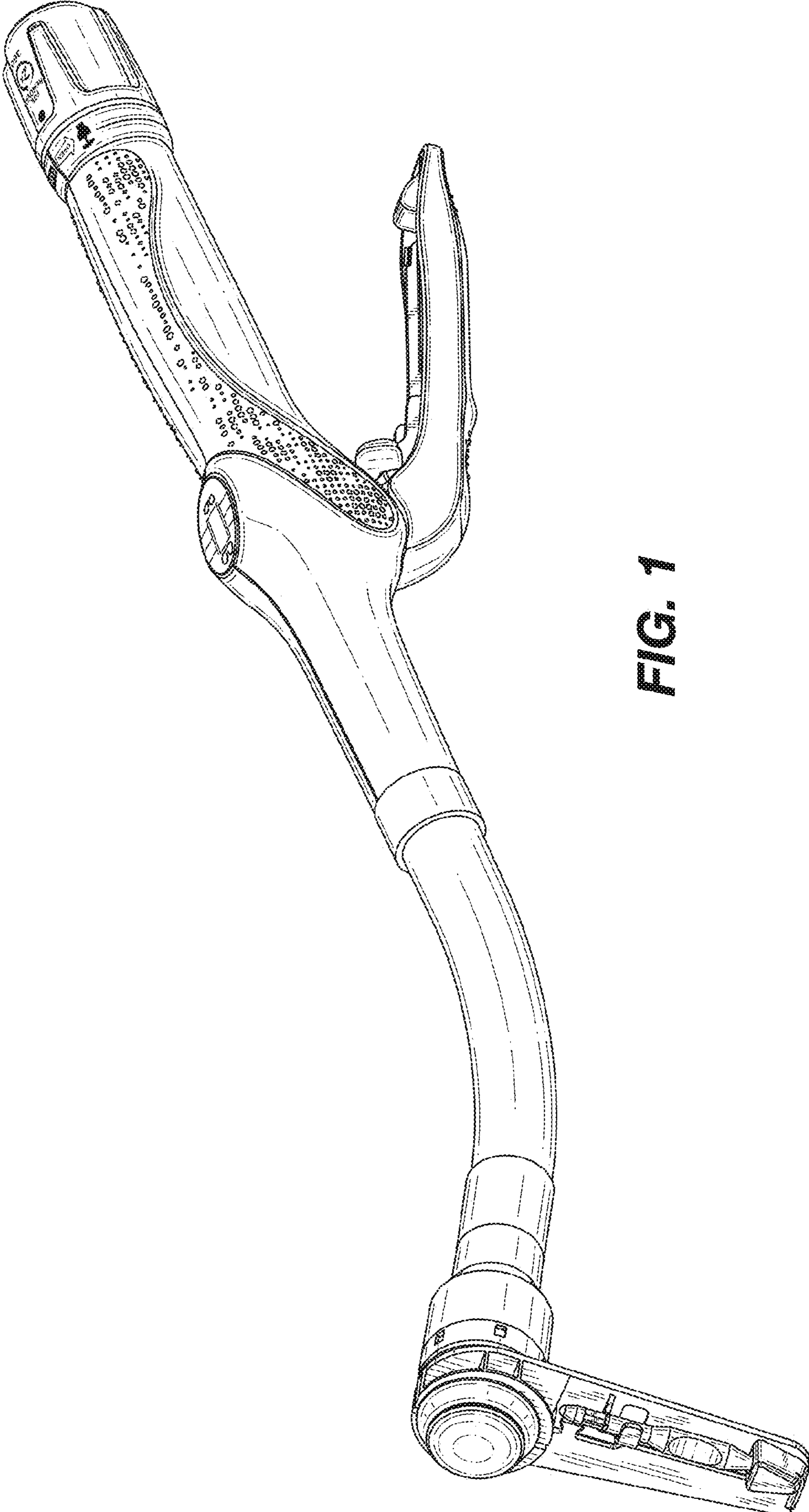
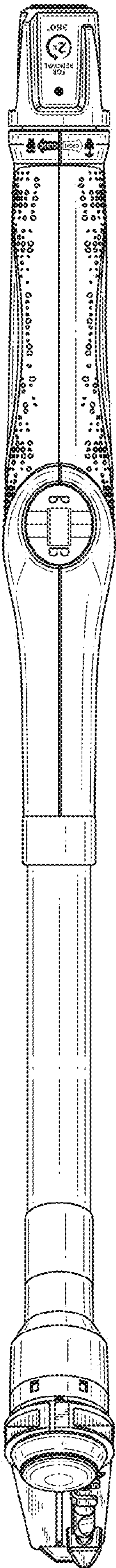
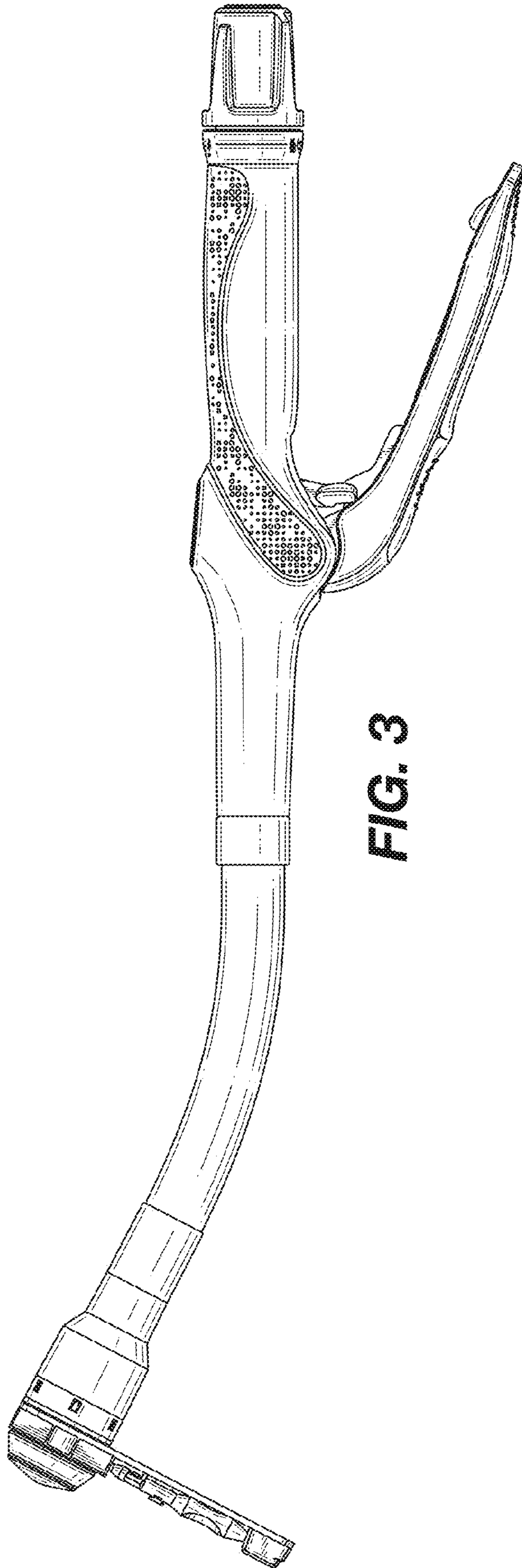


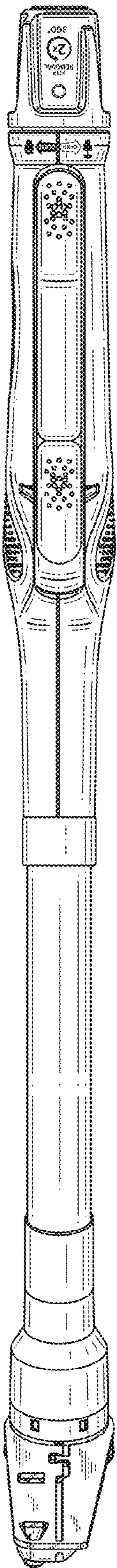

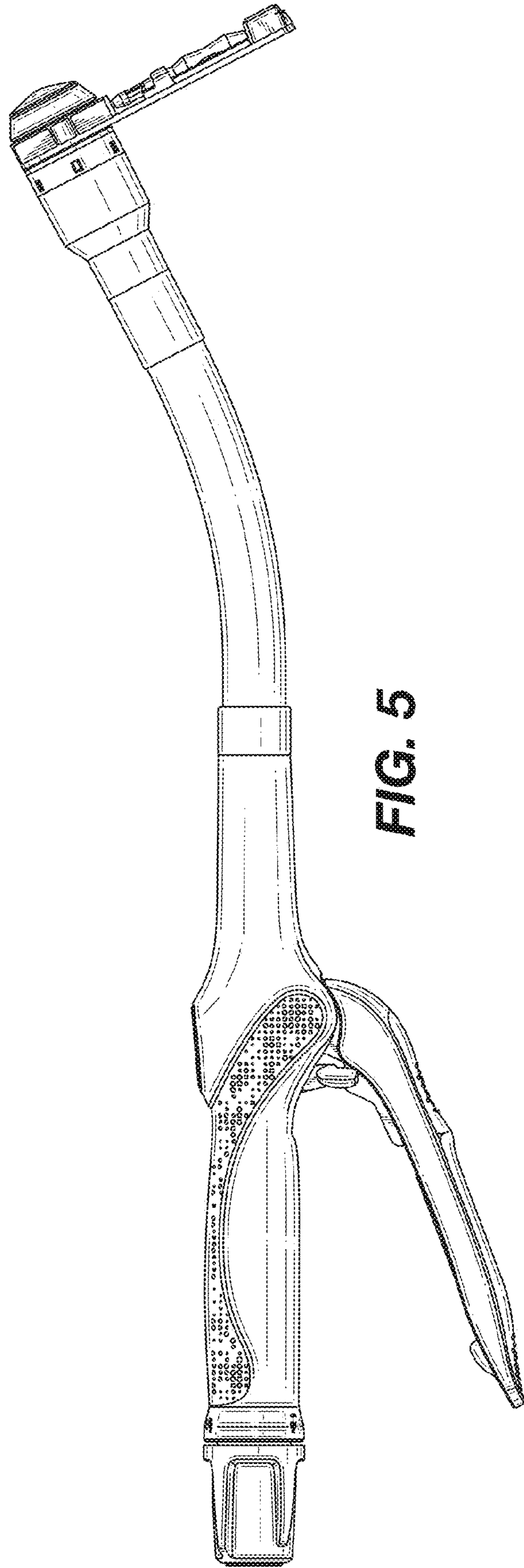

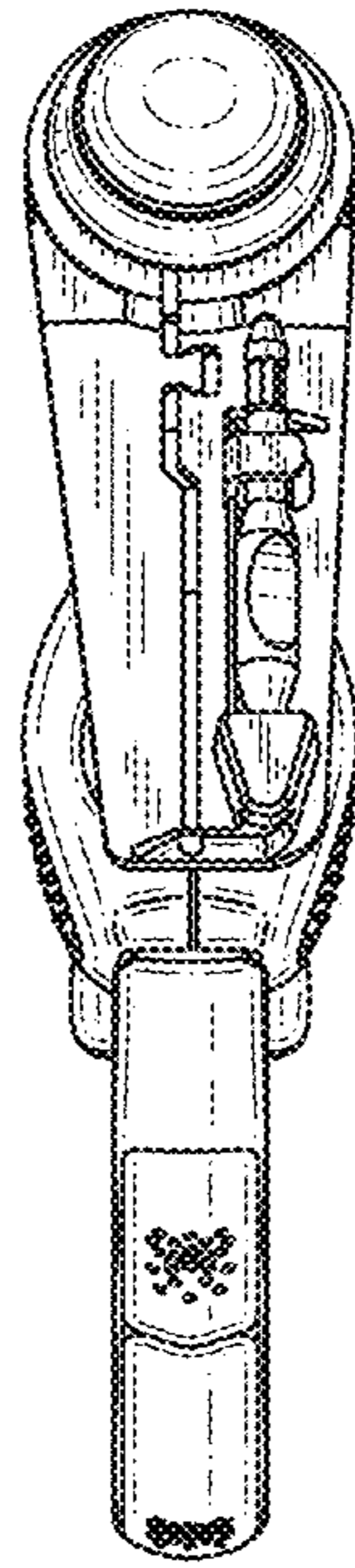

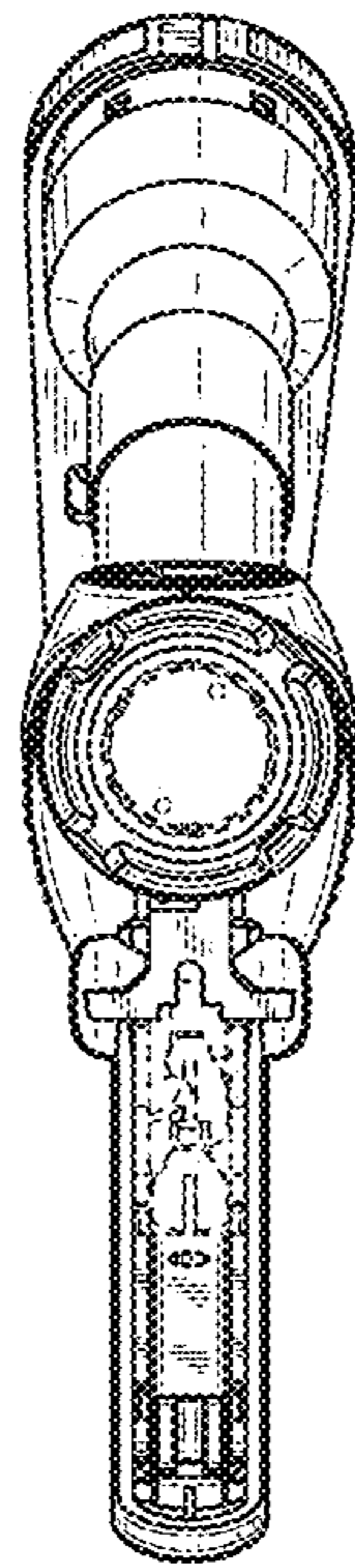

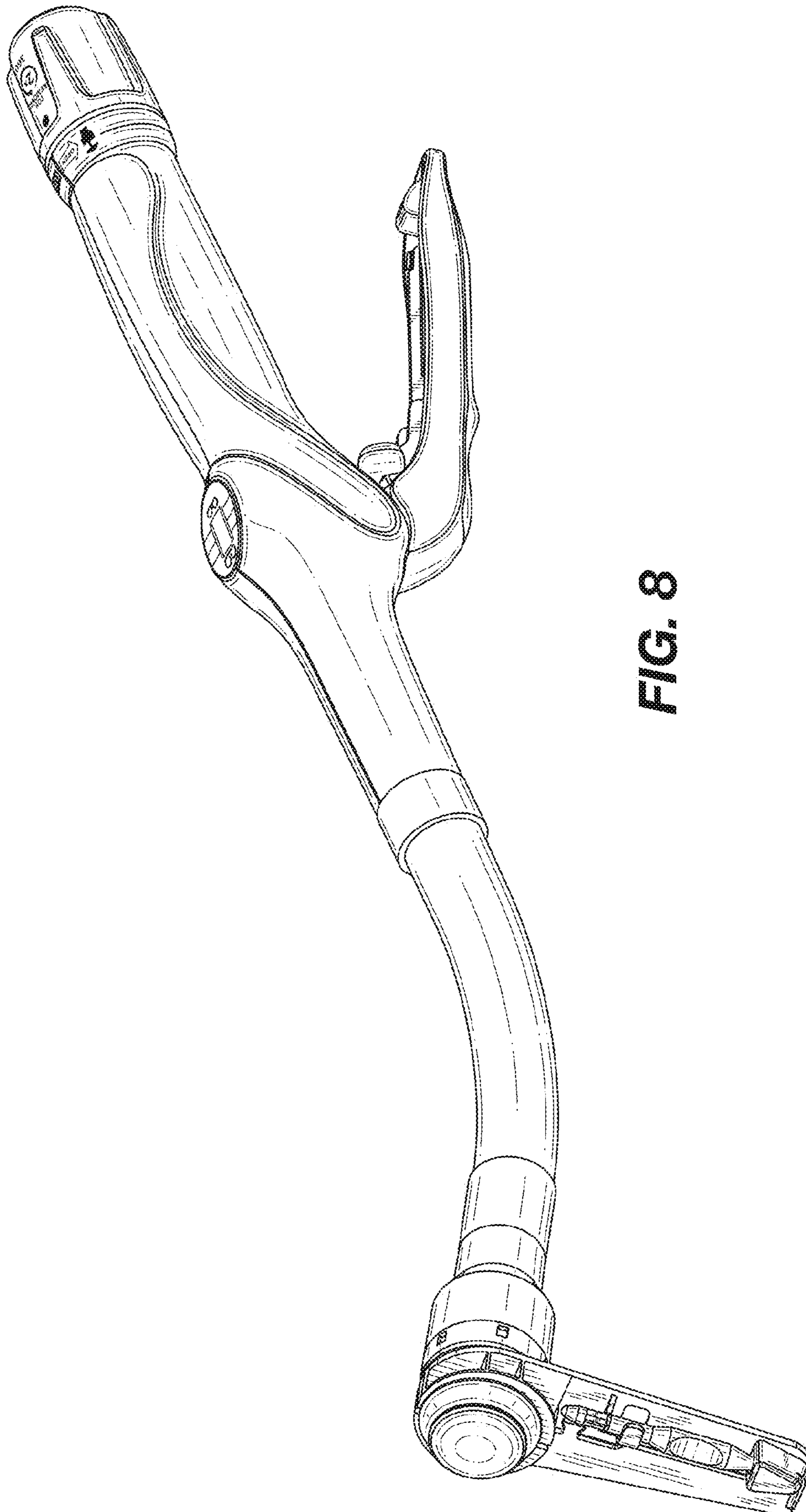
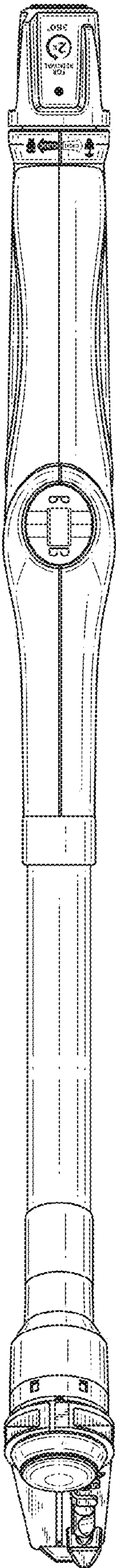
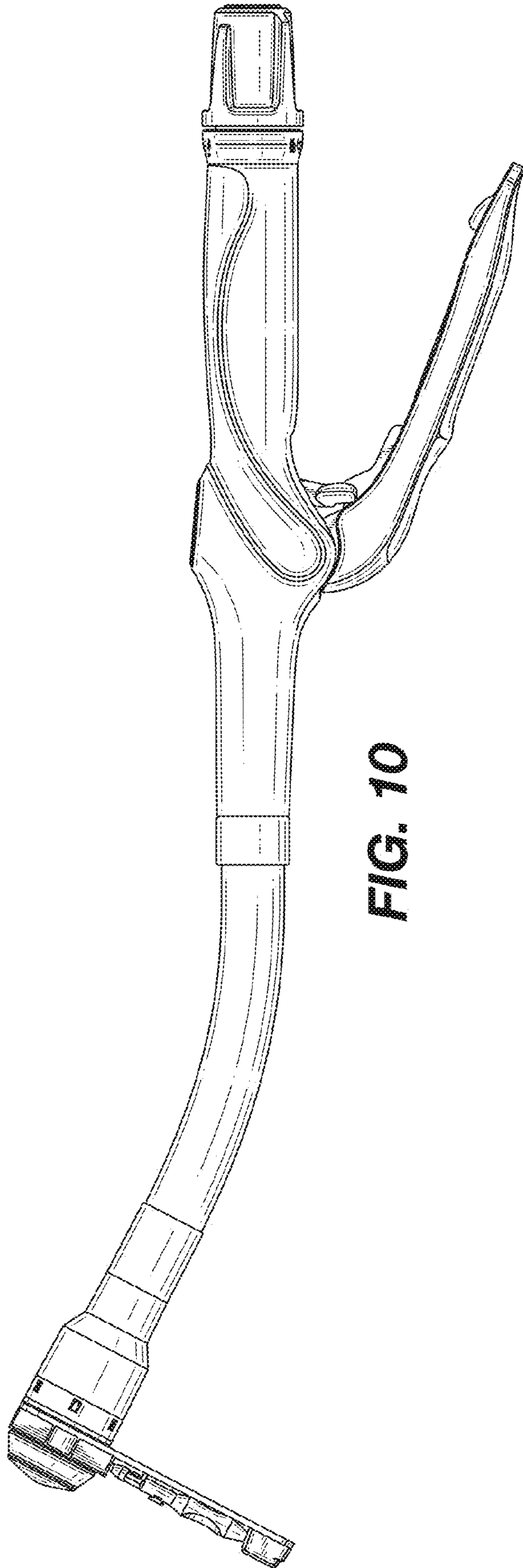

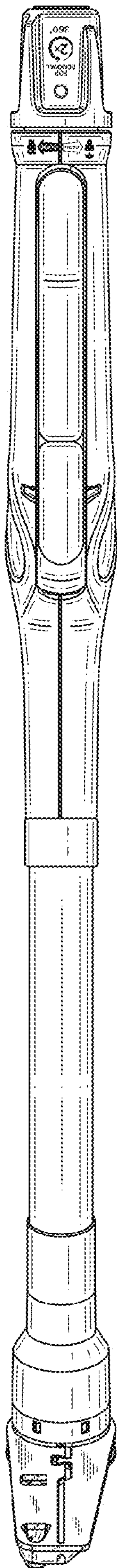

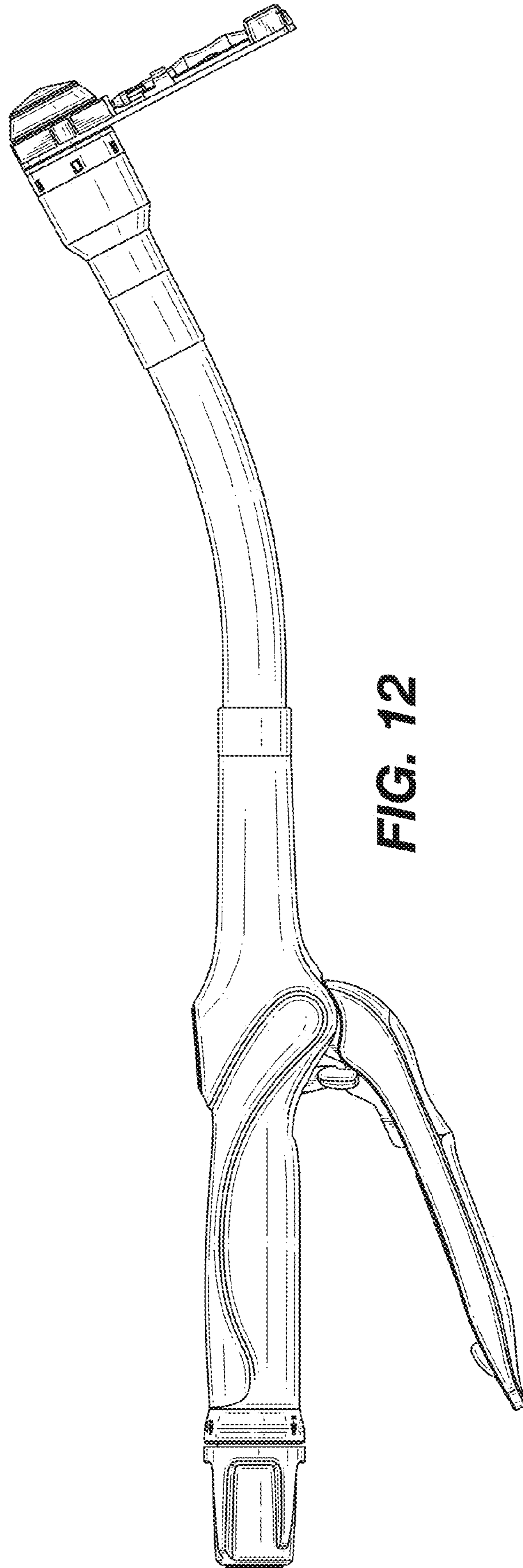

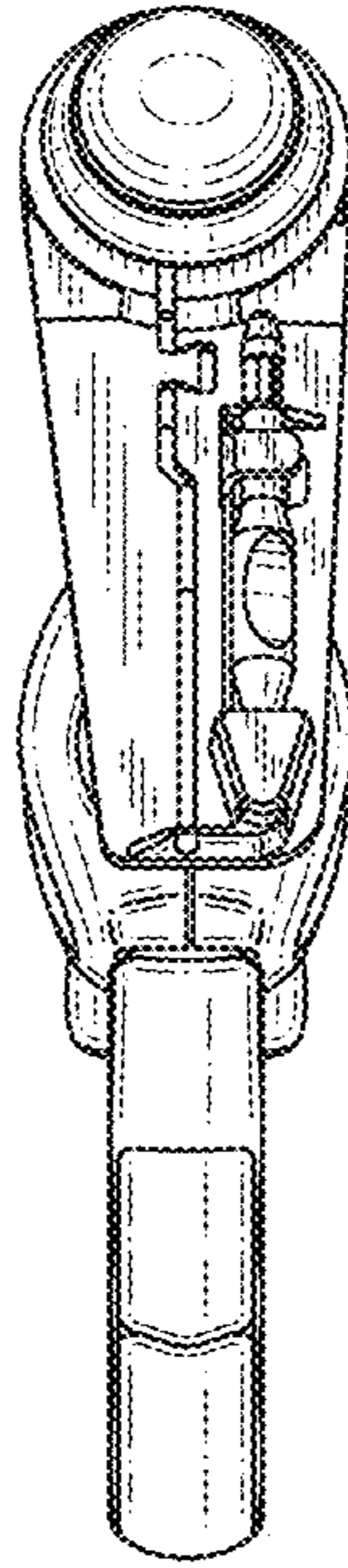




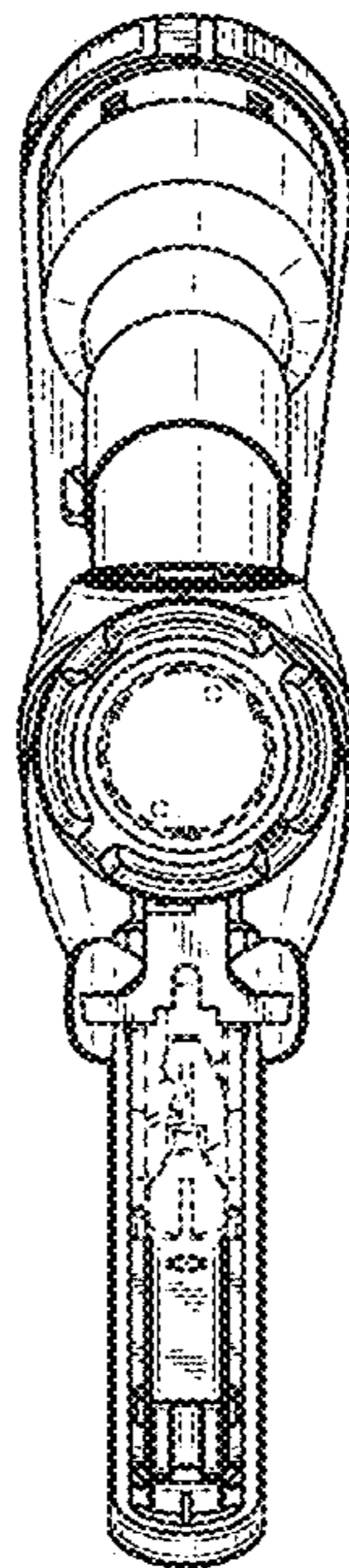

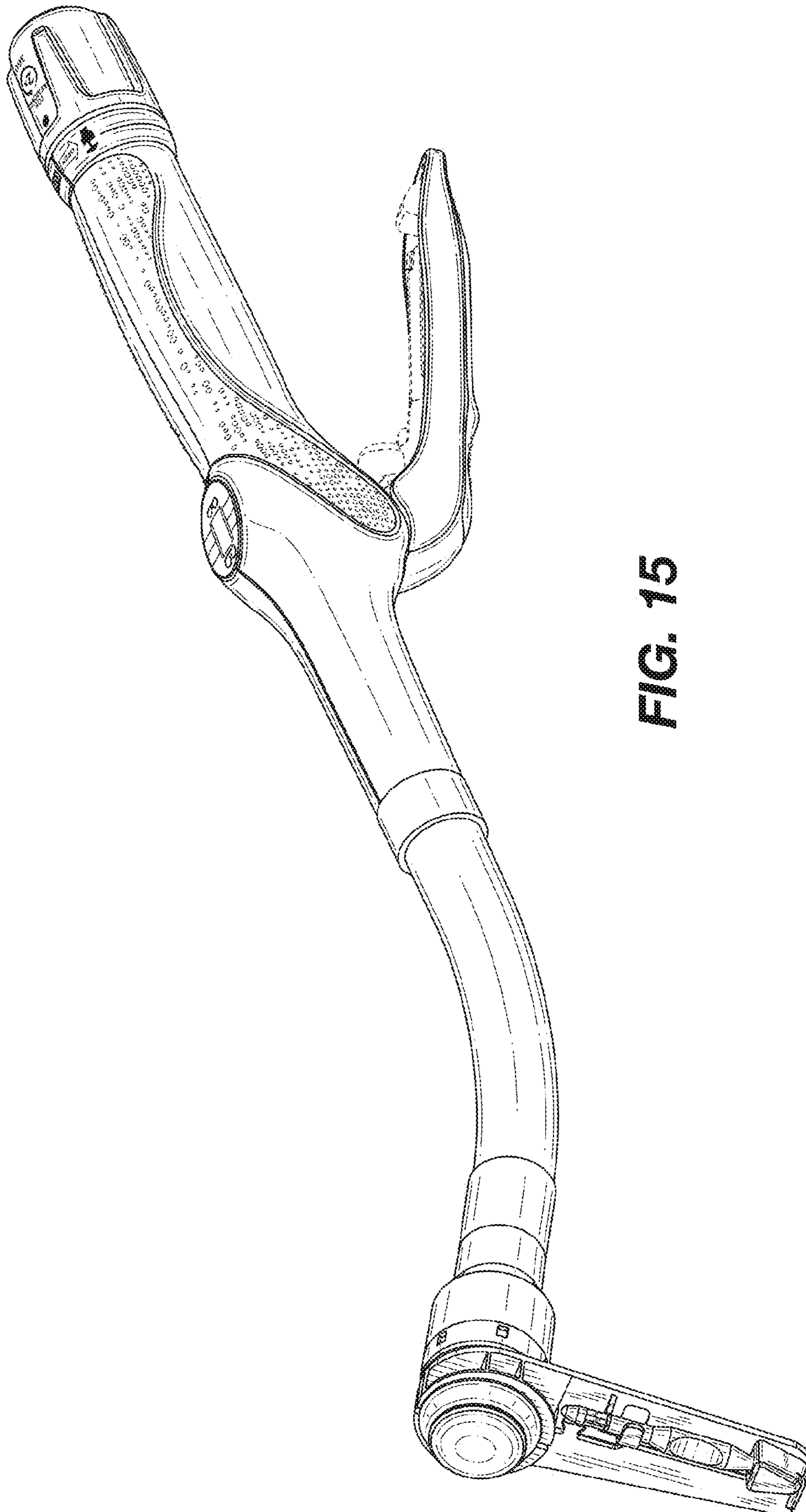
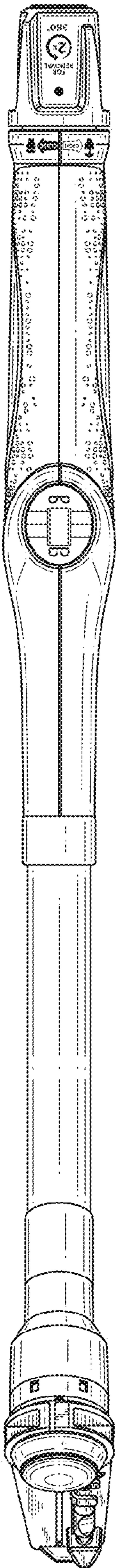
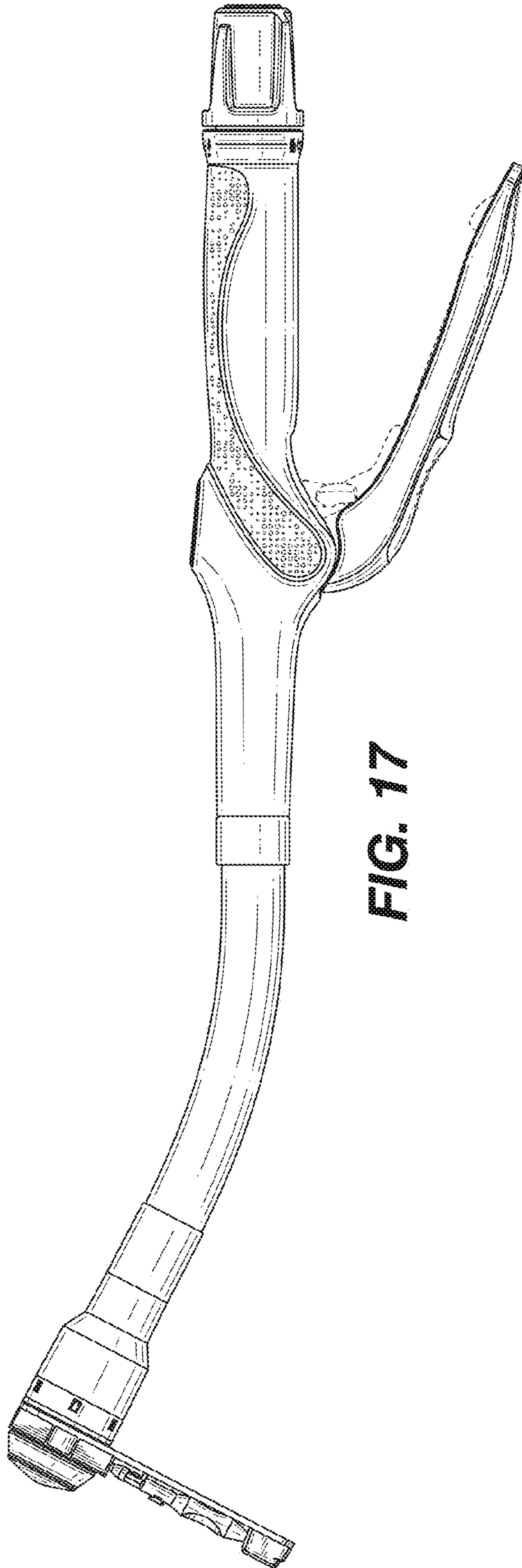


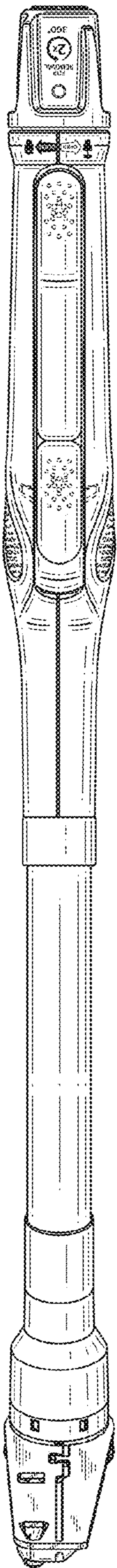

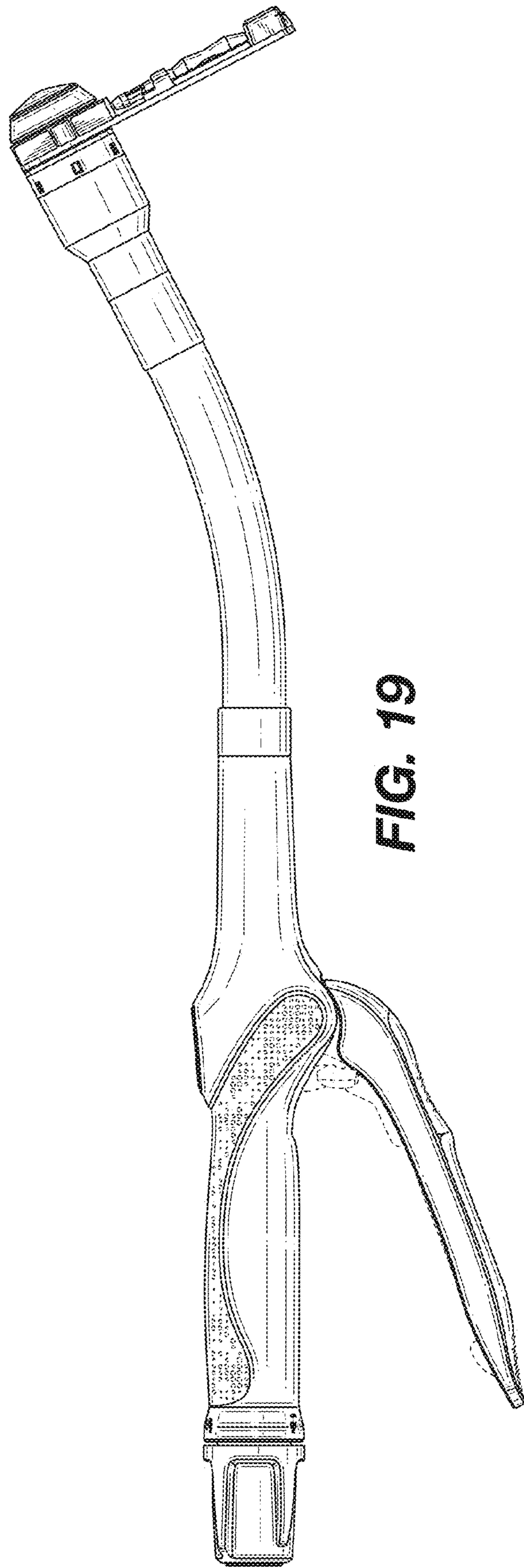

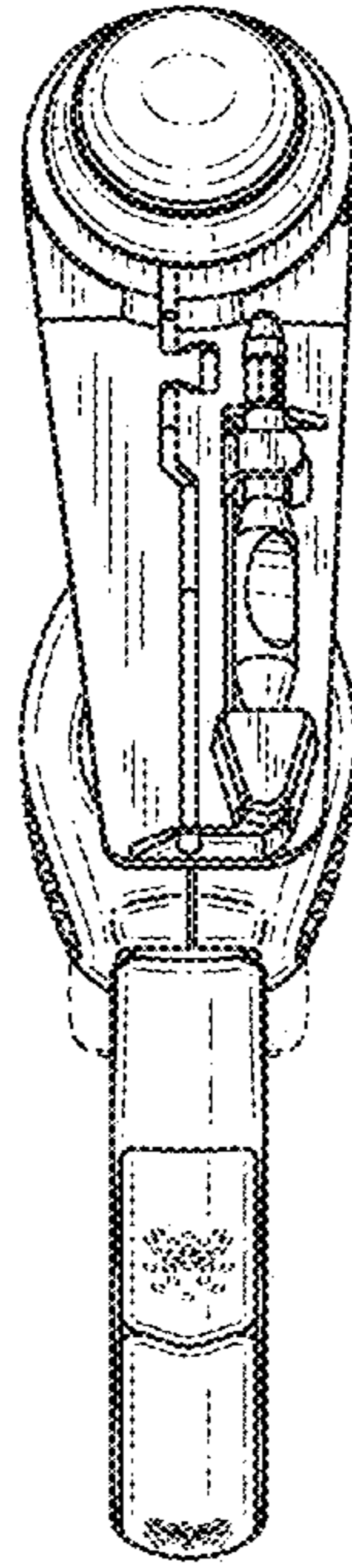

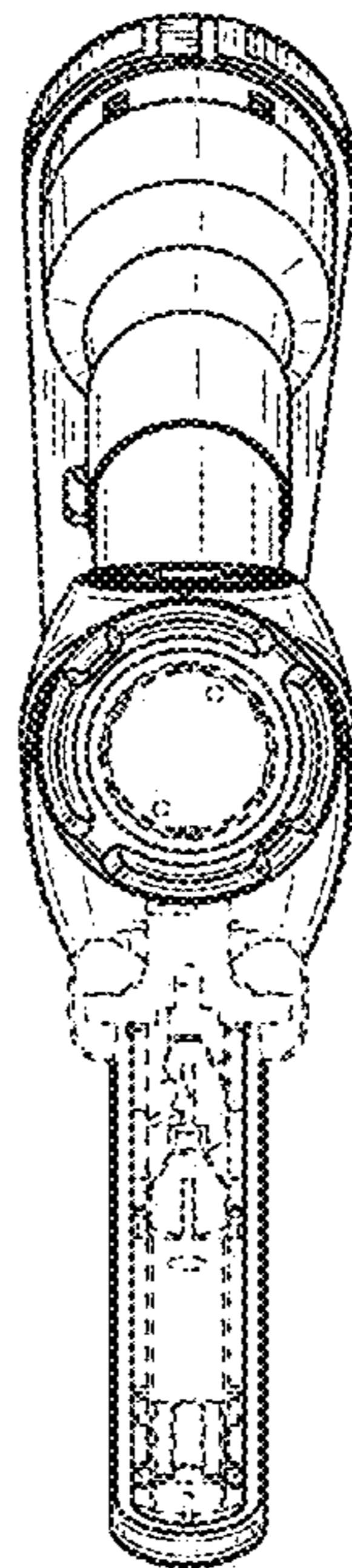
