(57) **CLAIM**

The ornamental design for an animal harness, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of an animal harness, showing my new design in an unfolded configuration for clarity of disclosure;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a rear elevation view of the animal harness of FIG. 1, in a folded configuration for clarity of disclosure;  
FIG. 4 is a top, front, right perspective view thereof; and,  
FIG. 5 is a front elevation view thereof.

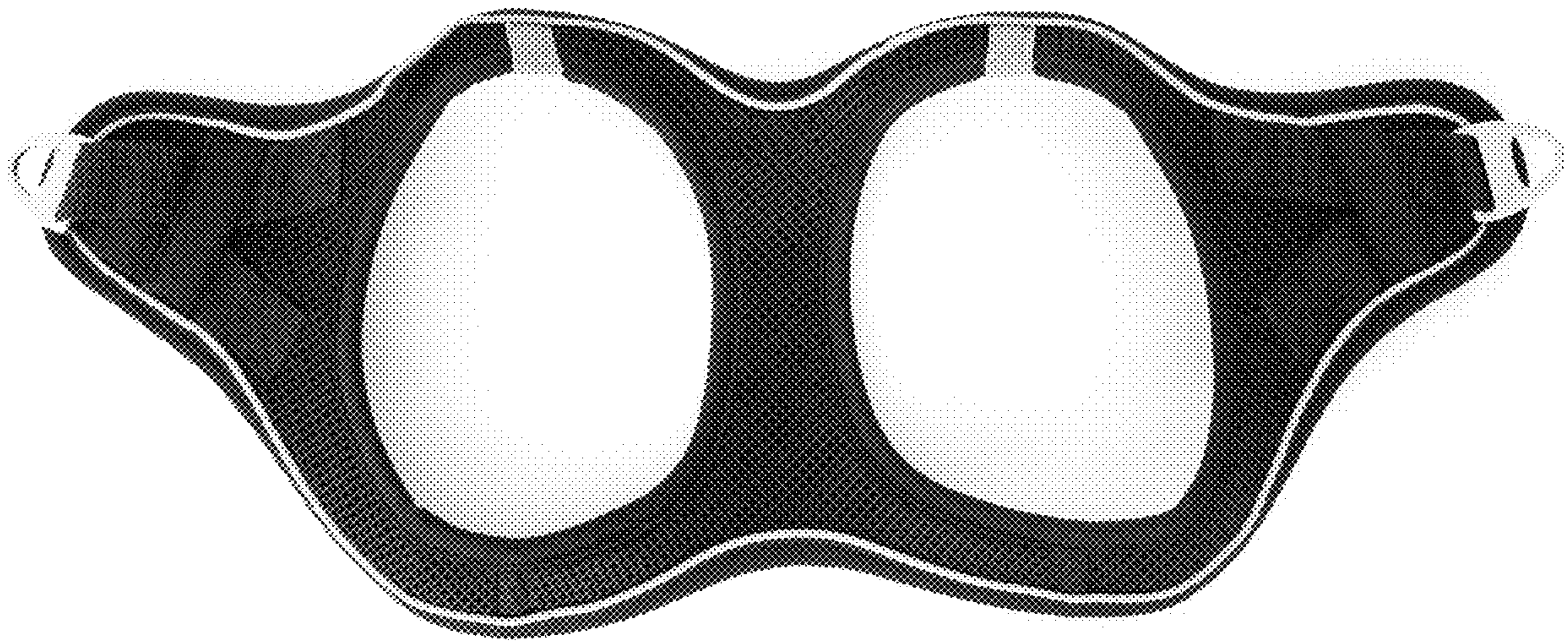
