FIG. 7 is a bottom plan view of the underwear.

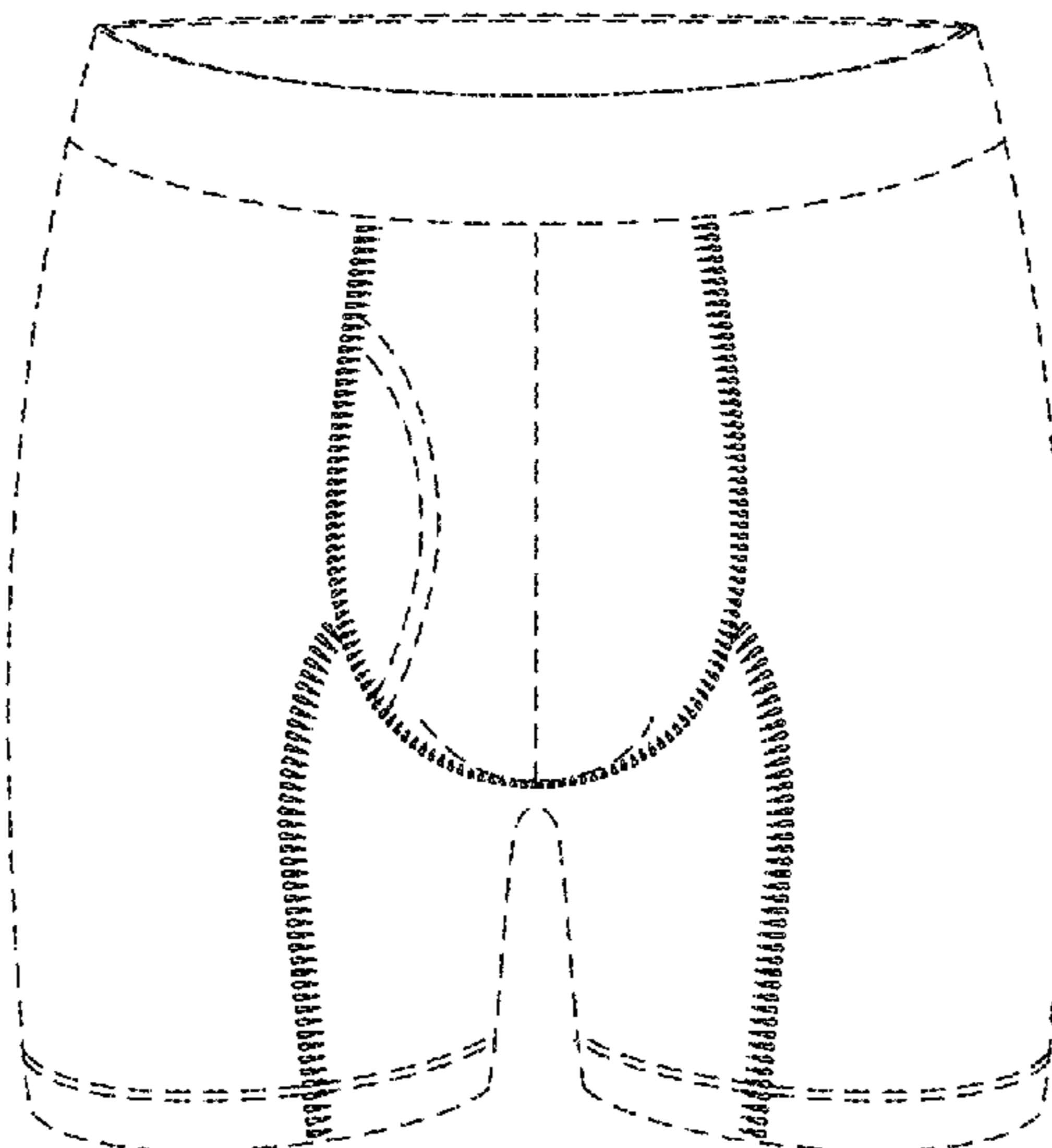
The broken lines shown in the drawings depict portions of the underwear that form no part of the claimed design.

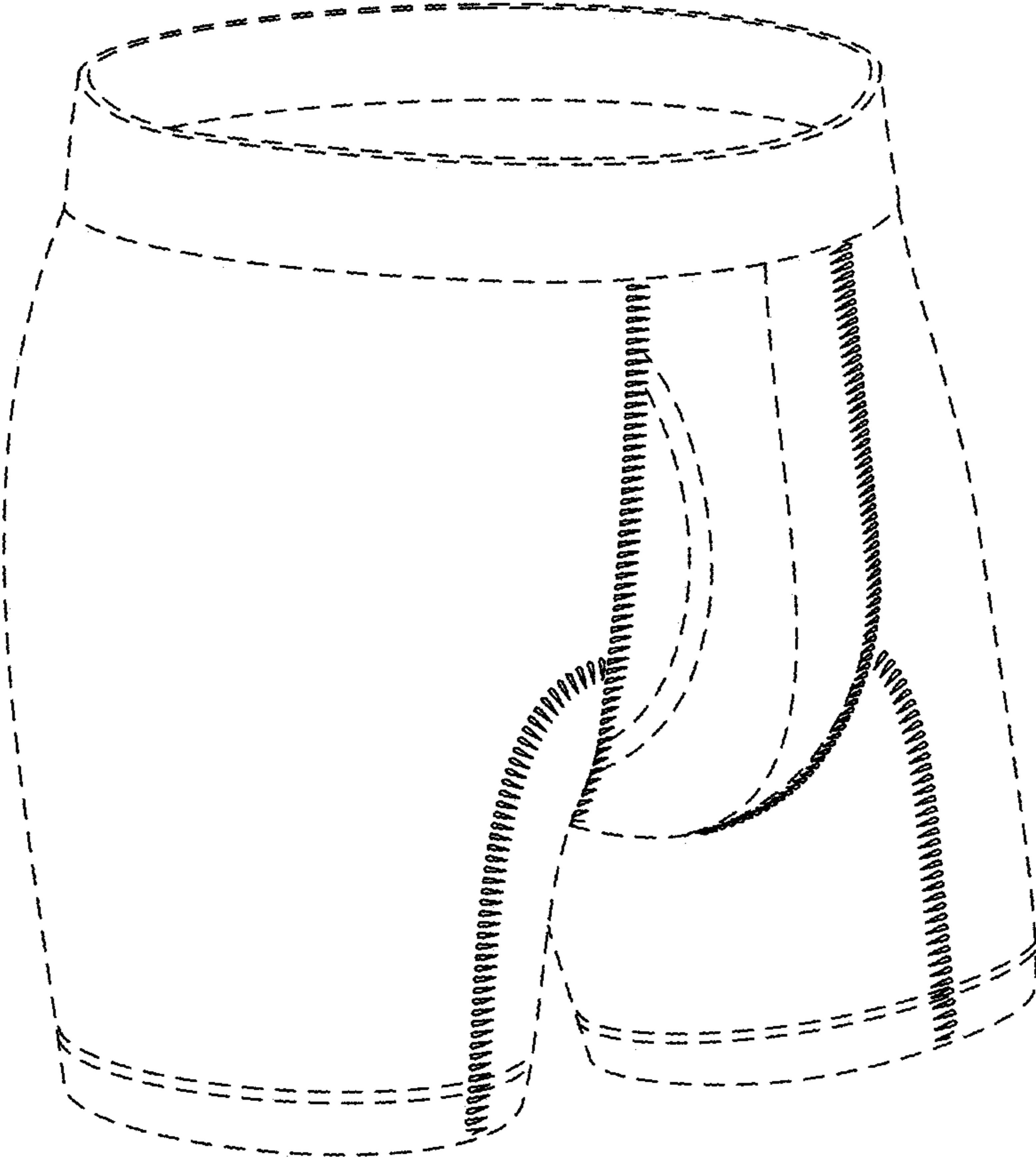

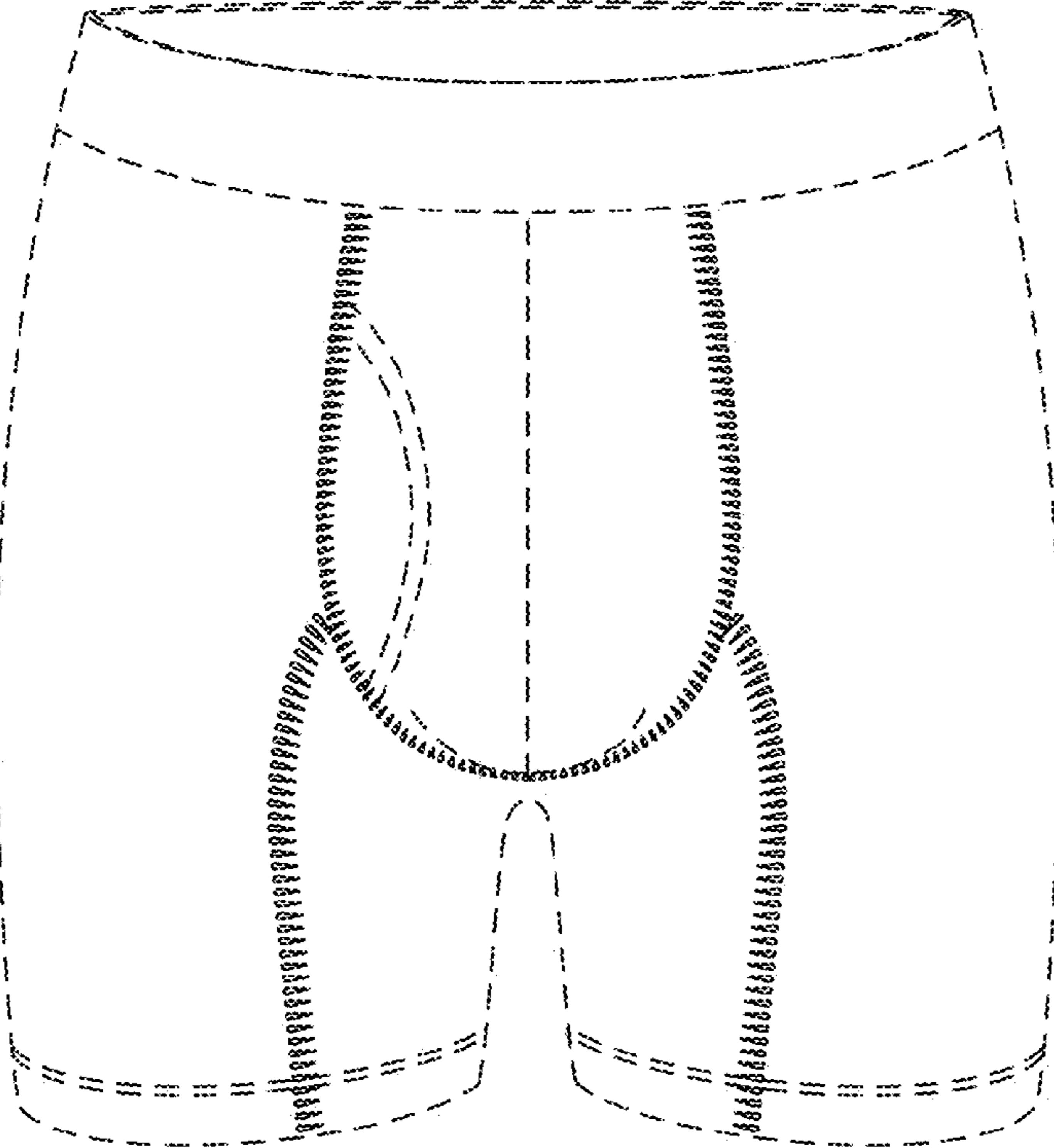

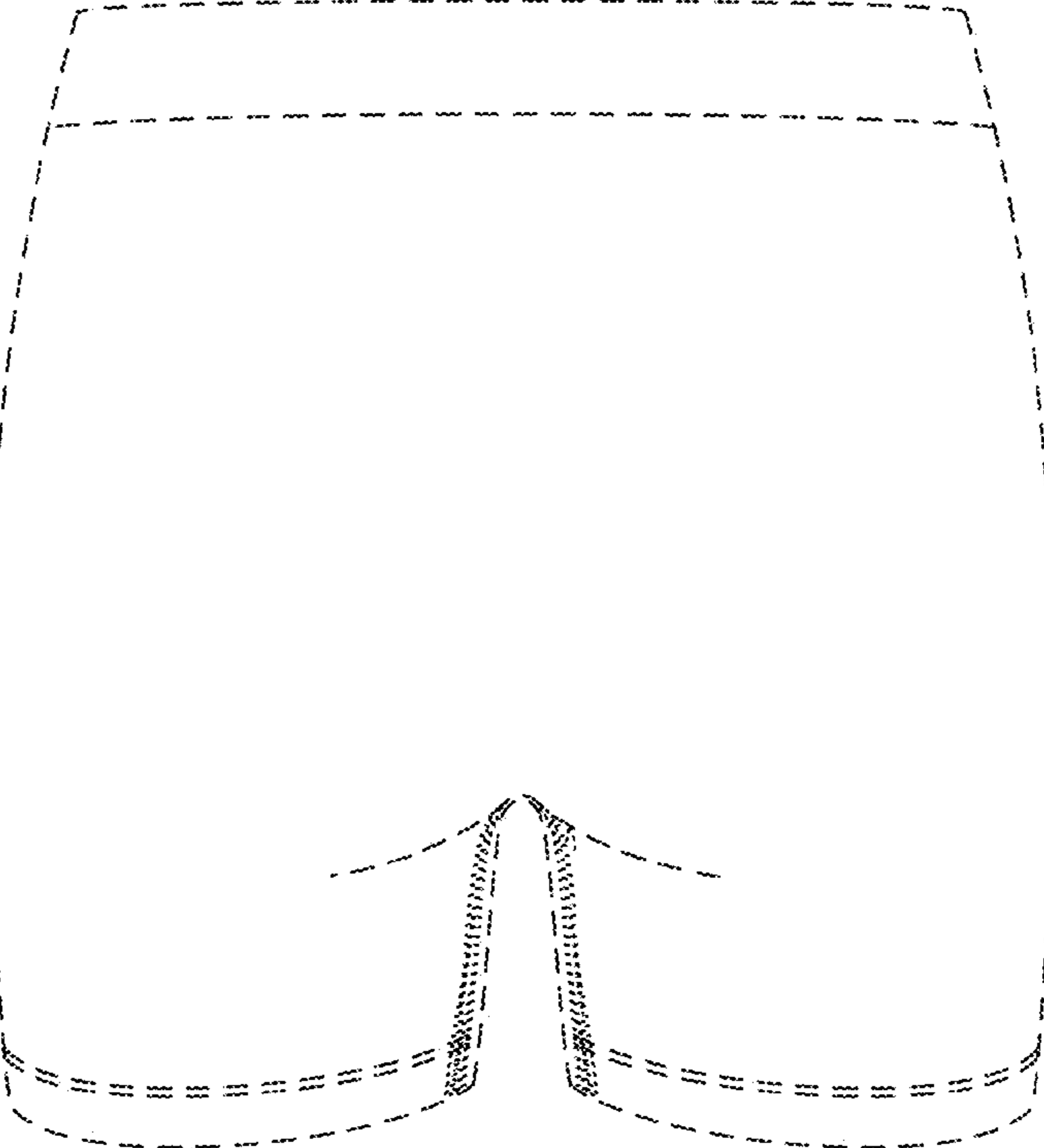

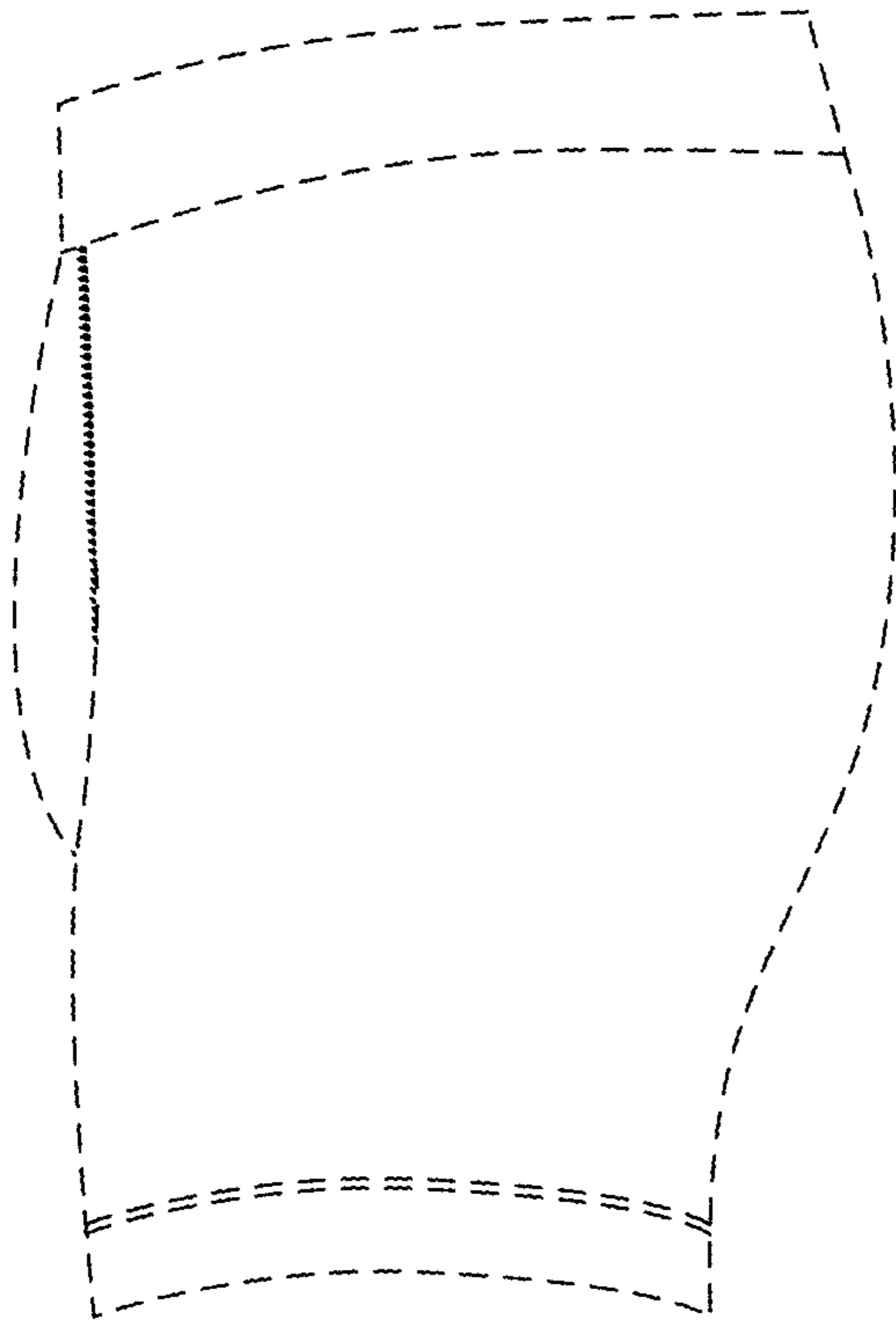

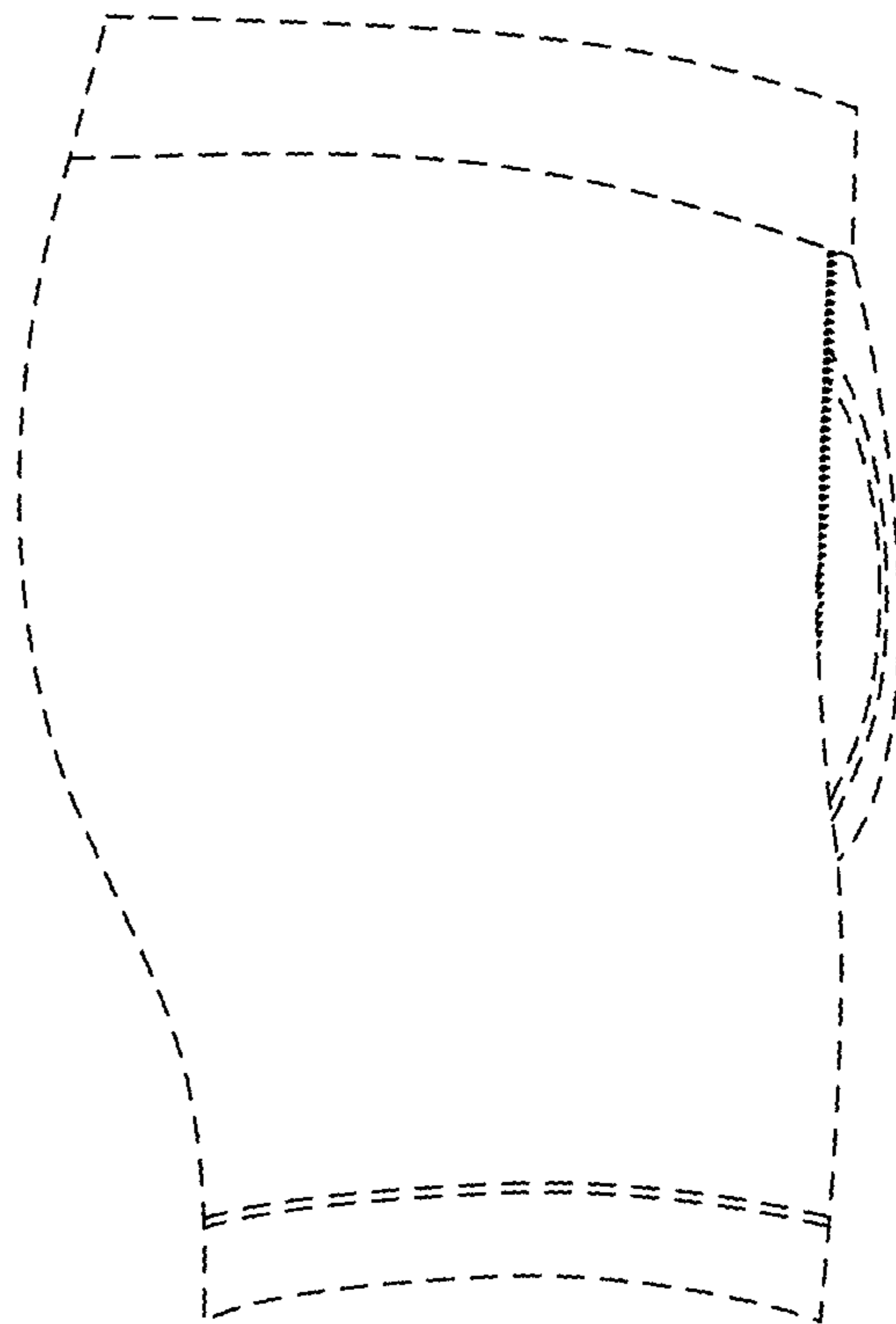

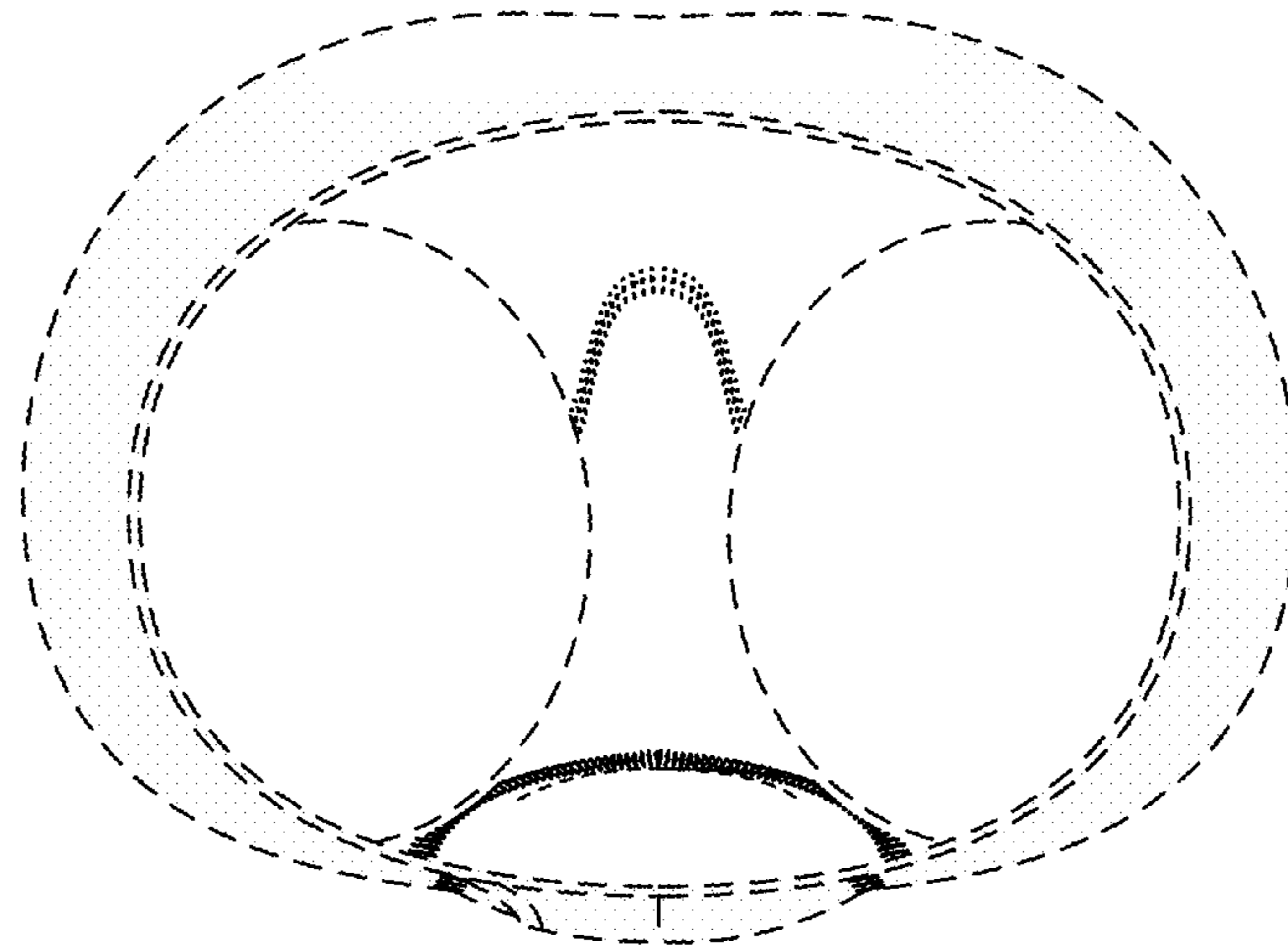

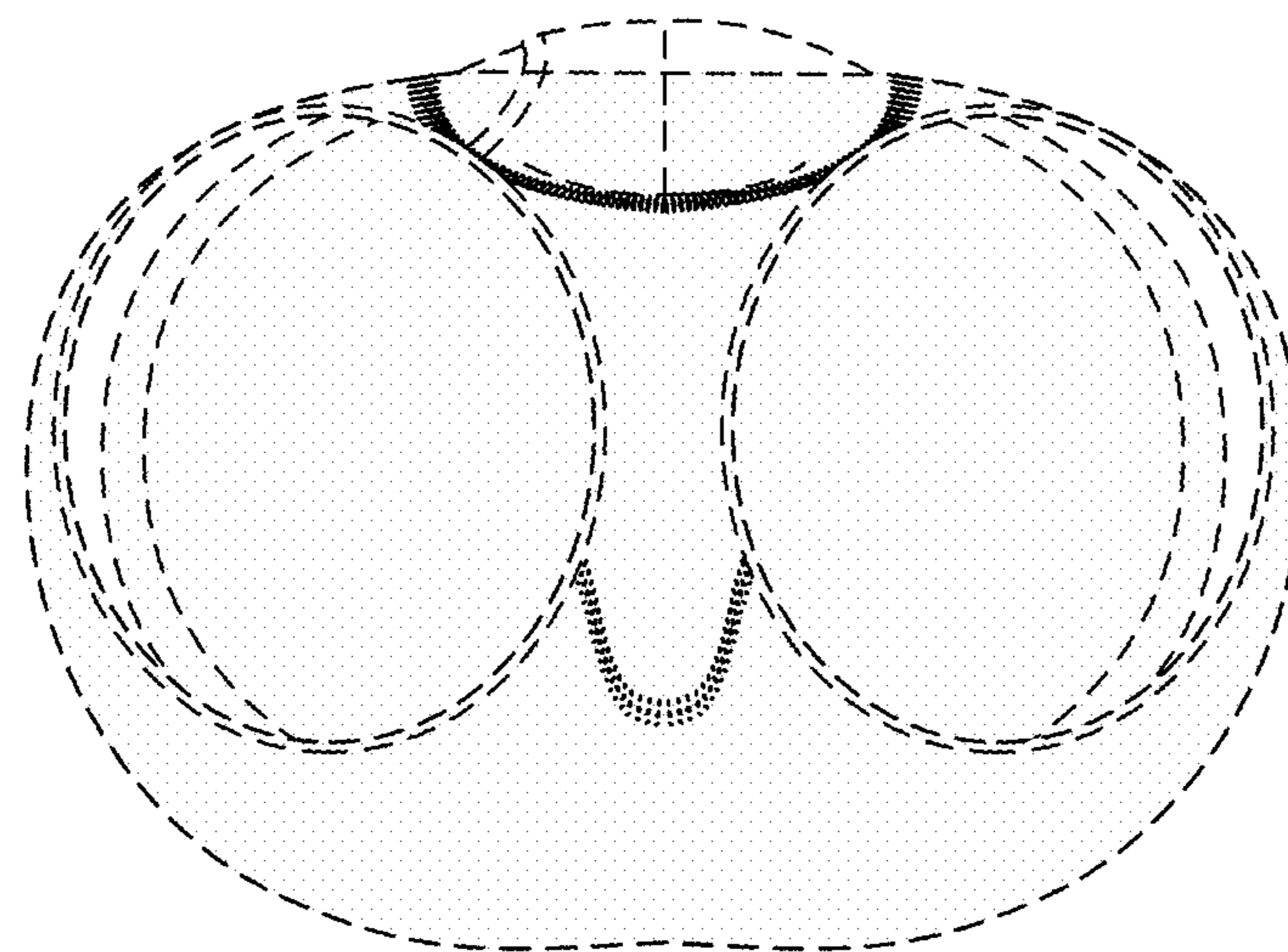
