(57) **CLAIM**

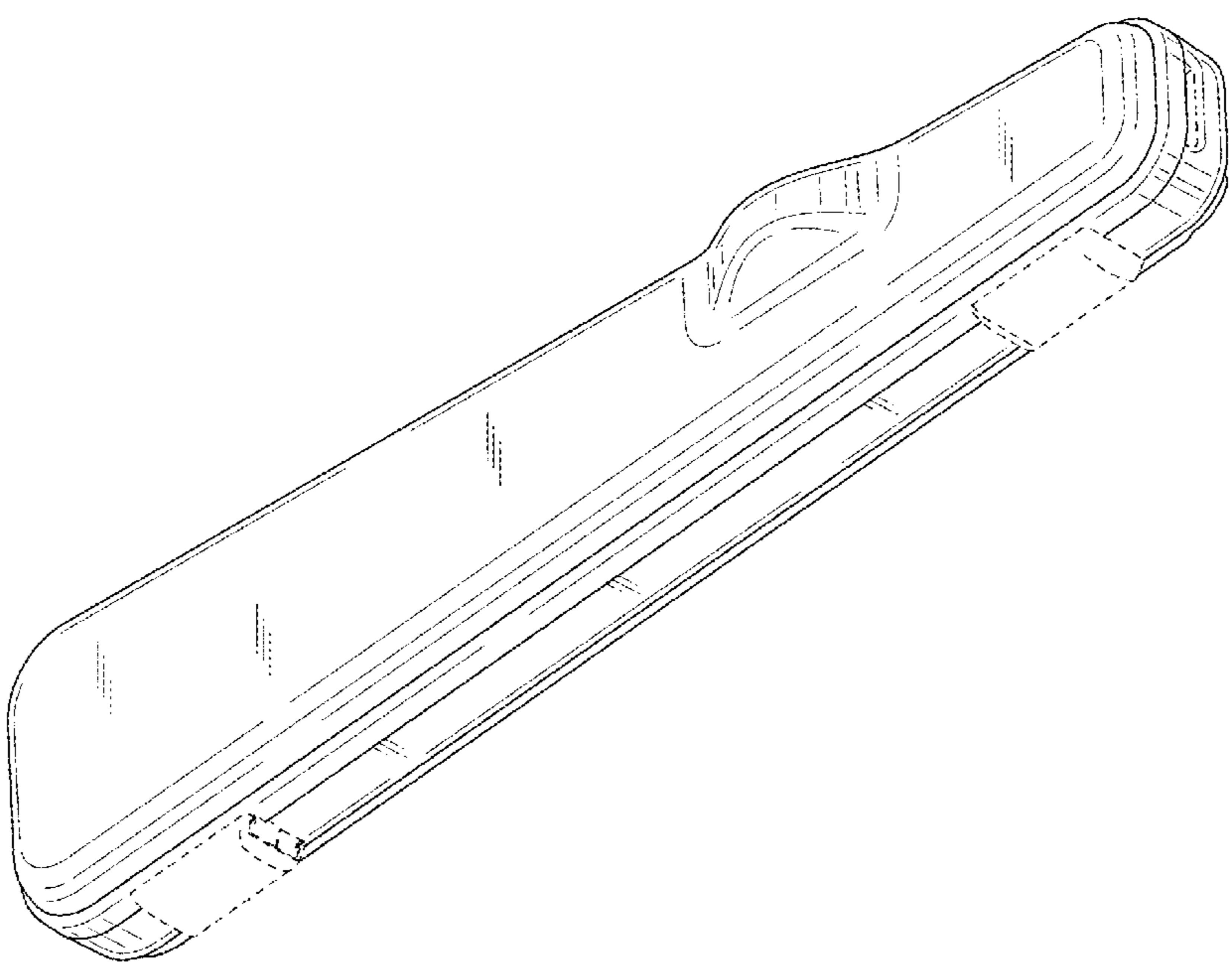
The ornamental design for a case for wind instrument, as

**DESCRIPTION**

FIG. 1 is a perspective view of the front, bottom and right  
side of a case for wind instrument showing my new design;

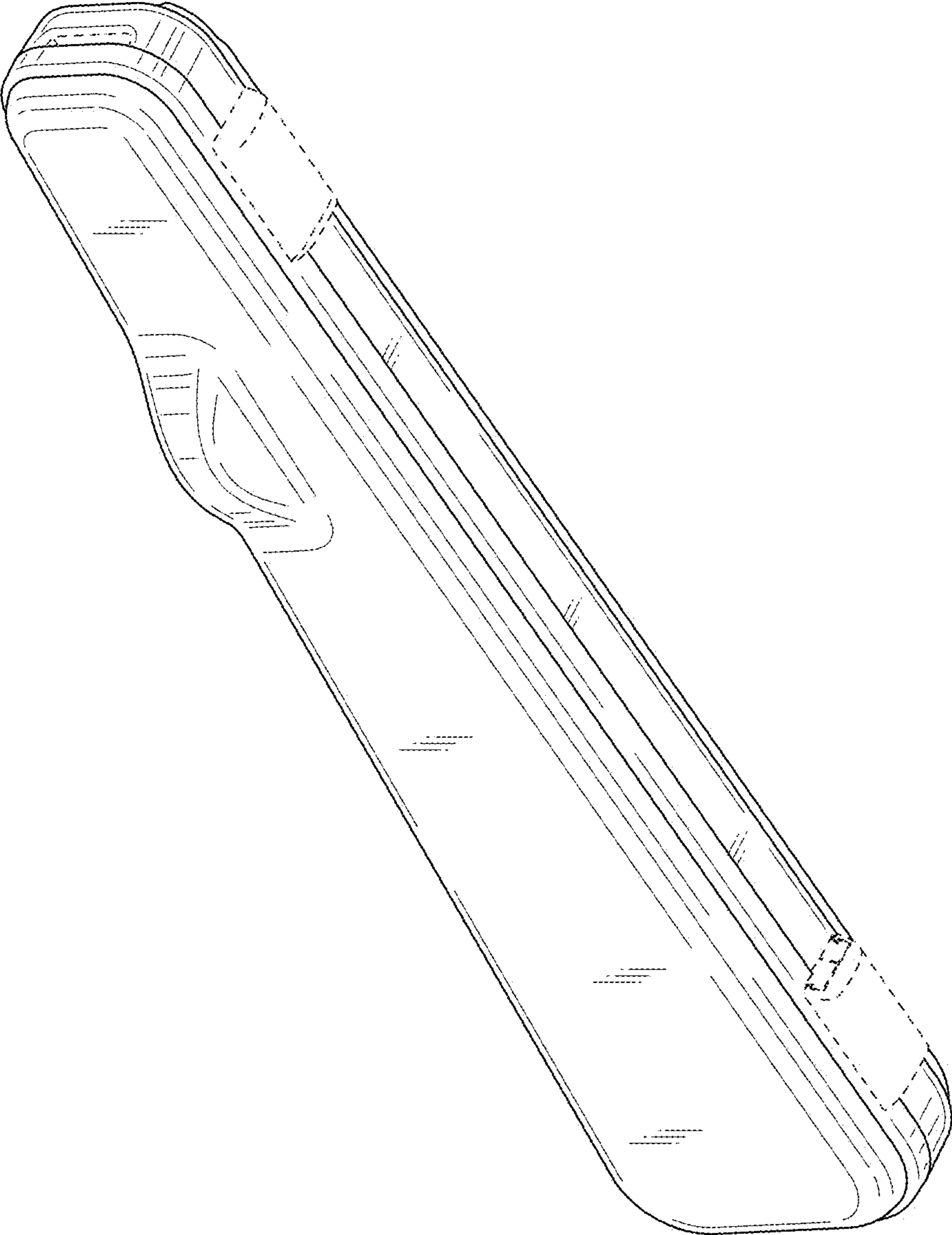

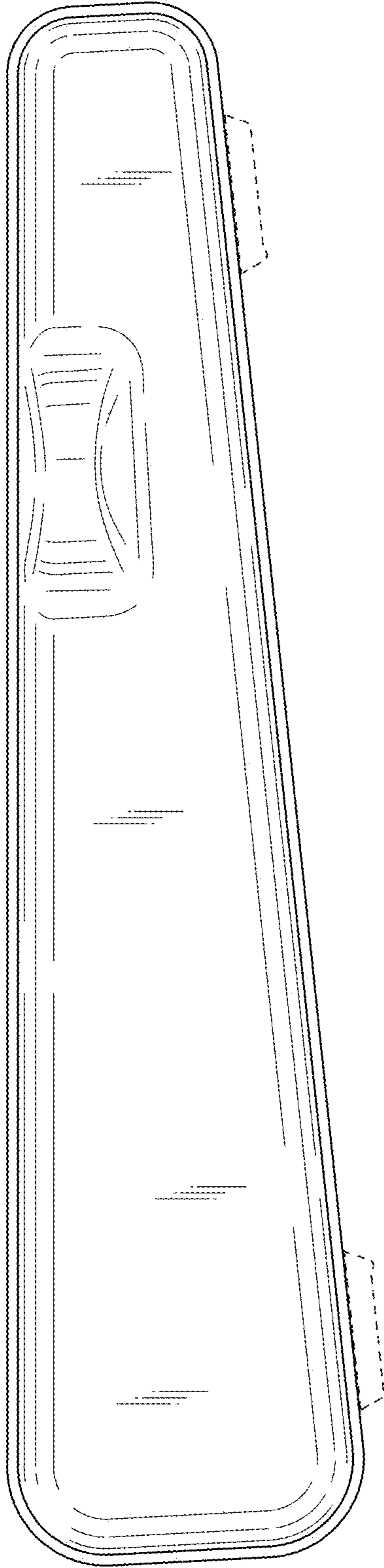

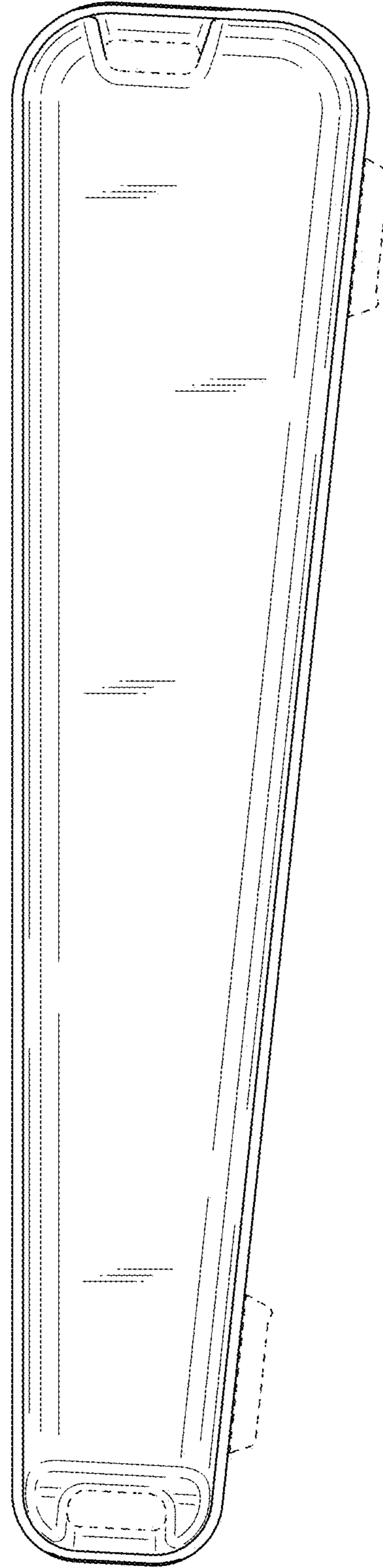

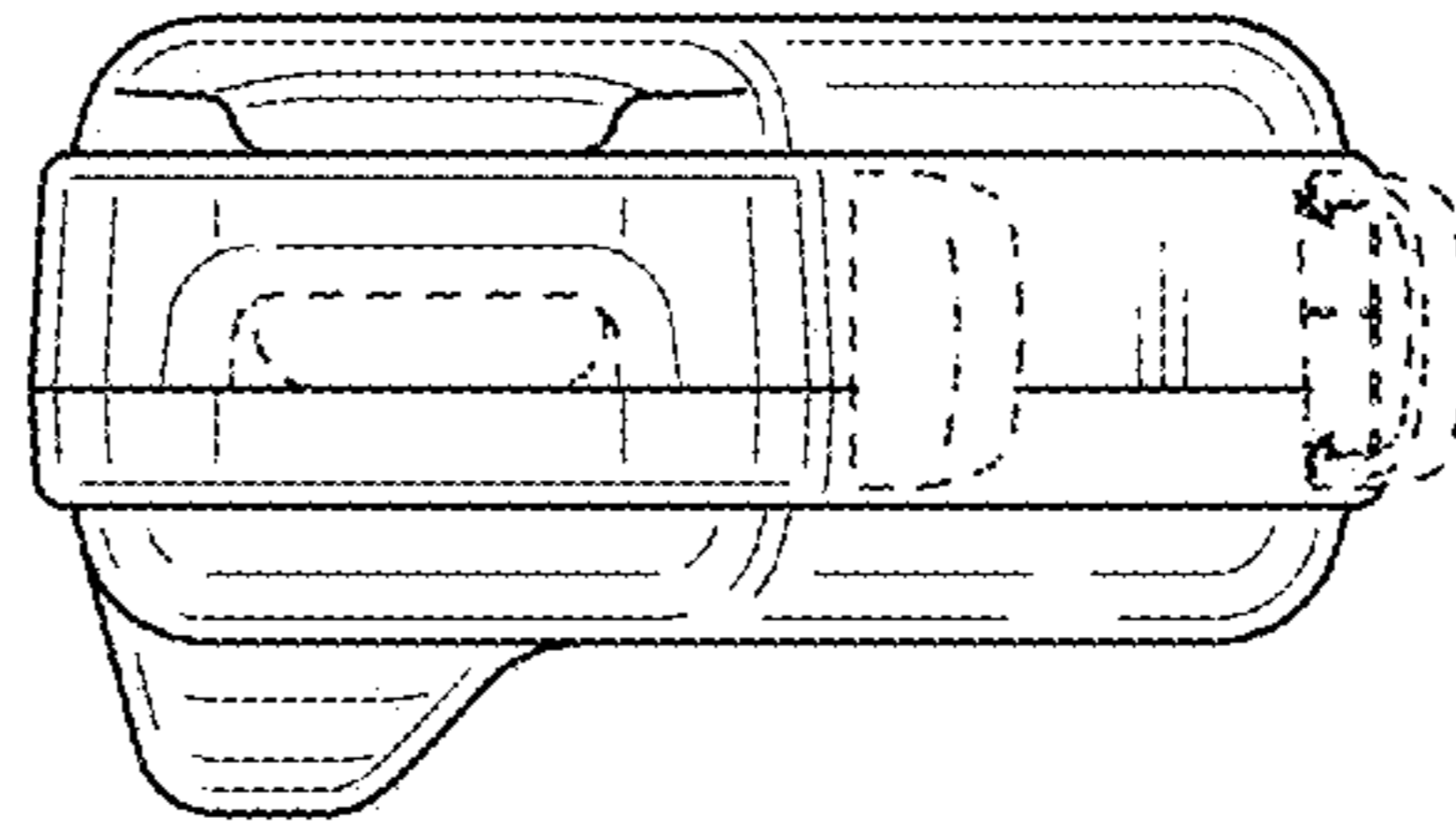

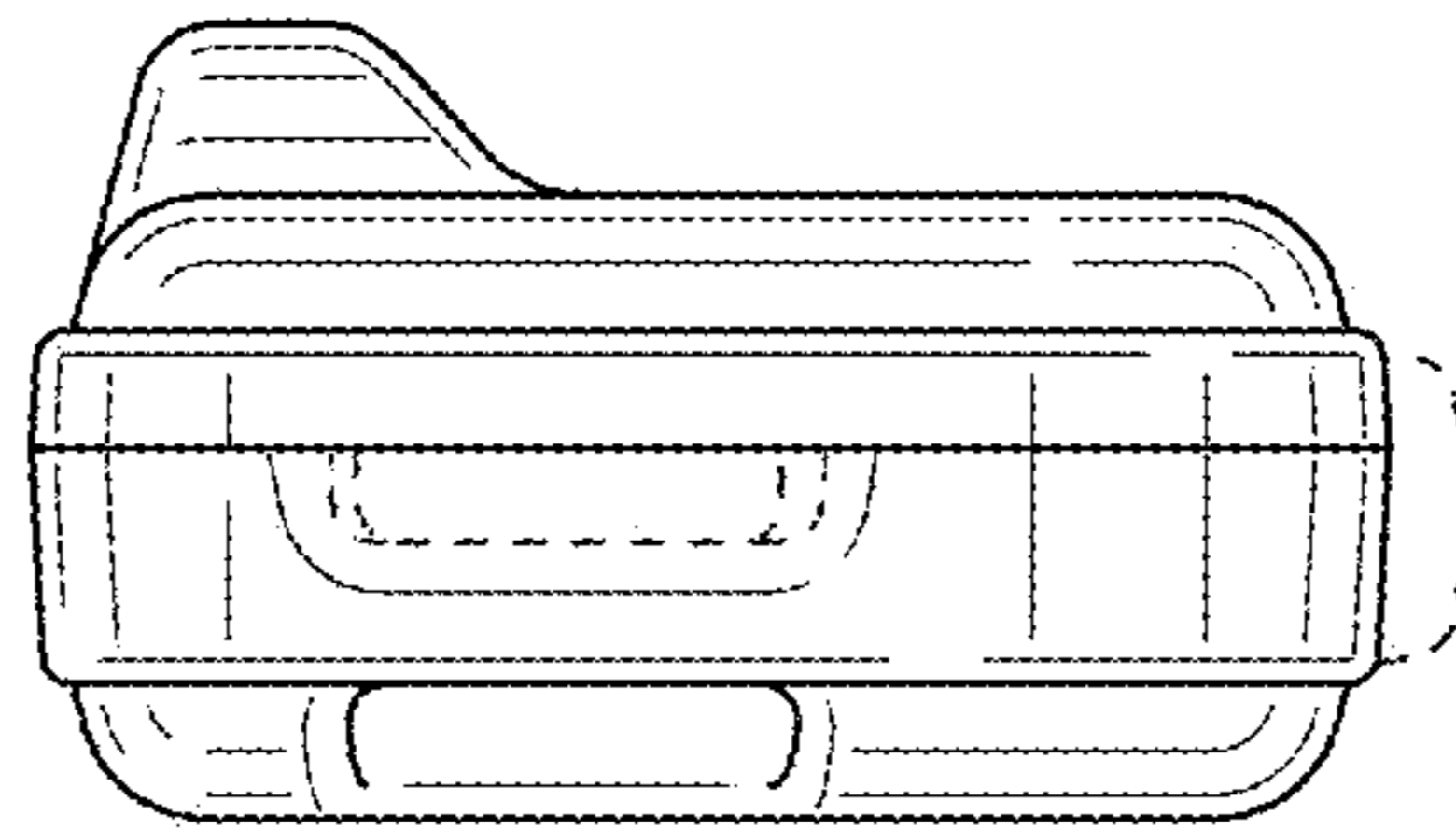

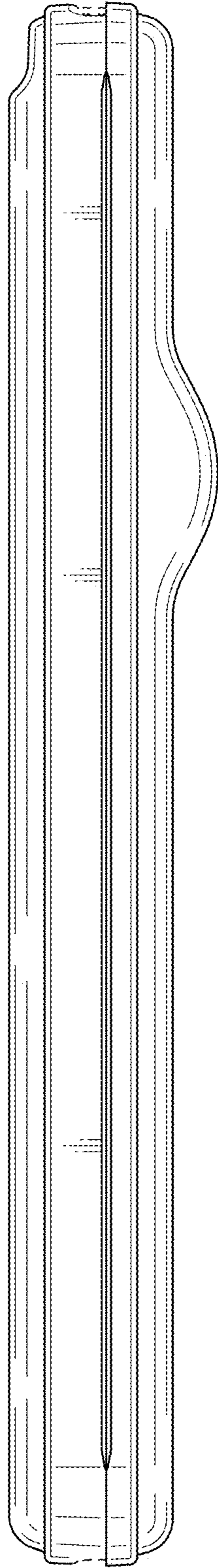
