DESCRIPTION

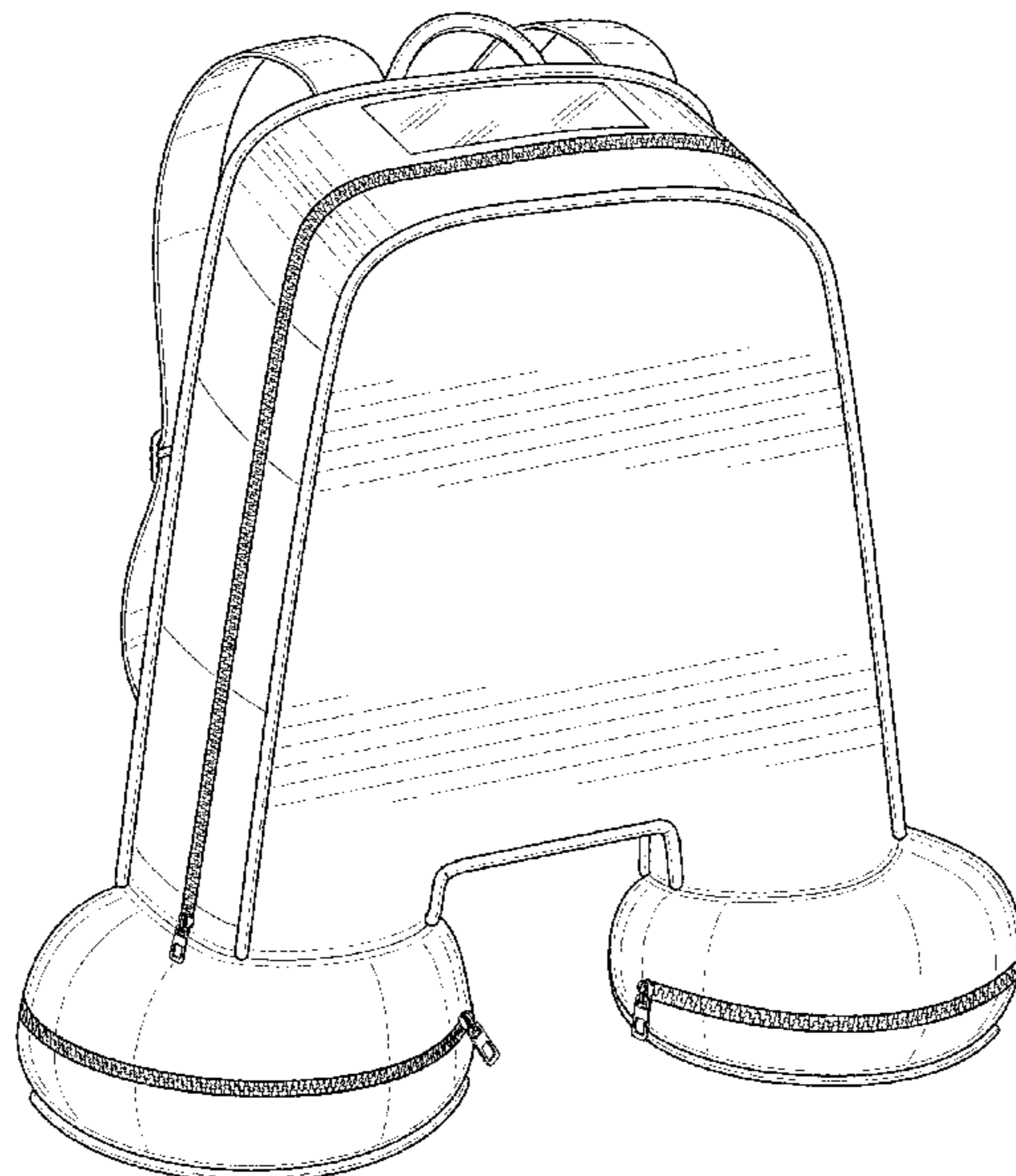
FIG. 1 shows a perspective view of the compartmented backpack.

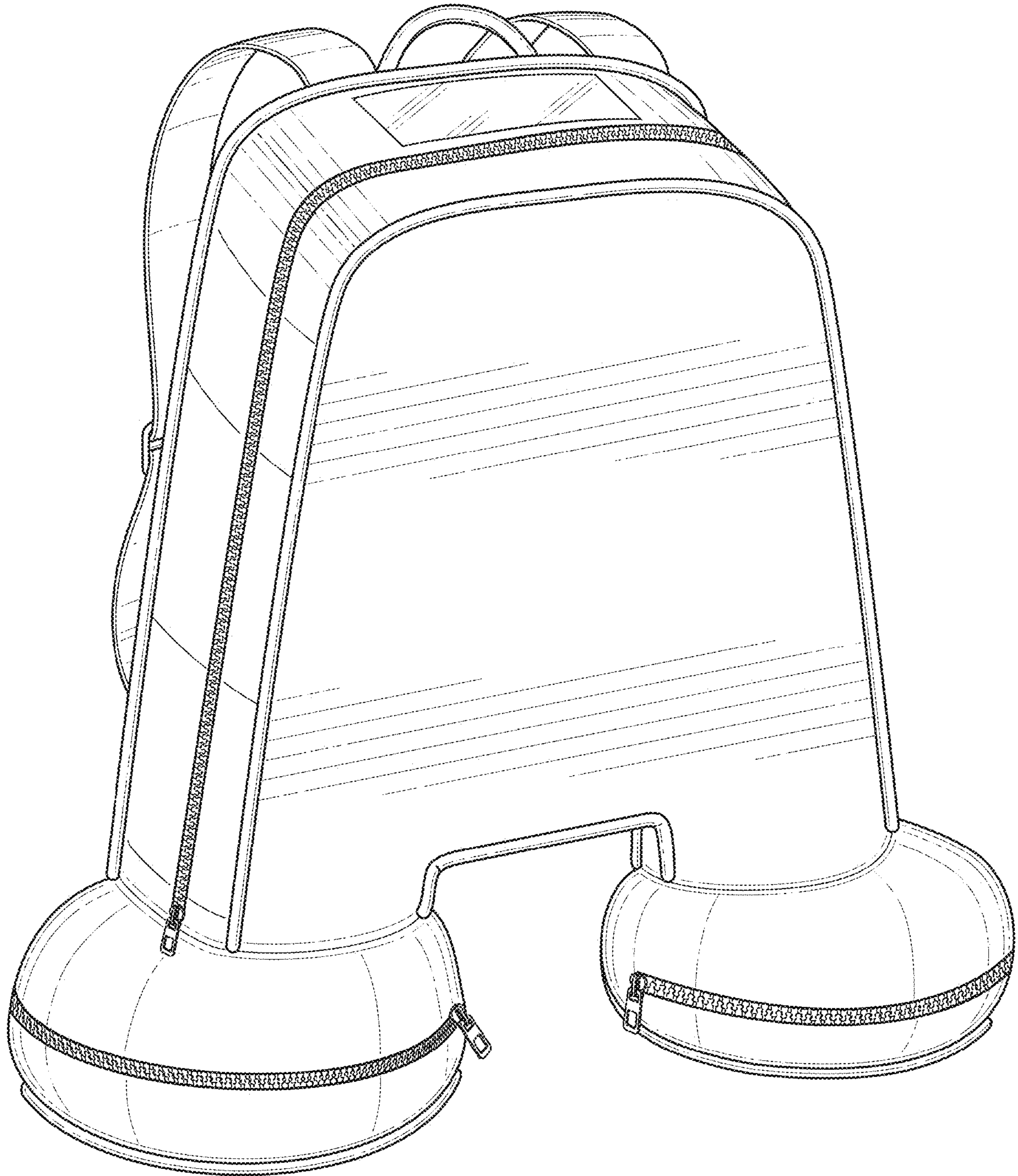

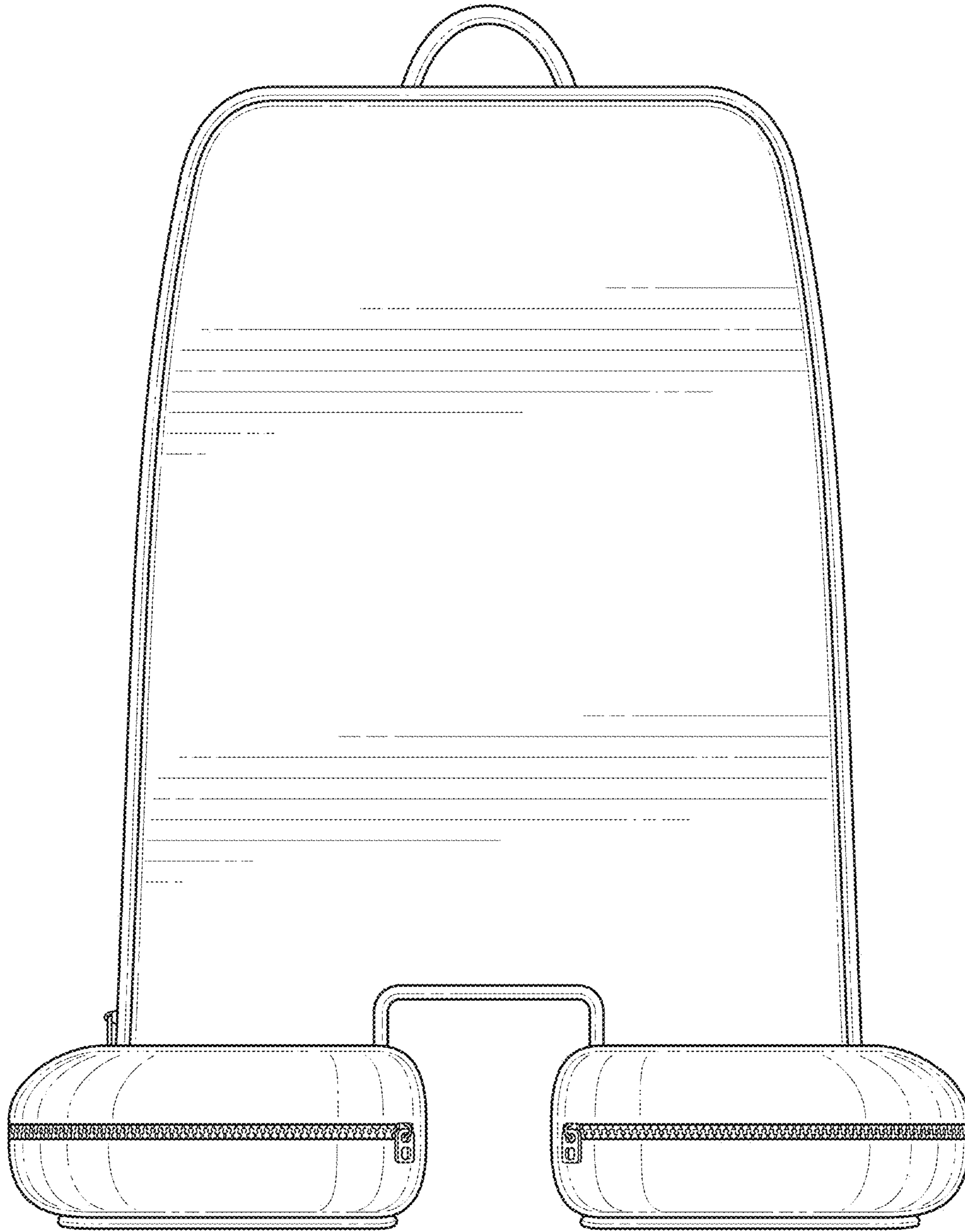

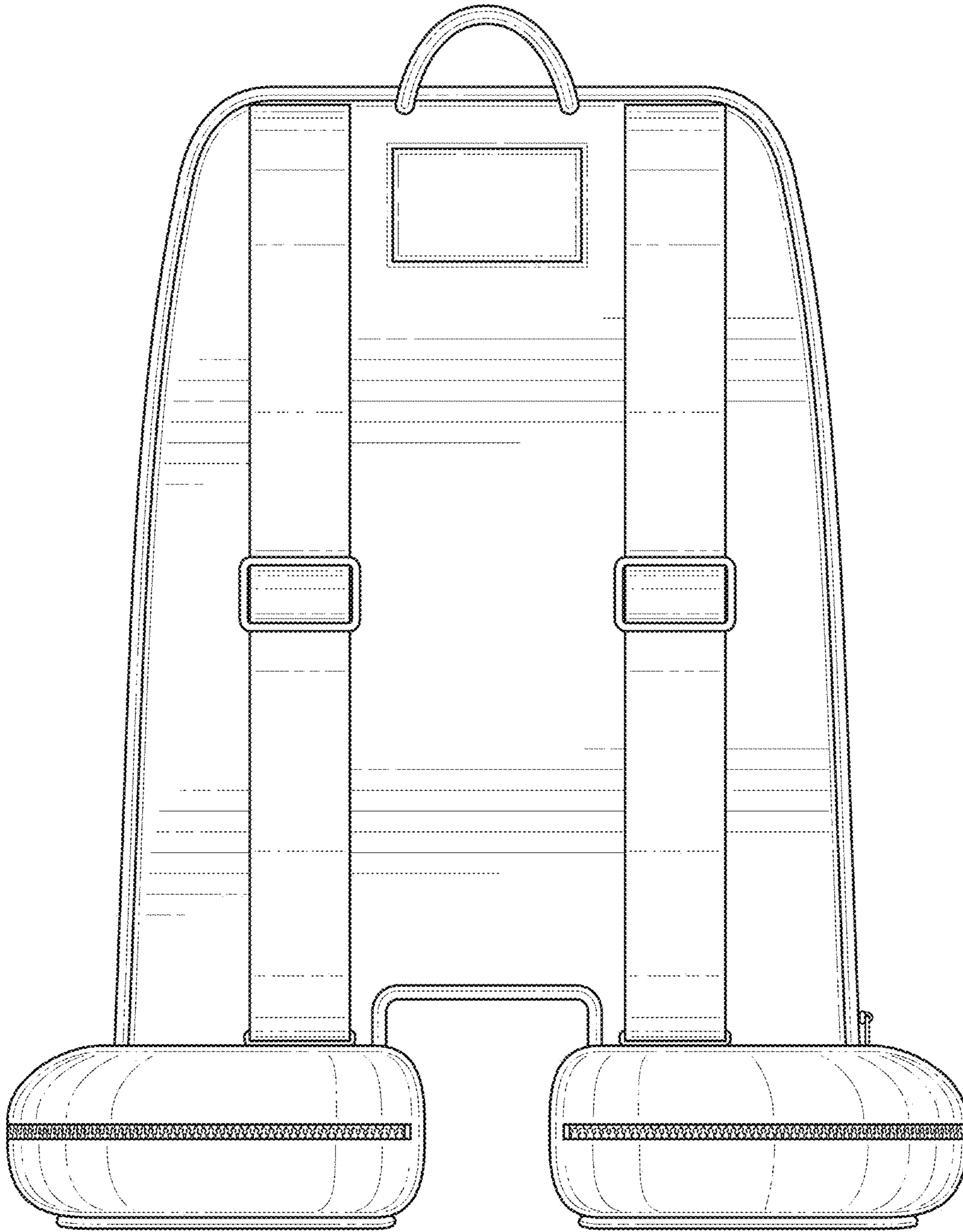

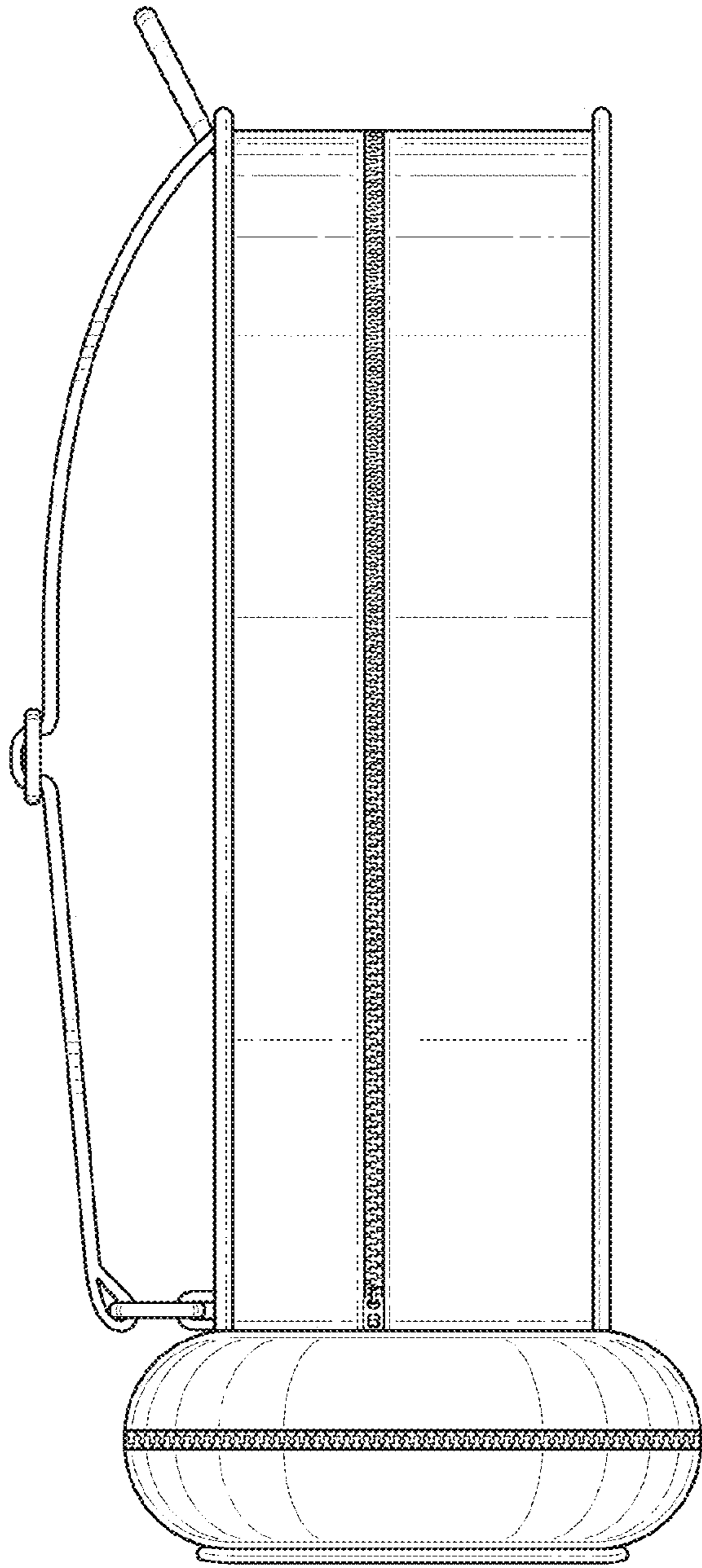

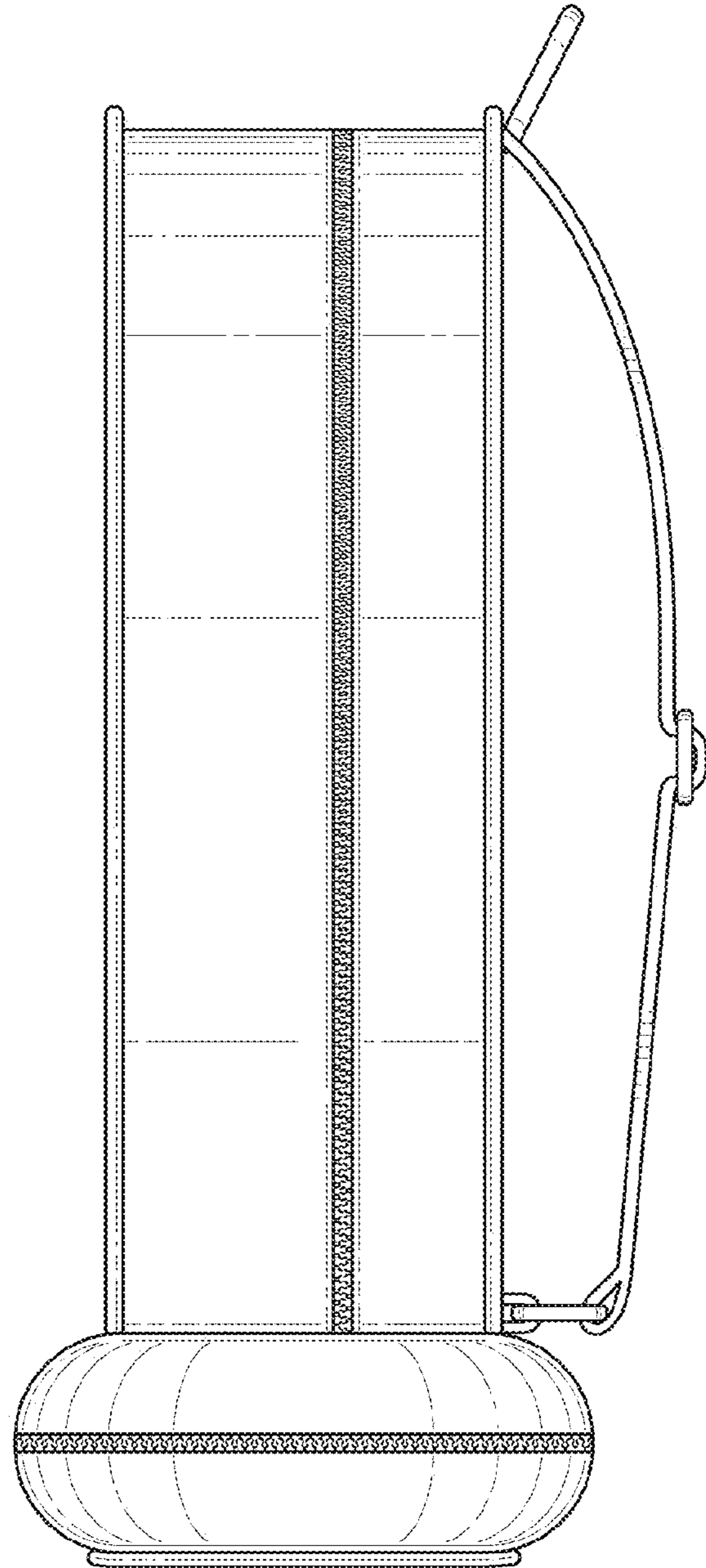

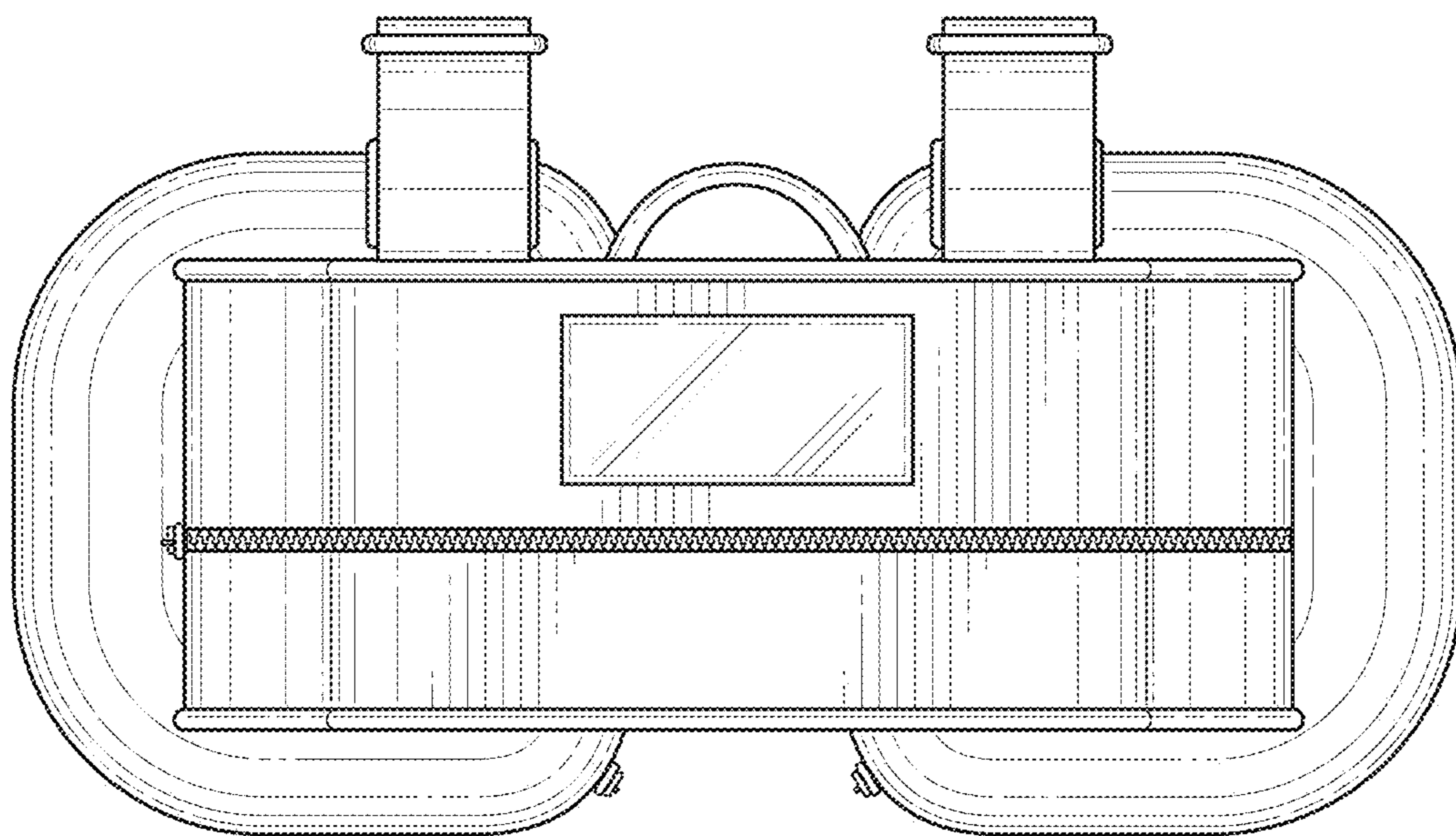

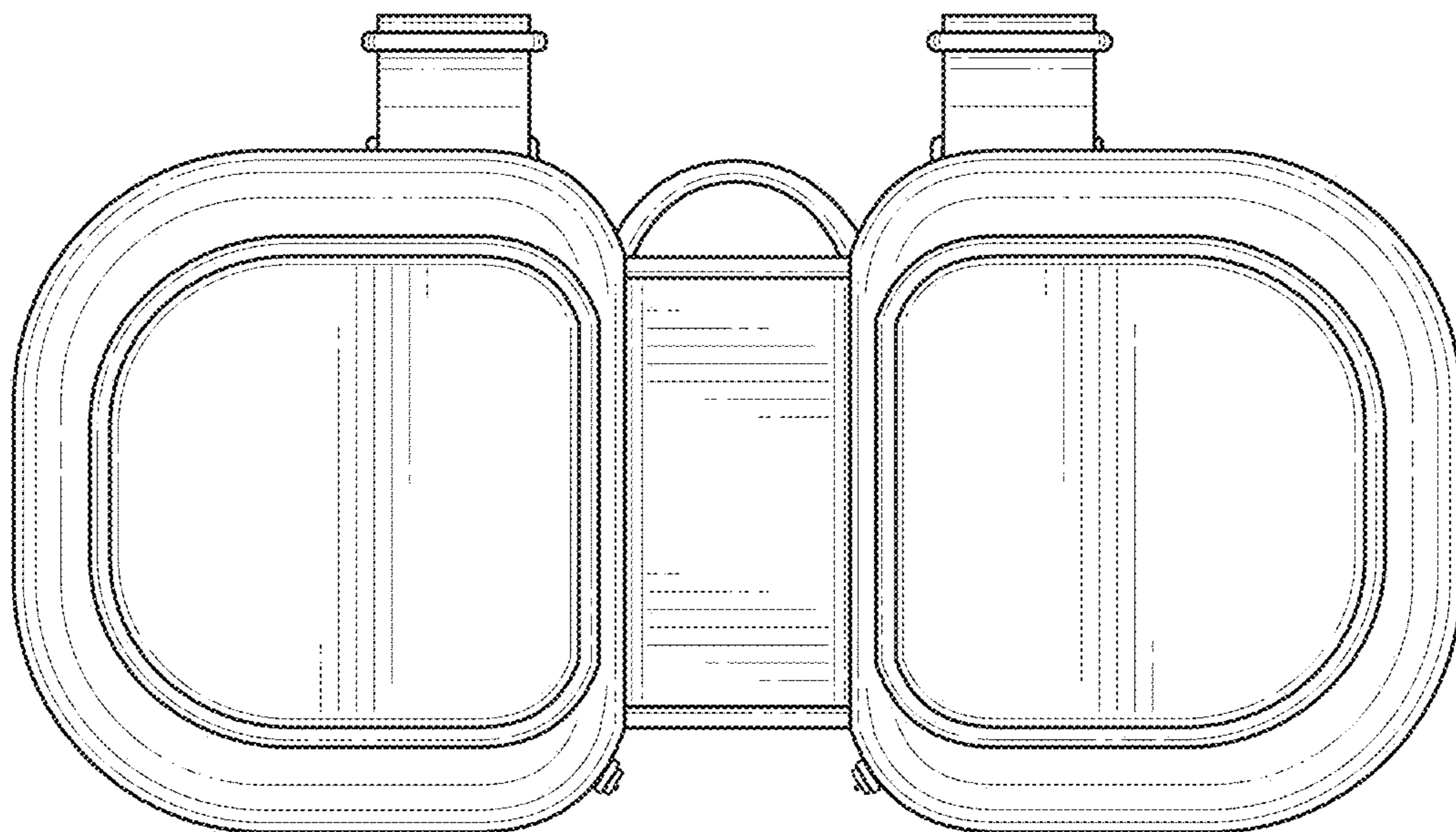
