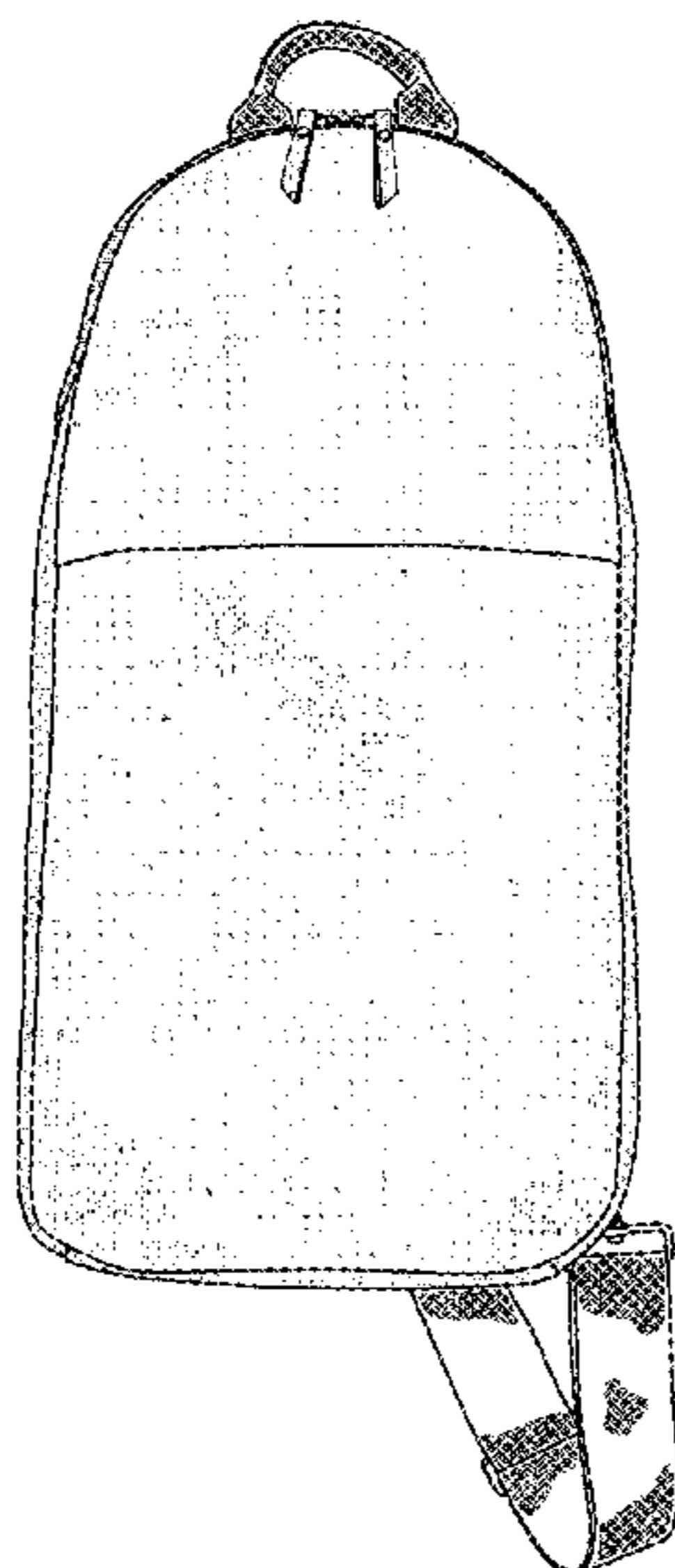

DESCRIPTION
FIG. 1 is a front view of a knife bag showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a top view thereof, with the knife bag shown in an opened state with the inner panels closed; FIG. 8 is a top view thereof, with the inner panels shown opened; and, FIG. 9 is a bottom view thereof.

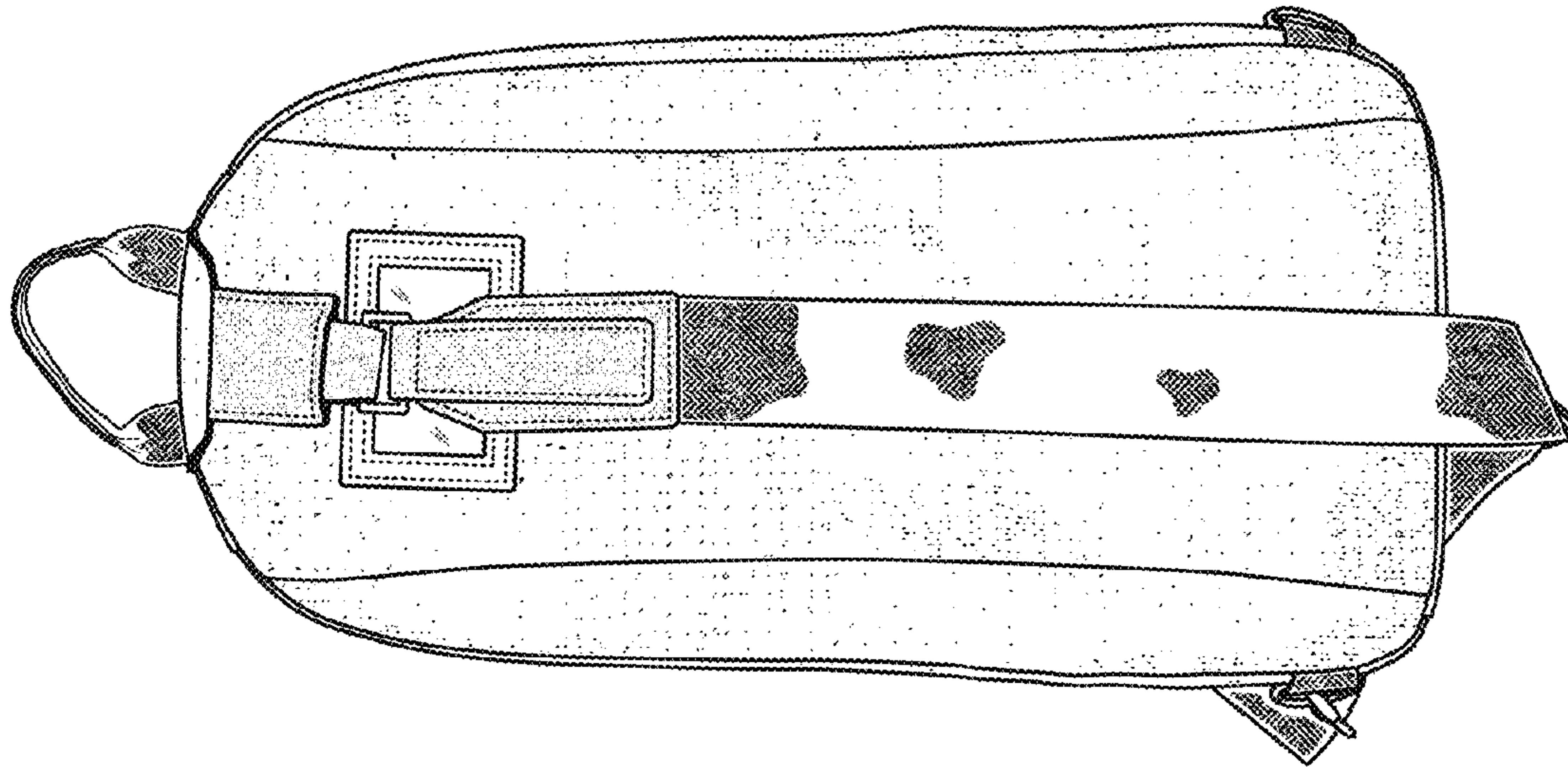

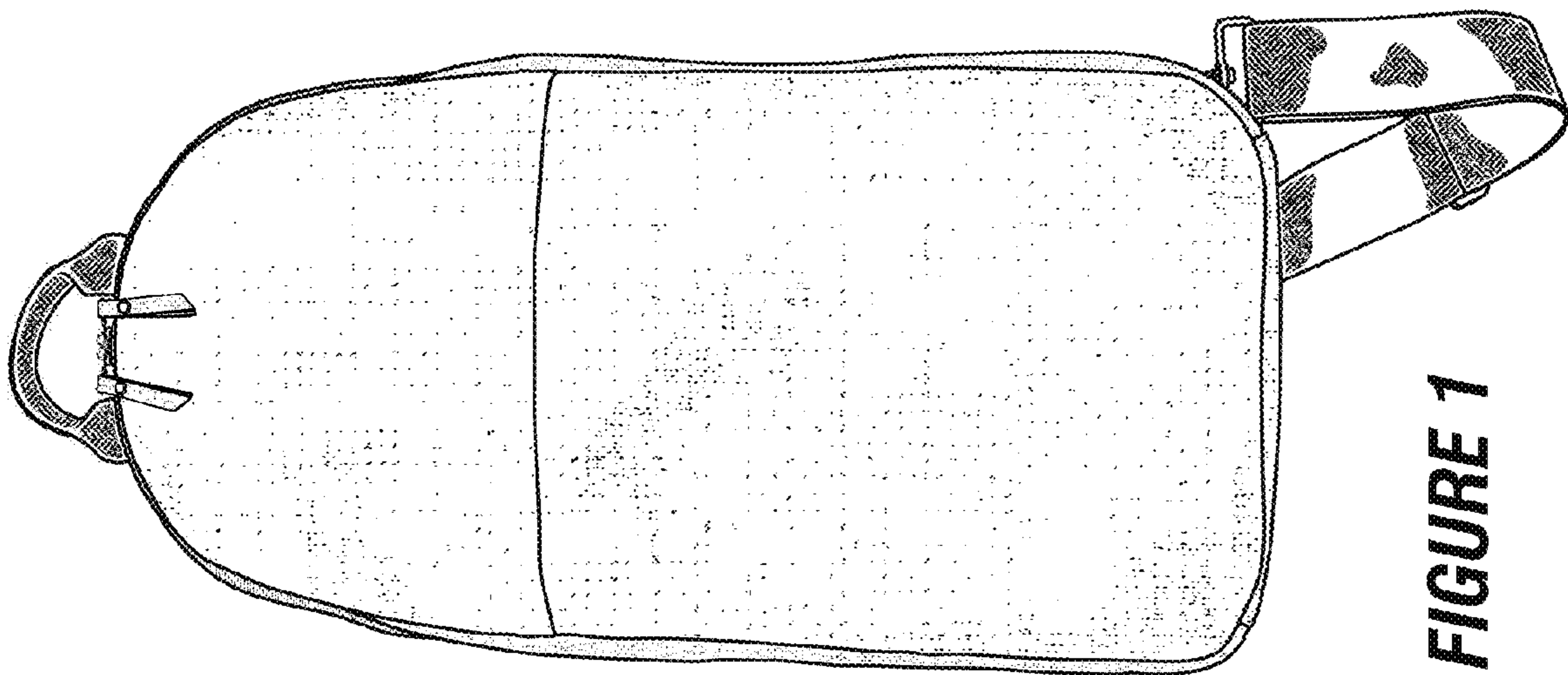

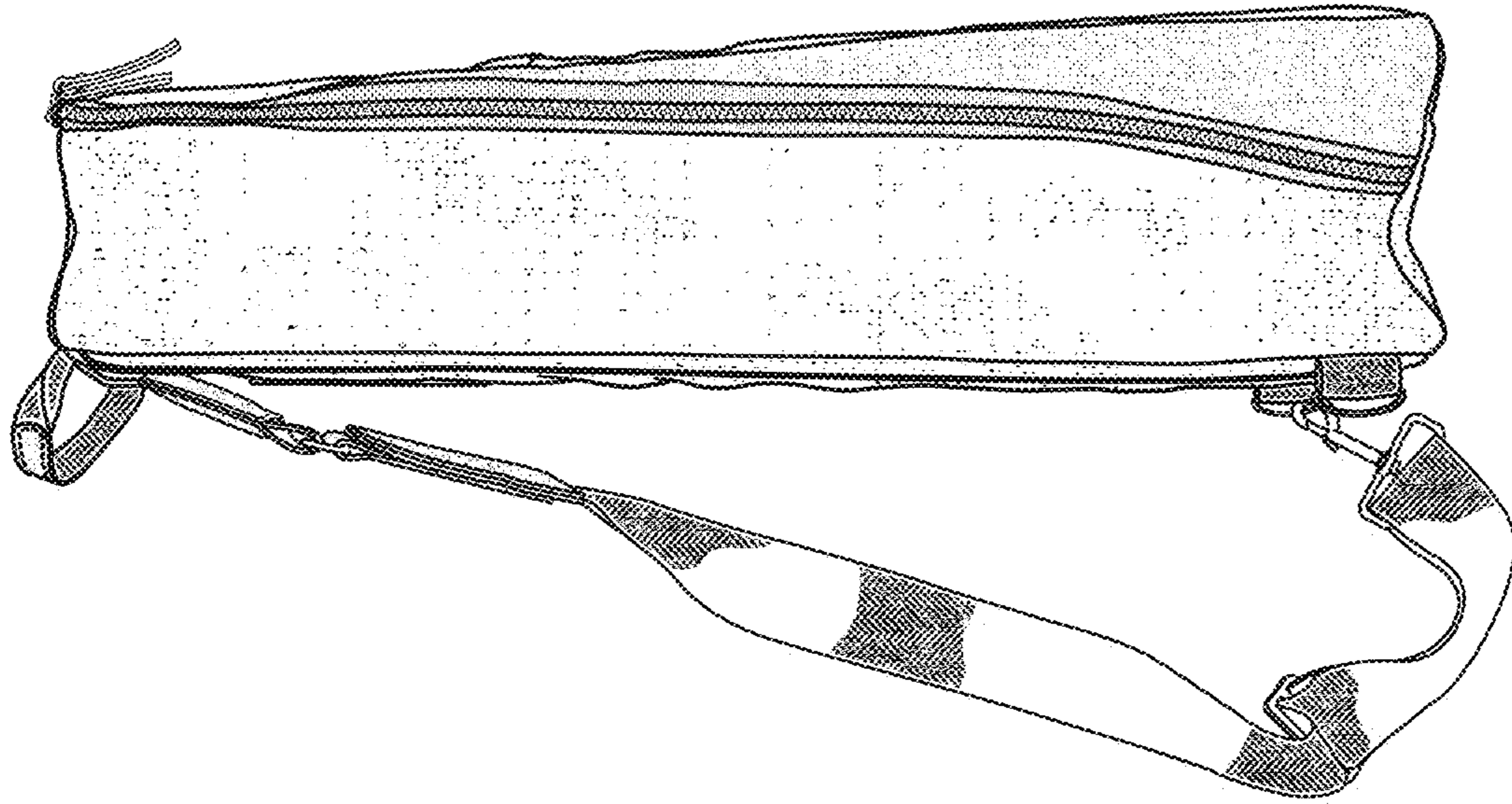

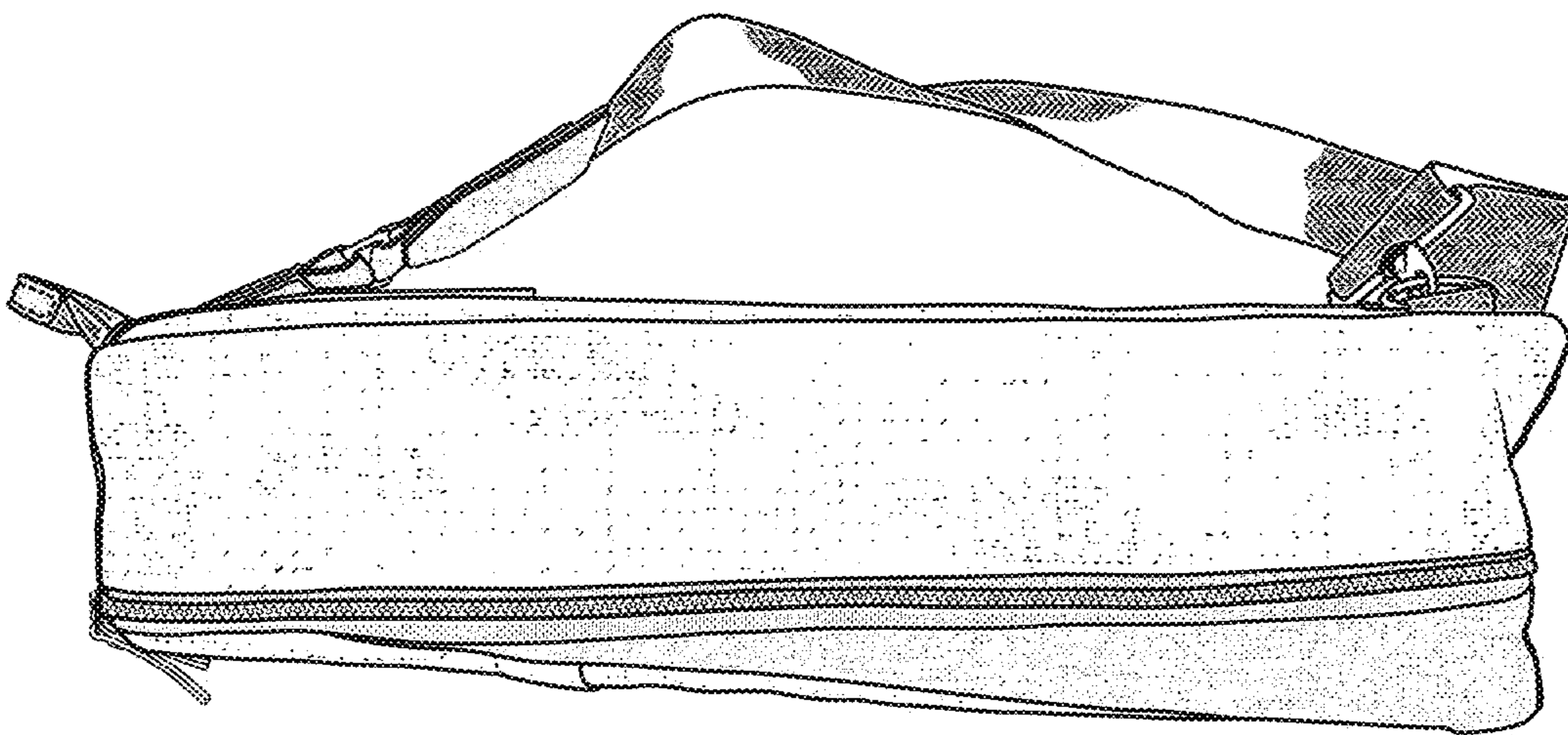

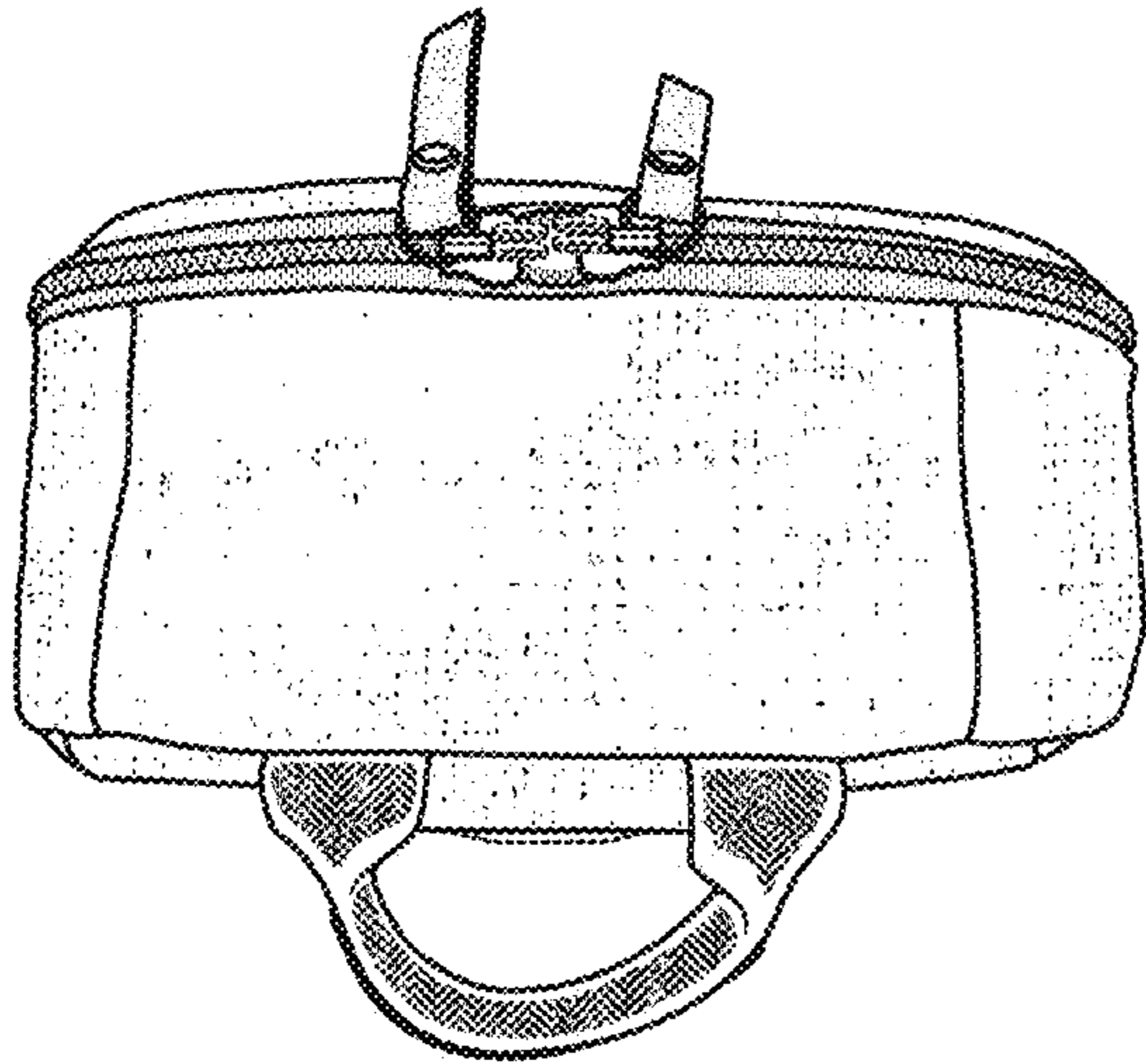

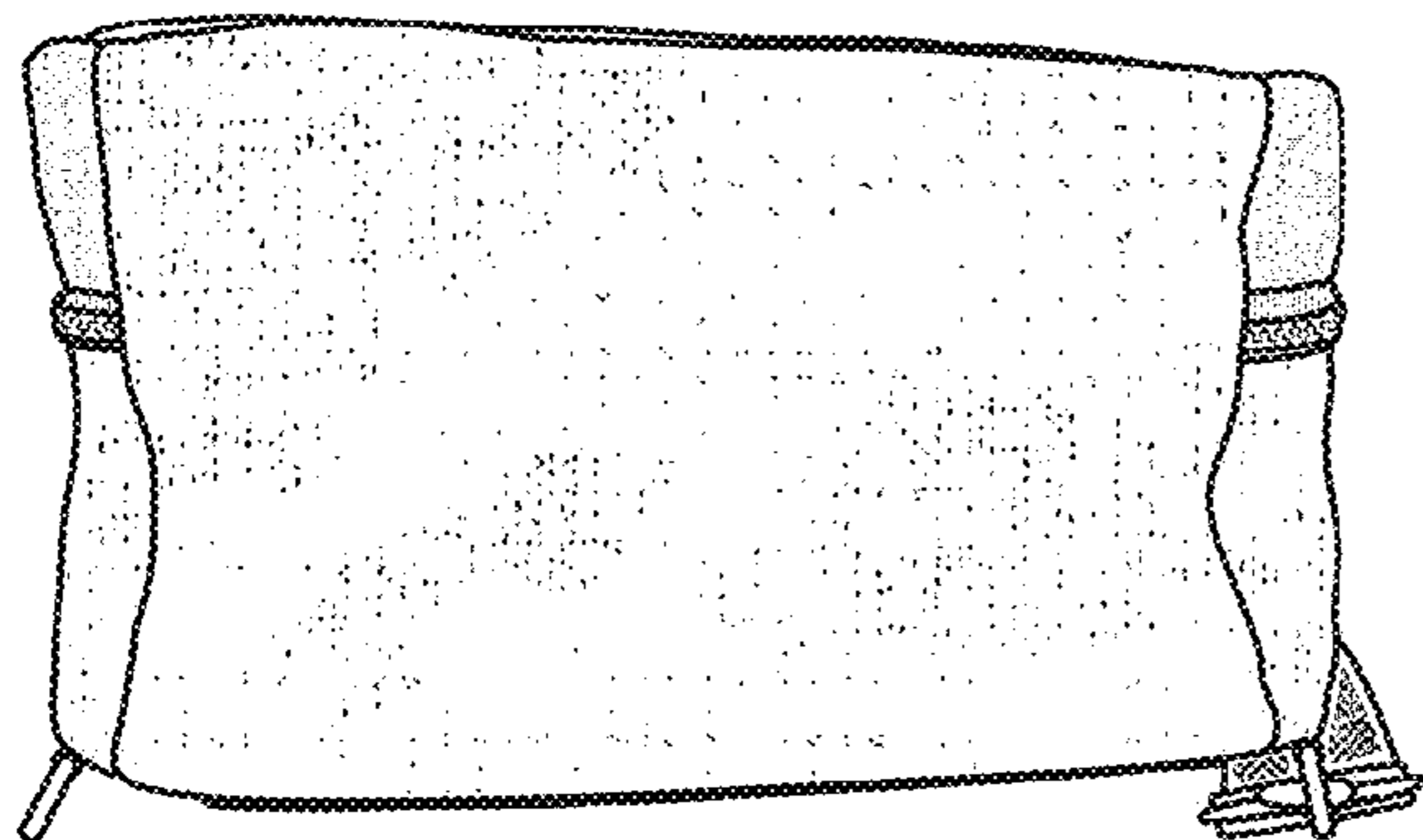

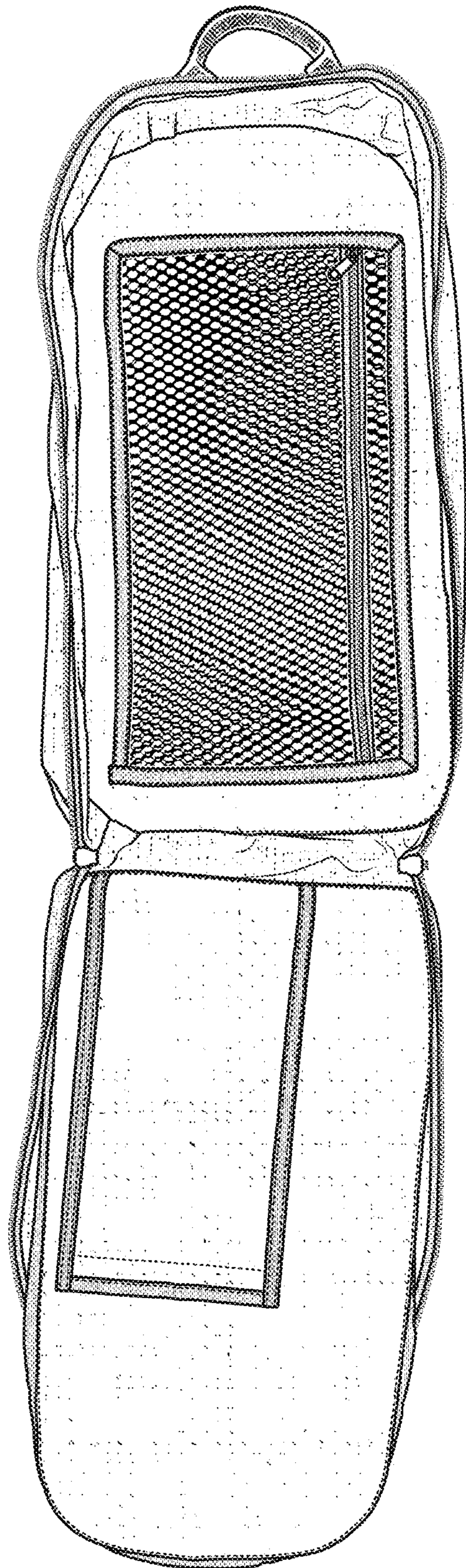

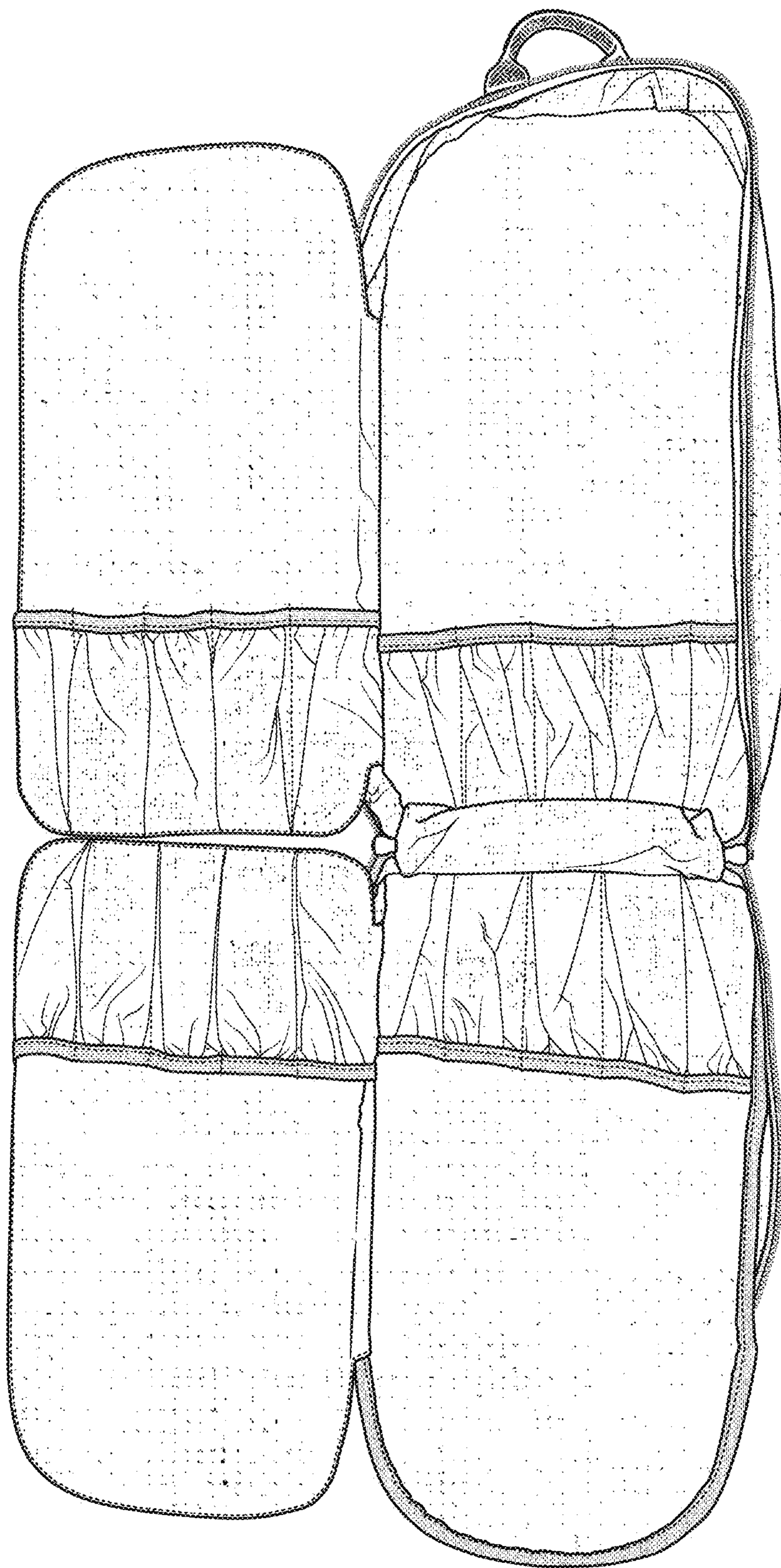
