(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines showing portions of the chain from no part of the claimed design.
The handbag is shown with symbolic breaks lines across the chain. The symbolic break lines and the appearance of any portion of the article between the break lines form no part of the claimed design.

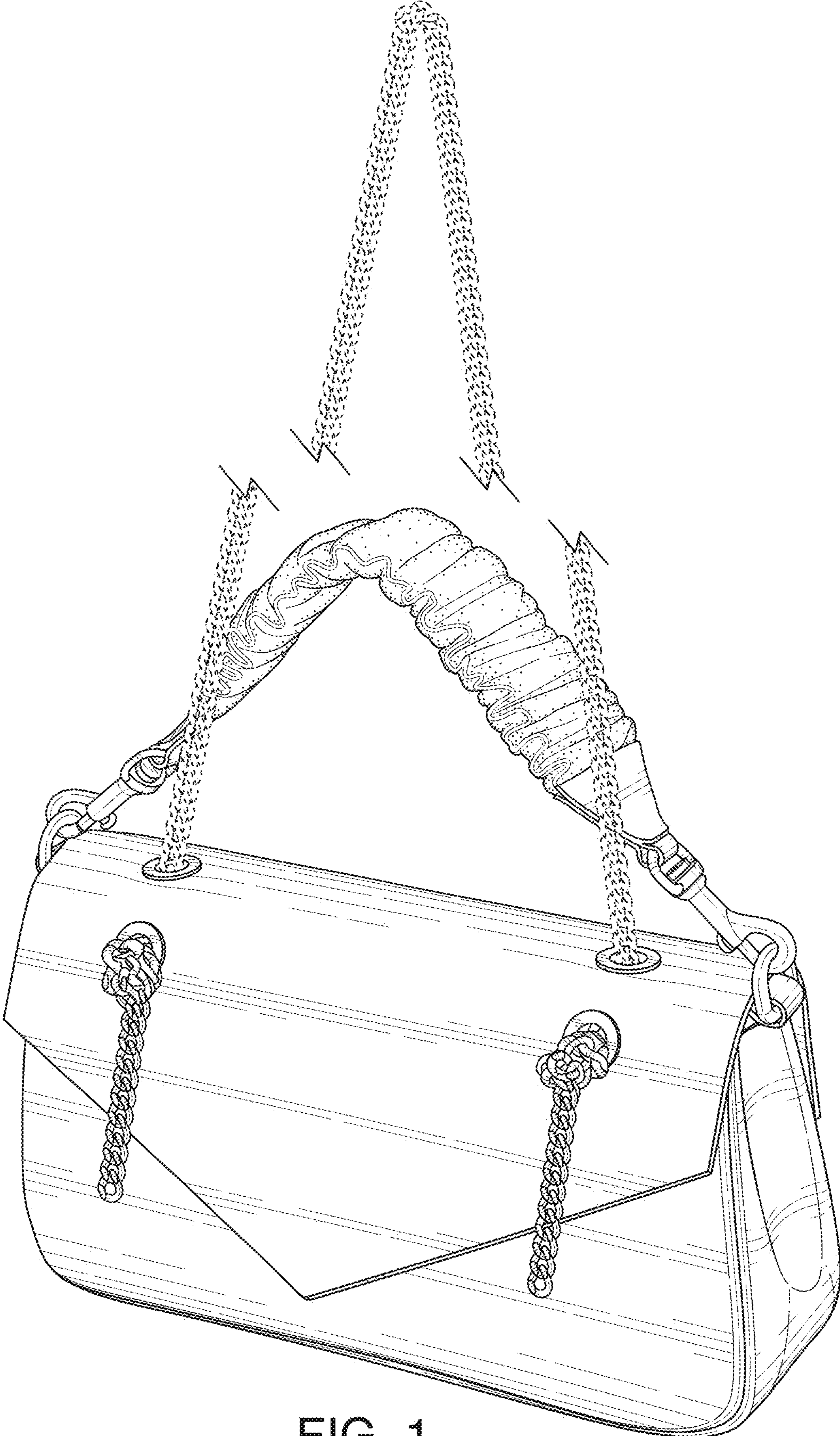

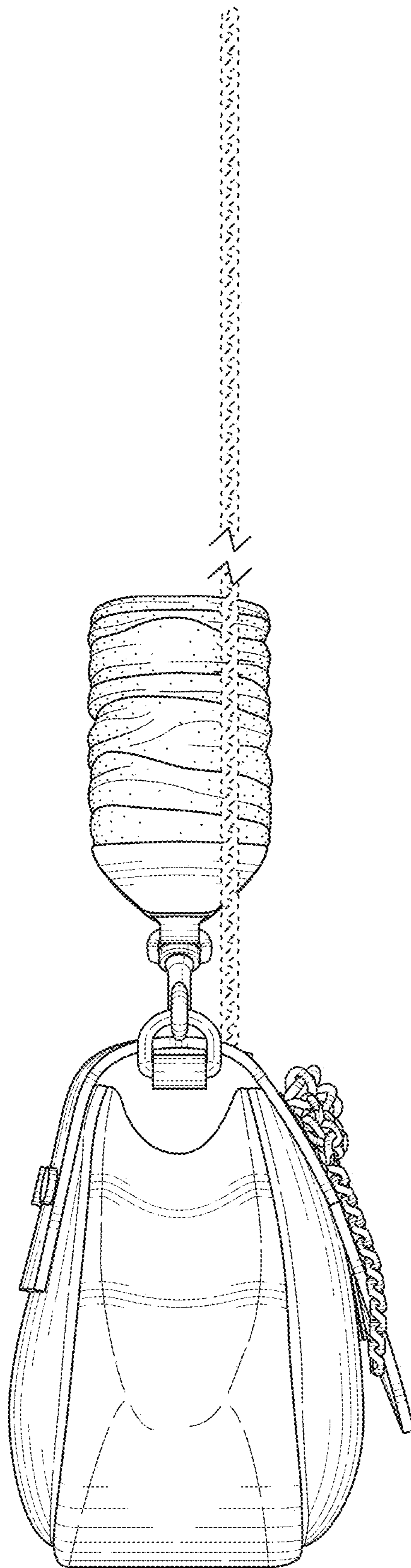

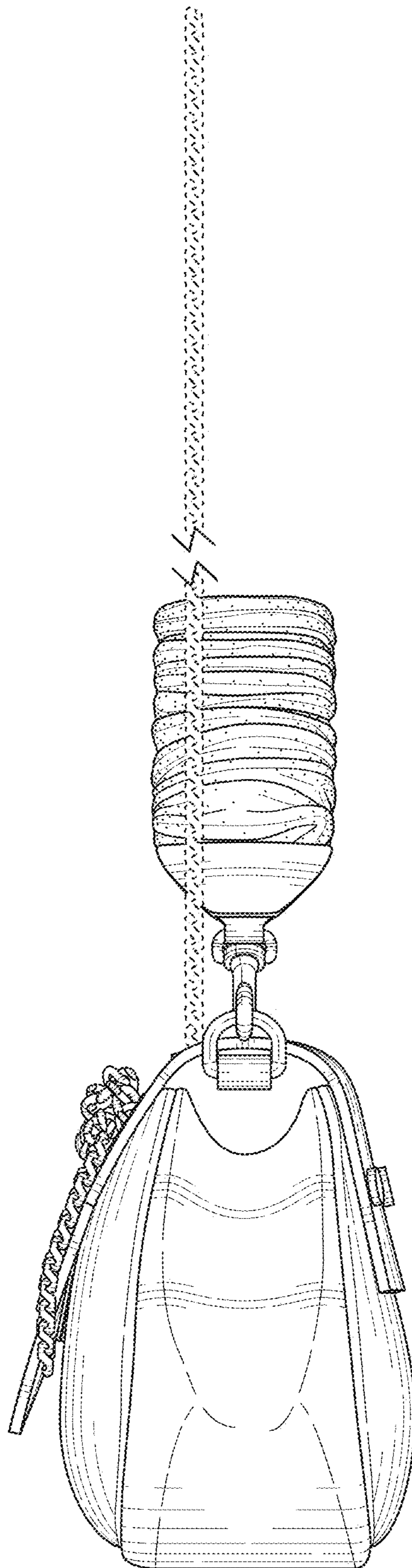

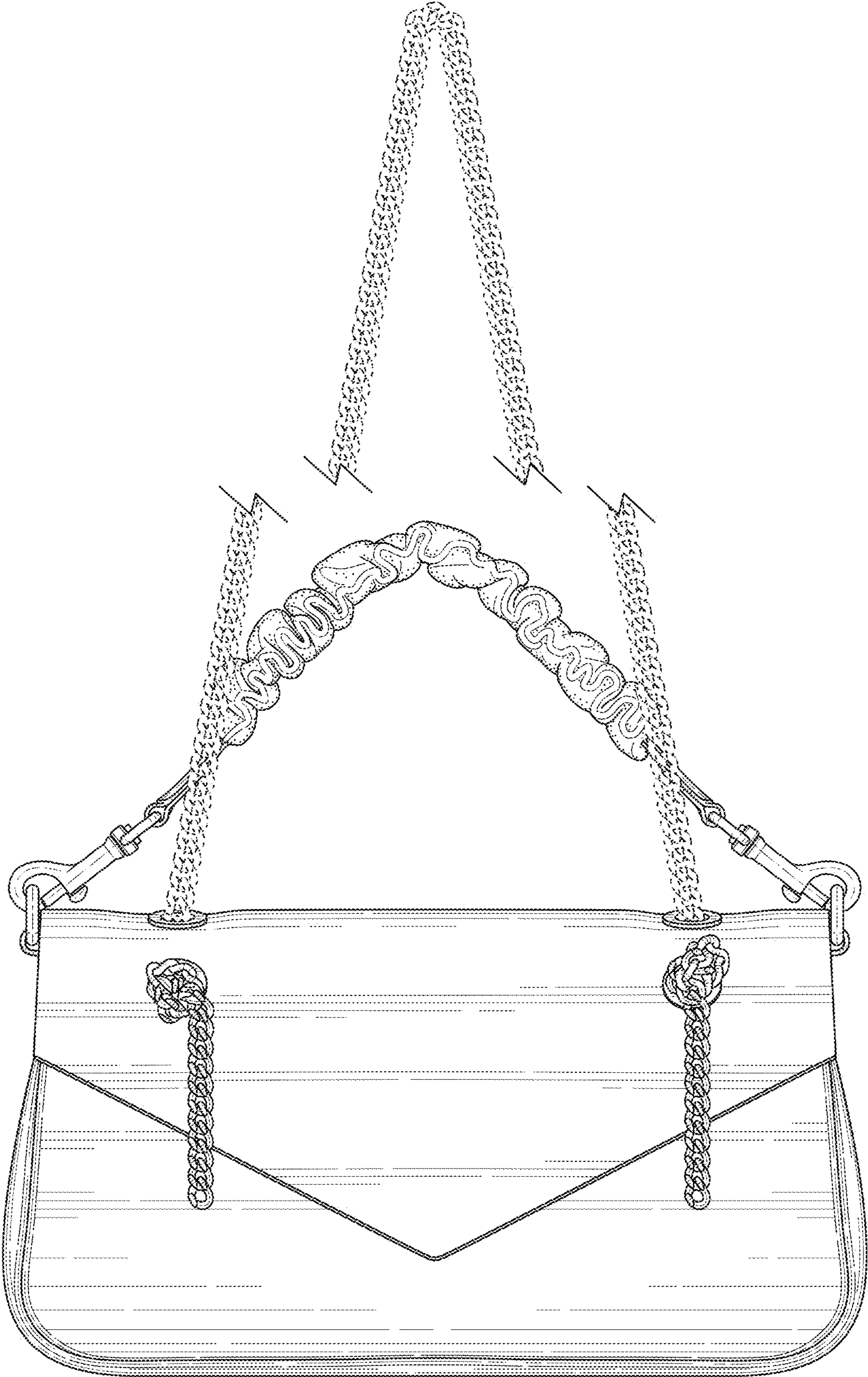

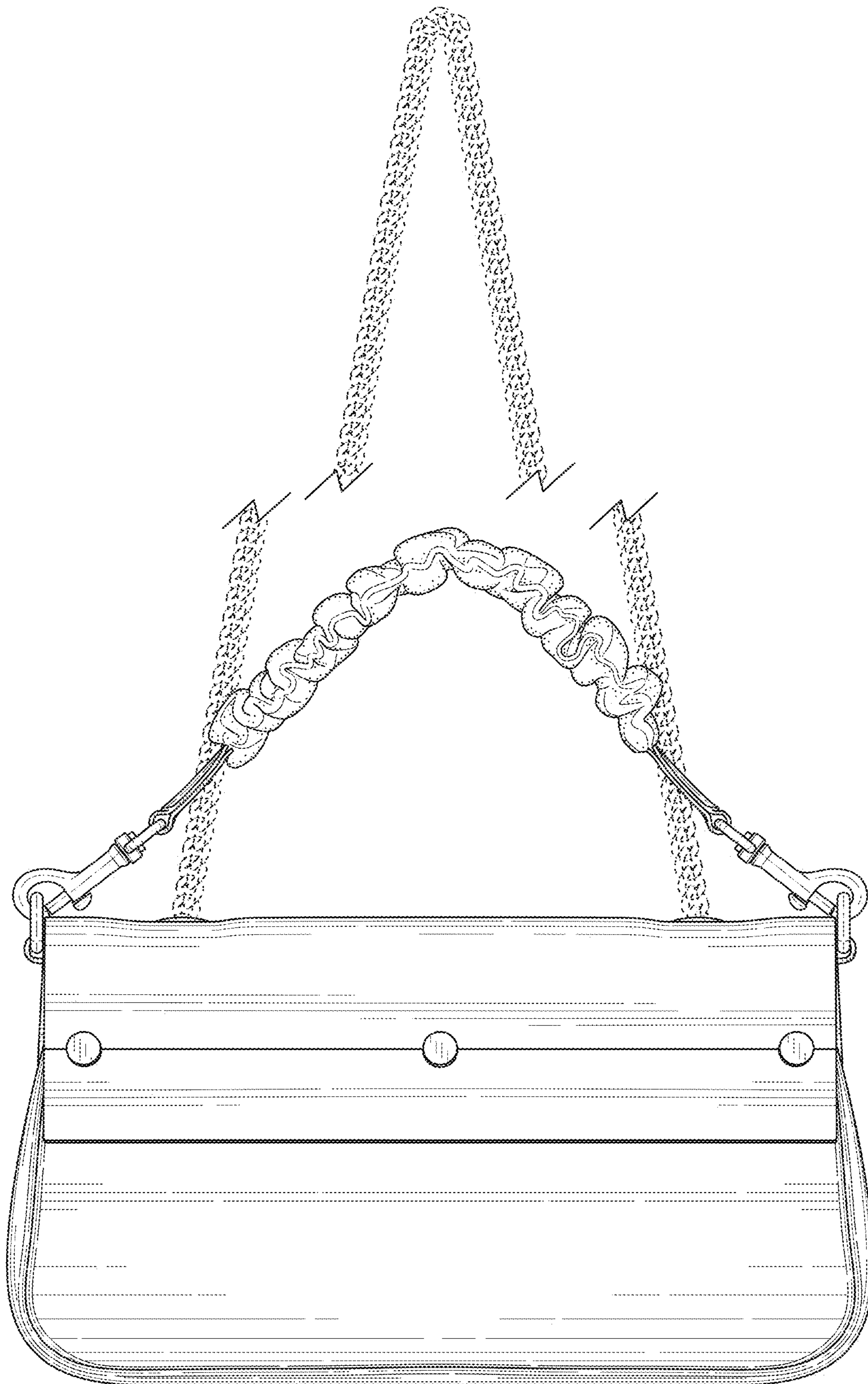

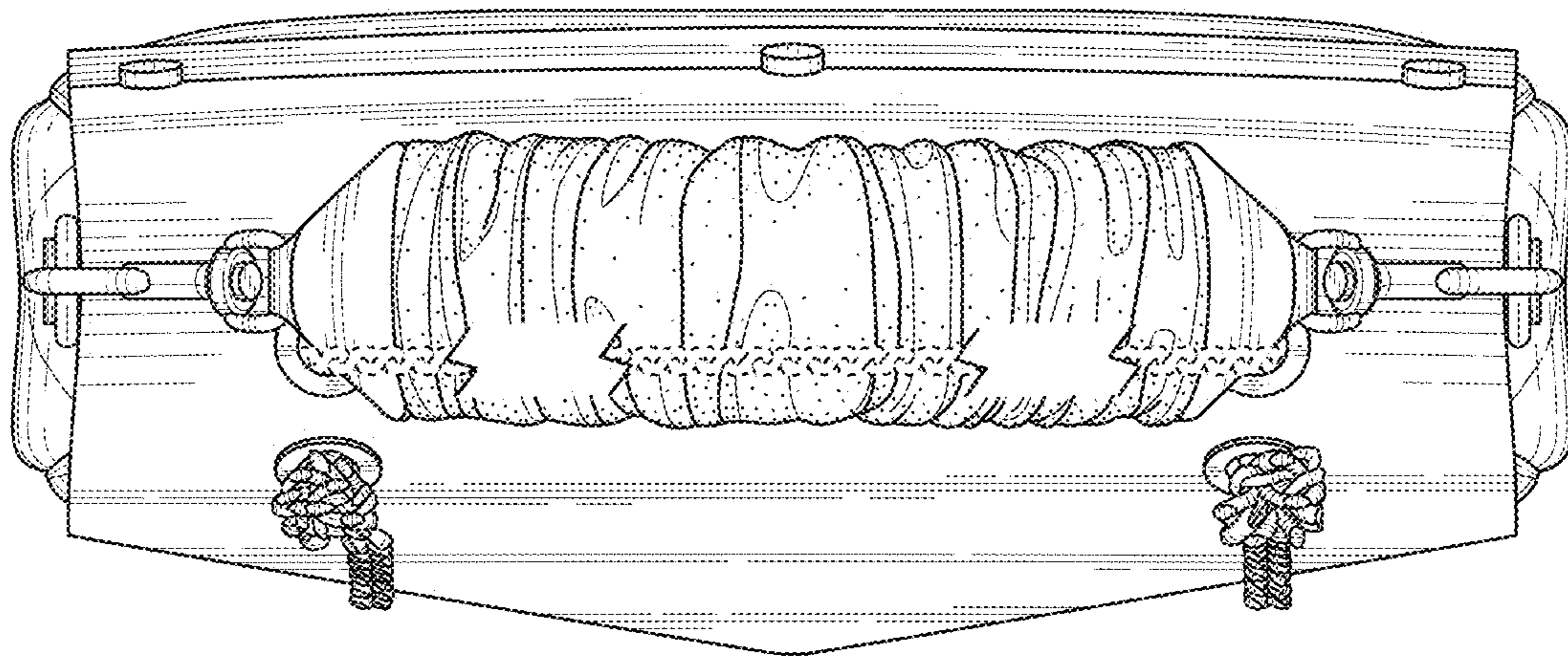

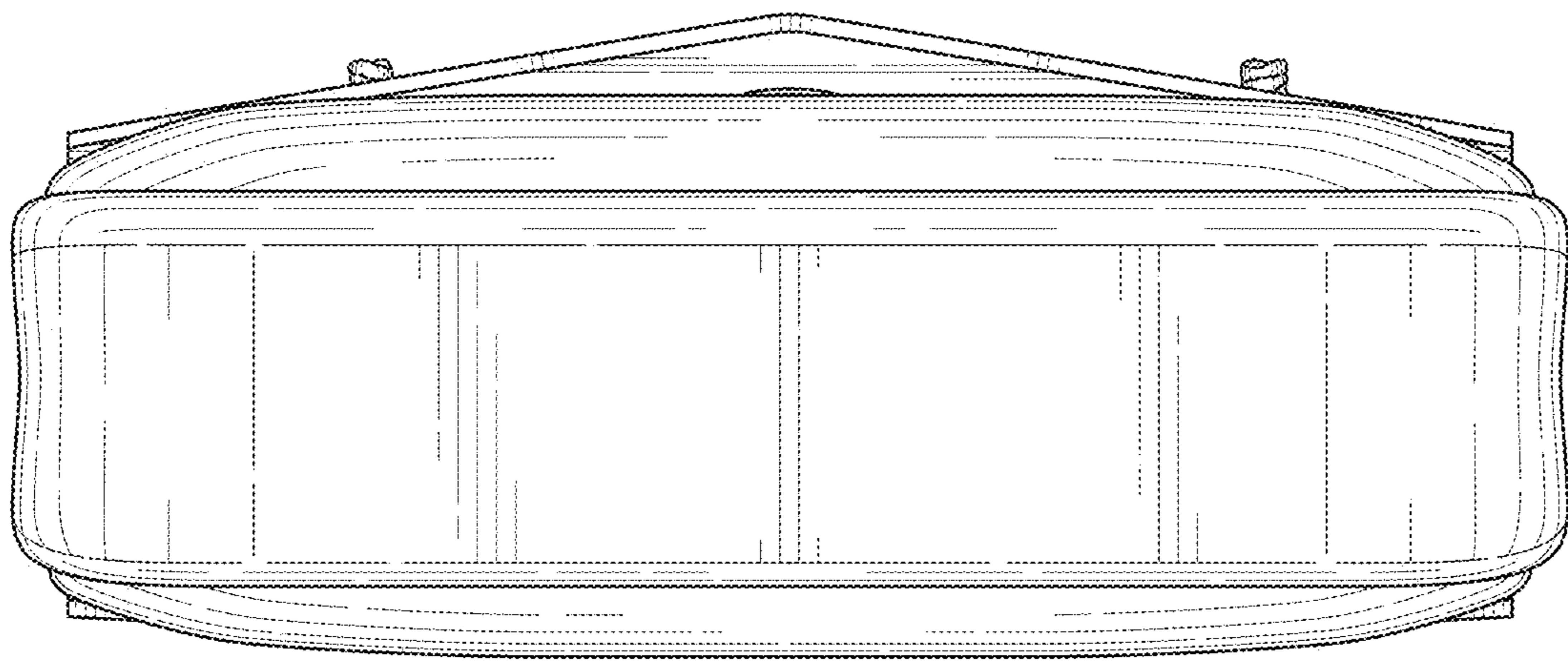
