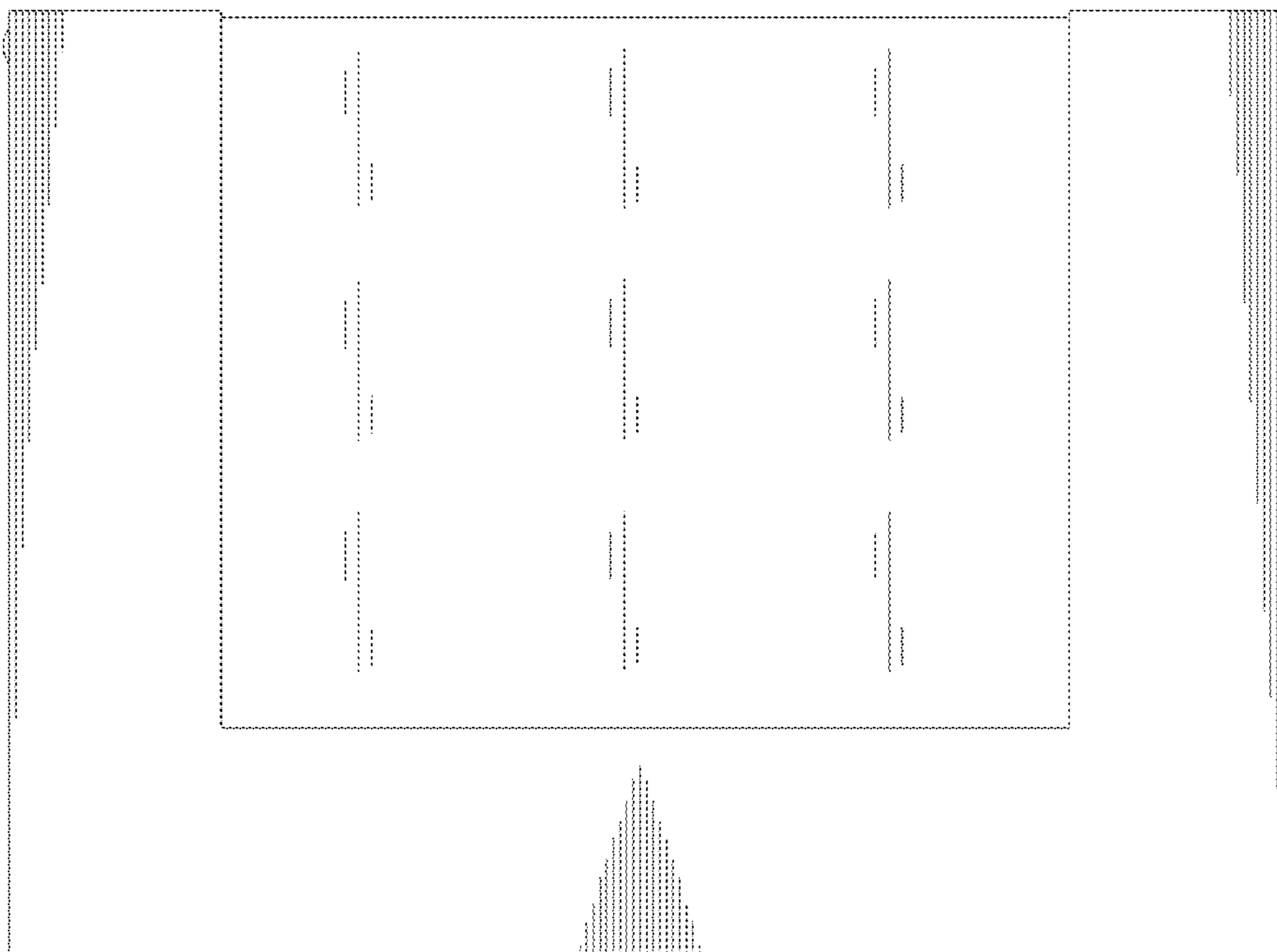
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a handbag with flexible display showing the new design;

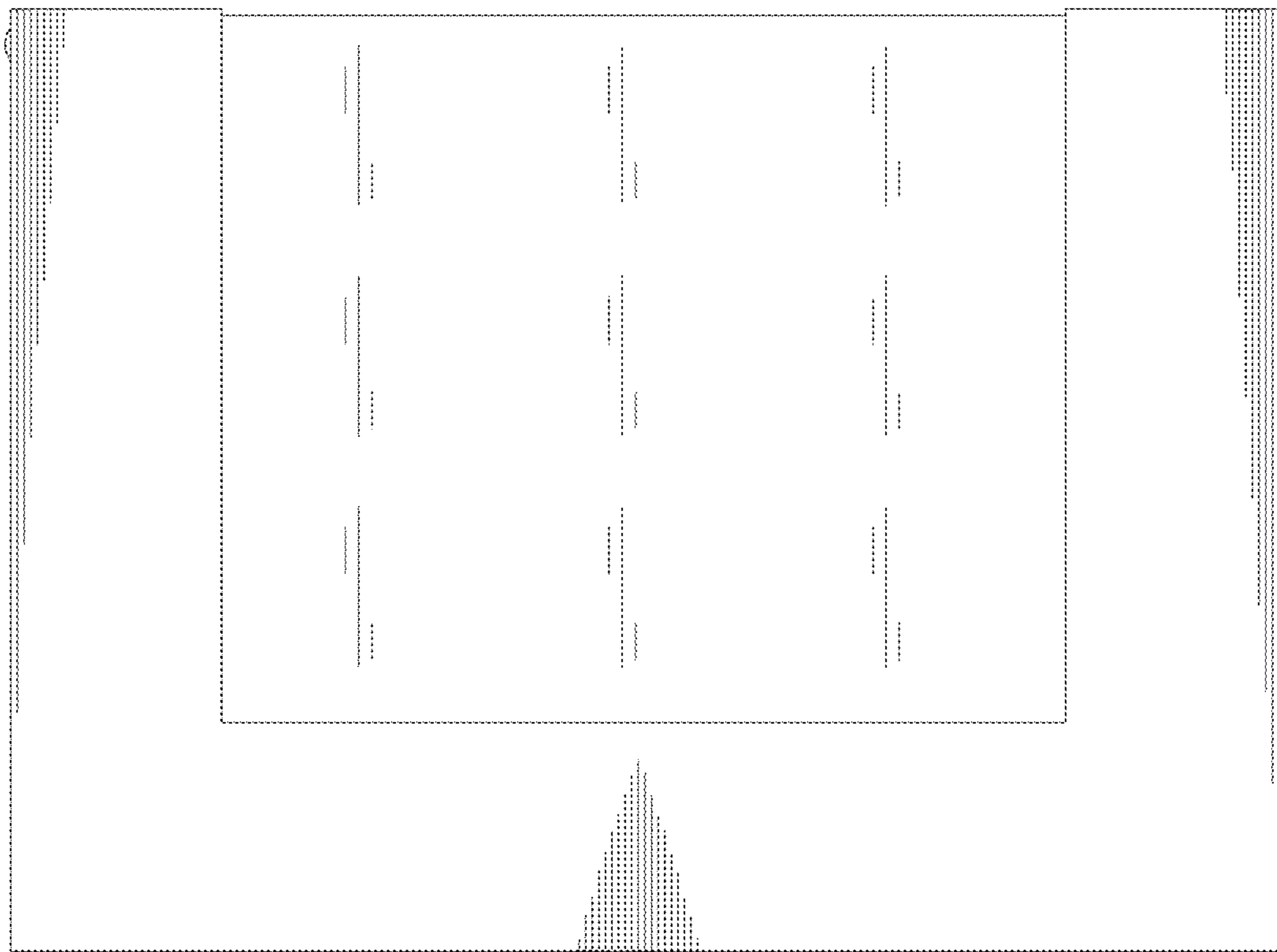

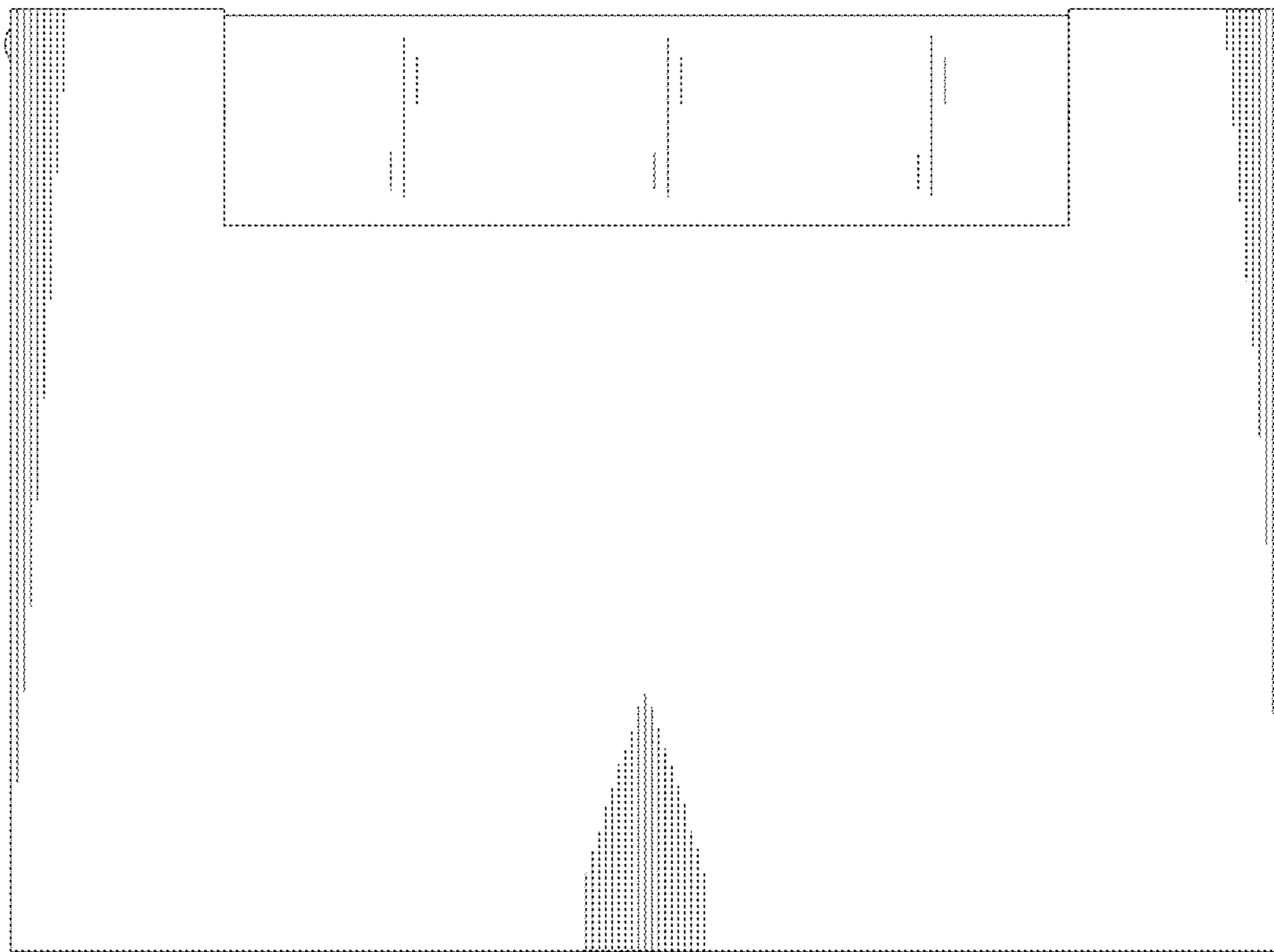

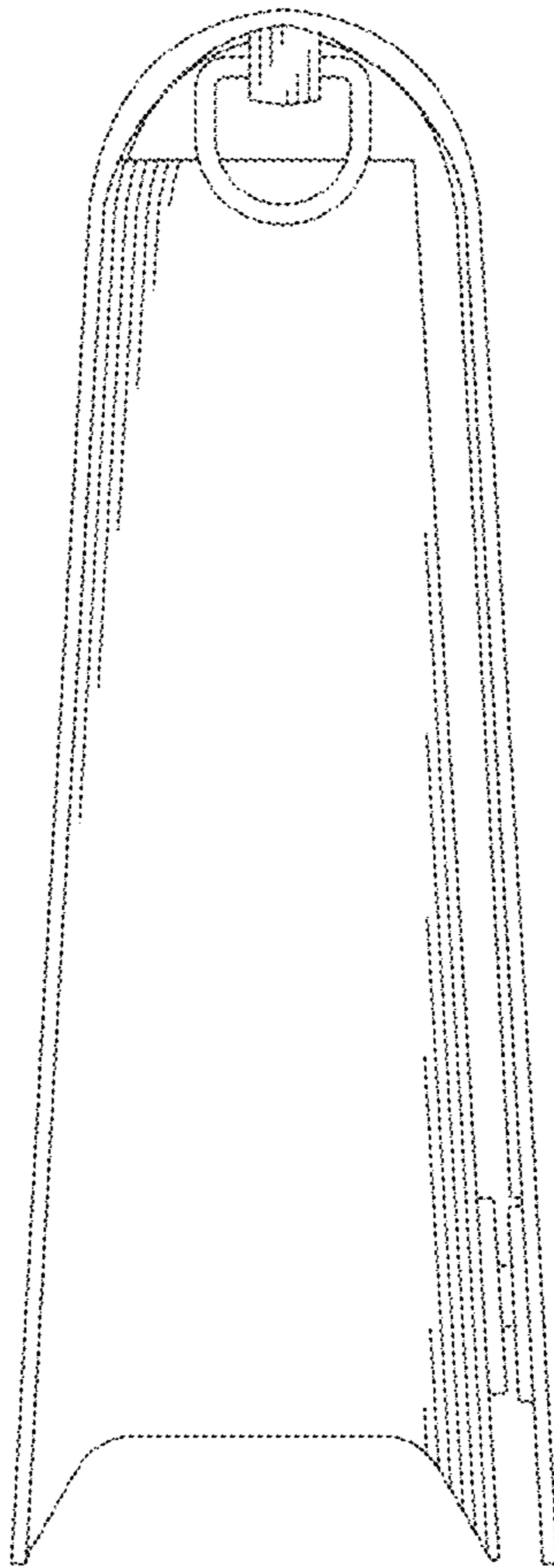

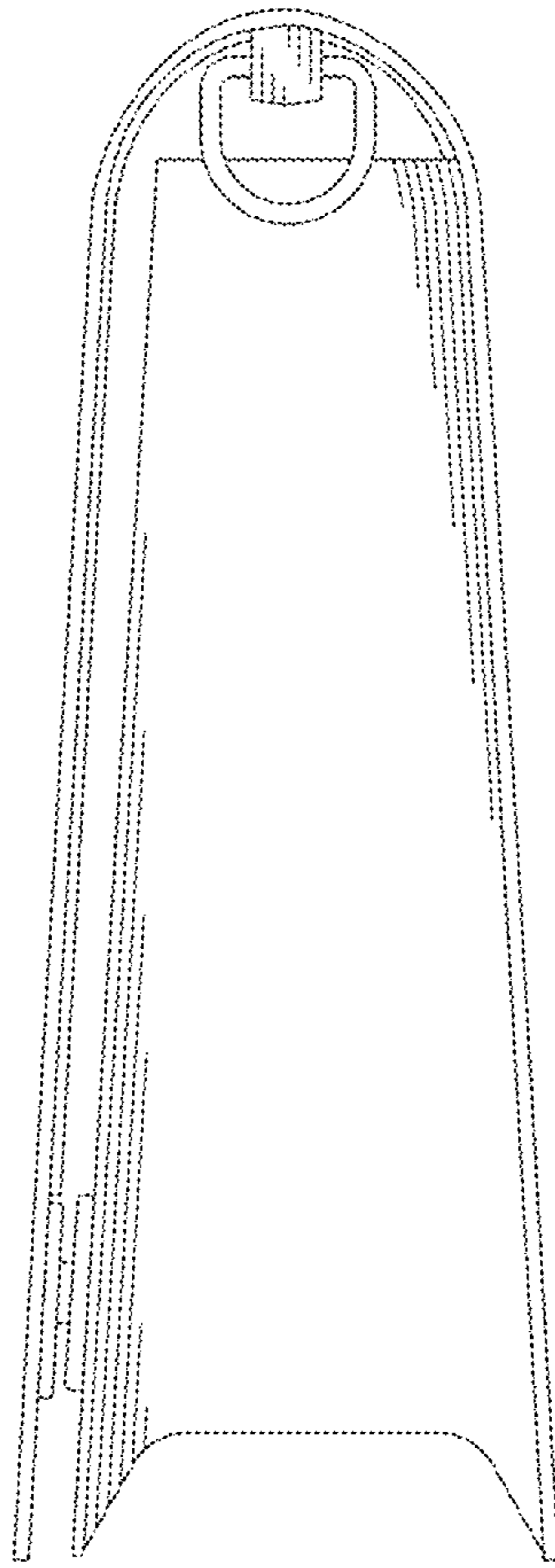

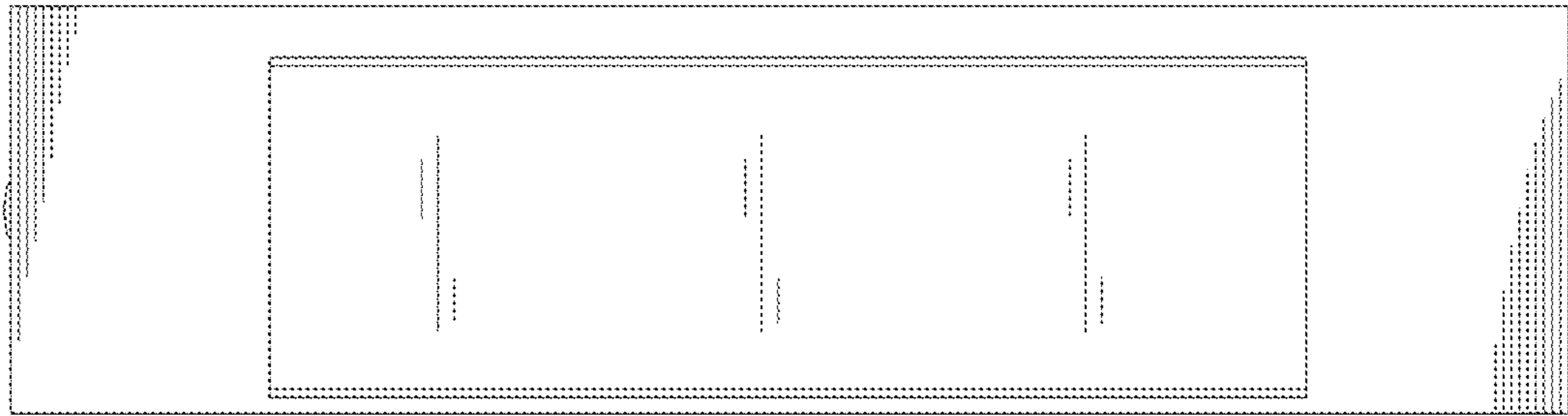

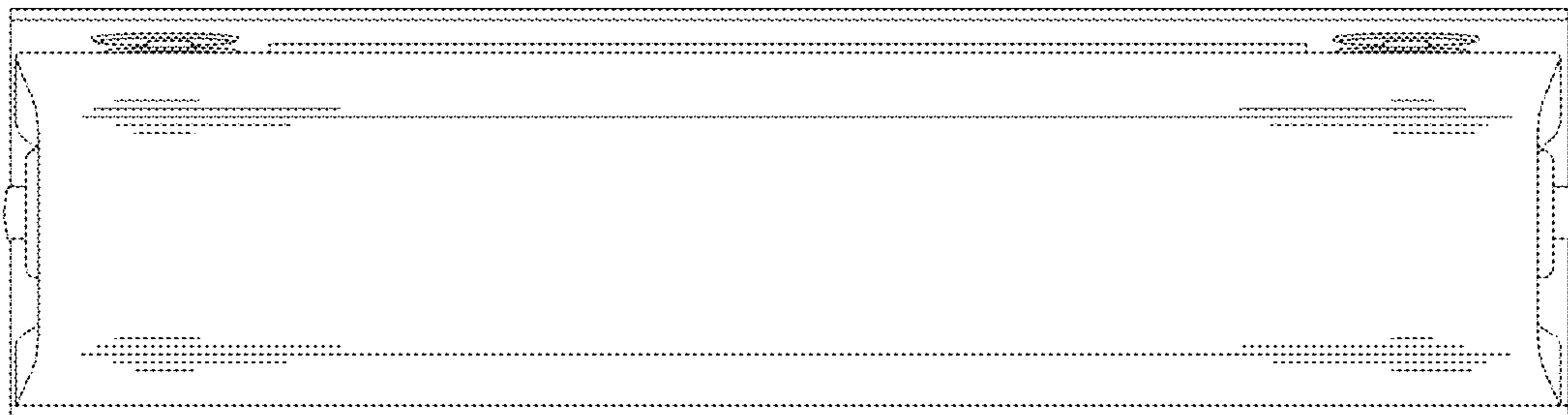

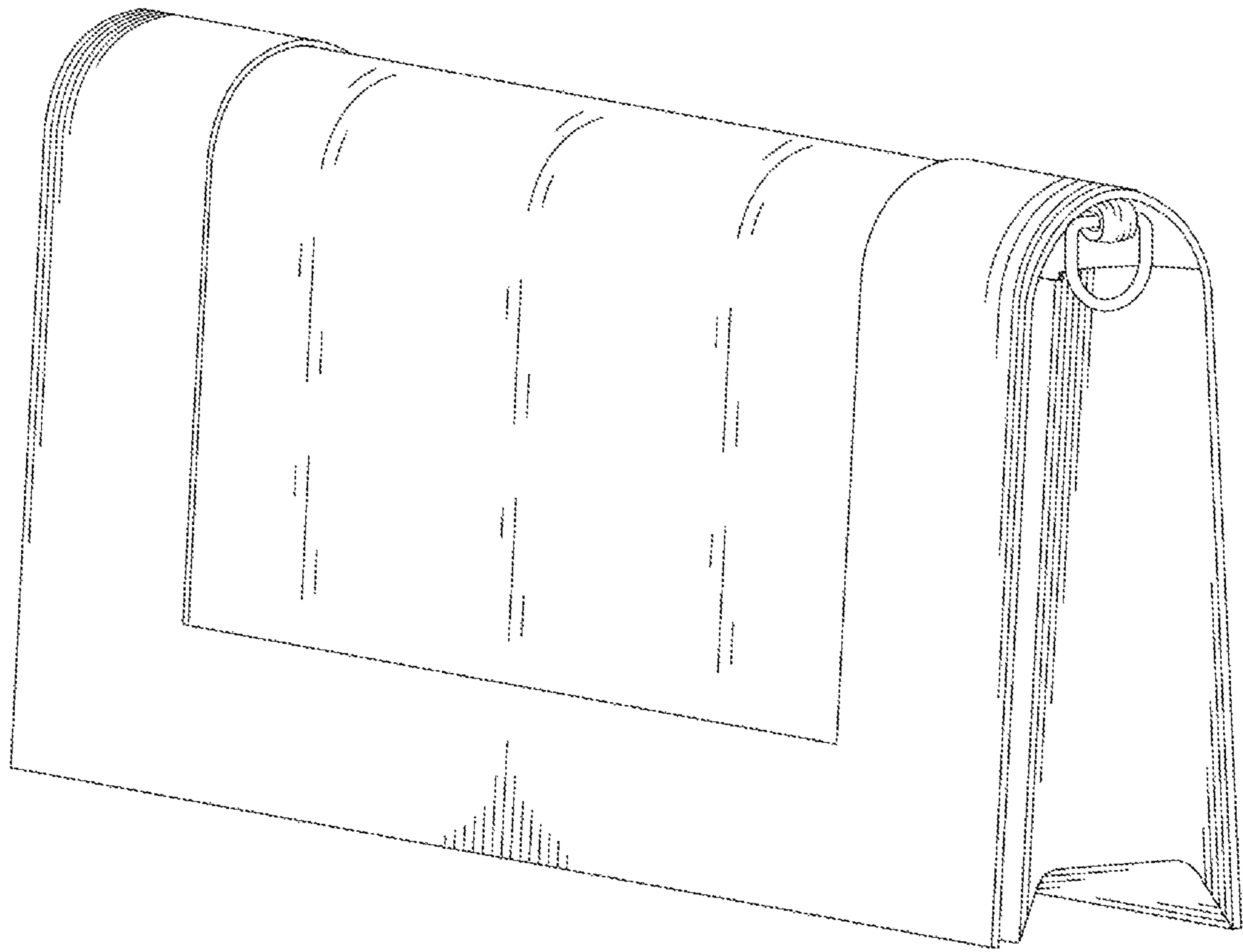
