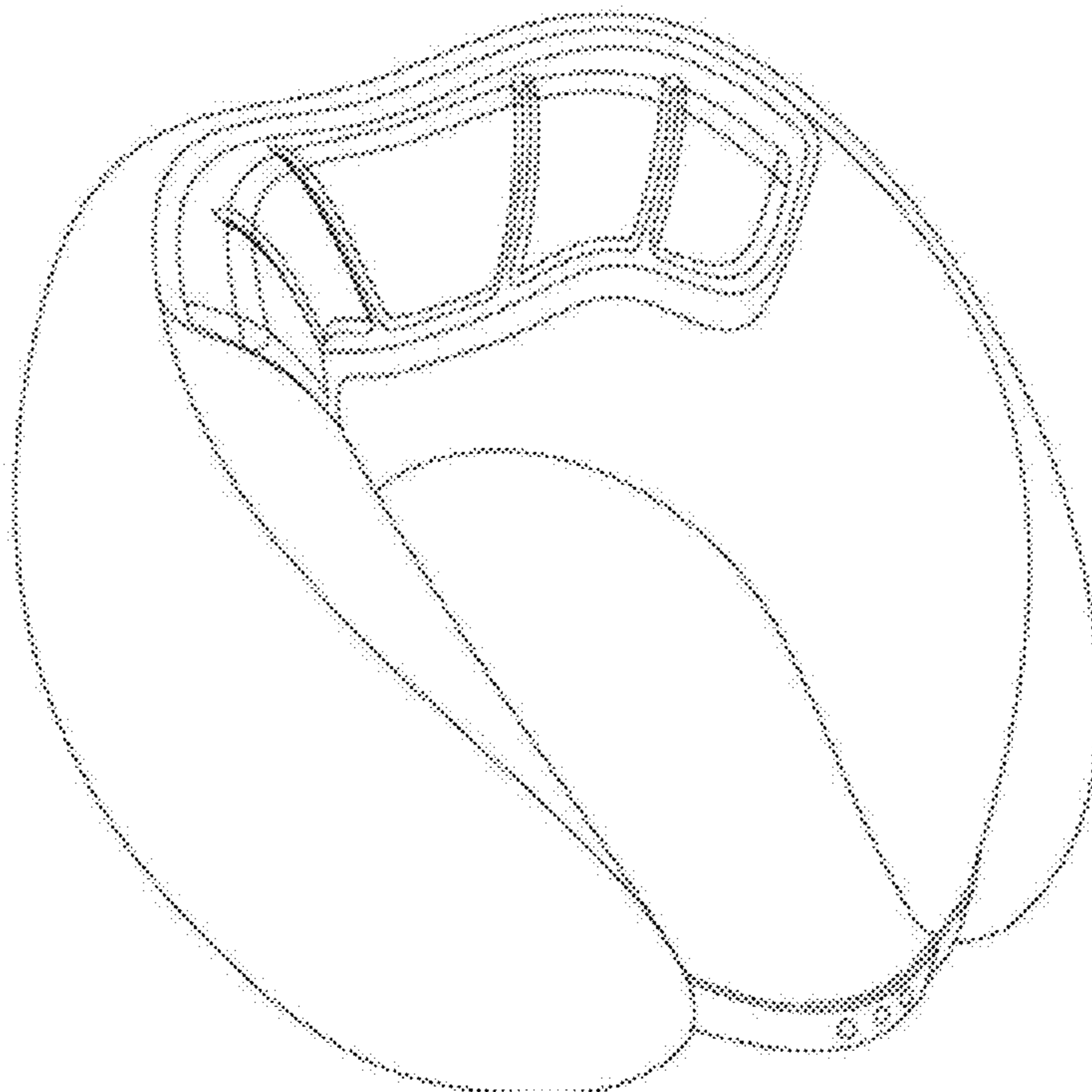
(57) **CLAIM**

The ornamental design for a cushion, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the cushion in a closed position, such as around a user's neck.
FIG. 2 is a top perspective view of the cushion in an opened position, such as around the user's waist.
FIG. 3 is a front perspective view of the cushion.
FIG. 4 is a front view of the cushion.
FIG. 5 is a back view of the cushion.
FIG. 6 is a top view of the cushion.
FIG. 7 is a bottom view of the cushion.
FIG. 8 is a left side view of the cushion; and,
FIG. 9 is a right side view of the cushion.
The broken line showing in FIG. 2 is for the purpose of illustrating possible attachments to the cushion and forms no part of the claimed design.

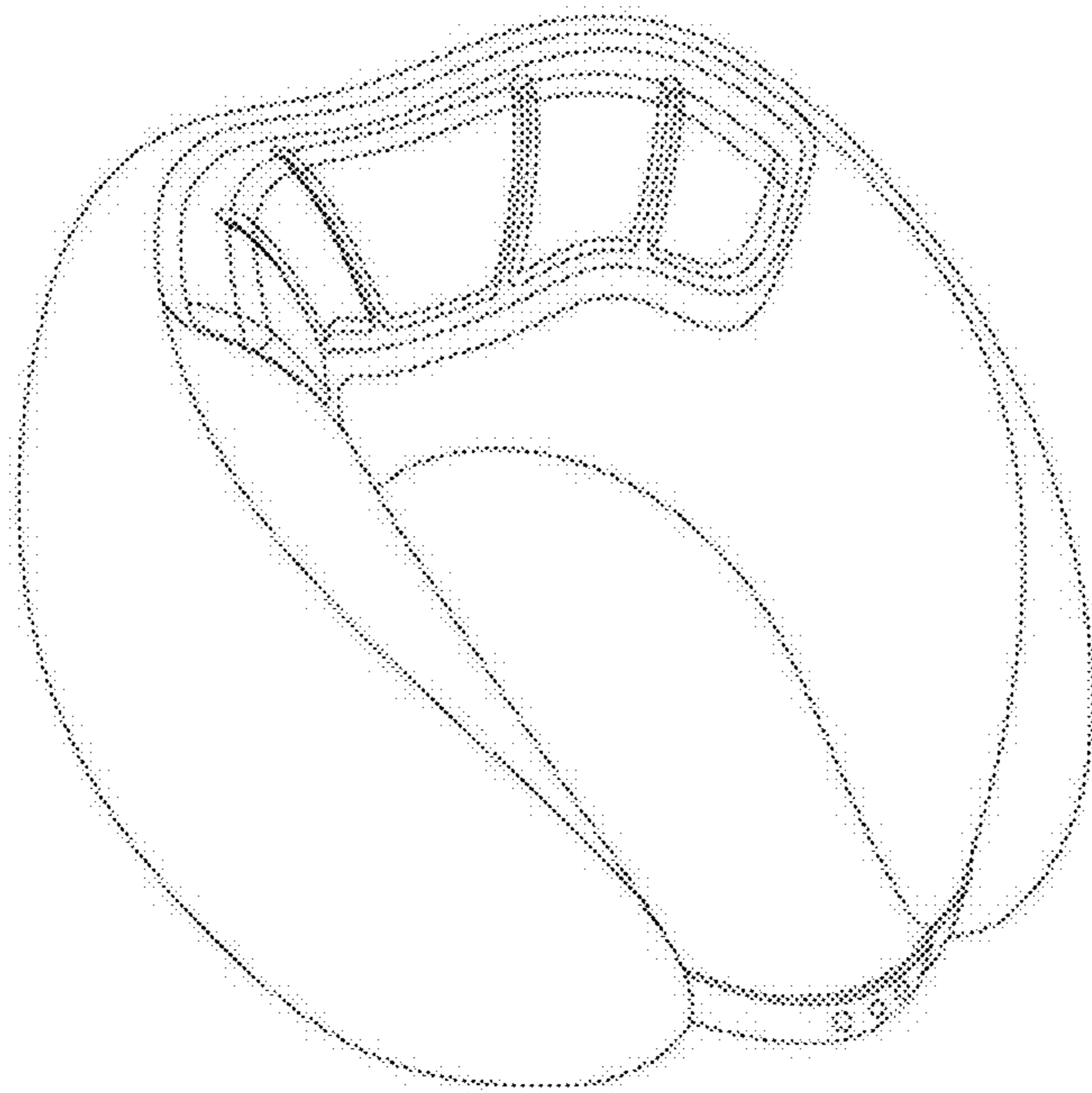

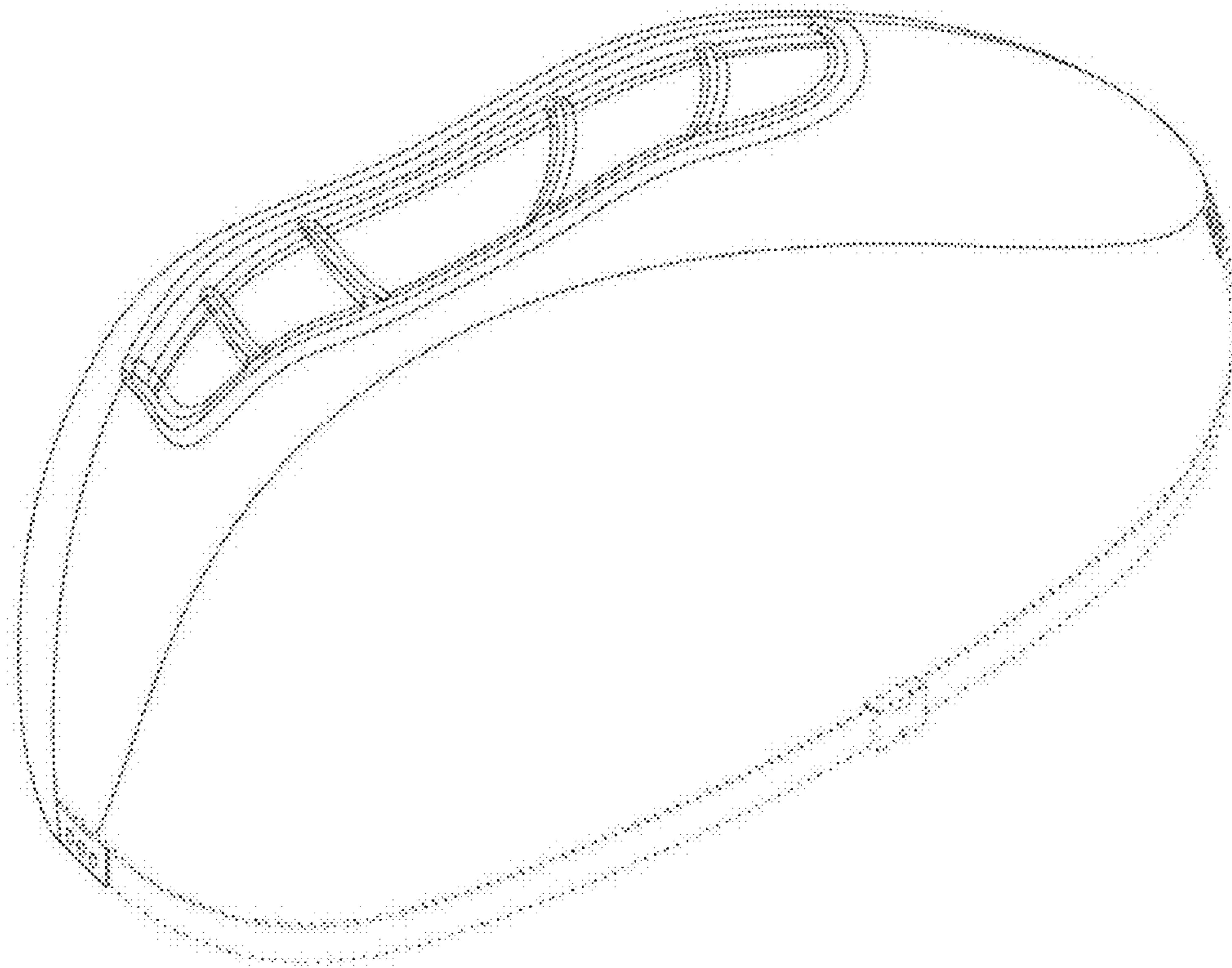

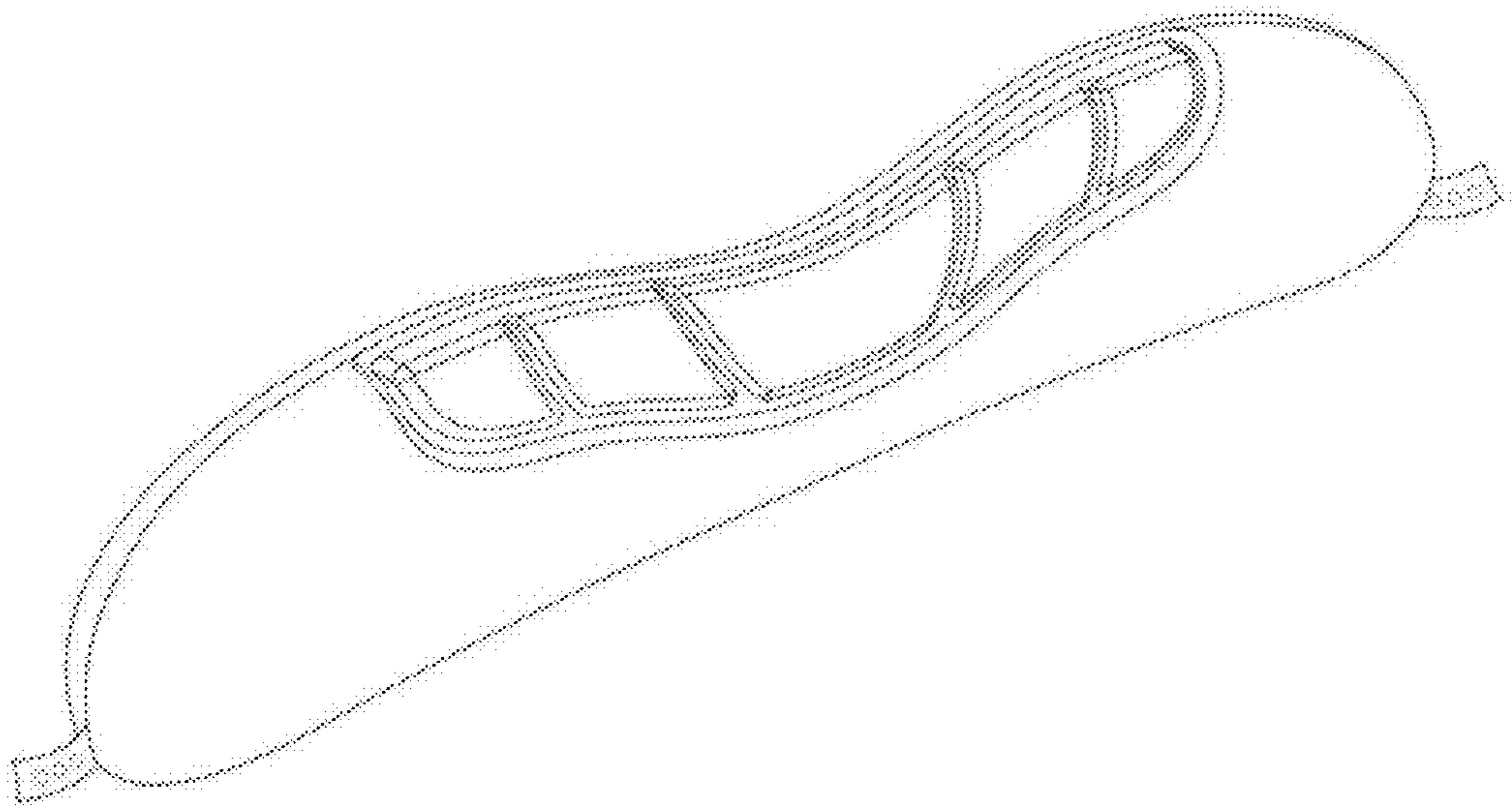

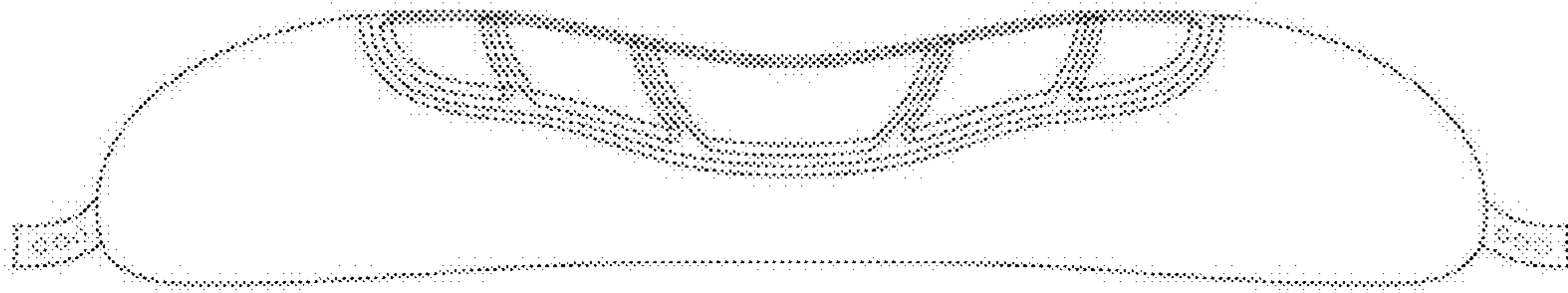

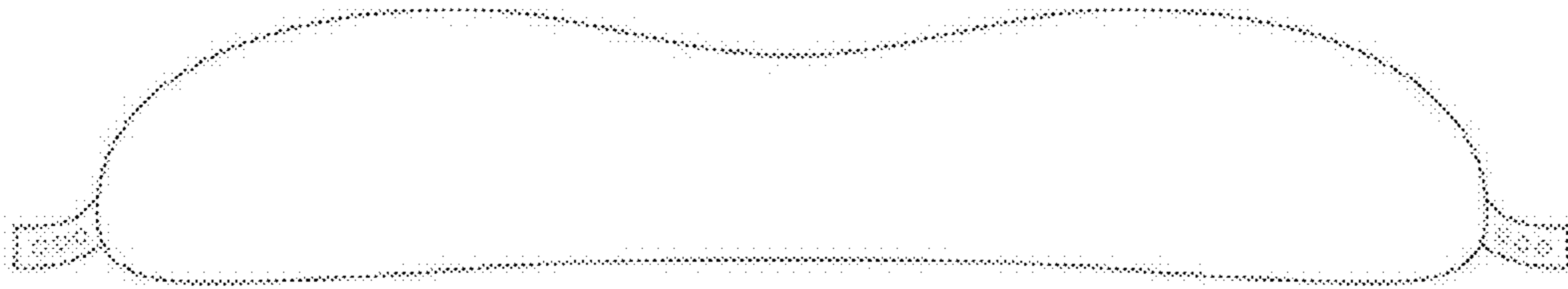

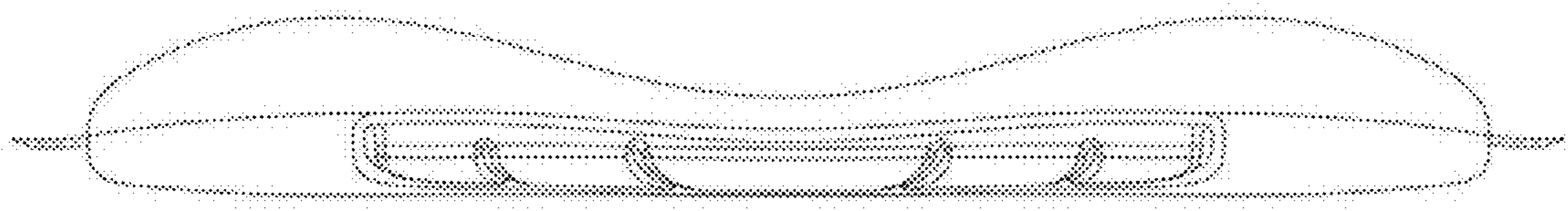

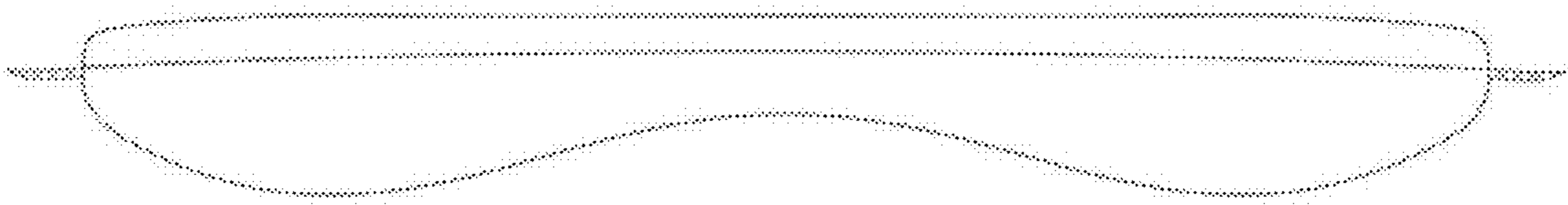
