(57) **CLAIM**

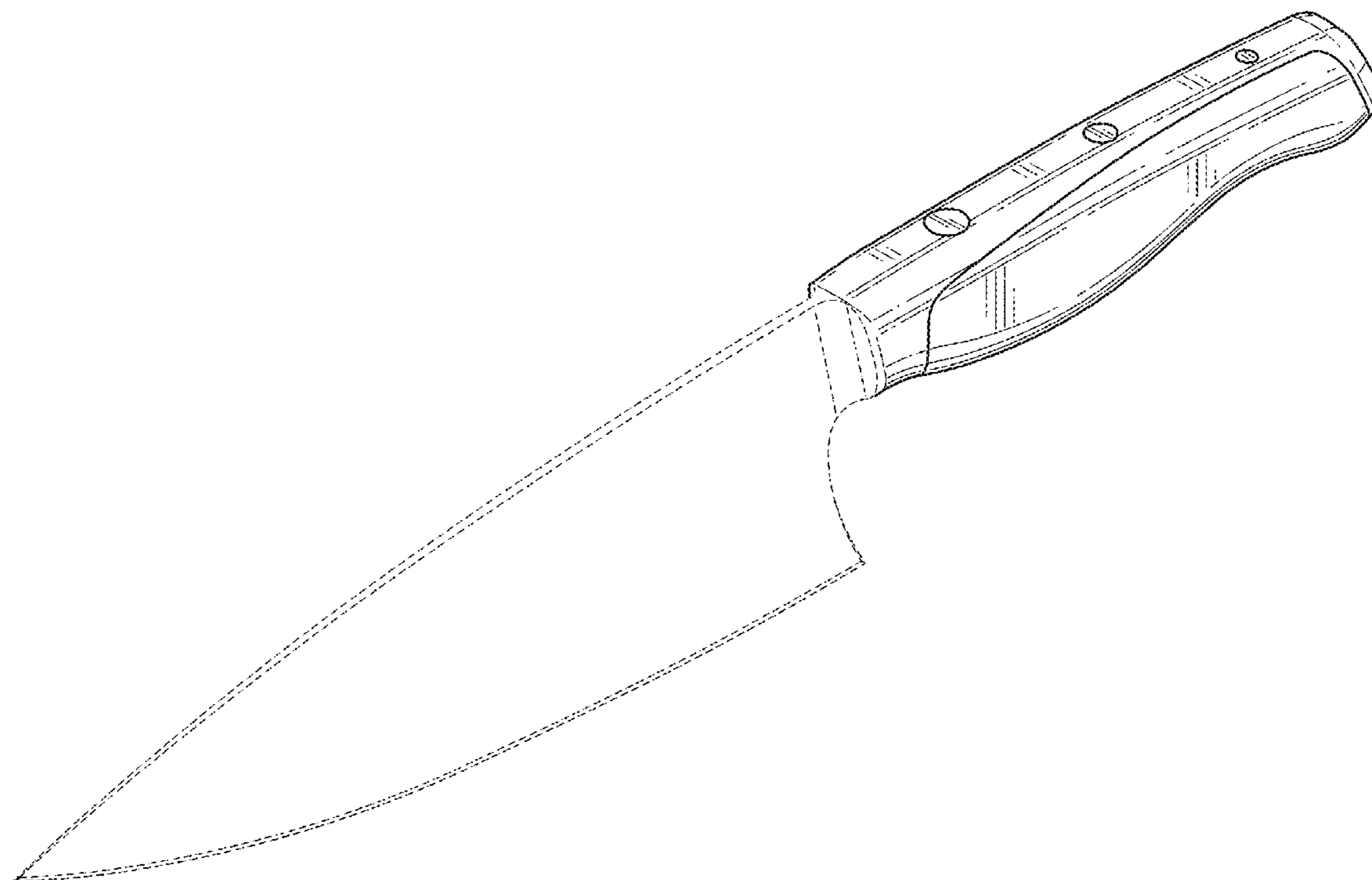
The ornamental design for a chef knife, as shown and described.

DESCRIPTION

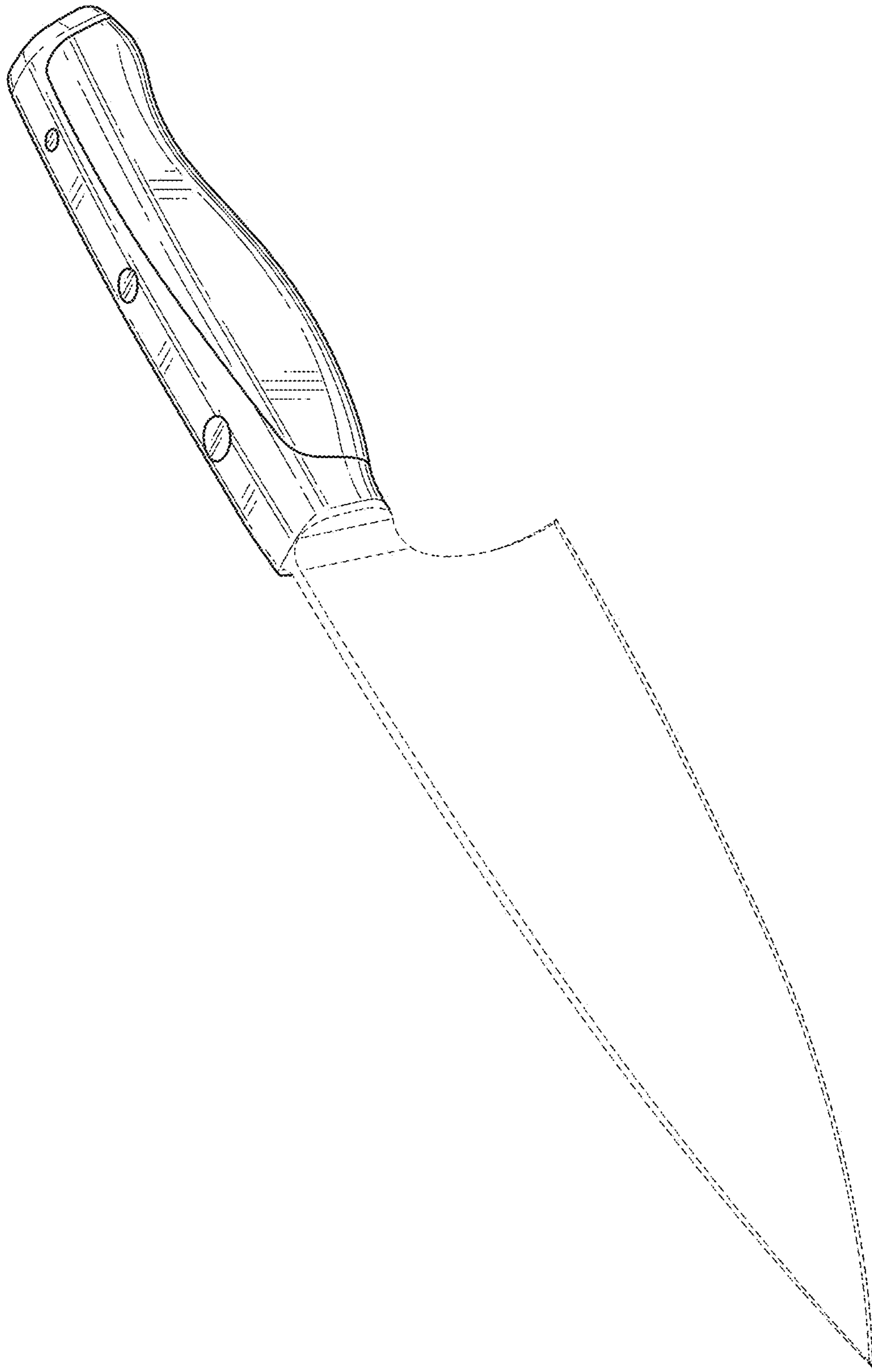

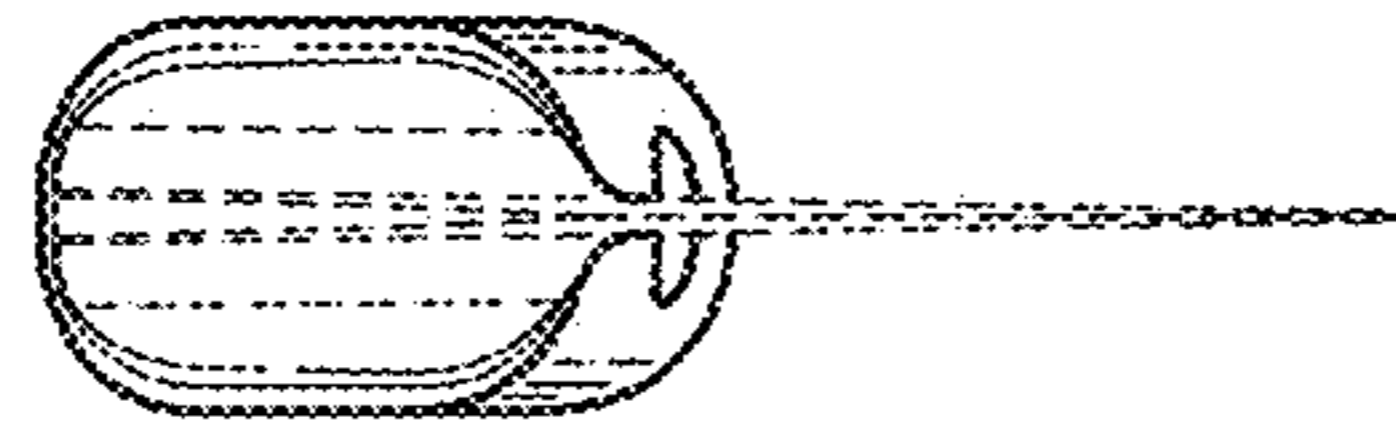

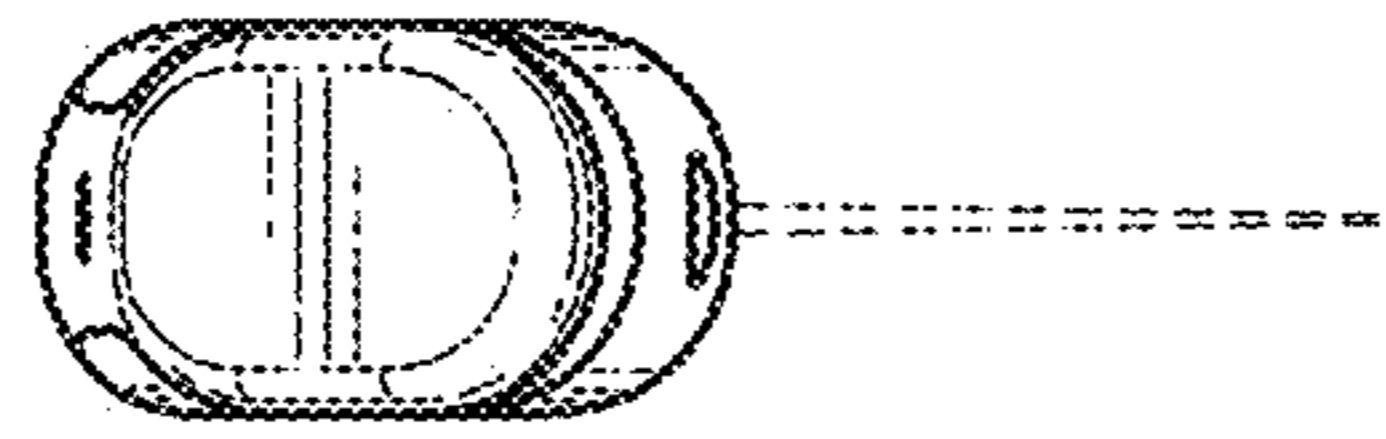

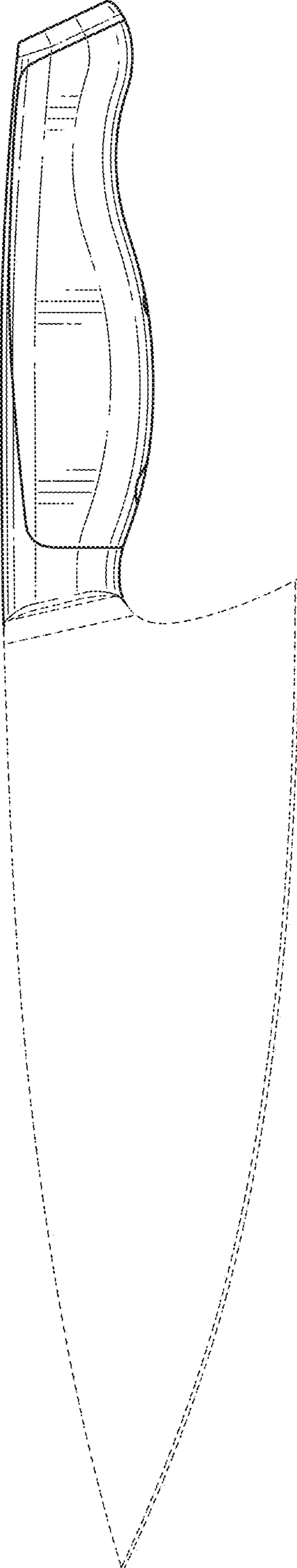

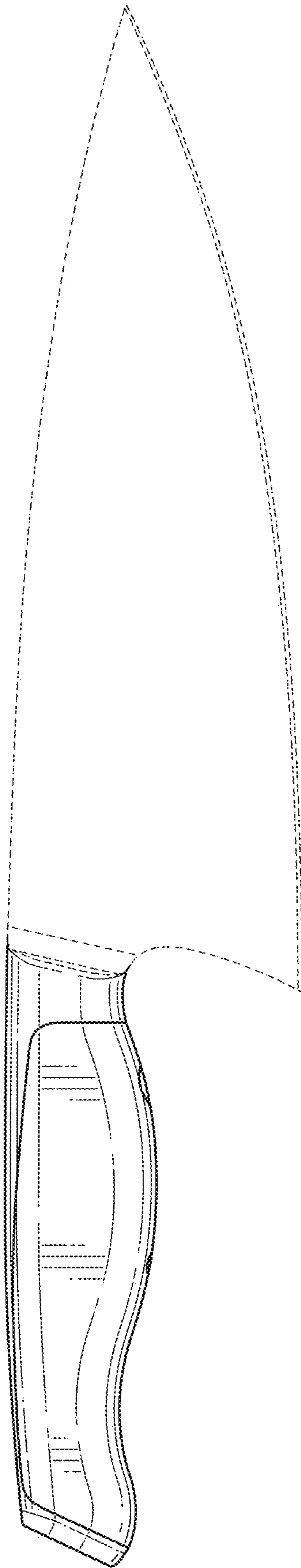

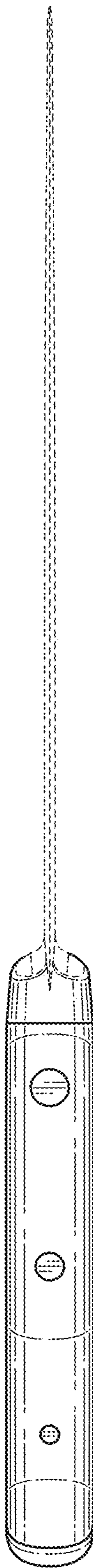

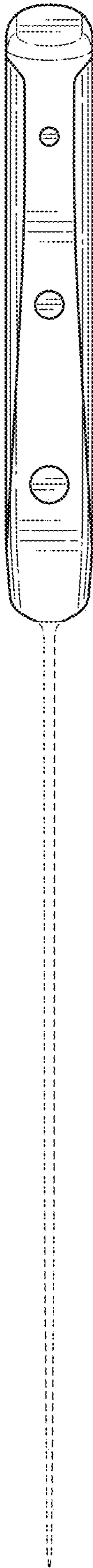
