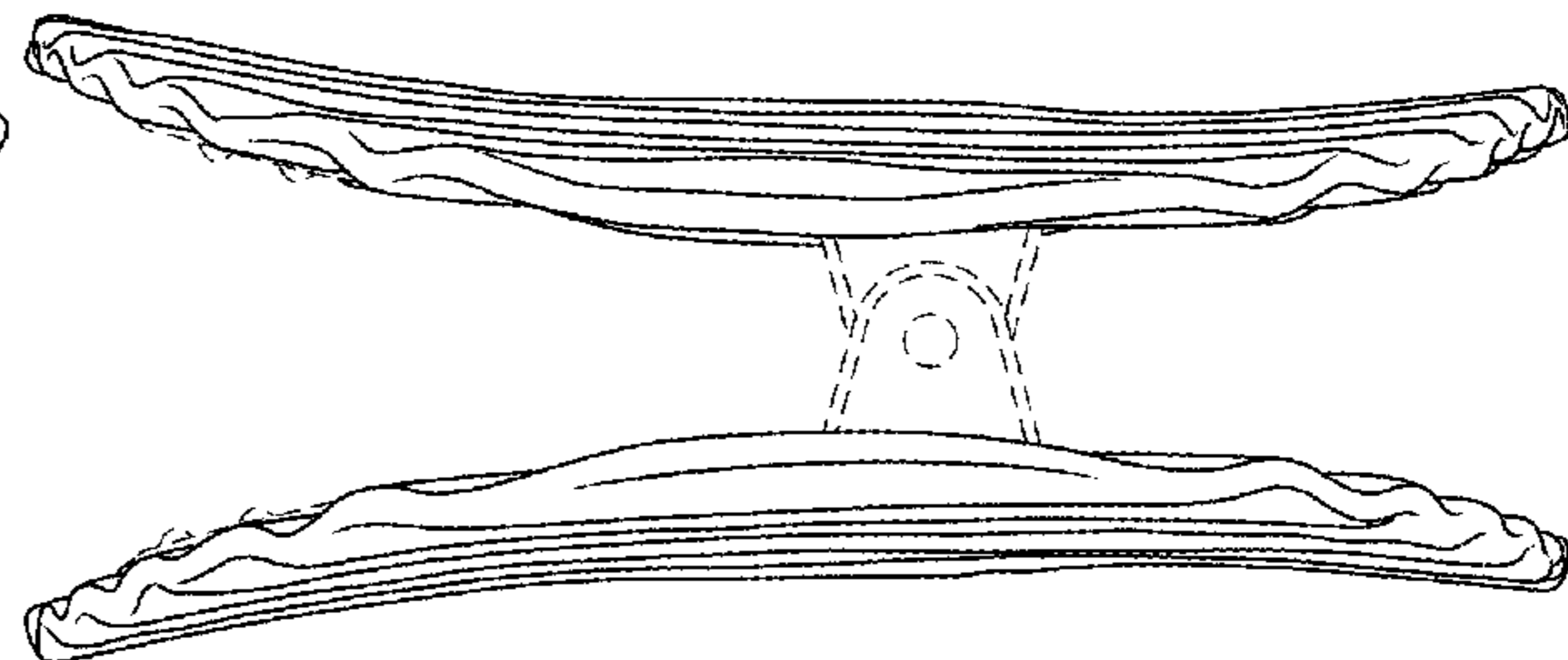
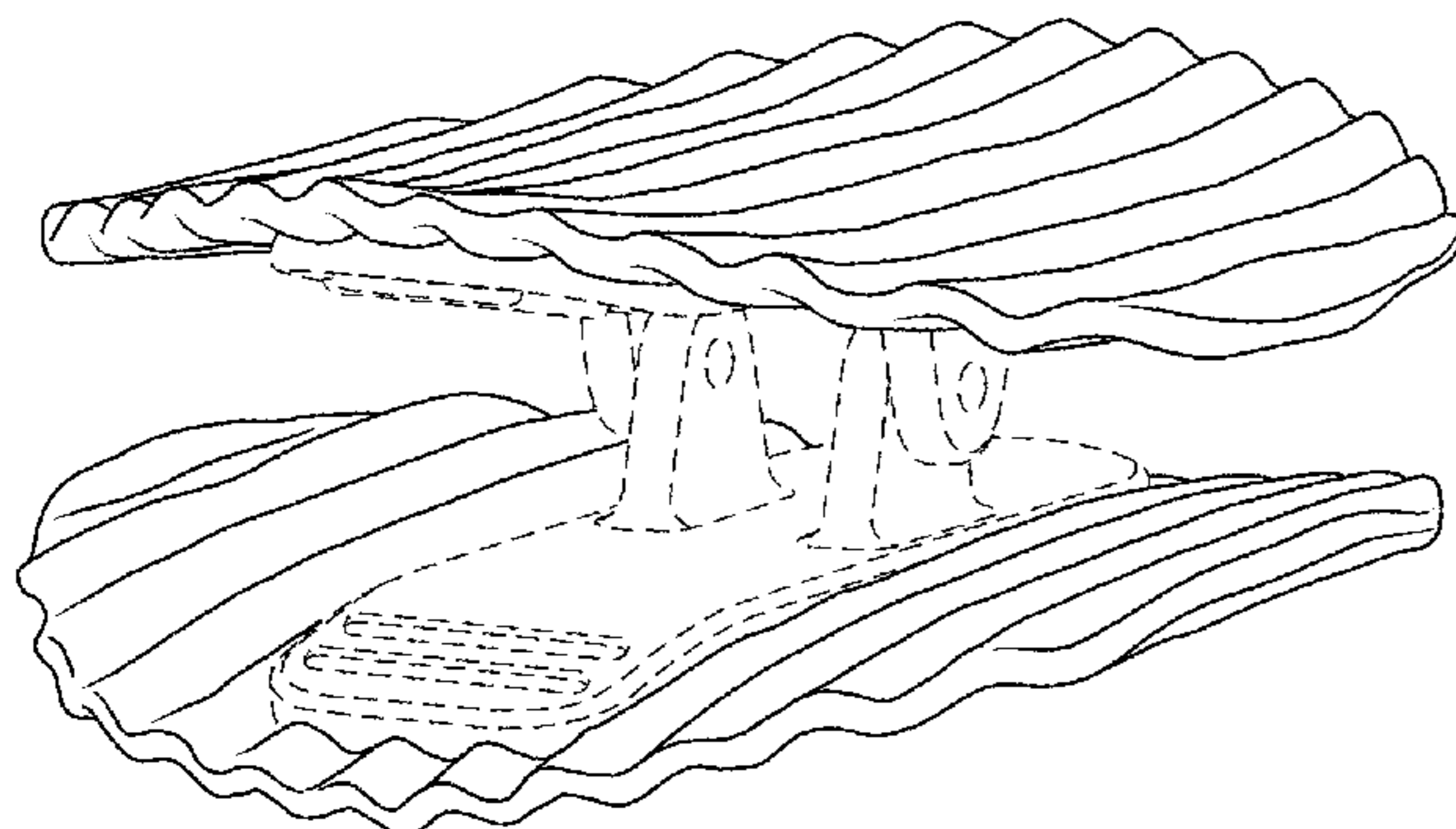
The ornamental design for a bag clip, as shown and

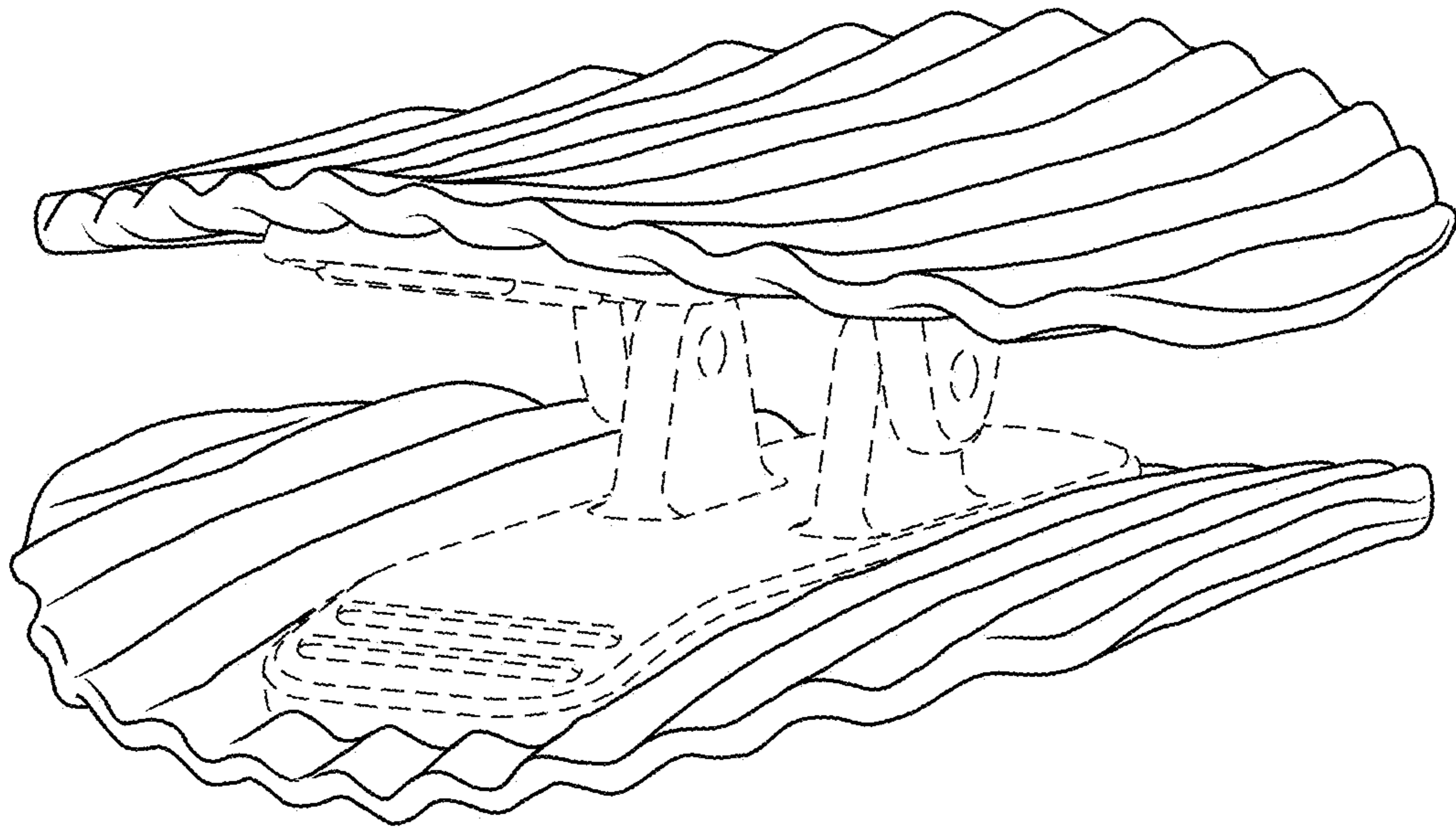

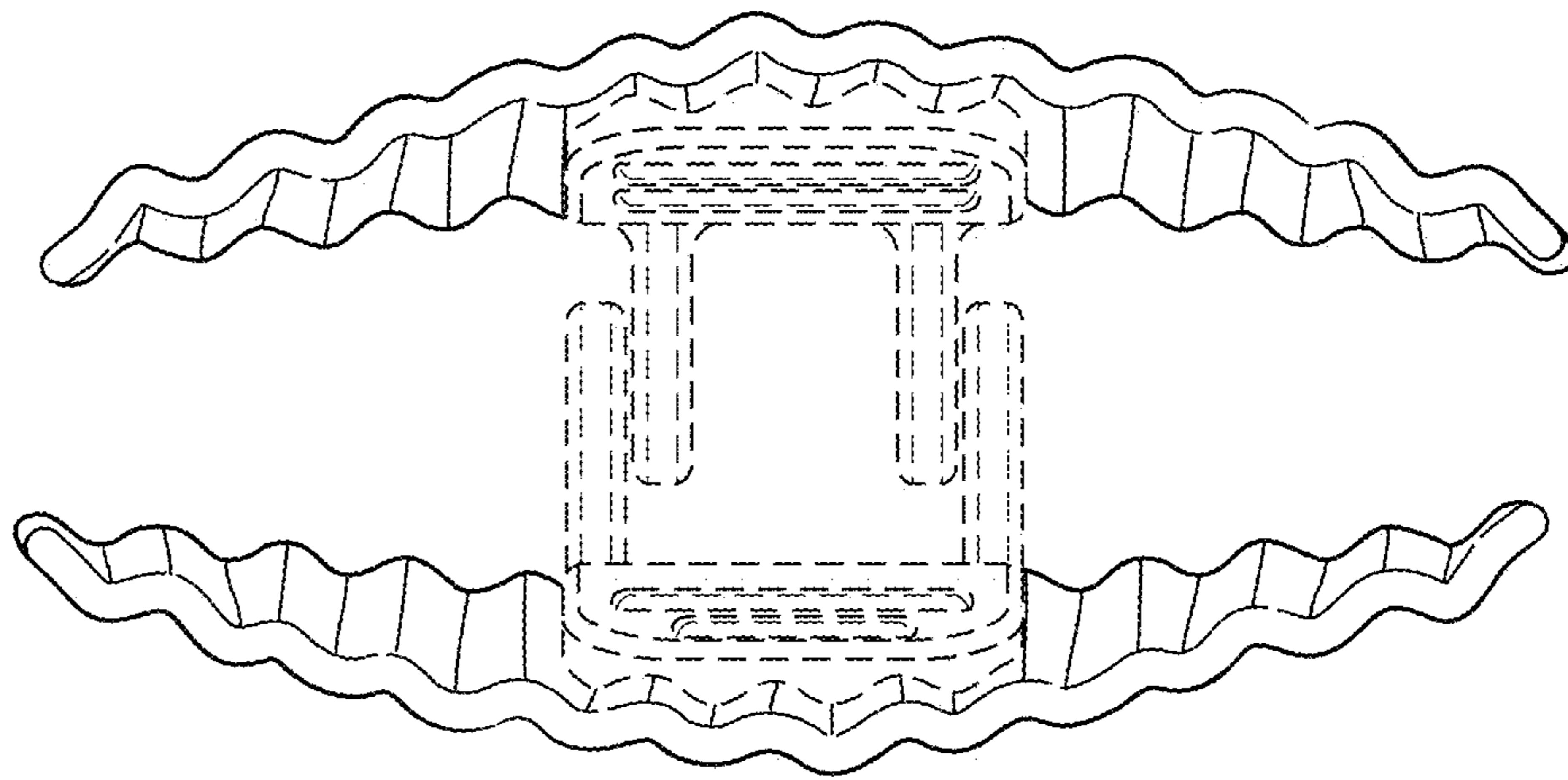

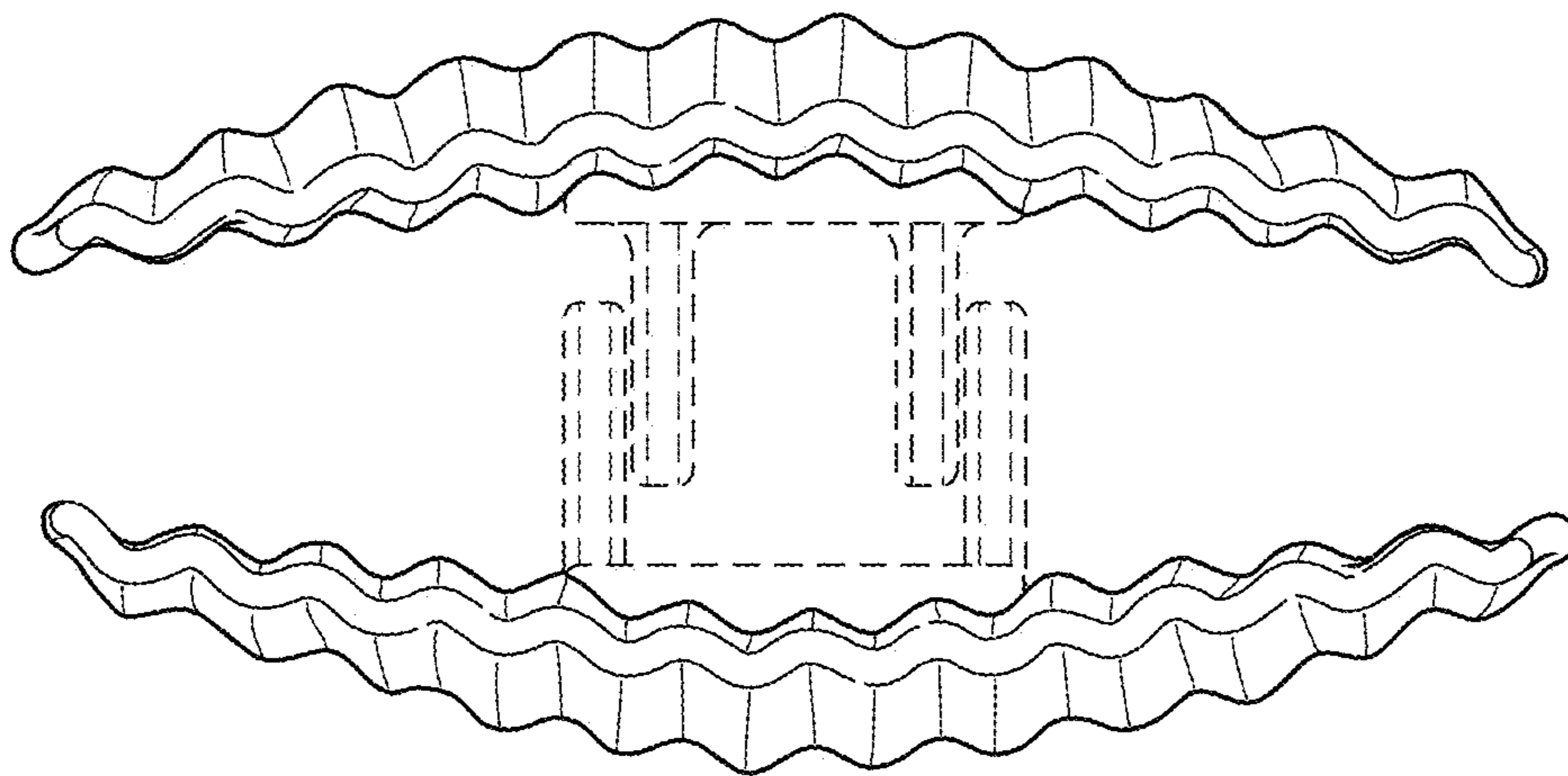

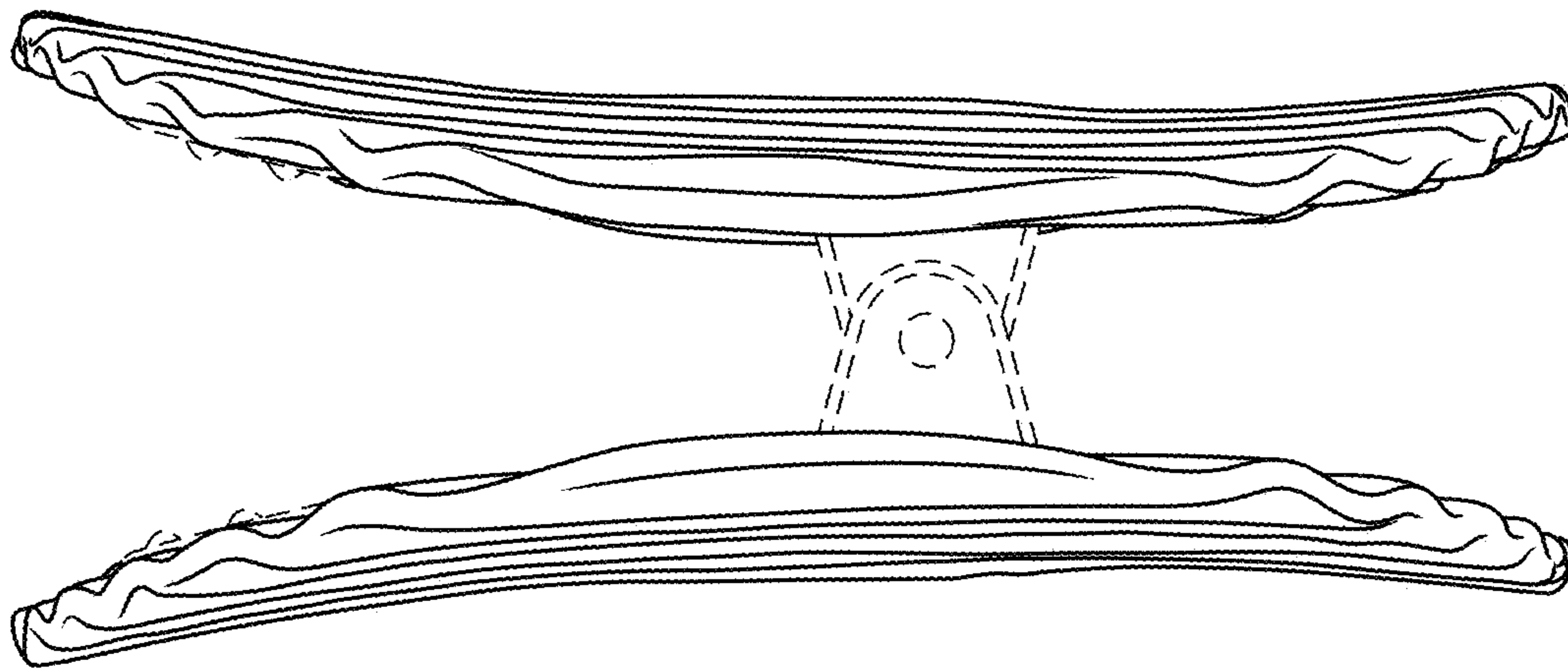

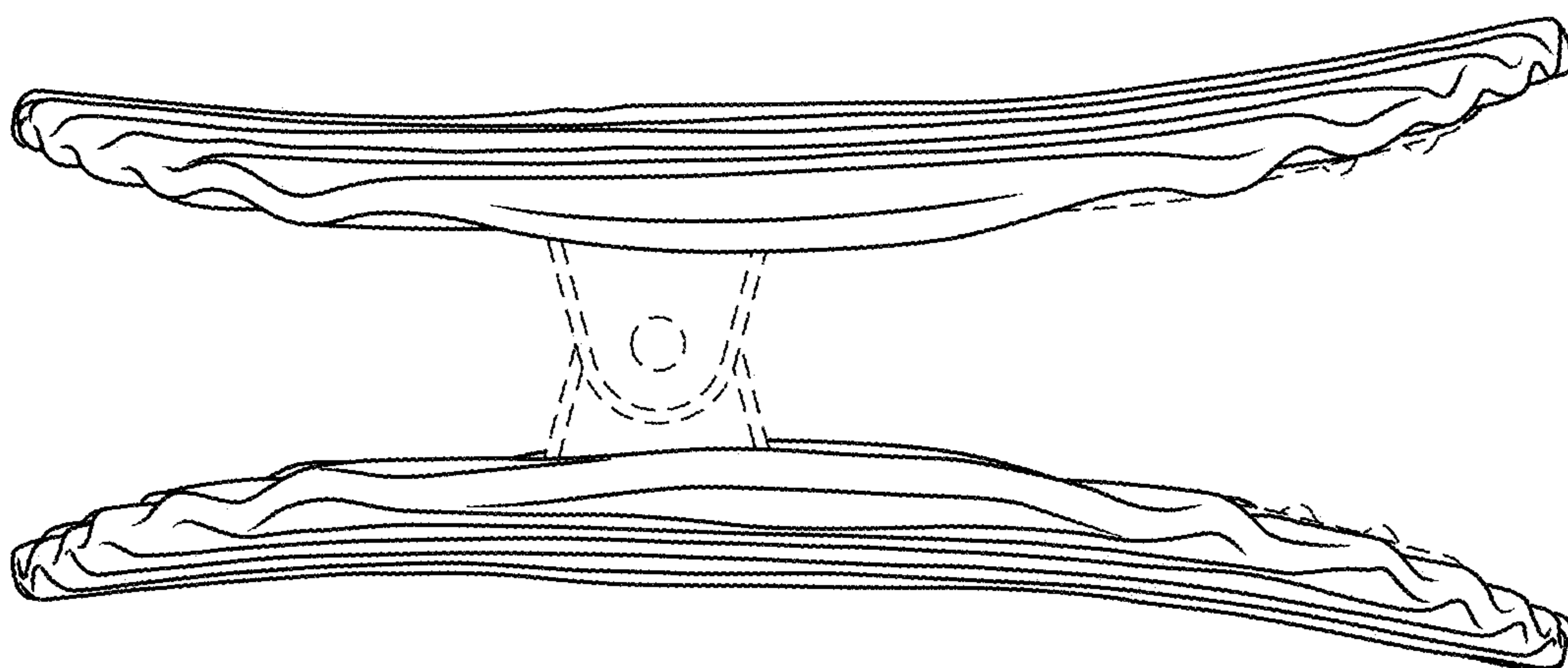

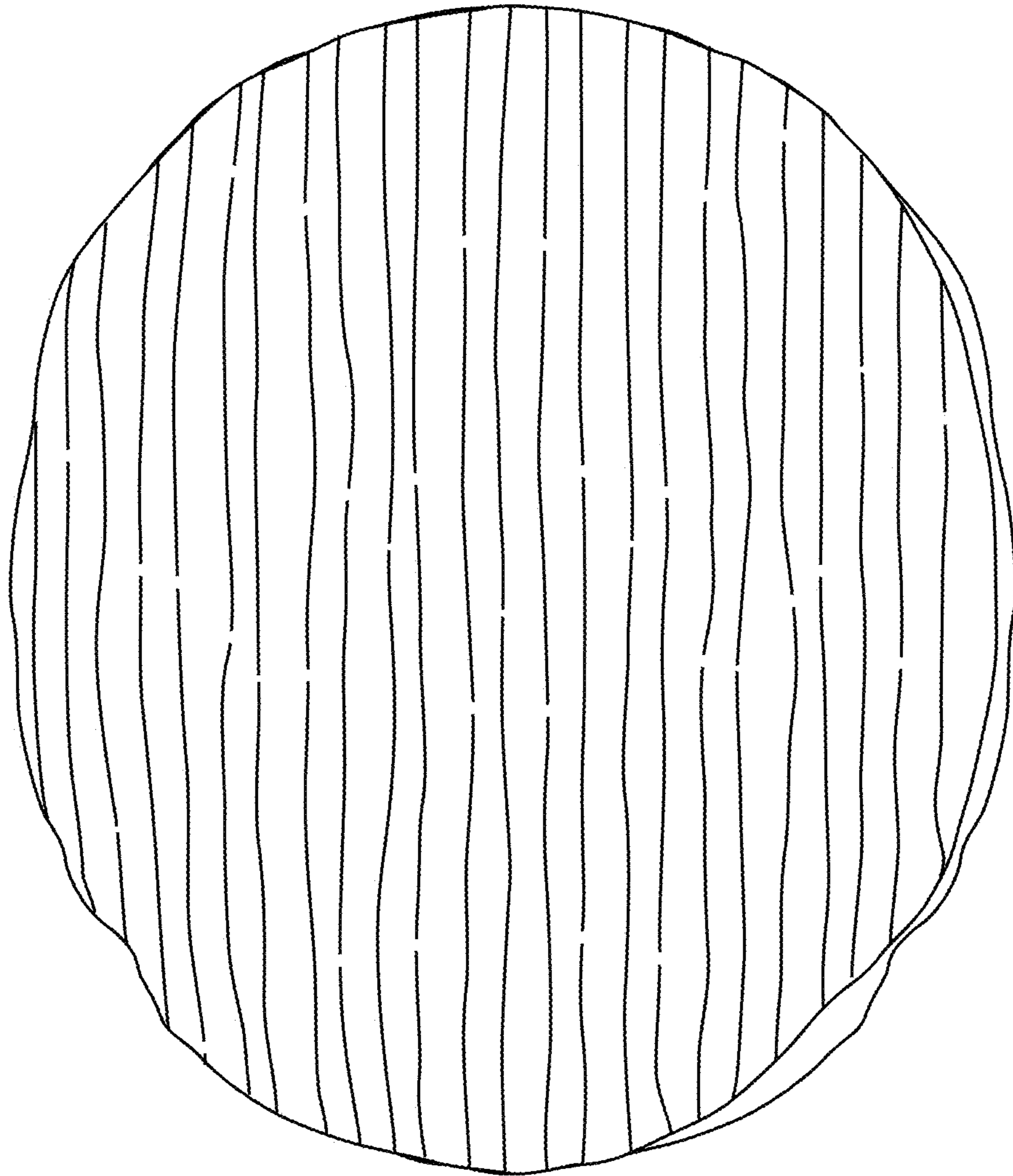

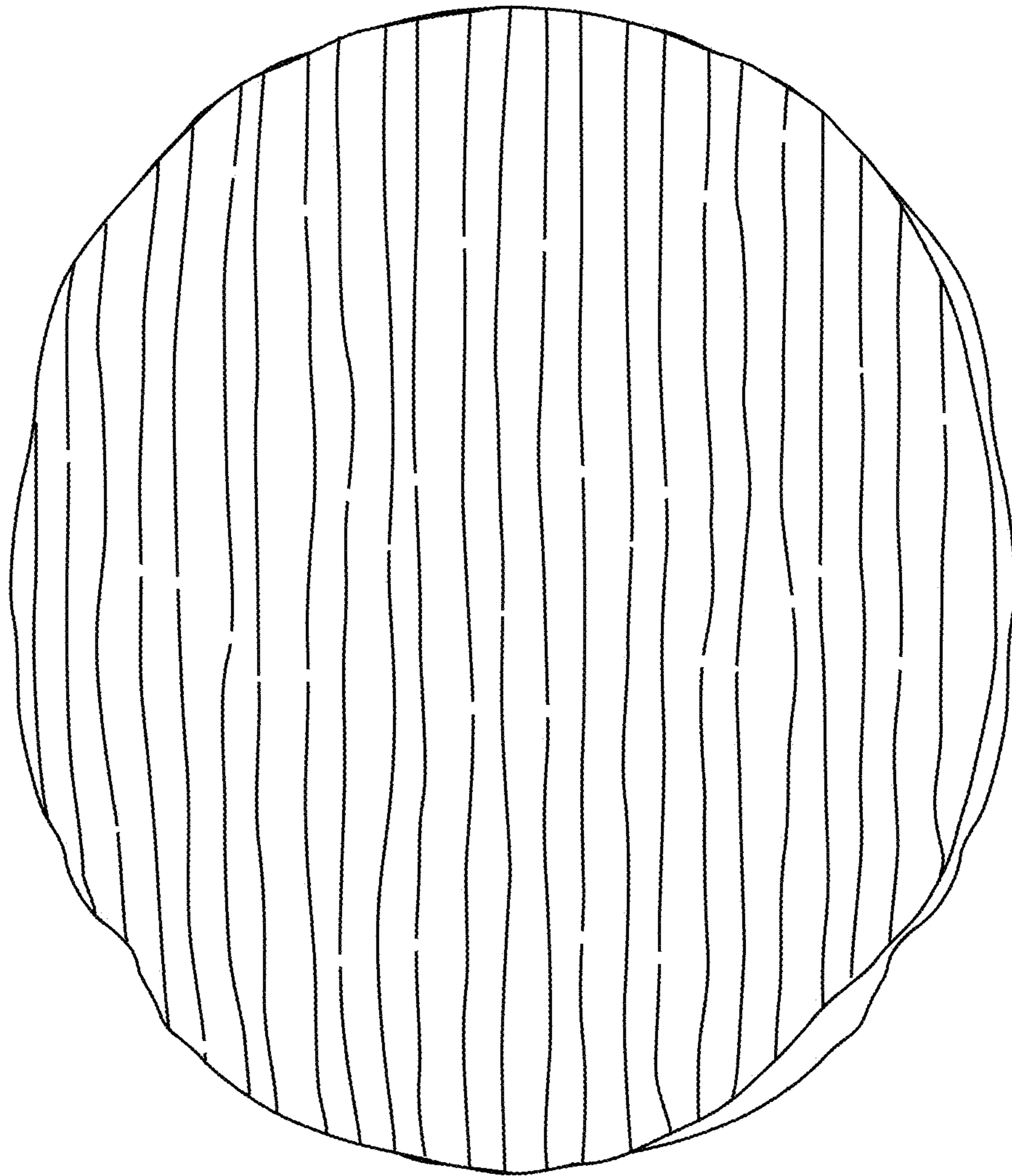
