DESCRIPTION

FIG. 1 is a front perspective view of a tab.

FIG. 4 is a left side view of the tab of FIG. 1.
FIG. 5 is a right side view of the tab of FIG. 1.
FIG. 6 is a top view of the tab of FIG. 1.
FIG. 7 is a bottom view of the tab of FIG. 1; and,
FIG. 8 is a front perspective view of the example tab of FIG.
1 coupled to an example can end.

and/or contours.

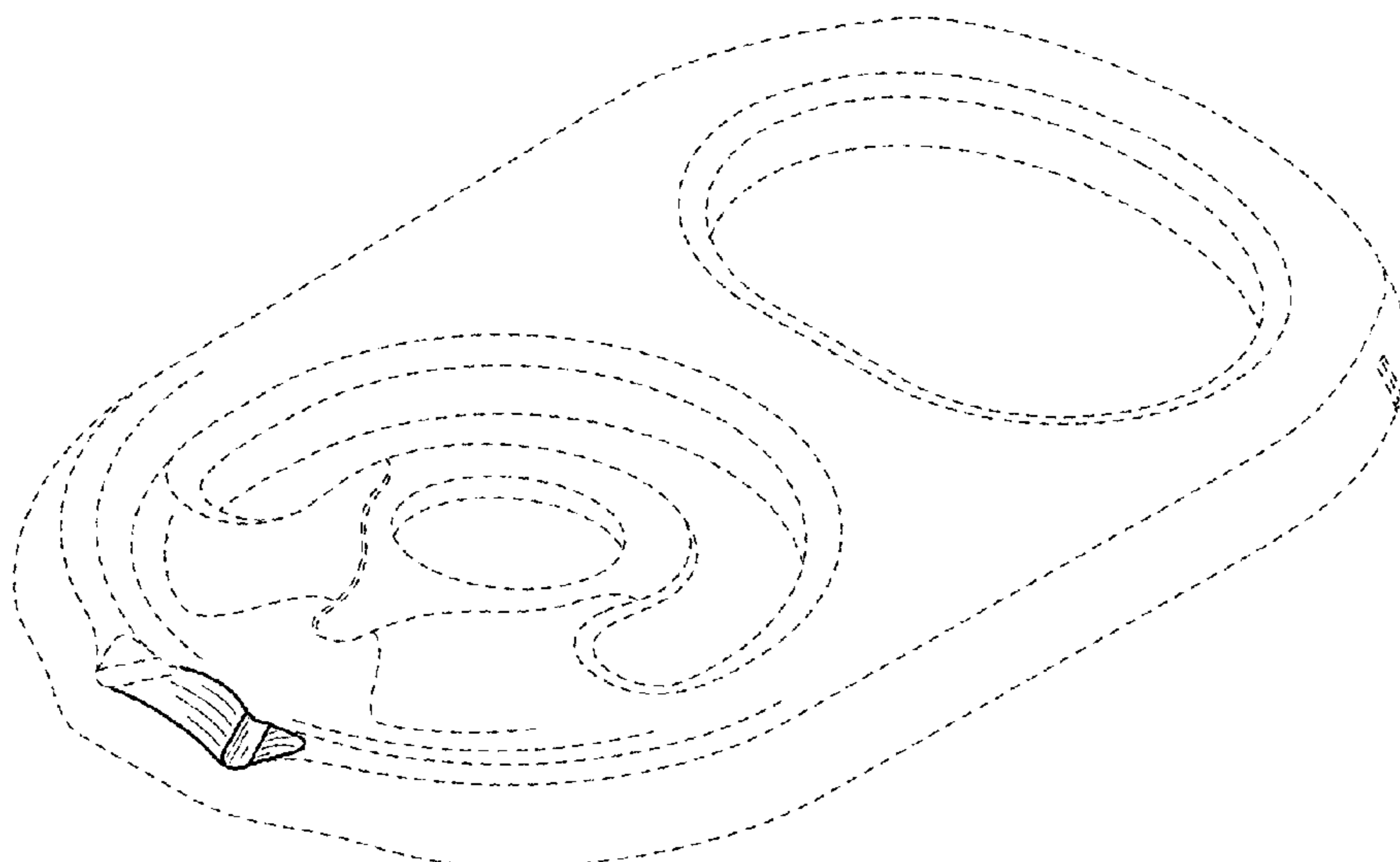

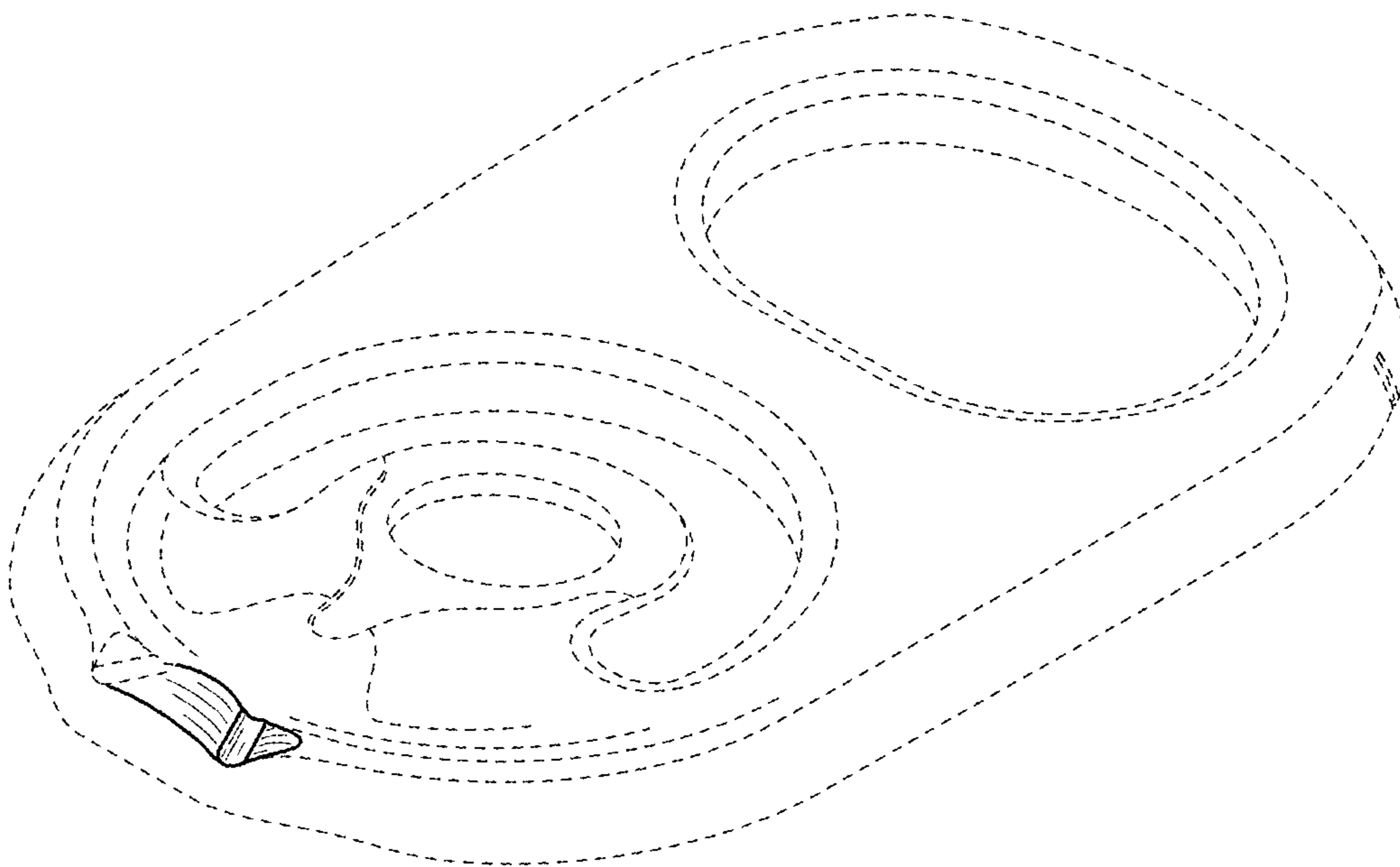

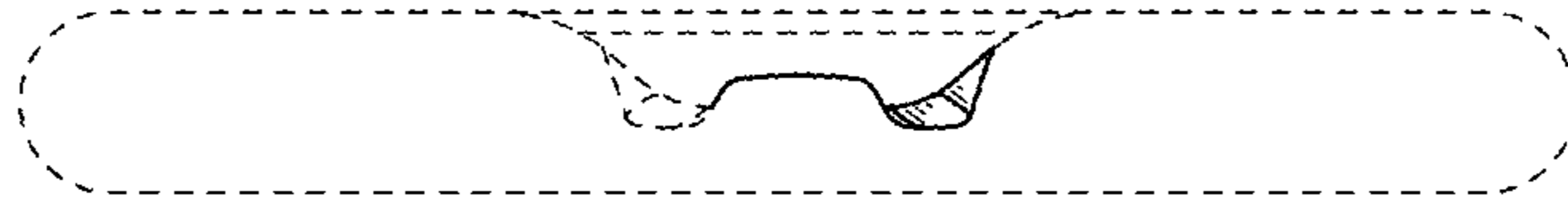

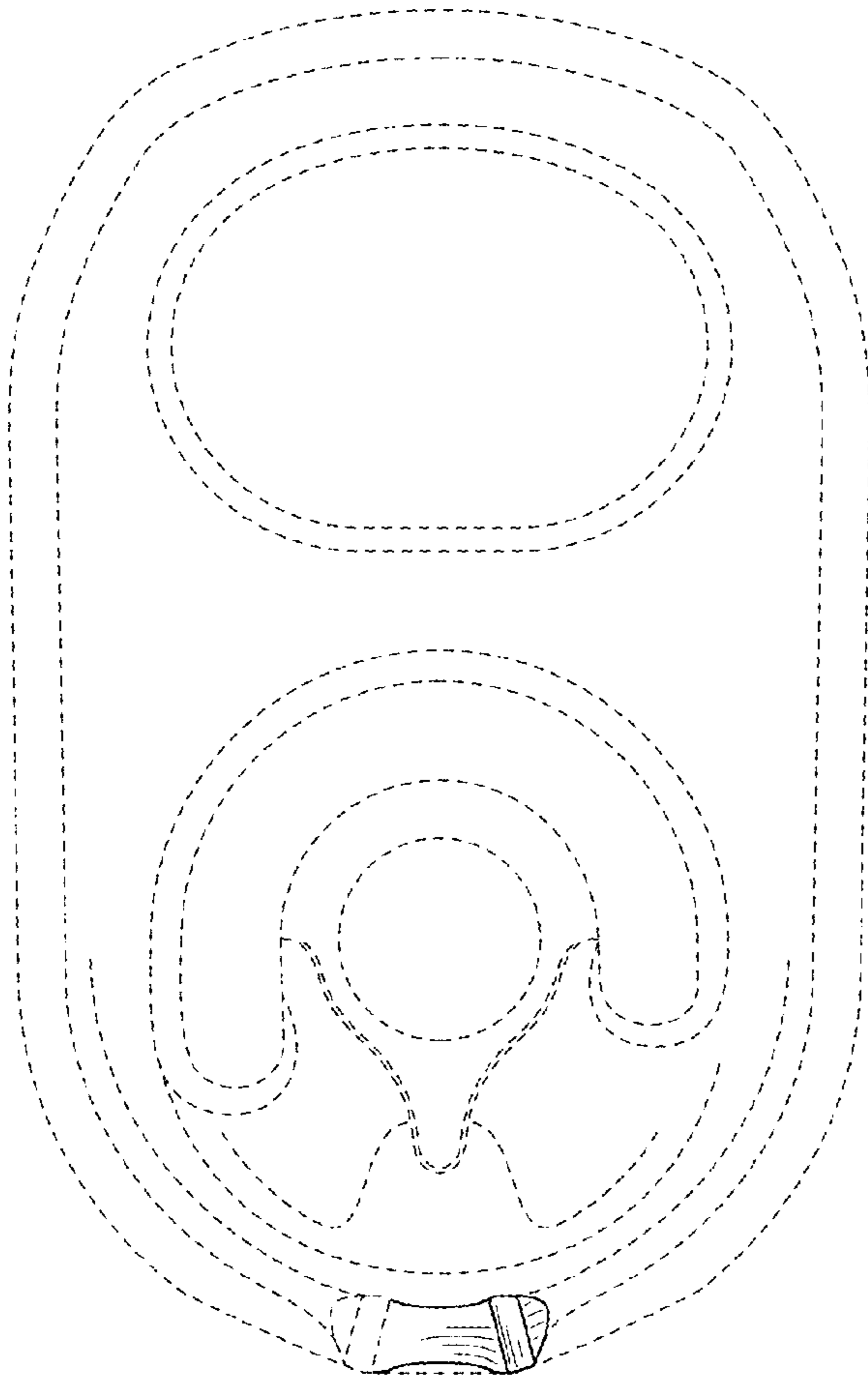

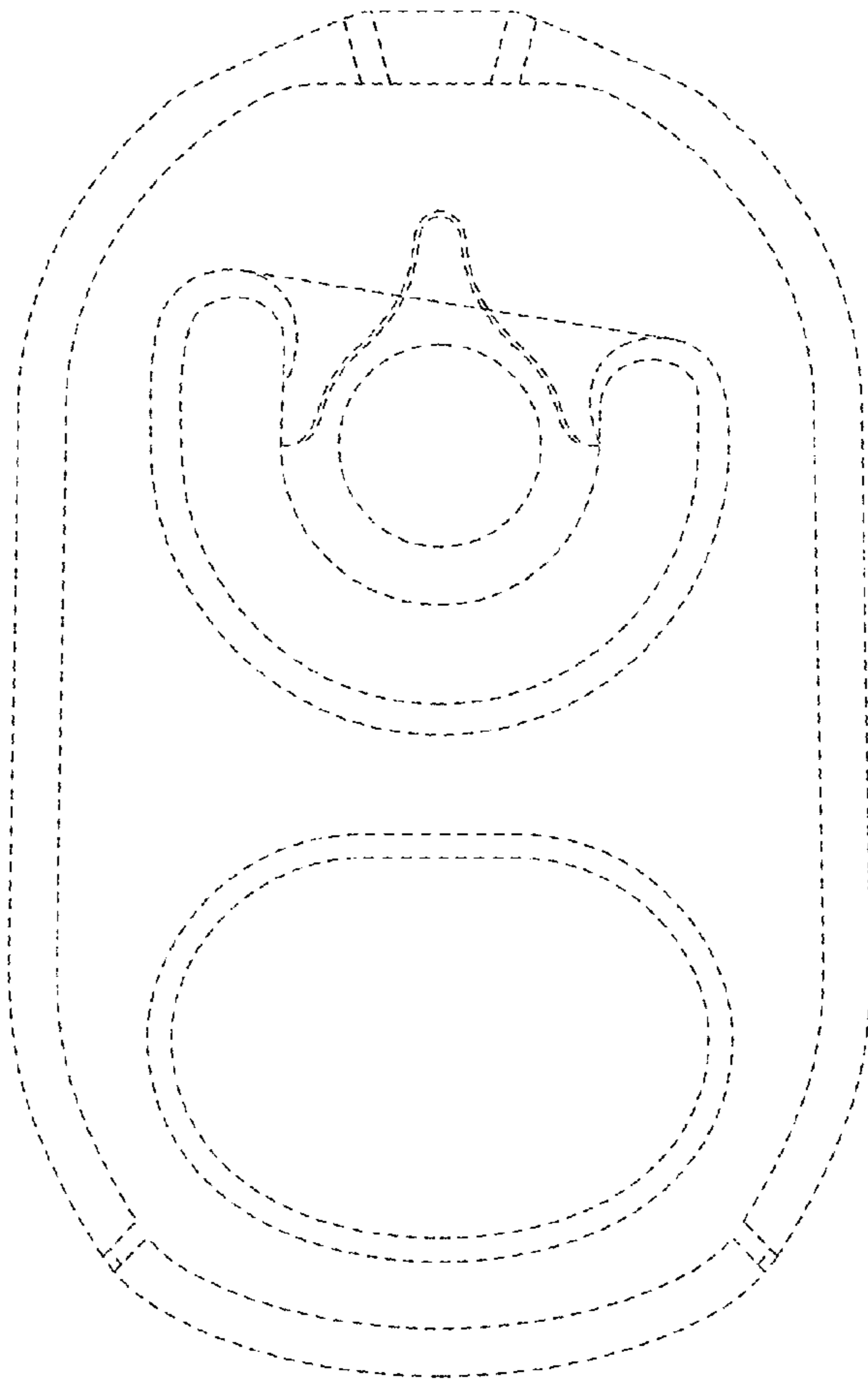

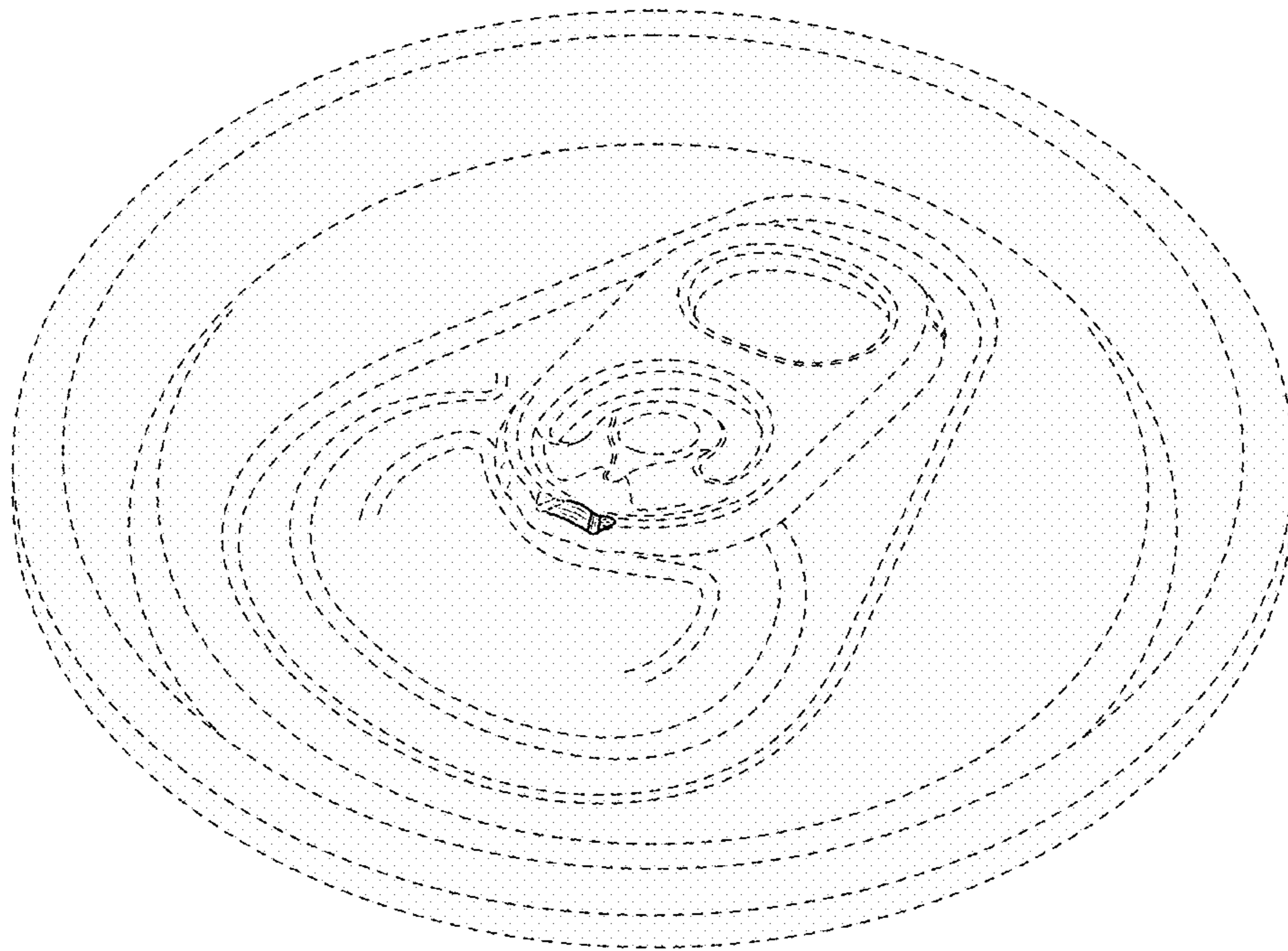
