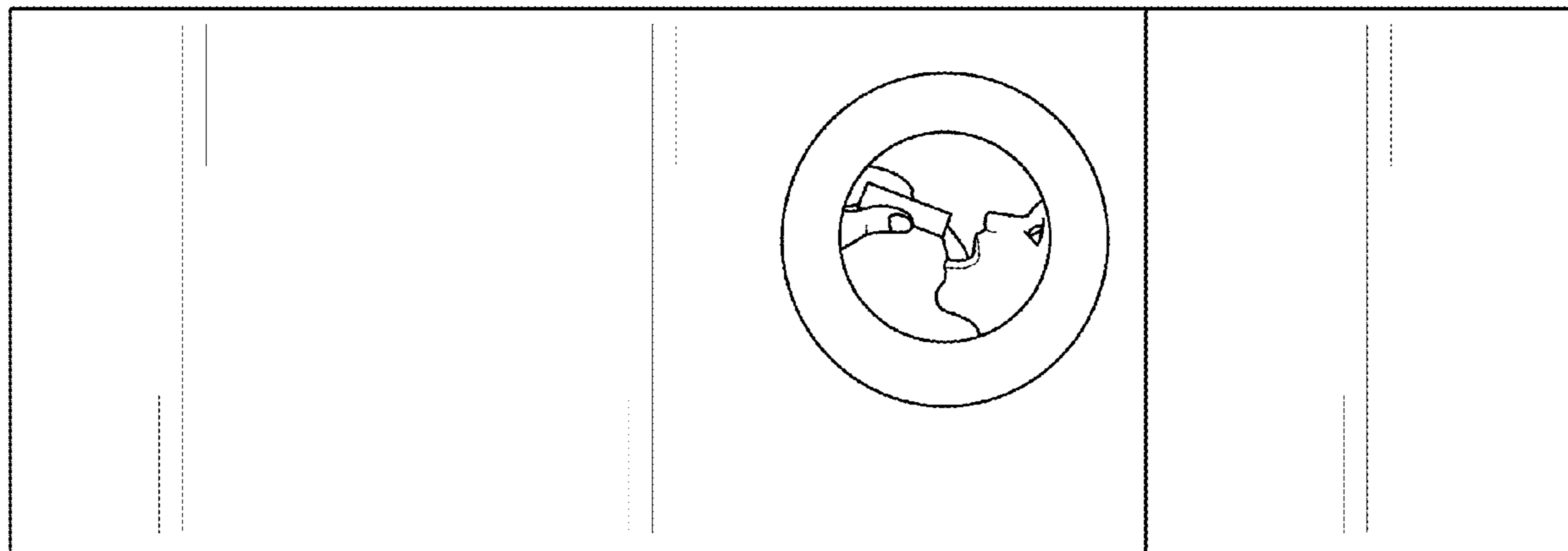
(57) **CLAIM**

The ornamental design for a product package with surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the product package with surface pattern; and,
FIG. 2 is a front view of a second embodiment of the product package with surface pattern.
The ornamental design which is claimed is shown in solid lines in the drawings.
The dashed broken lines are shown for the purpose of illustrating environment and form no part of the claimed design.
Designs 1-2 show packages with surface patterns for medication.

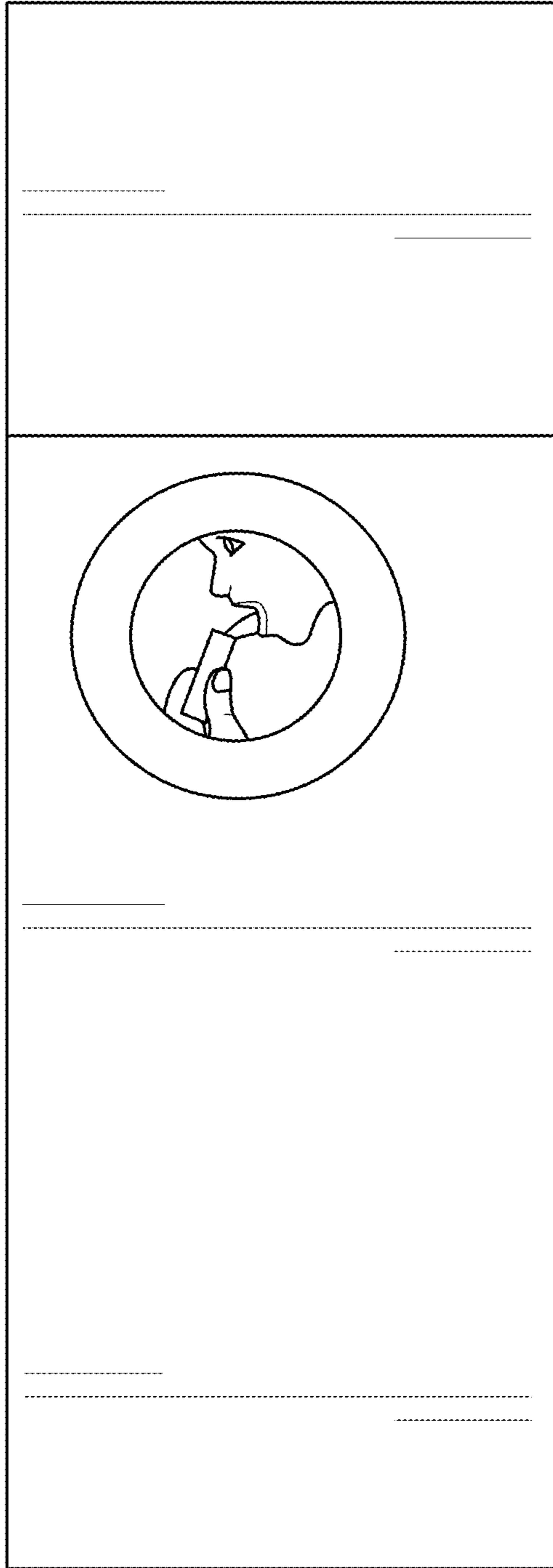

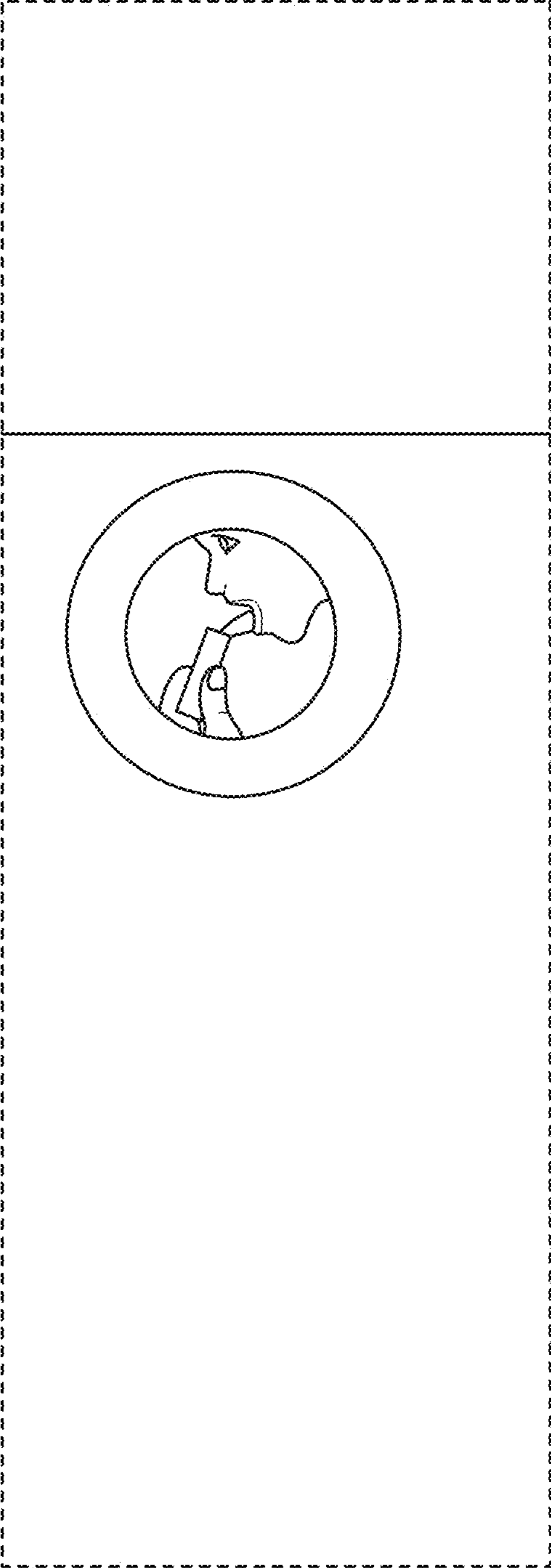
