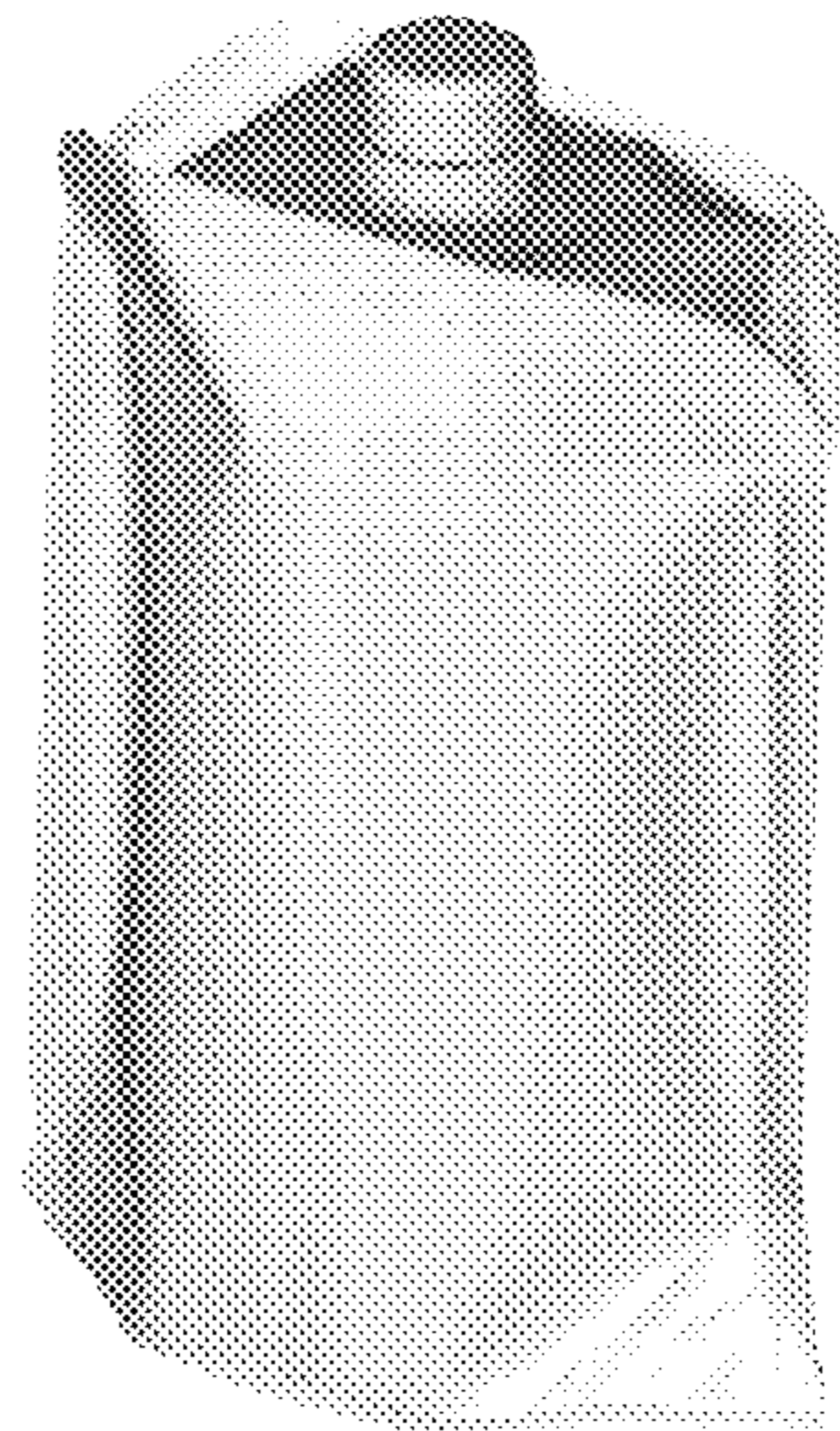
The ornamental design for a packaging bag, as shown and described.

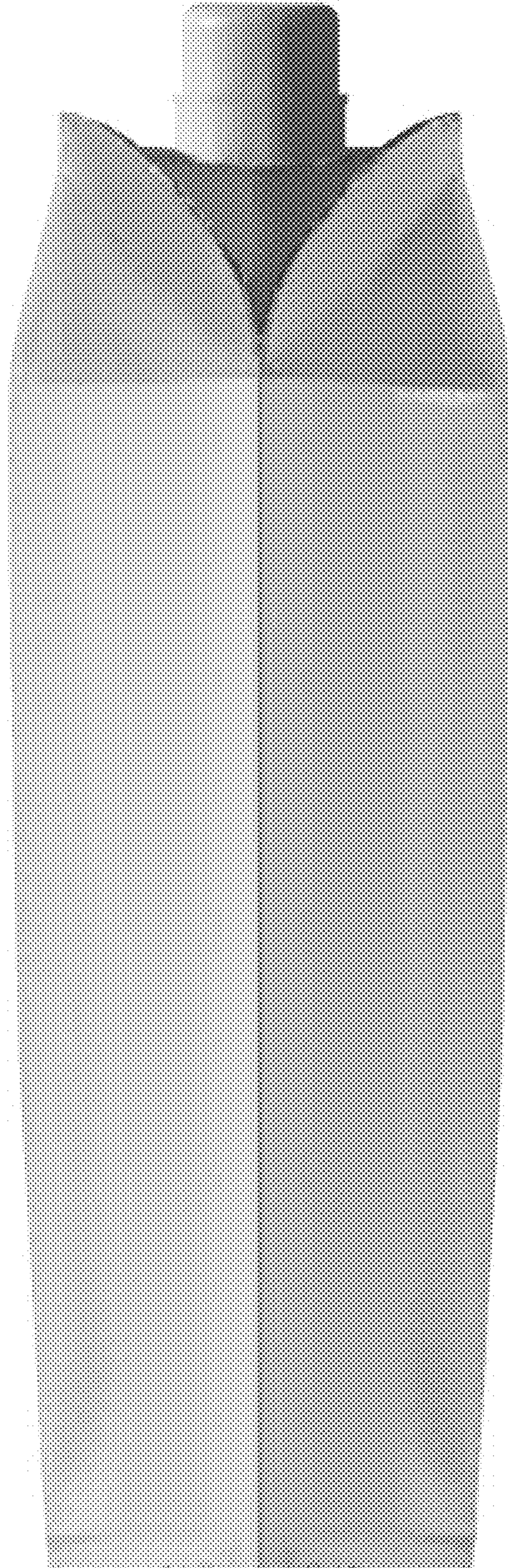

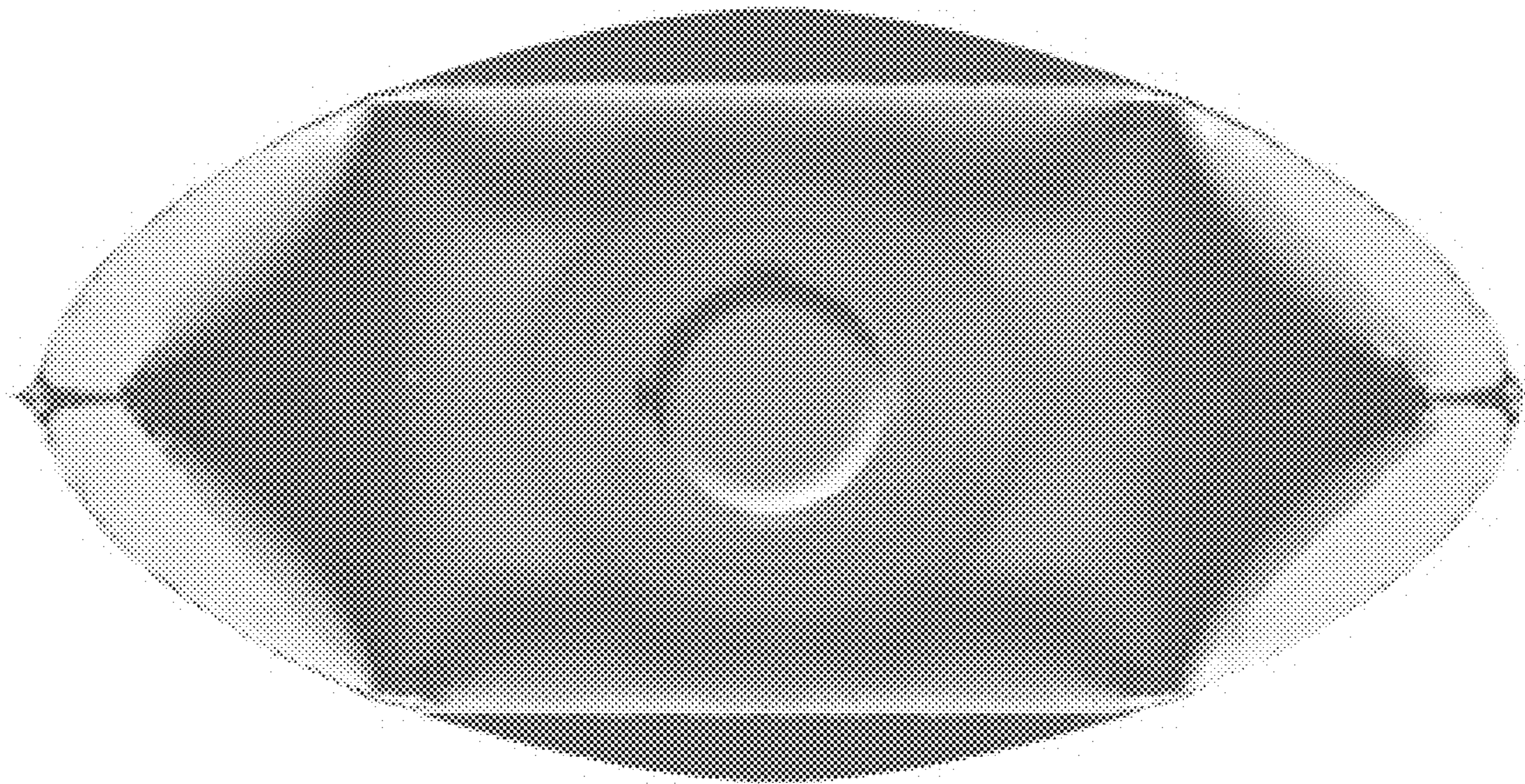

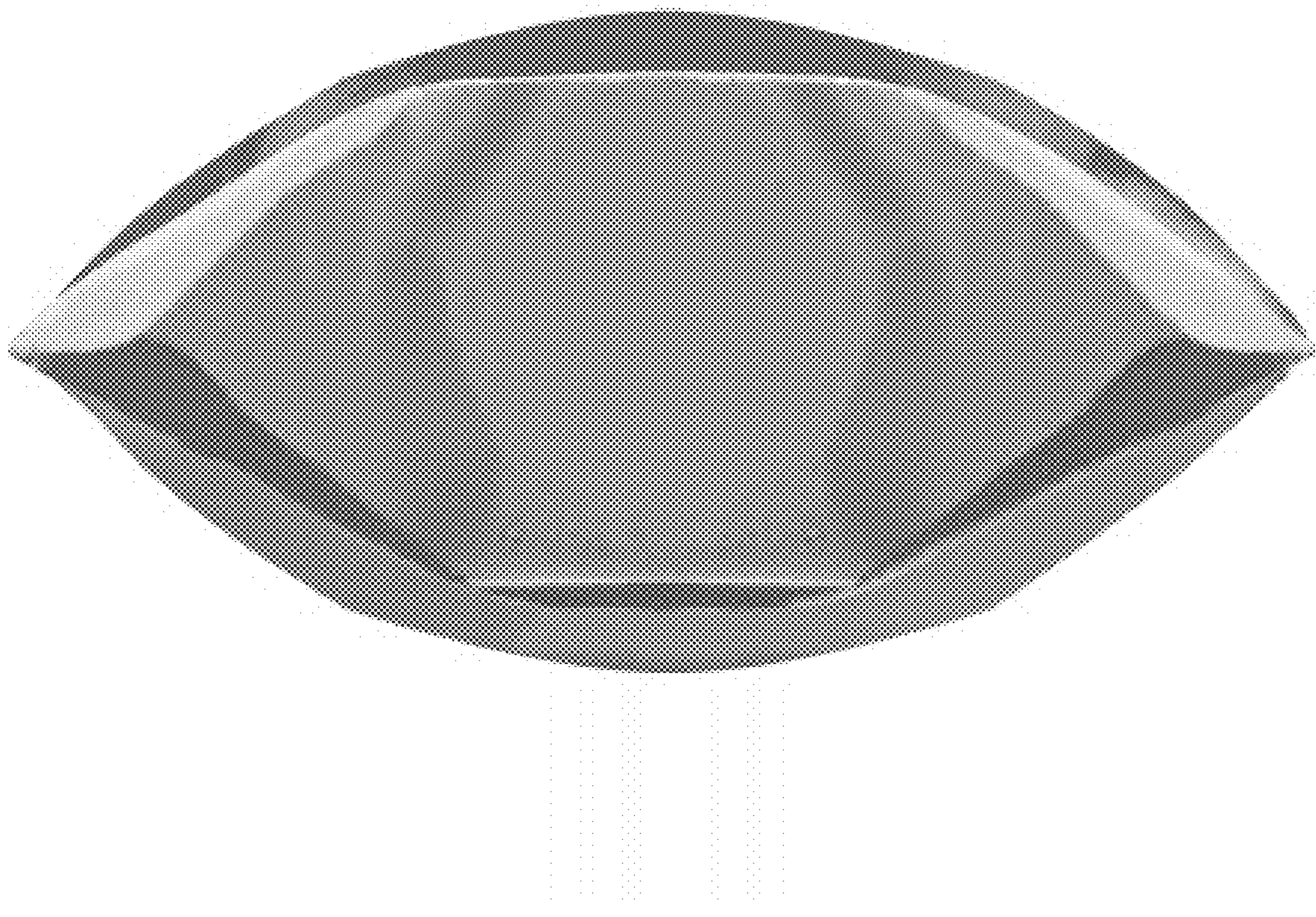
