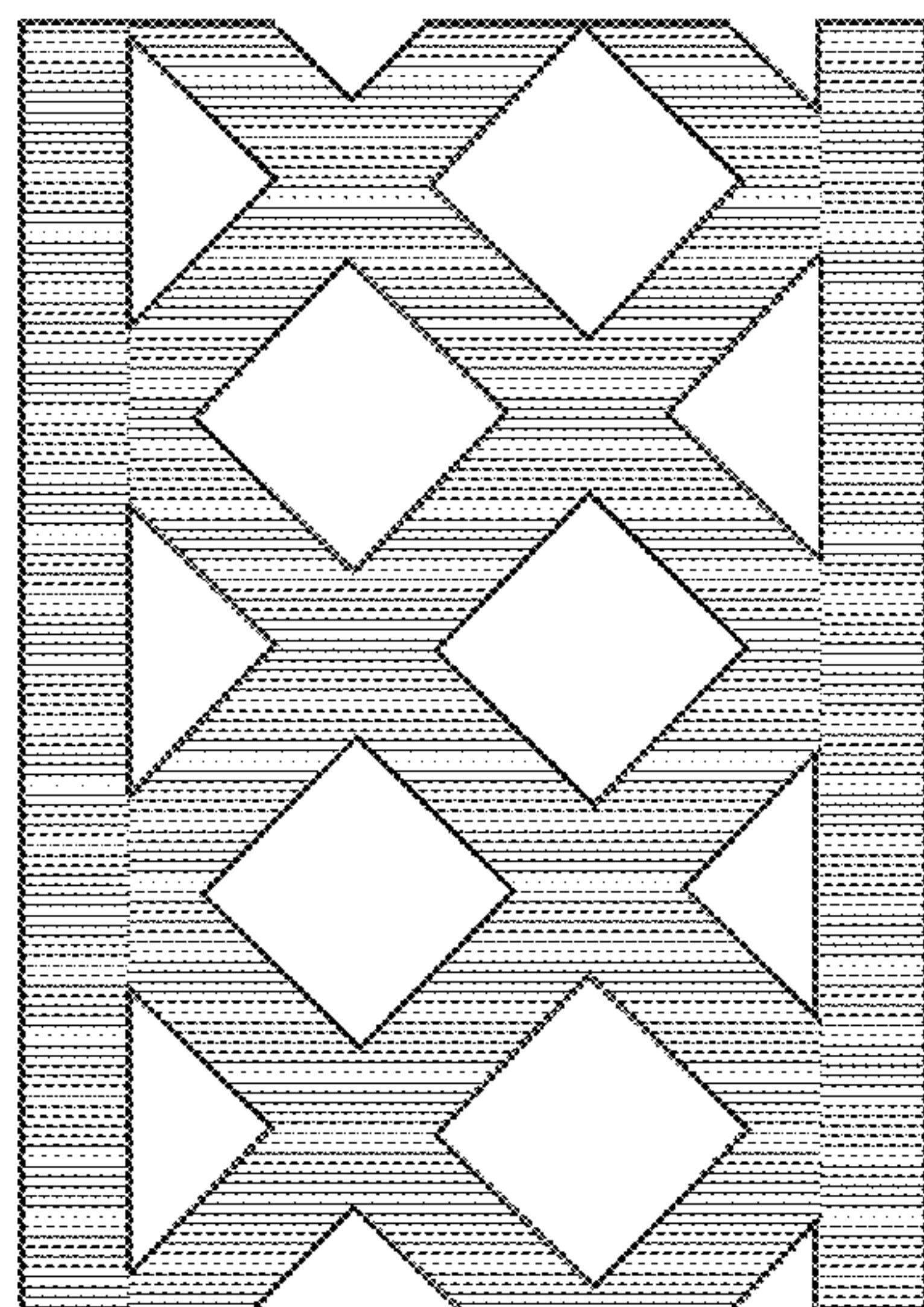
(57) **CLAIM**

The ornamental design for a turf grid, as shown and described.

**DESCRIPTION**

FIG. 1 is top plan view of a turf grid showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a front elevation view thereof, the back elevation view being identical; and,  
FIG. 4 is a left side elevation view thereof, the right side elevation view being identical.  
All the white areas in the drawings represent open, pass through spaces.

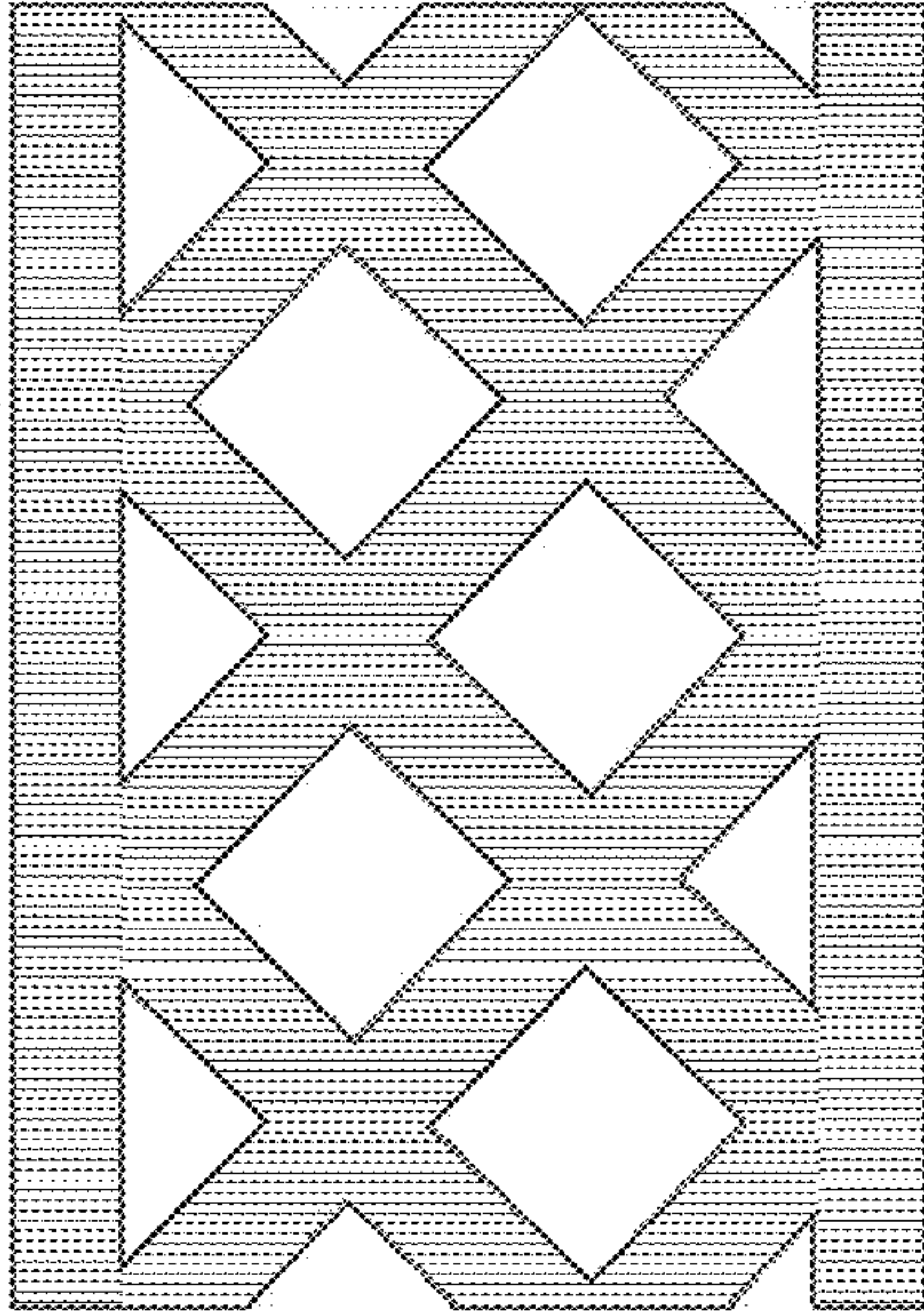

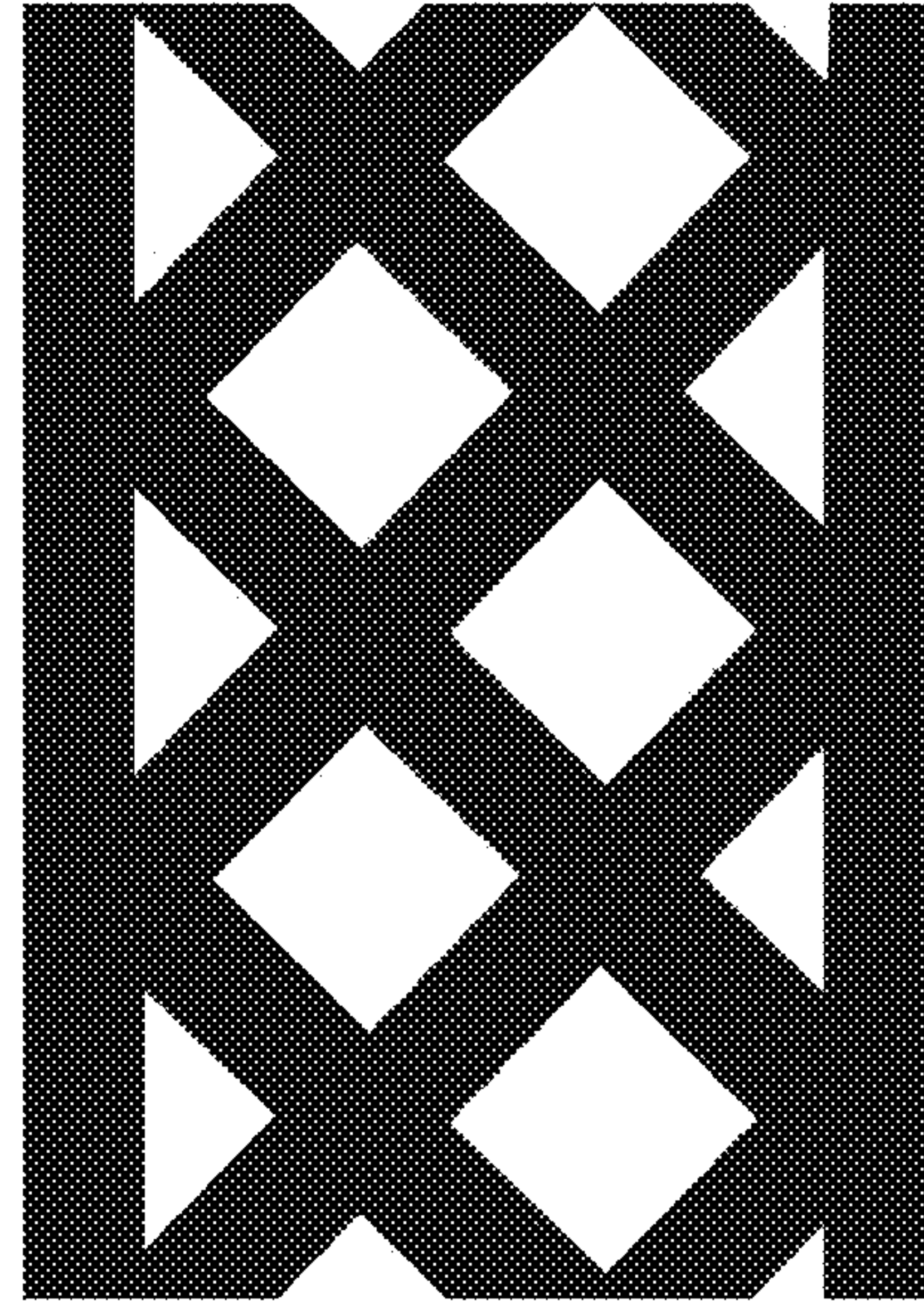
