DESCRIPTION

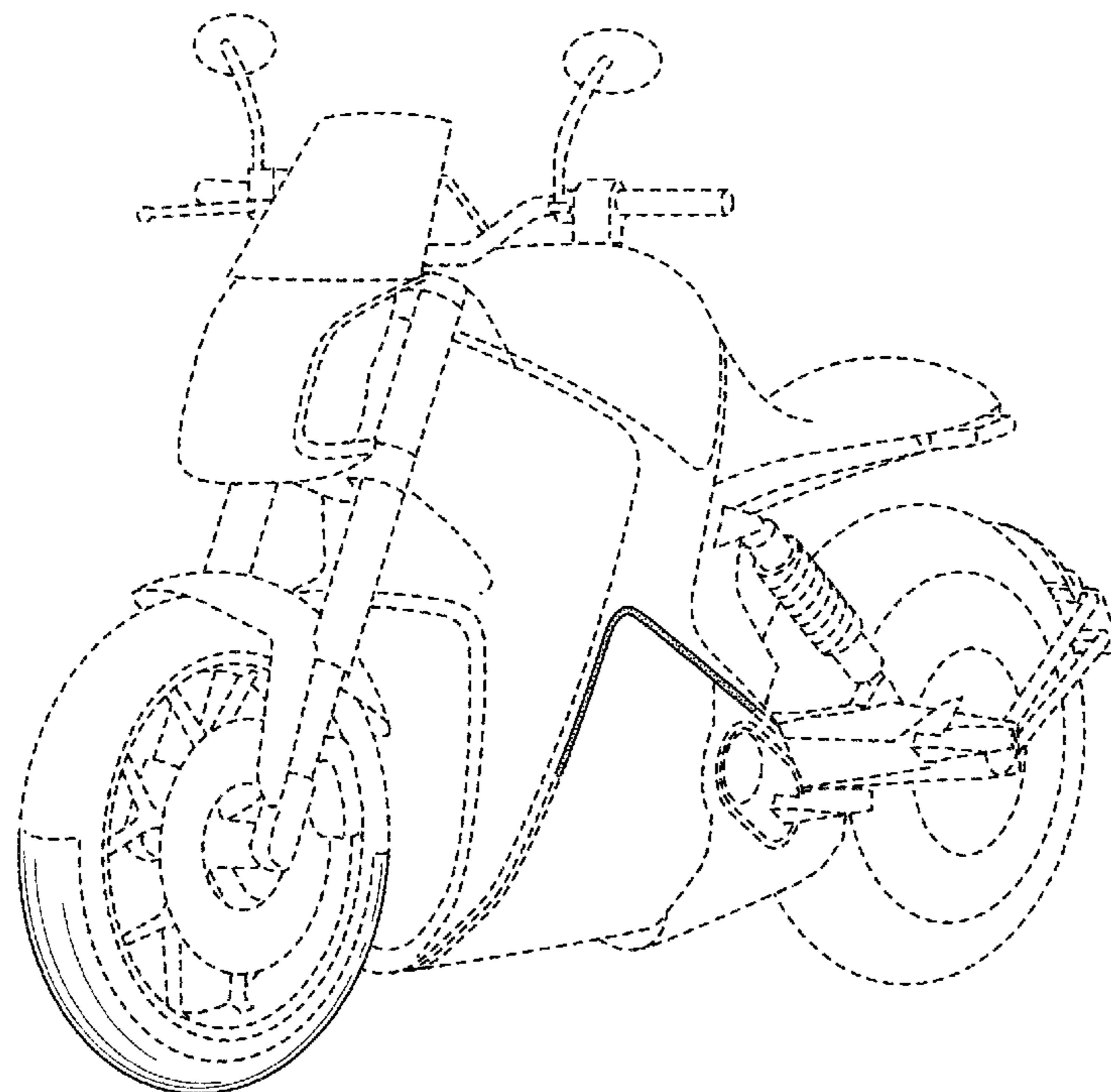
FIG. 1 is a front, right perspective view of a motorcycle showing my new design;

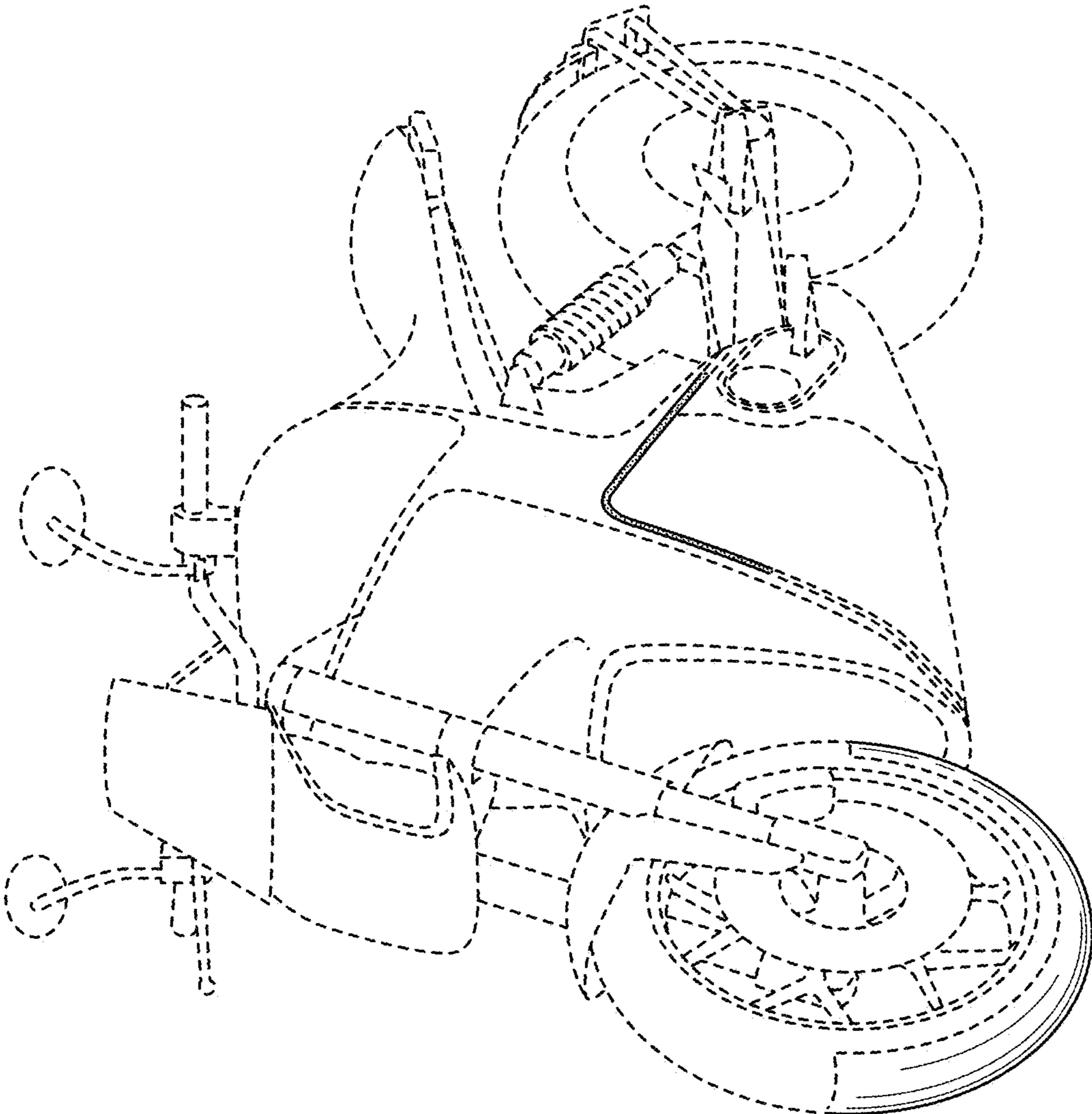

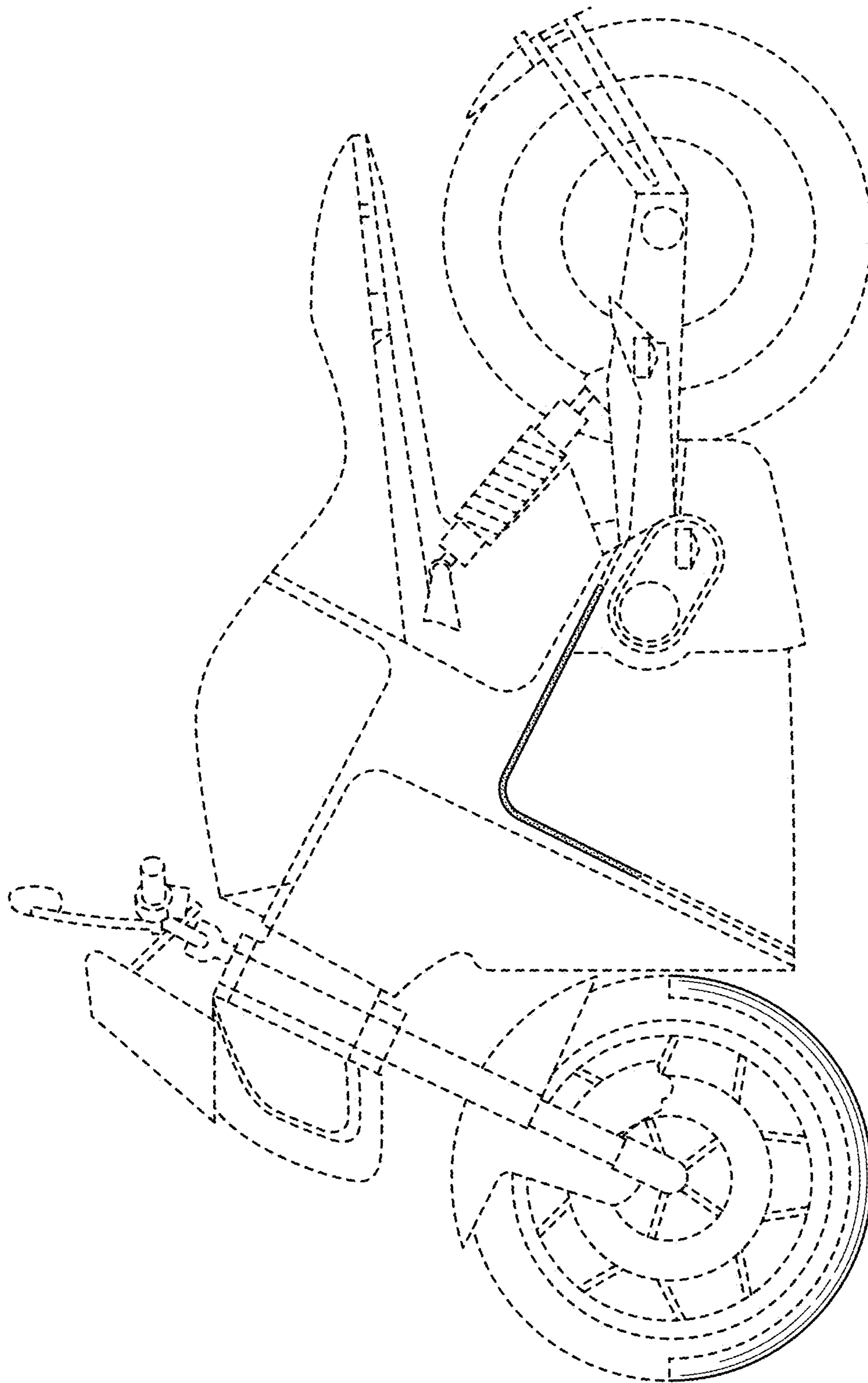

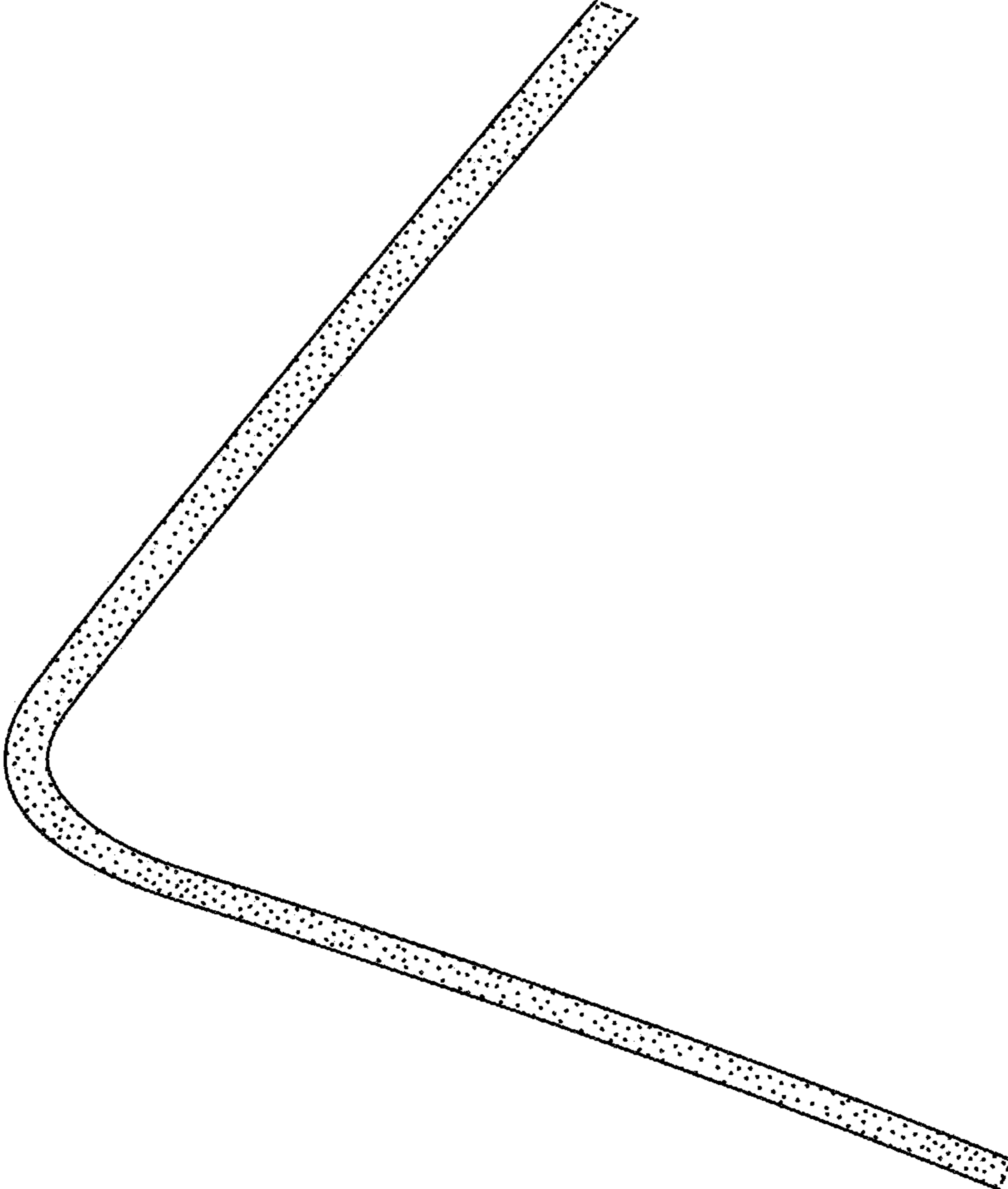
