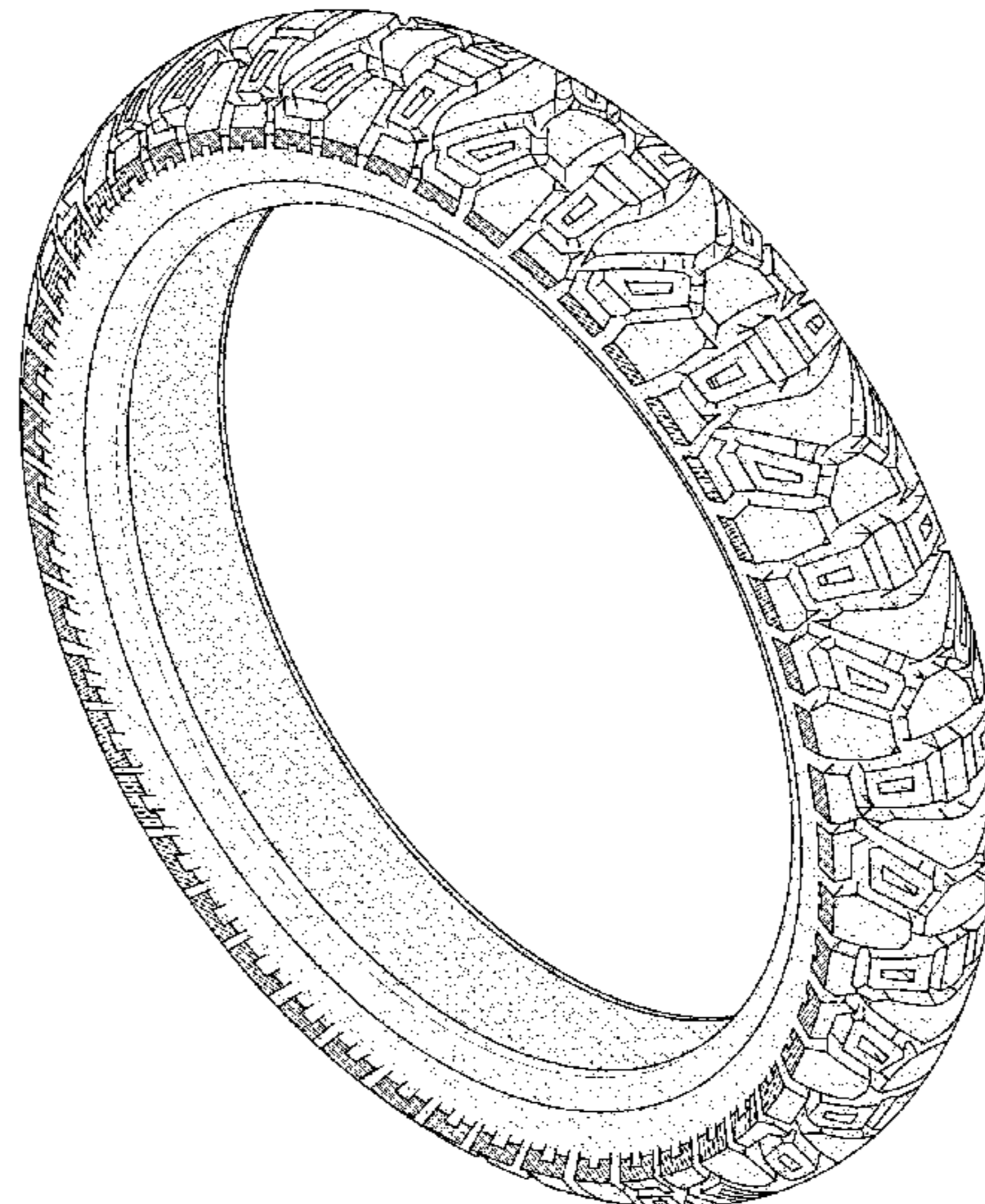
(57) **CLAIM**

The ornamental design for a tire for motorcycle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire for motorcycle showing our new design, it being understood that the pattern repeats uniformly throughout the circumference of the tread;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a top view thereof;  
FIG. 8 is a partial enlarged view of FIG. 2;  
FIG. 9 is a partial enlarged left, perspective view, of the portion 9-9 illustrated in FIG. 3, the right side being a mirror image thereof; and,  
FIG. 10 is a cross-sectional view along the lines 10-10 in FIG. 5.

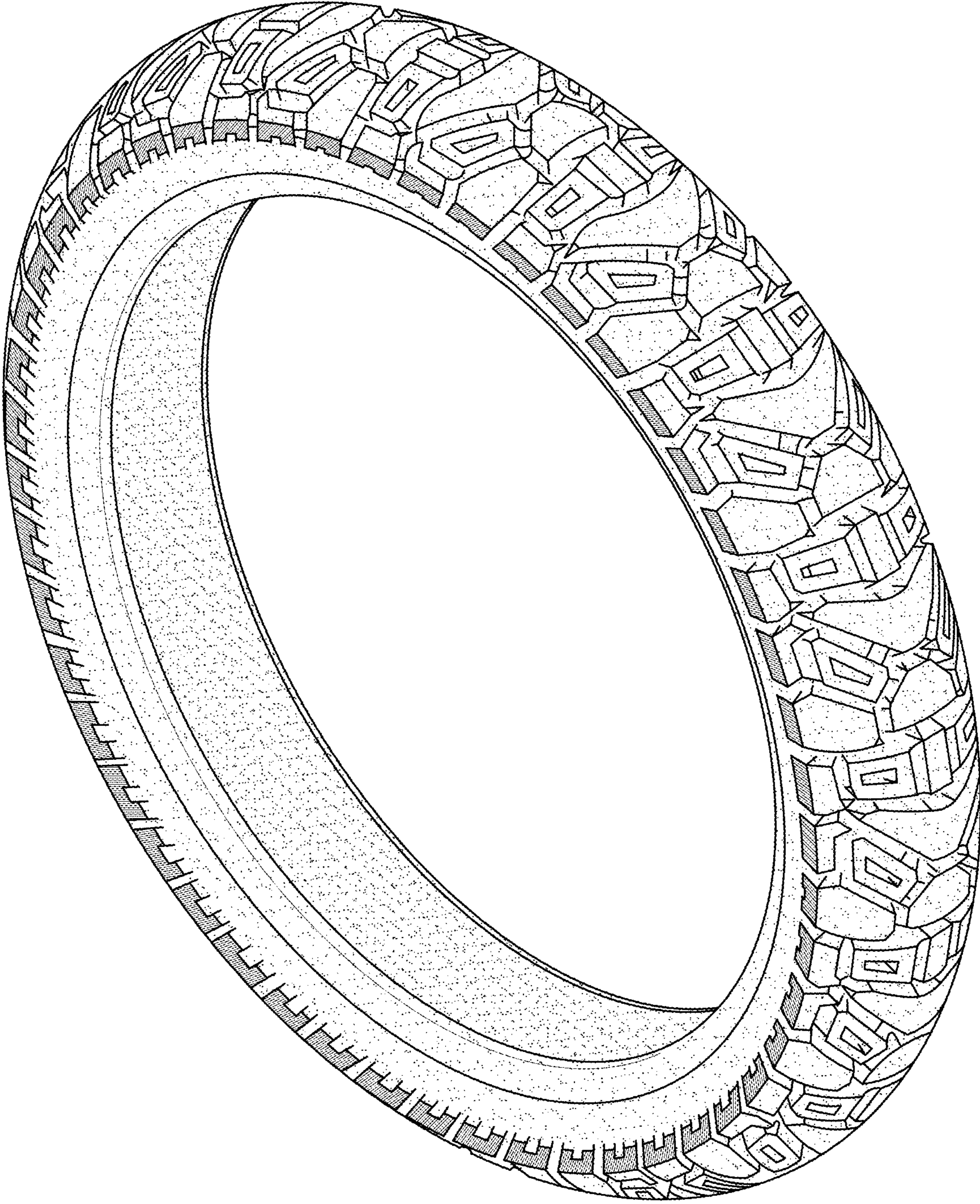

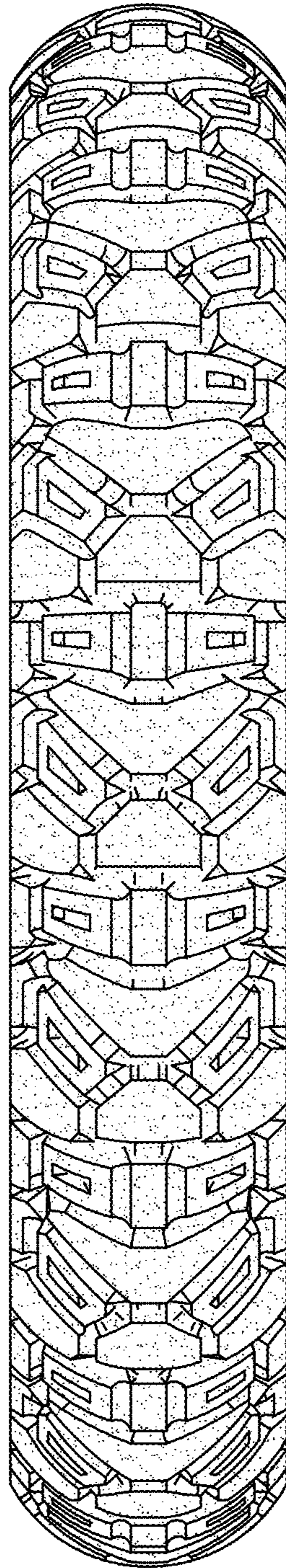

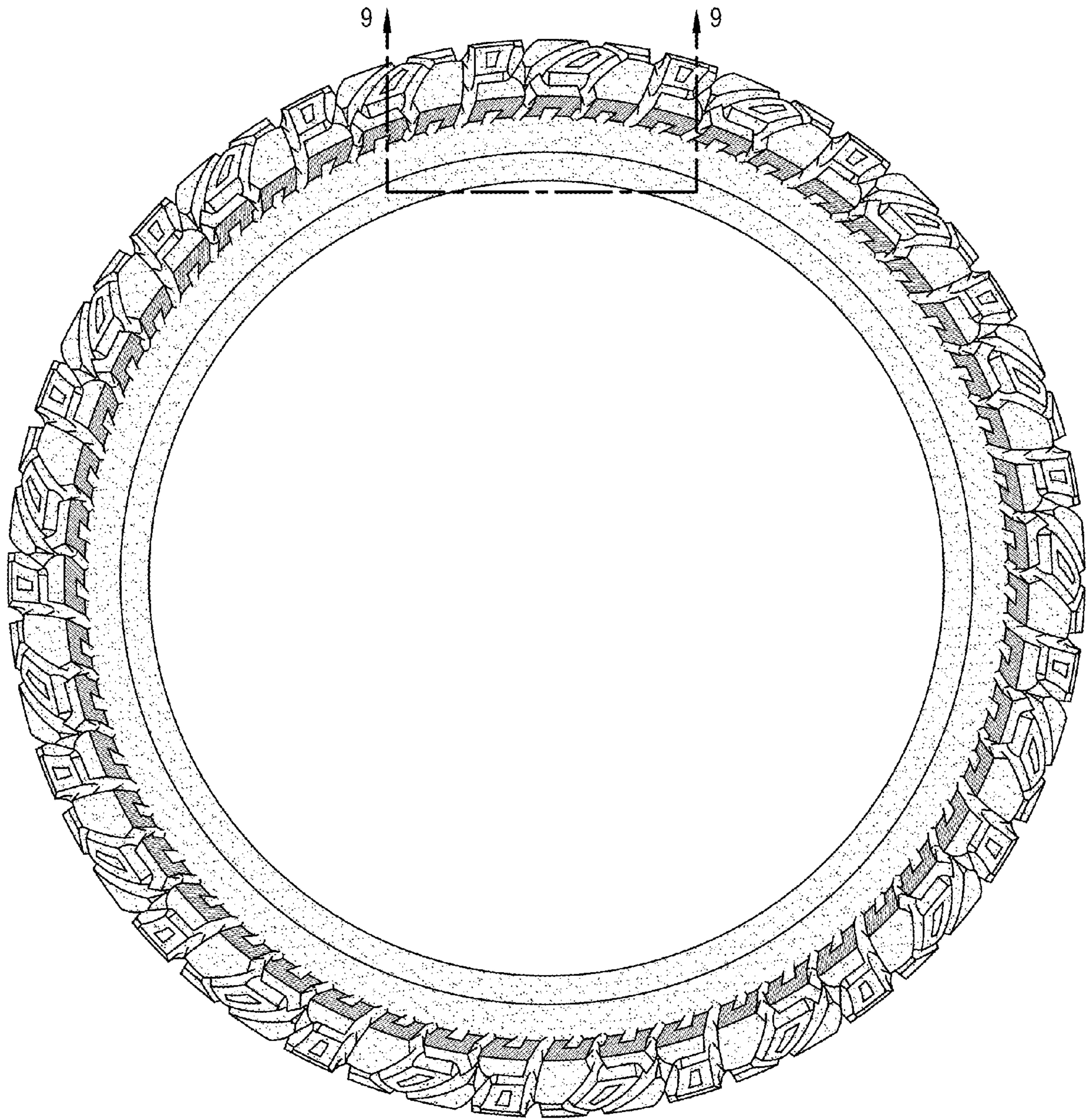

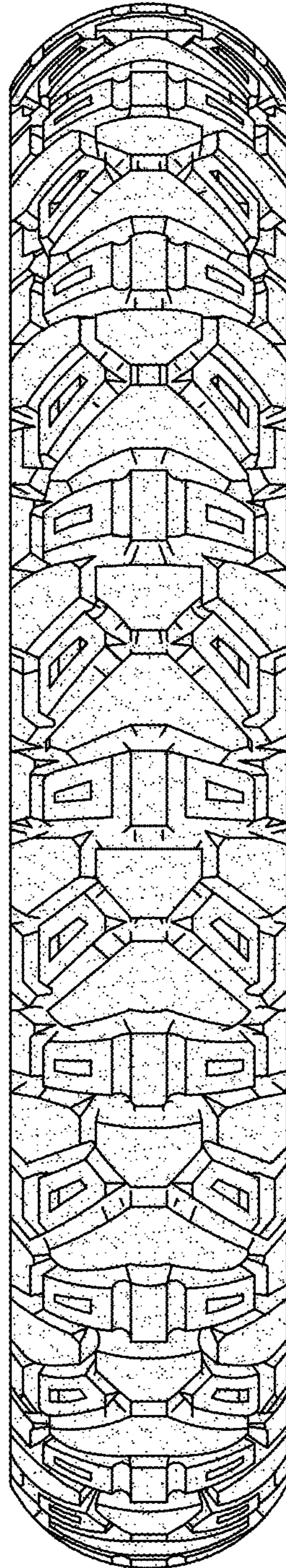

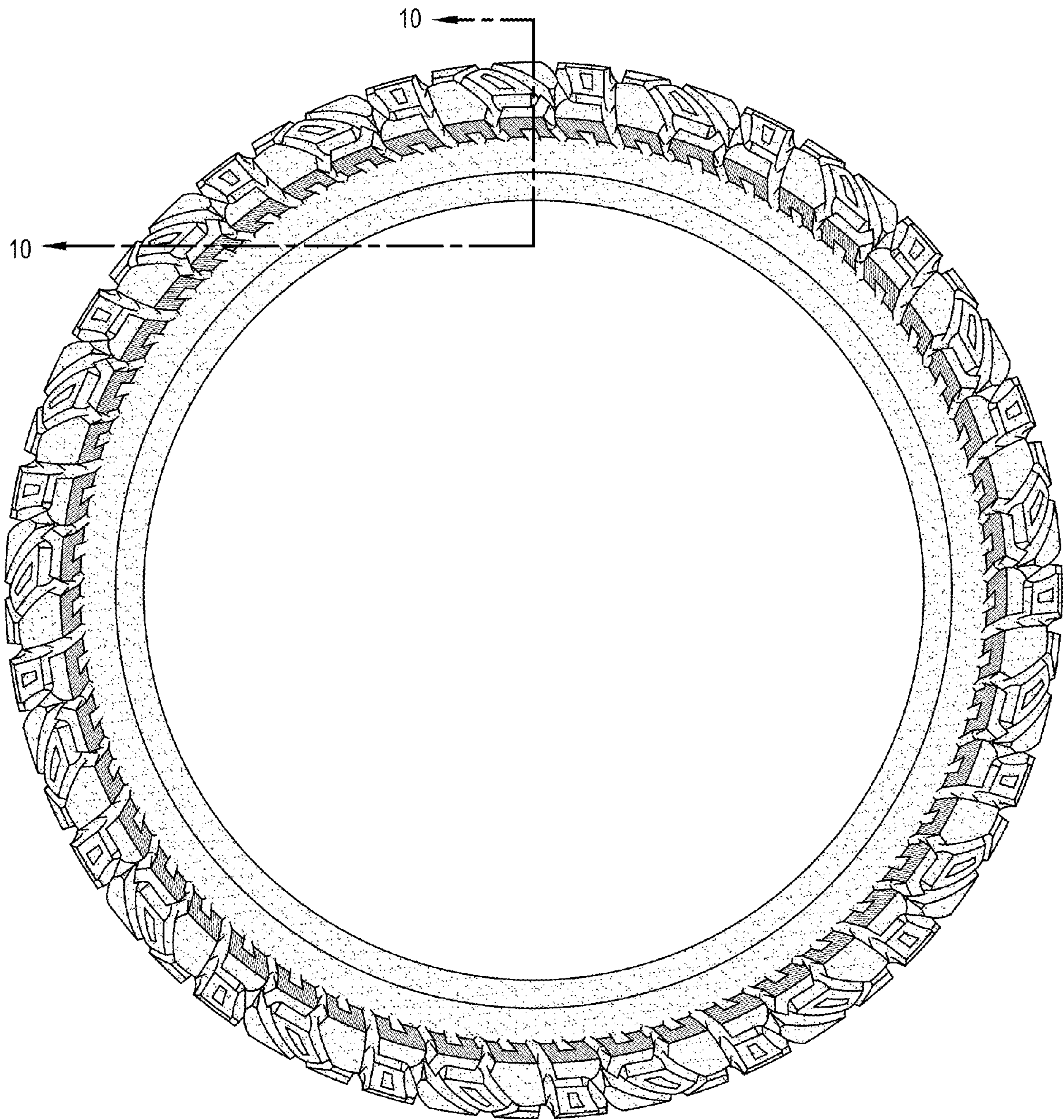

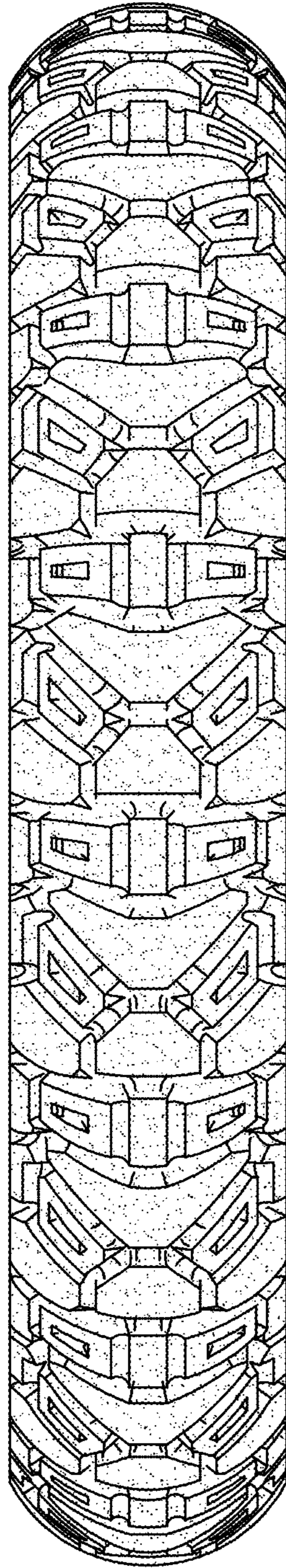

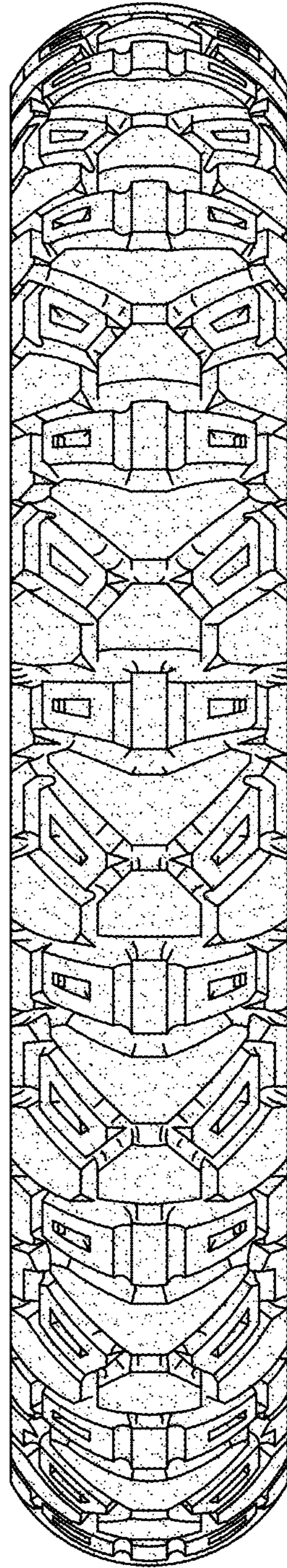

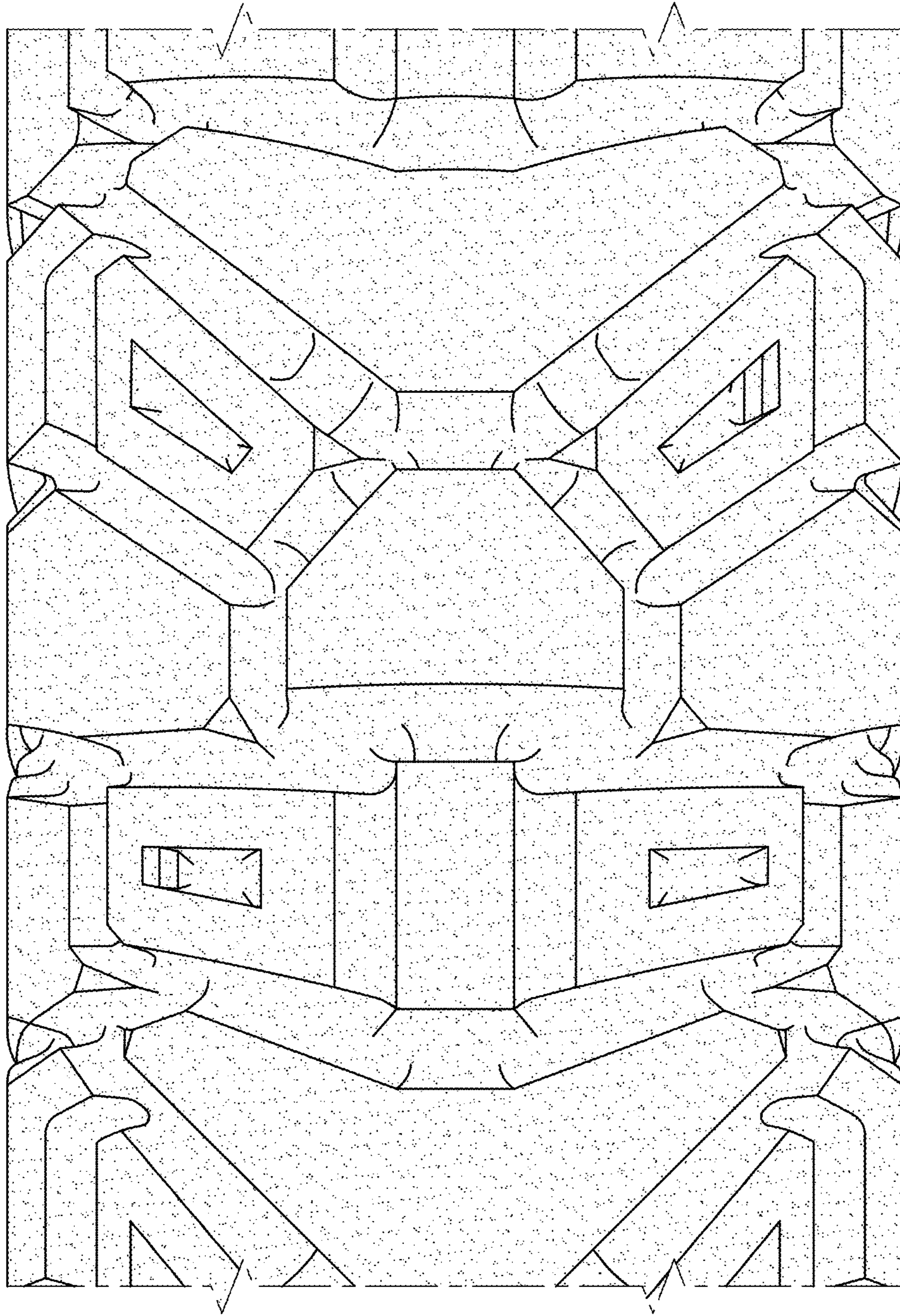

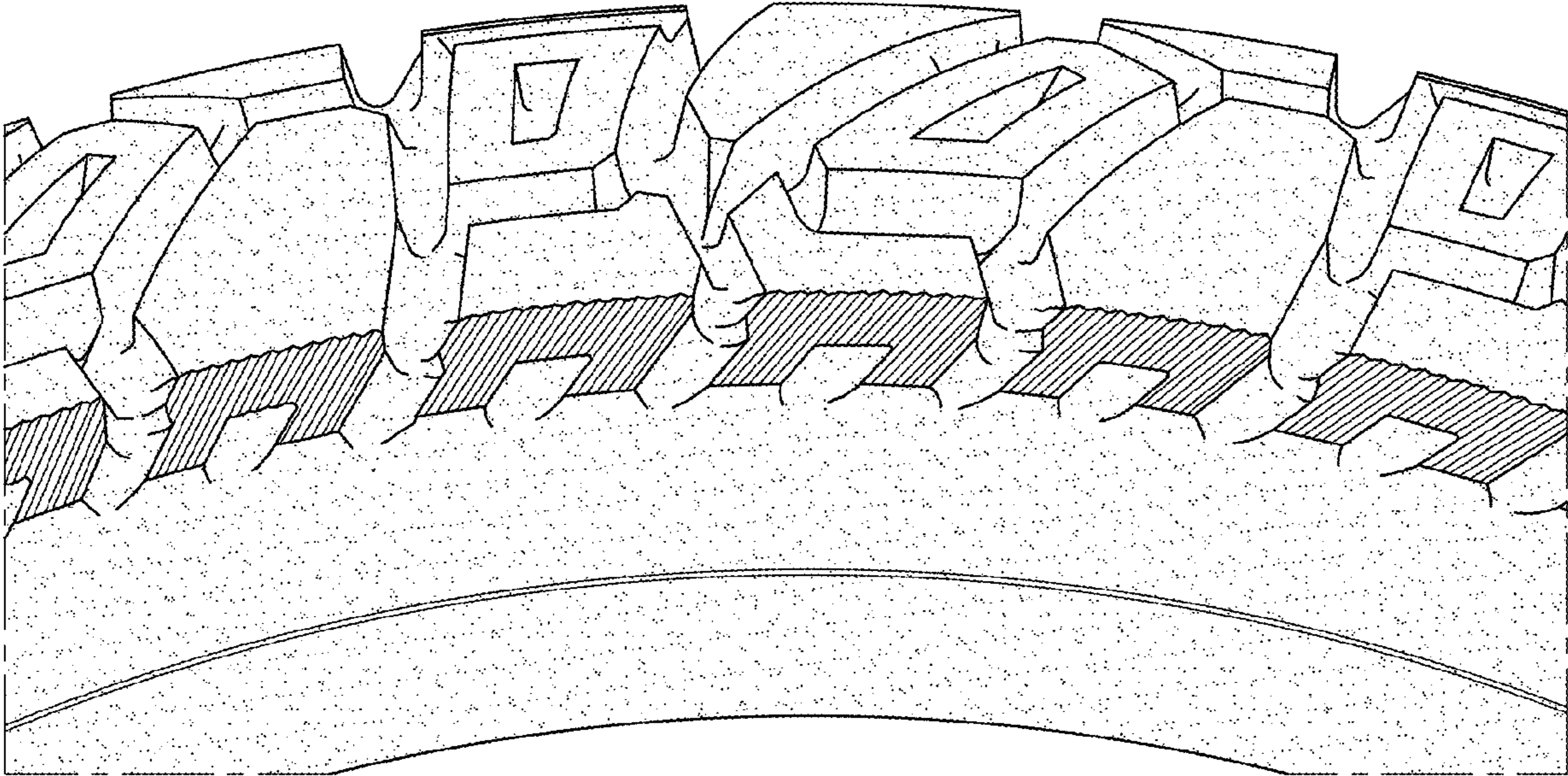

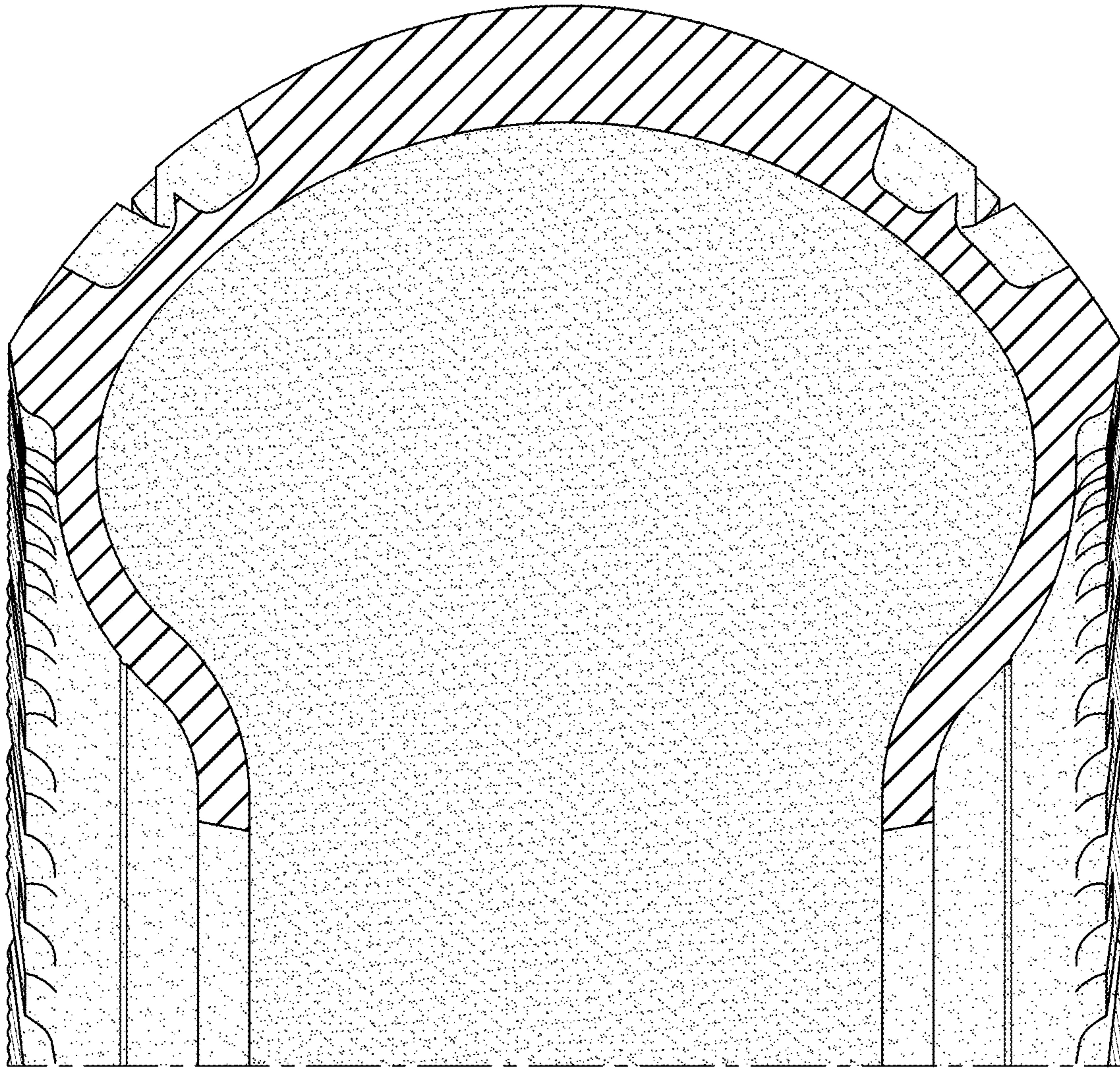
