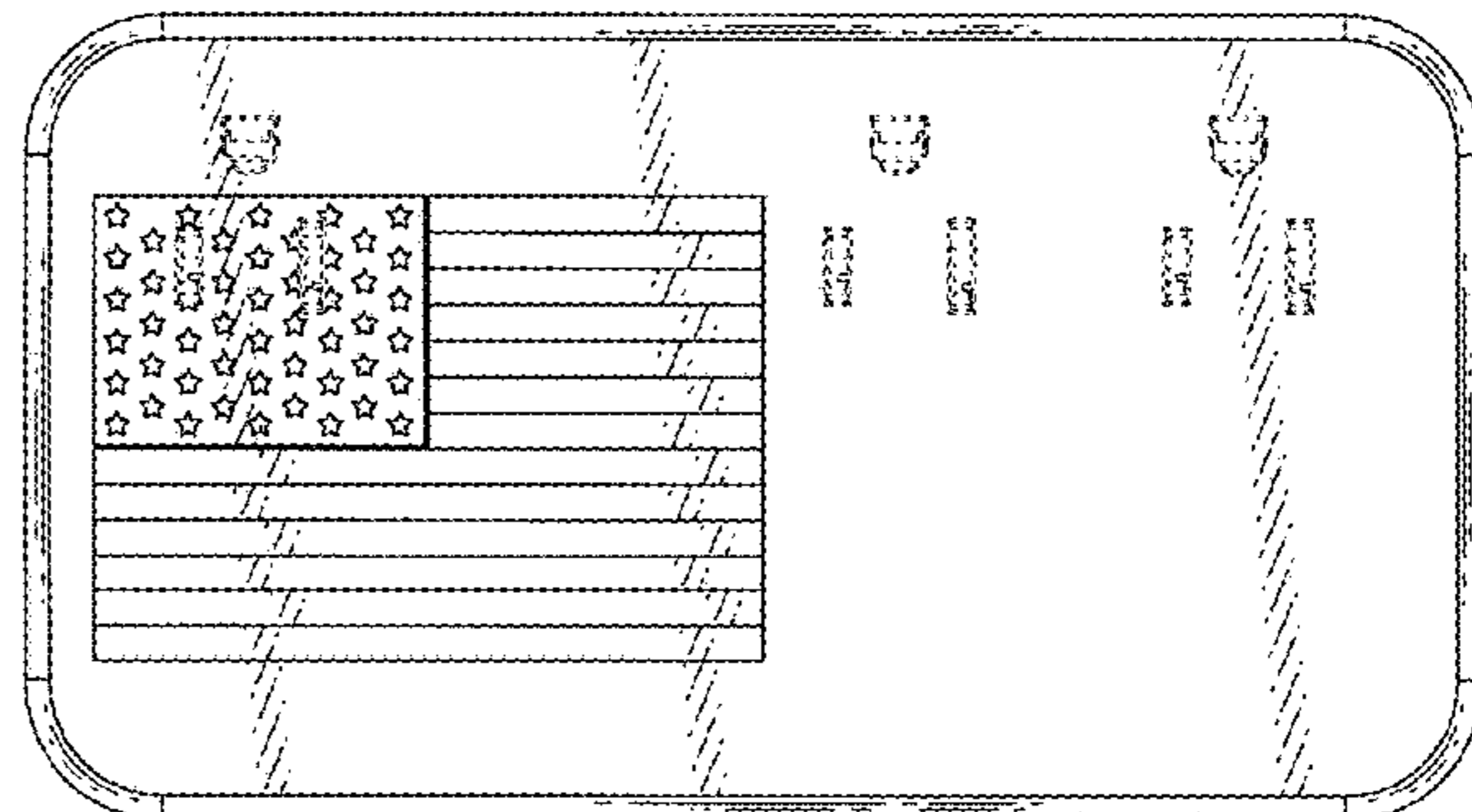
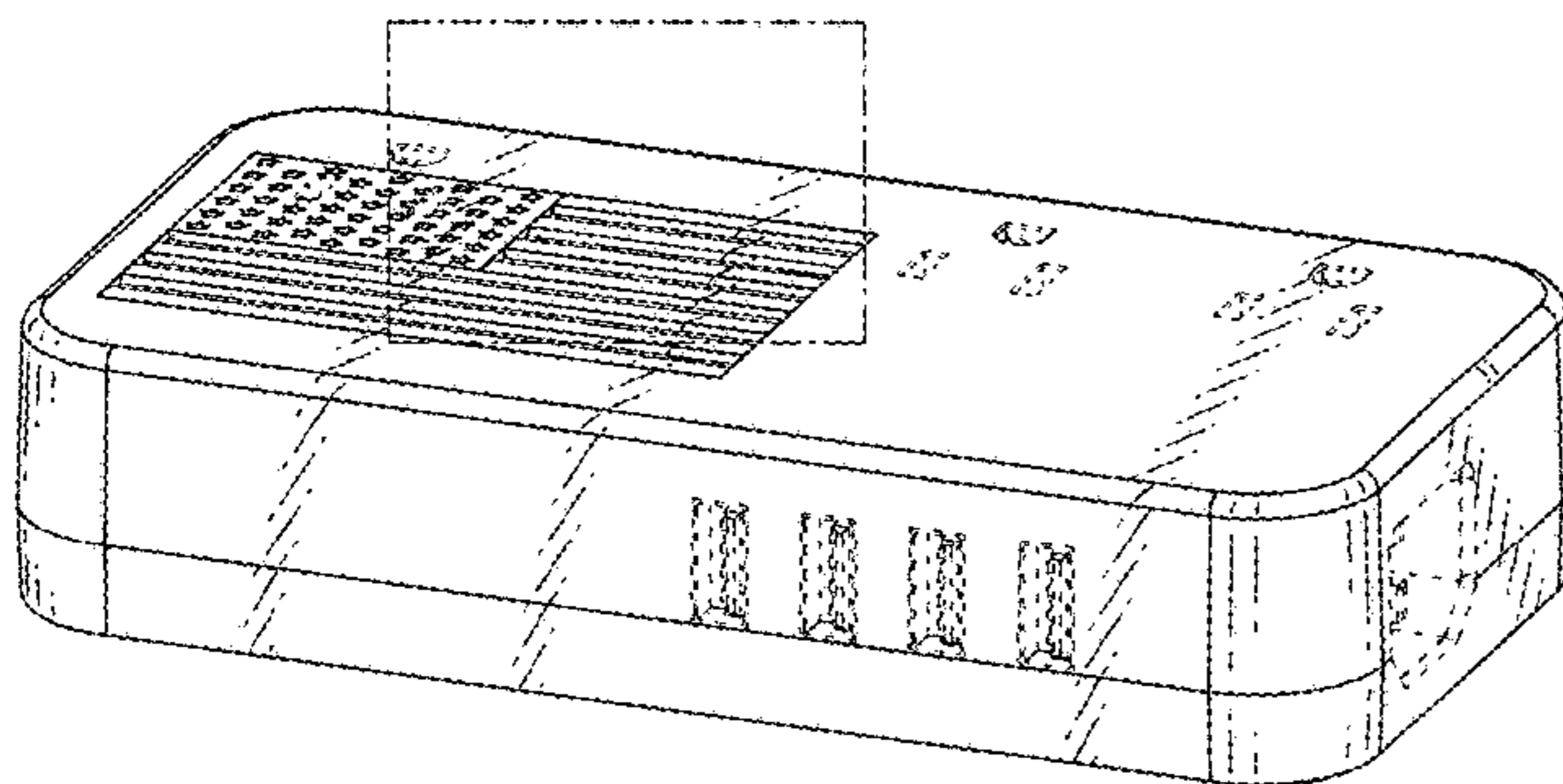
The ornamental design for a multi-socket plug adapter, as

DESCRIPTION

FIG. 1 is a perspective view of a multi-socket plug adapter
showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is another perspective view thereof; and,
FIG. 9 is an enlarged view of the portion of FIG. 1 outlined
by the dot-dash broken line.

The dash-dash broken lines in the drawings are for the
purpose of illustrating portions of the multi-socket plug
adapter that form no part of the claimed design. The dot-dash
broken line shown in FIGS. 1 and 9 is for the purpose of
illustrating the boundary of the enlarged portion shown in
FIG. 9, and forms no part of the claimed design.

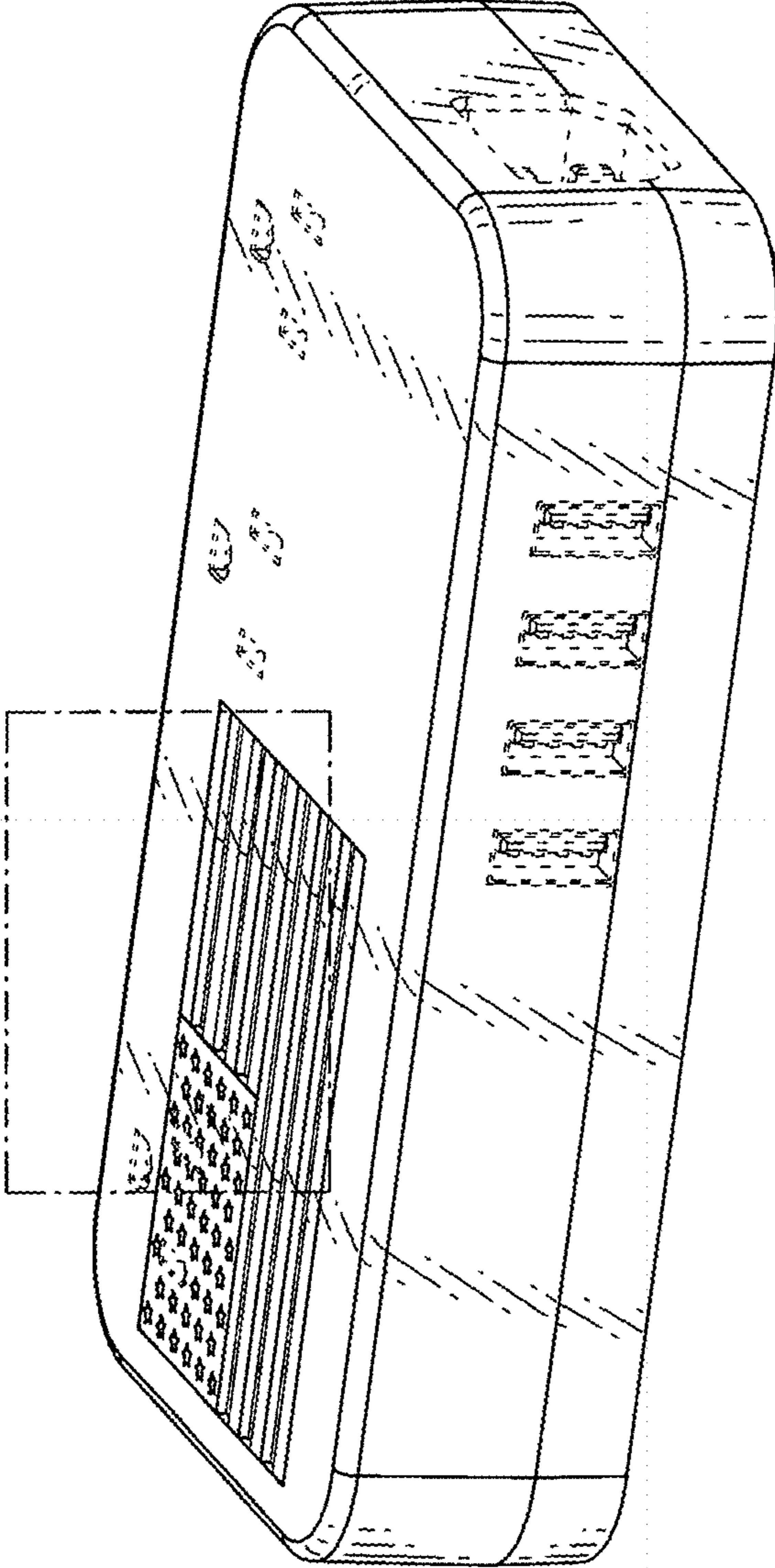

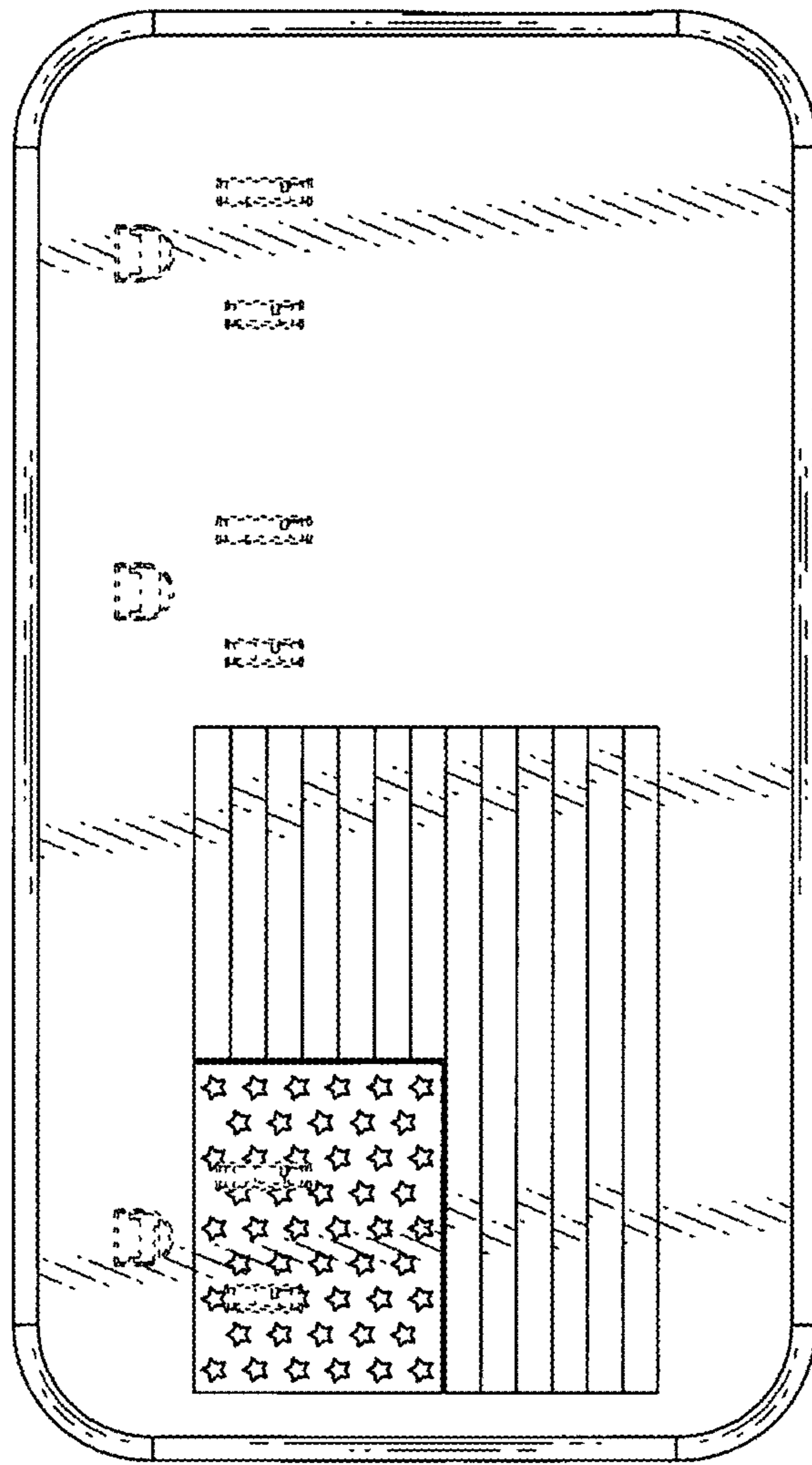

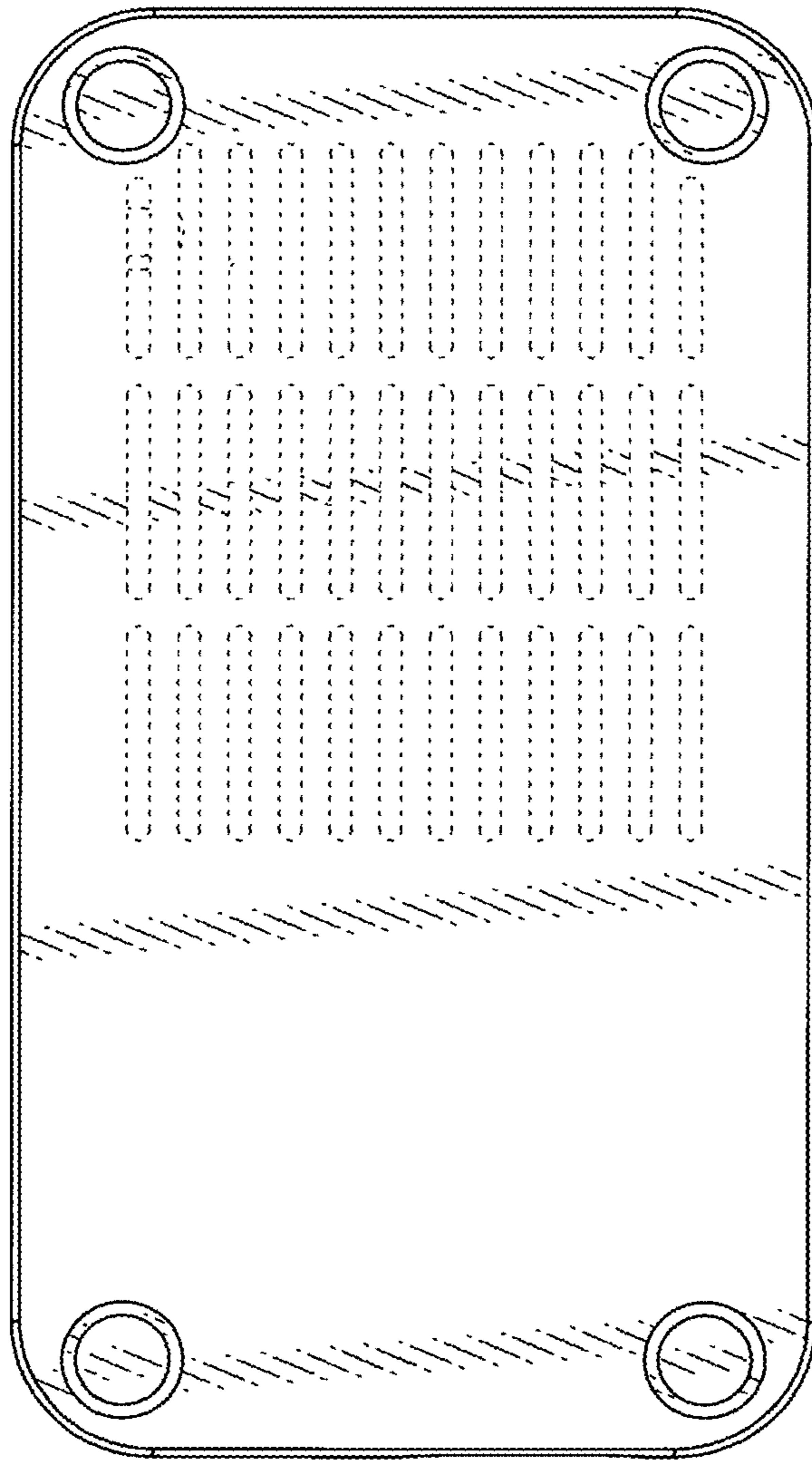

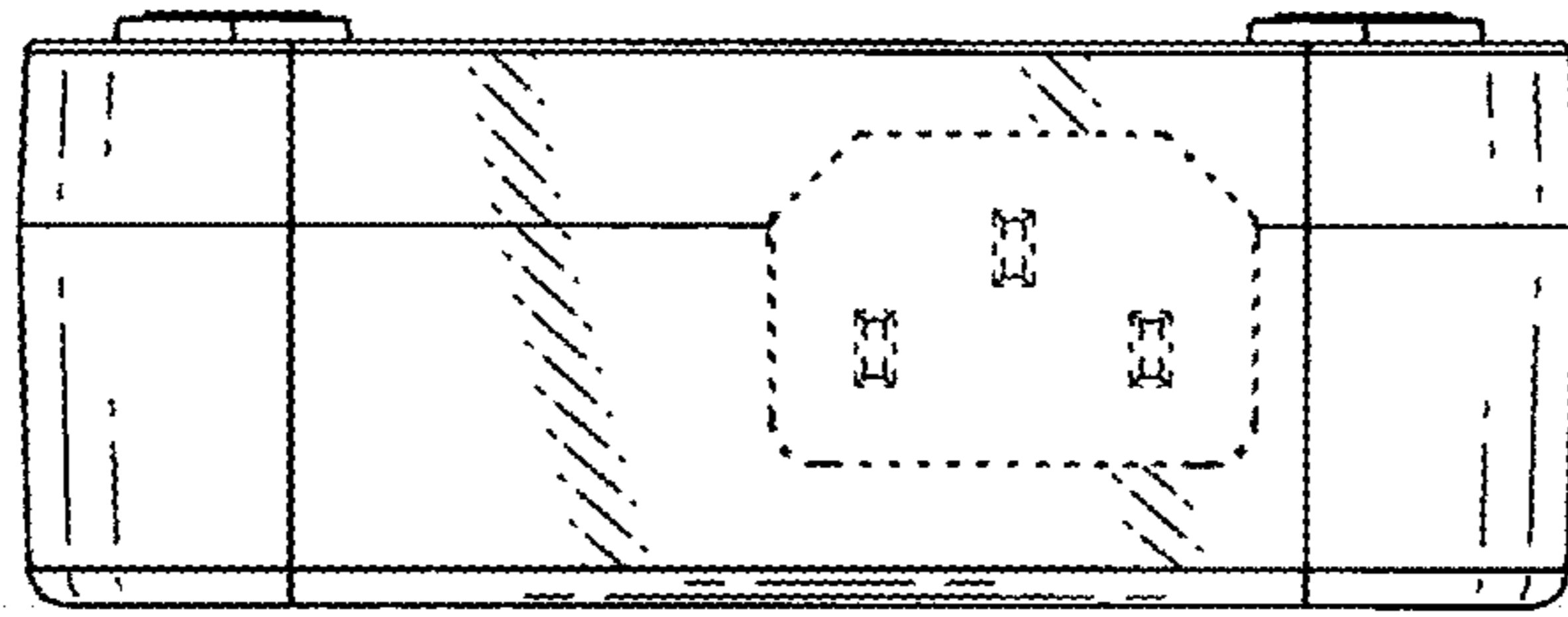

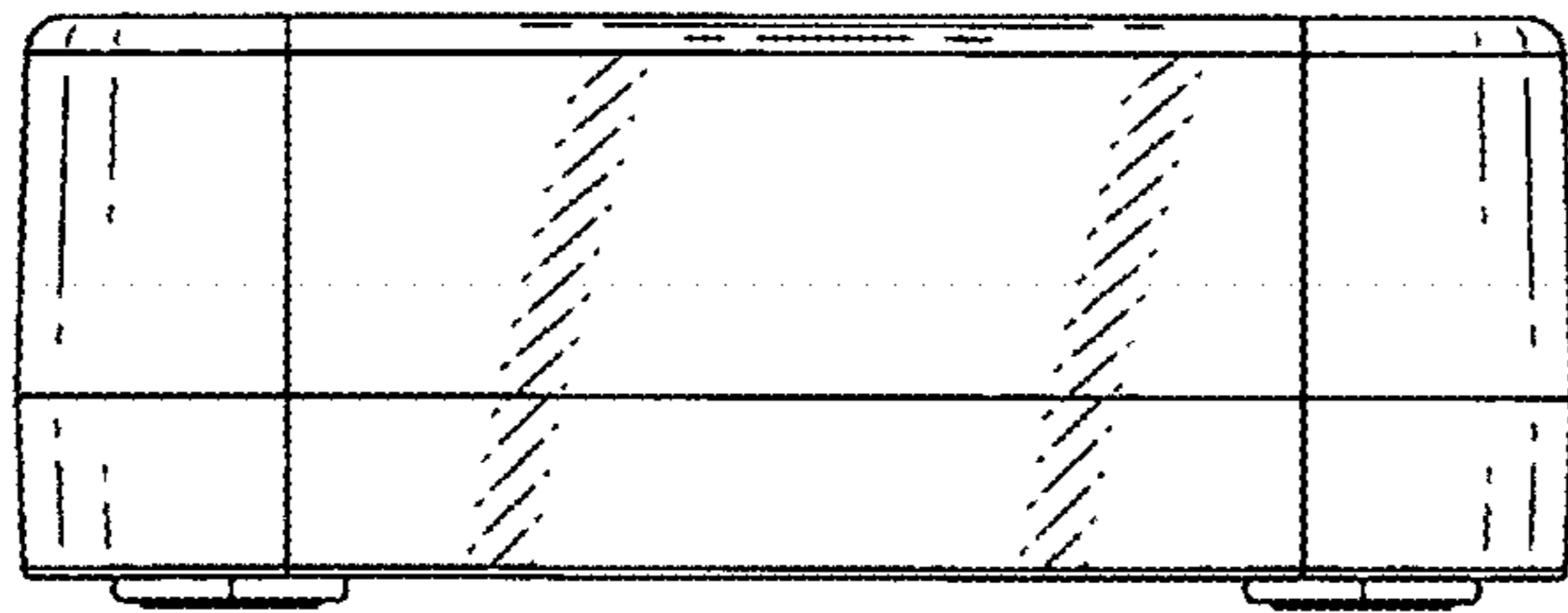

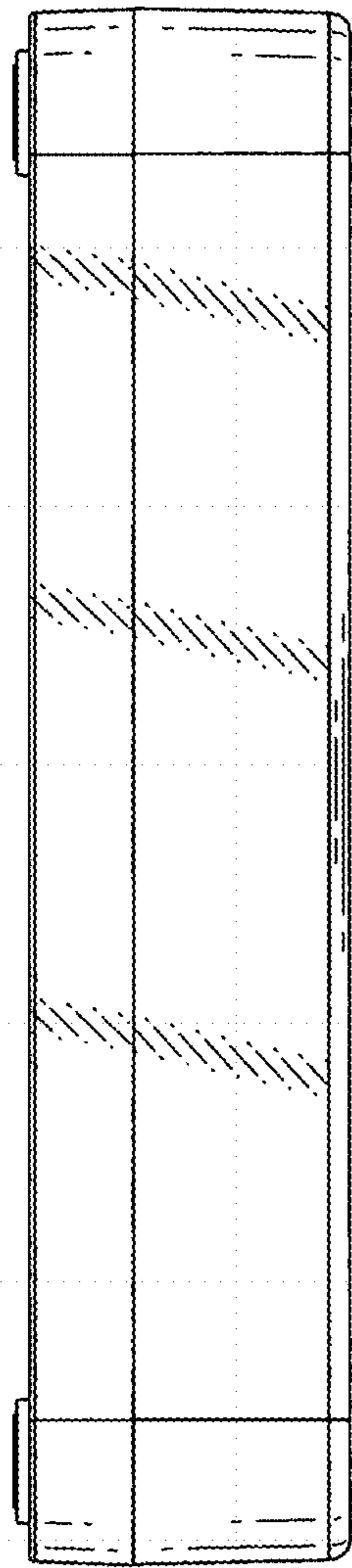

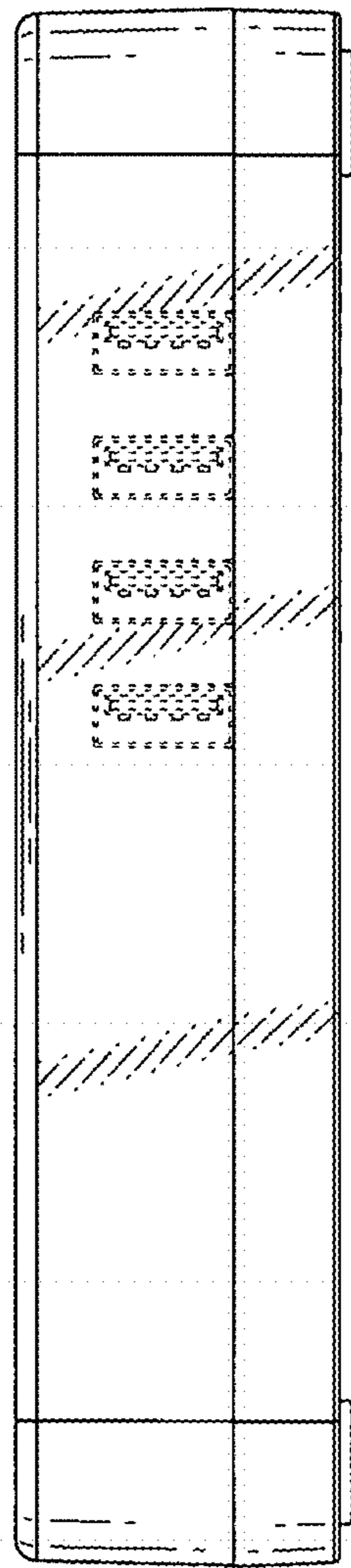

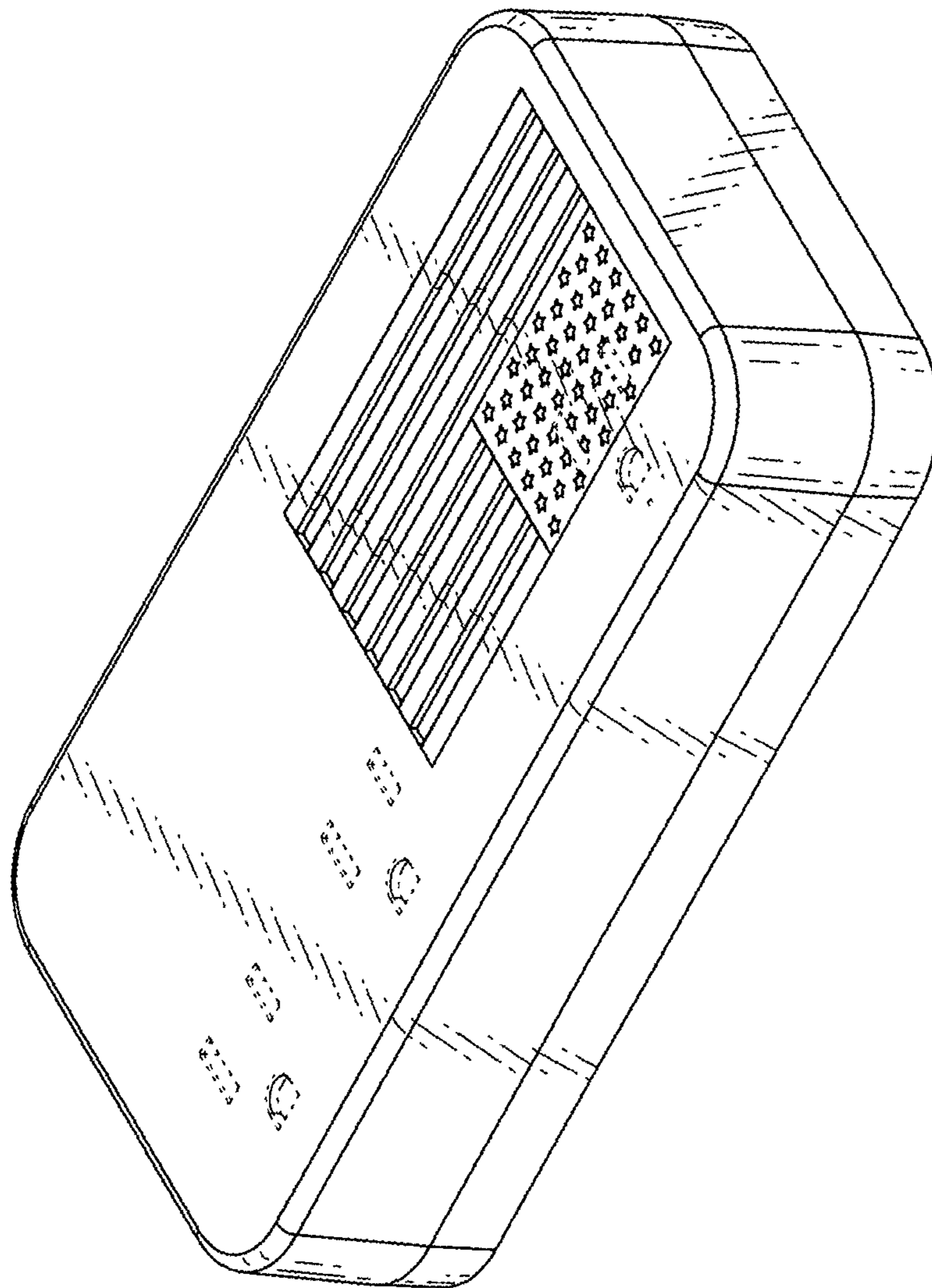

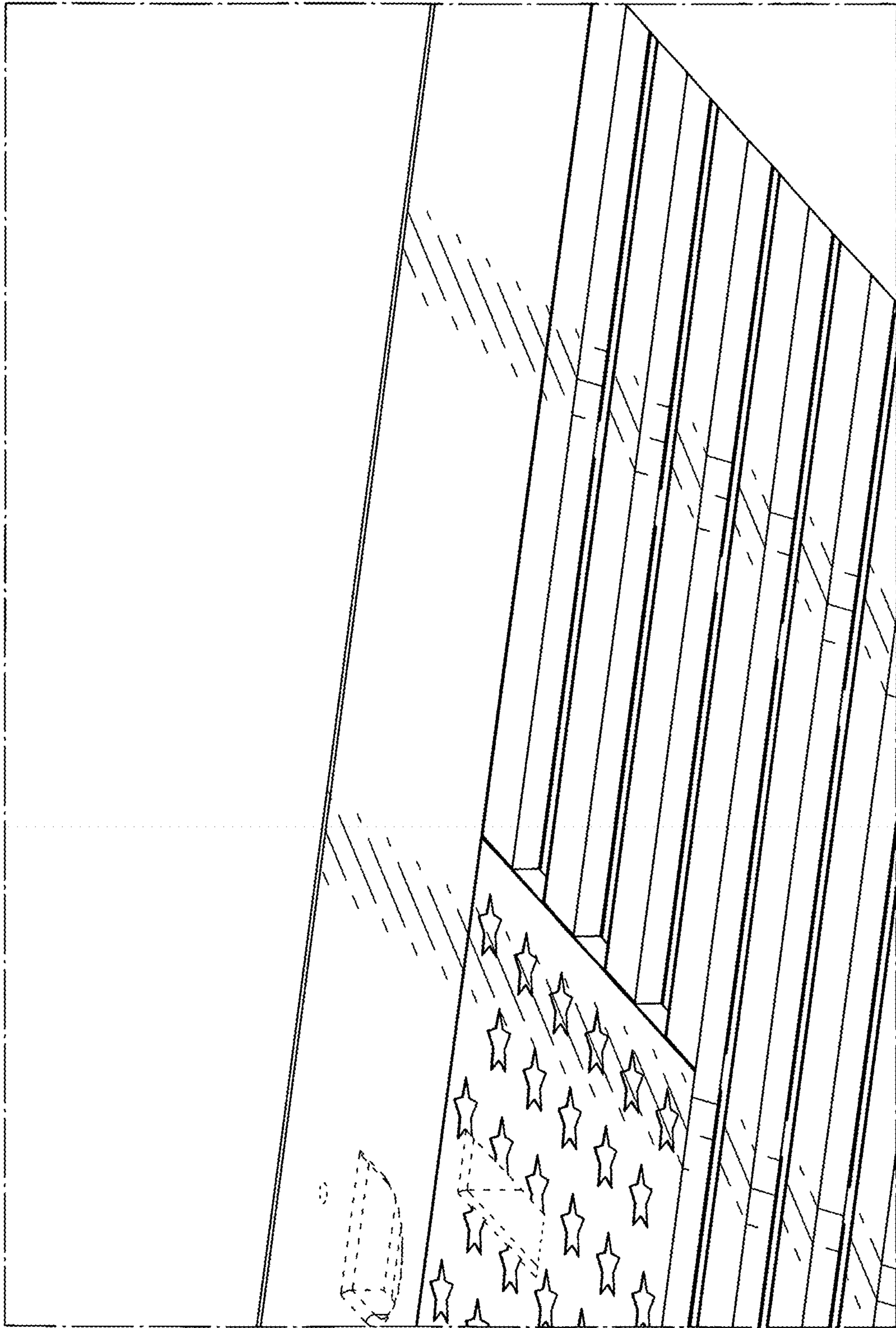
