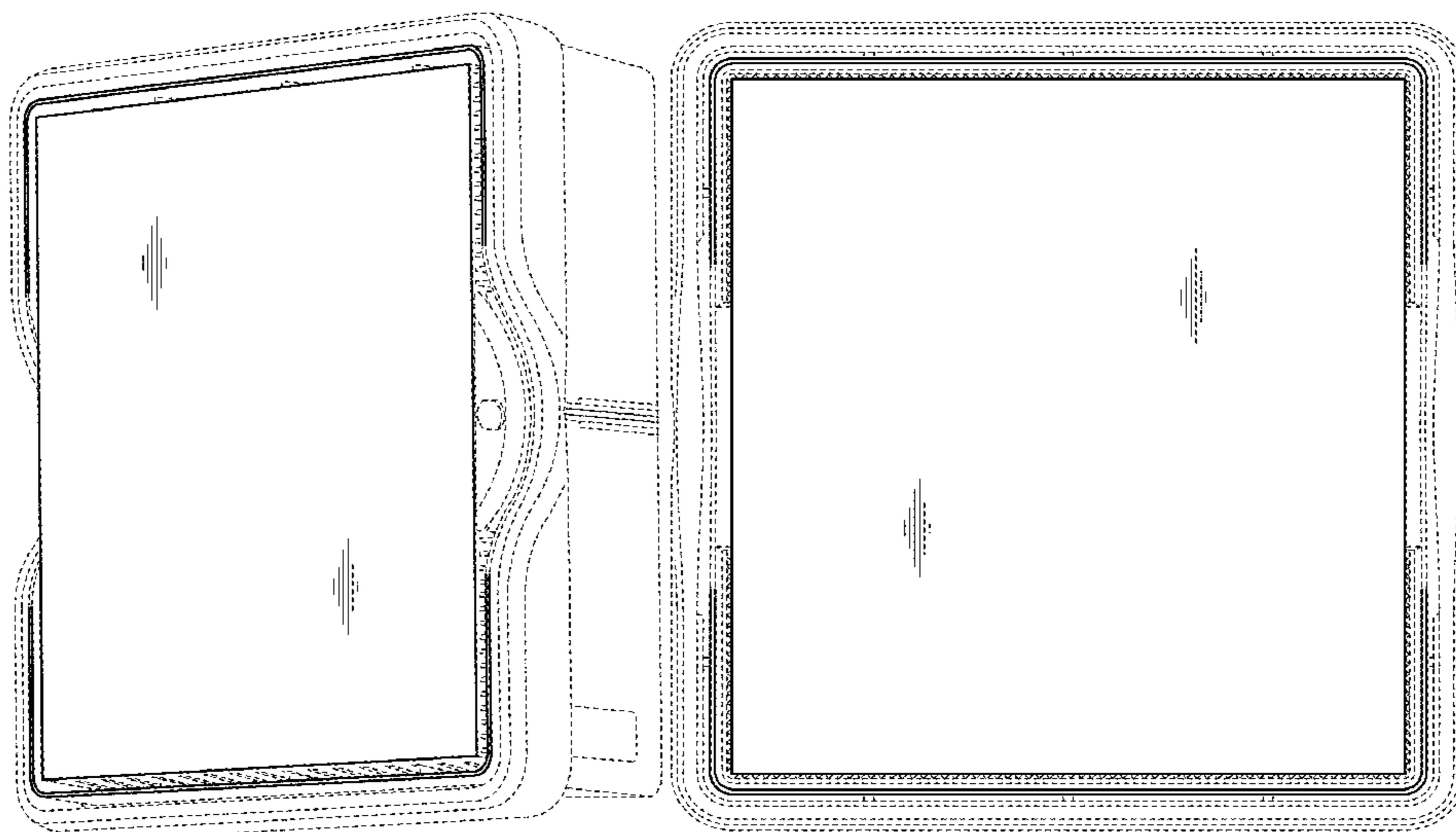
(57) **CLAIM**
The ornamental design of a networking enclosure assembly,
as shown and described.

DESCRIPTION

FIG. 1 is an exploded view of a networking enclosure assembly;
 FIG. 2 is a perspective view of the assembly of FIG. 1;
 FIG. 3 is a right-side view of the assembly of FIG. 1, the left-side being a mirror image;
 FIG. 4 is a top view of the assembly of FIG. 1, the bottom being a mirror image;
 FIG. 5 is a front view of the assembly of FIG. 1; and,
 FIG. 6 is a rear view of the assembly of FIG. 1.

The broken lines in the drawings depict portions of the networking enclosure assembly that form no part of the claimed design. Shade lines on various portions of the networking enclosure assembly are provided to show contour and do not show surface ornamentation.

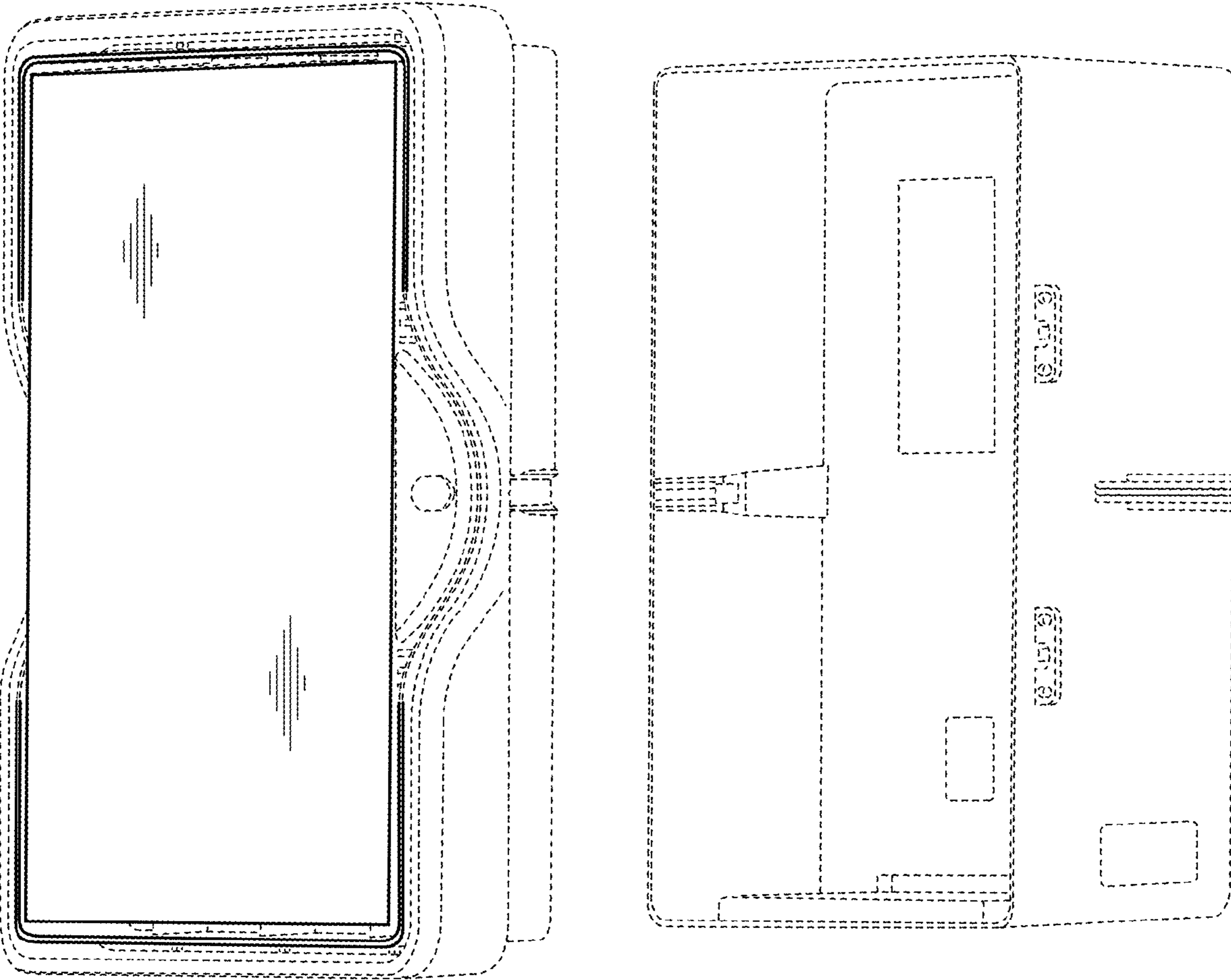

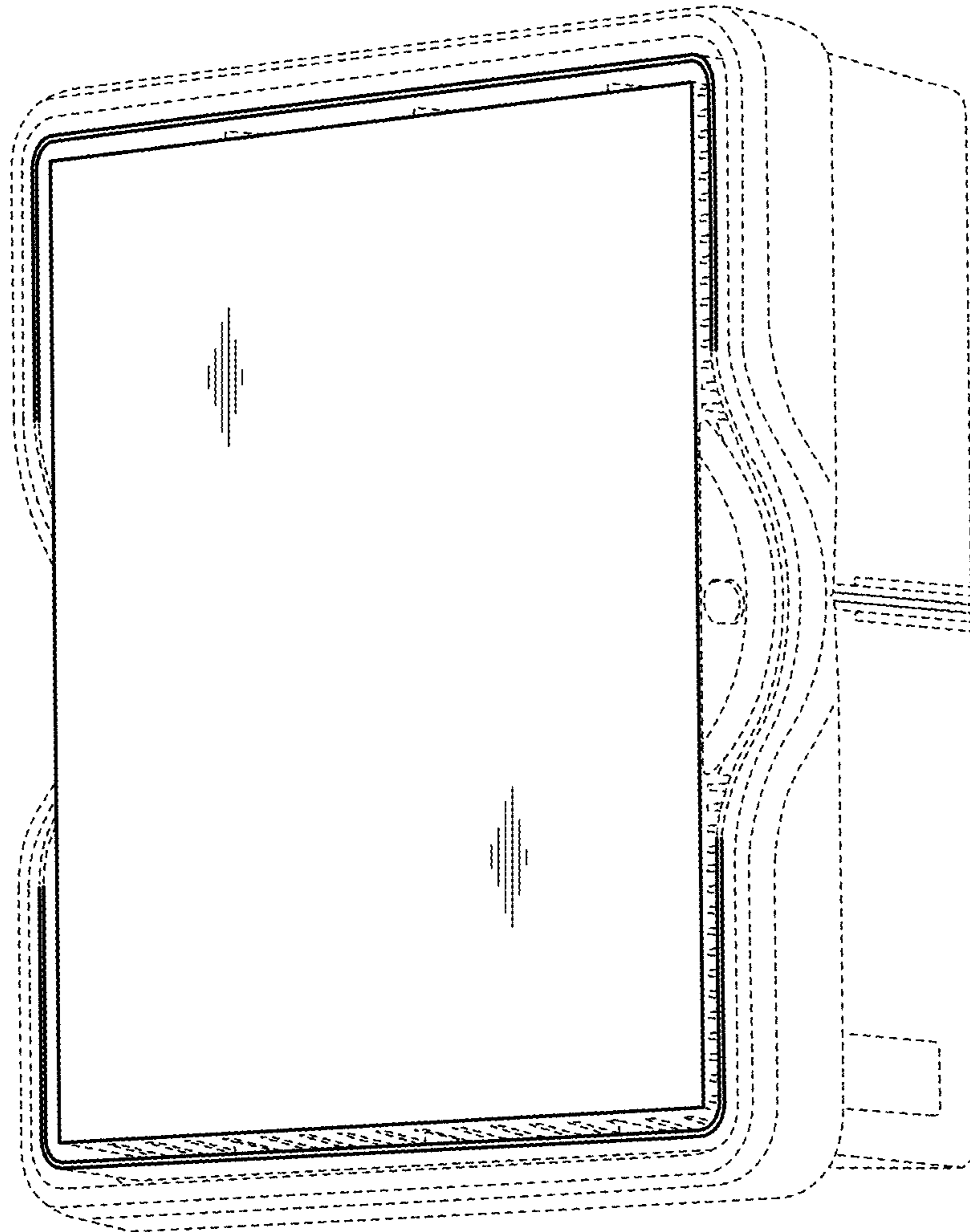

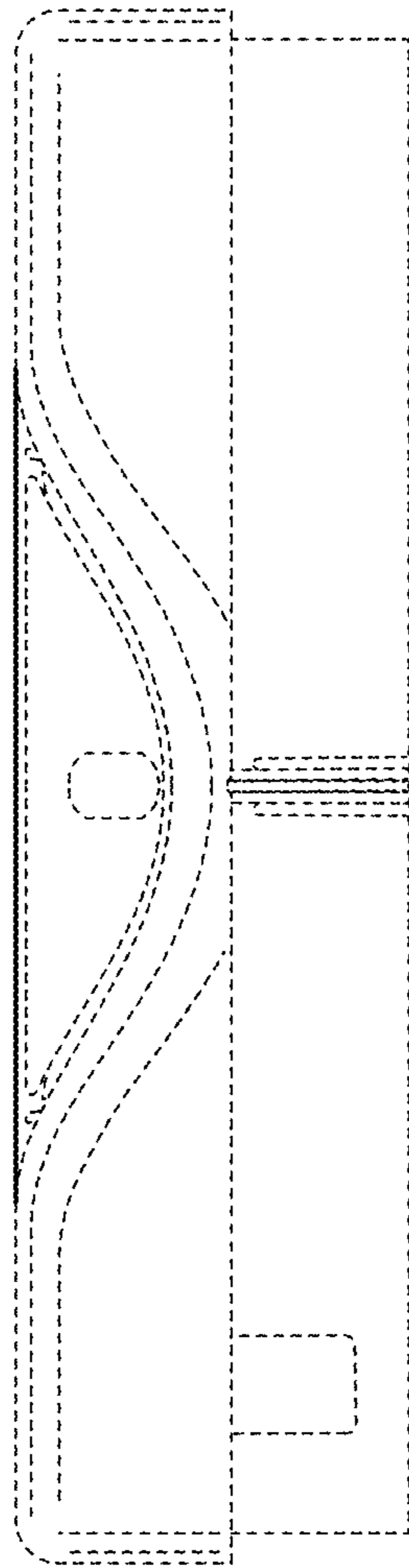

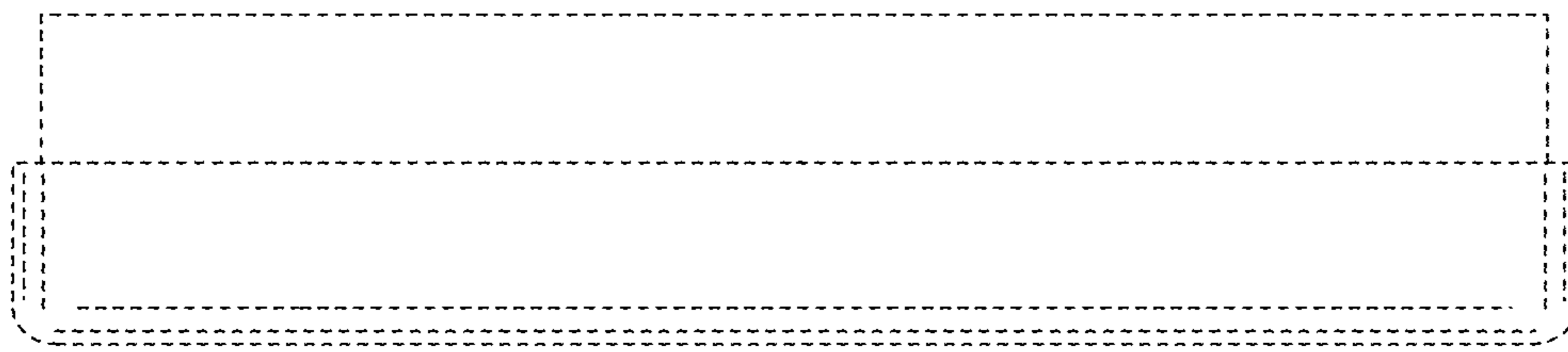

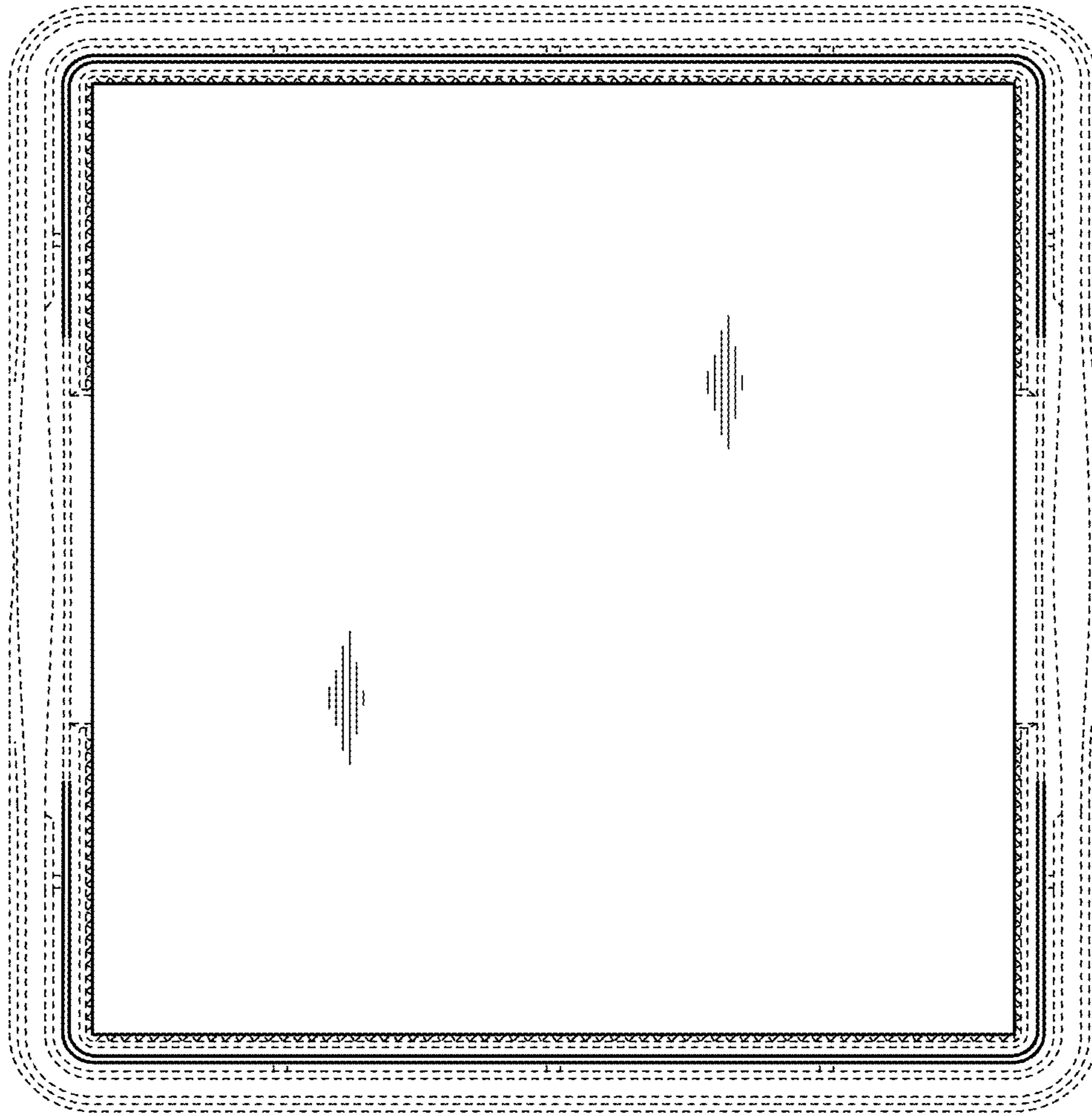

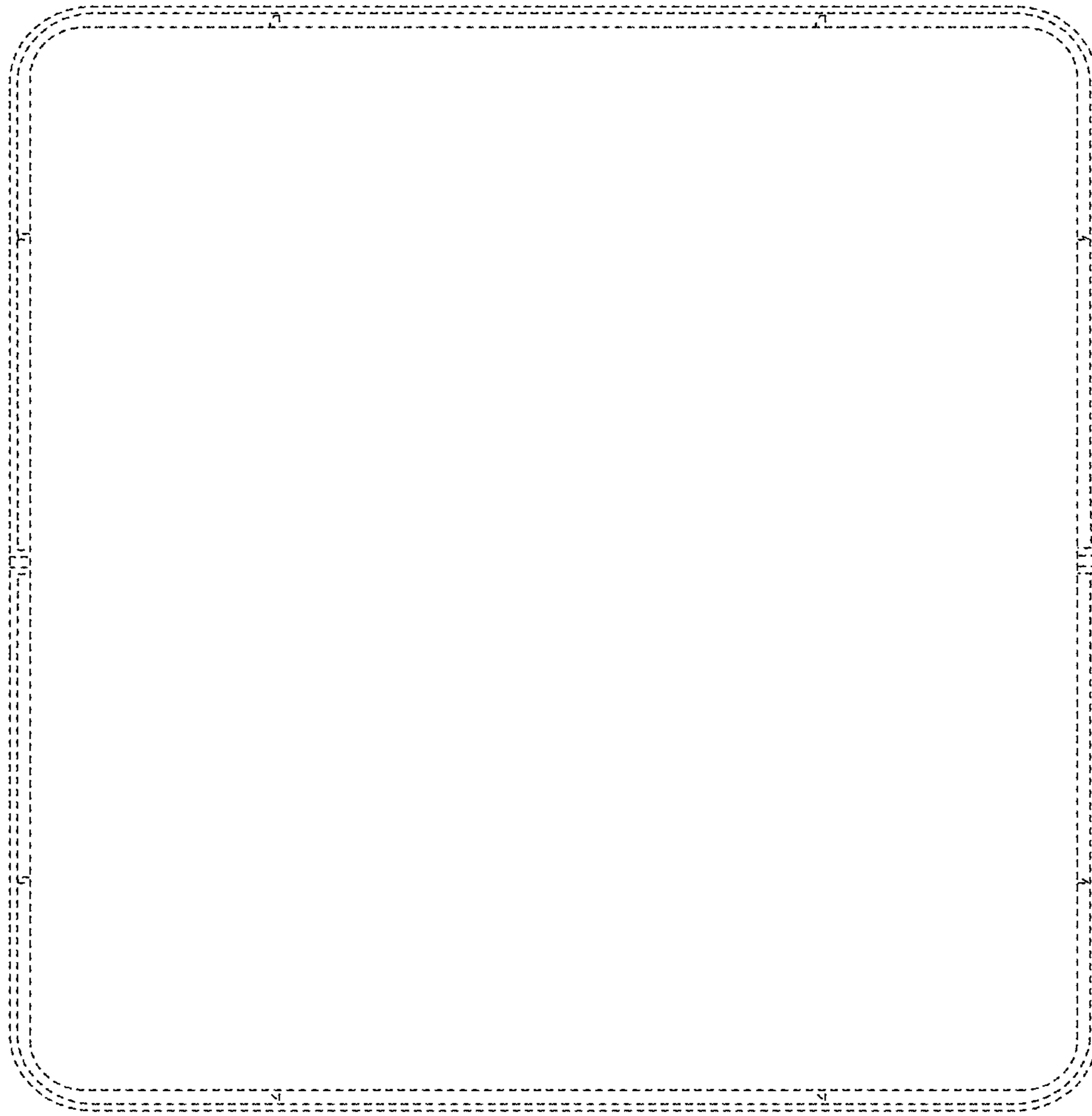
