(57) **CLAIM**

The ornamental design for a headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a headset showing the new design;

FIG. 2 is a rear elevational view of the headset;

FIG. 3 is a top plan view of the headset;

FIG. 4 is a bottom plan view of the headset;

FIG. 5 is a right side elevational view of the headset;

FIG. 6 is a left side elevational view of the headset;

FIG. 7 is a perspective view of the headset;

FIG. 8 is an enlarged partial view of the headset taken in the direction of lines 8-8 of FIG. 5;

FIG. 9 is an enlarged partial view of the headset taken in the direction of lines 9-9 of FIG. 6;

FIG. 10 is an enlarged partial view of the headset taken in the direction of lines 8-8 of FIG. 5 with the LED in an on position; and,

FIG. 11 is an enlarged bottom plan view of the headset in which the headphone is shown separately without the microphone for ease of illustration.
