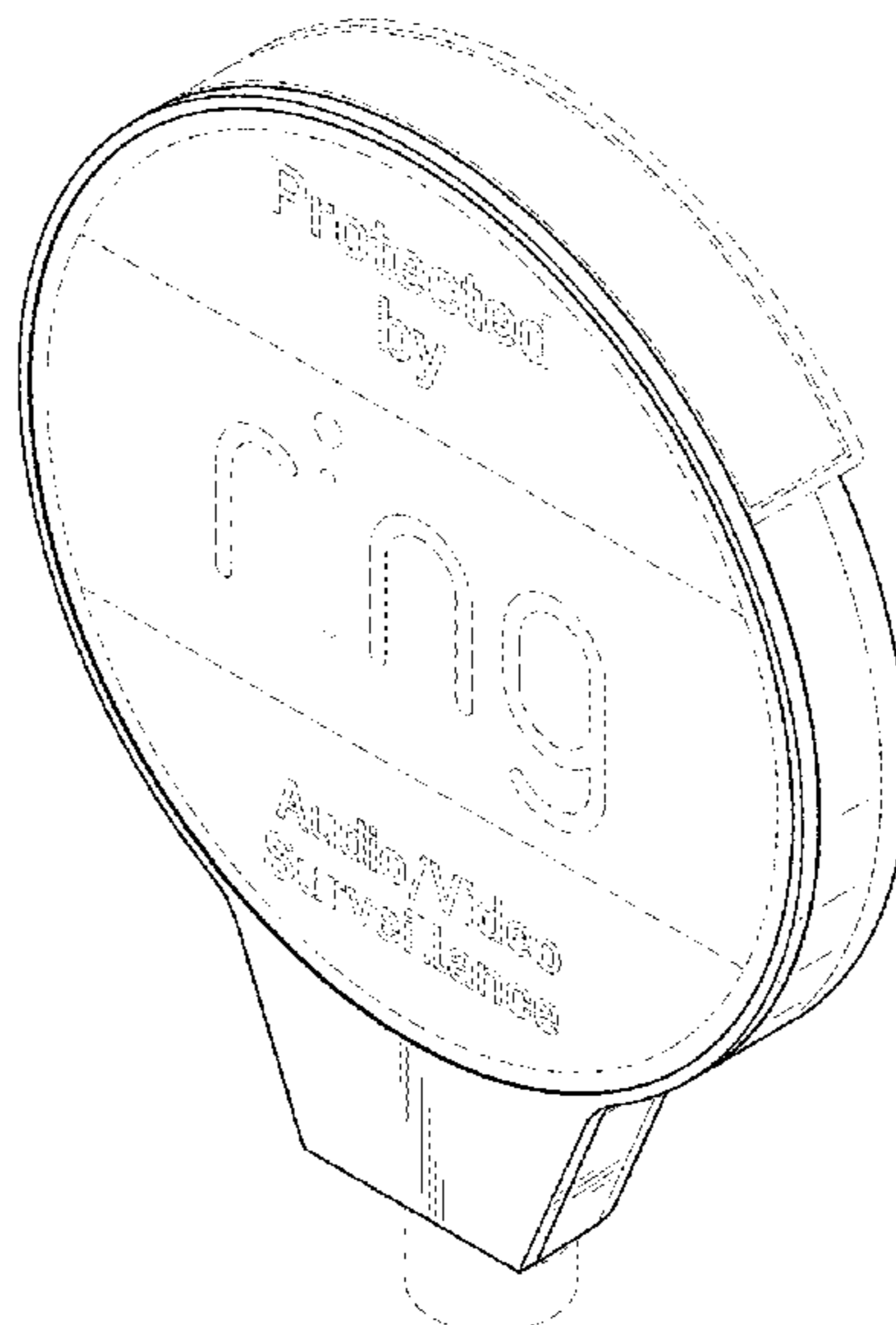
(57) **CLAIM**

The ornamental design for an illuminated sign, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the illuminated sign according to the present design;  
FIG. 2 is a front elevational view of the illuminated sign of FIG. 1;  
FIG. 3 is a rear elevational view of the illuminated sign of FIG. 1;  
FIG. 4 is a right-side elevational view of the illuminated sign of FIG. 1, the left-side elevational view being a mirror image thereof;  
FIG. 5 is a top plan view of the illuminated sign of FIG. 1;  
FIG. 6 is a bottom plan view of the illuminated sign of FIG. 1; and,  
FIG. 7 is a front perspective view of the illuminated sign of FIG. 1, showing the illuminated sign in a manner of use.  
In the drawings, the broken lines depict portions of the illuminated sign that form no part of the claimed design.

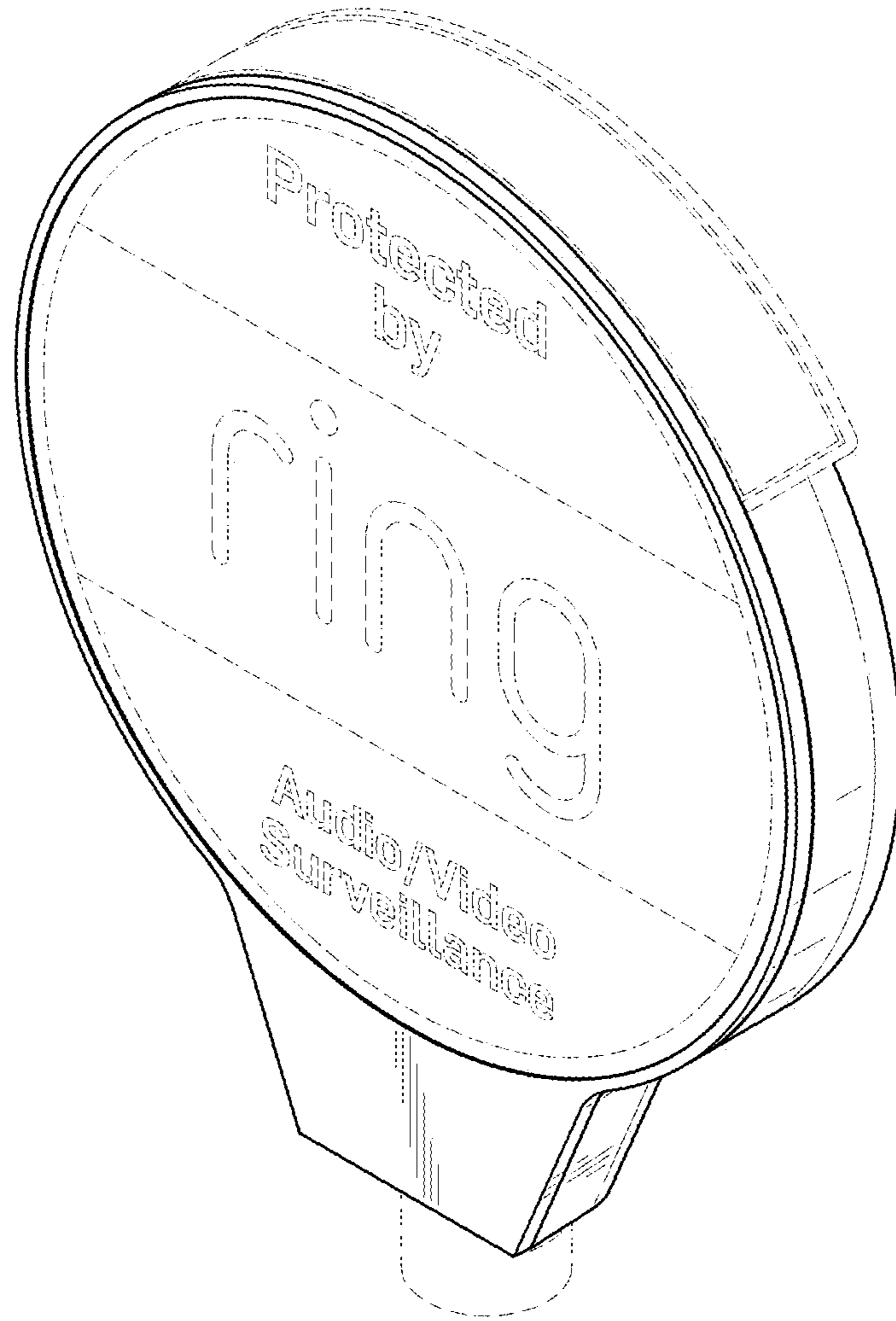

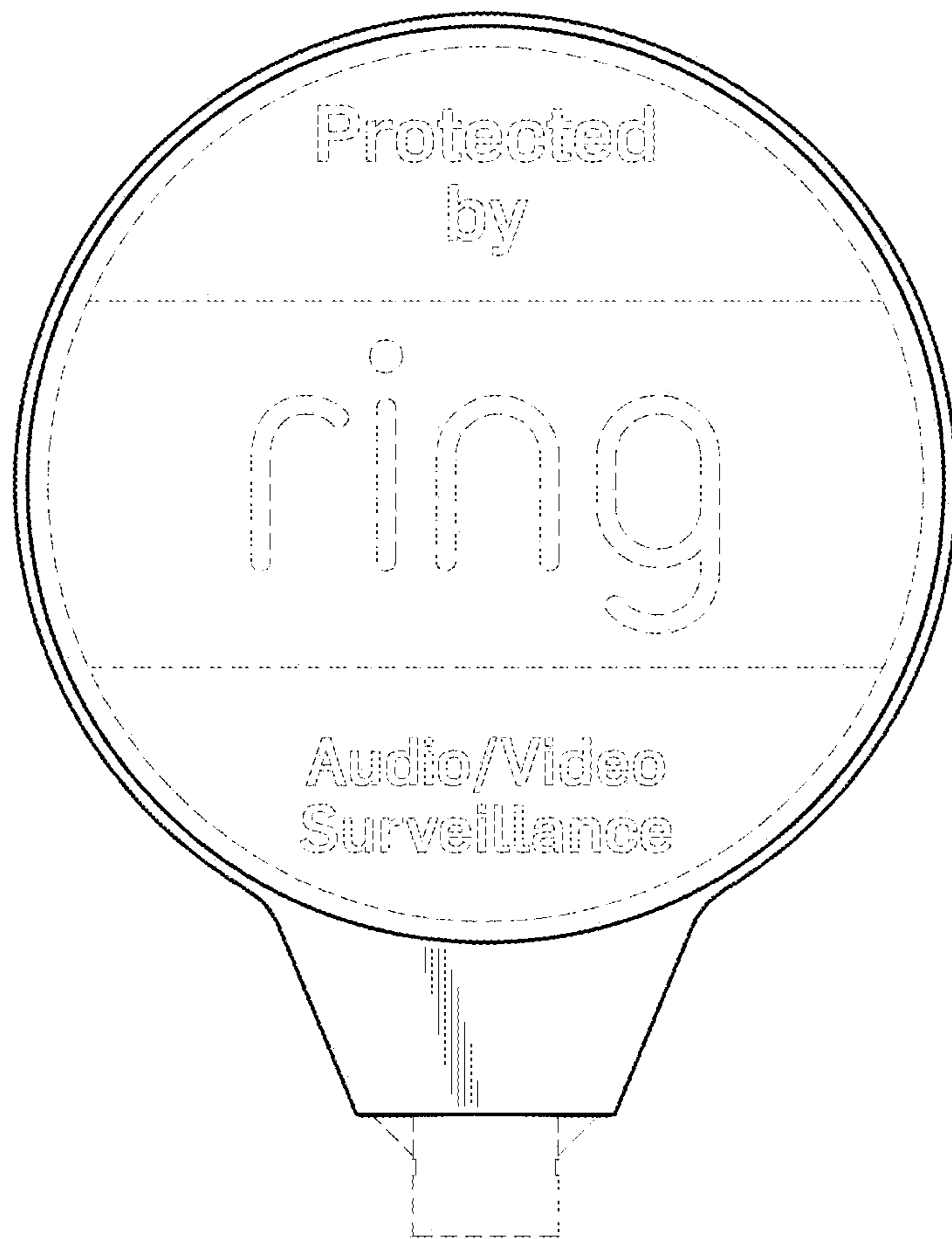

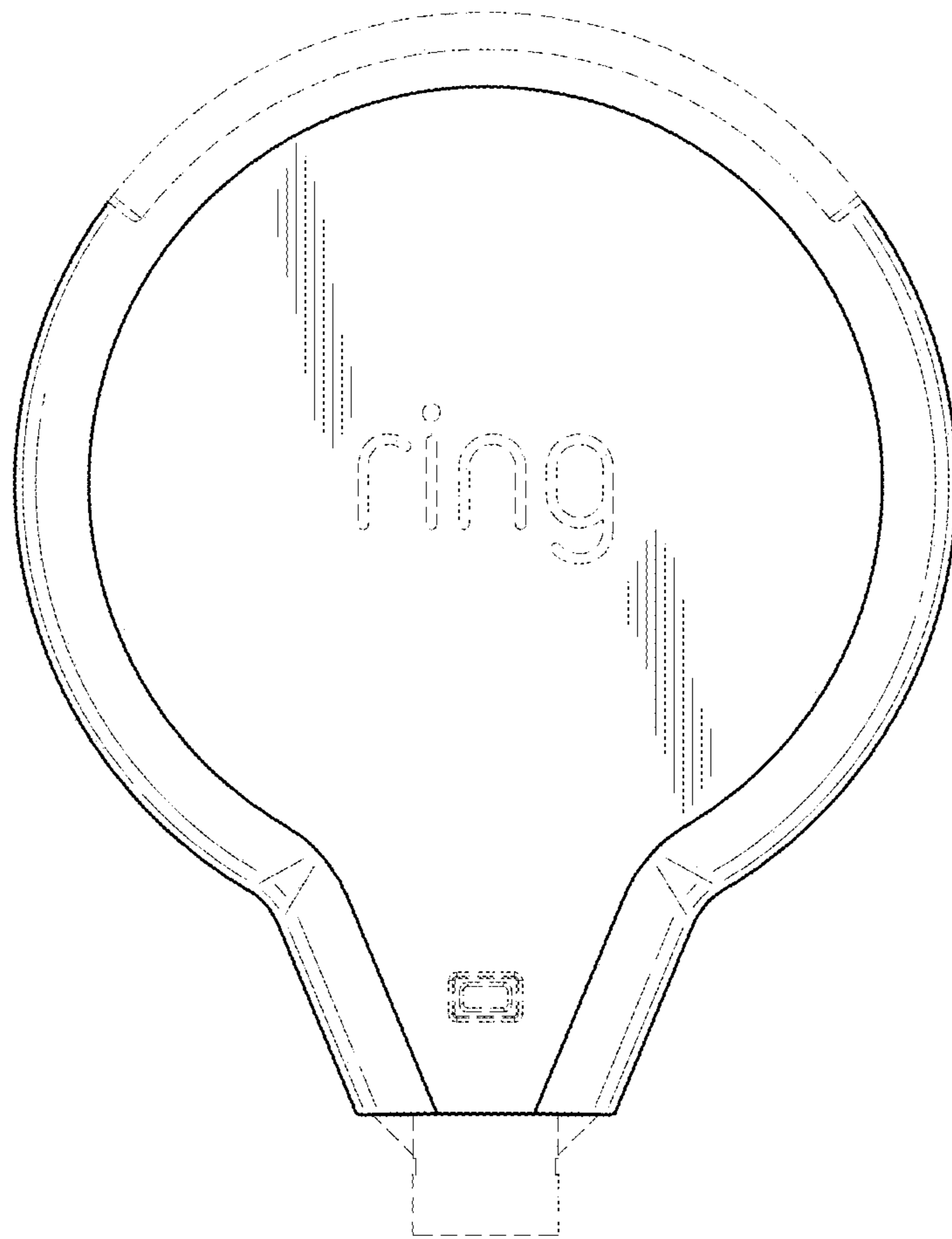

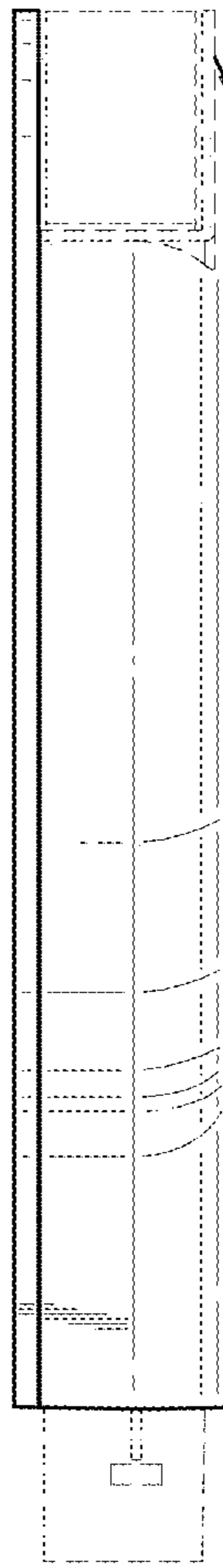

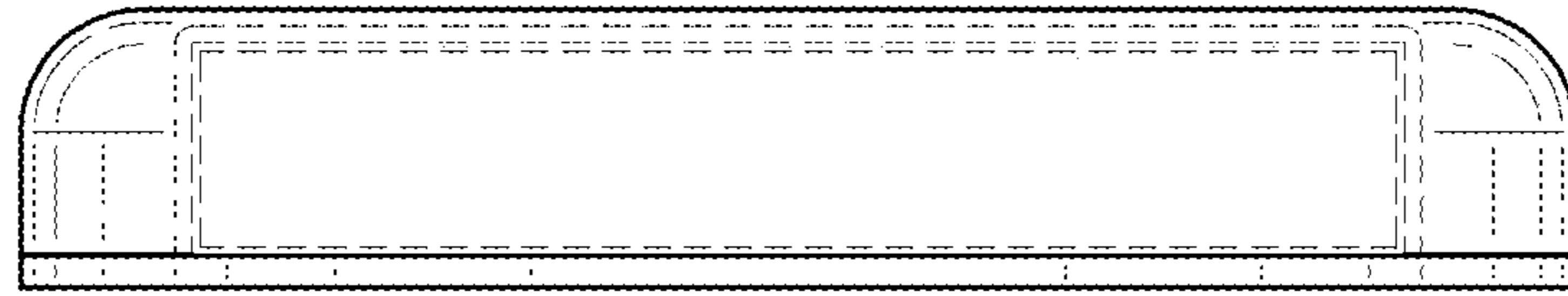

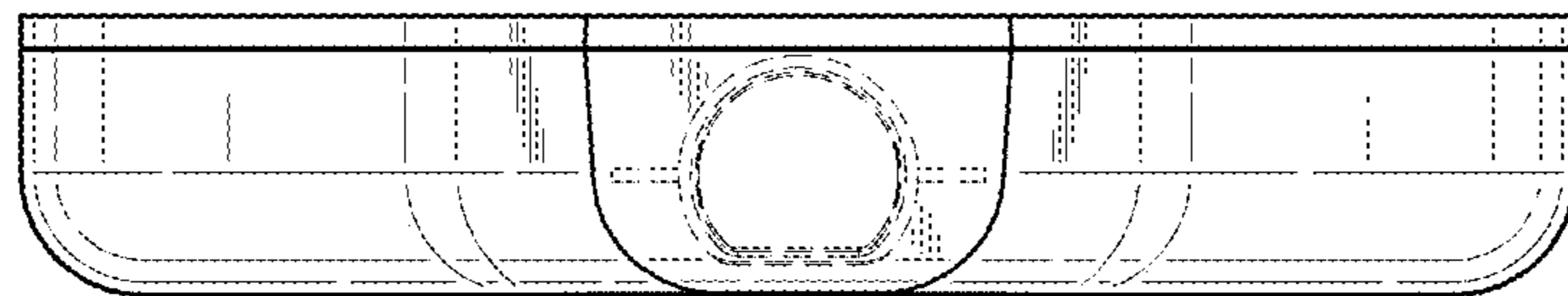

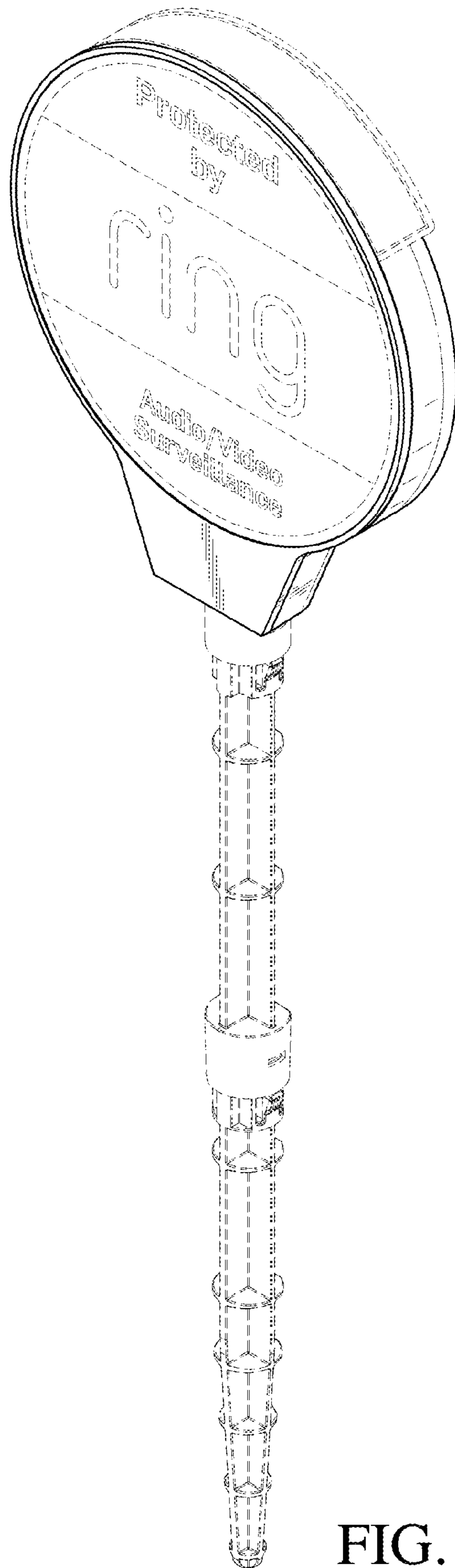
