The ornamental design for a set of fish toys, as shown and described.

**DESCRIPTION**

FIG. 17 is a top plan view thereof;

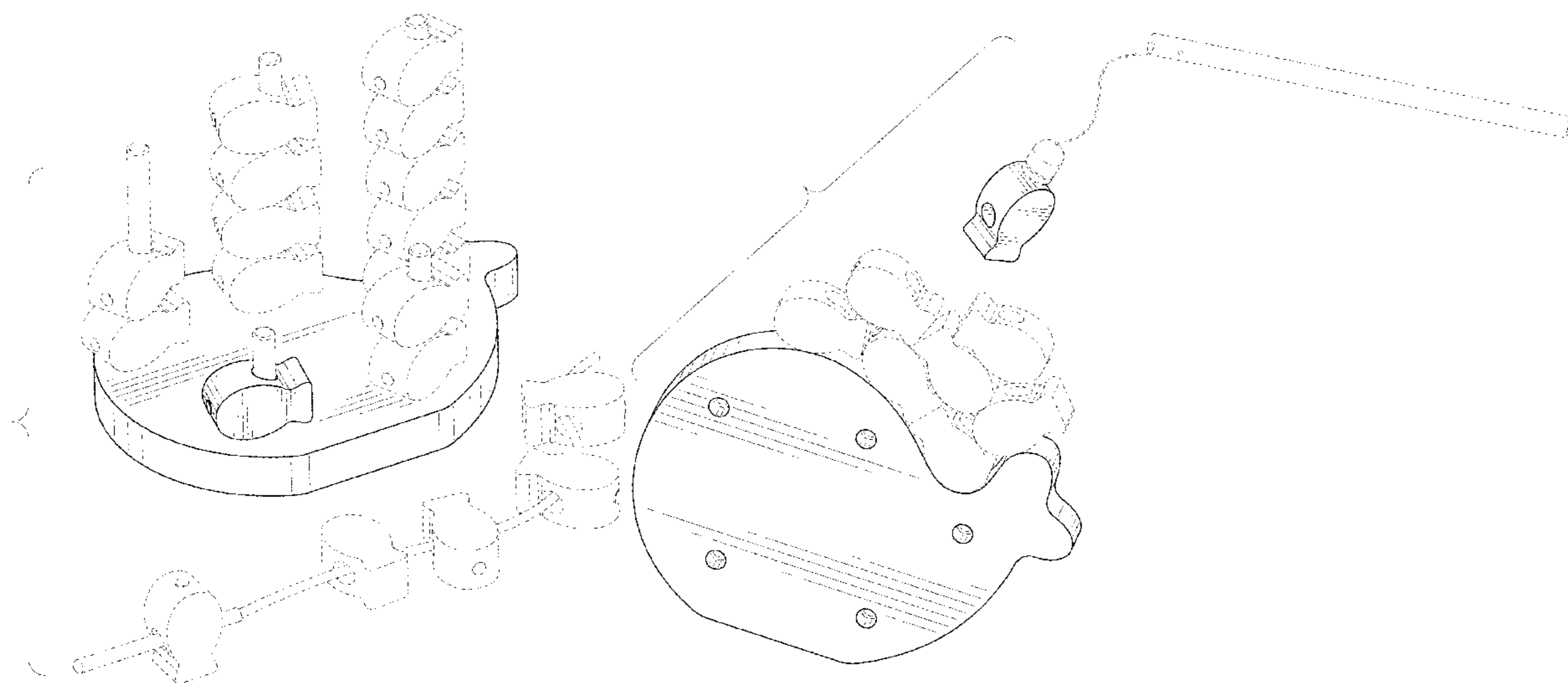
FIG. 18 is a bottom plan view thereof;

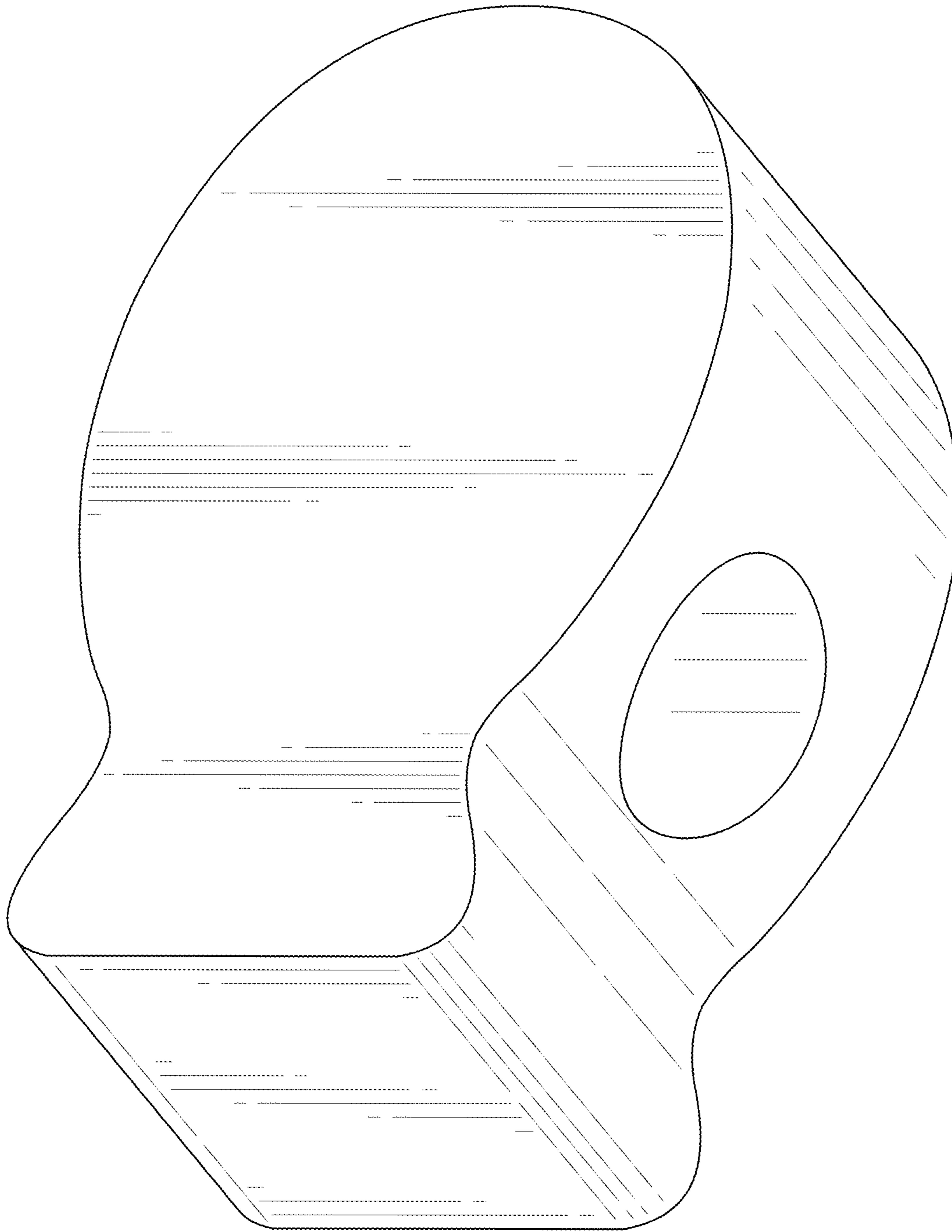

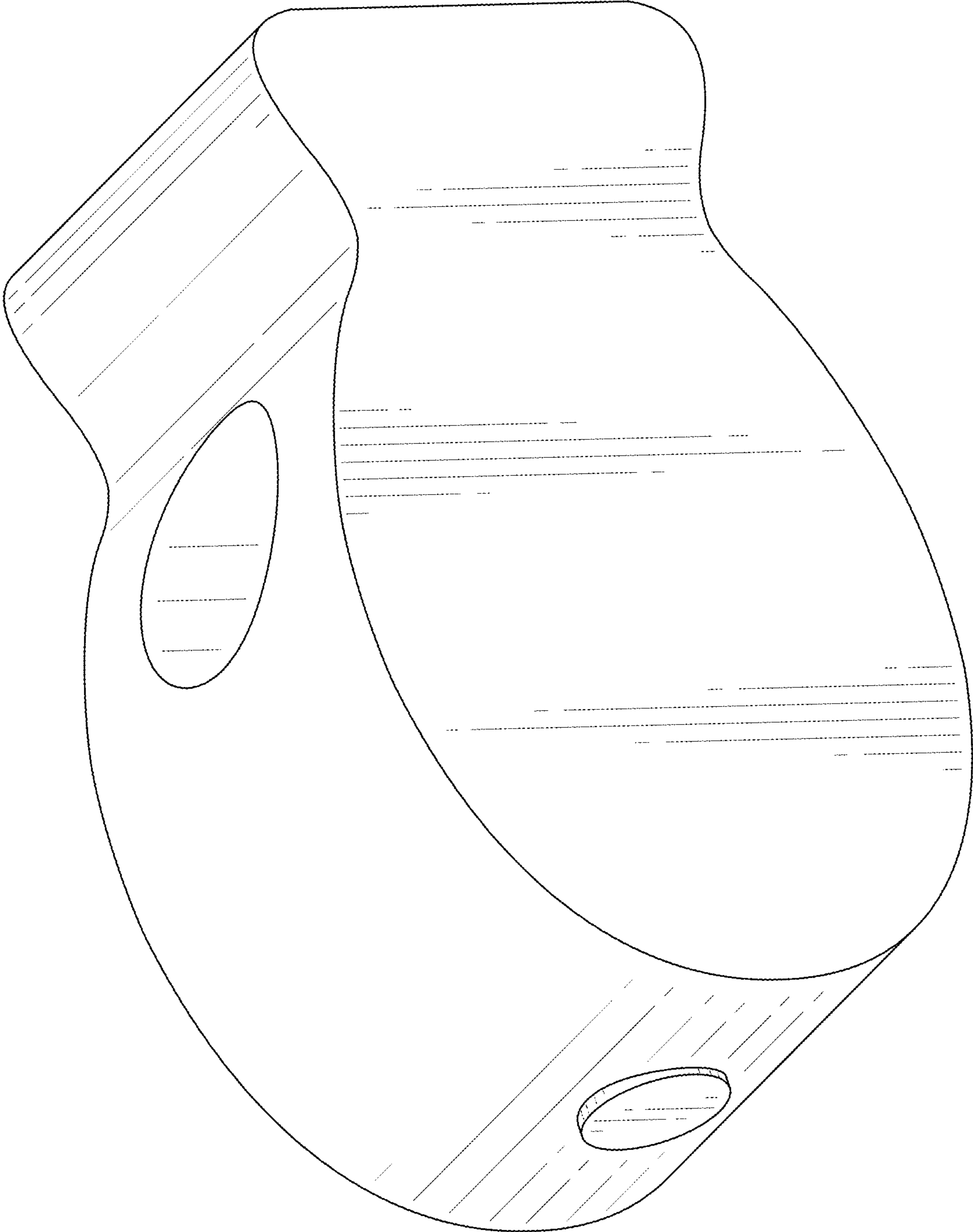

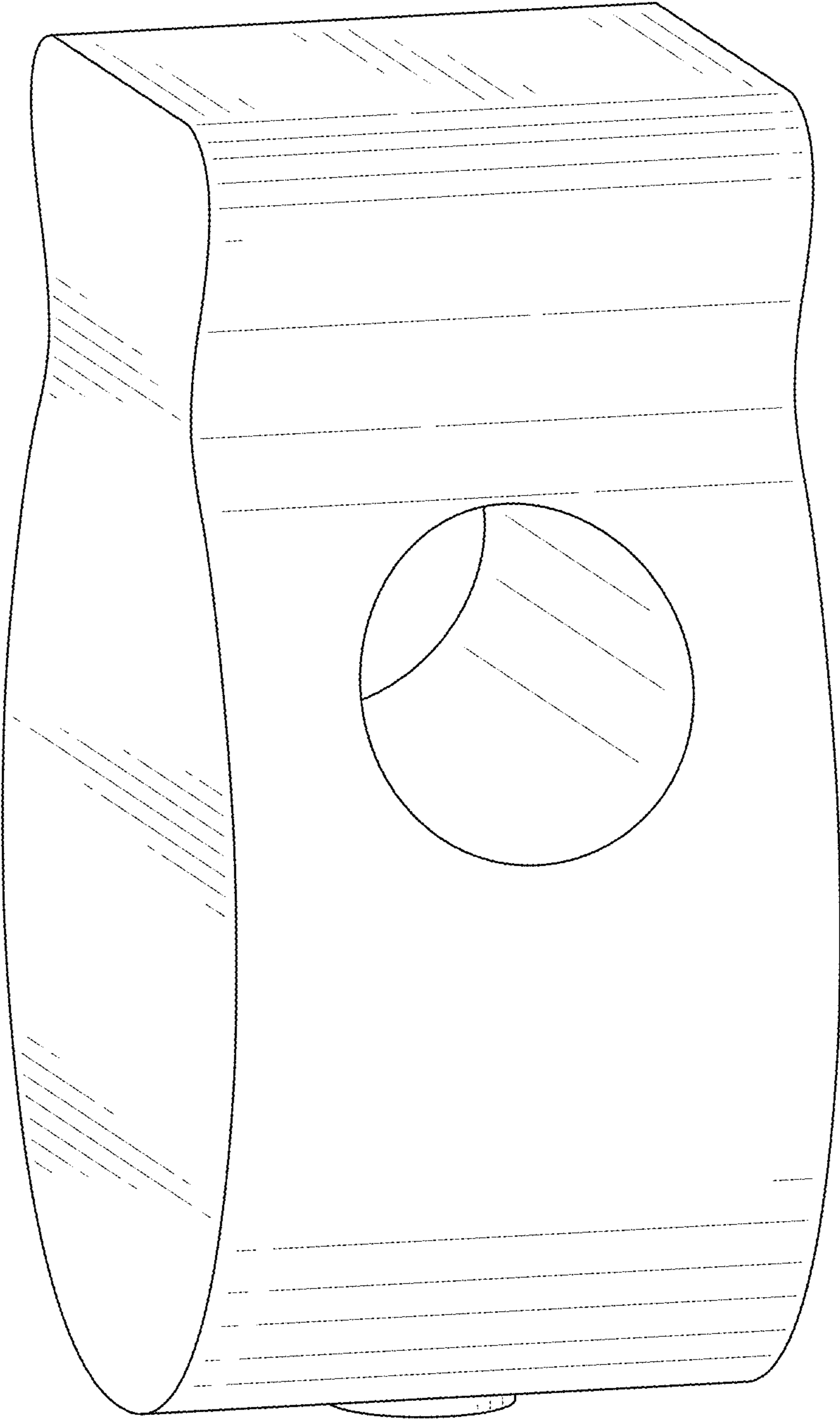

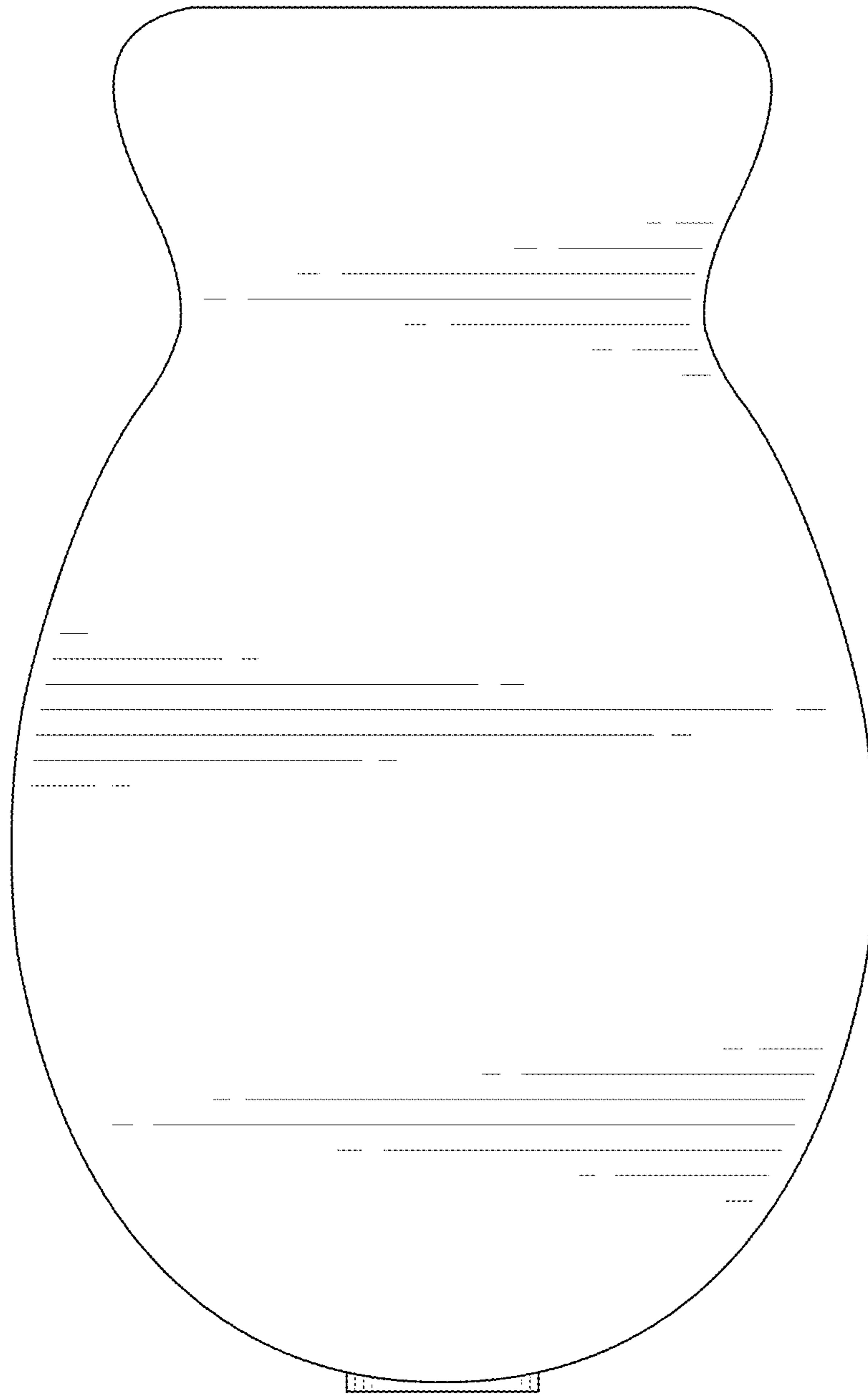

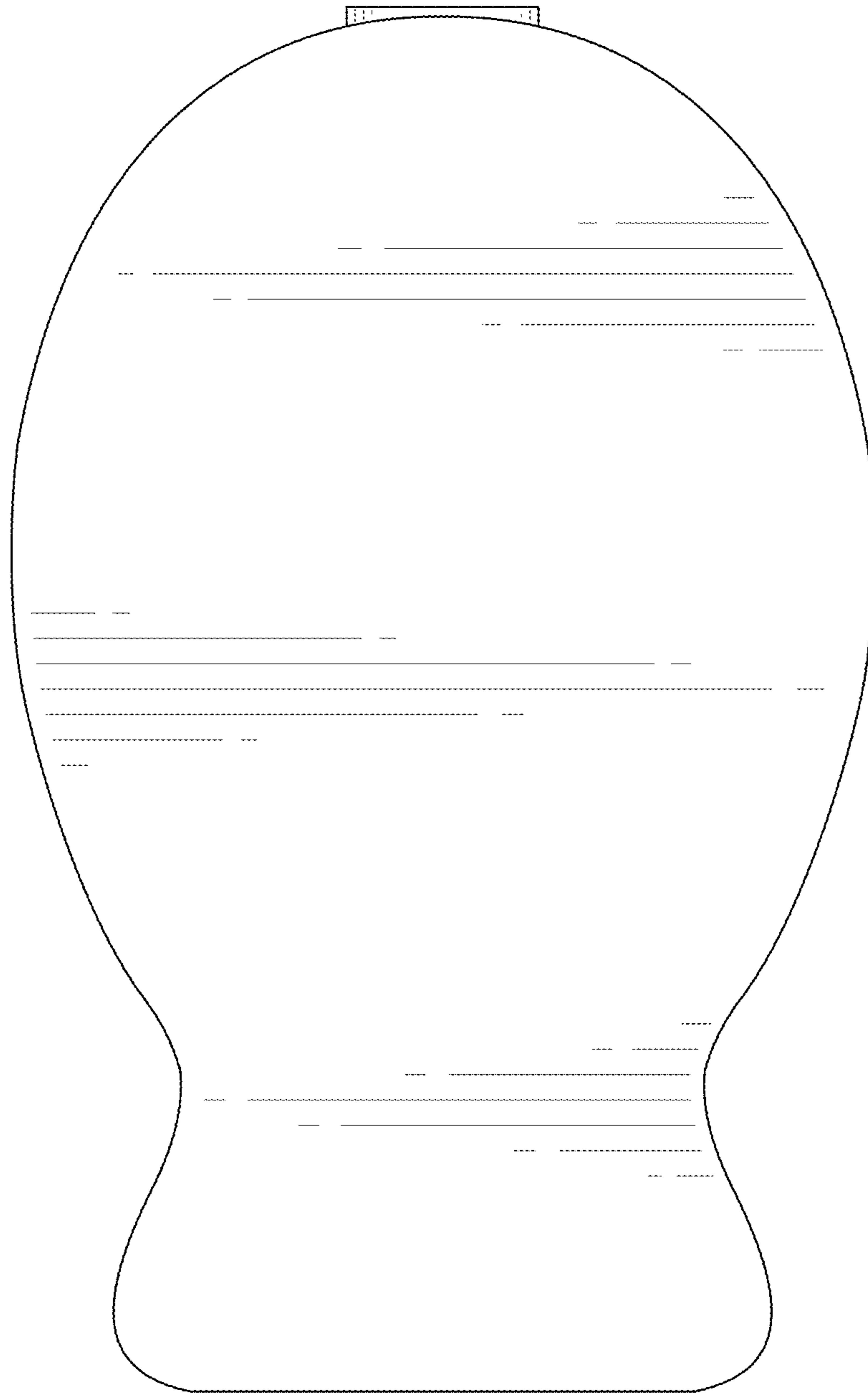

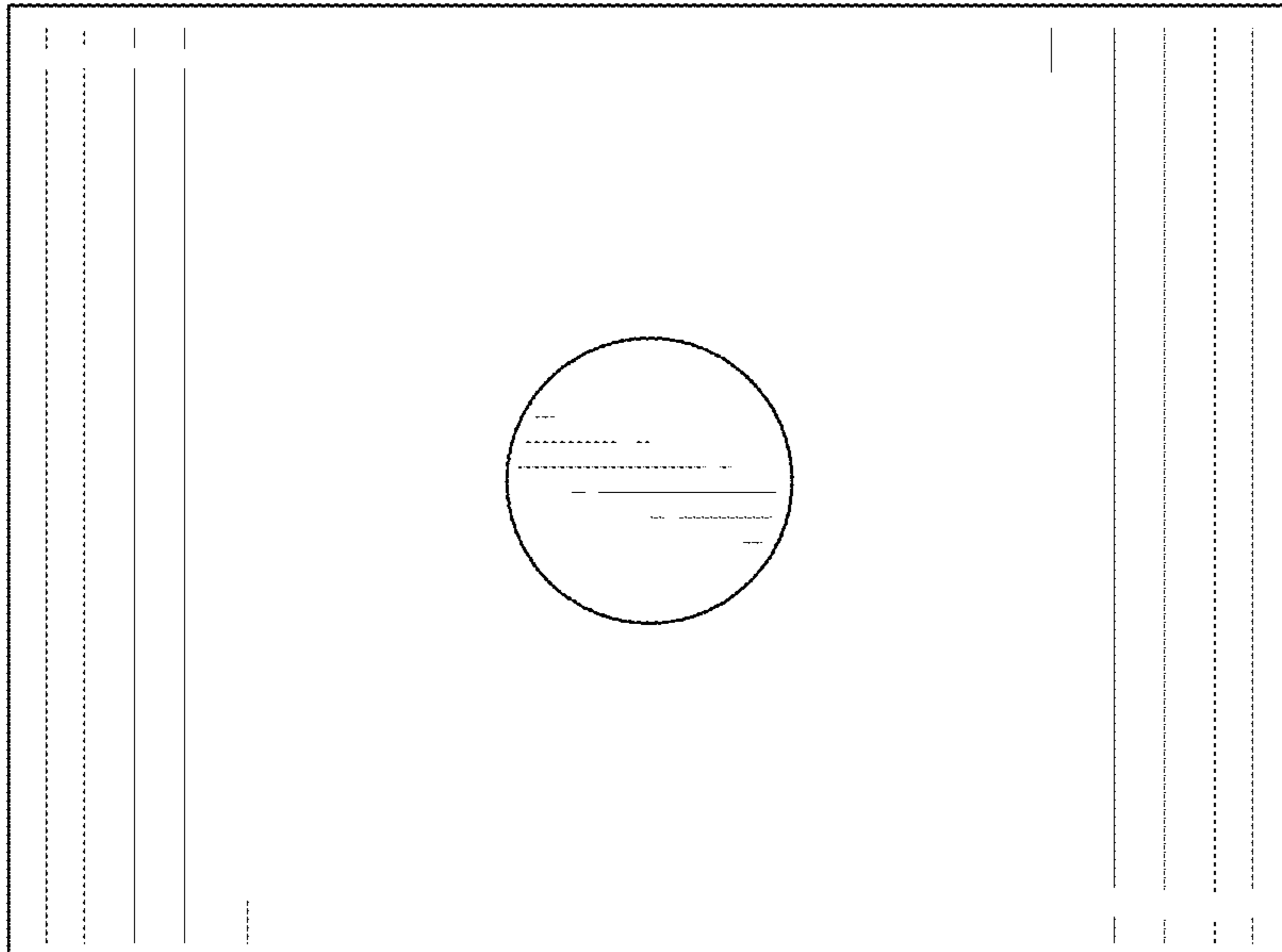

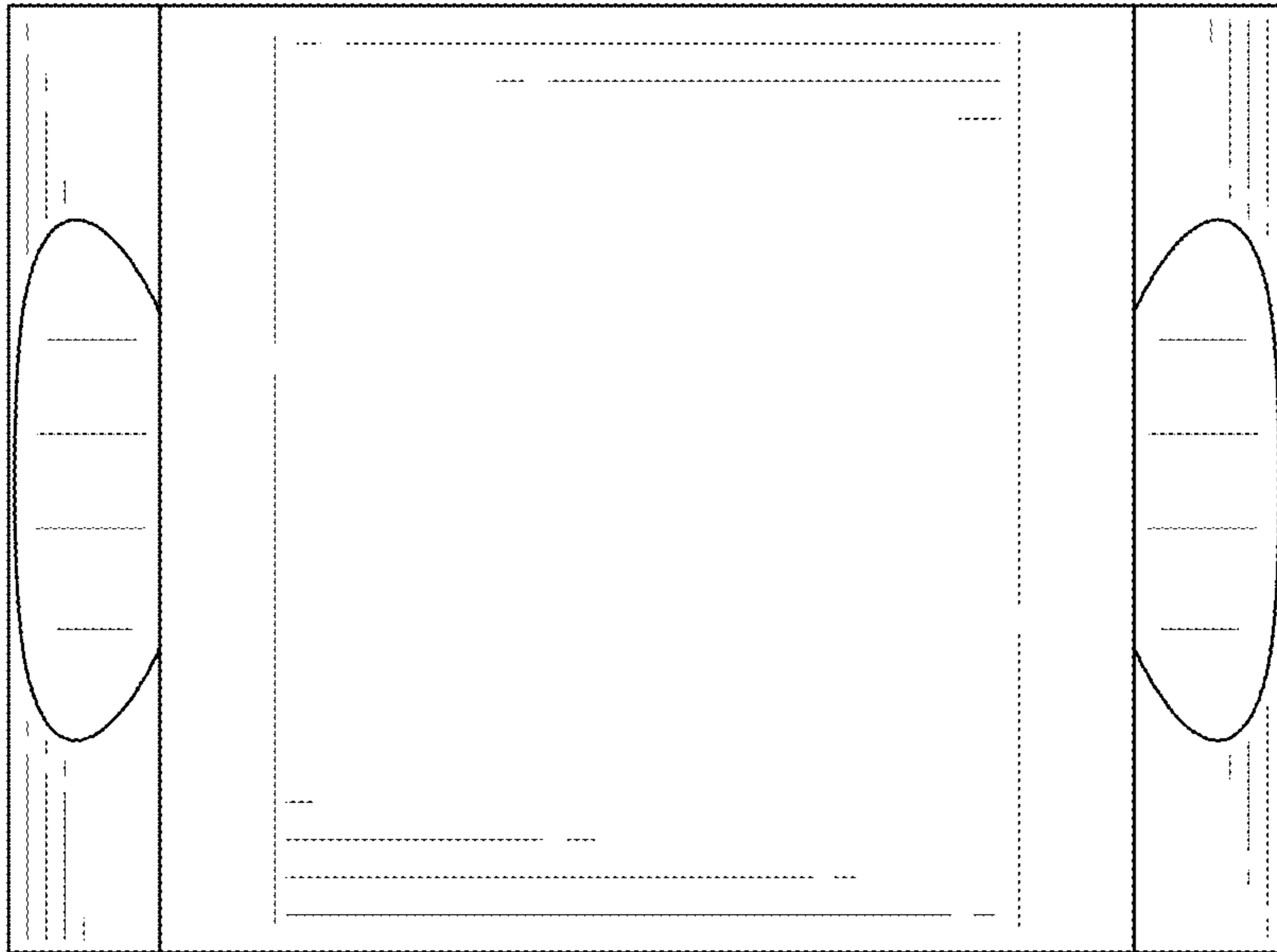

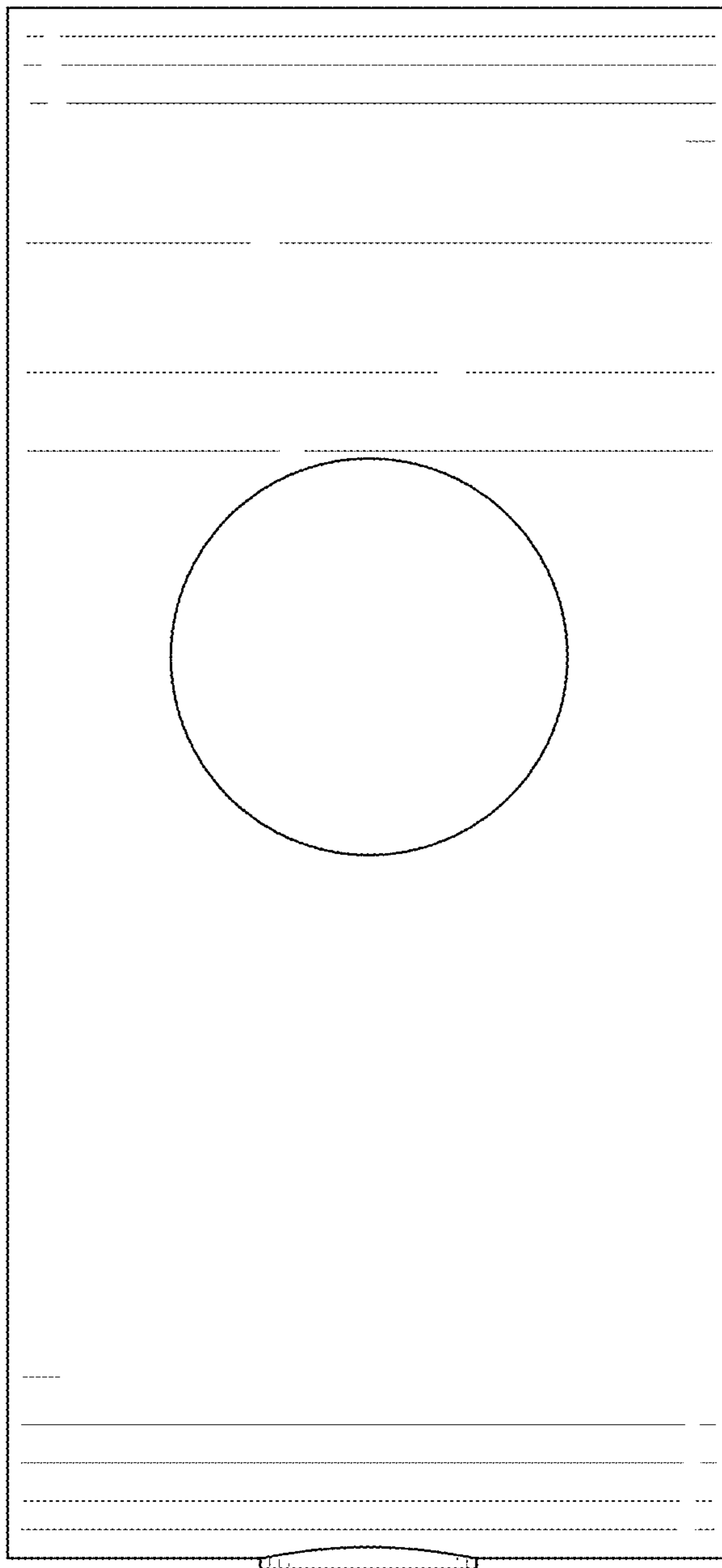

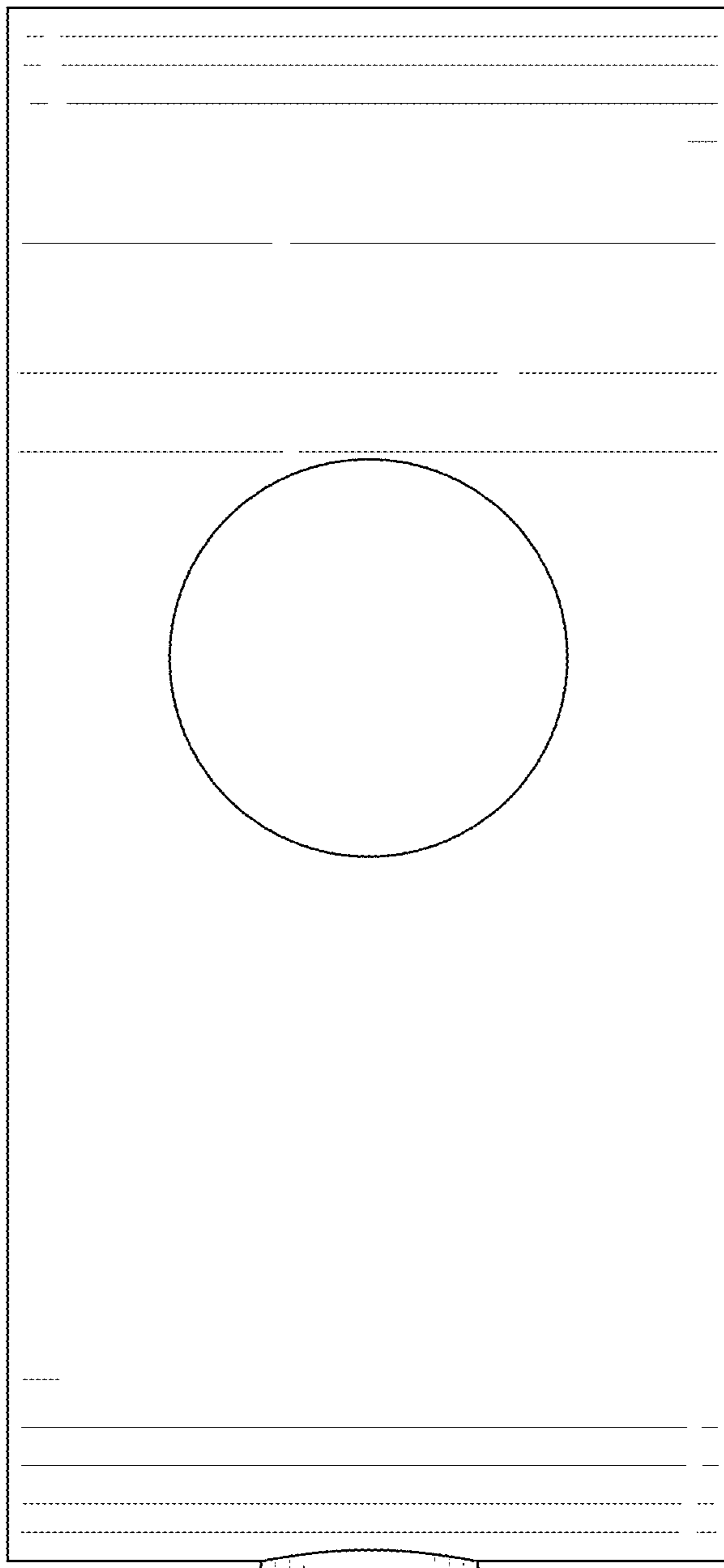

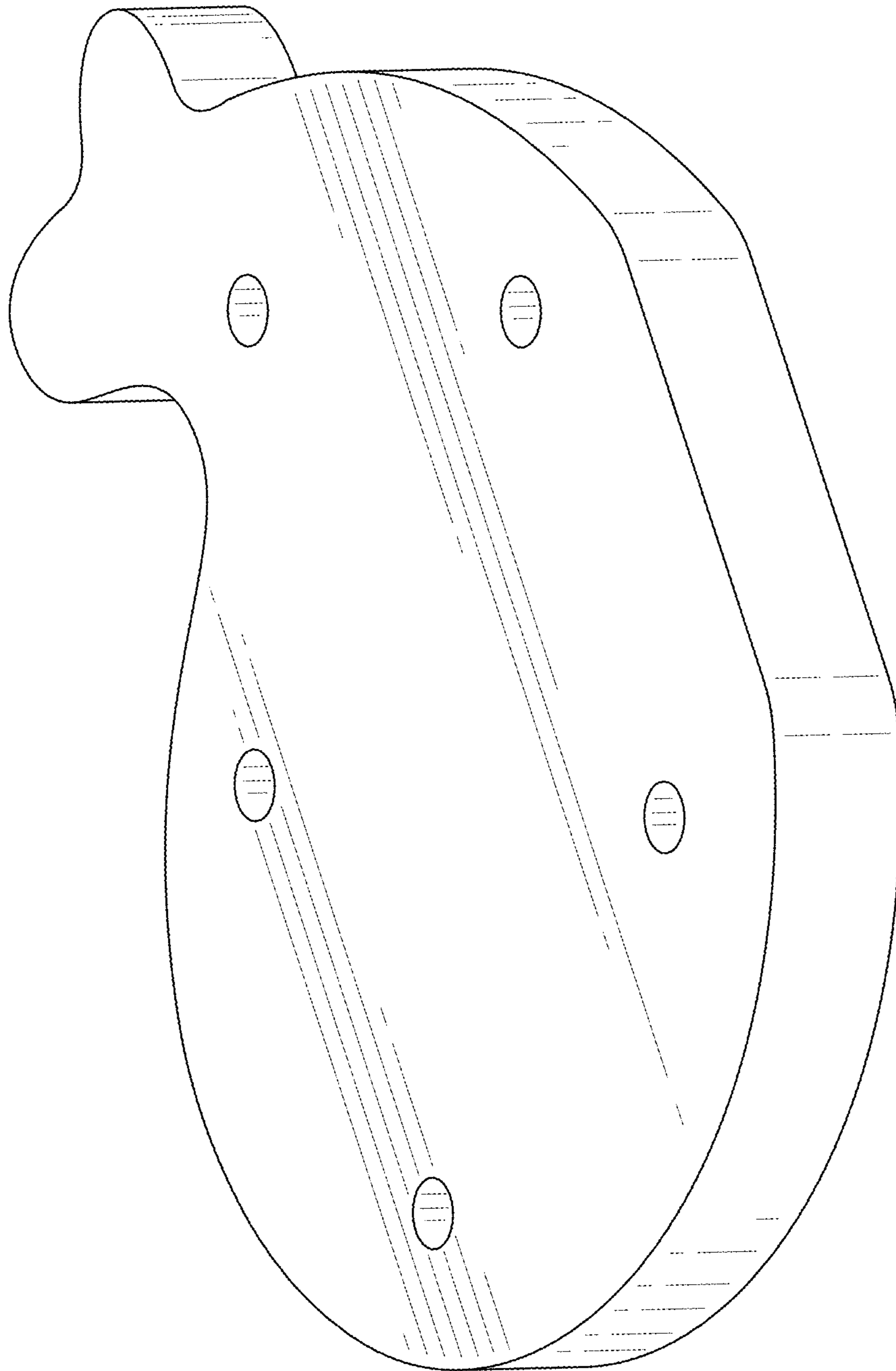

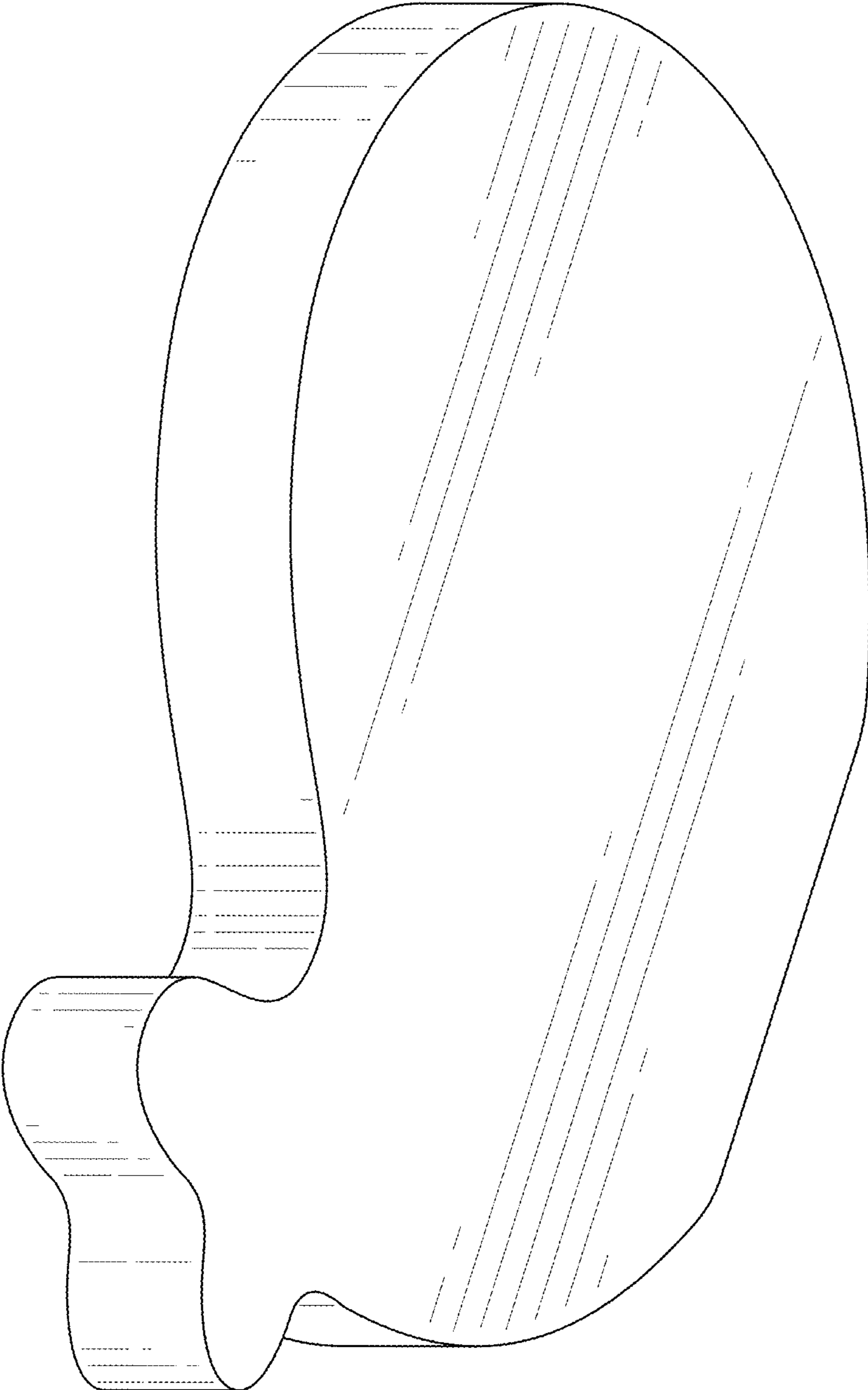

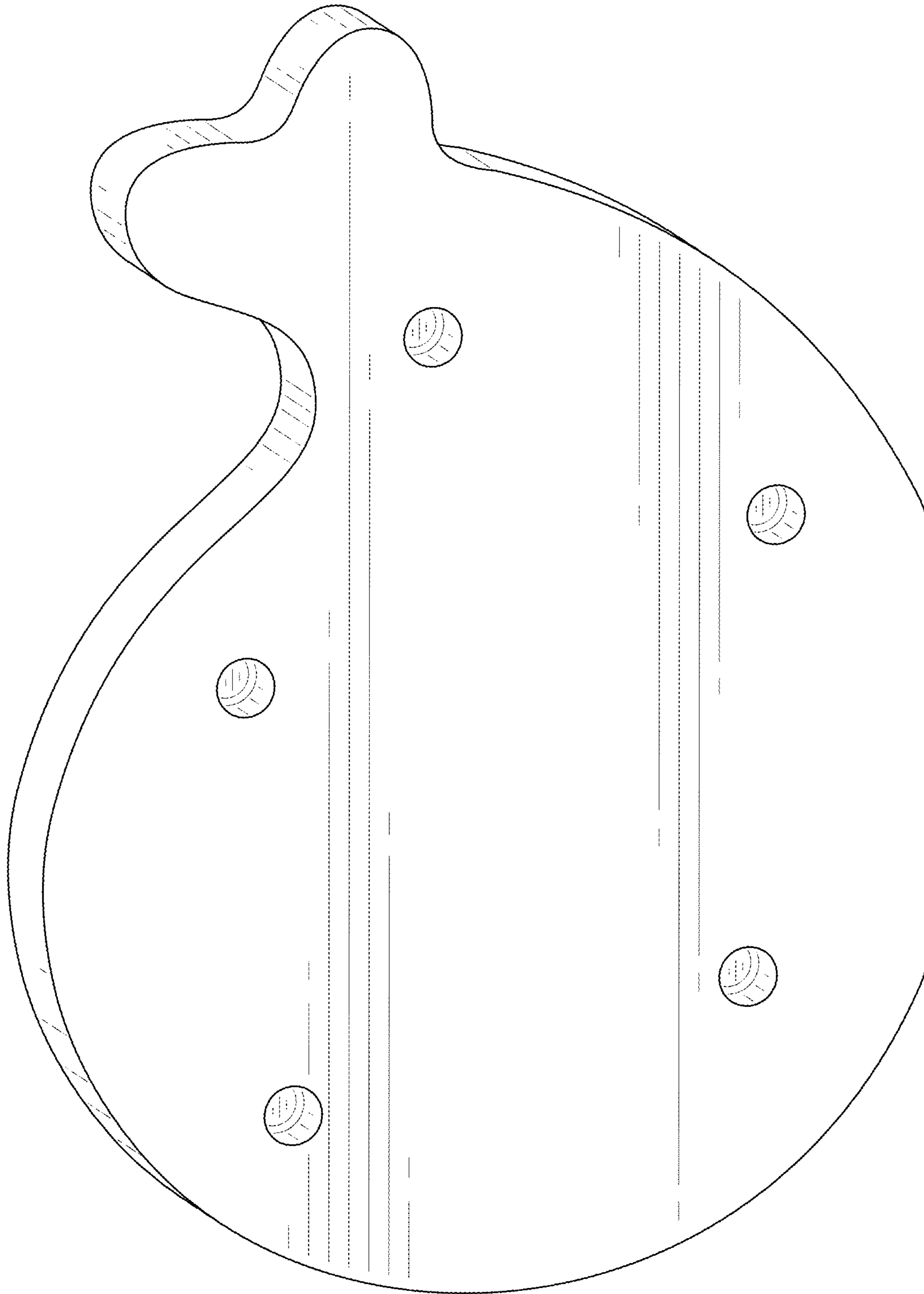

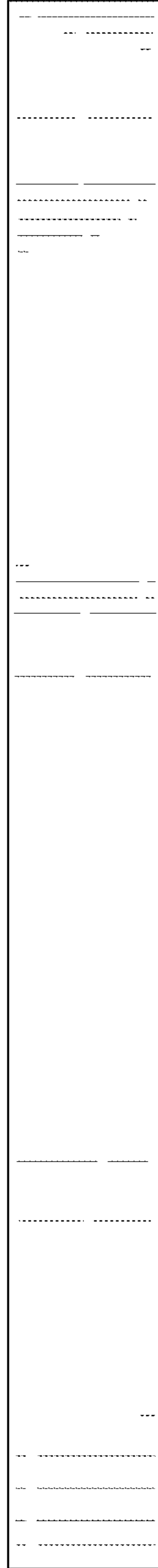

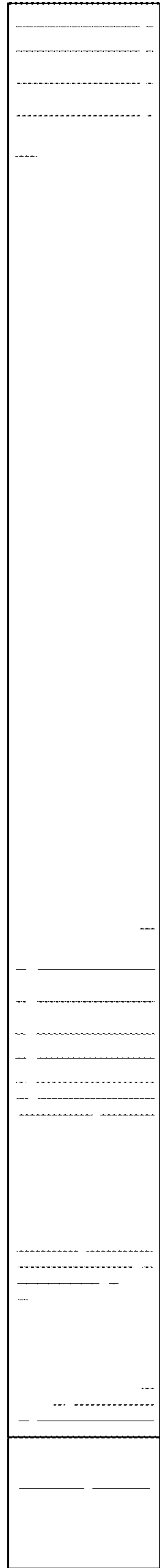

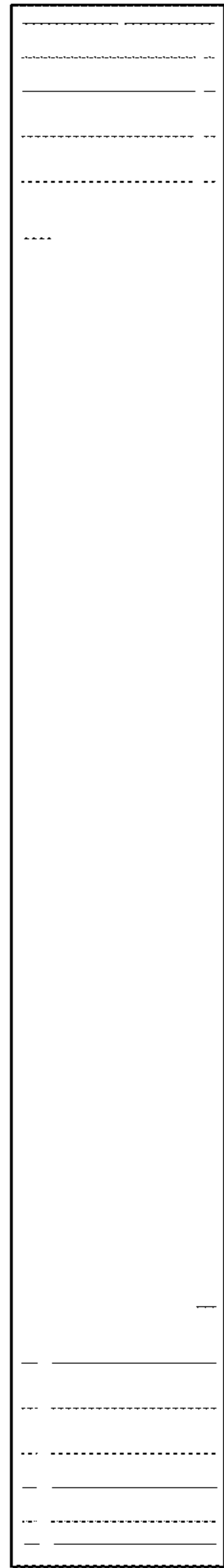

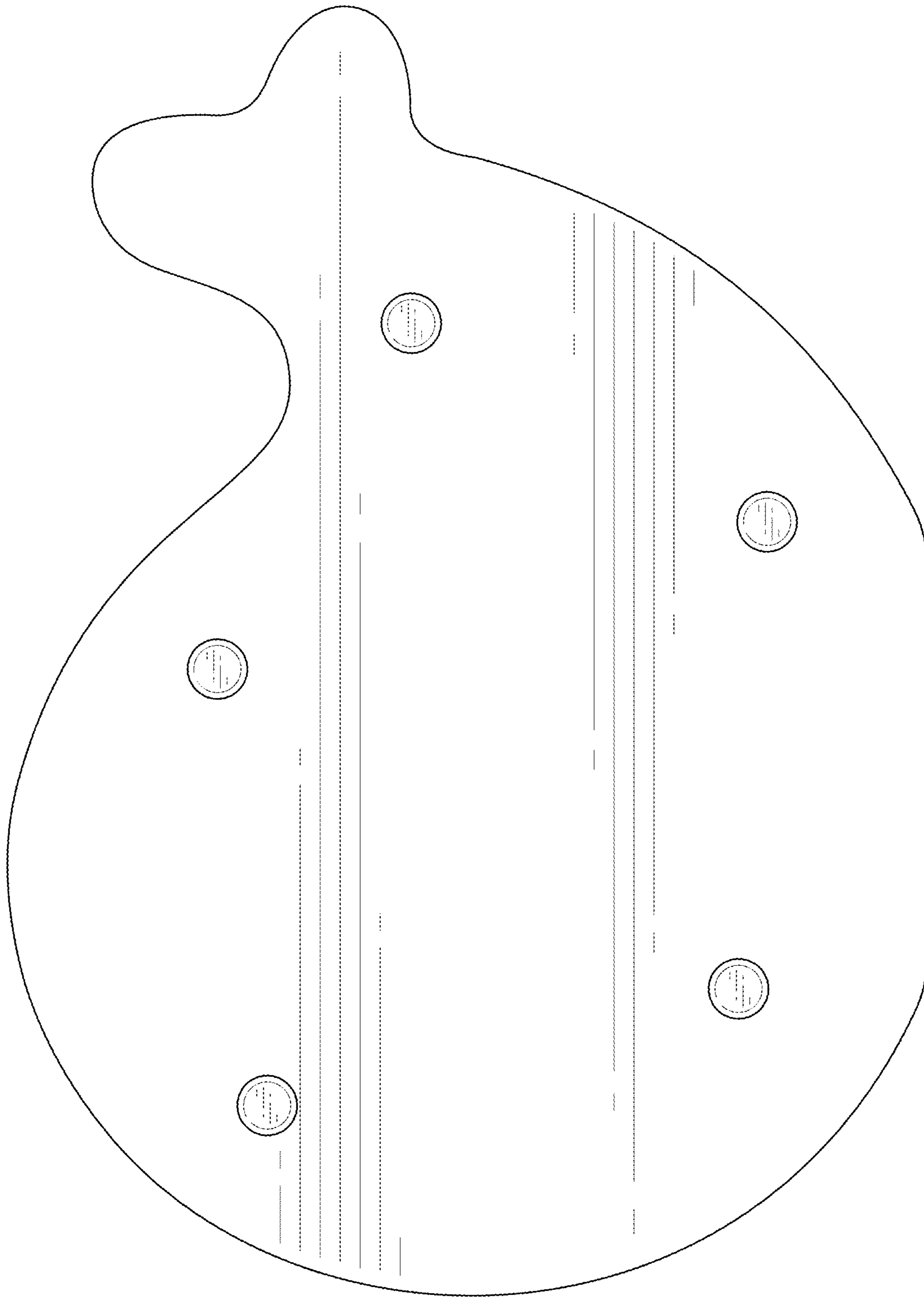

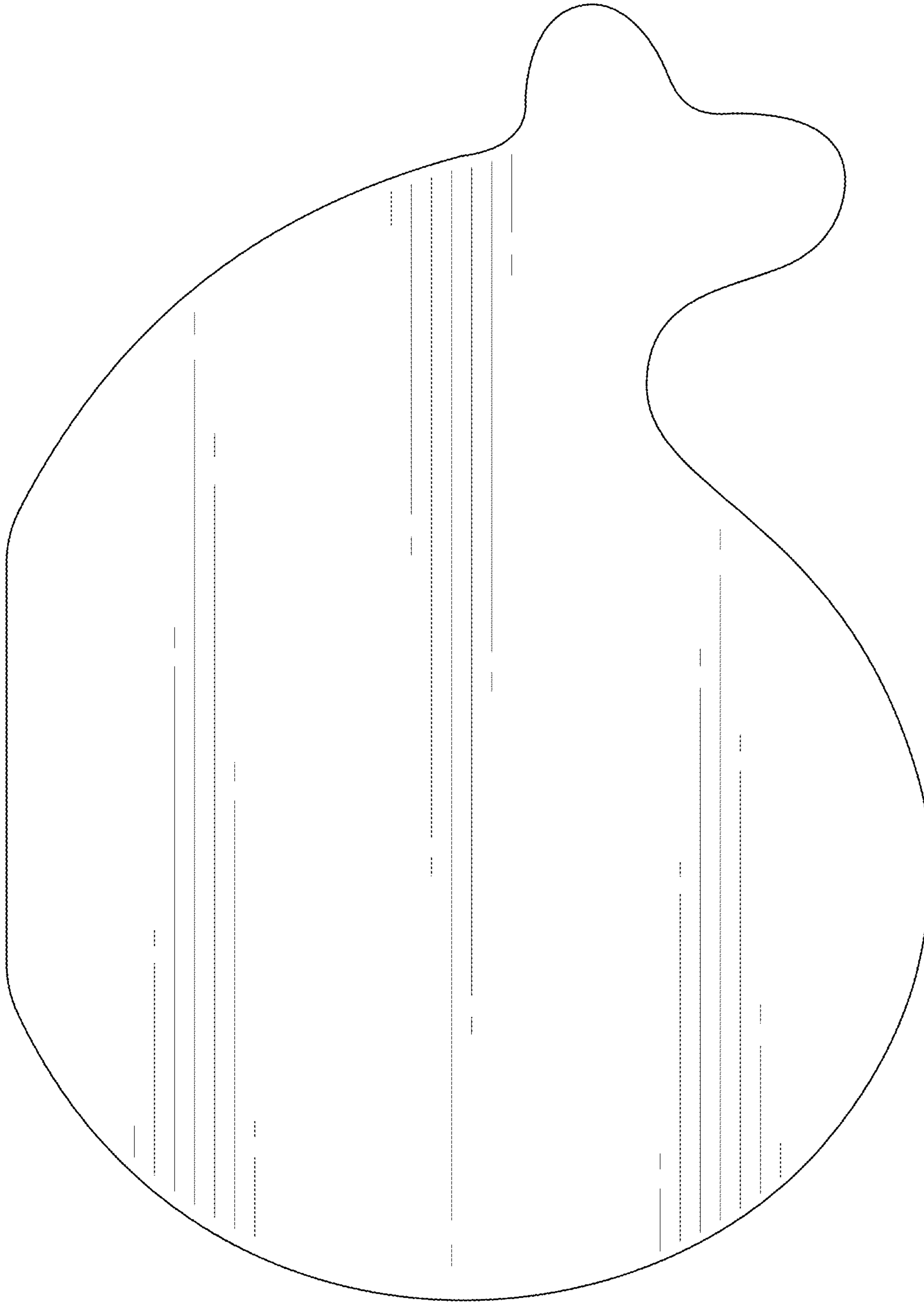

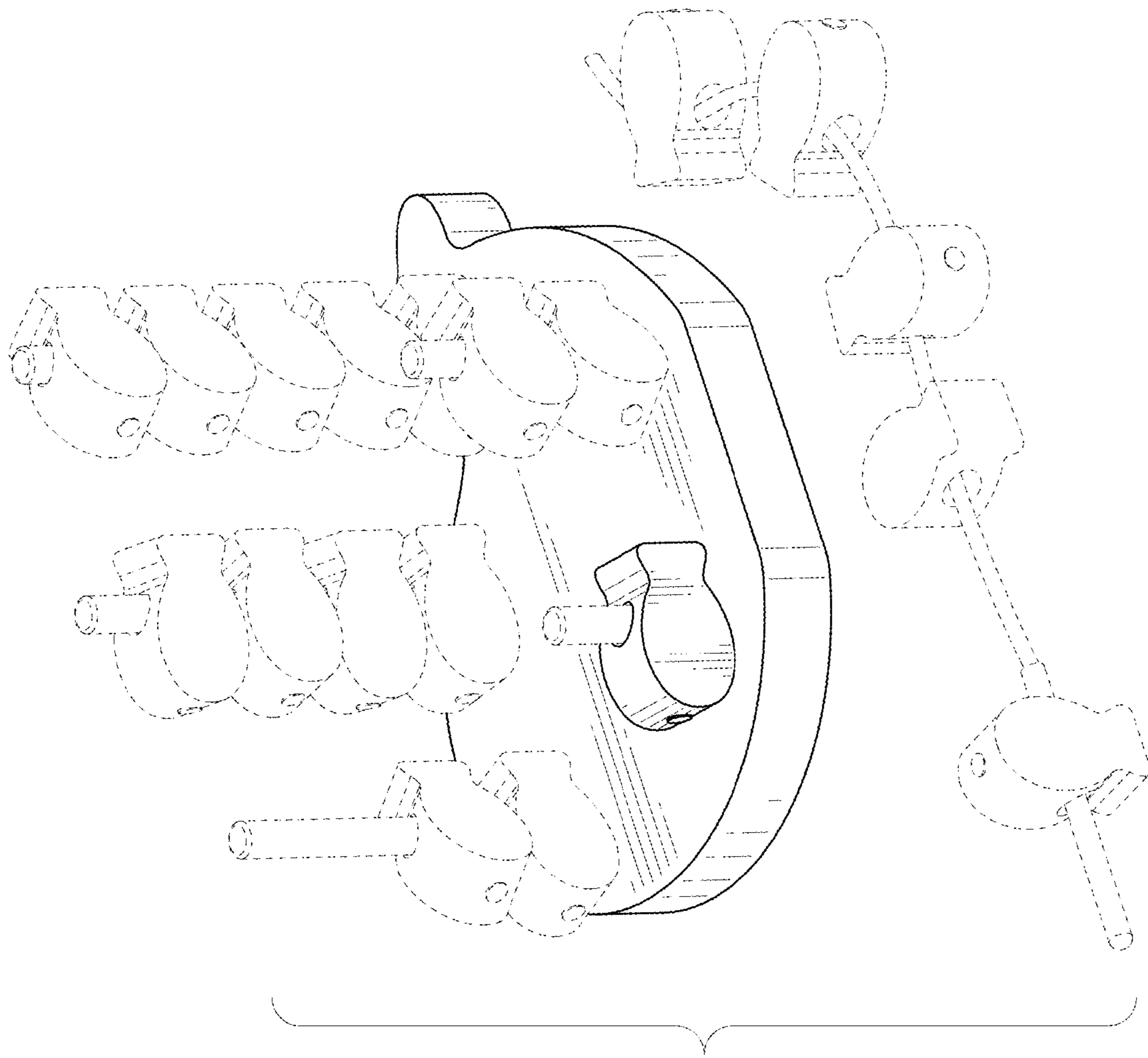

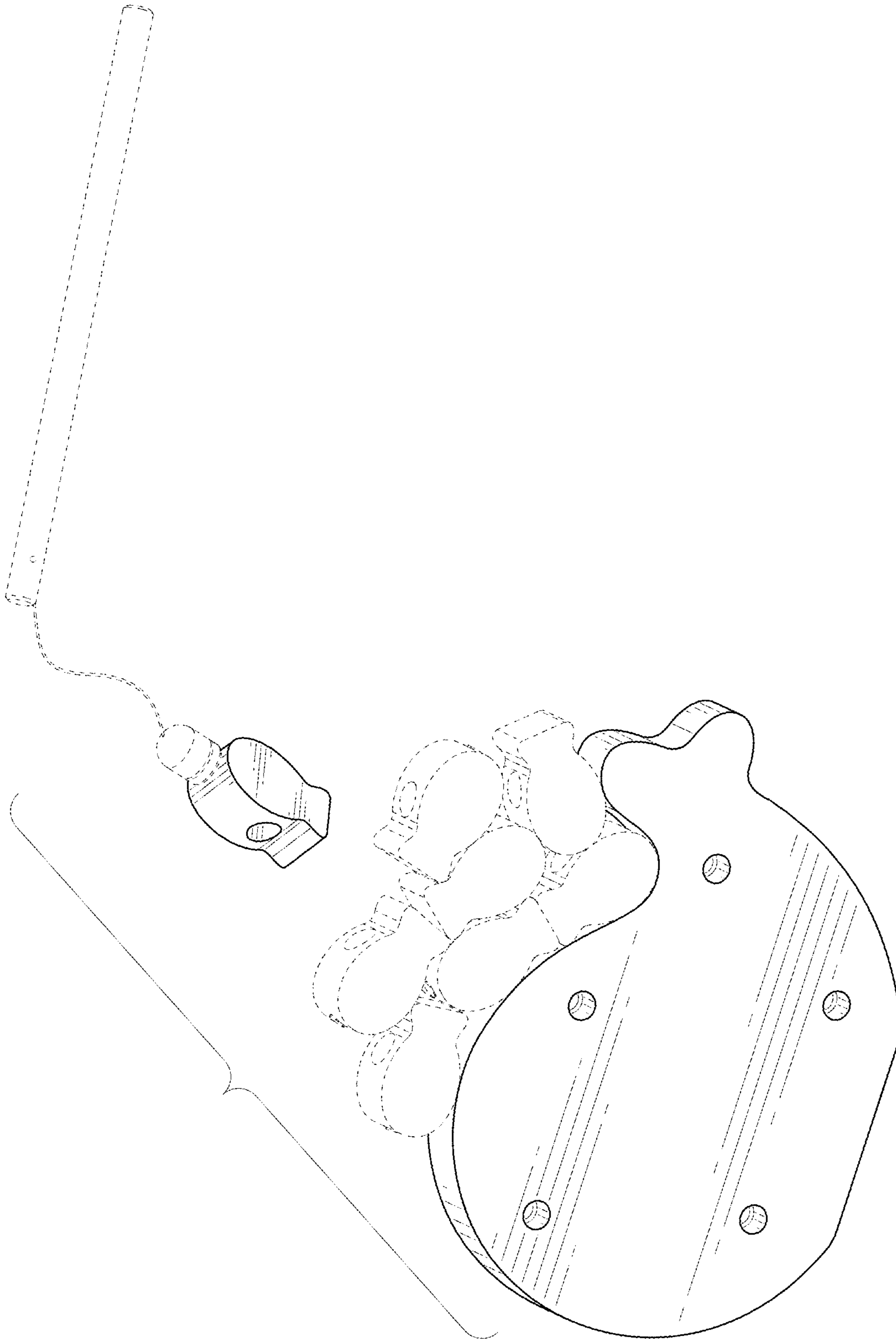
