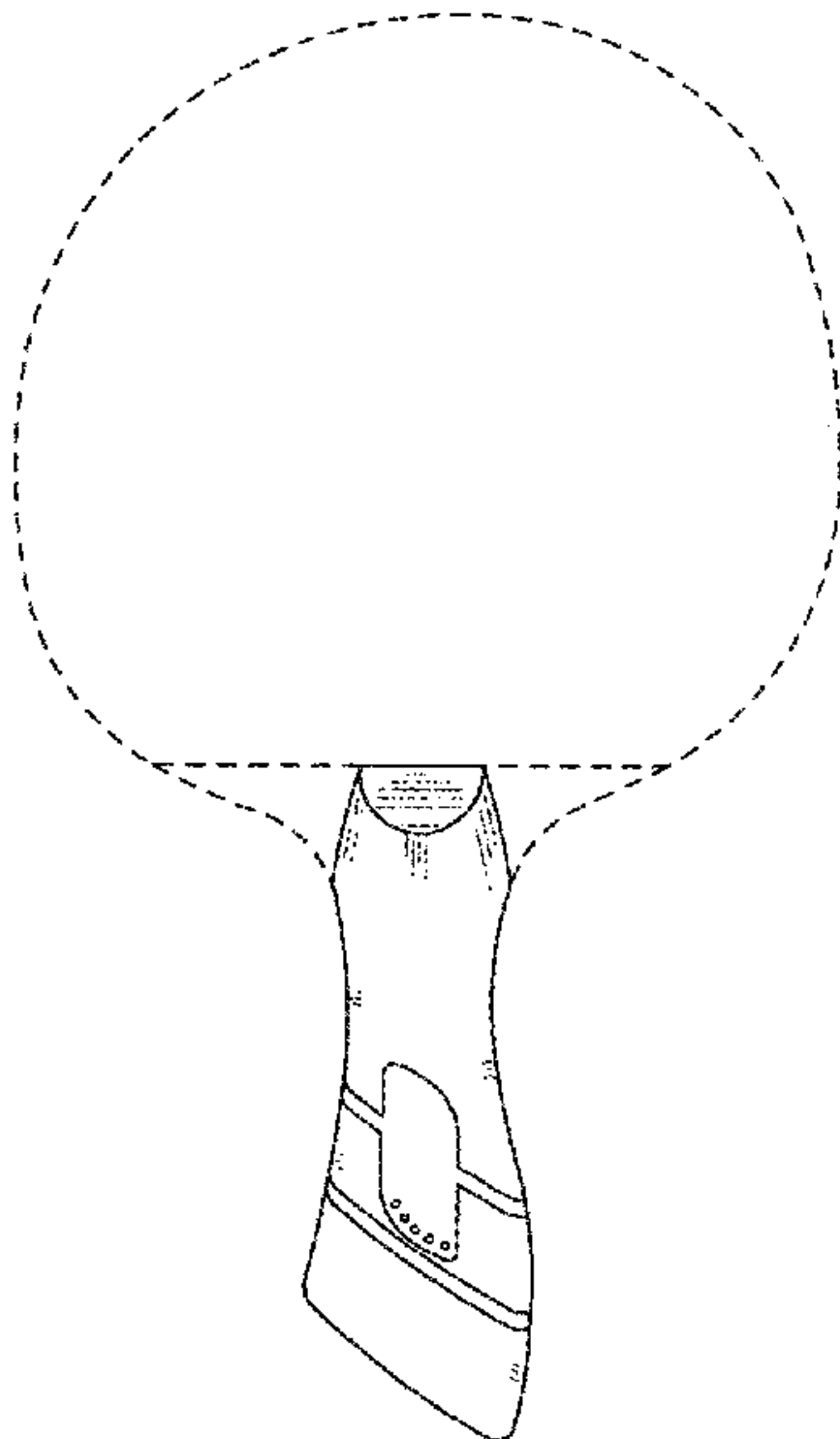

(57) **CLAIM**
The ornamental design for a slopehandle paddle for table tennis, as shown and described.

DESCRIPTION
FIG. 1 is a front view of the slopehandle paddle for table tennis, showing my new design;
FIG. 2 is a back view of the slopehandle paddle for table tennis of FIG. 1;
FIG. 3 is a top view of the slopehandle paddle for table tennis of FIG. 1;
FIG. 4 is a bottom view of the slopehandle paddle for table tennis of FIG. 1;
FIG. 5 is a left side view of the slopehandle paddle for table tennis of FIG. 1;
FIG. 6 is a right-side view of the slopehandle paddle for table tennis of FIG. 1; and,

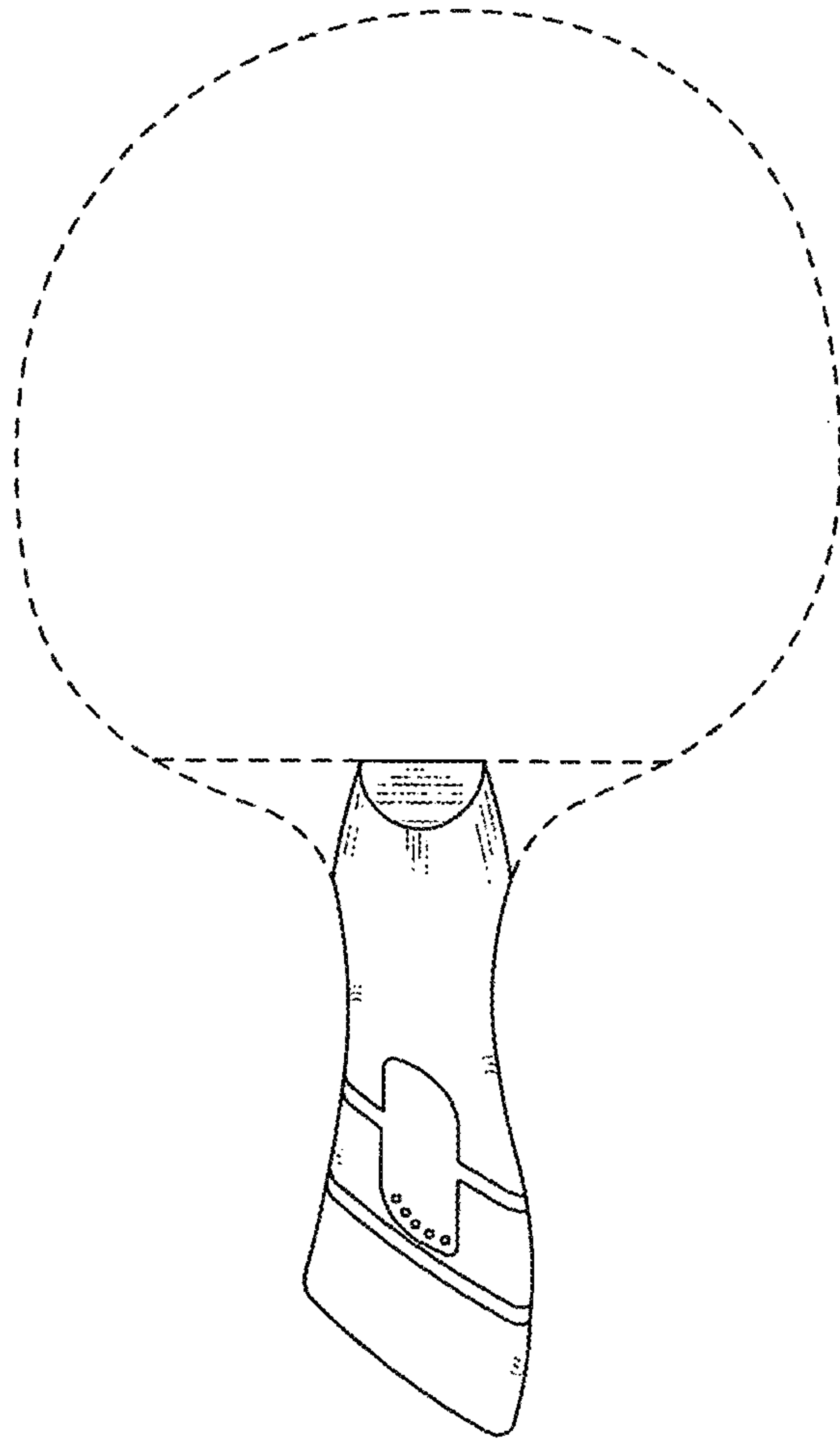

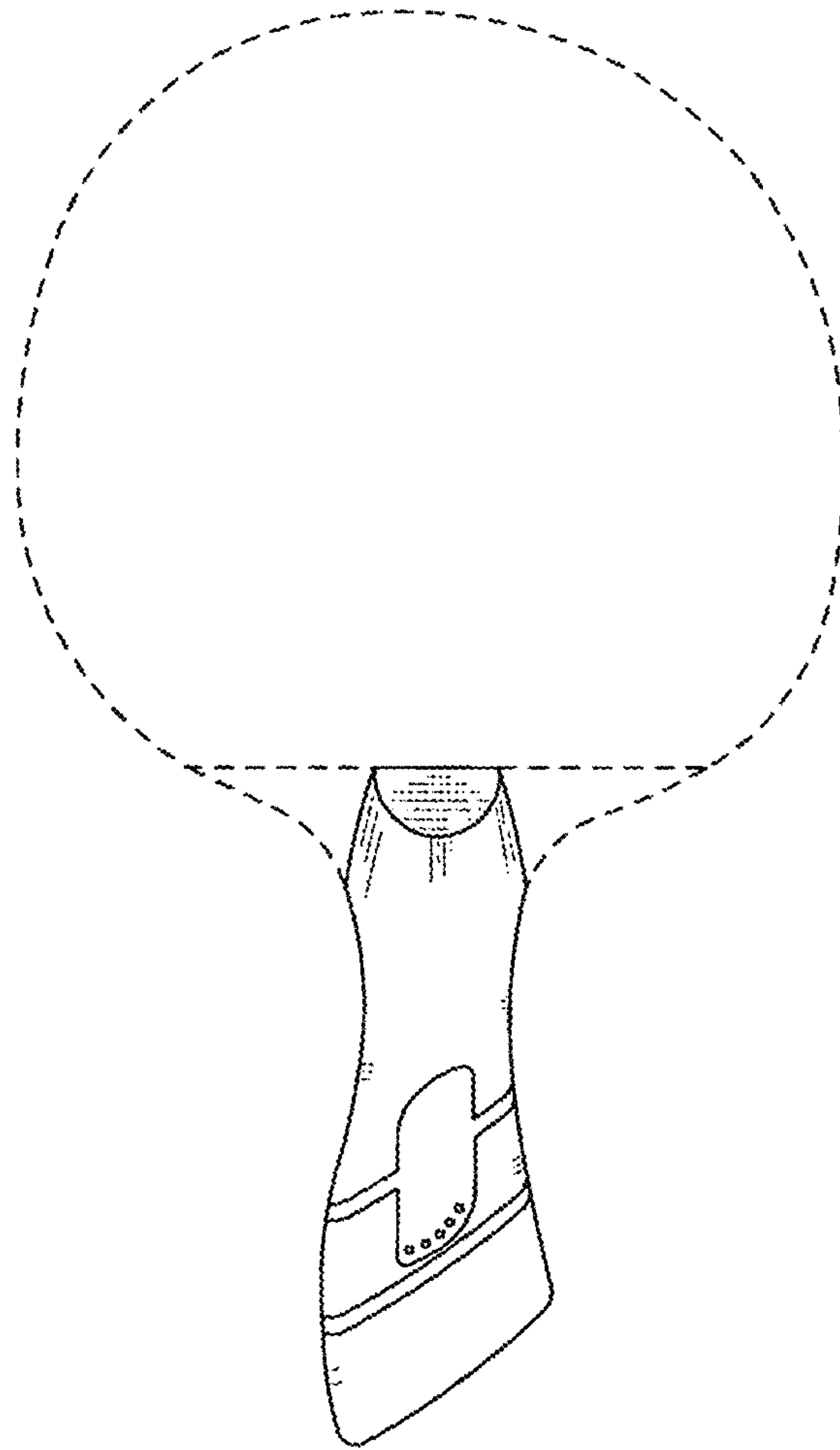

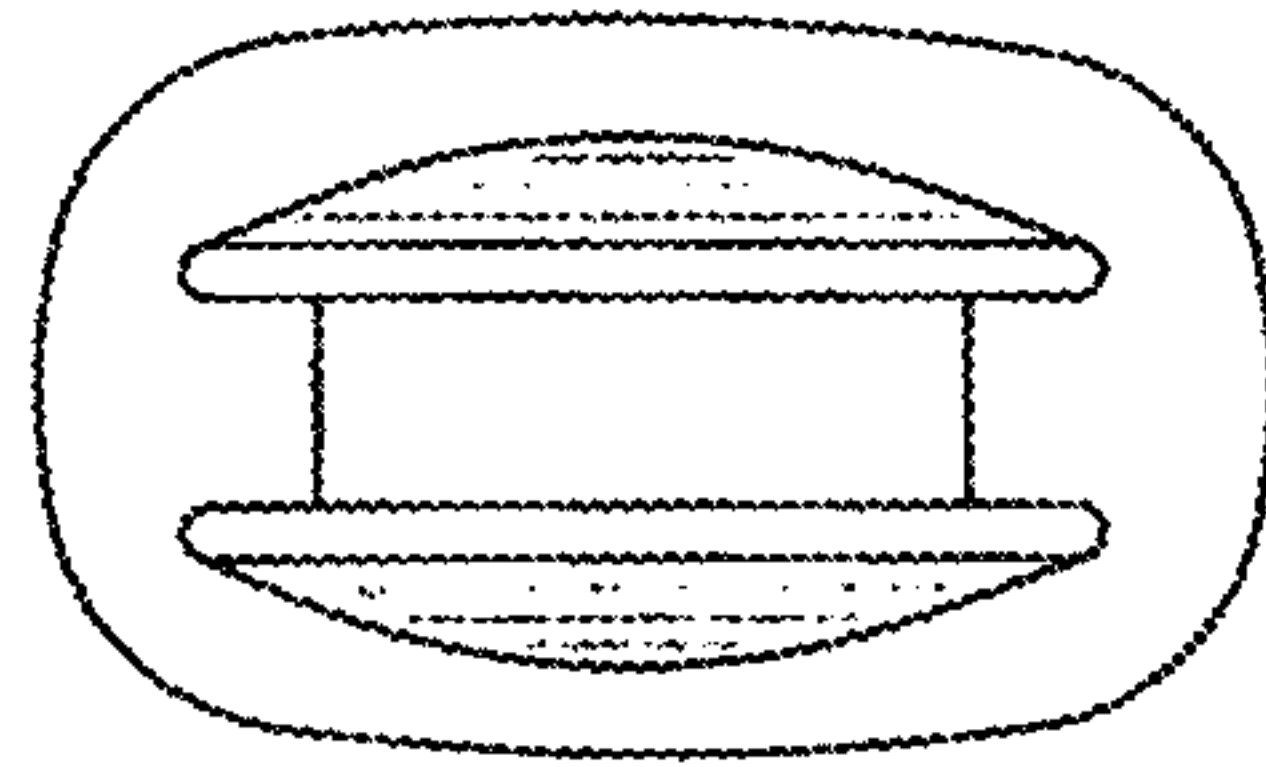

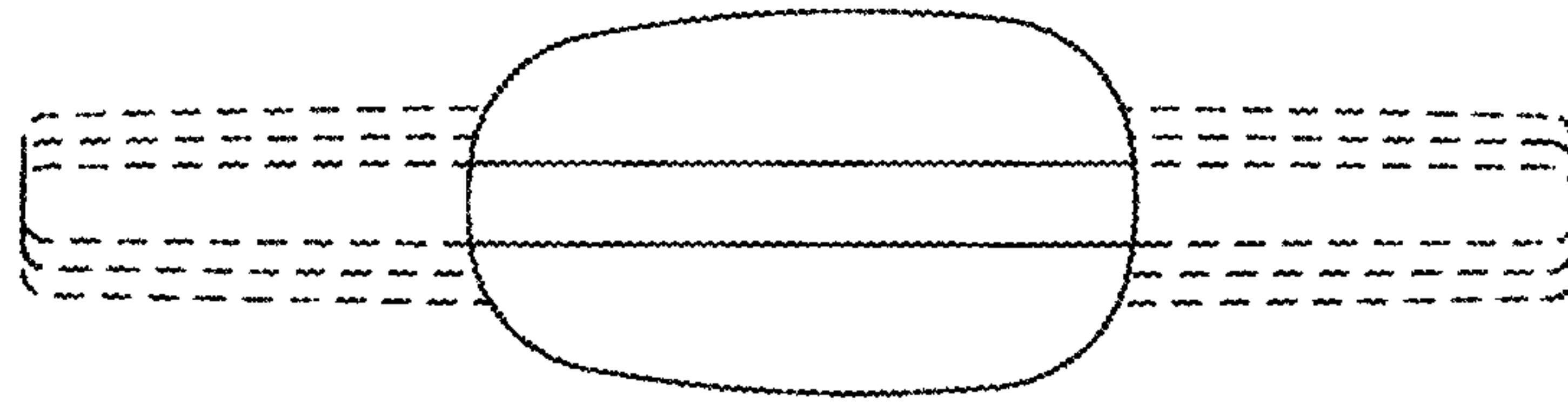

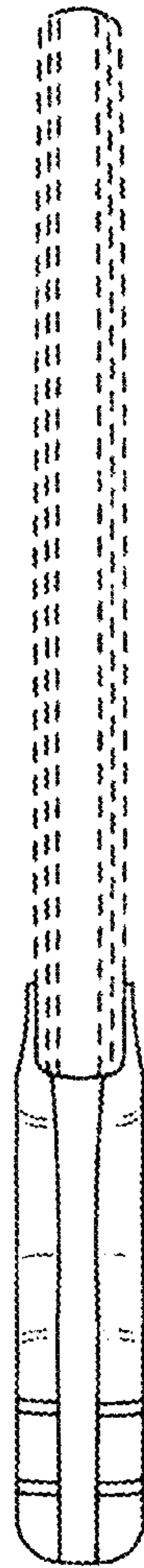

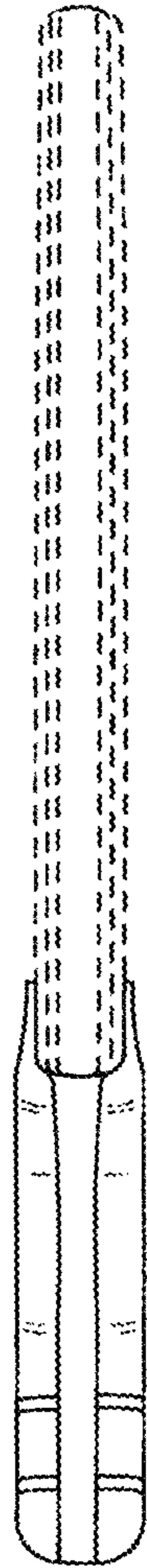

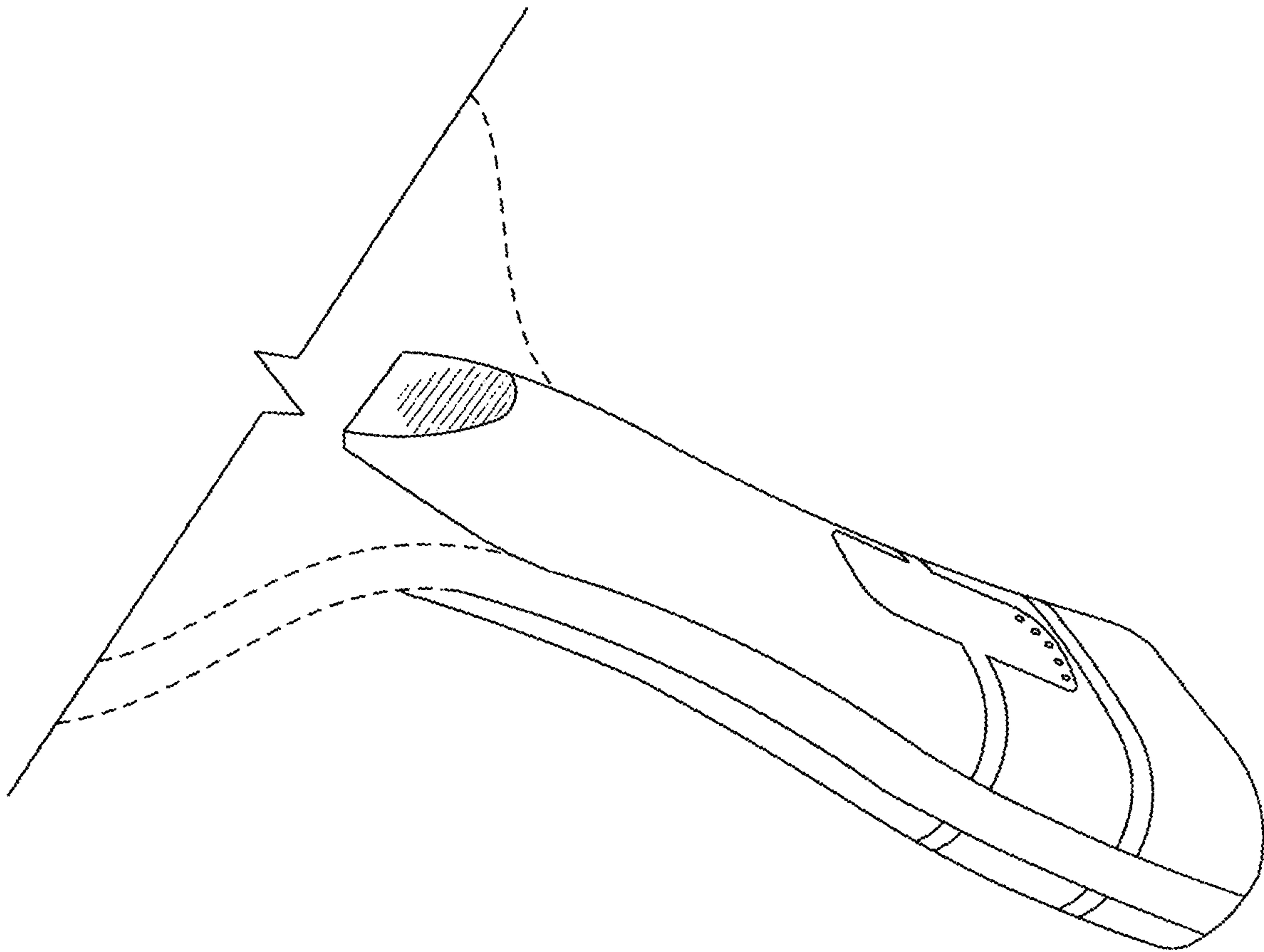
