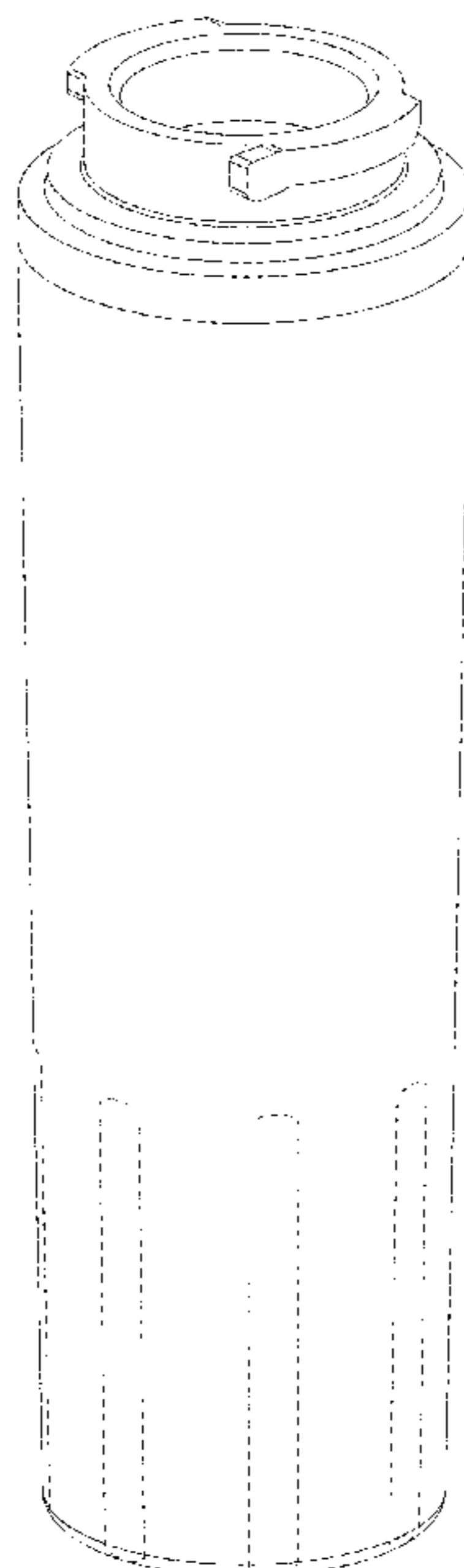
(57) **CLAIM**

The ornamental design for a filter unit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a filter unit showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a light side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective views thereof;
In the drawings, the dot/dash broken lines immediately adjacent to the outer edges of the filter unit shown in FIG. 6; represent boundaries of the claim. ALL other broken lines shown in the drawings depict portions of the filter unit that form no part of the claimed design.

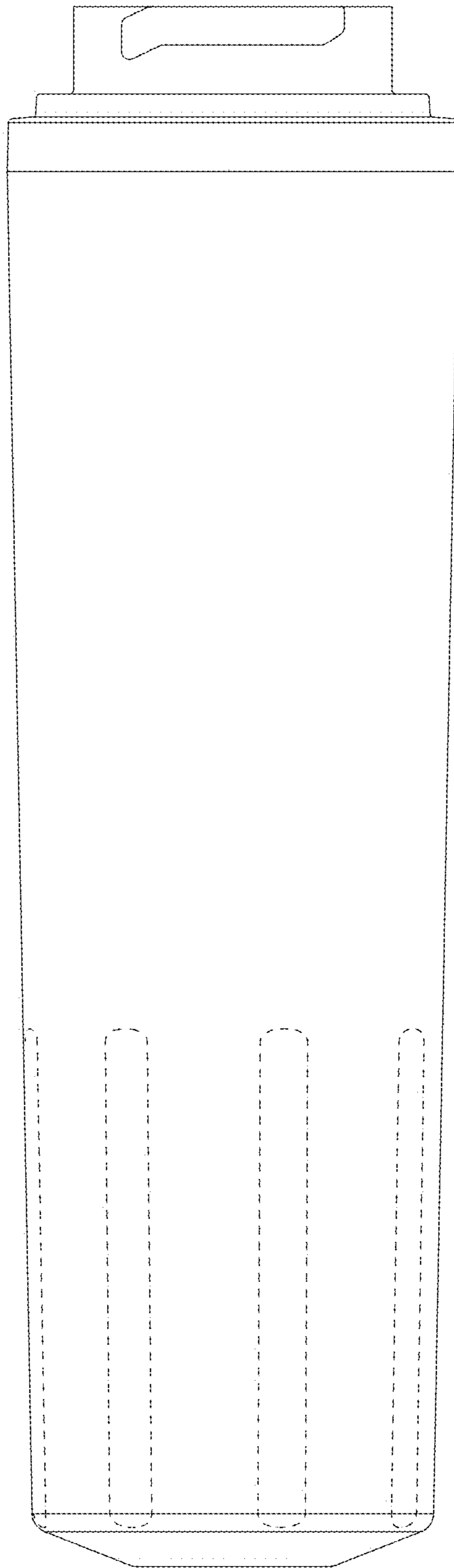

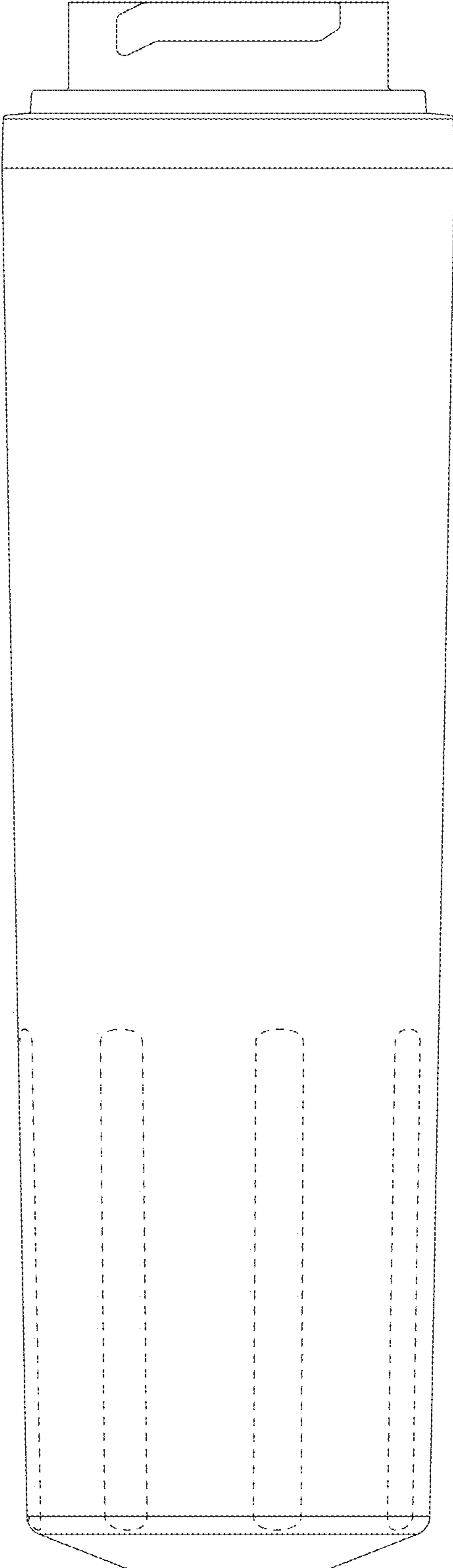

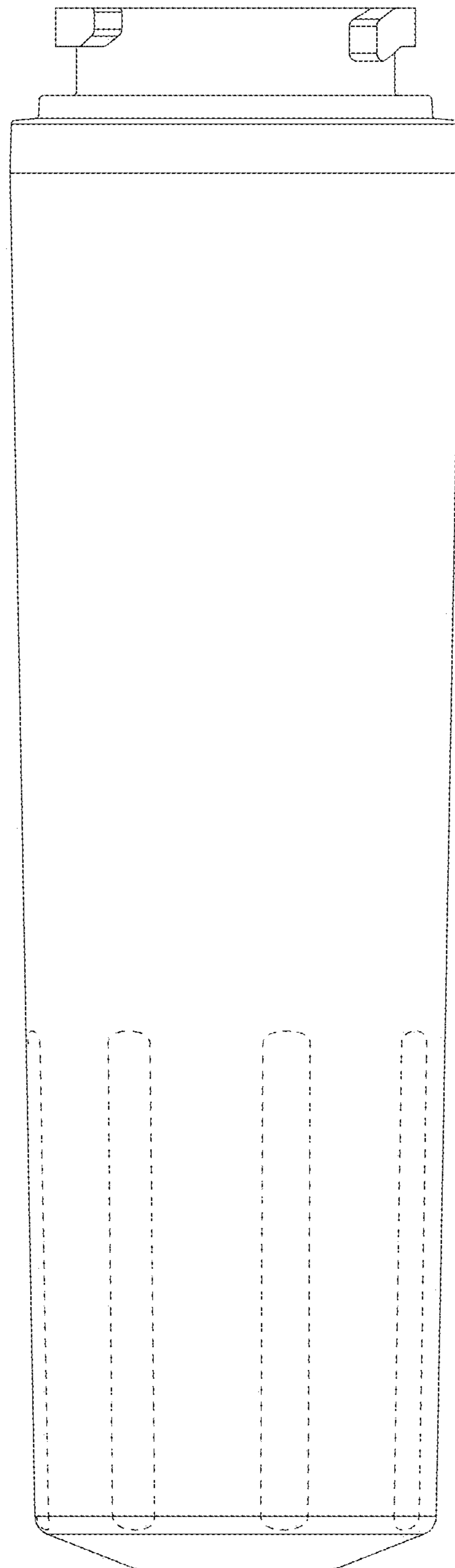

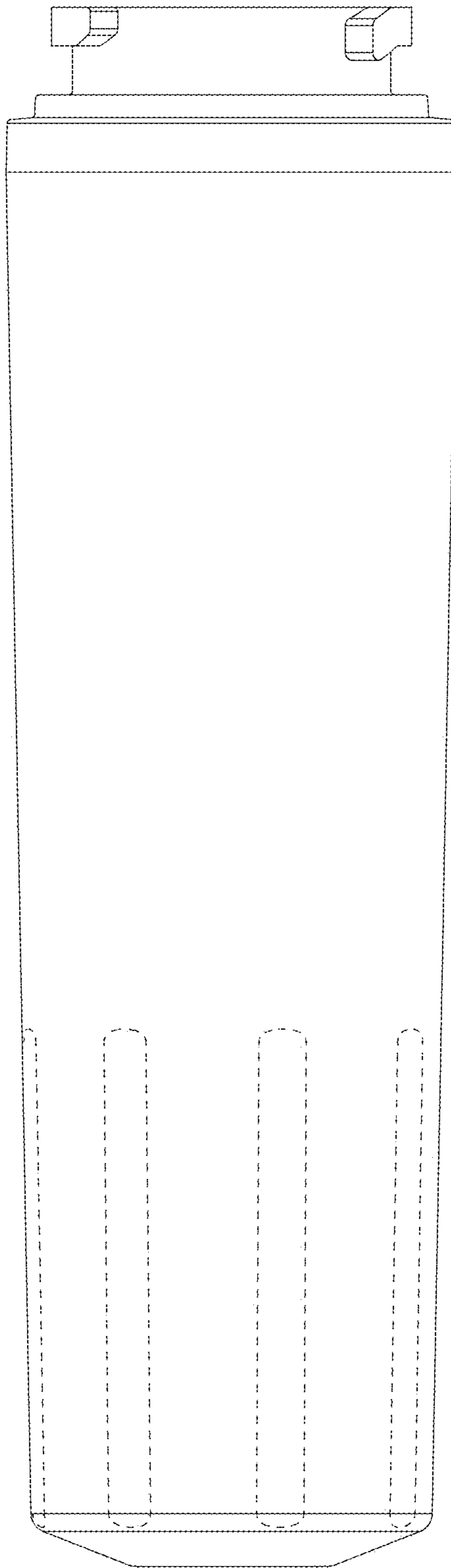

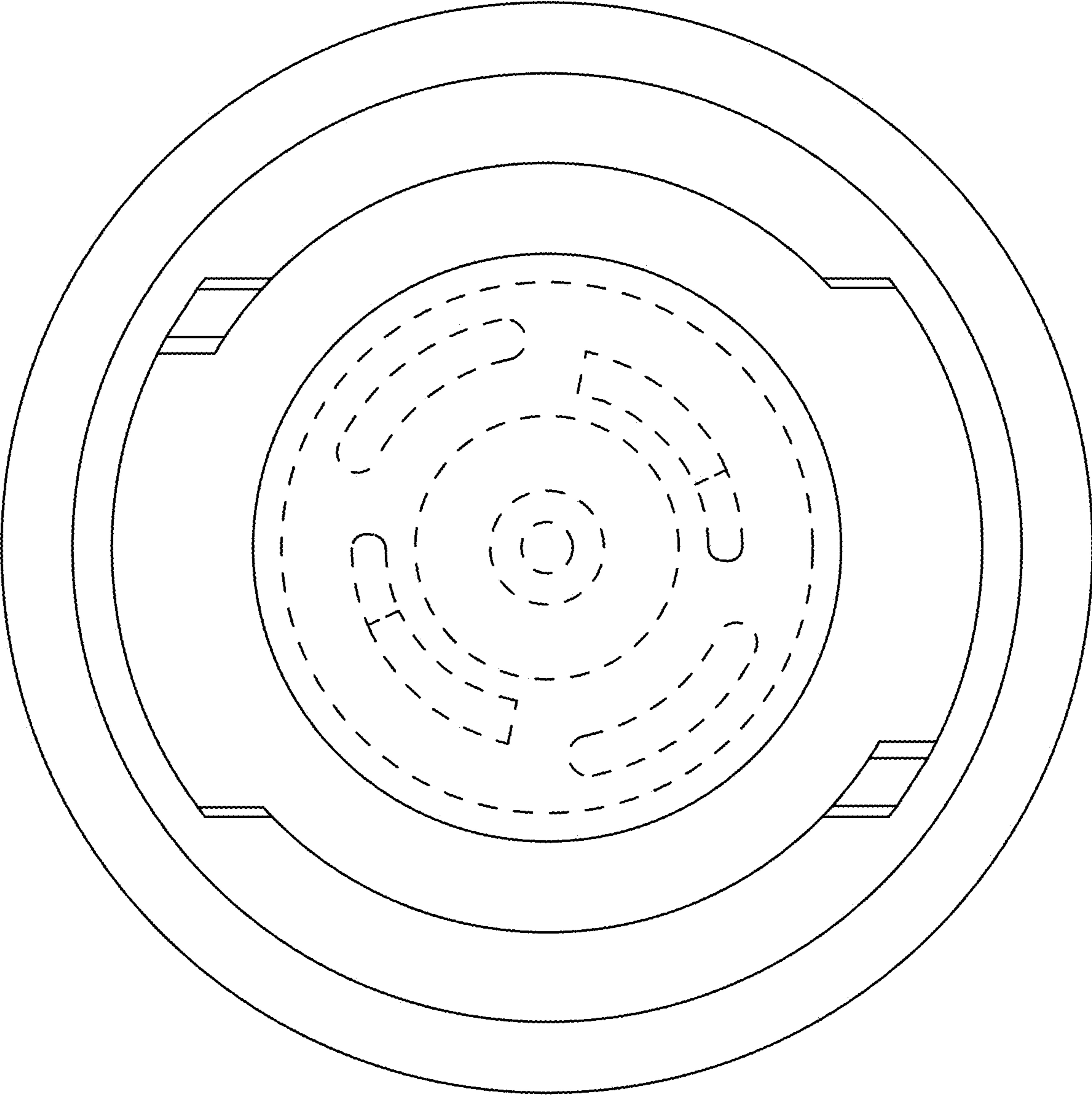

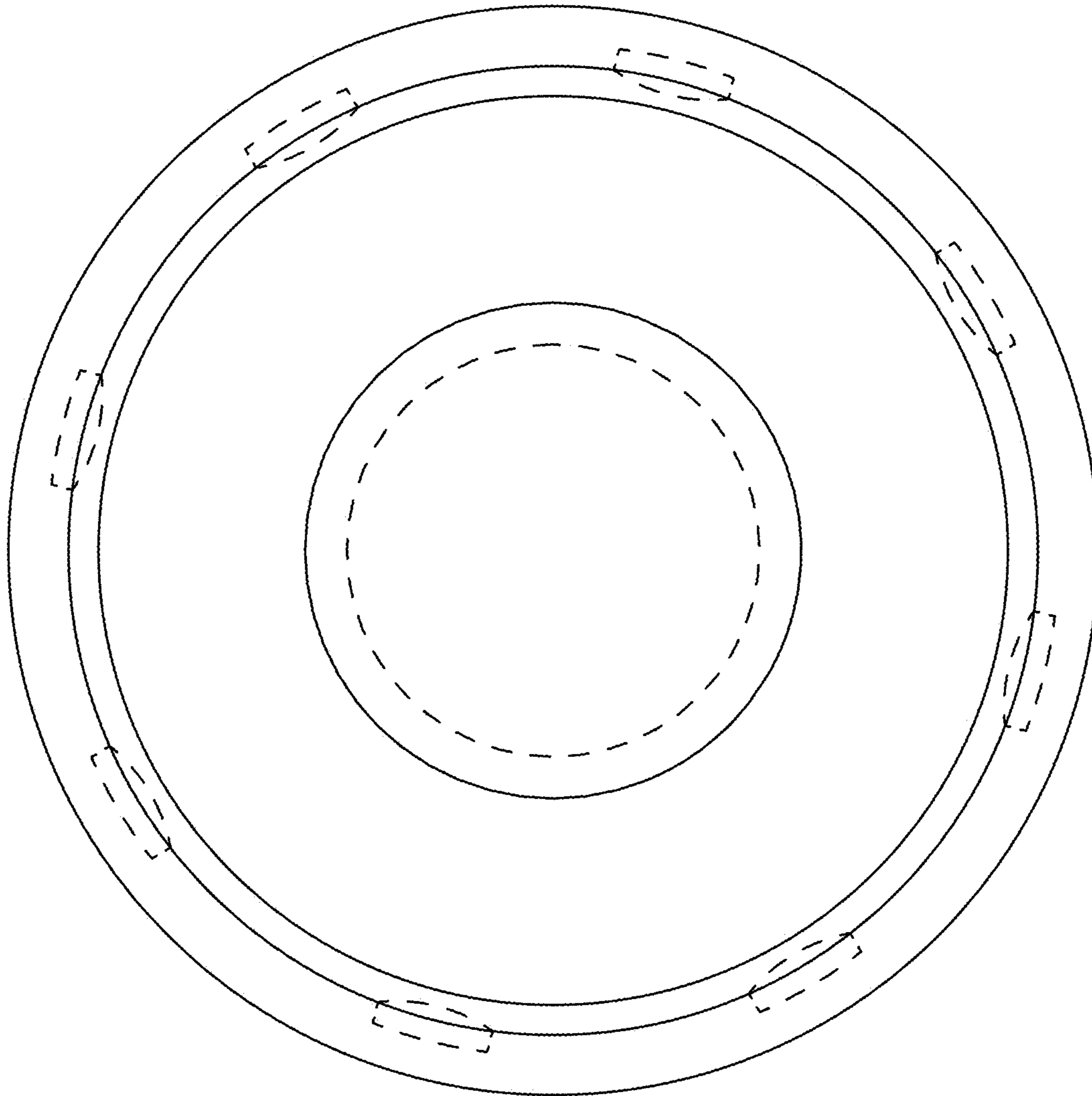

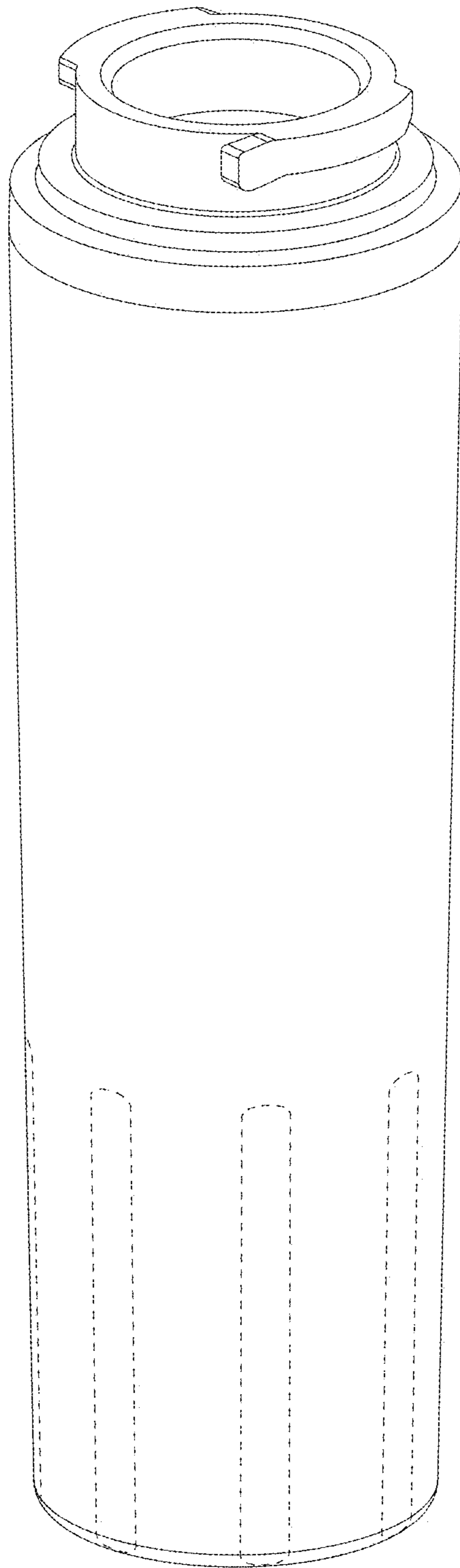
