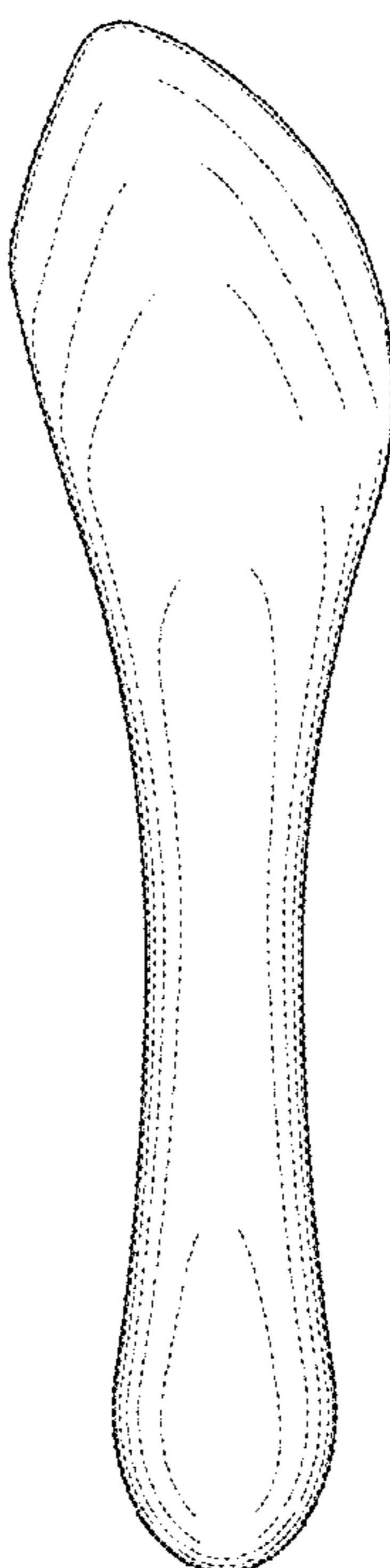

The ornamental design for massage apparatus, as shown and described.

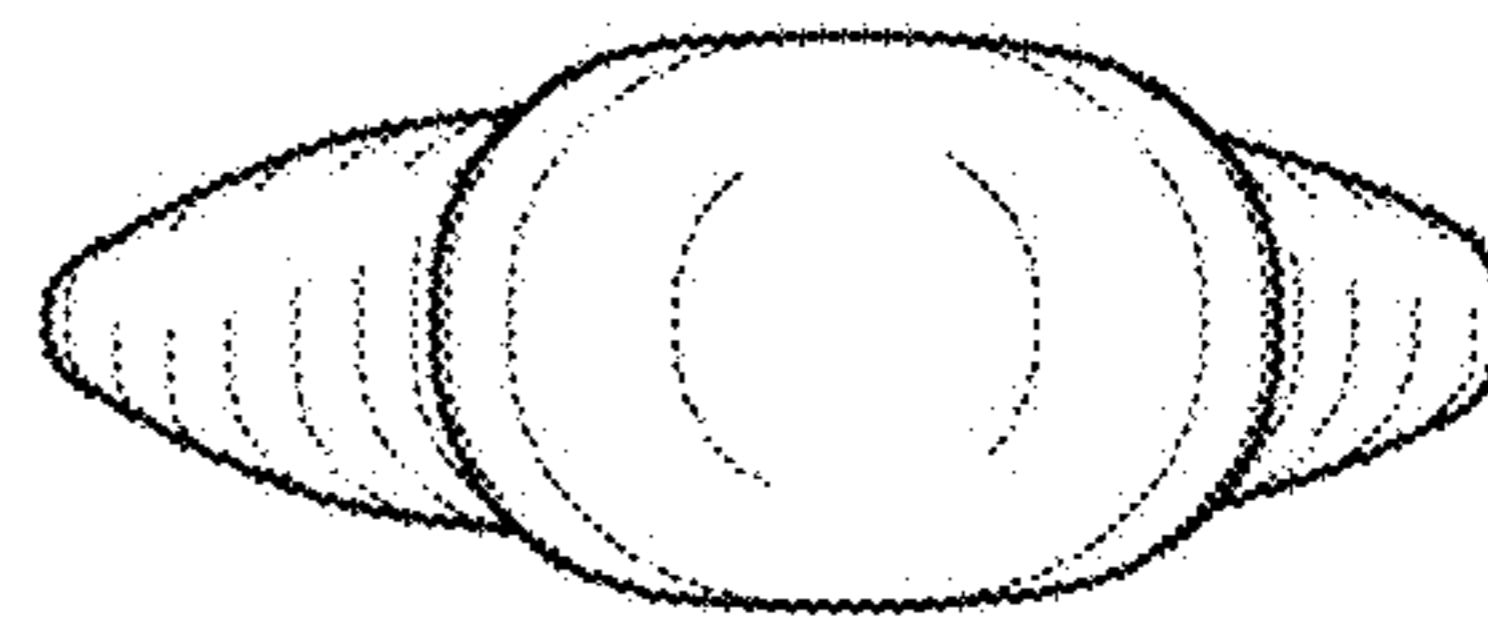
**DESCRIPTION**

Figure 1.9 is another side view thereof.

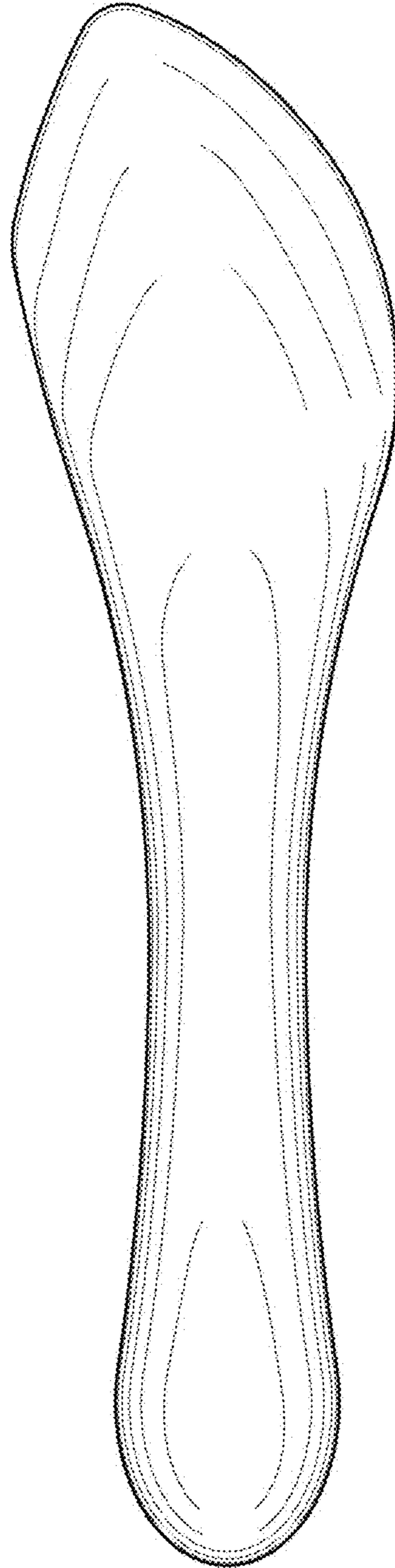

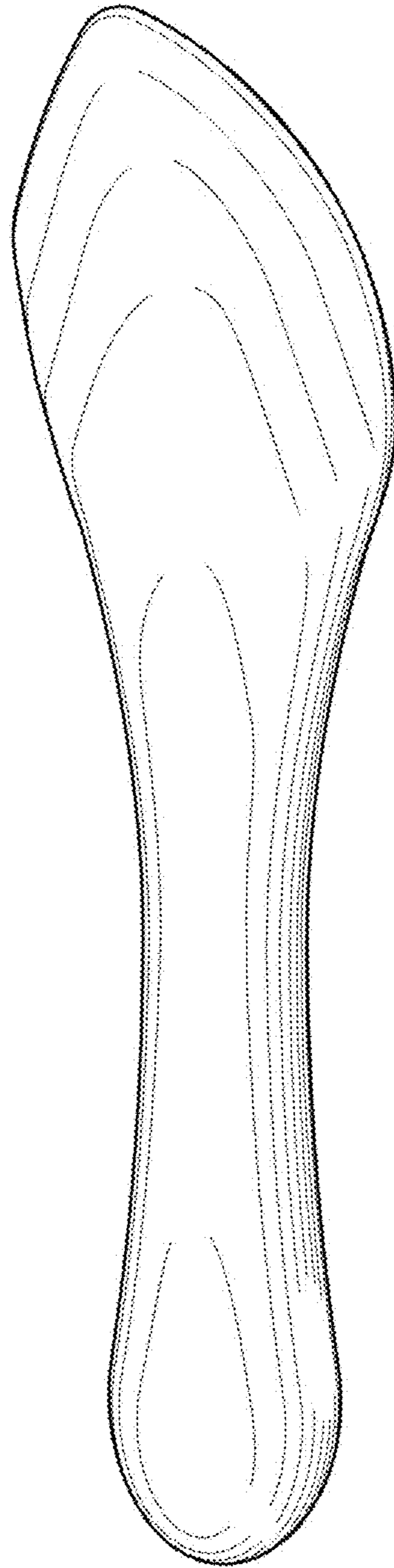

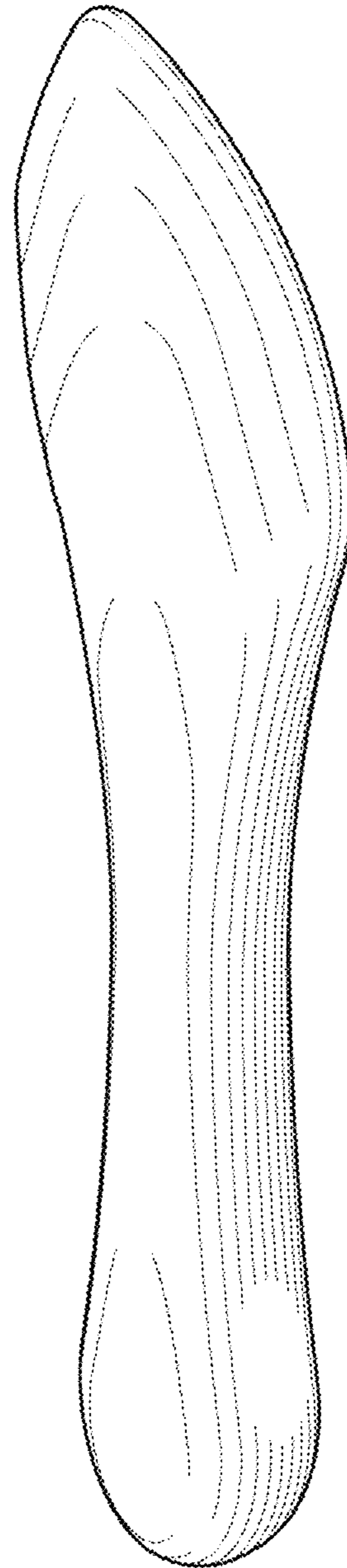

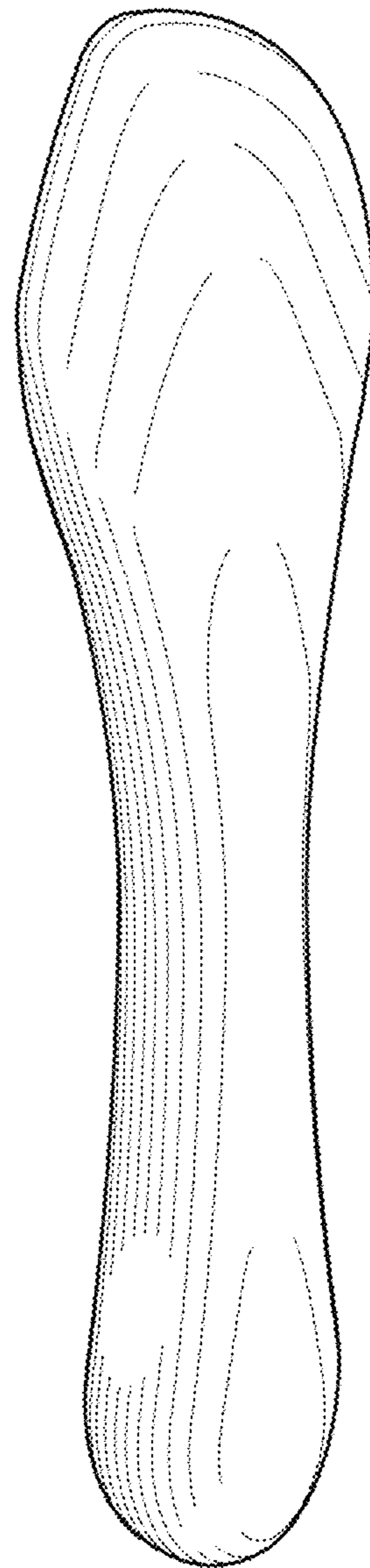

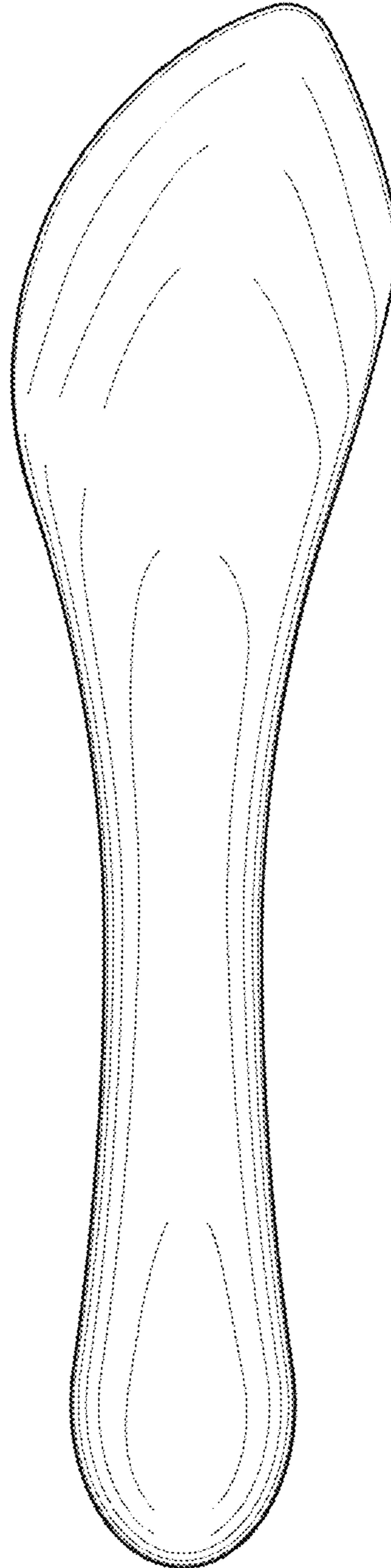

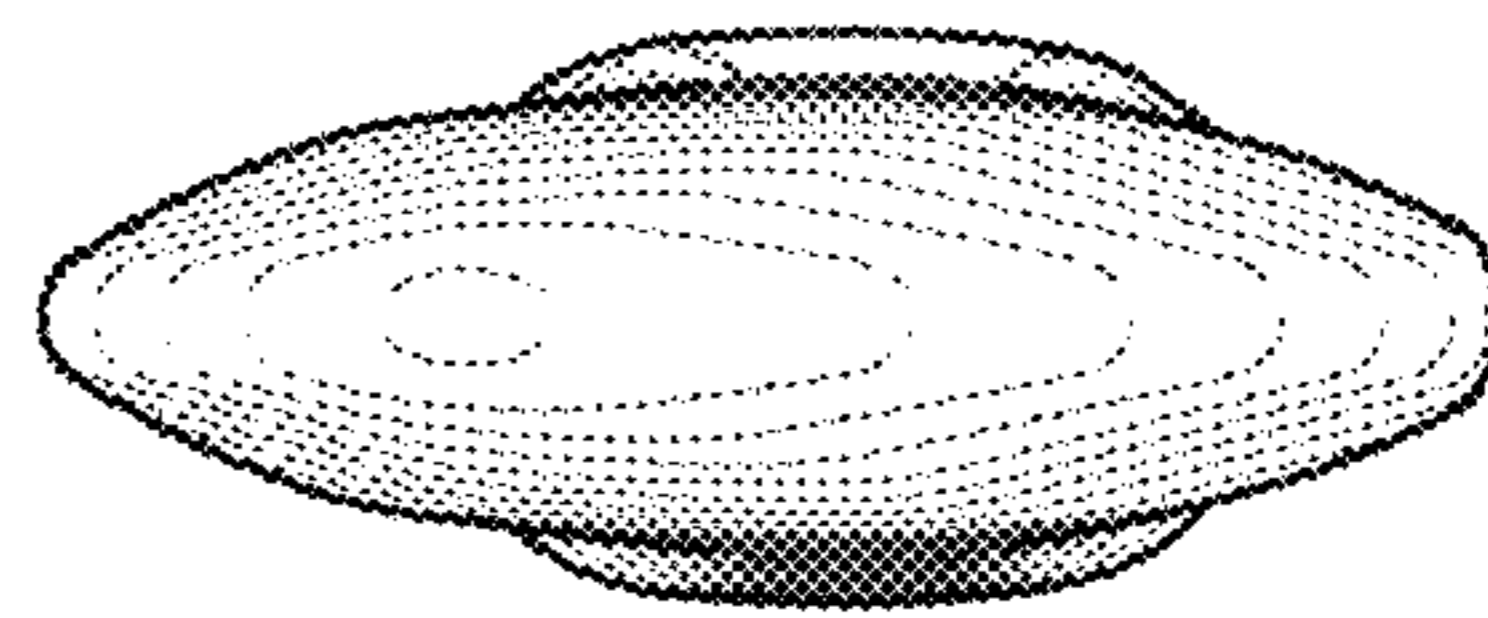
