FIG. 10 is a bottom plan view thereof.

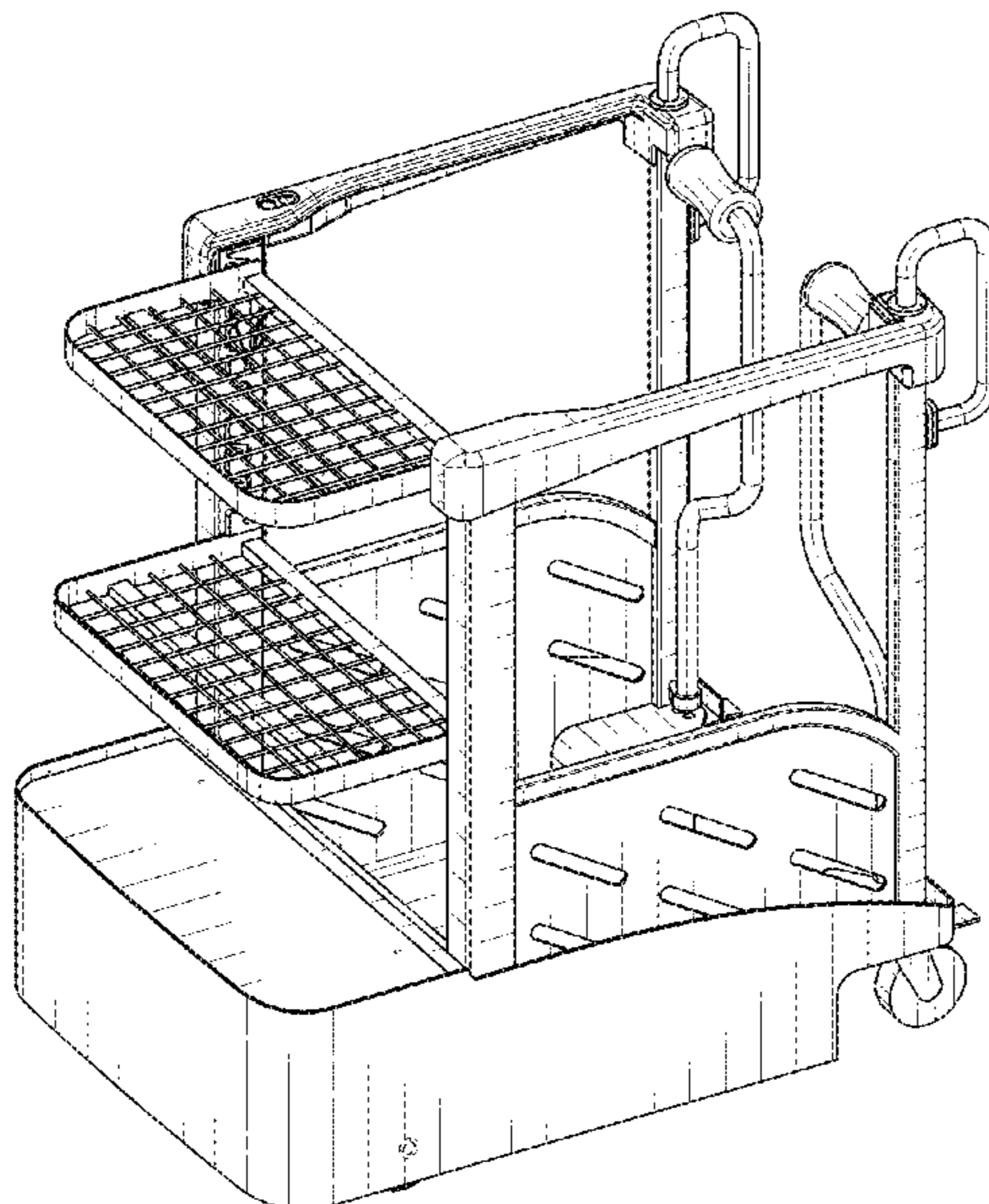

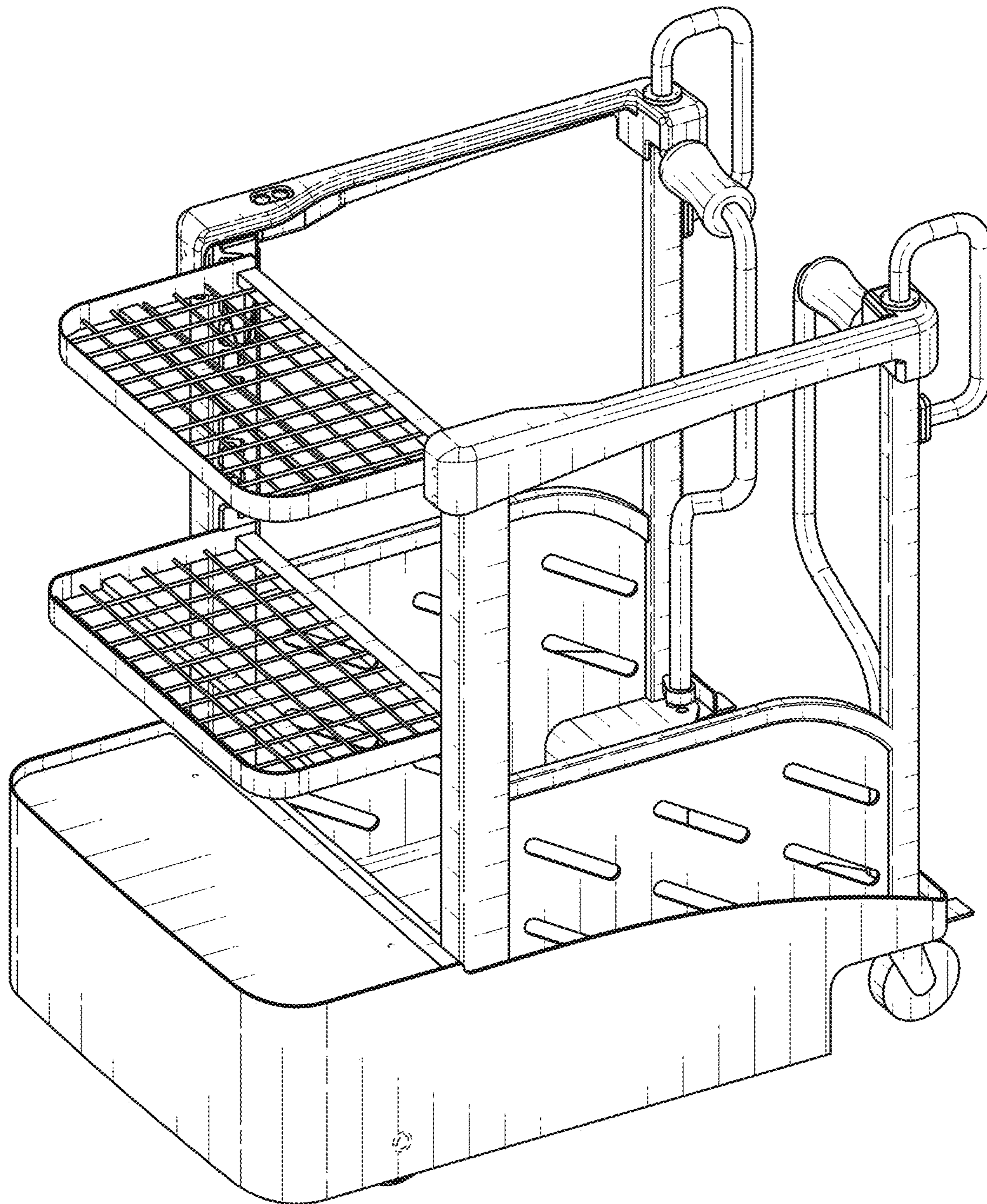

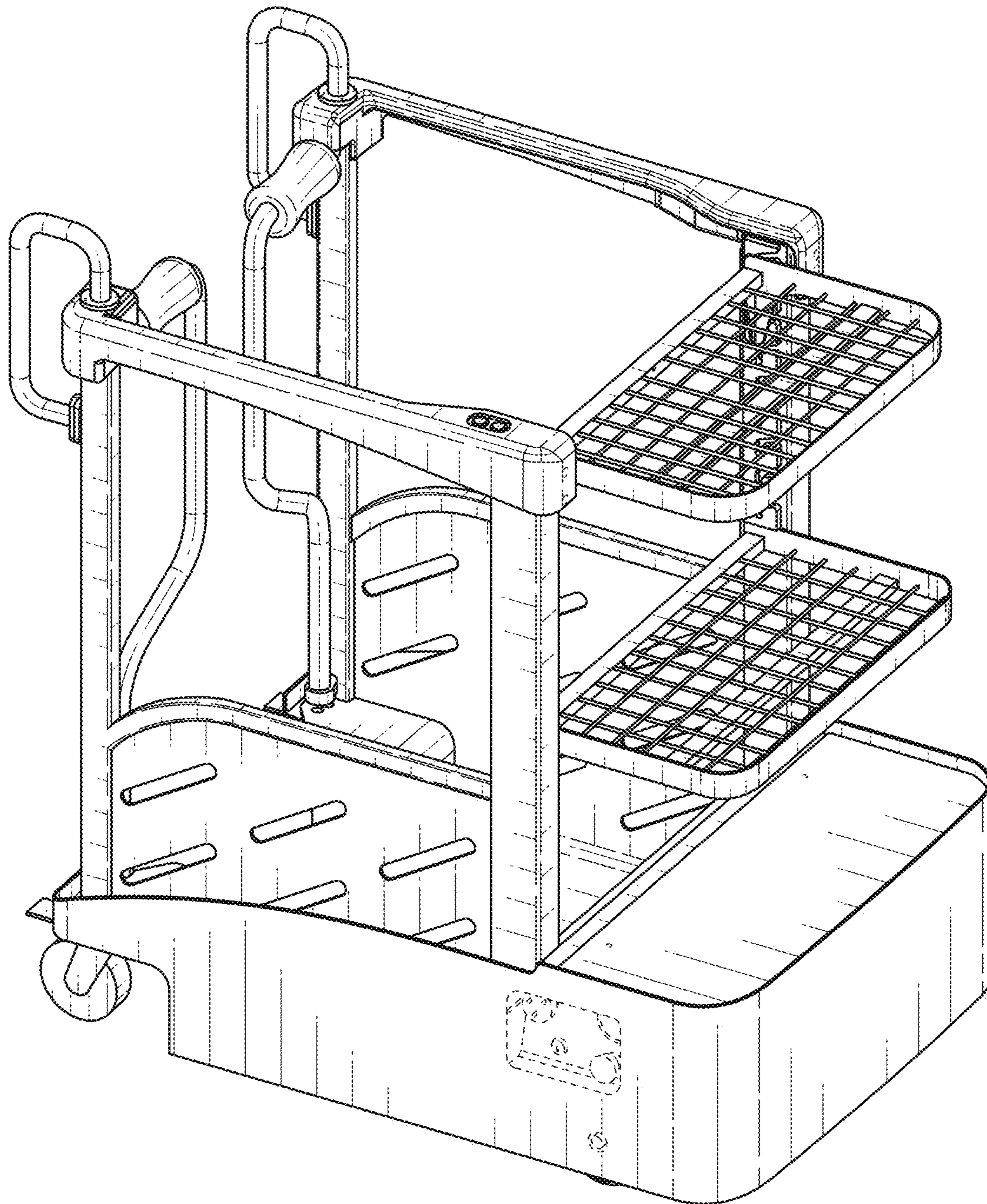

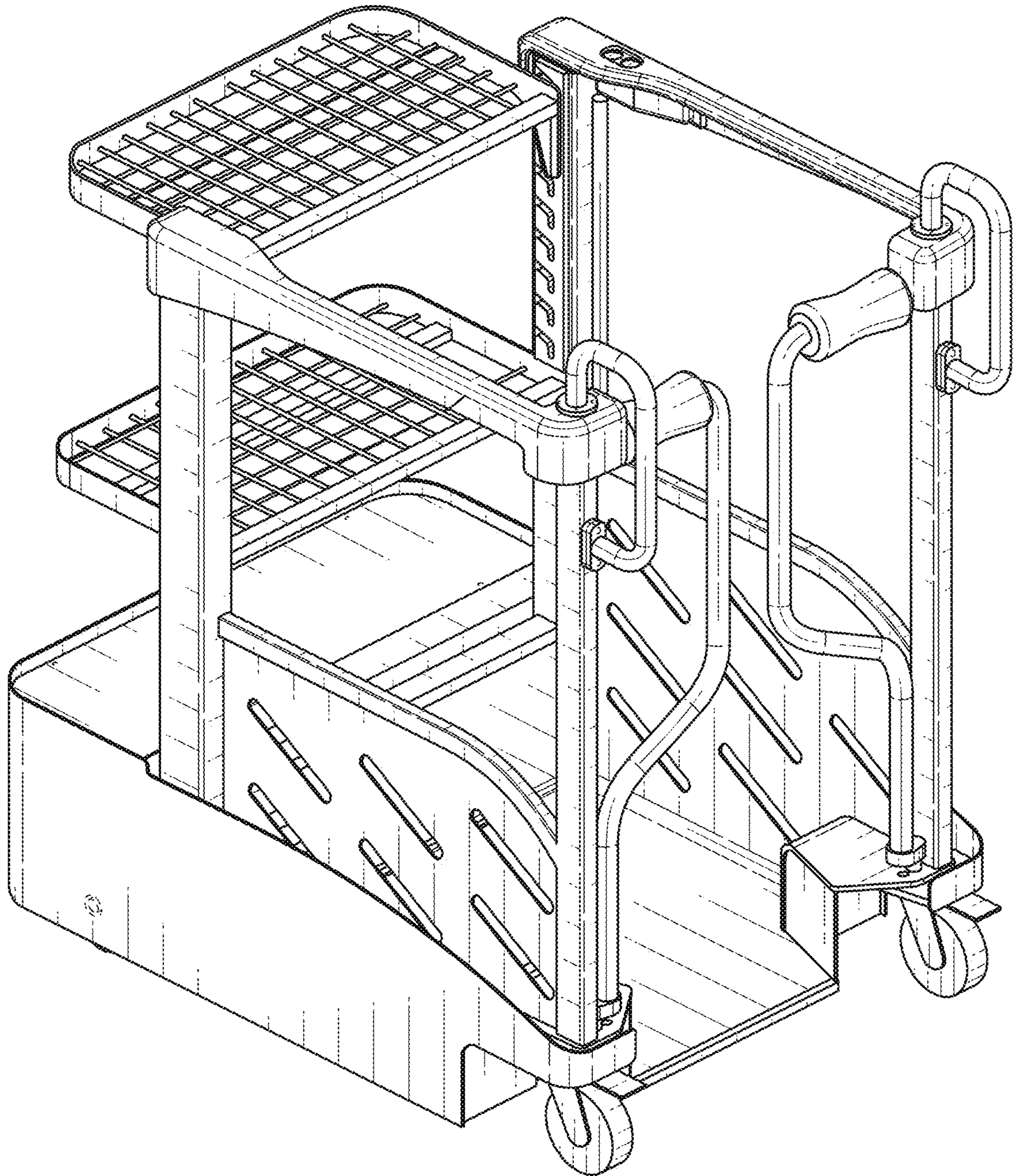

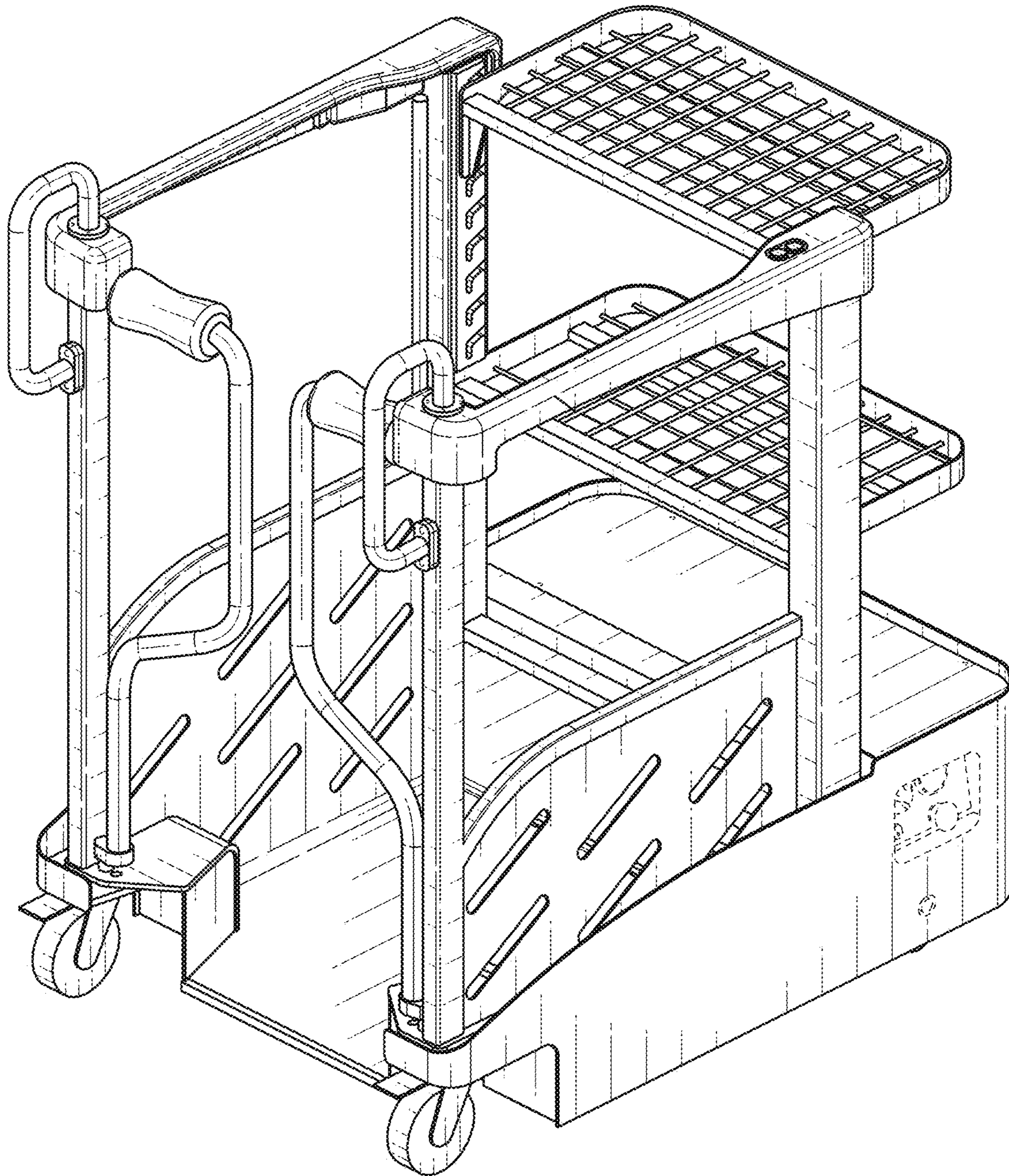

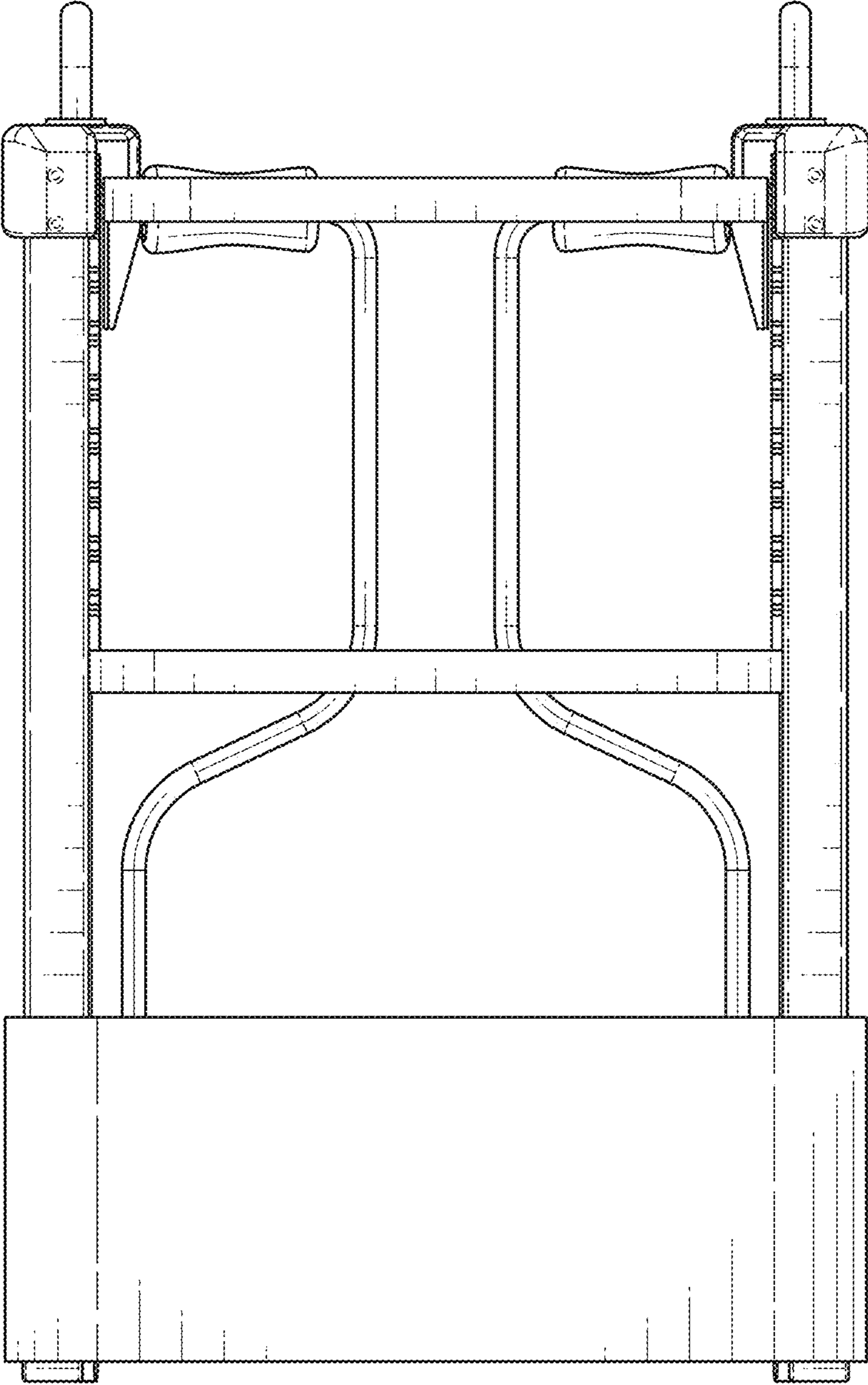

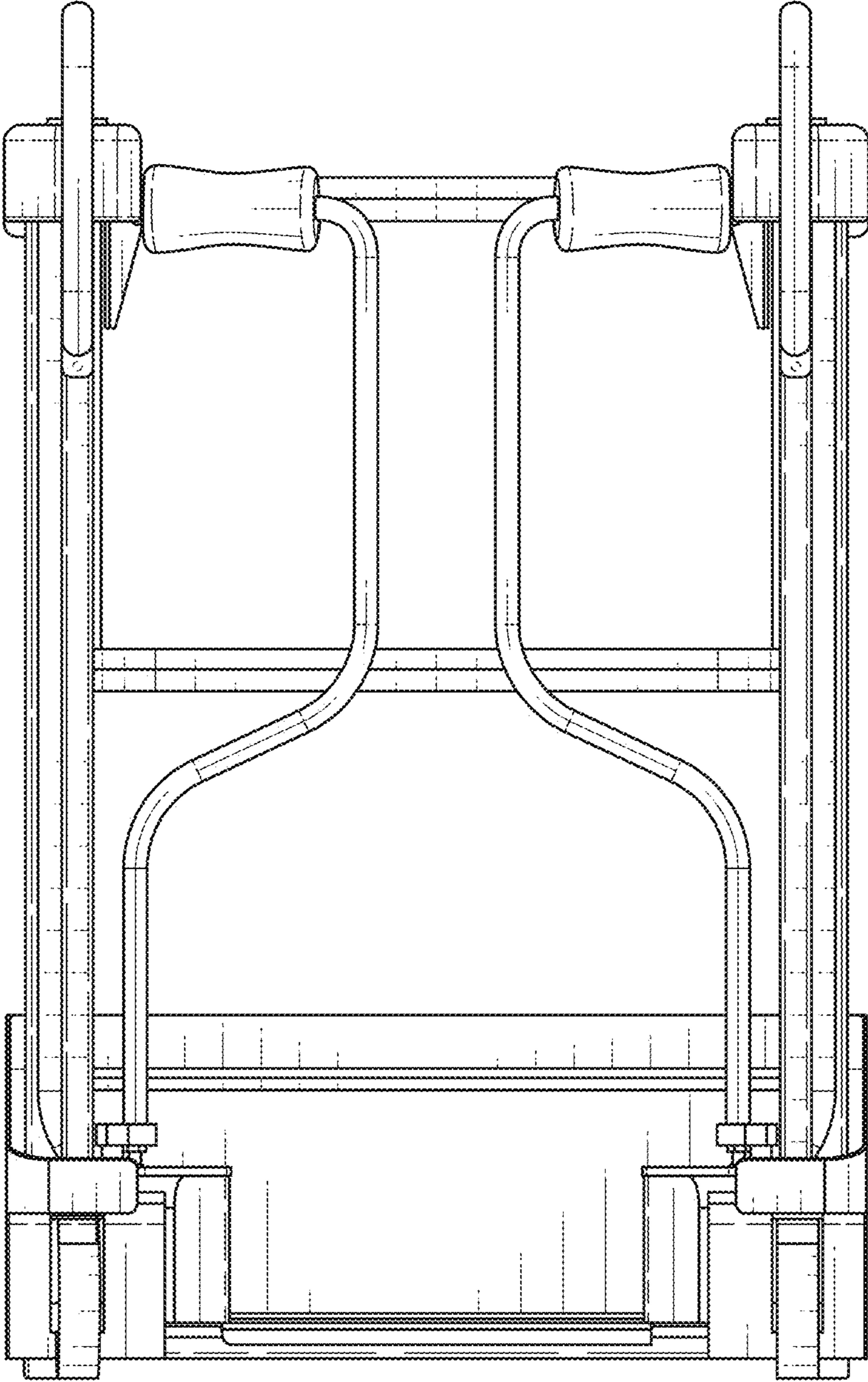

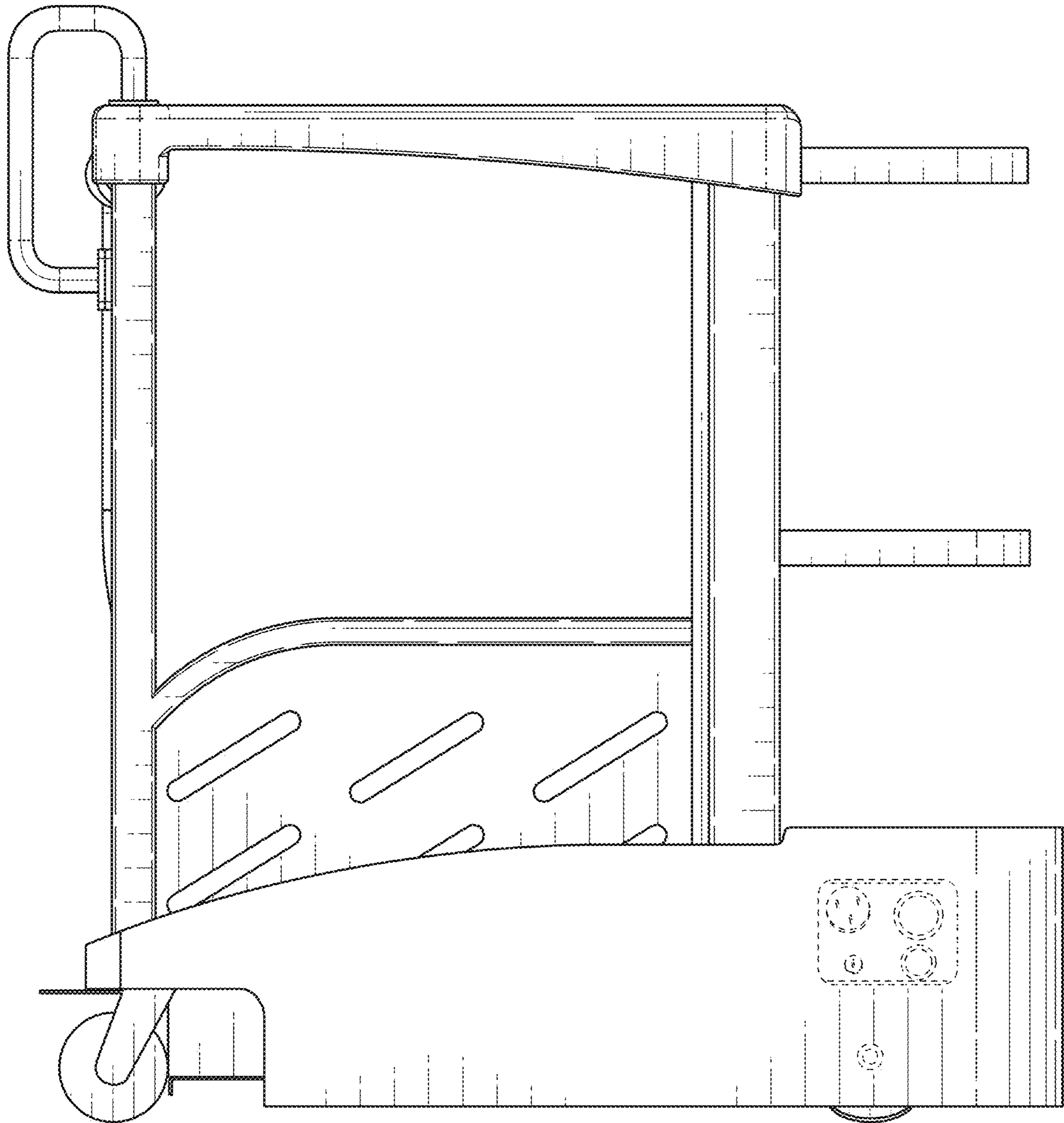

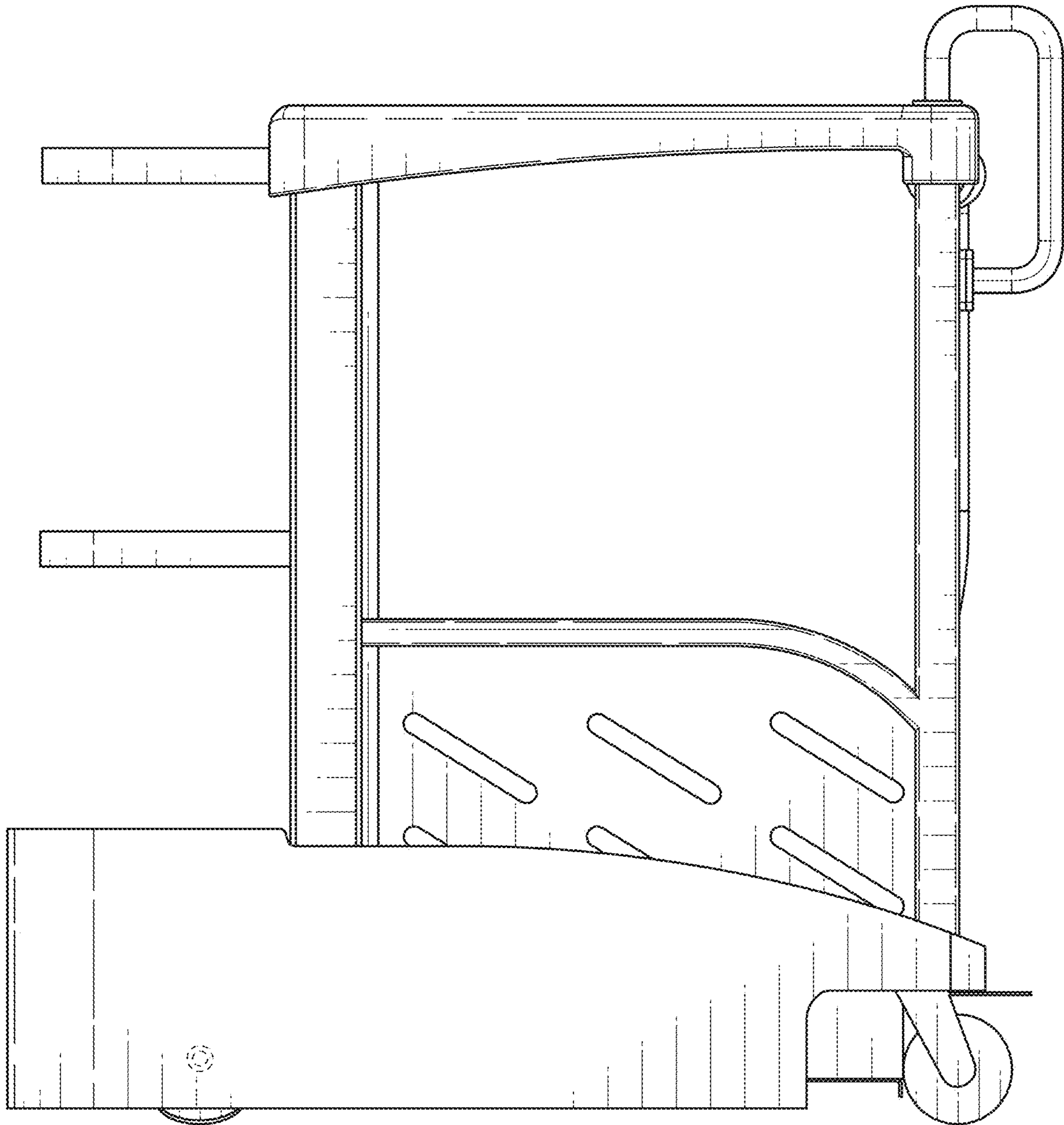

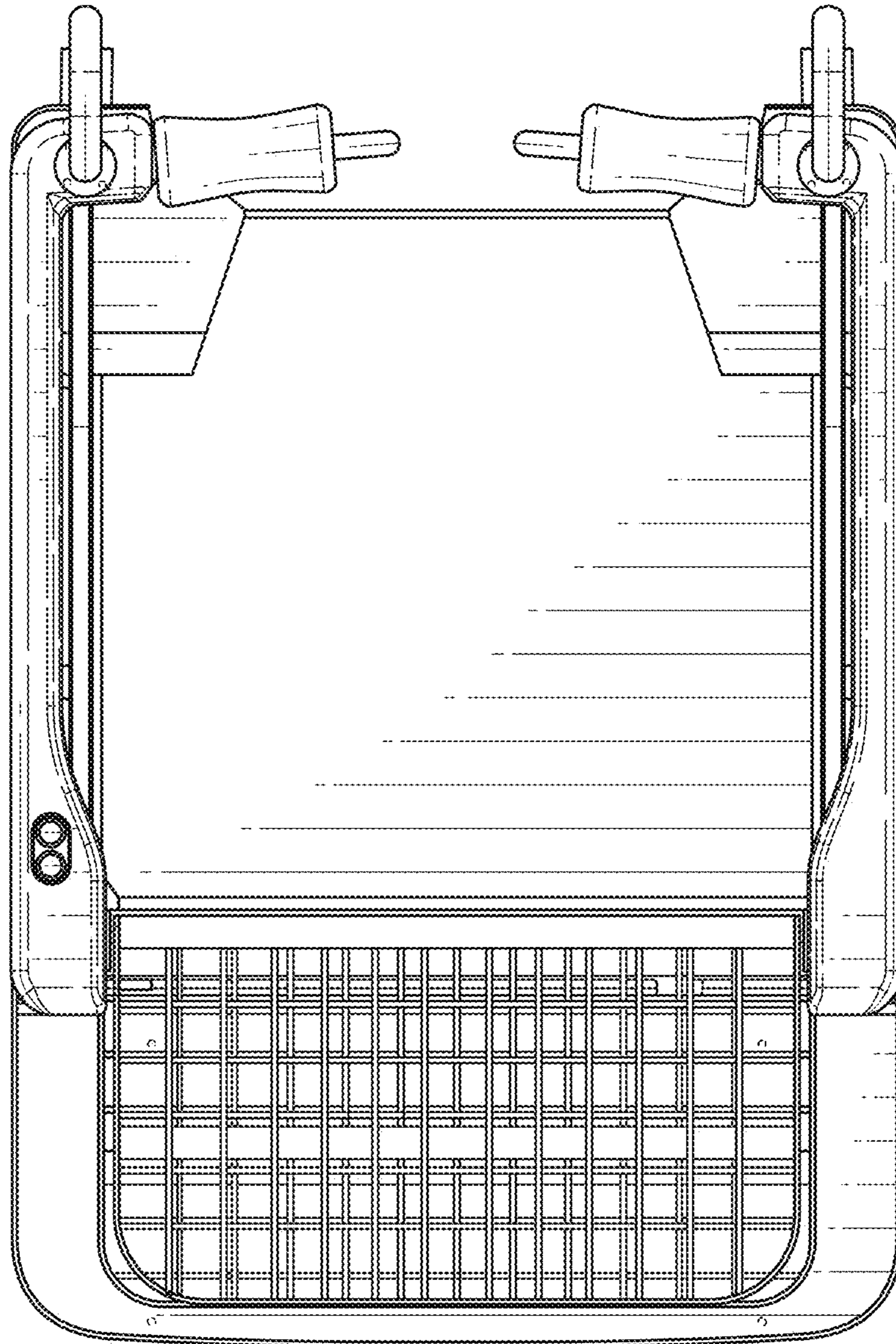

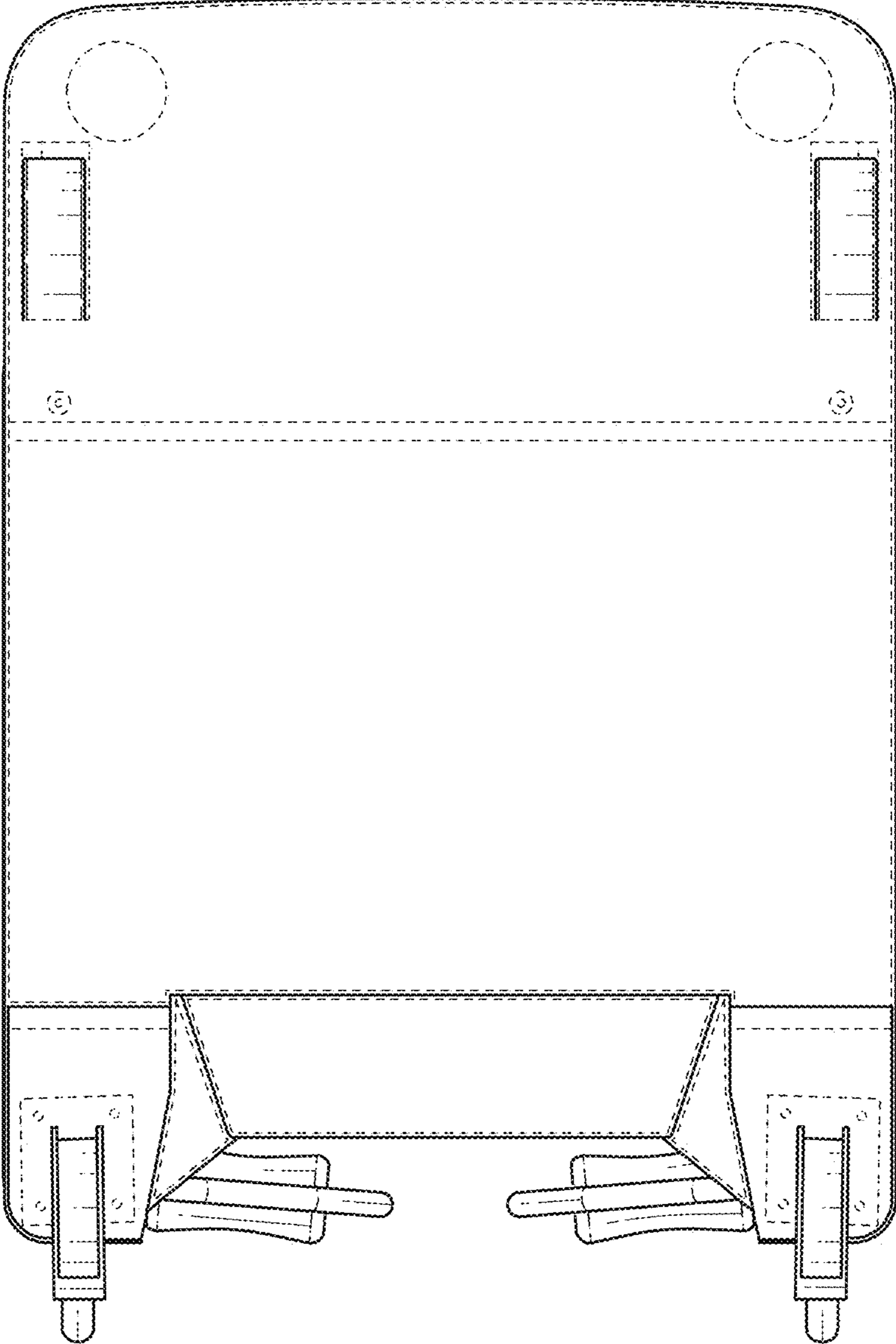
