(57) **CLAIM**

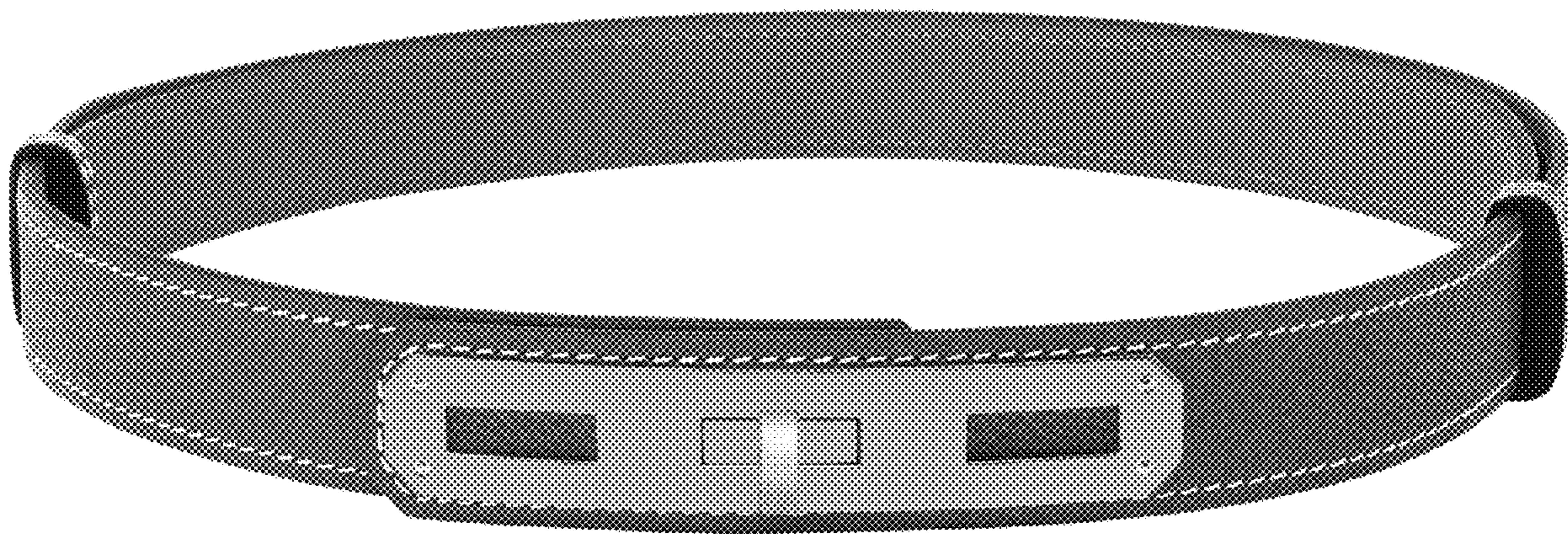
The ornamental design for a belt, as shown and described.

DESCRIPTION

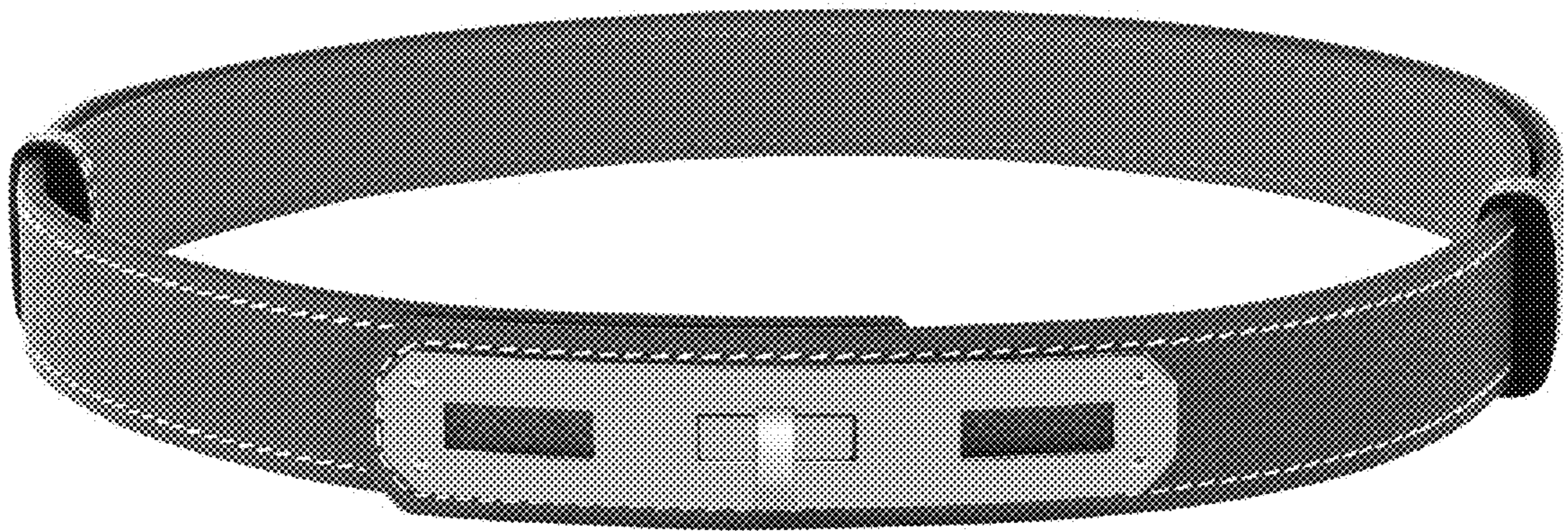
1.1 is a front perspective view of a belt of the claimed design;
1.2 is a front elevational view of the belt shown in FIG. **1.1**;
1.3 is a rear elevational view of the belt shown in FIG. **1.1**;
1.4 is a right elevational view of the belt shown in FIG. **1.1**;
1.5 is a left elevational view of the belt shown in FIG. **1.1**;
1.6 is a top plan view of the belt shown in FIG. **1.1**;
1.7 is a bottom plan view of the belt shown in FIG. **1.1**; and
1.8 is a perspective of the belt shown in FIG. **1.1** in an alternate configuration.

The claimed design is shown in solid lines in the figures. The broken lines represent stitching and form no part of the claimed design.

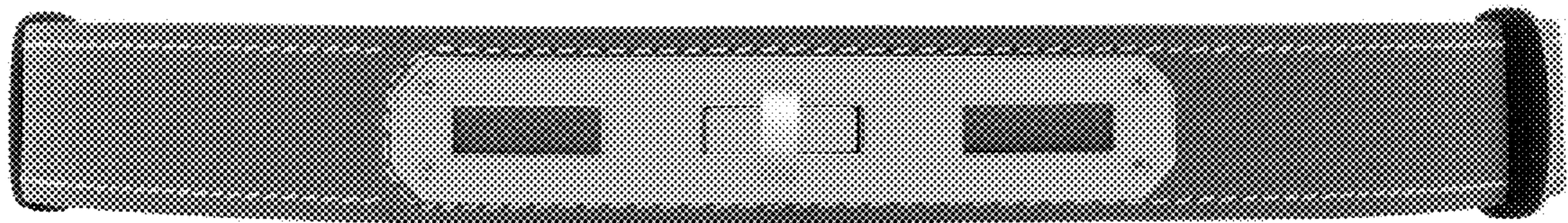

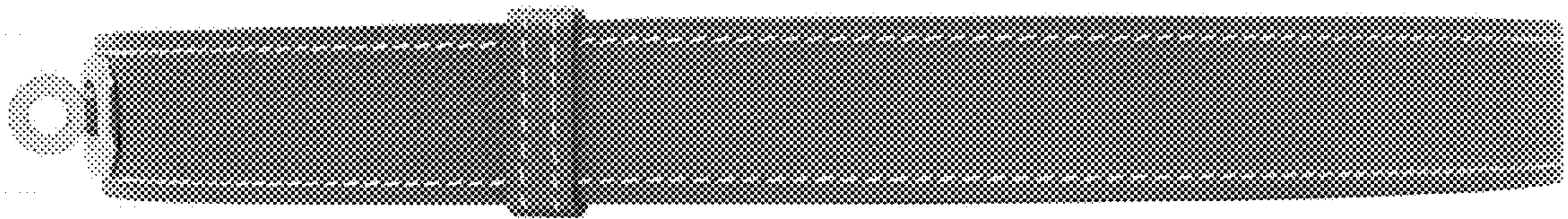

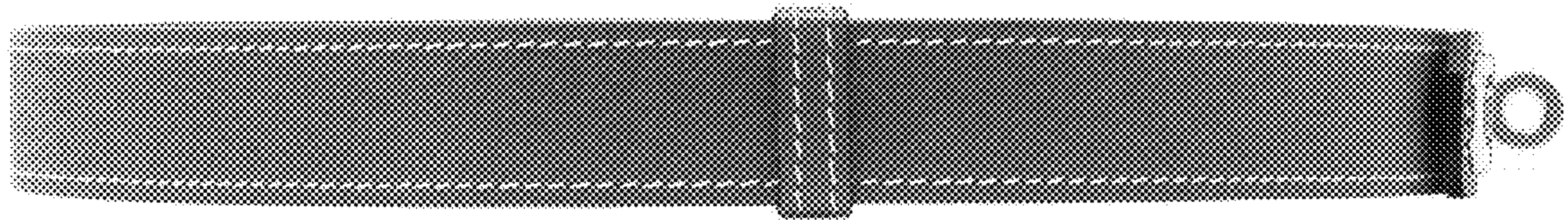
