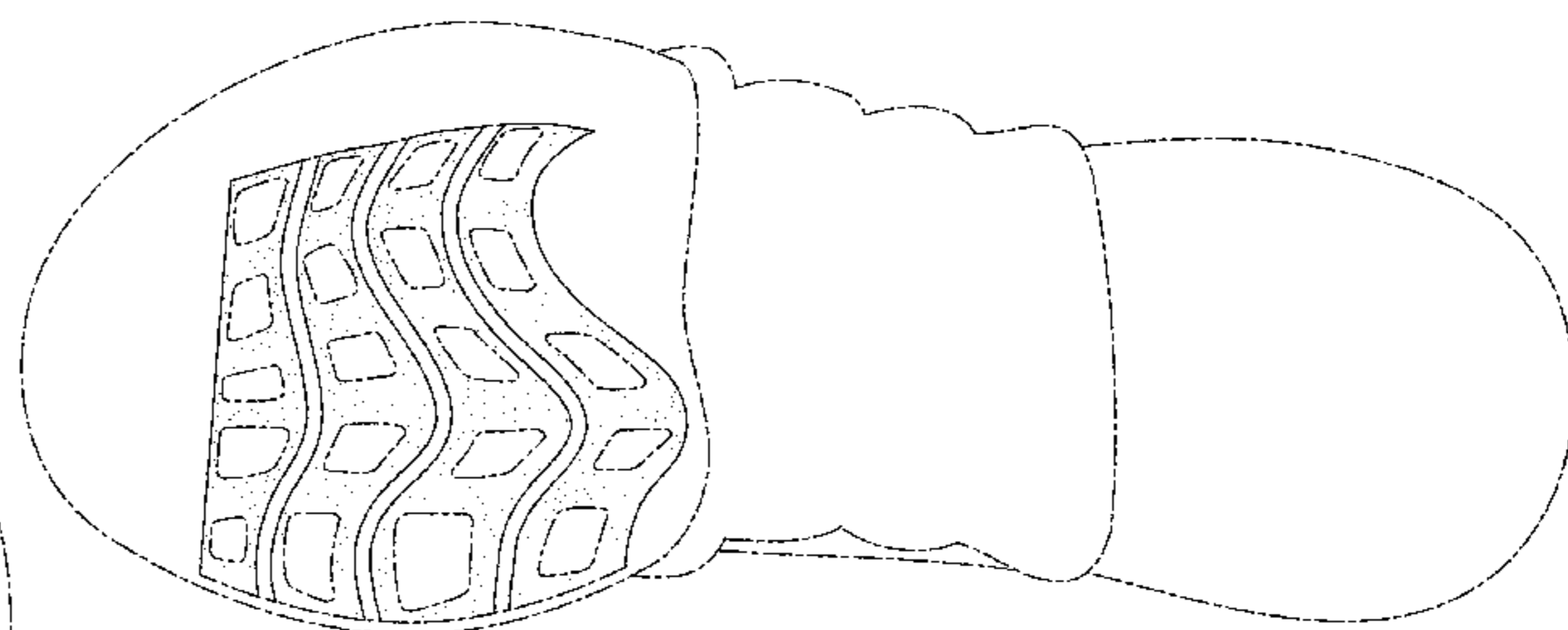
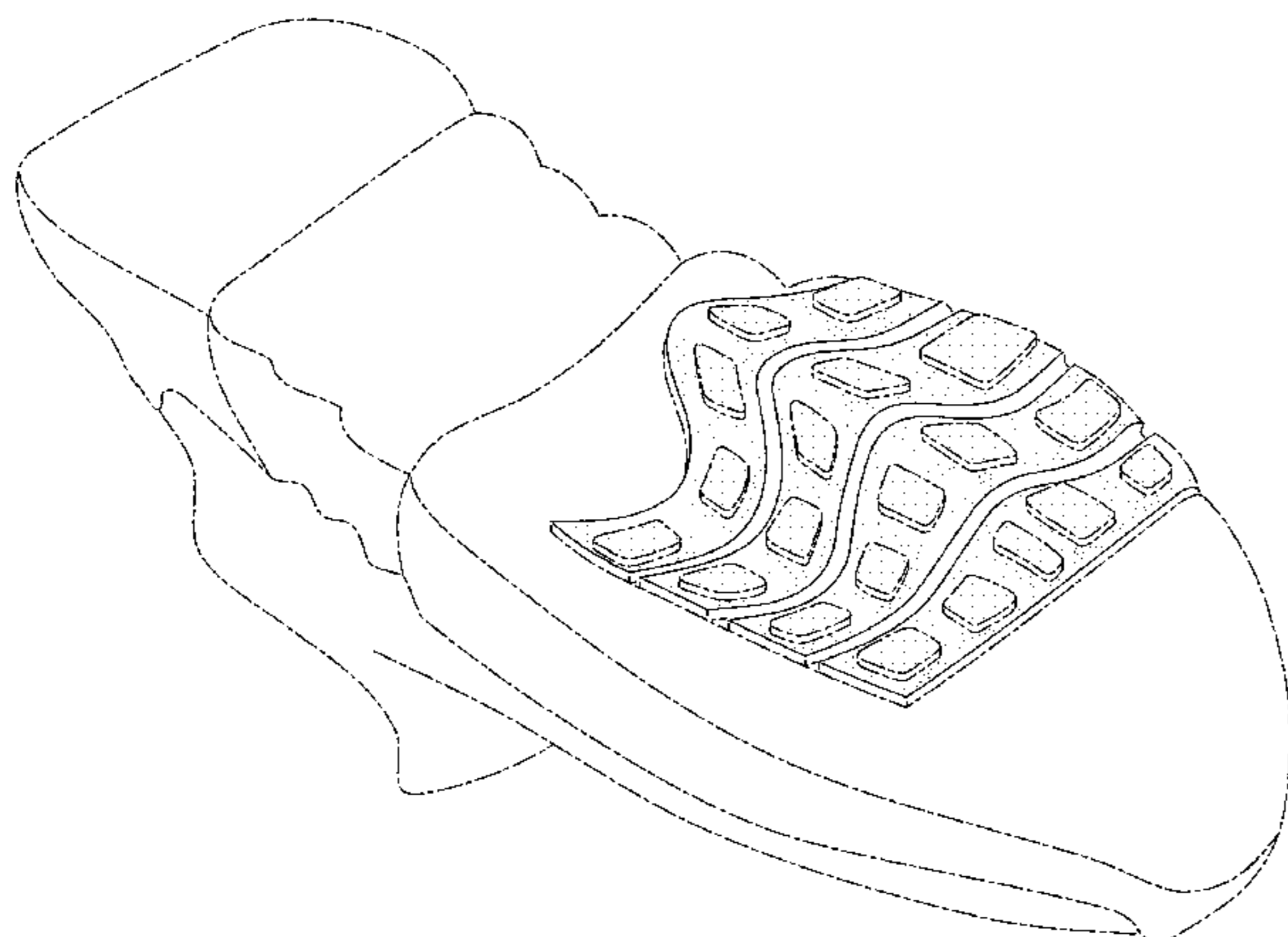
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front bottom perspective view of a shoe showing our new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a second front bottom perspective view thereof.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The twenty unshaded broken line polygons within the shaded area form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

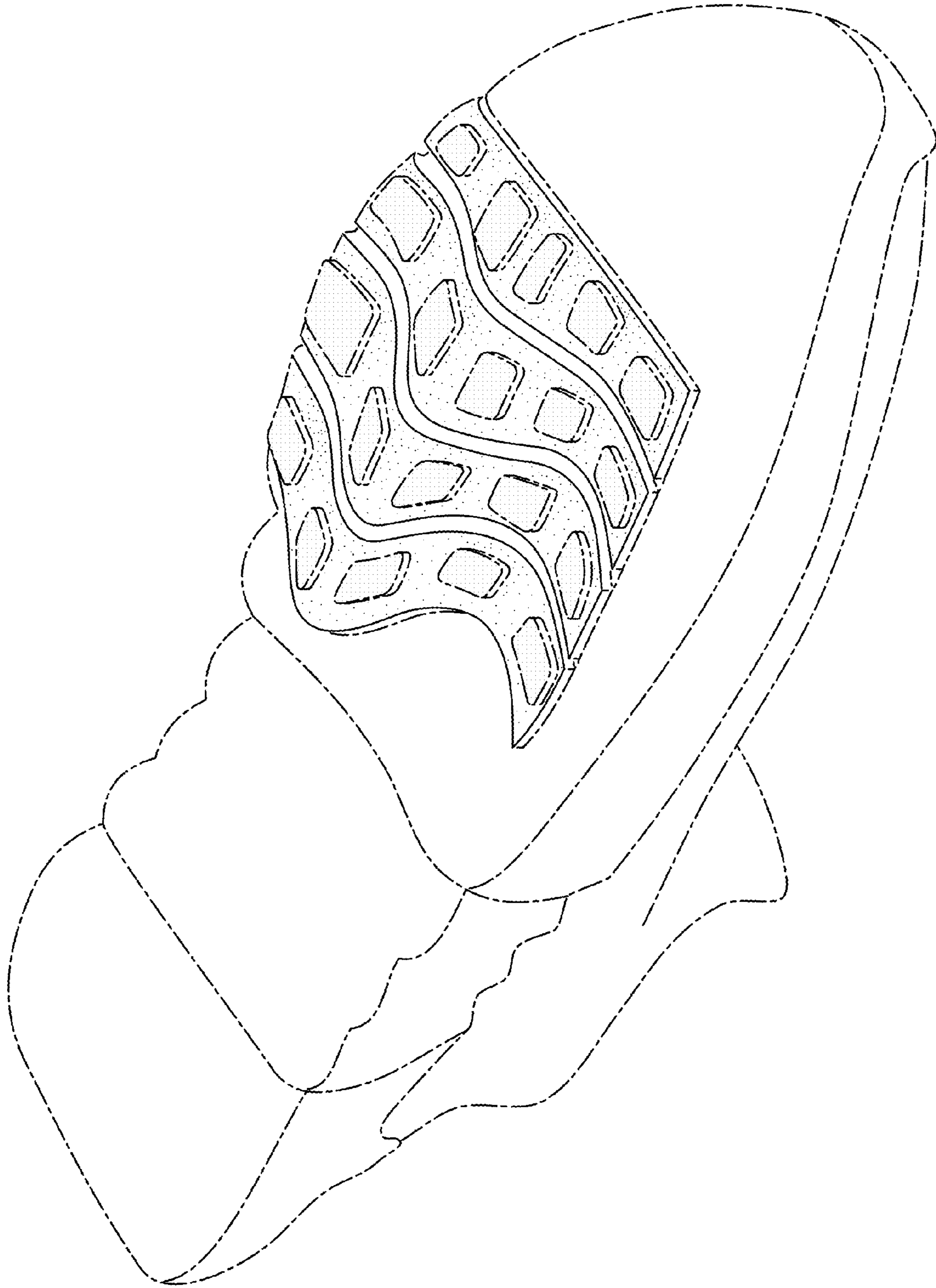

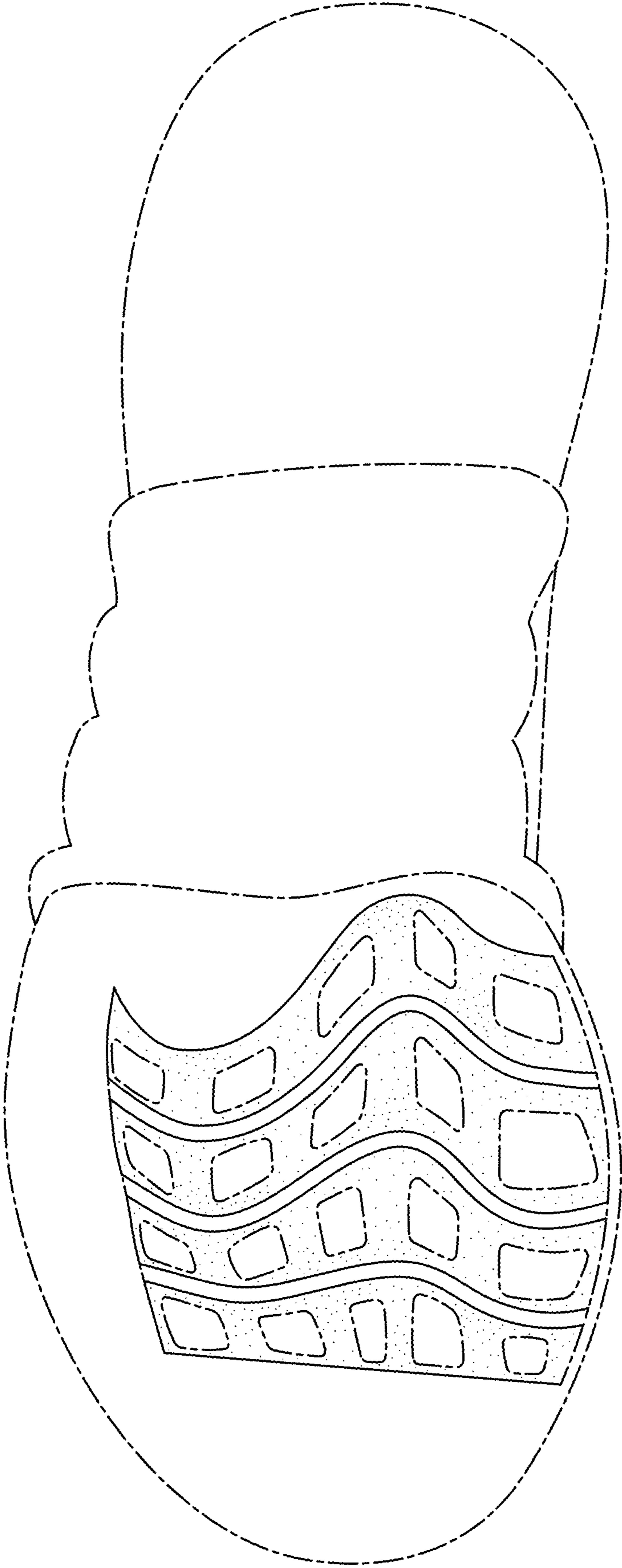

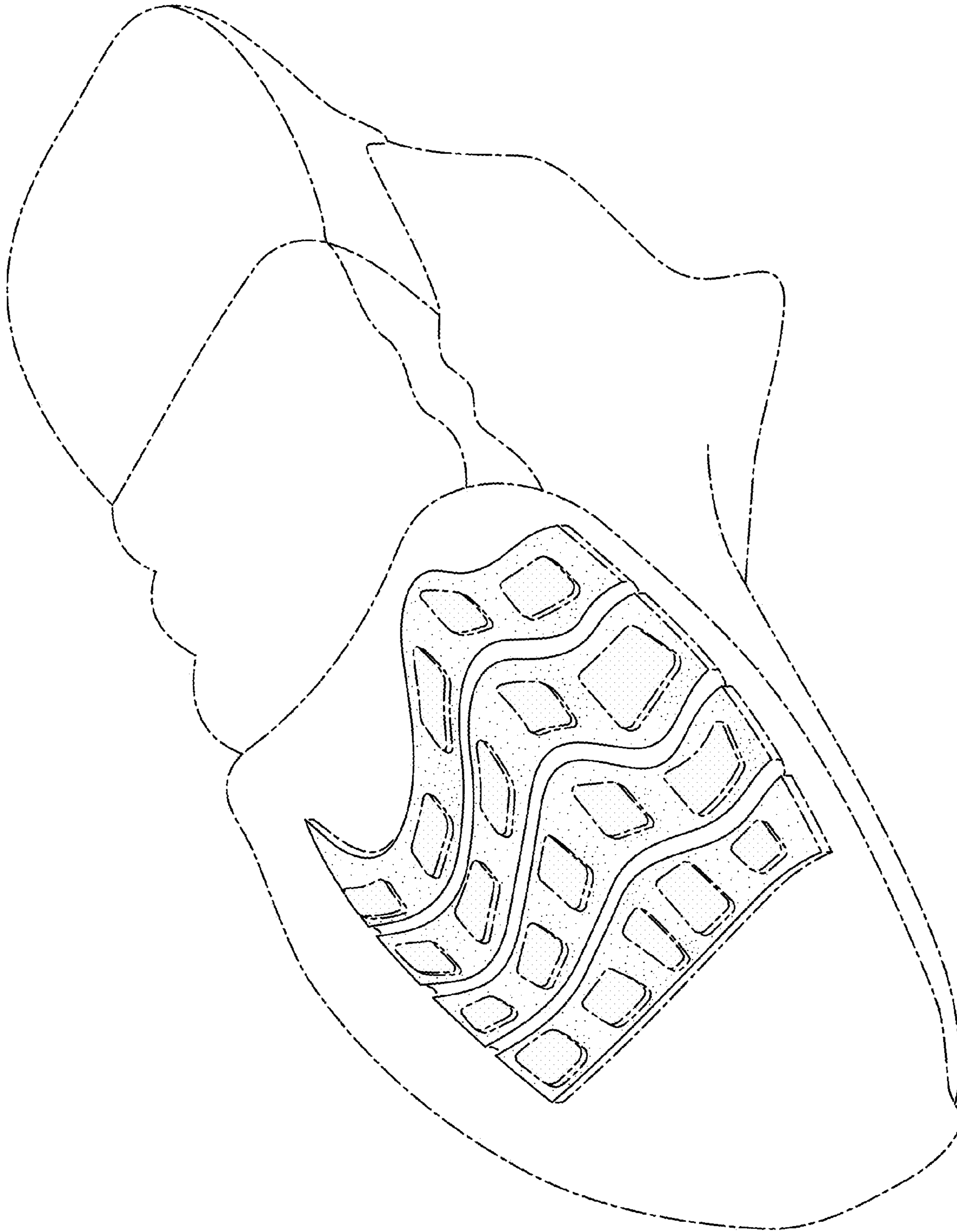
