FIG. 1 is a bottom perspective view of the sole for safety shoe;

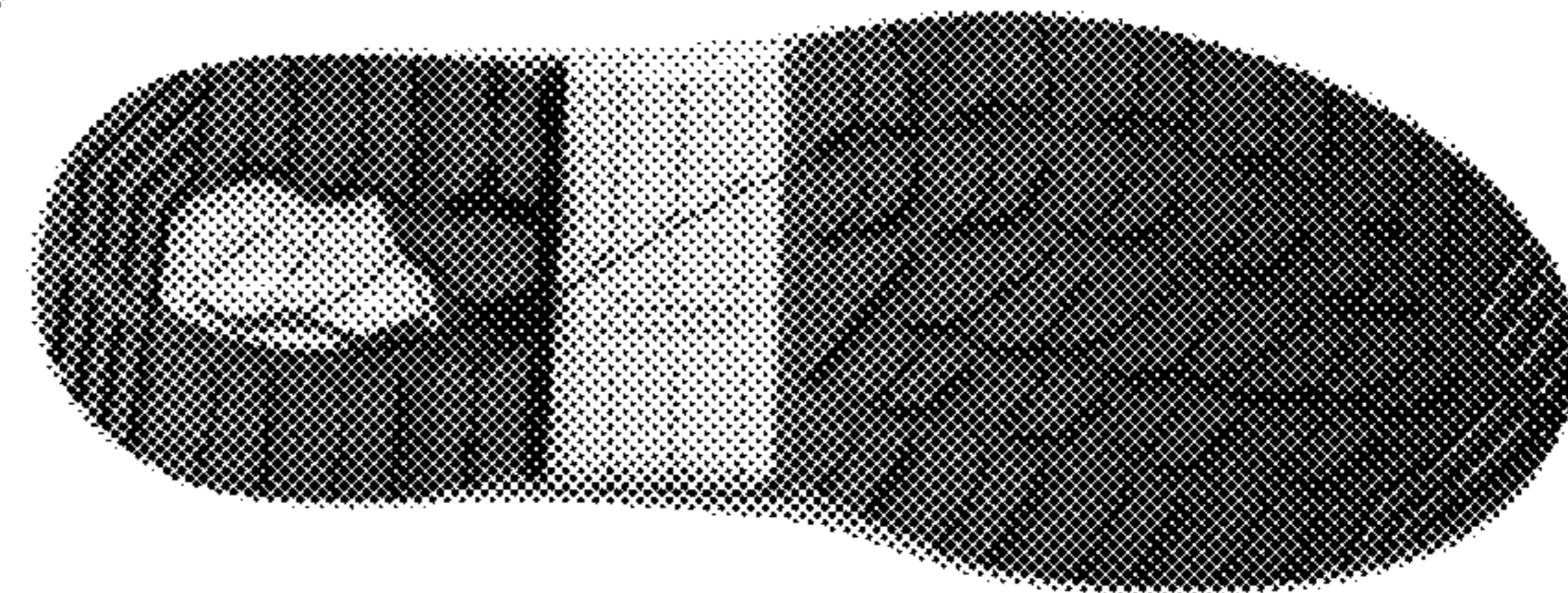
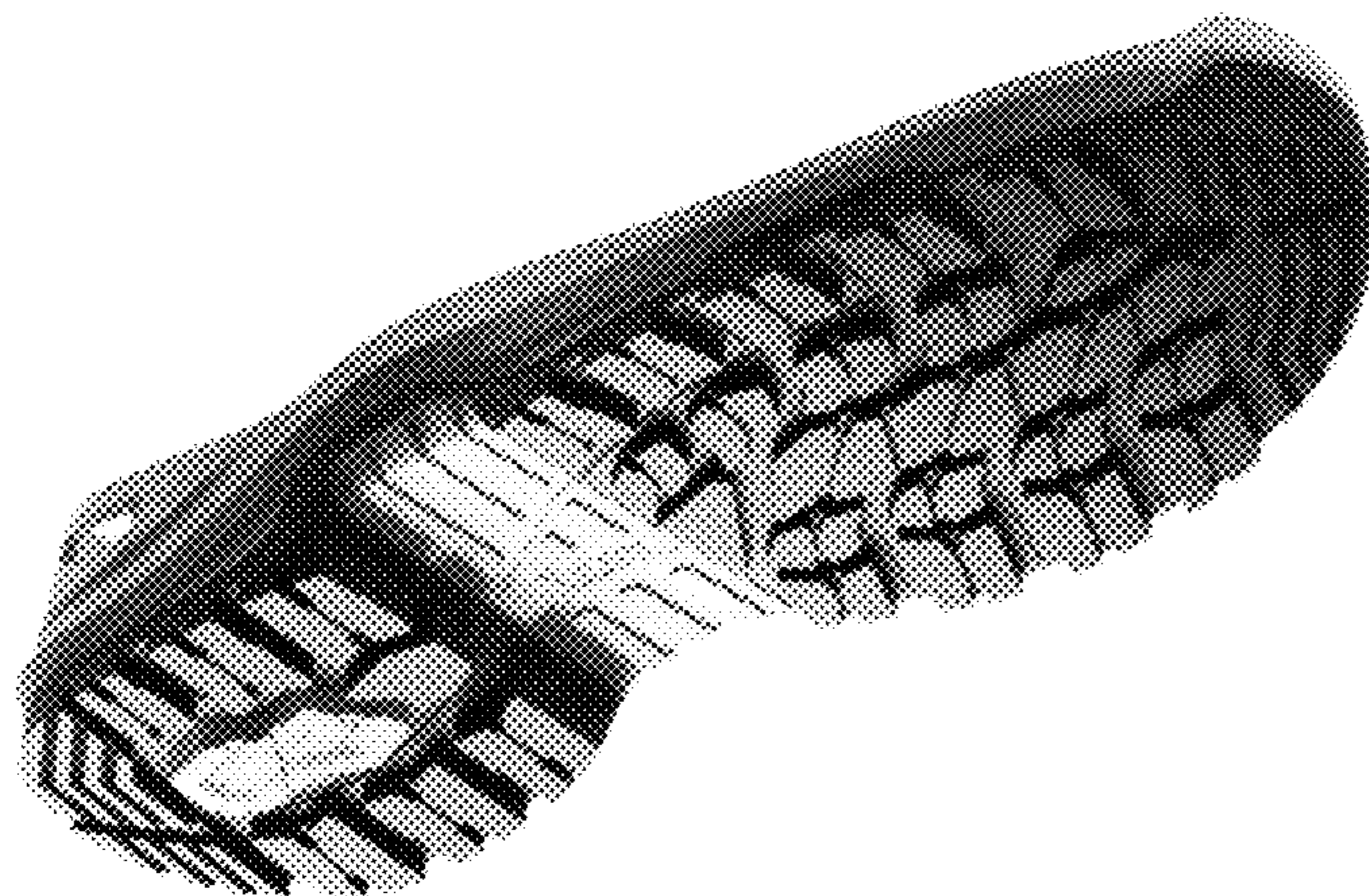
FIG. 2 is a bottom view of the sole for safety shoe;

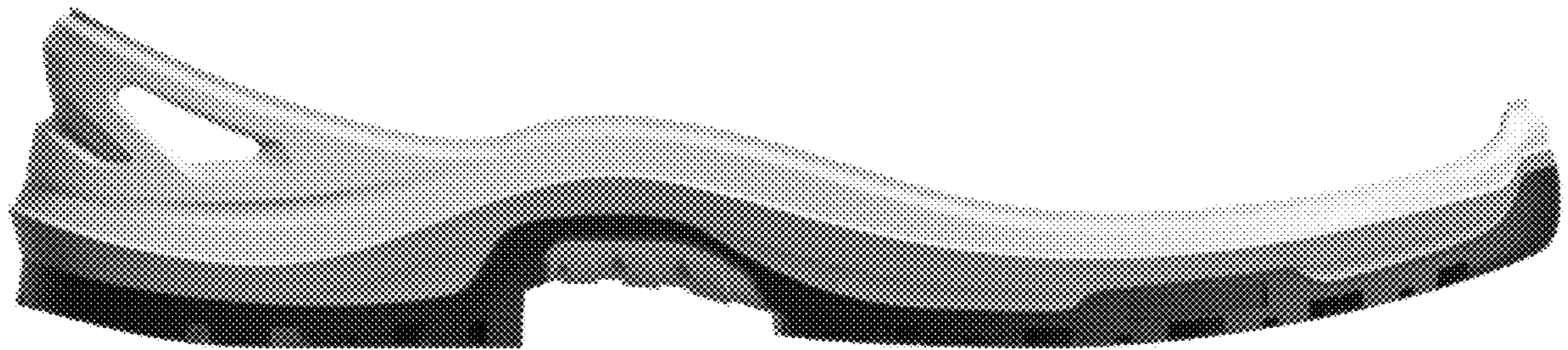

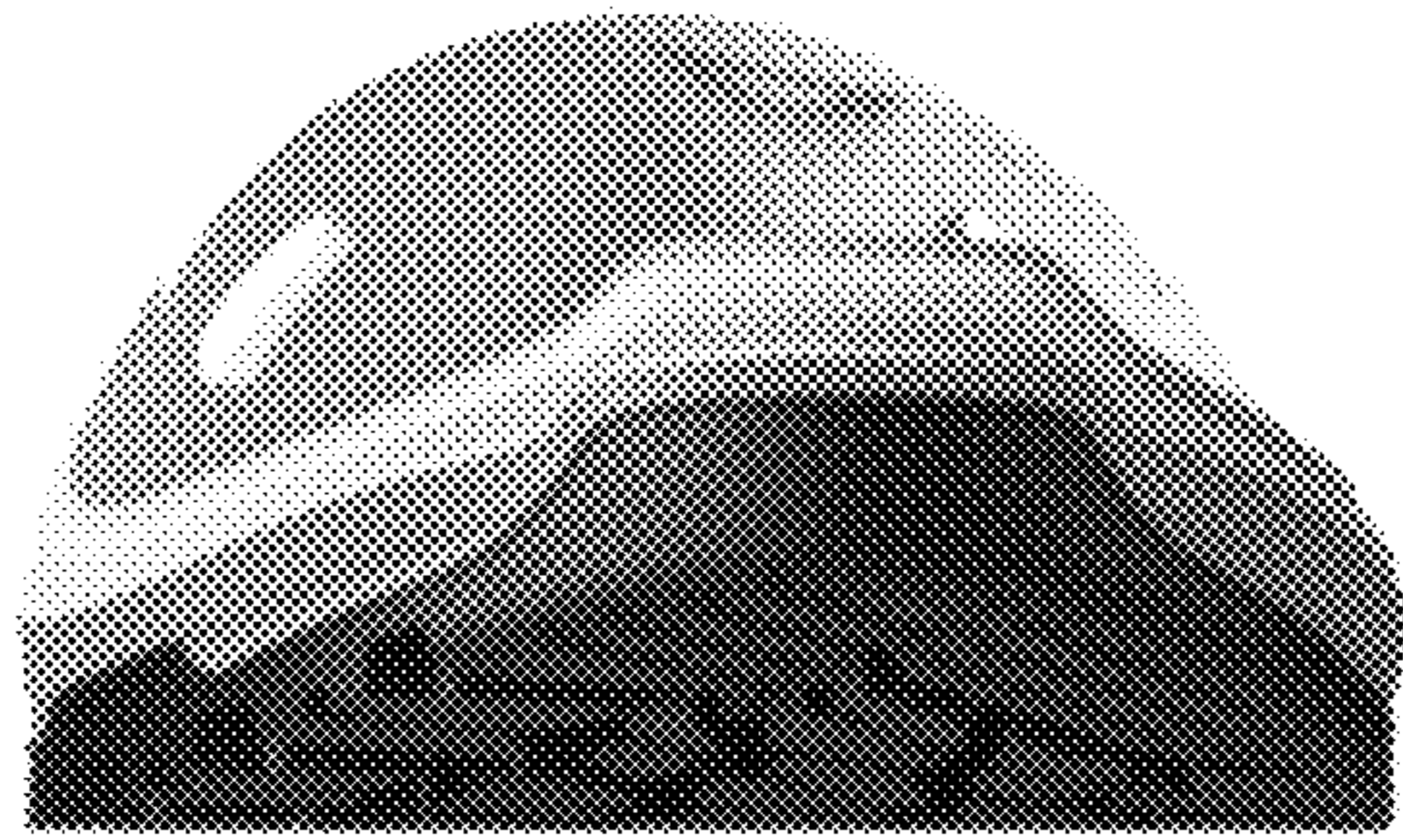

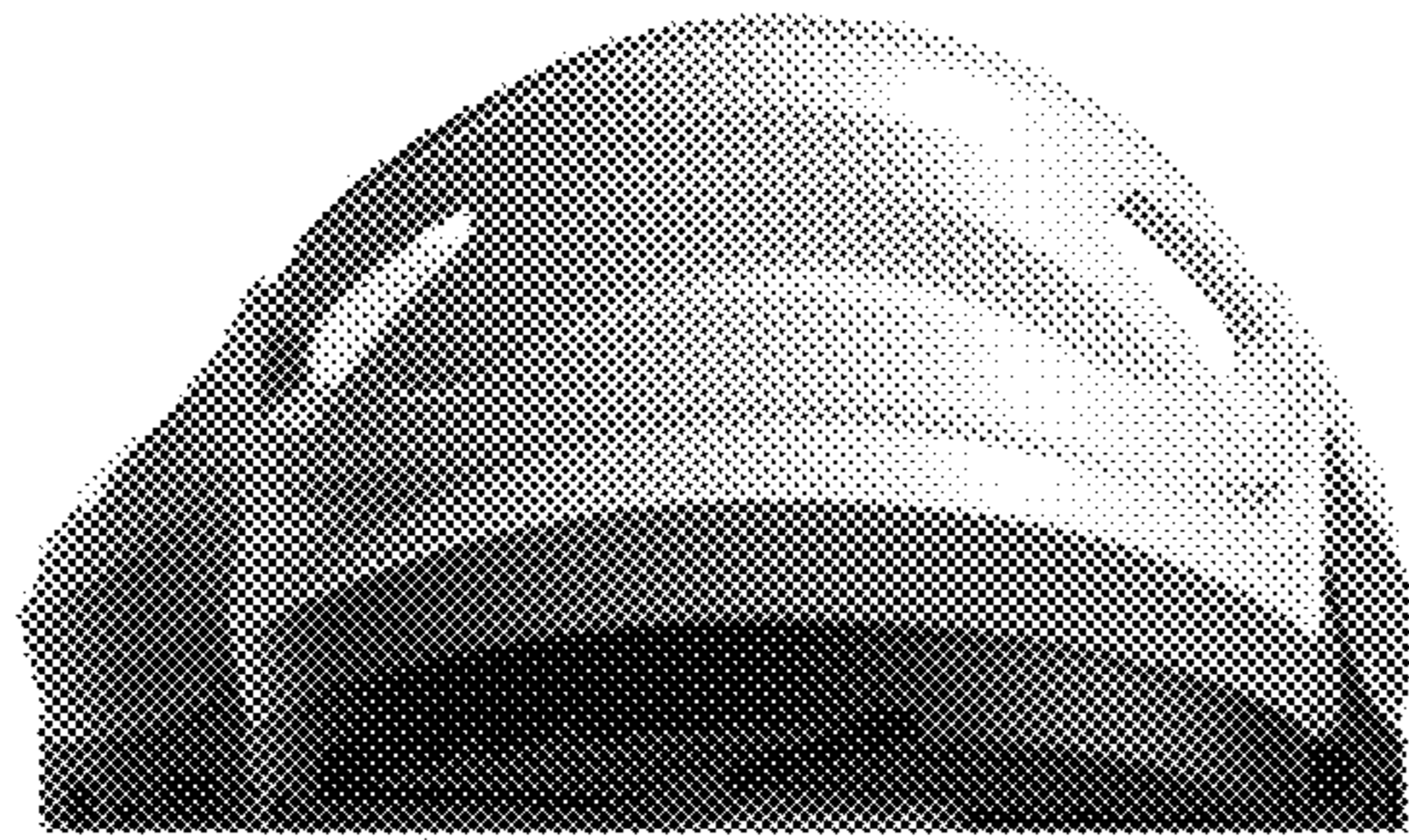
