FIG. 1 is a side view of a first embodiment of a shoe showing my new design;

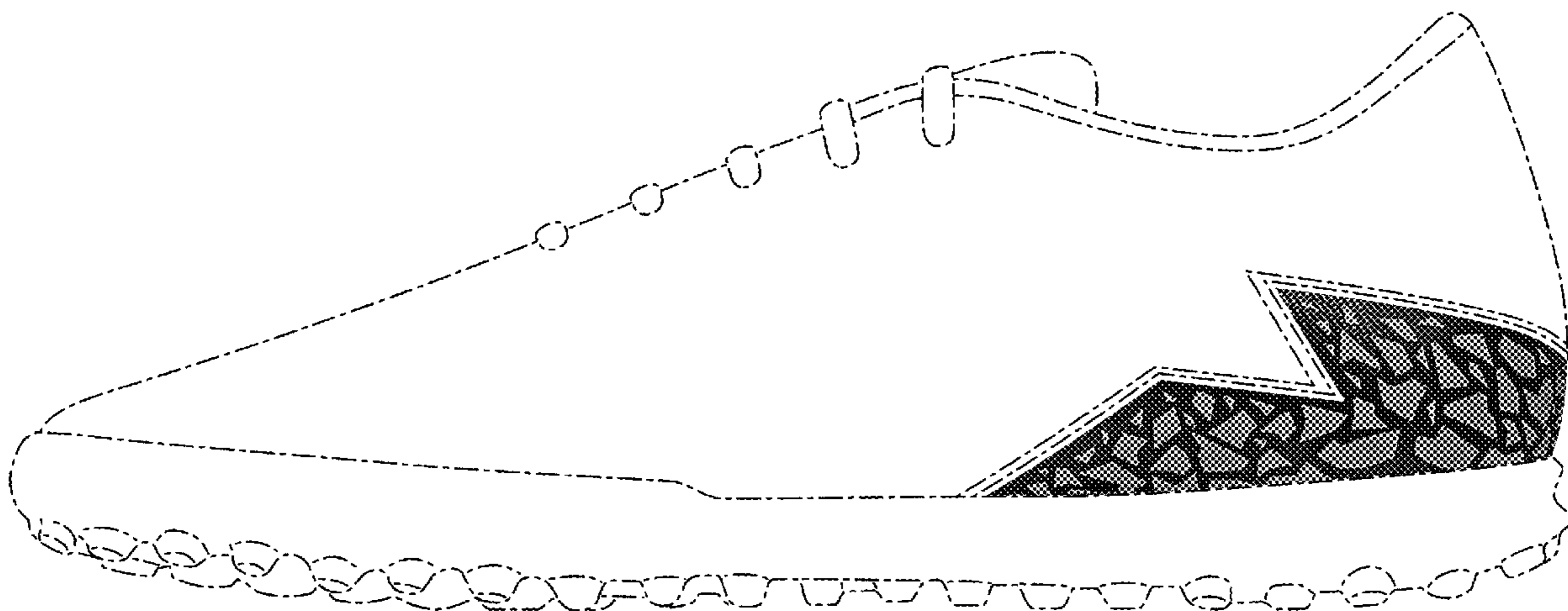
FIG. 2 is a rear view thereof;

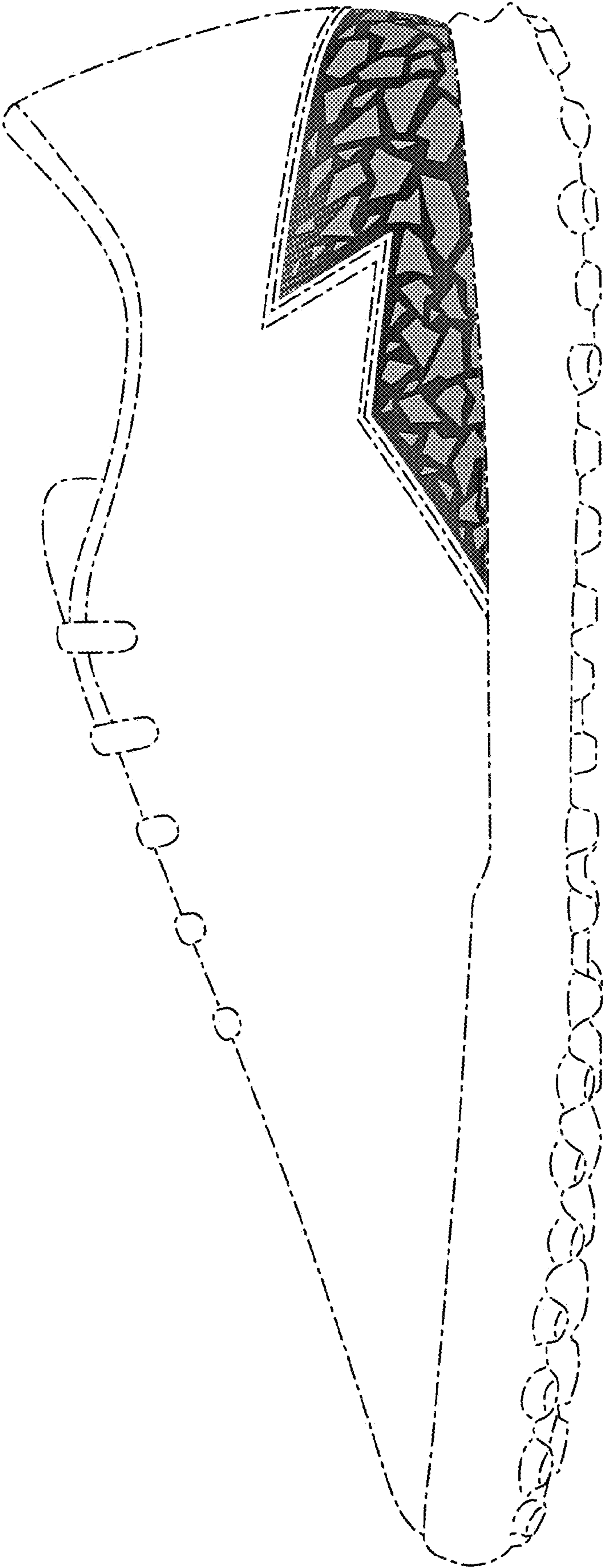

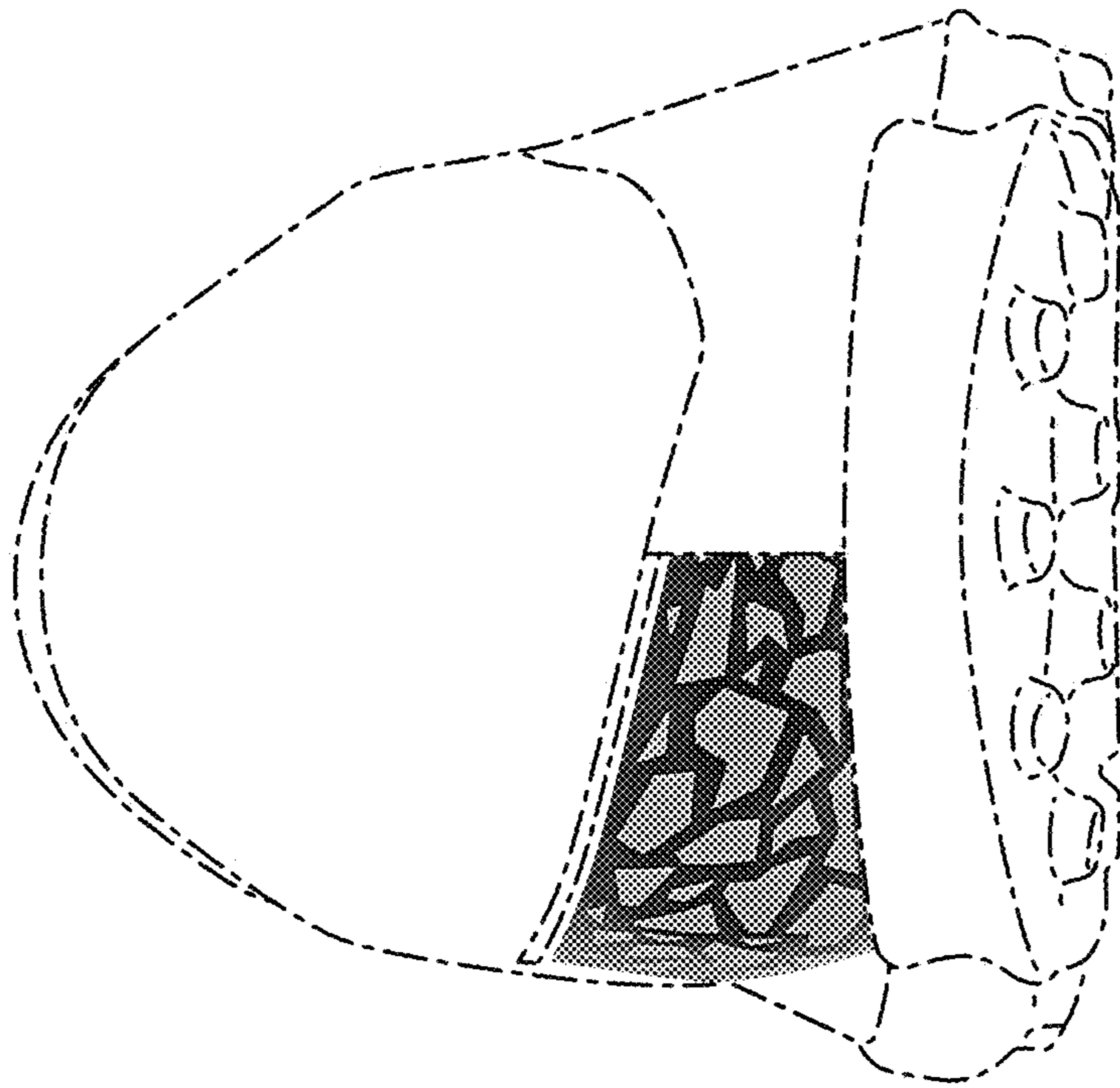

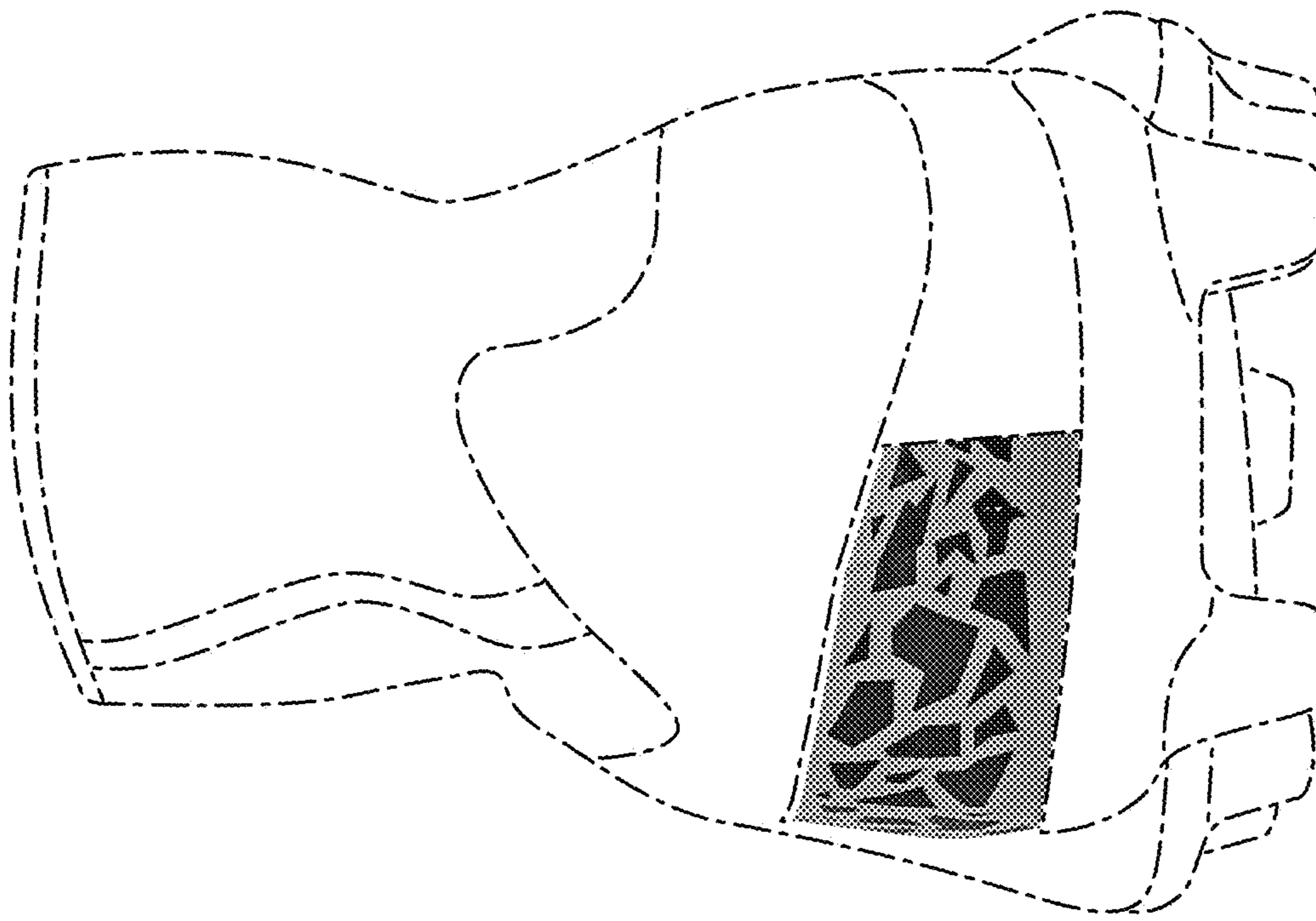
