DESCRIPTION

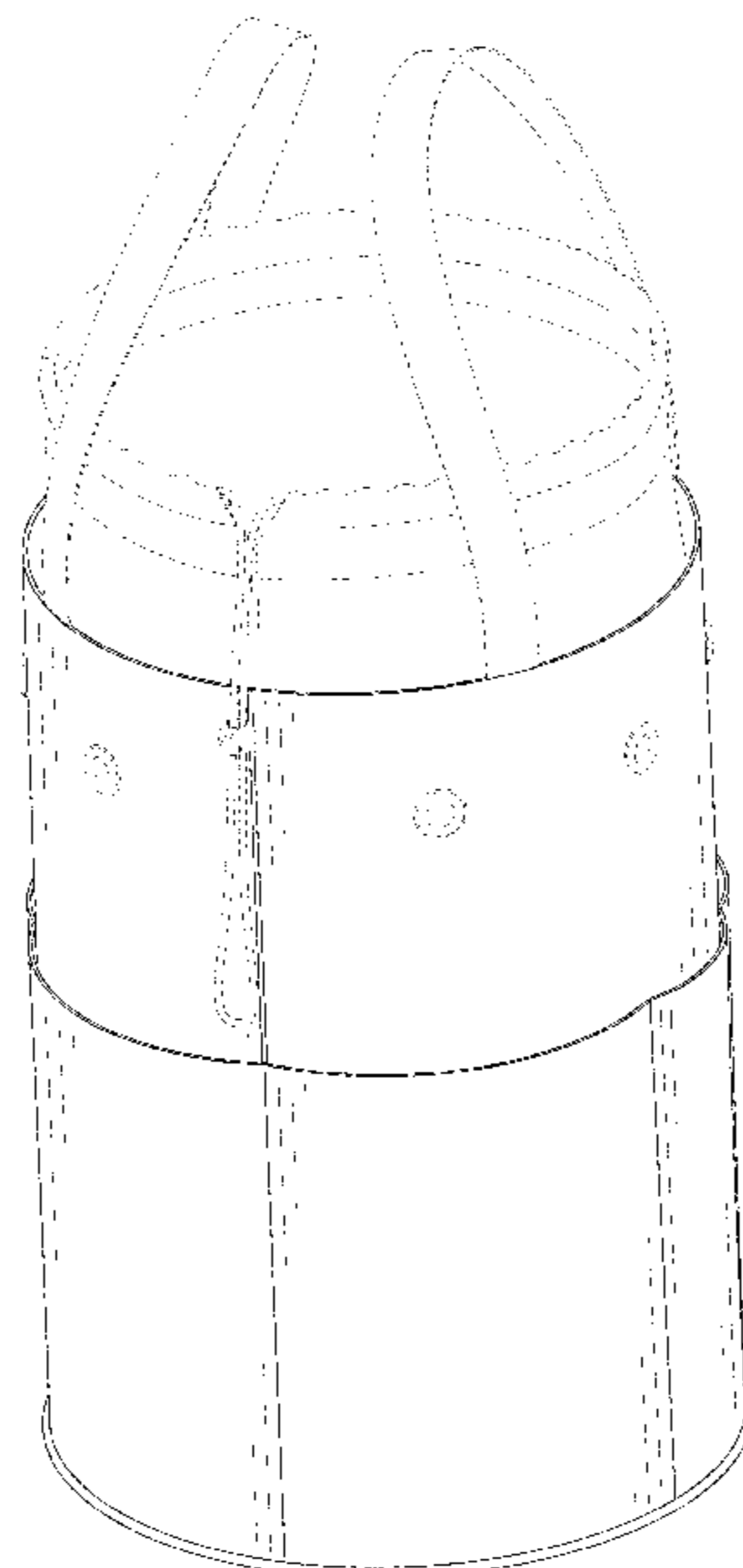
FIG. 1 is a perspective view of a storage bag showing my new design;

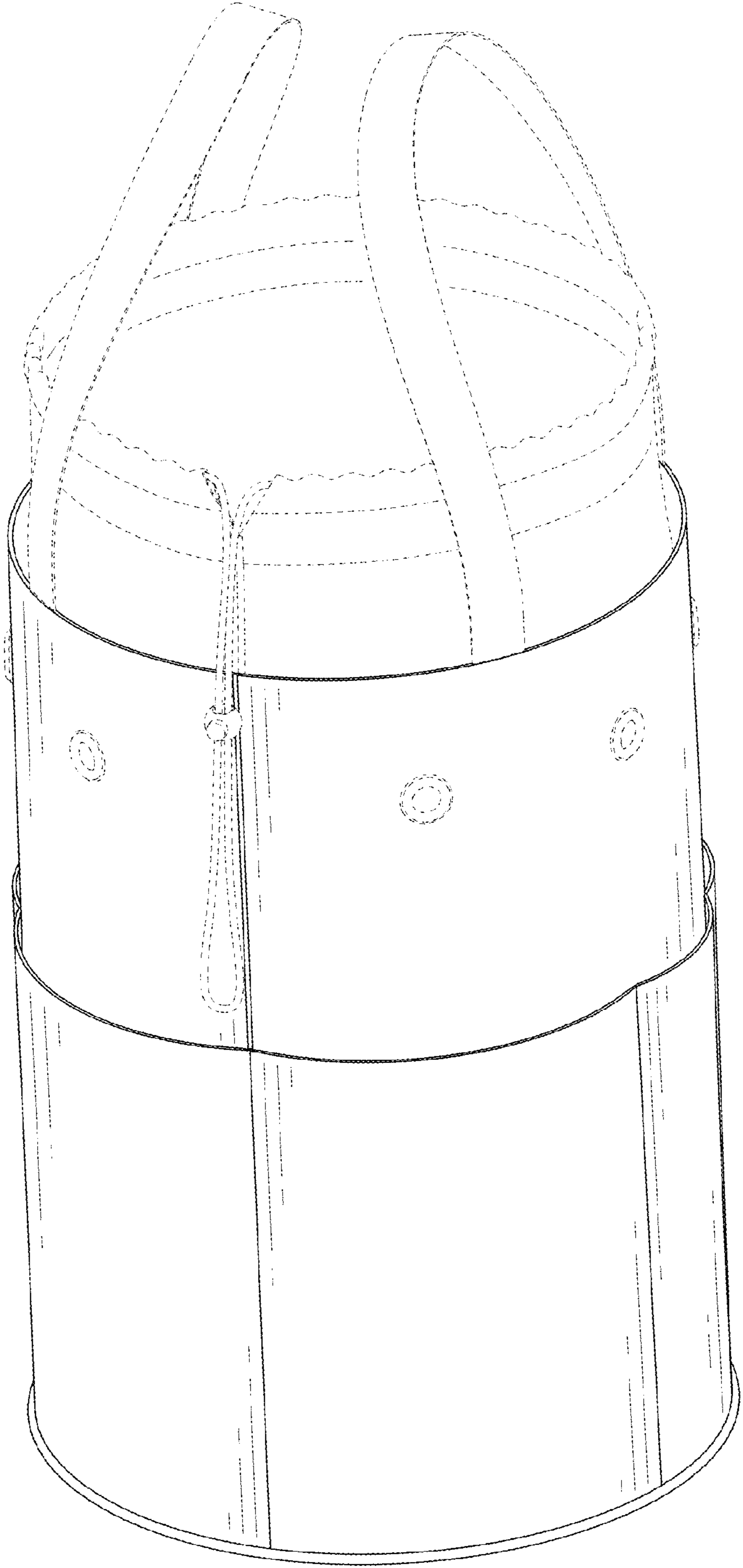

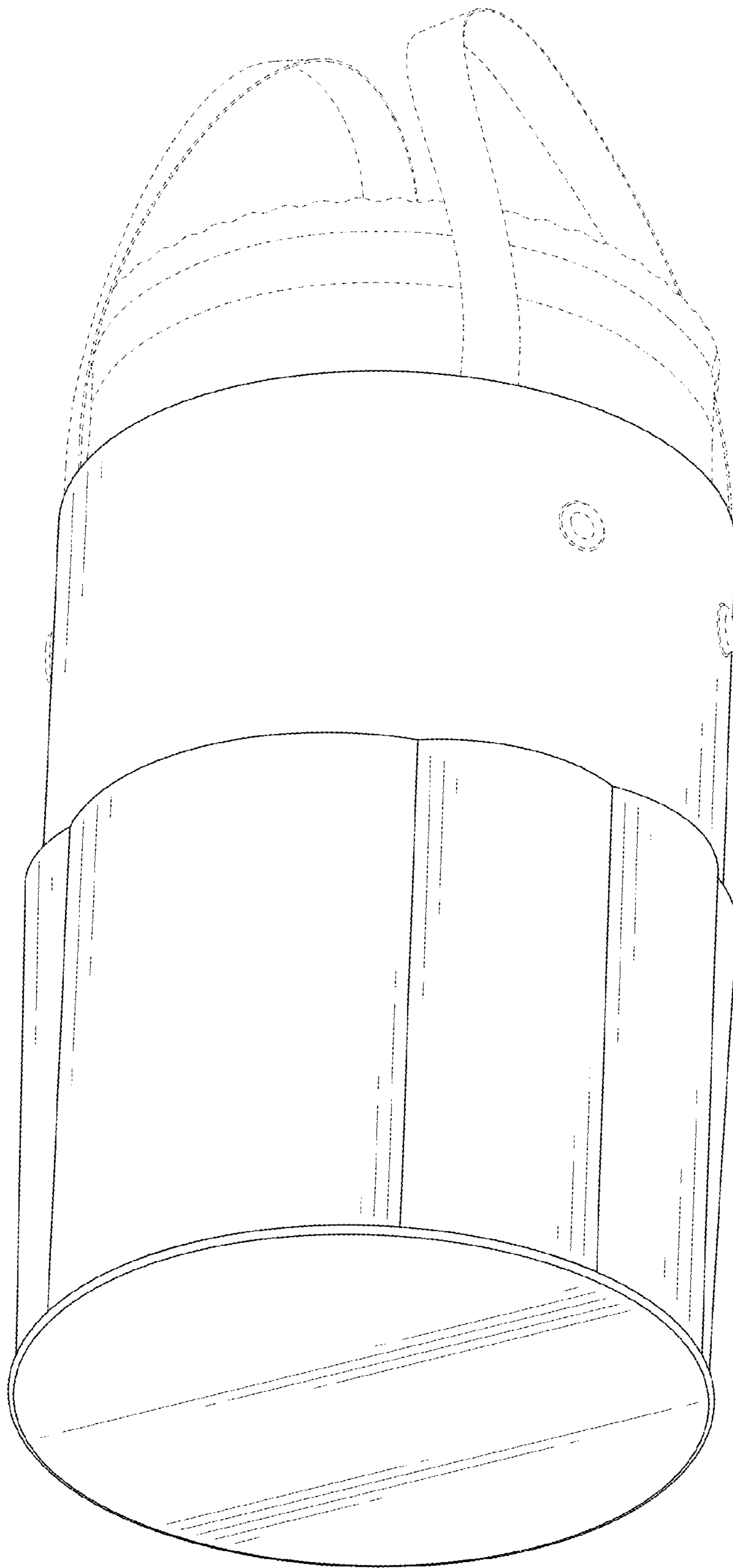

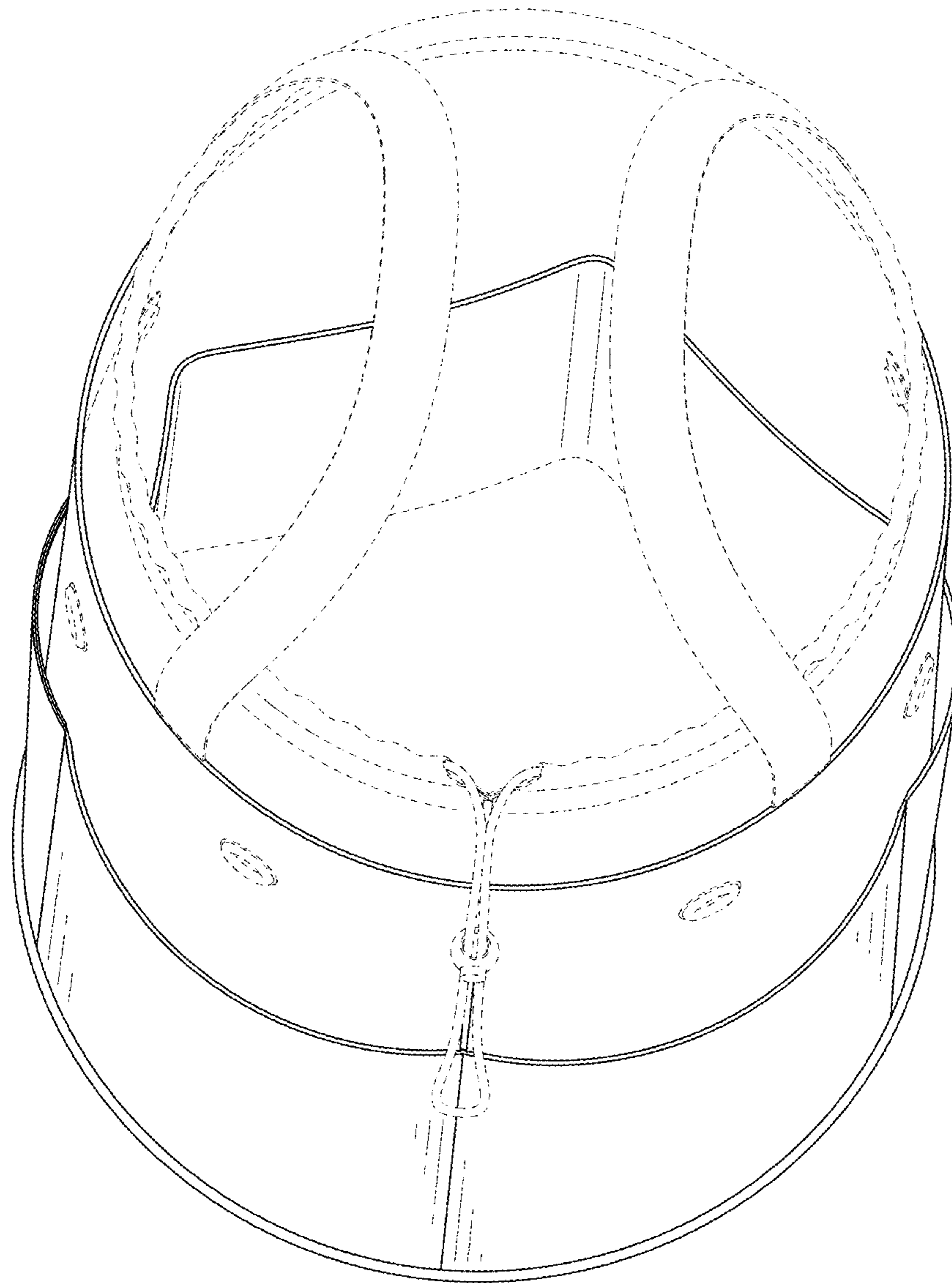

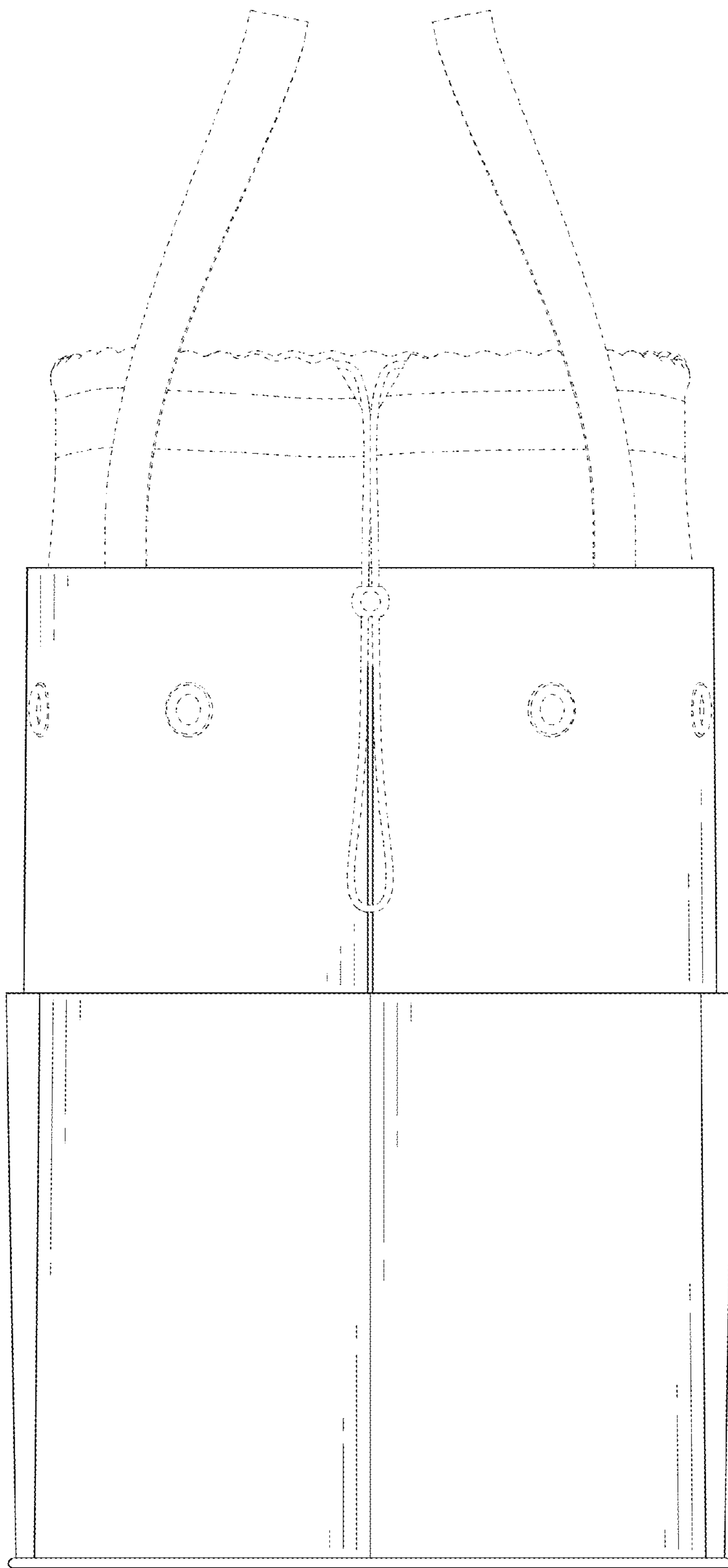

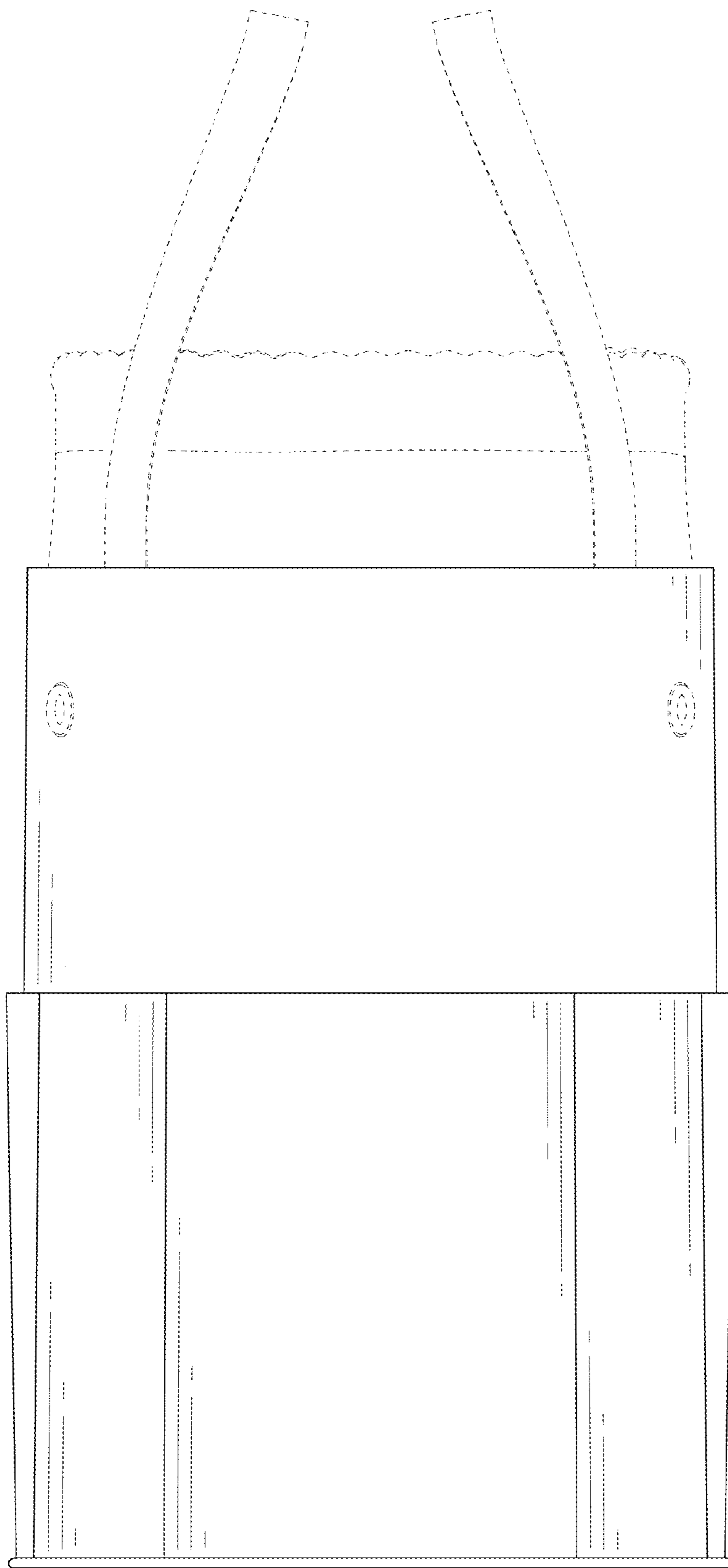

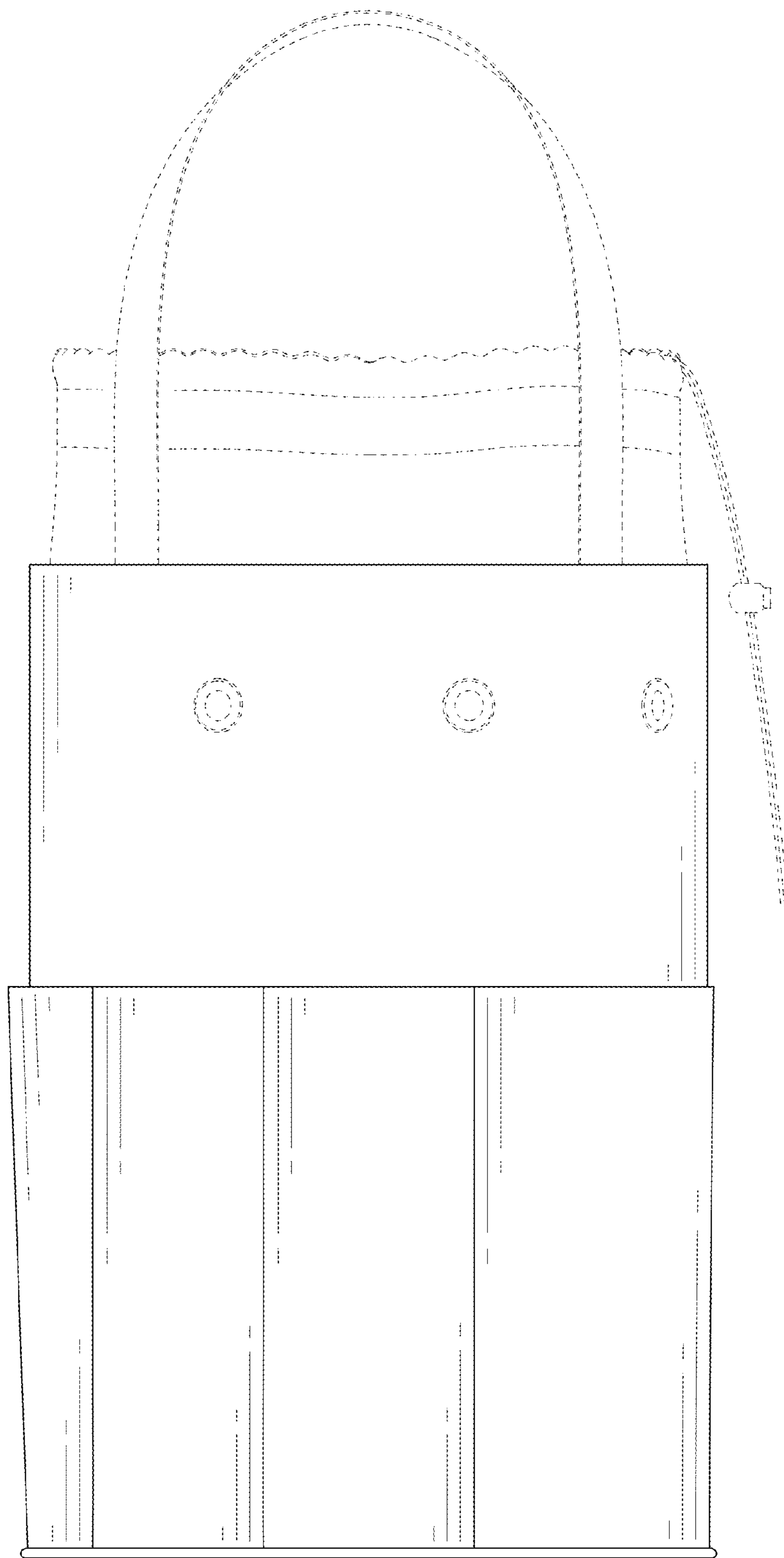

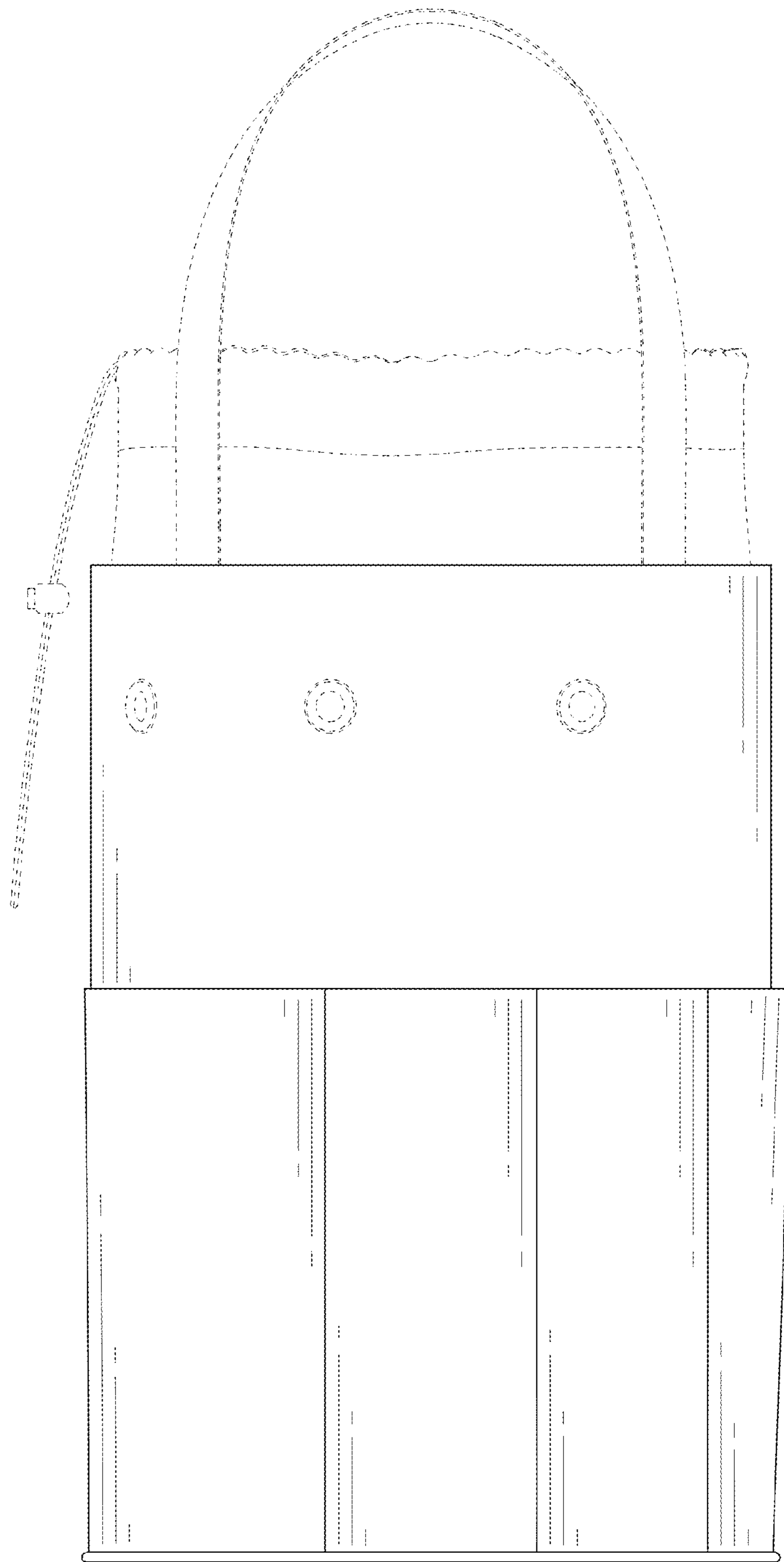

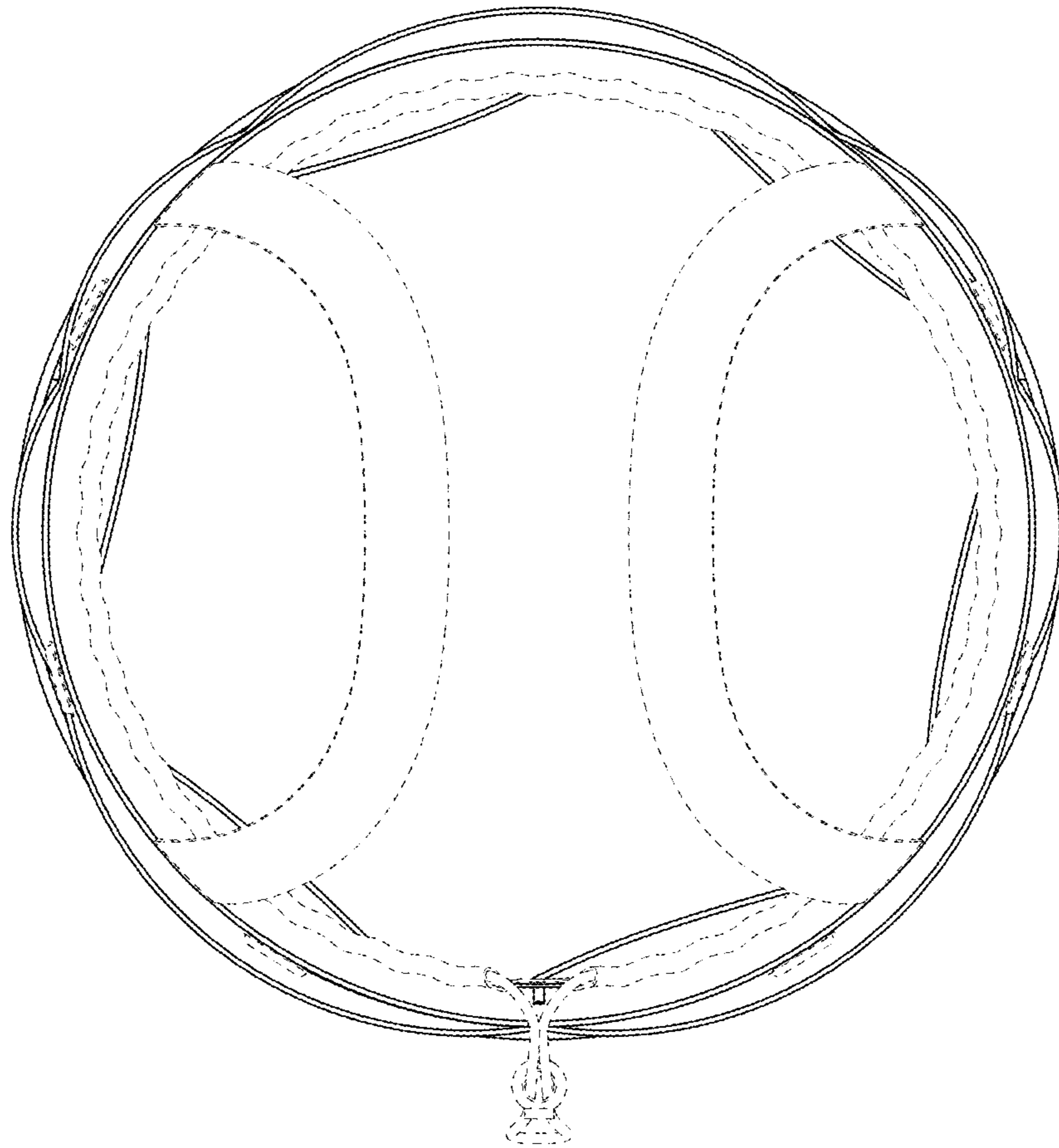

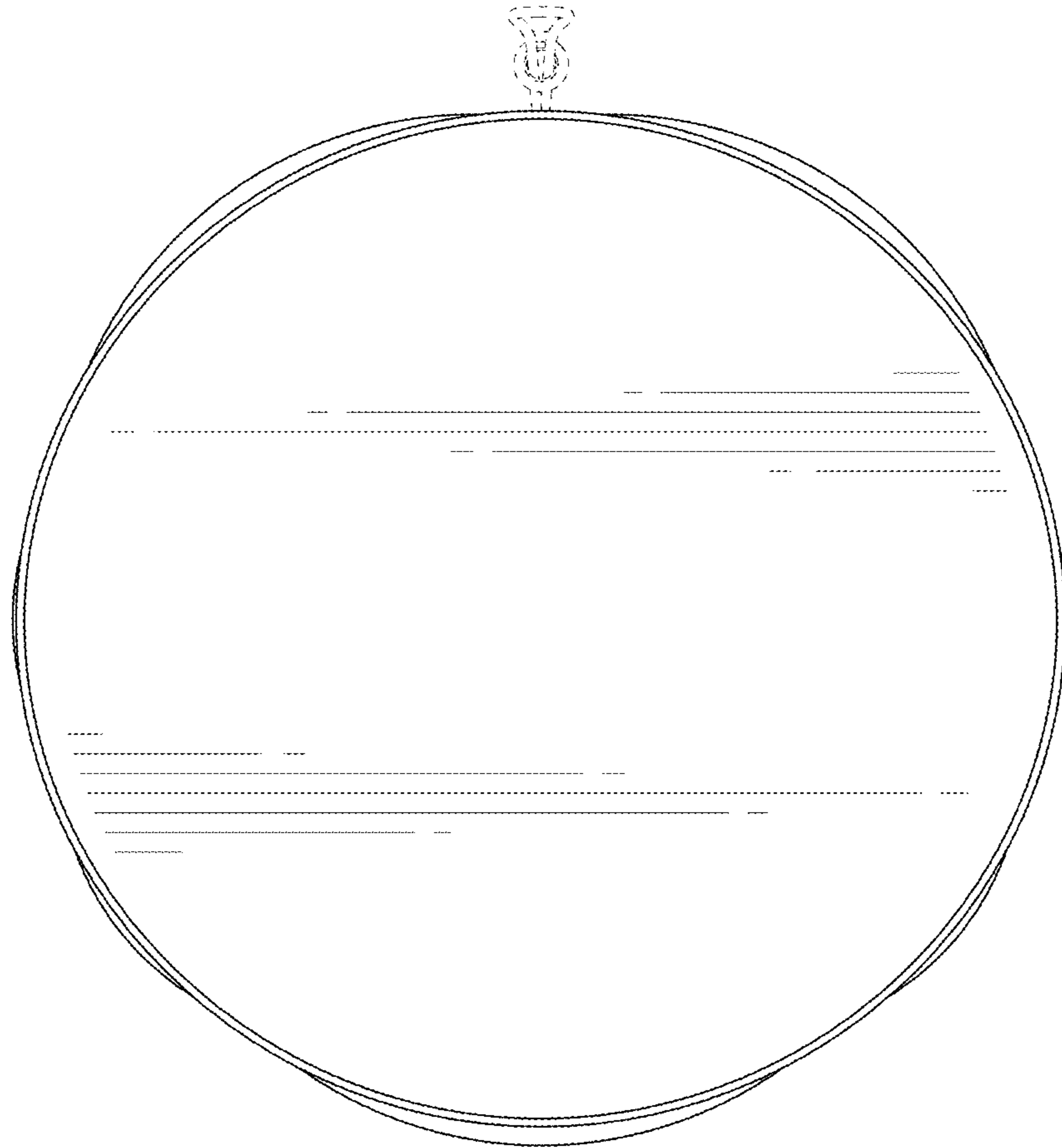

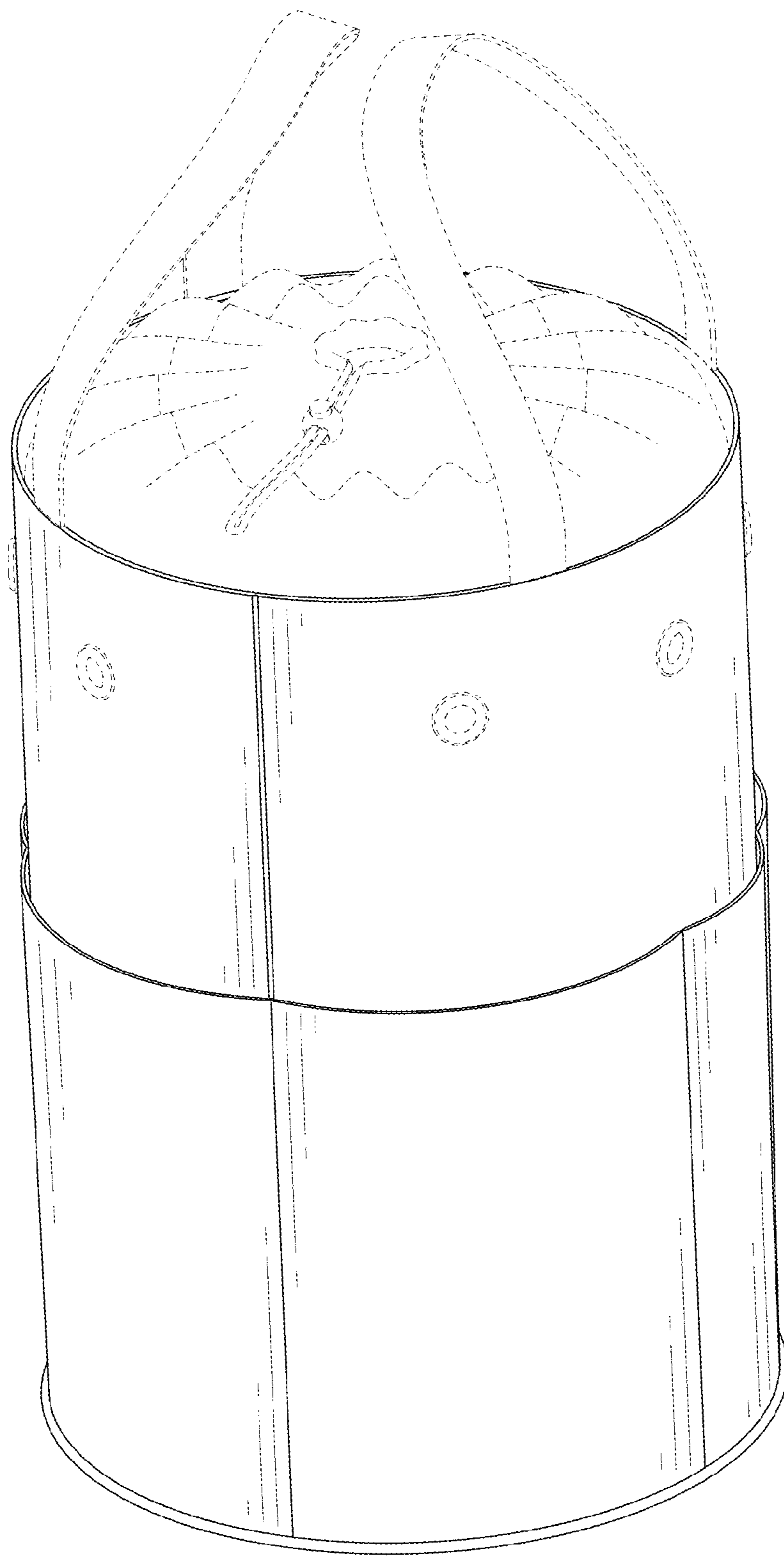
