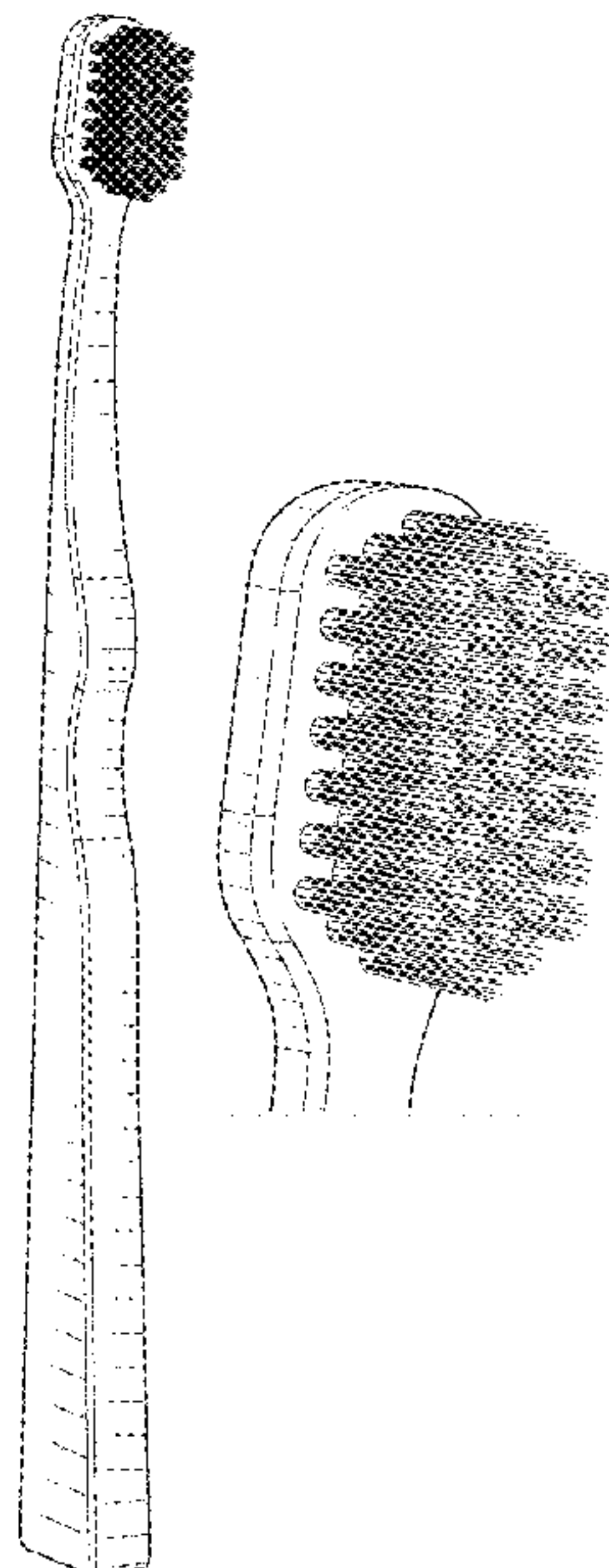
(57) **CLAIM**

The ornamental design for a toothbrush, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the toothbrush showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left-side elevation view thereof;
FIG. 5 is a right-side elevation view thereof;
FIG. 6 is a top plan view thereof;

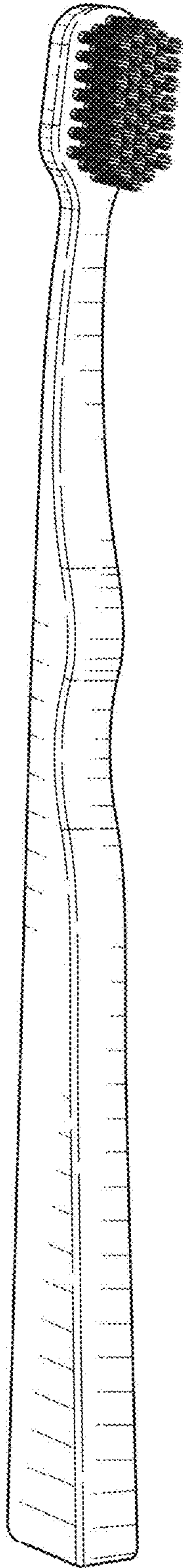

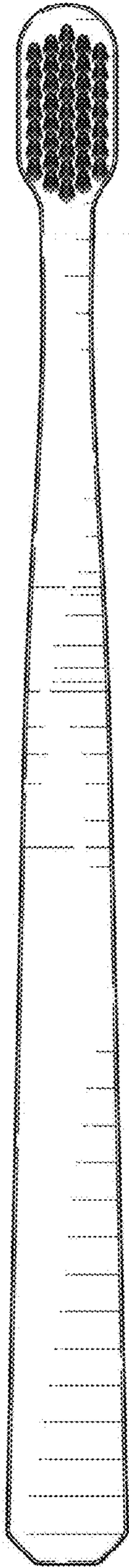

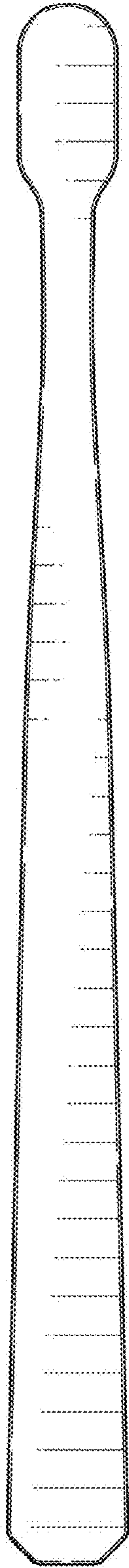

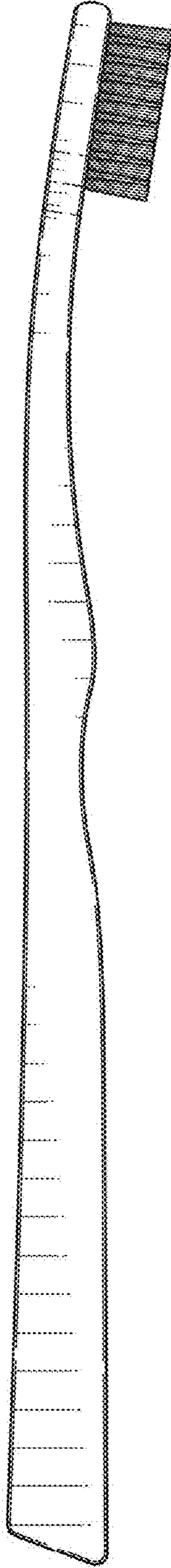

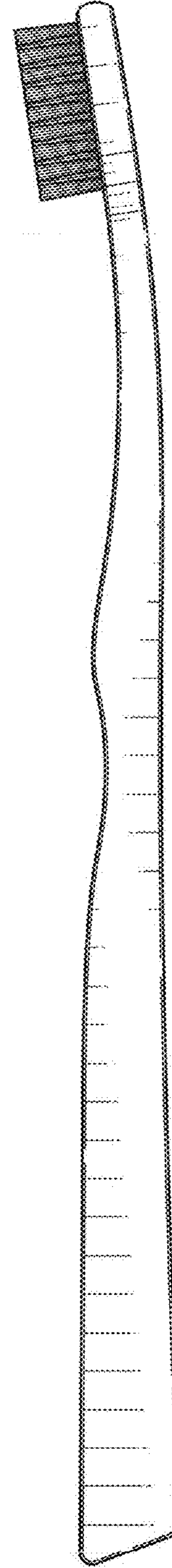

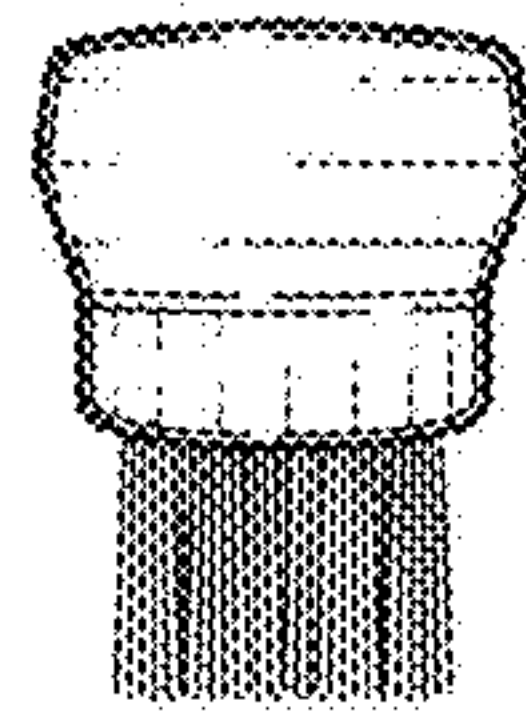

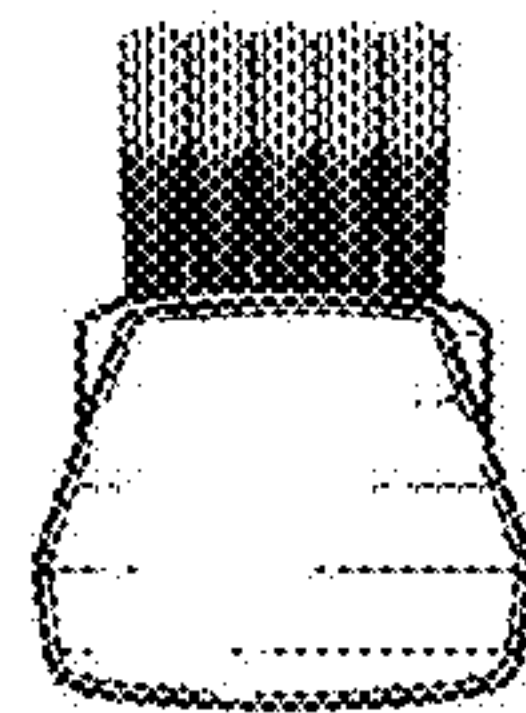

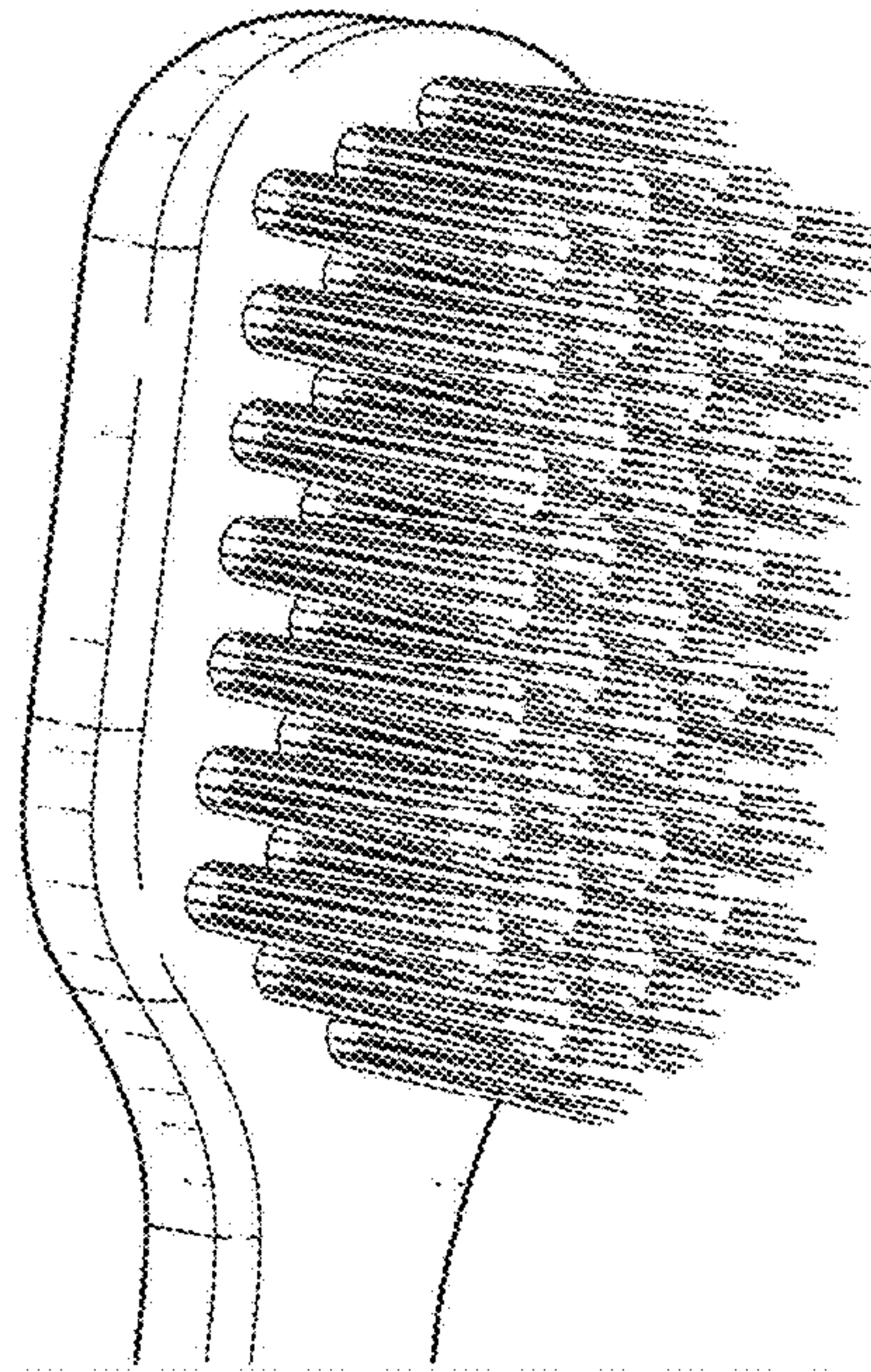

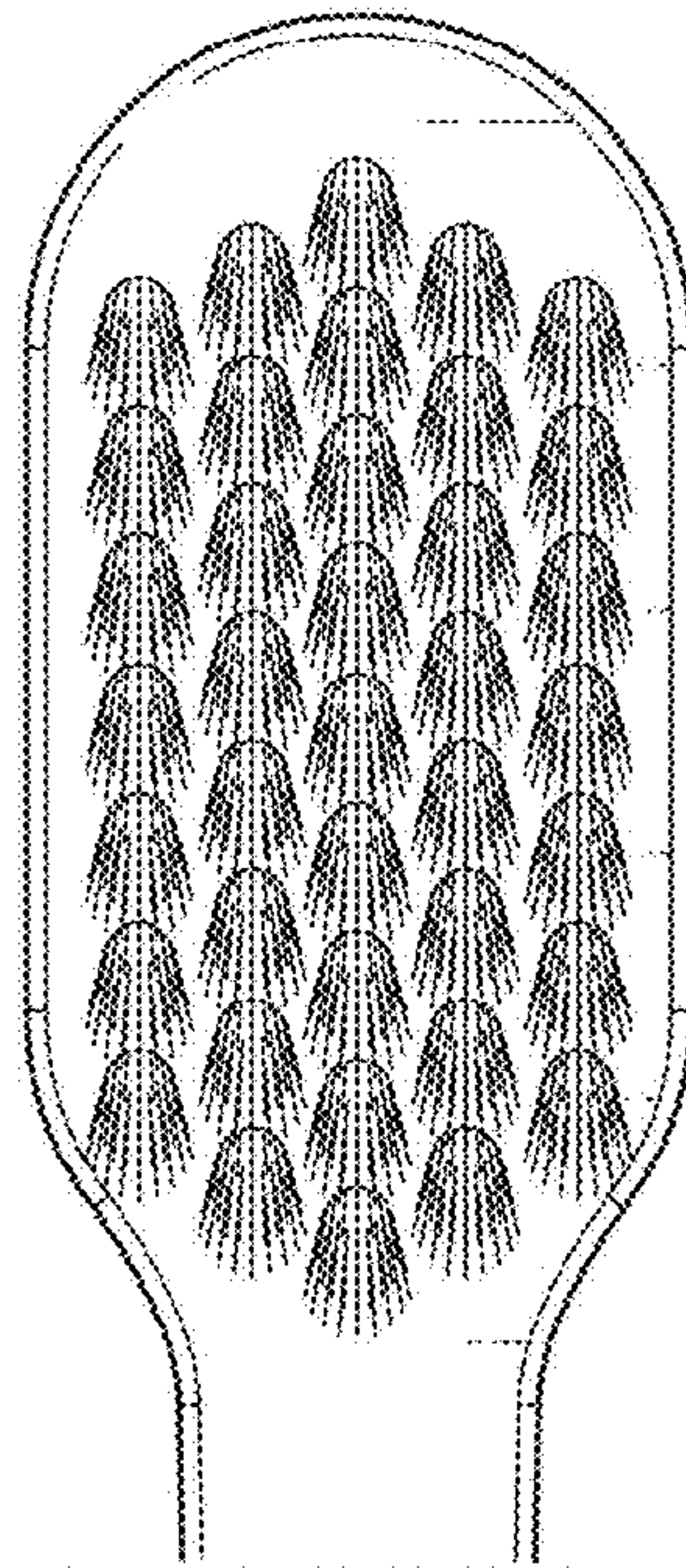

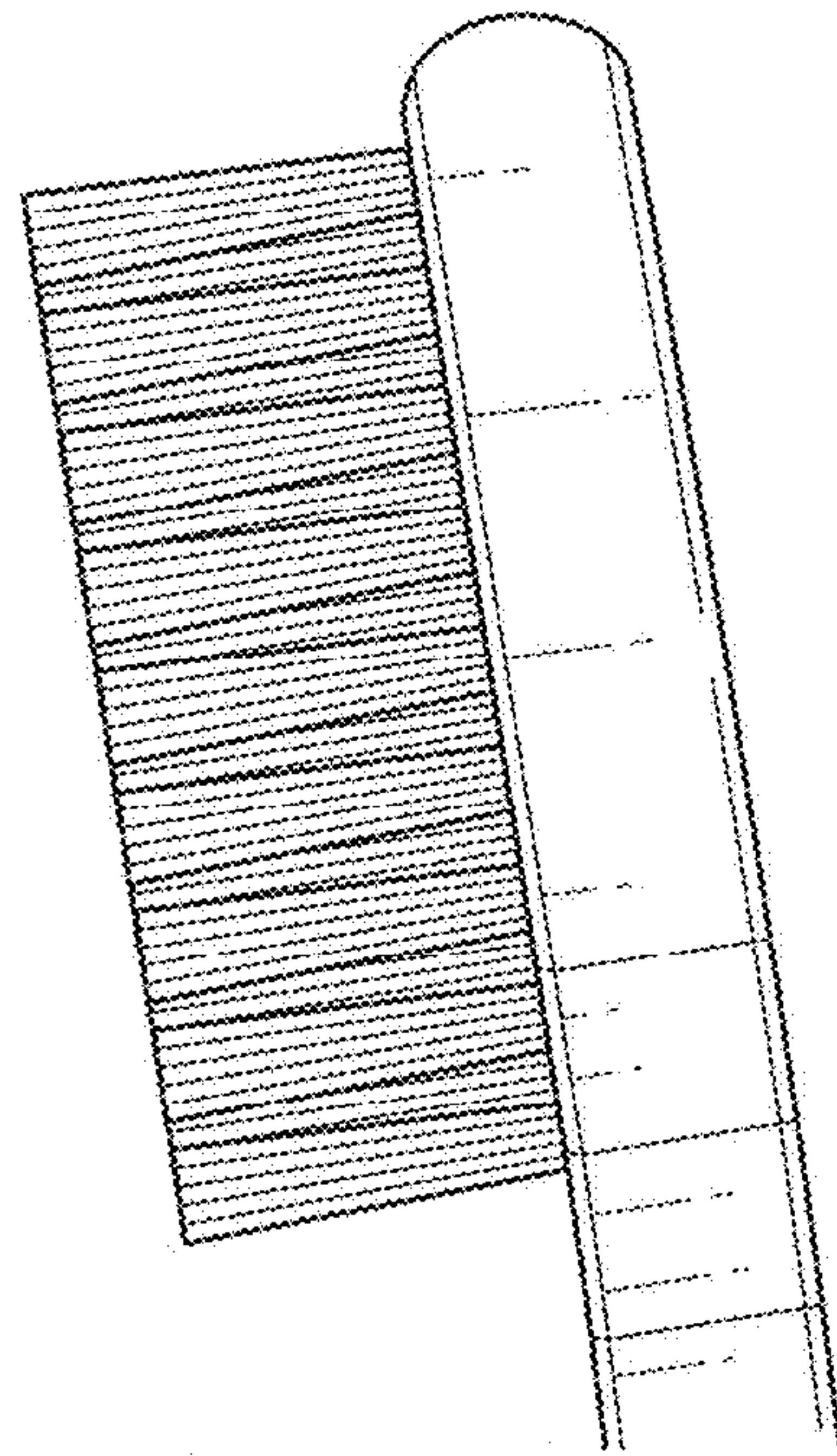
