**DESCRIPTION**

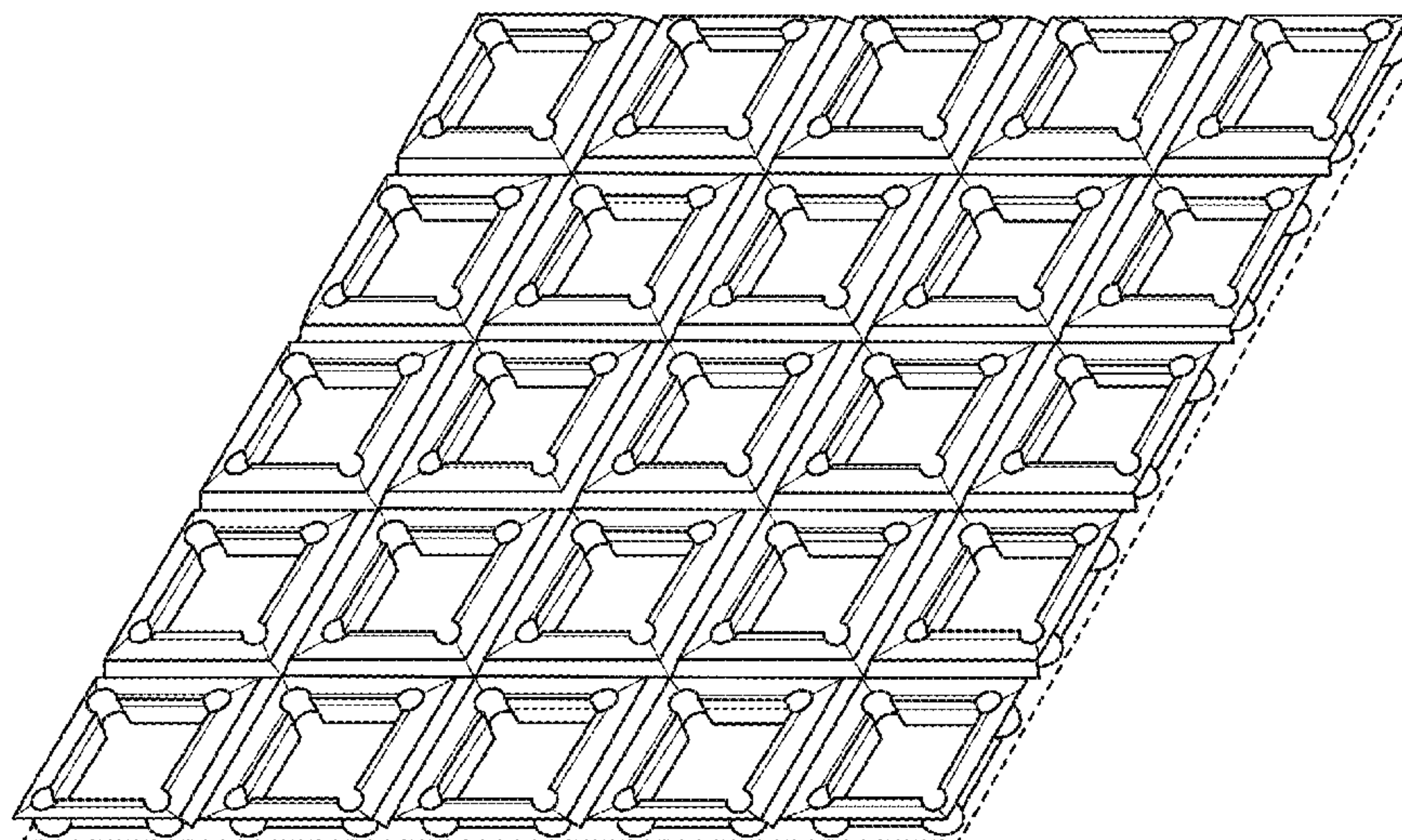
FIG. 1 is a perspective view of my support mat in accor-

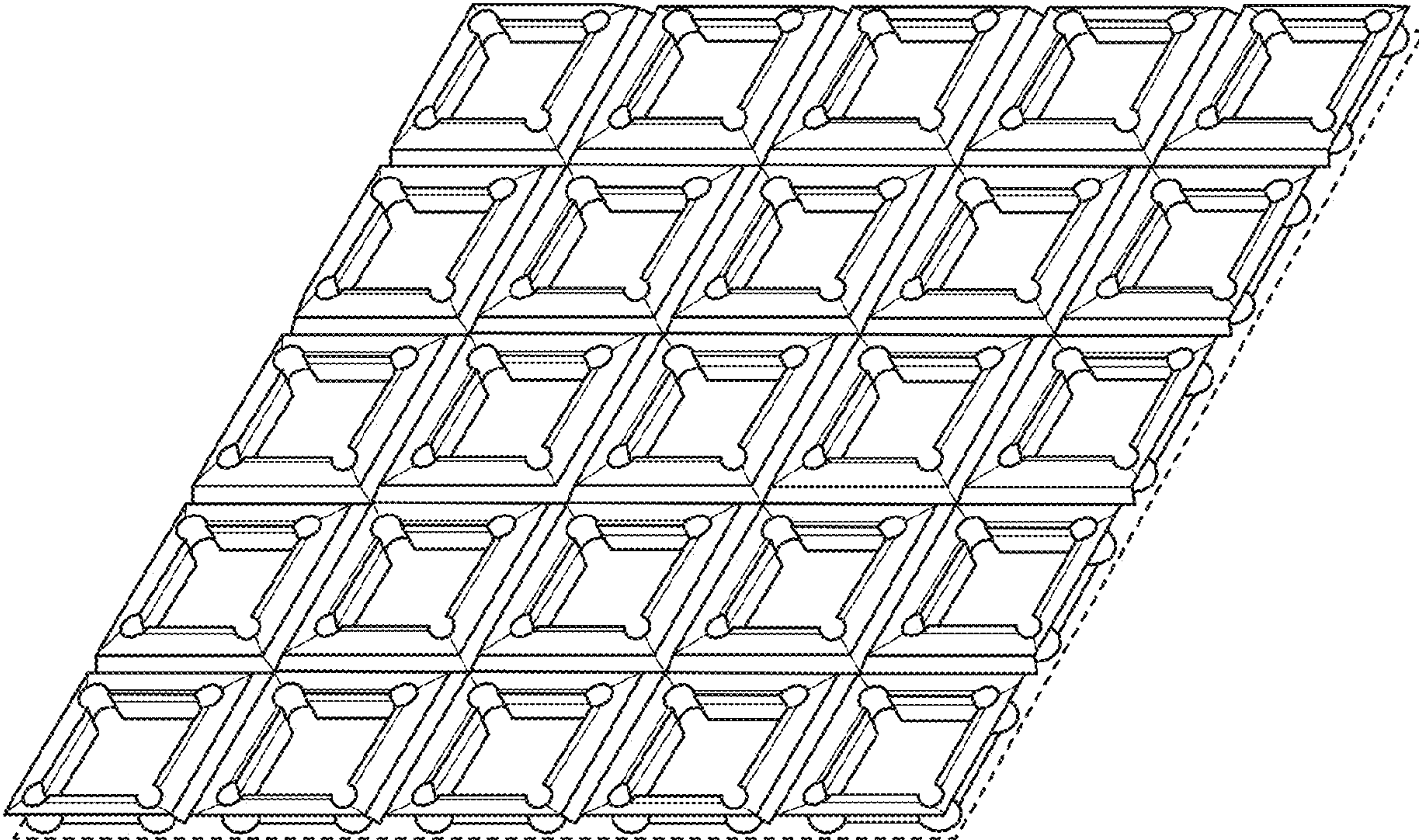

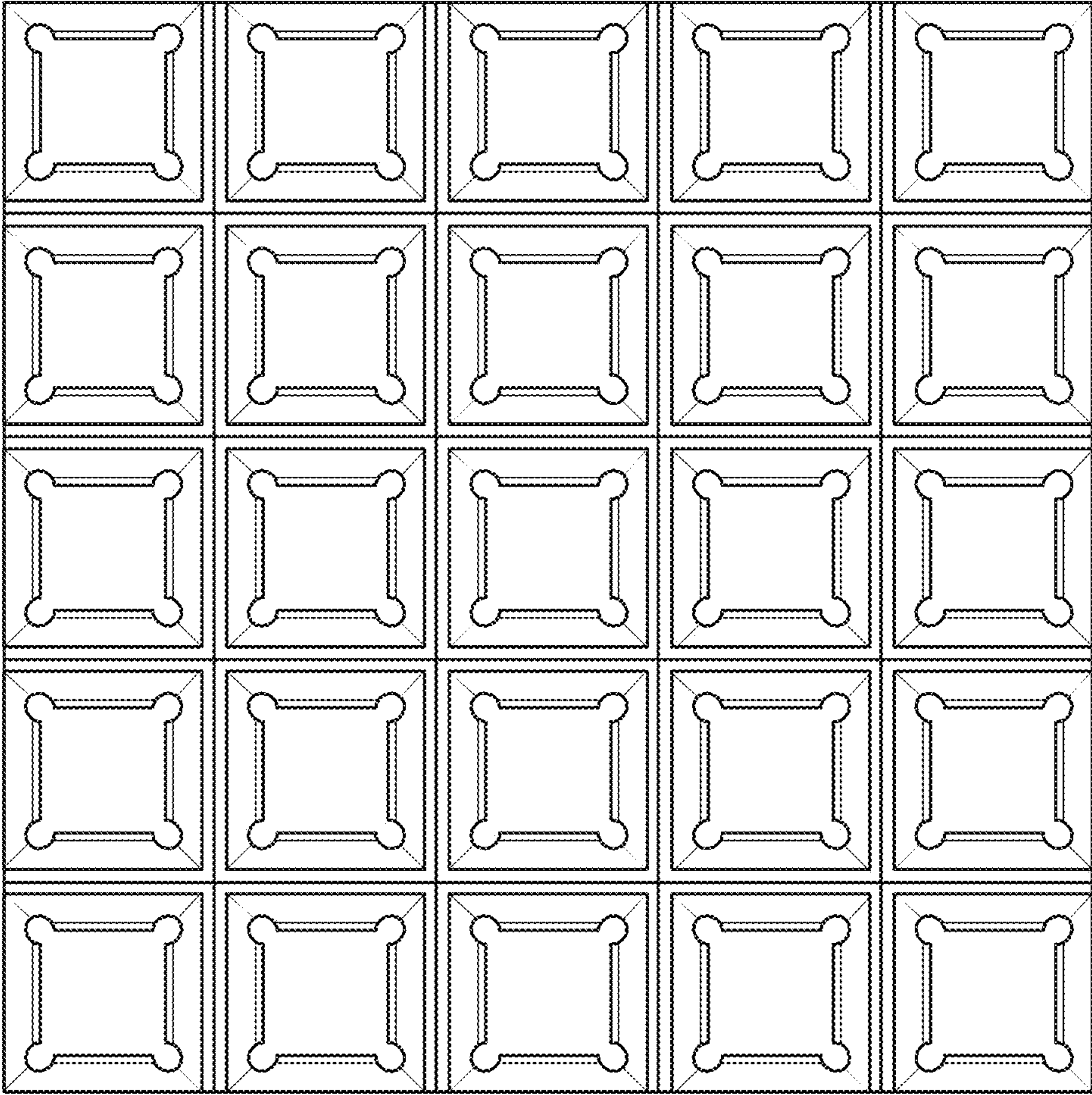

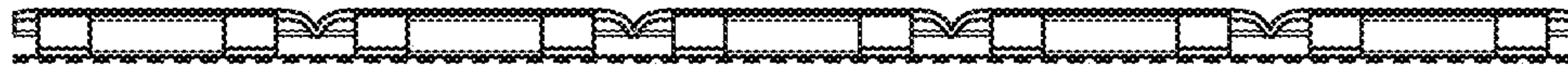
