The ornamental design for a bearer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and right side perspective view of a first embodiment of a bearer showing our new design; FIG. 2 is an enlarged front view thereof, the rear view being symmetrical to the front view;

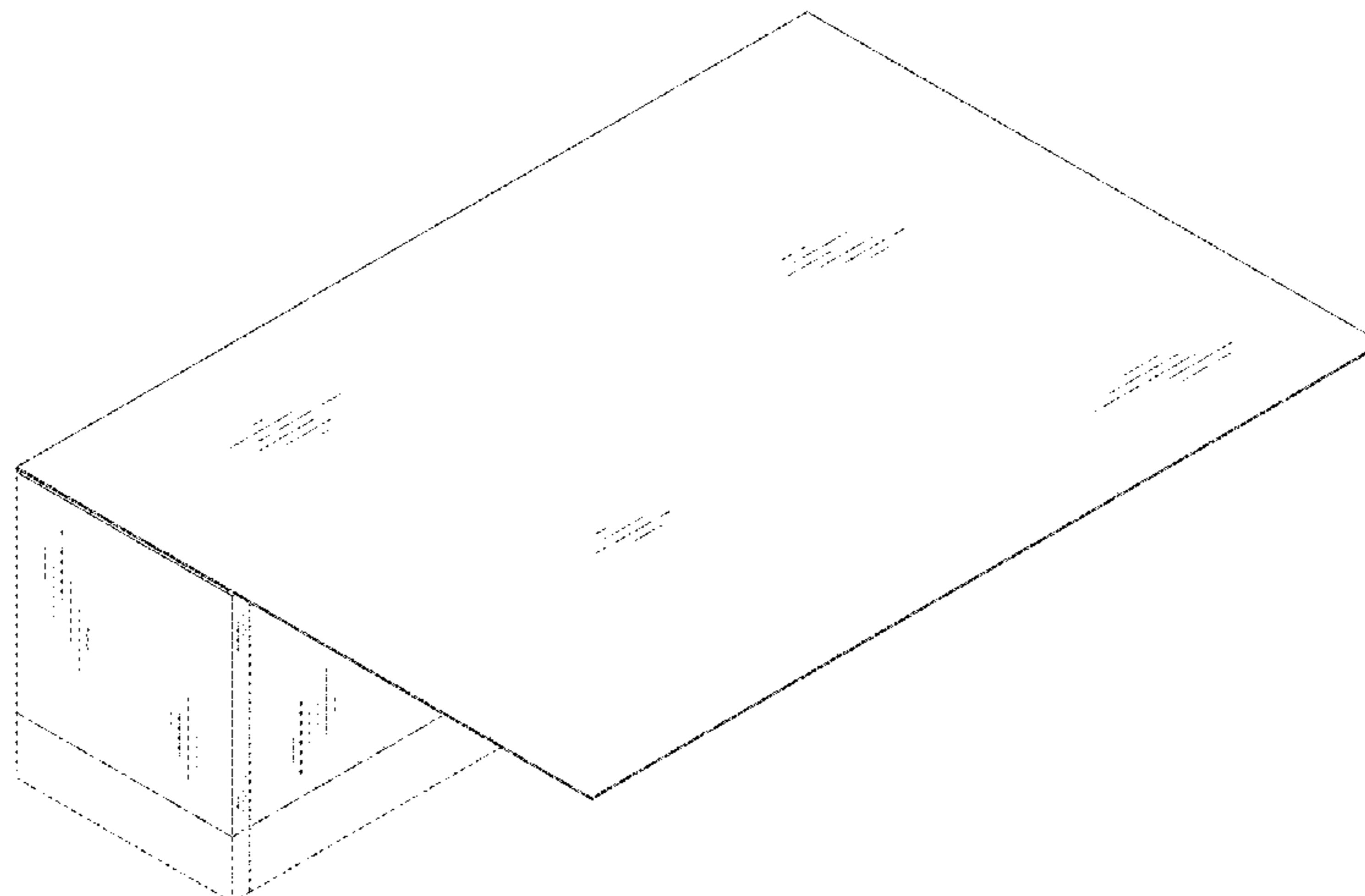


FIG. 22 is a right side view thereof;

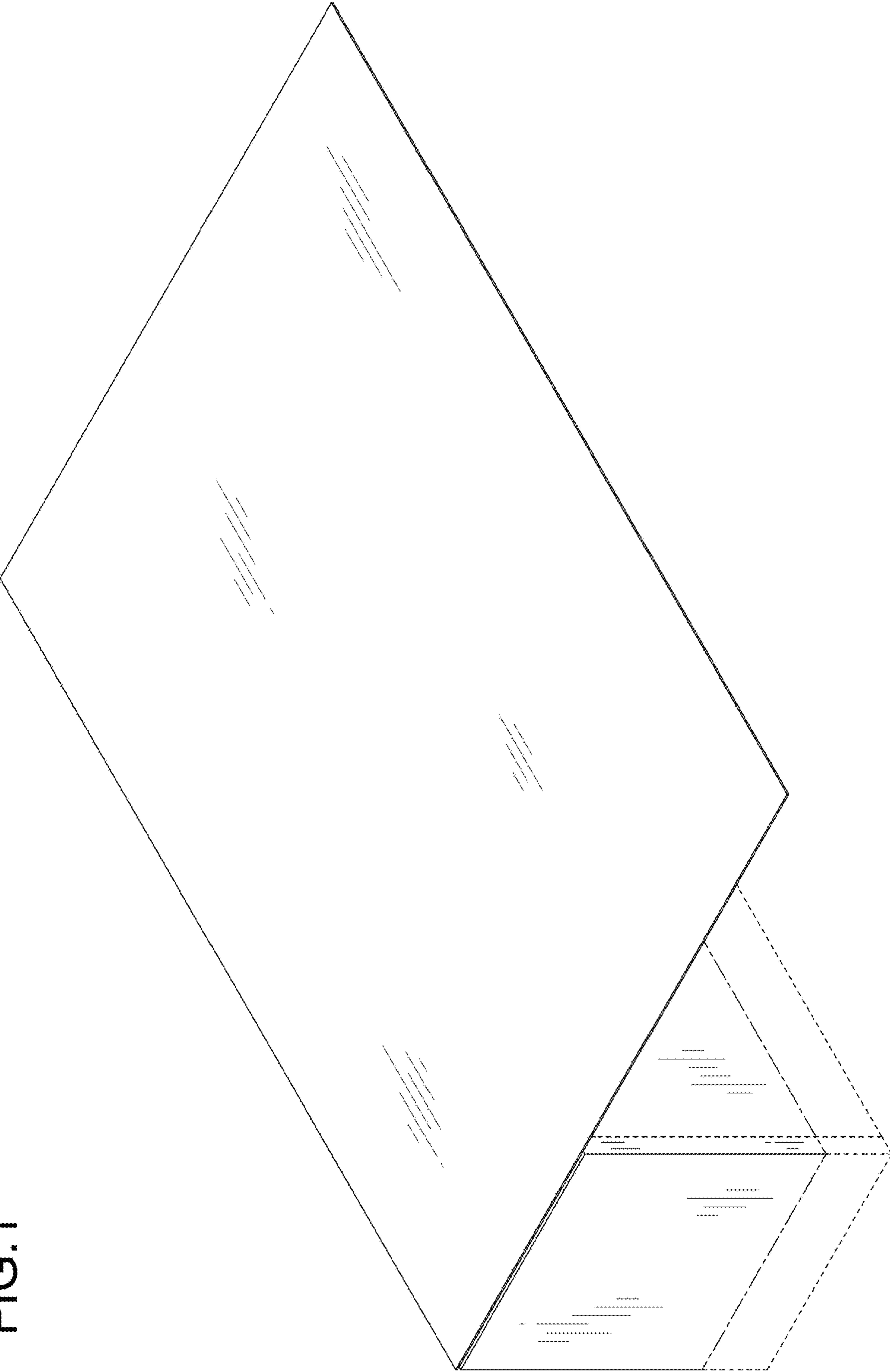

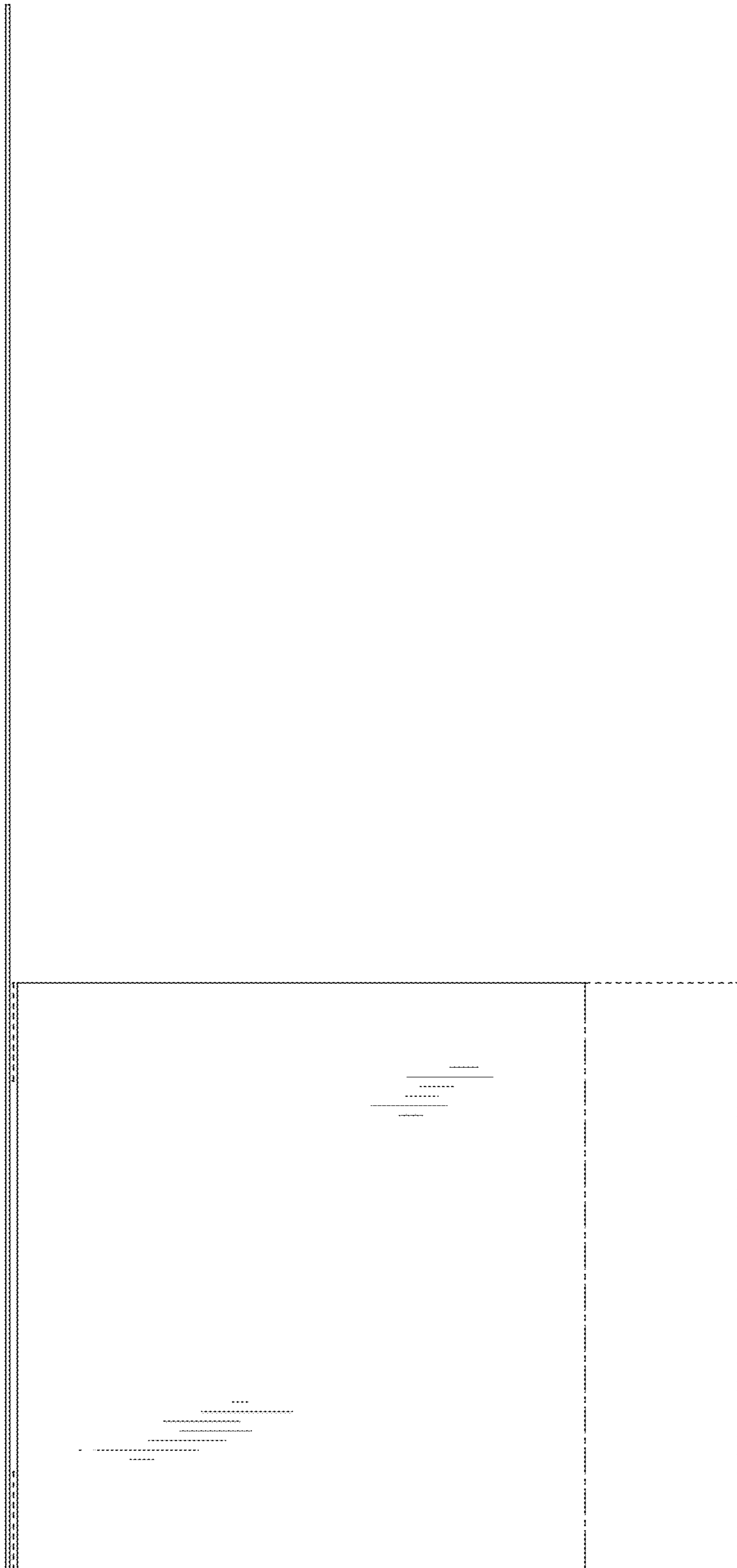

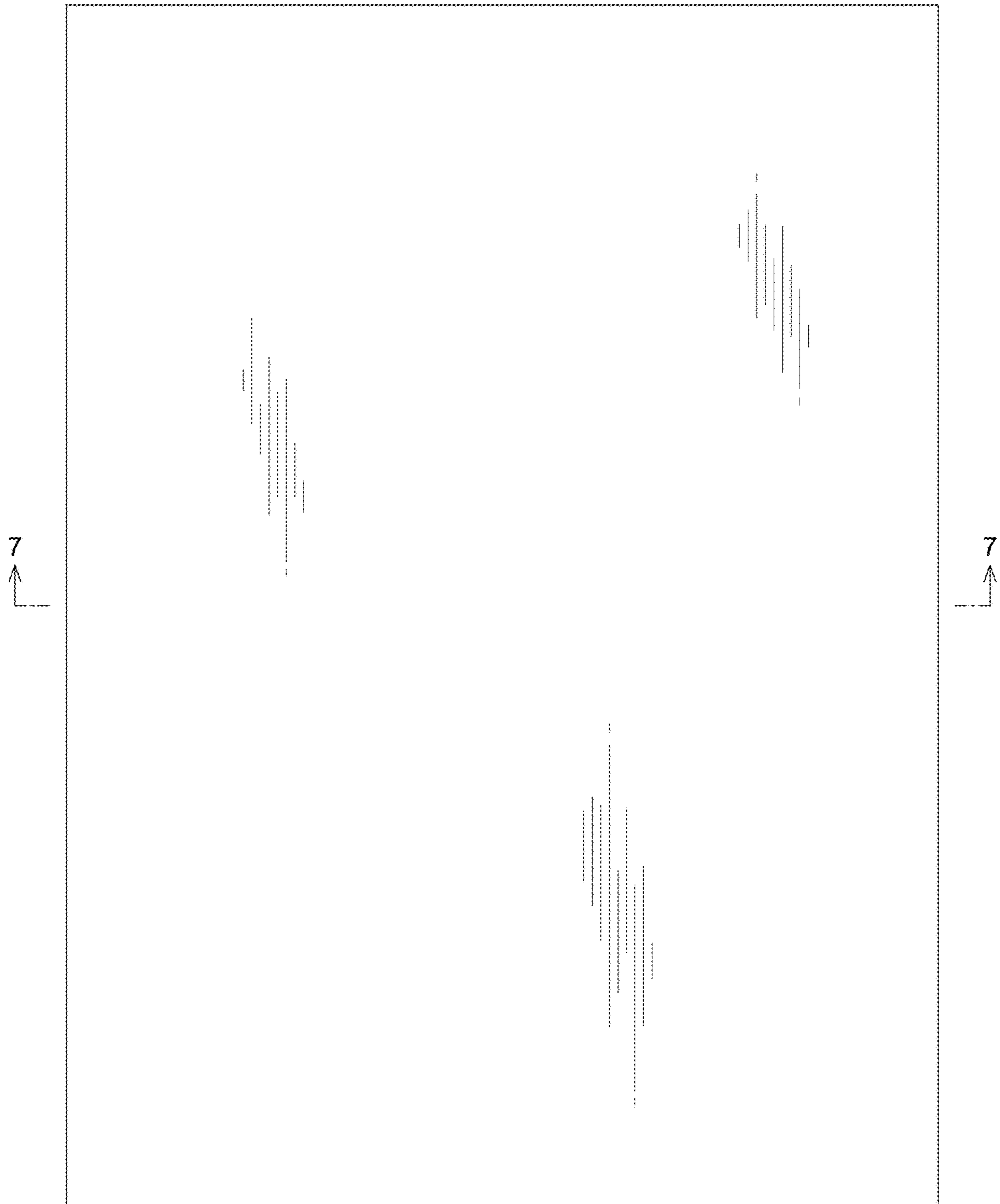

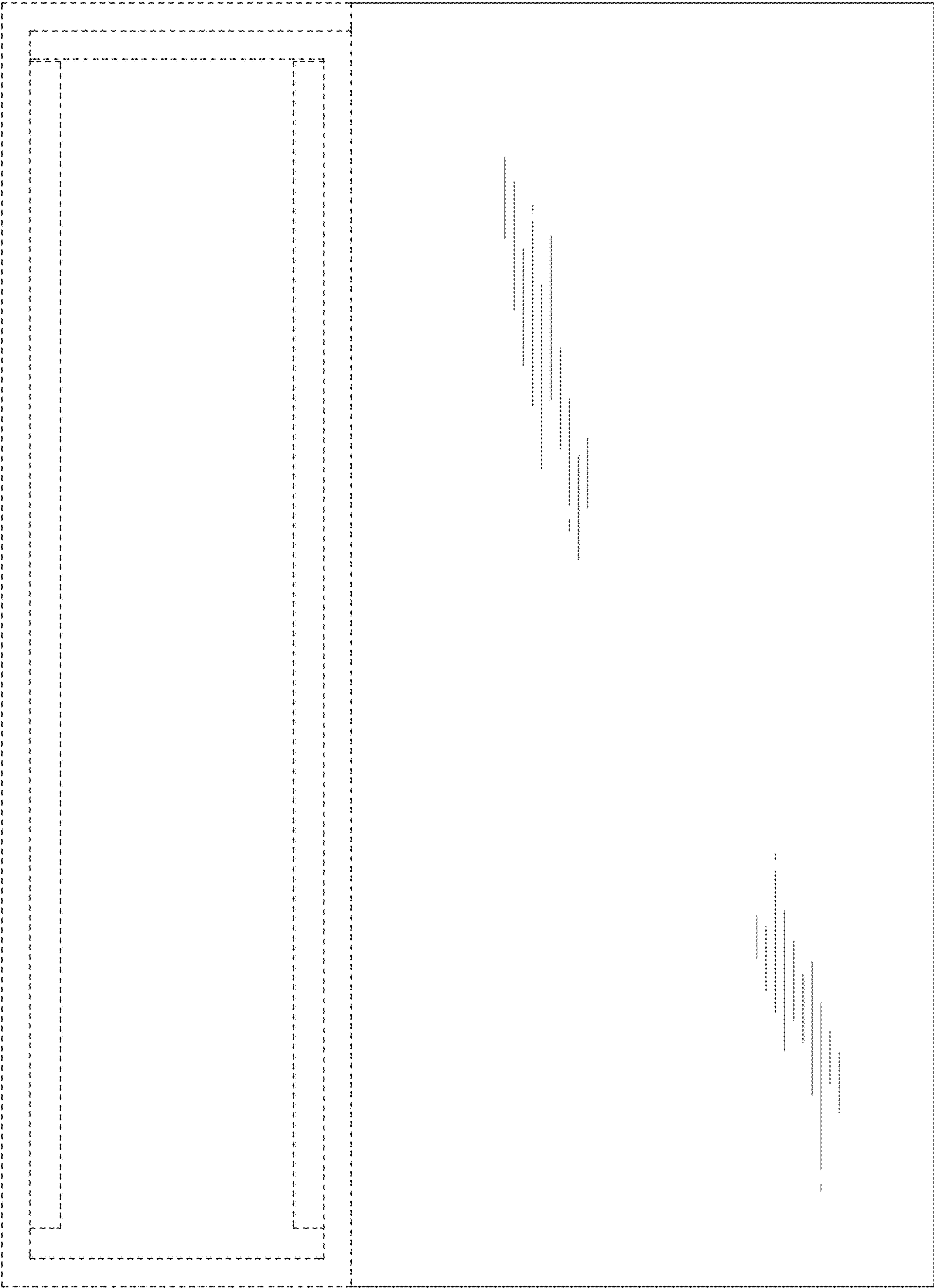

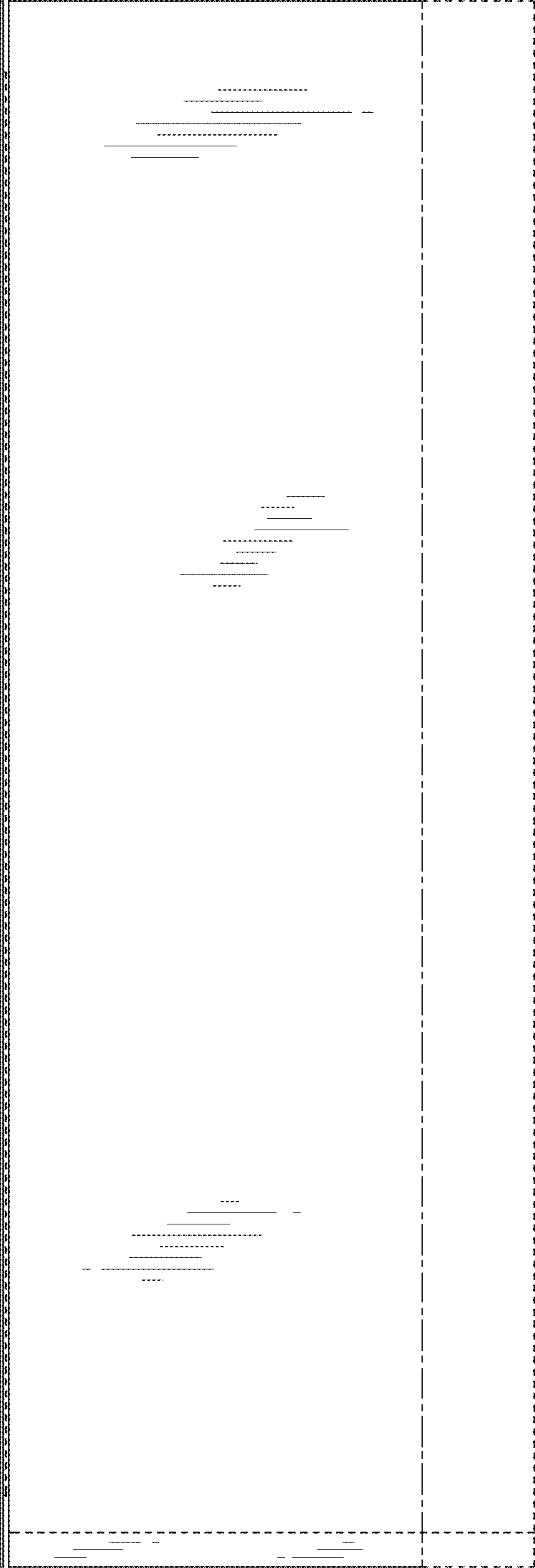

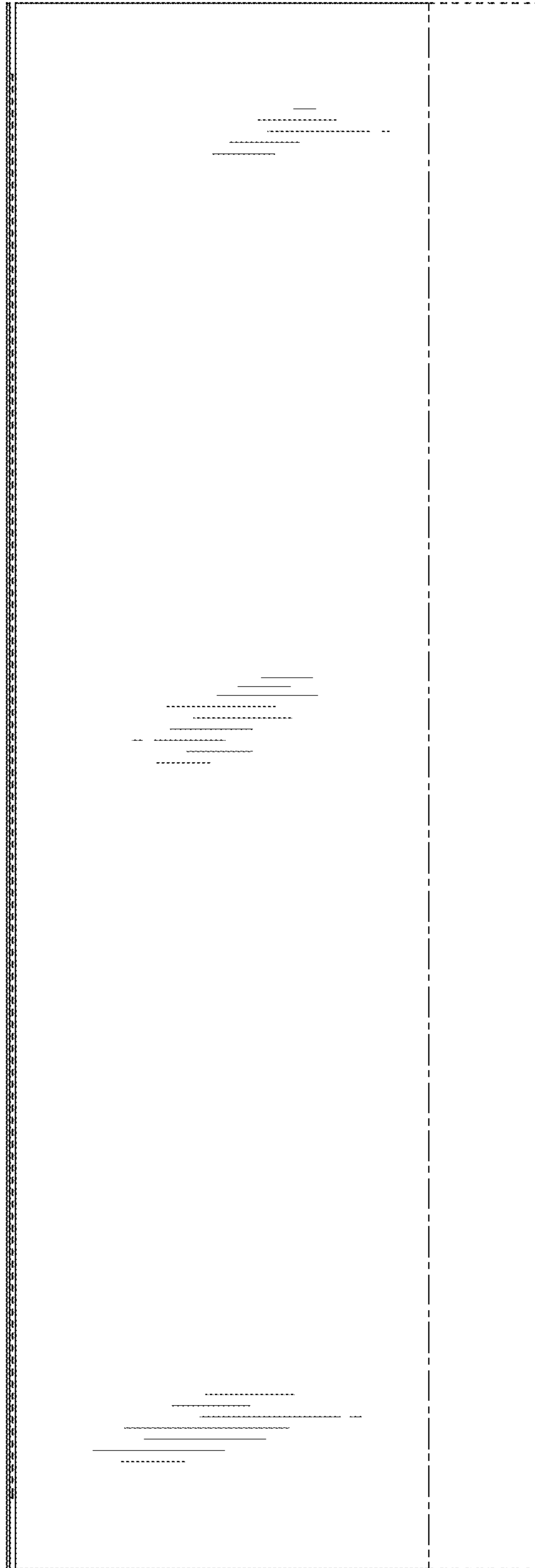

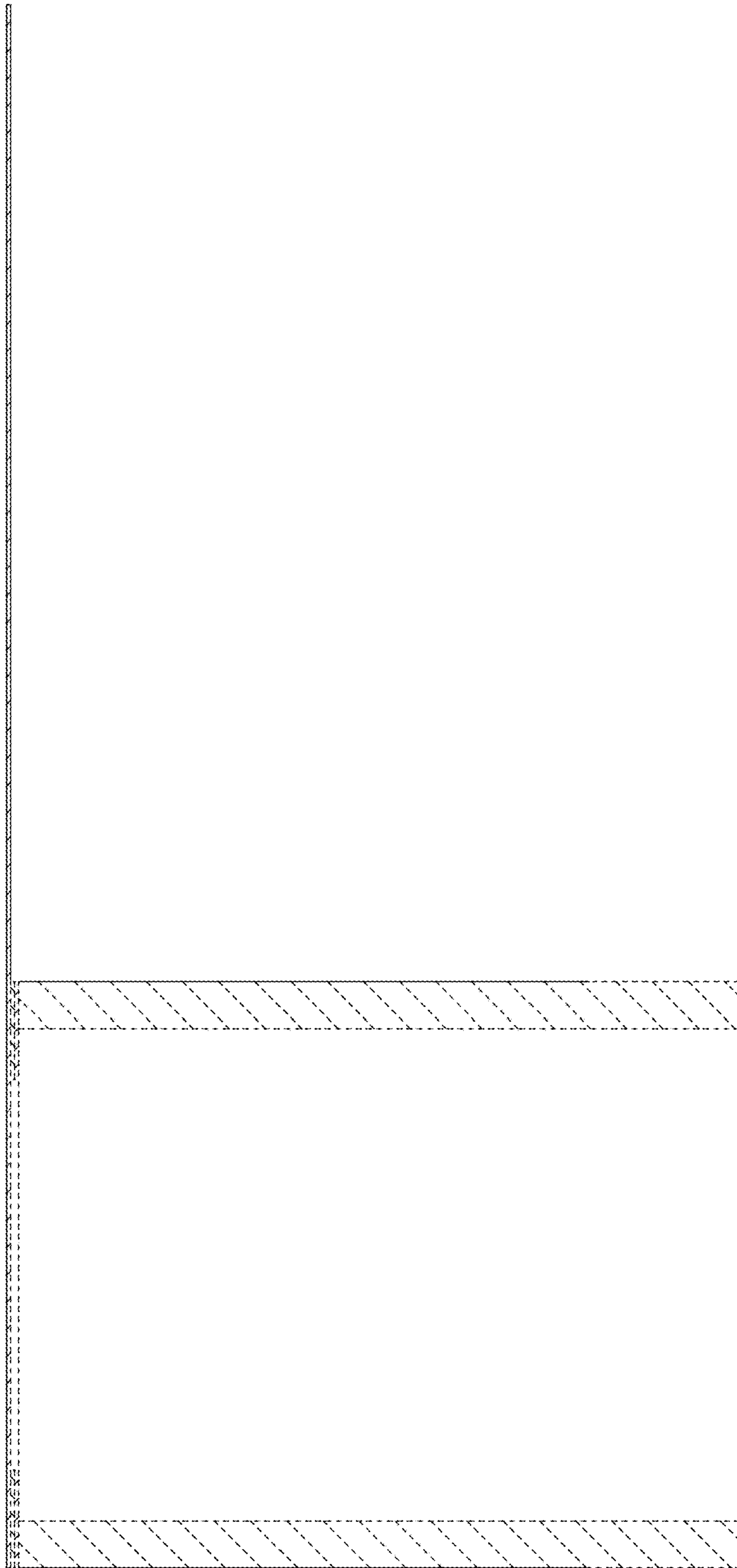

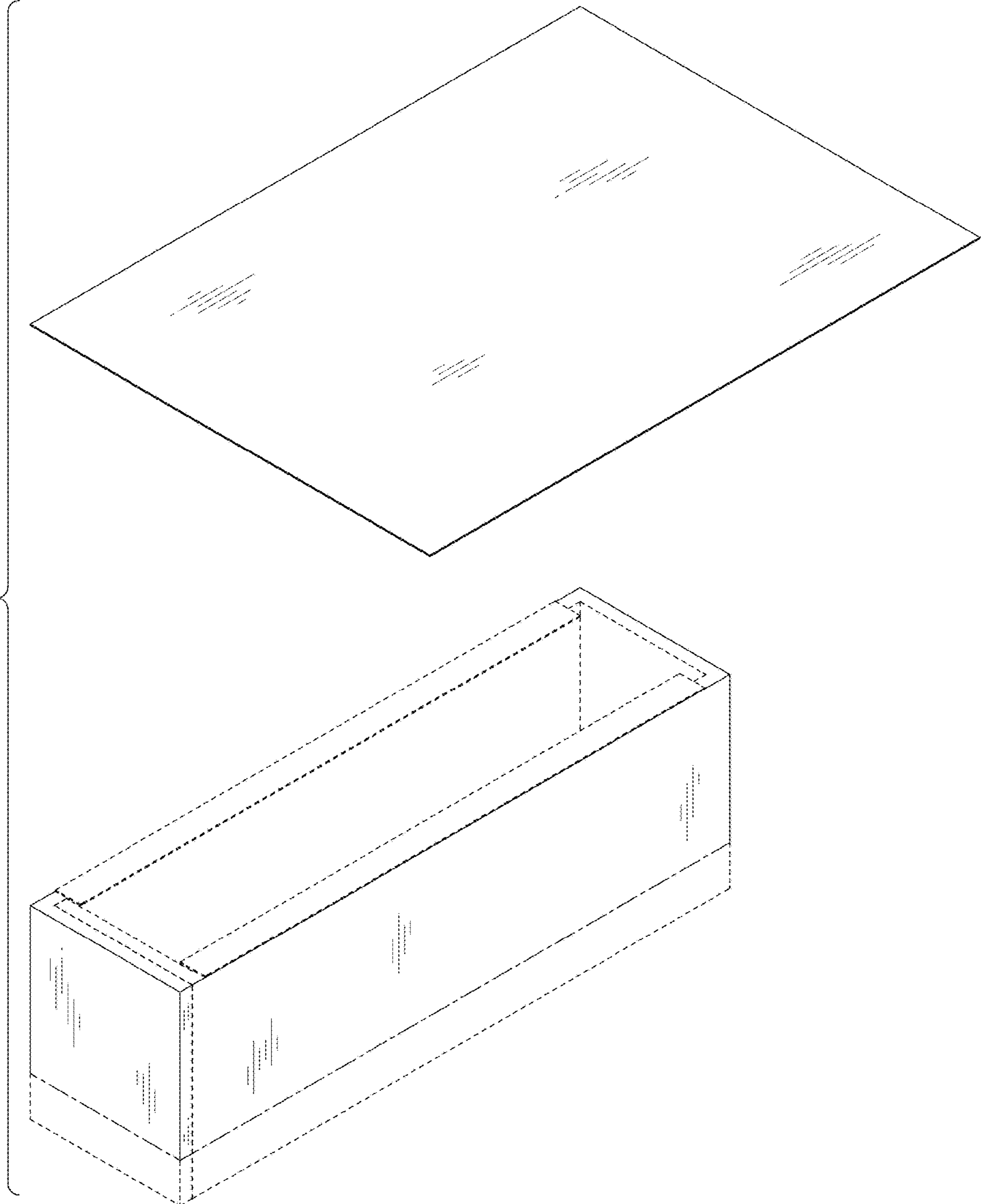

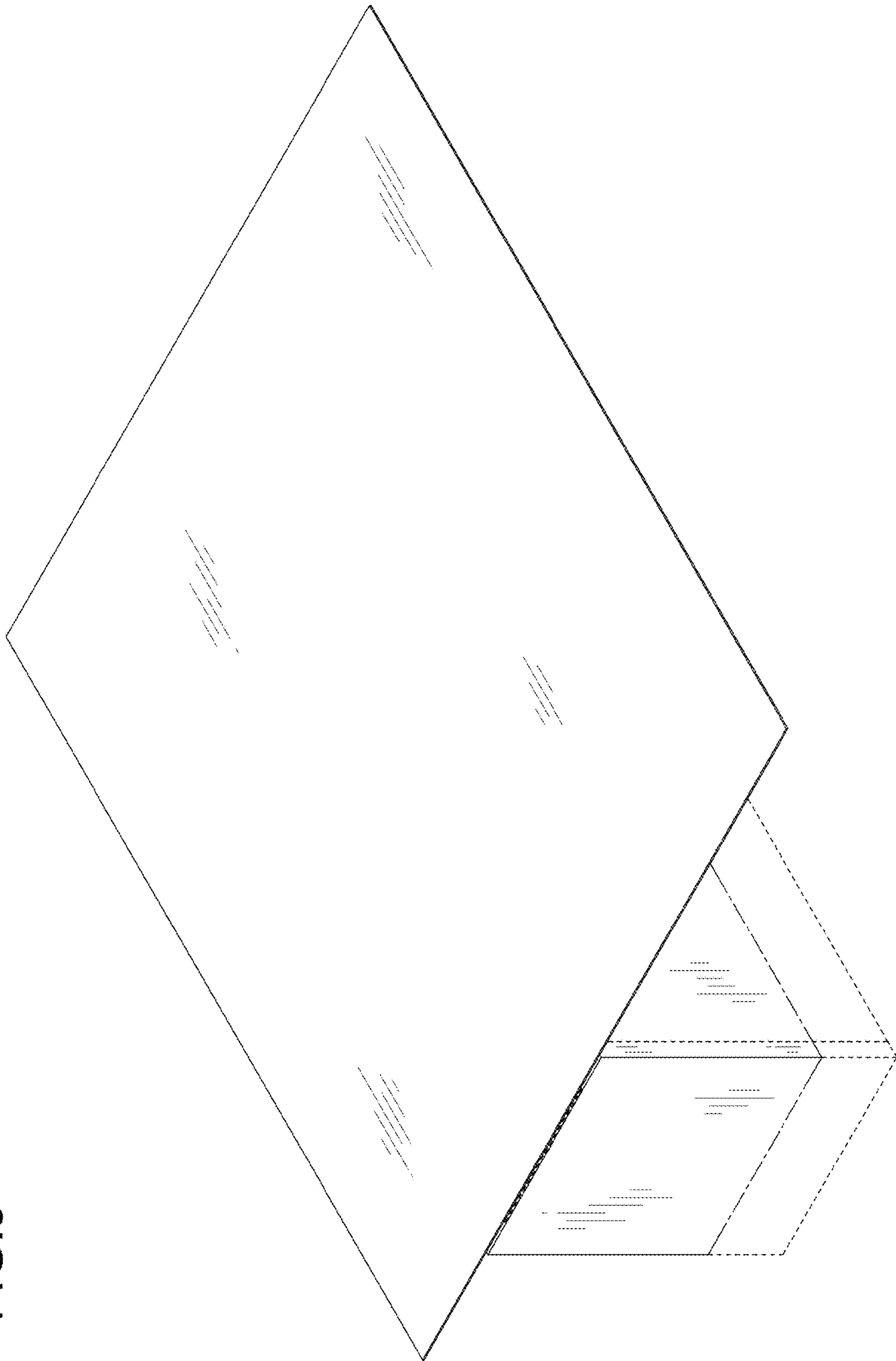

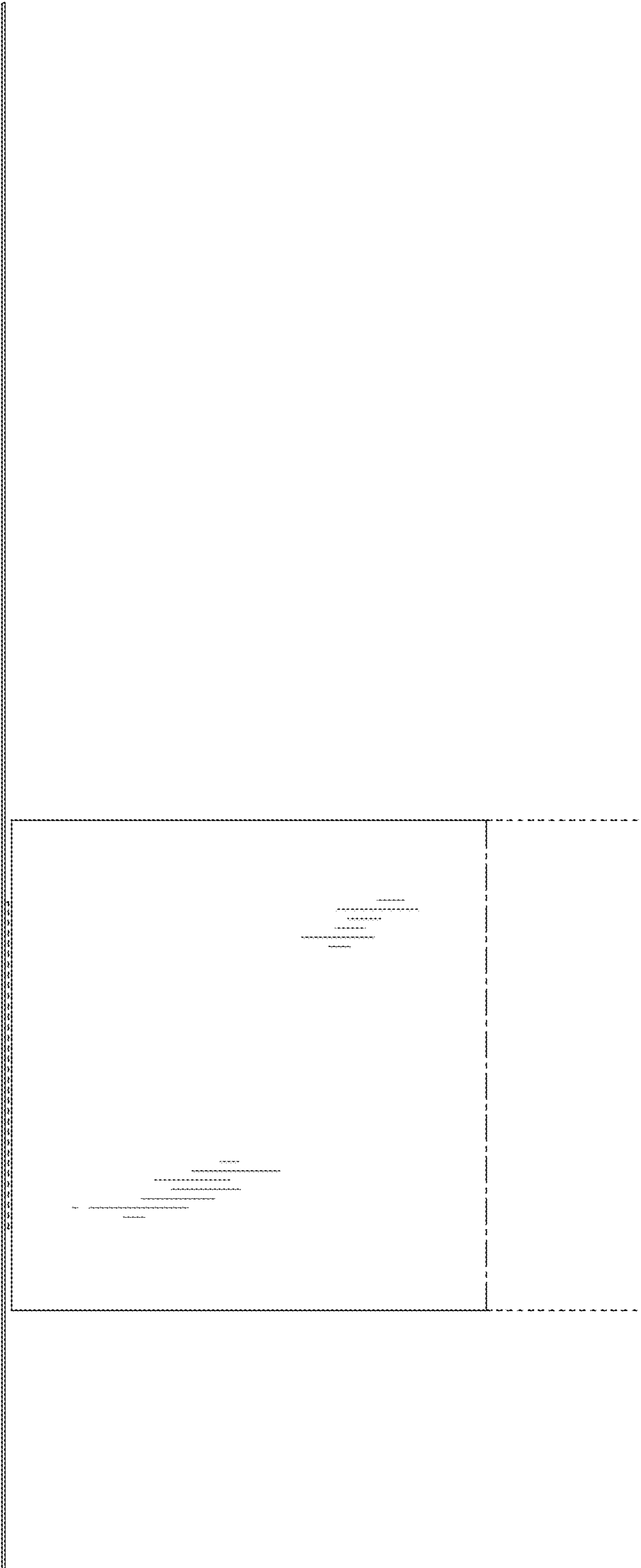

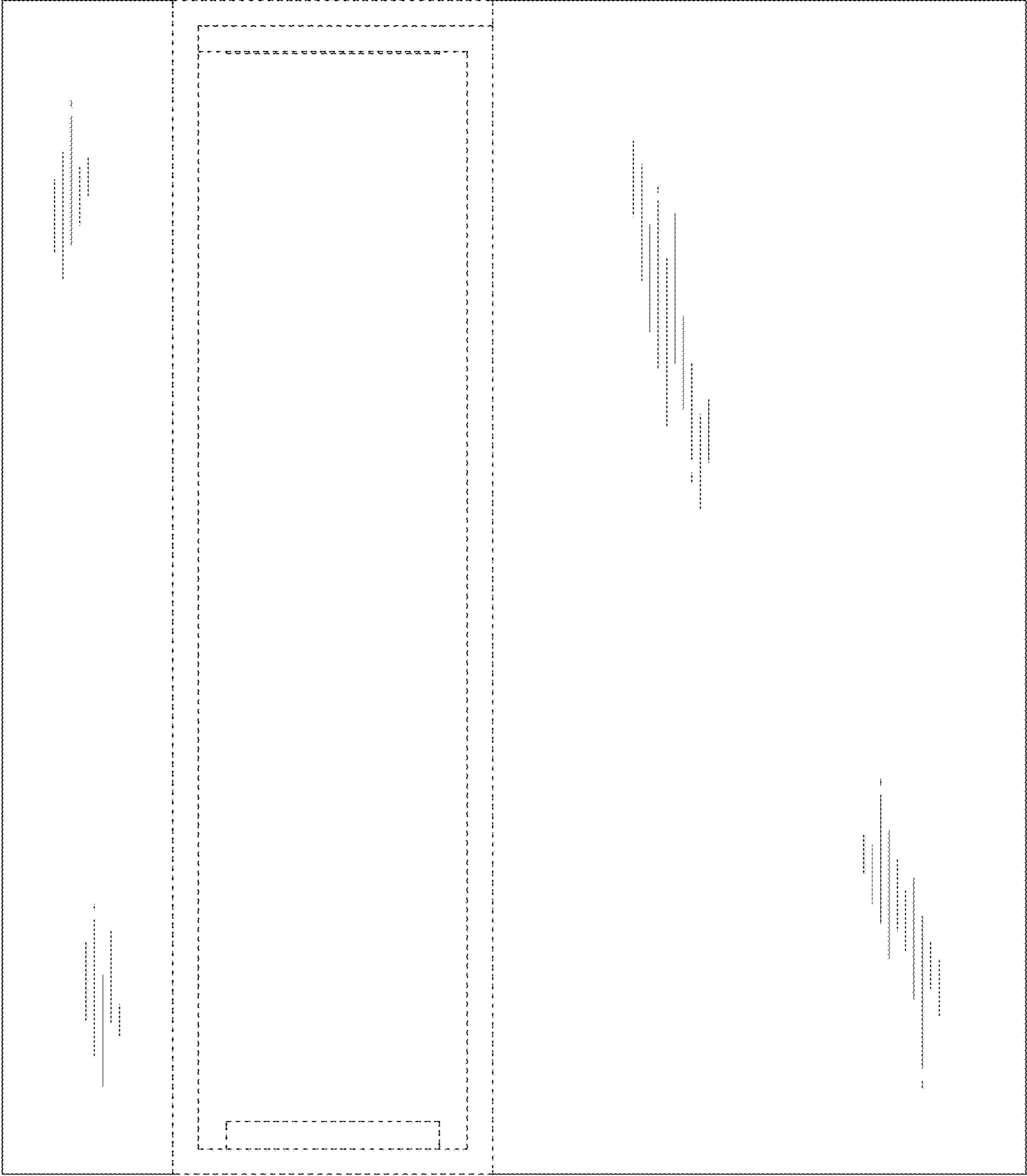

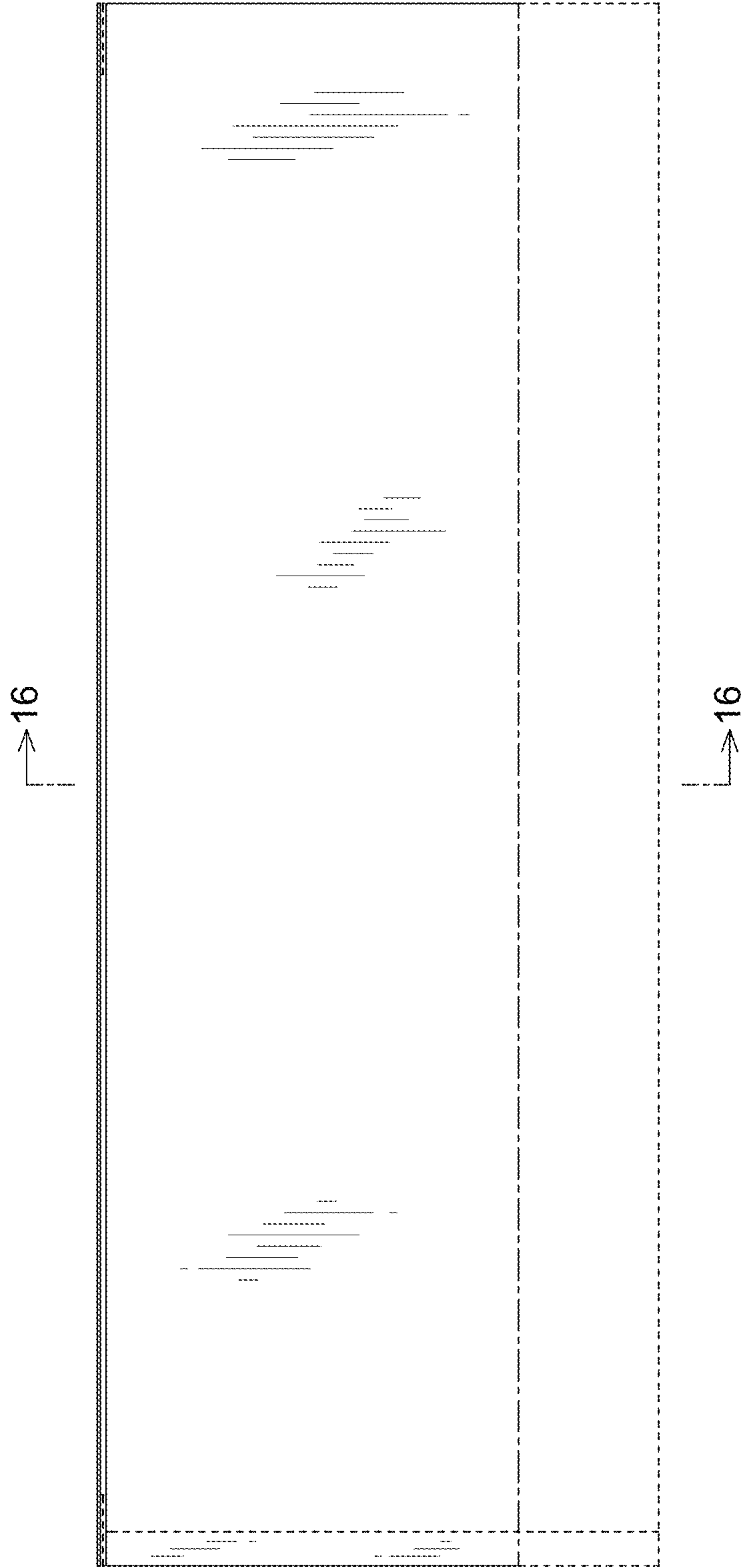

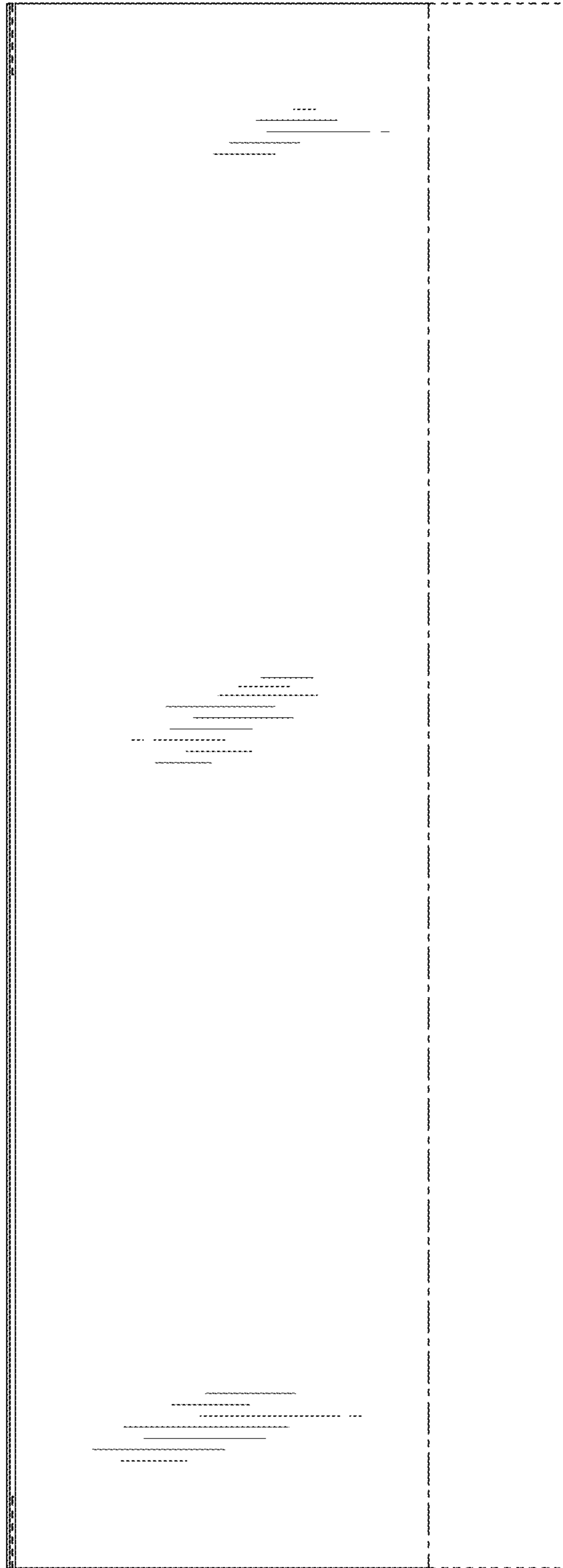

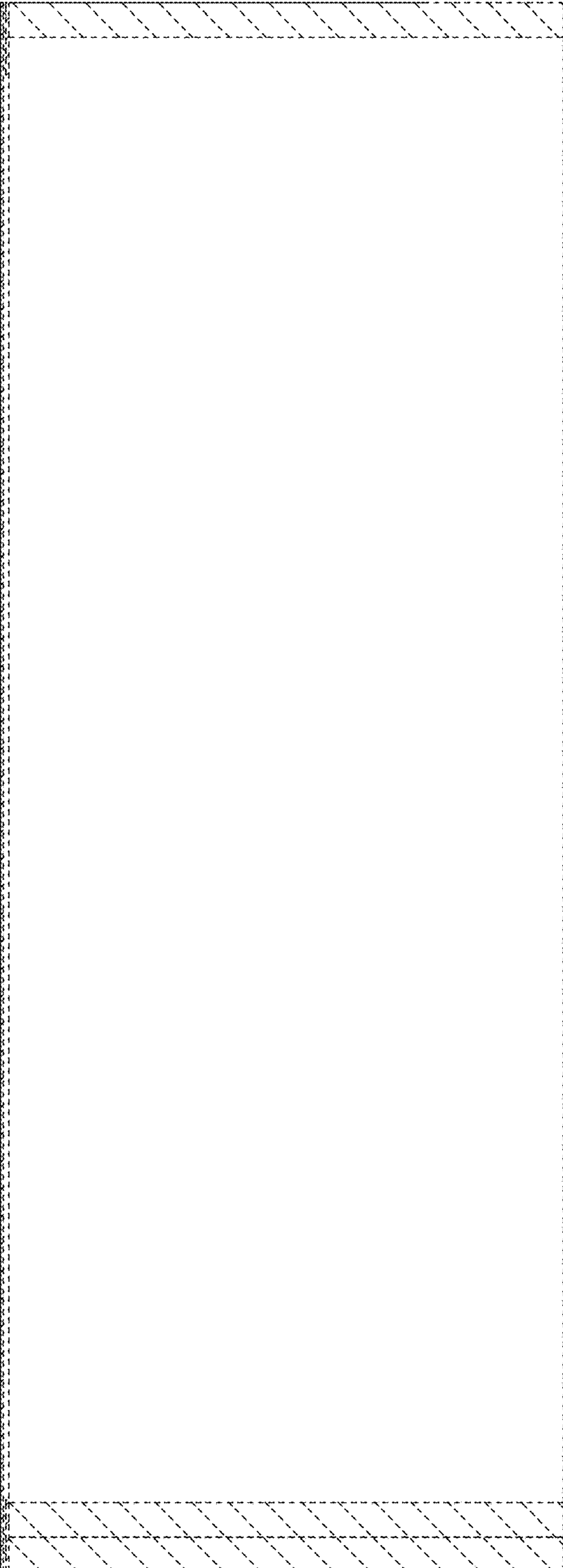

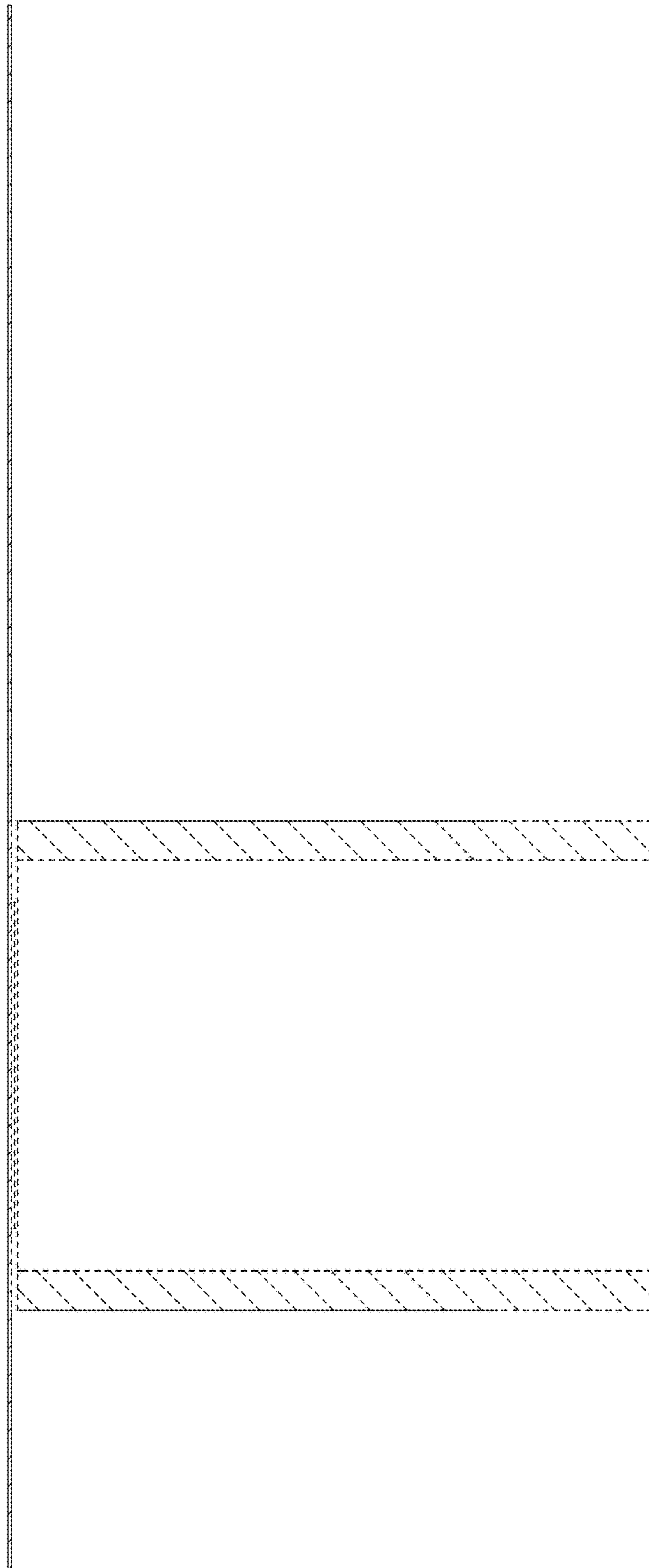
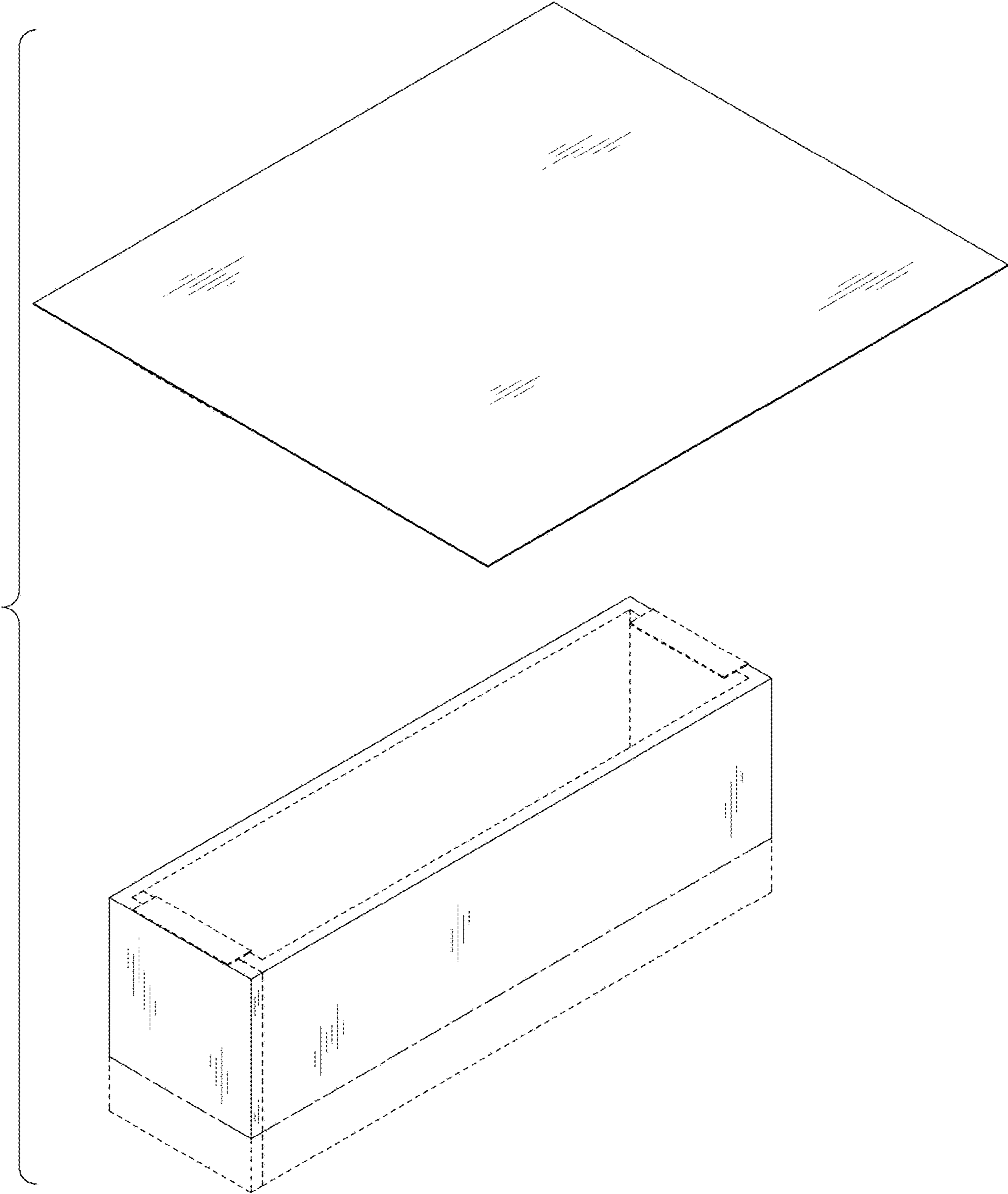

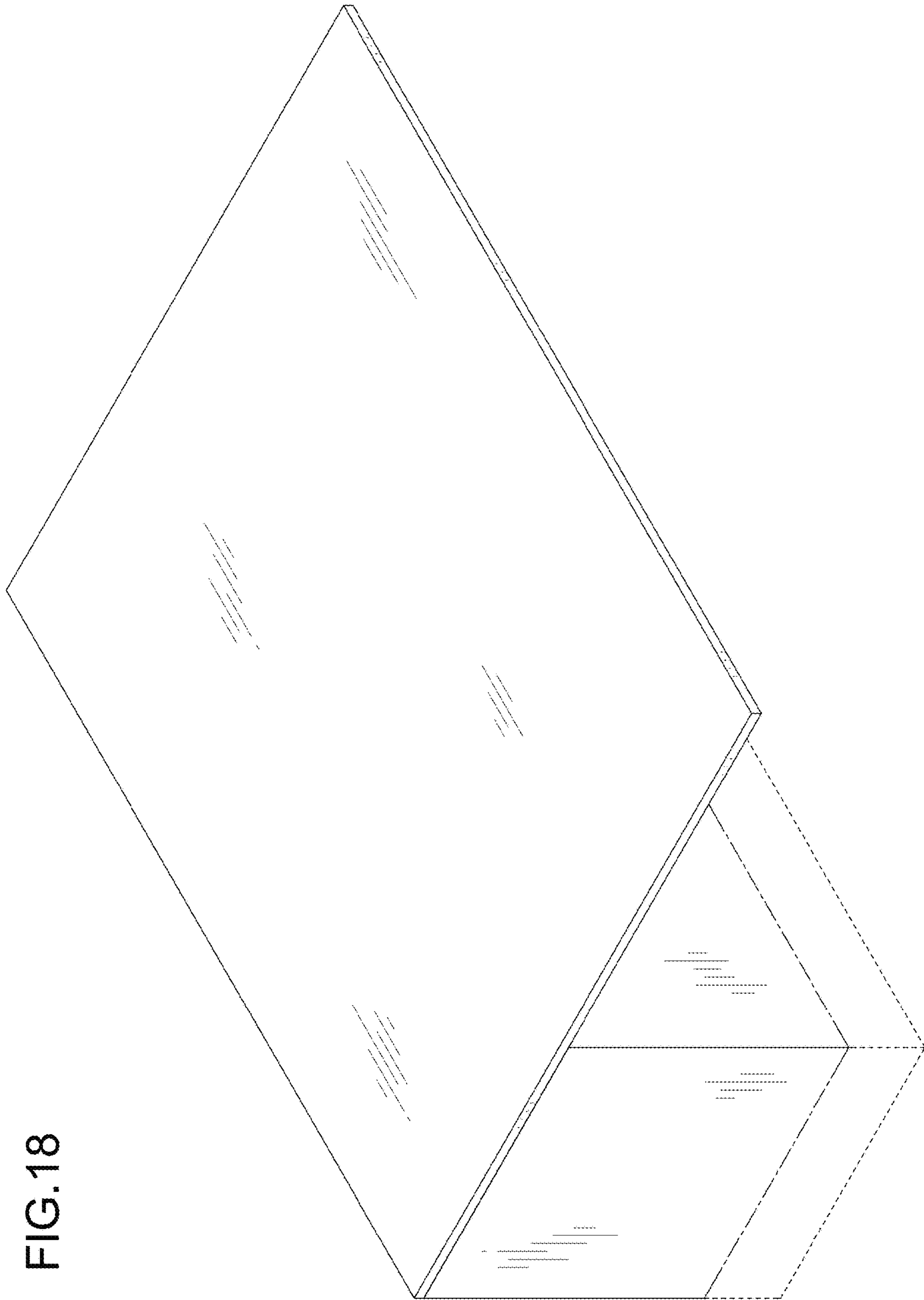

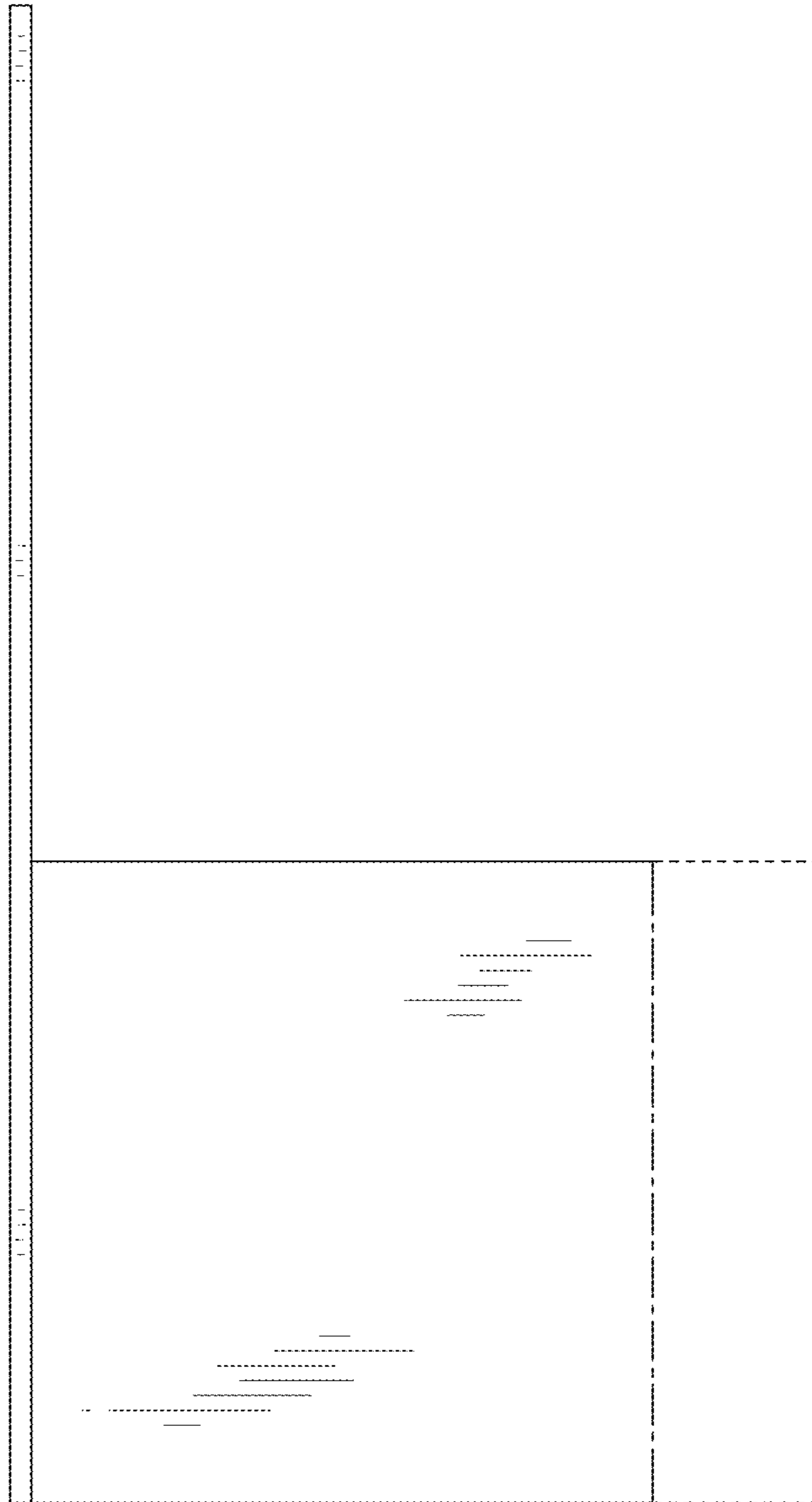

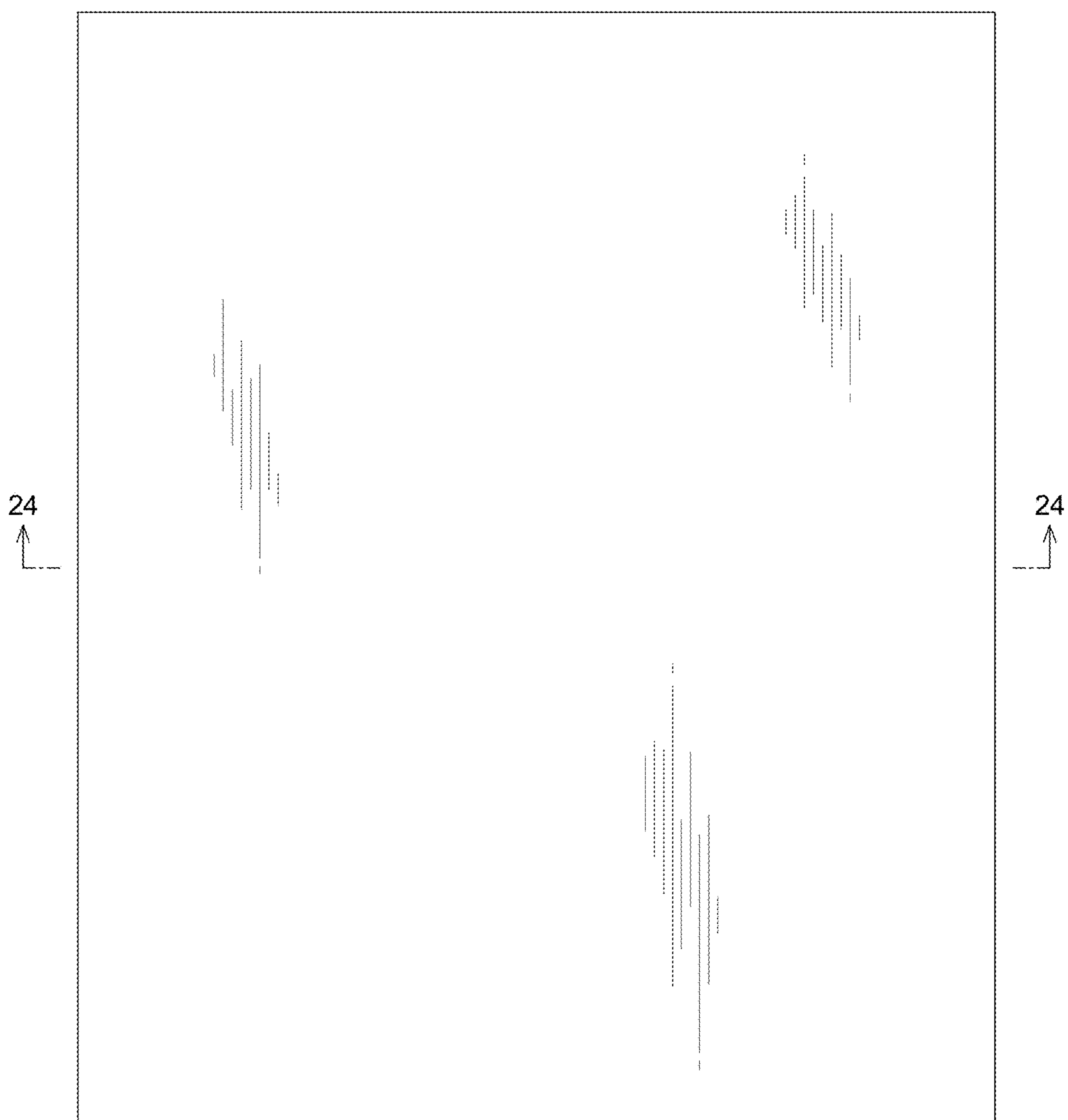

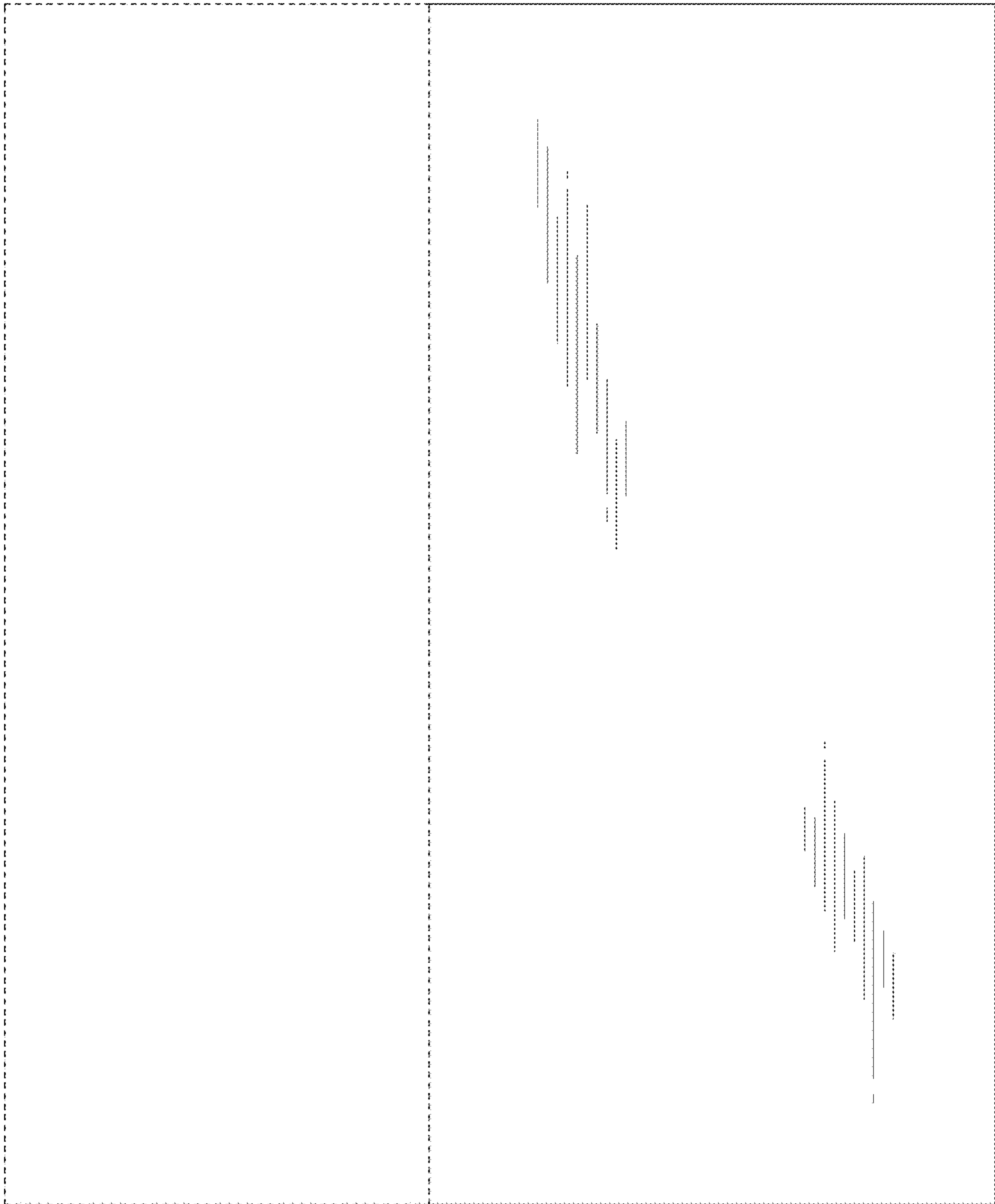

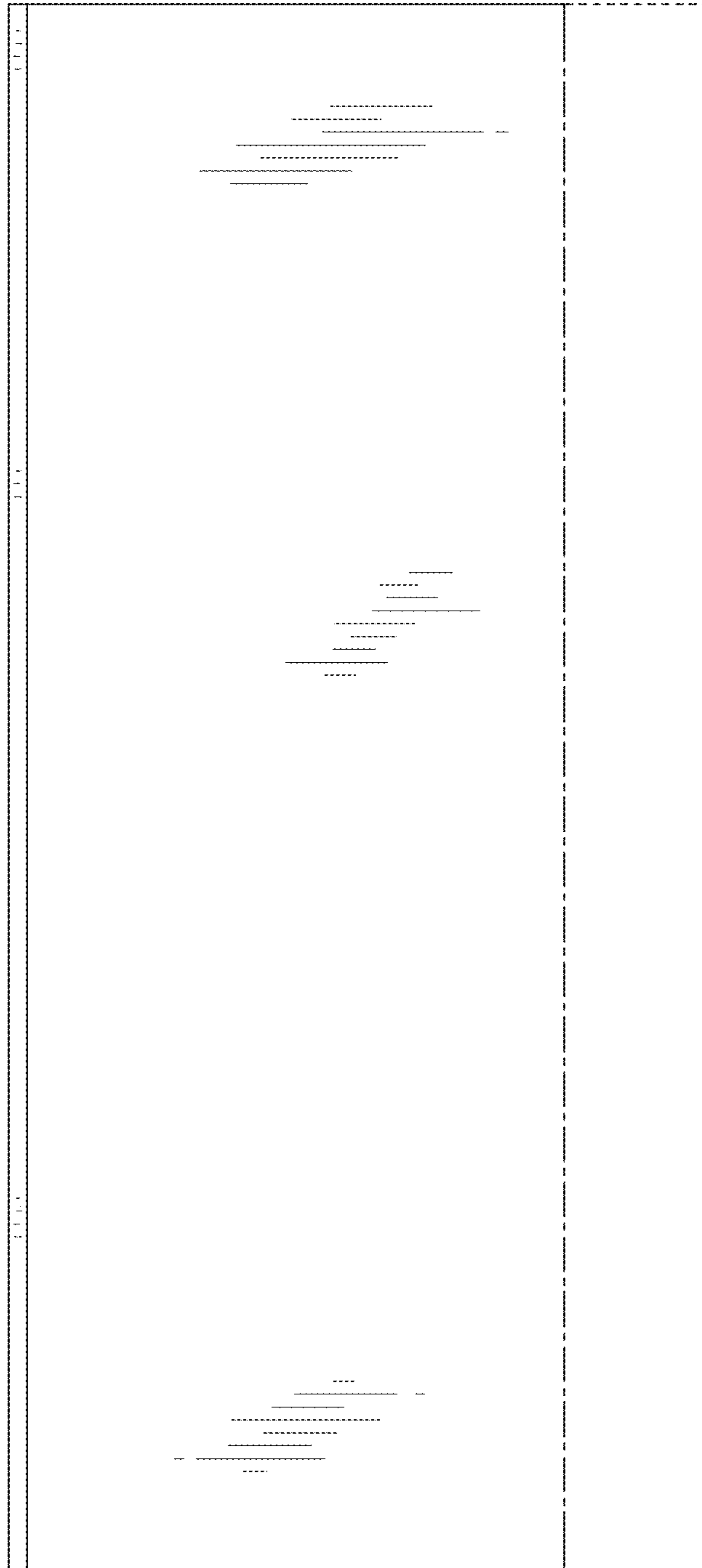
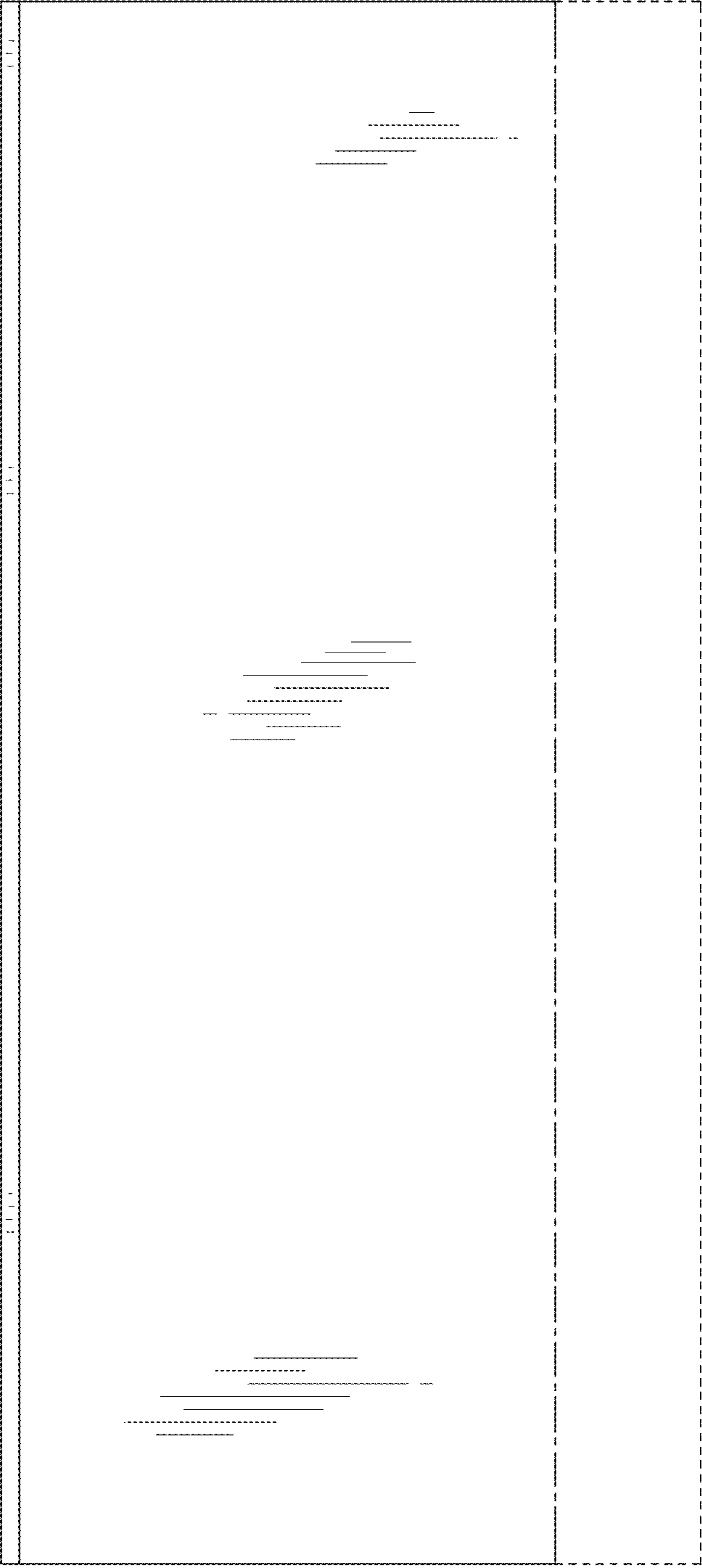

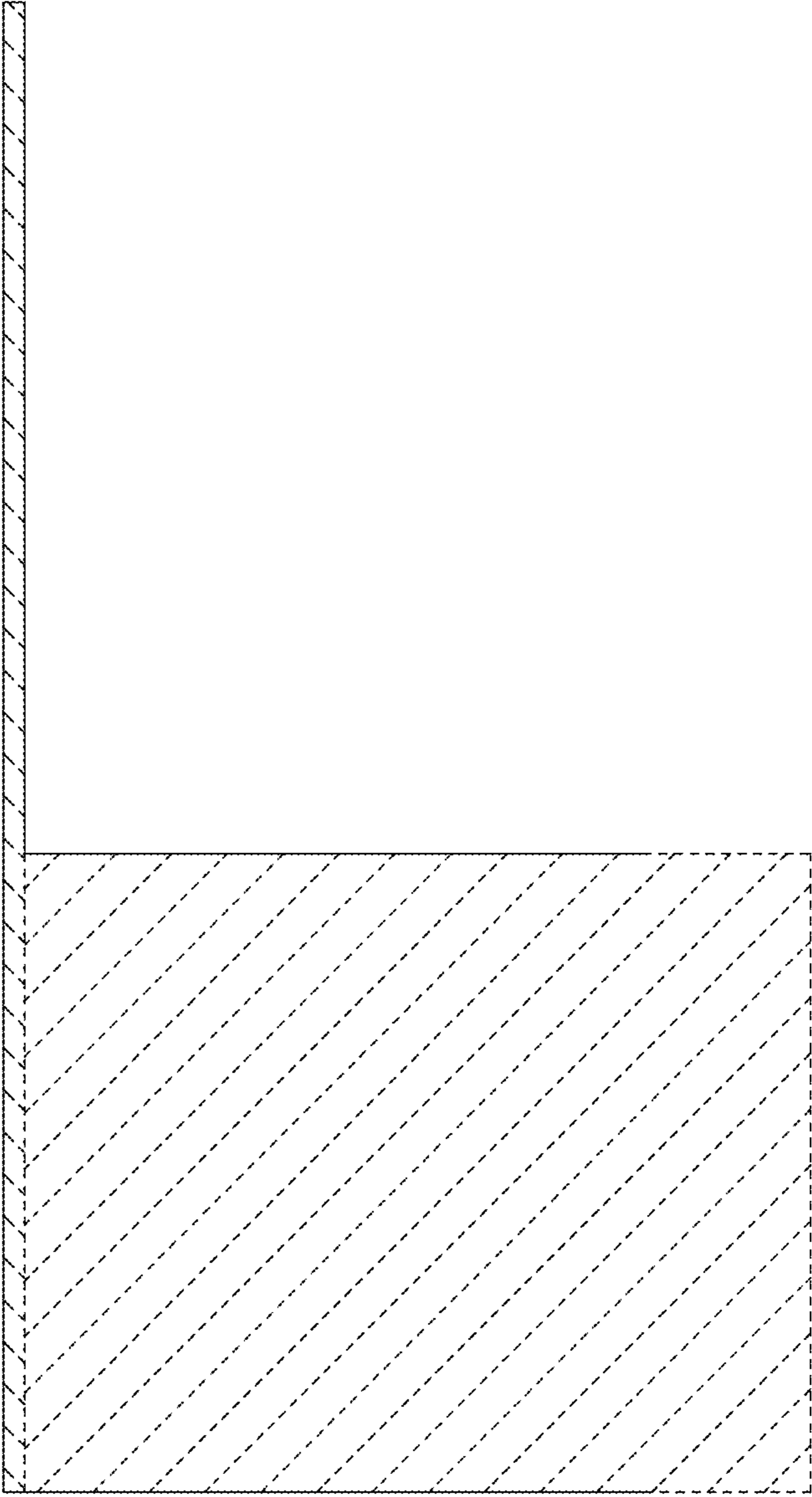
