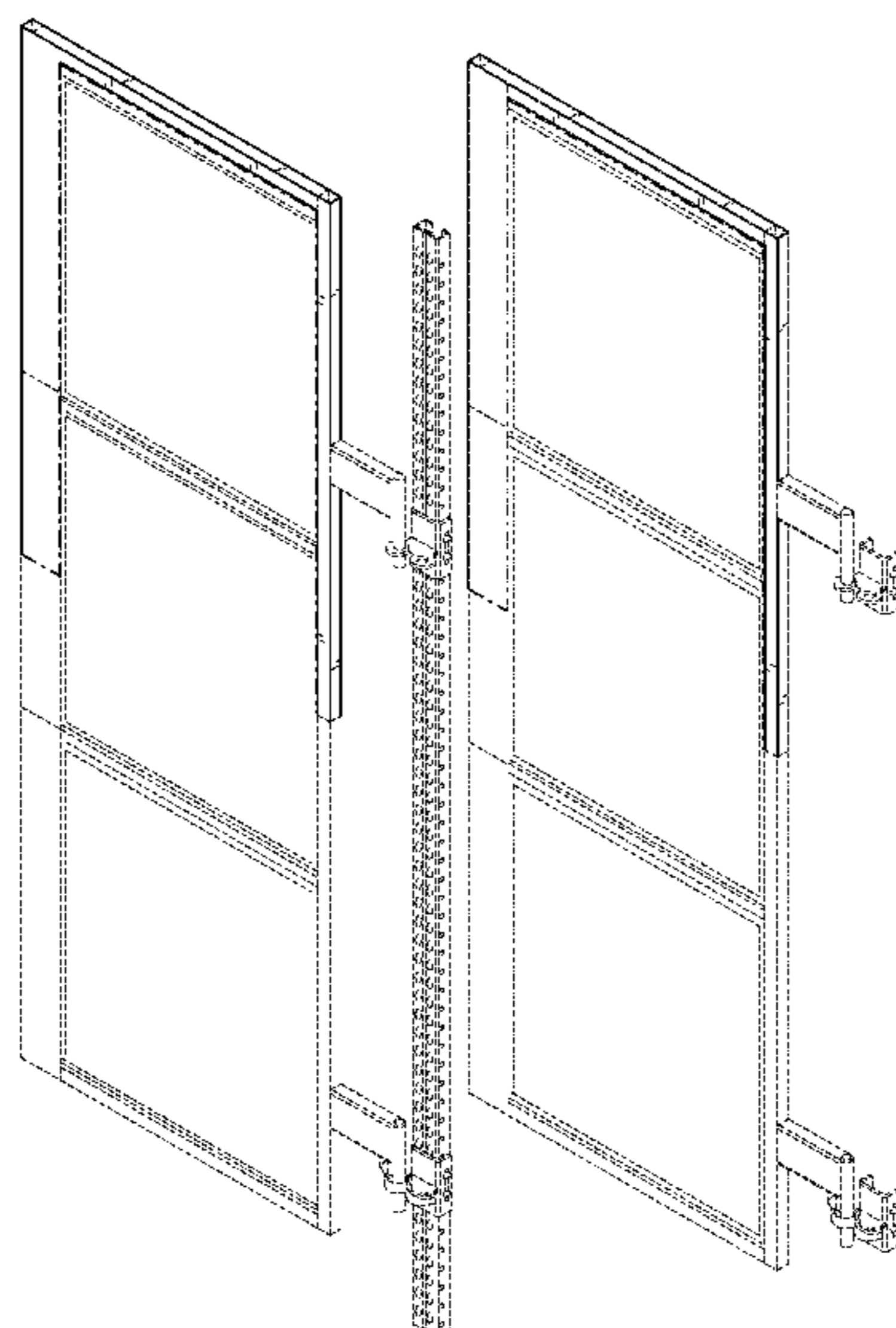
(57) **CLAIM**

I claim the ornamental design for a tile display apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tile display apparatus having my design;
FIG. 2 is another front perspective view of the tile display apparatus of FIG. 1;
FIG. 3 is a front view of the tile display apparatus of FIG. 1;
FIG. 4 is a back view of the tile display apparatus of FIG. 1; and,
FIG. 5 is a right-side view of the tile display apparatus of FIG. 1.
The left side and top of the tile display apparatus are fully disclosed in the perspective views of FIGS. 1 and 2, and therefore separate left-side and top views are omitted. Features illustrated with evenly broken lines are portions of the article that form no part of the claimed design. The dot-dash line demarcates boundaries of the claim.

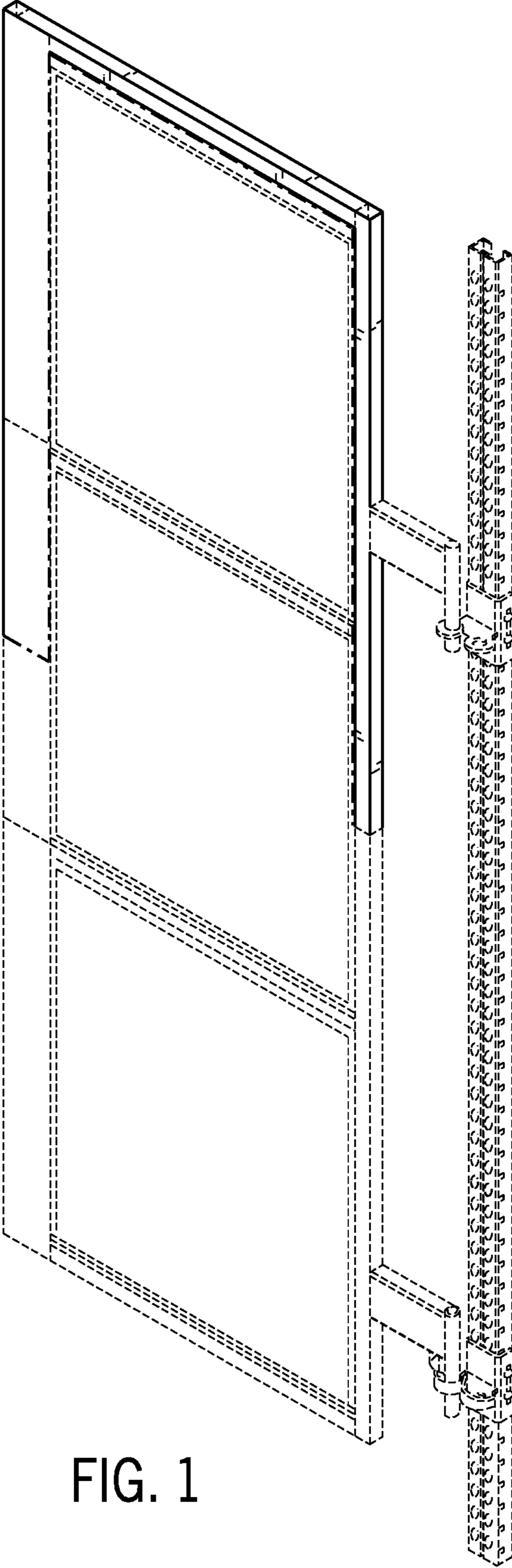

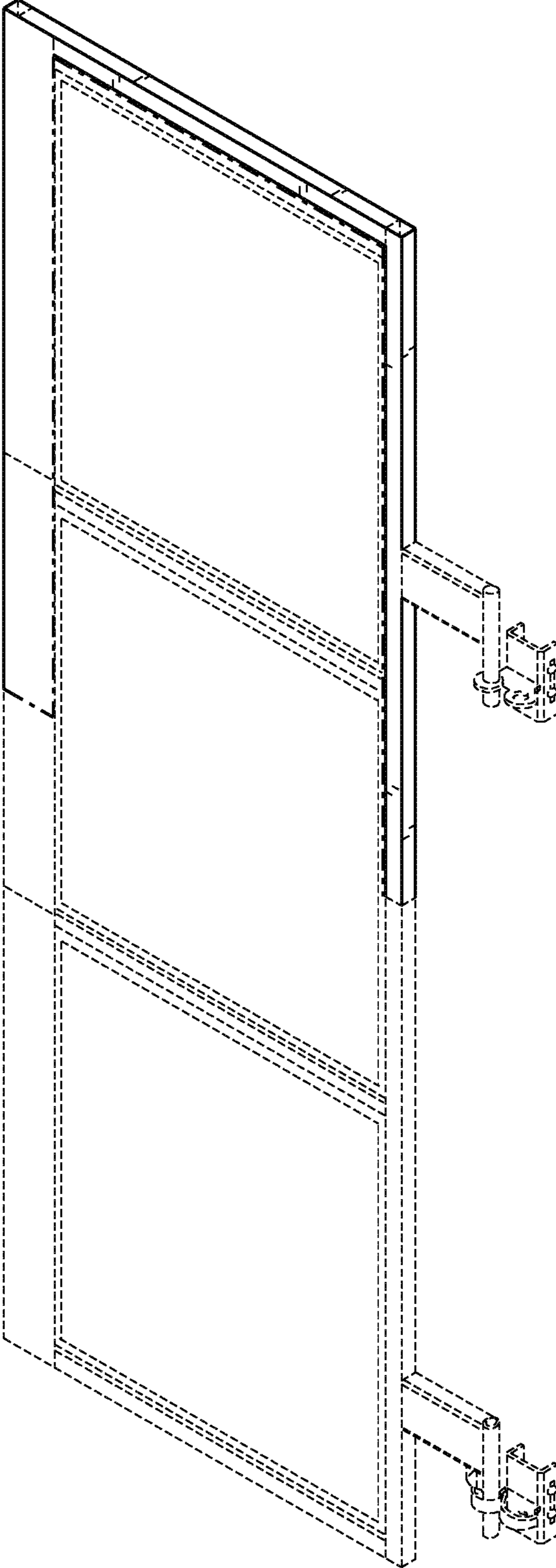
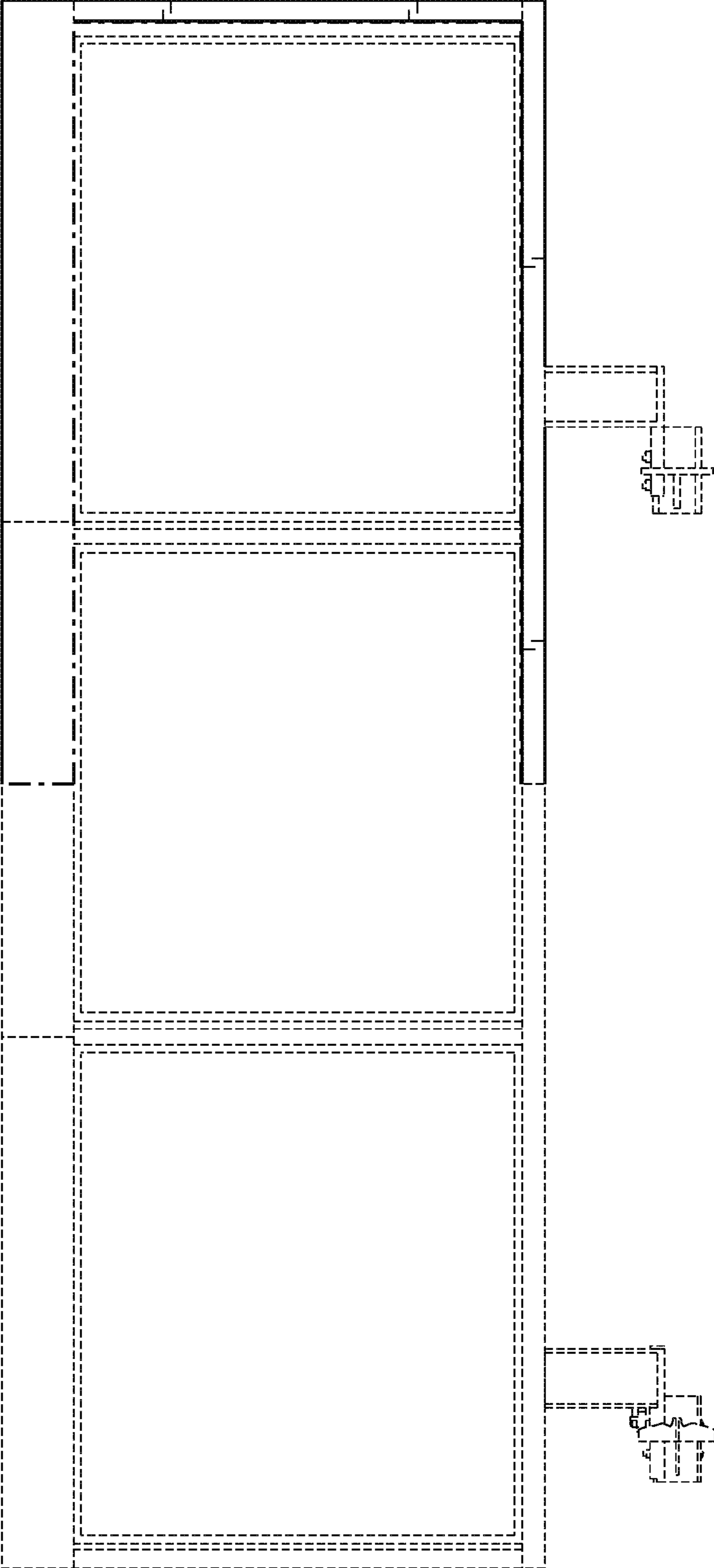

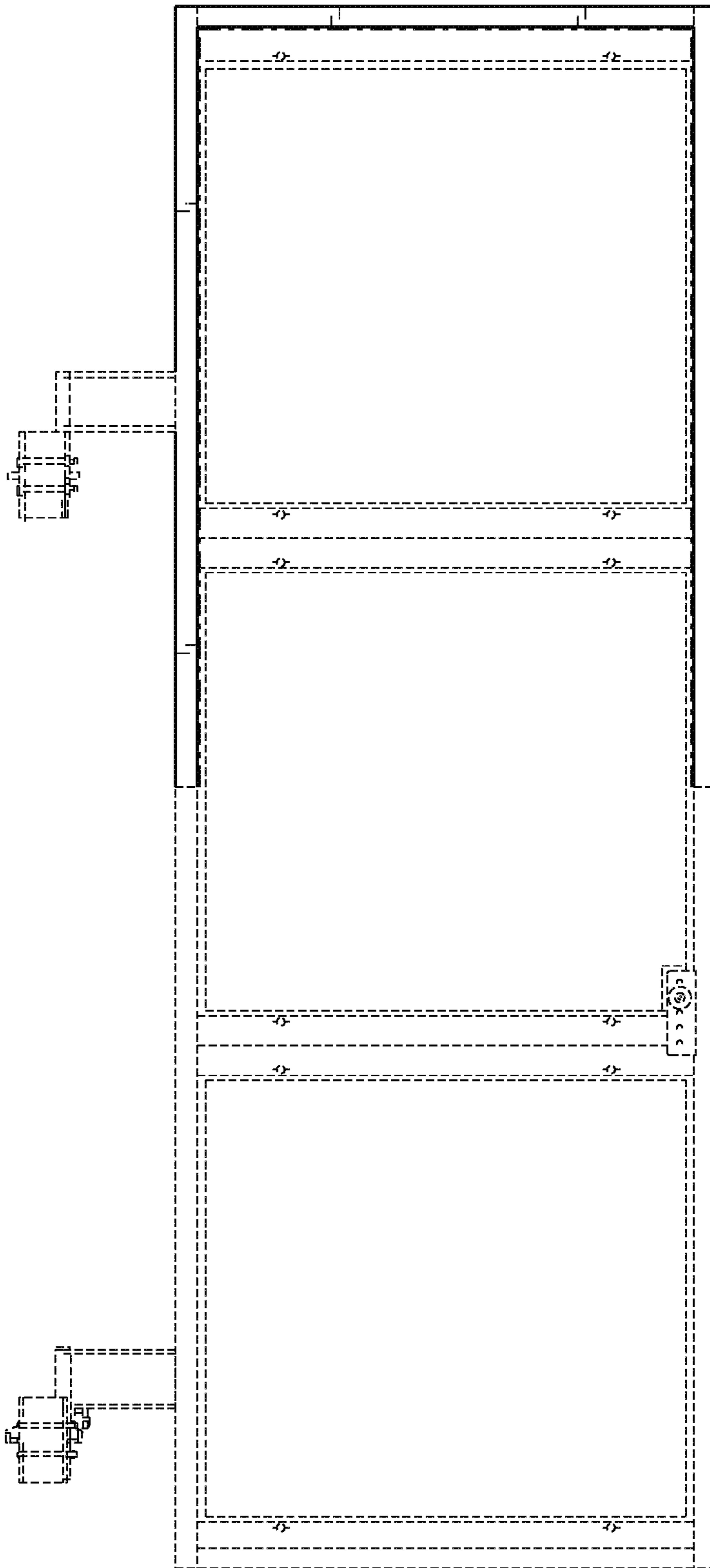

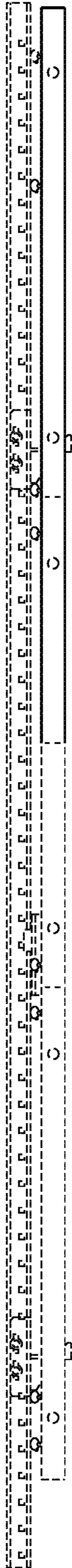
