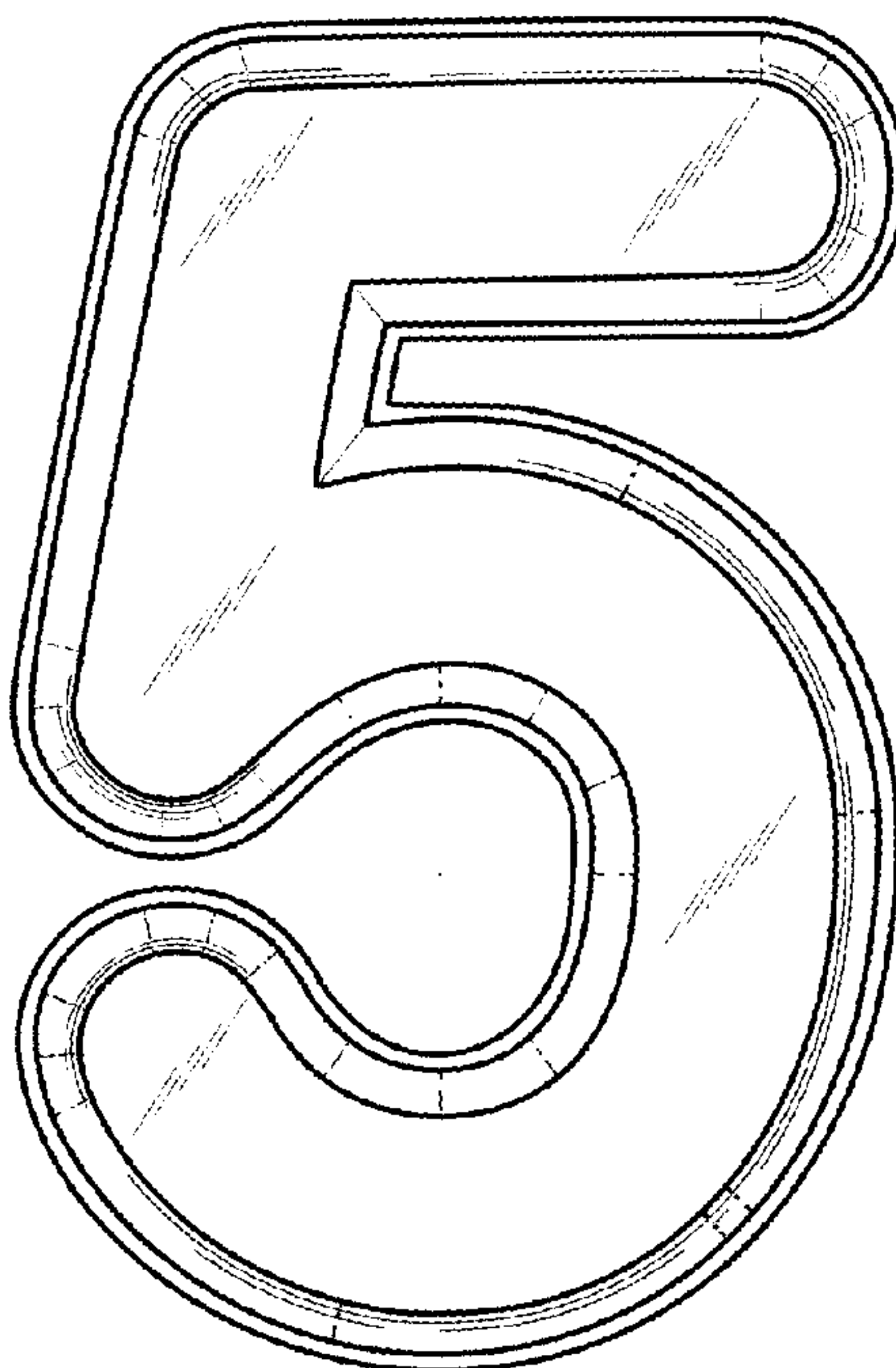
FIG. 1 is a front side elevation of the disposable decorative number shaped baking pan

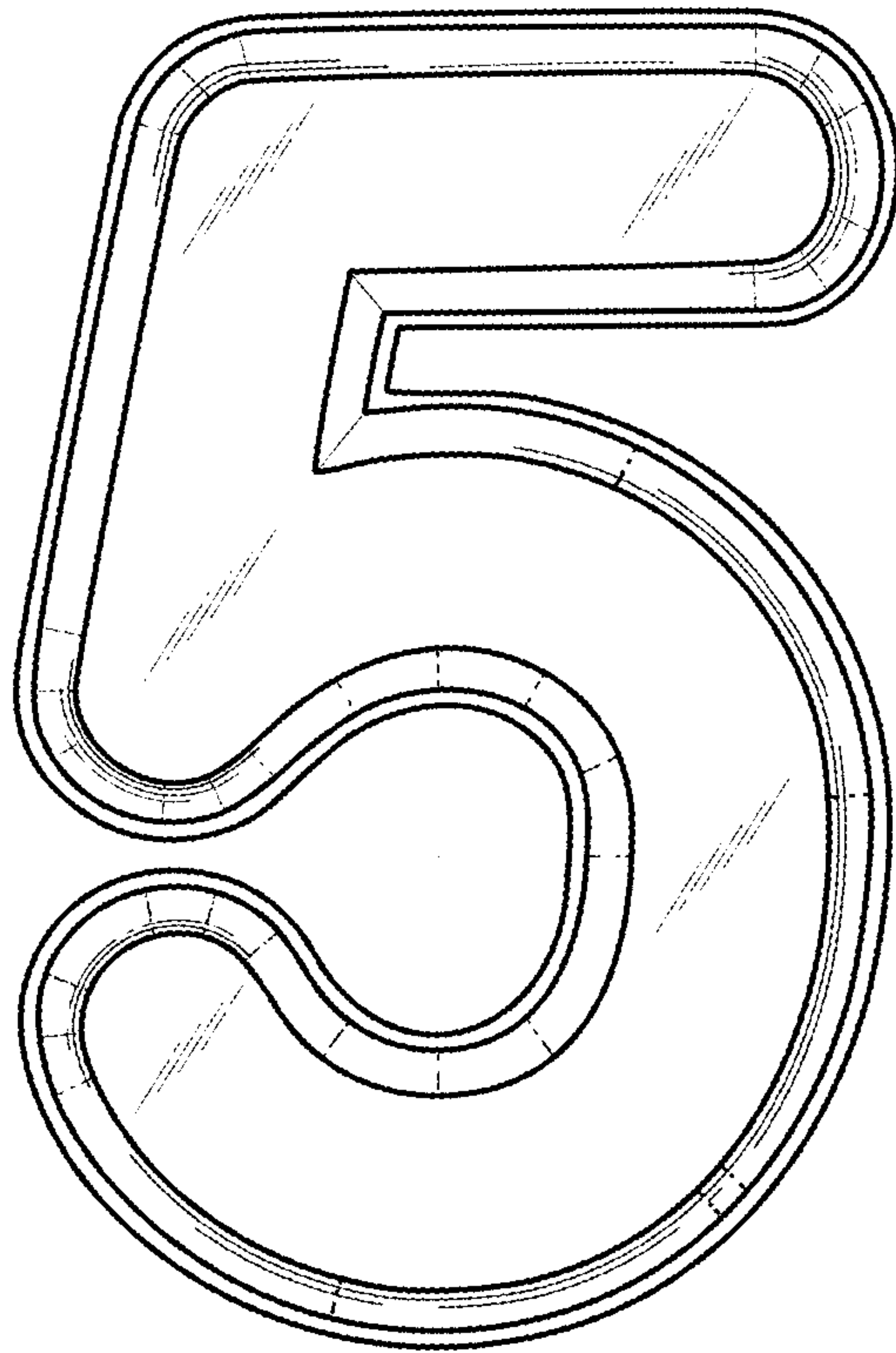

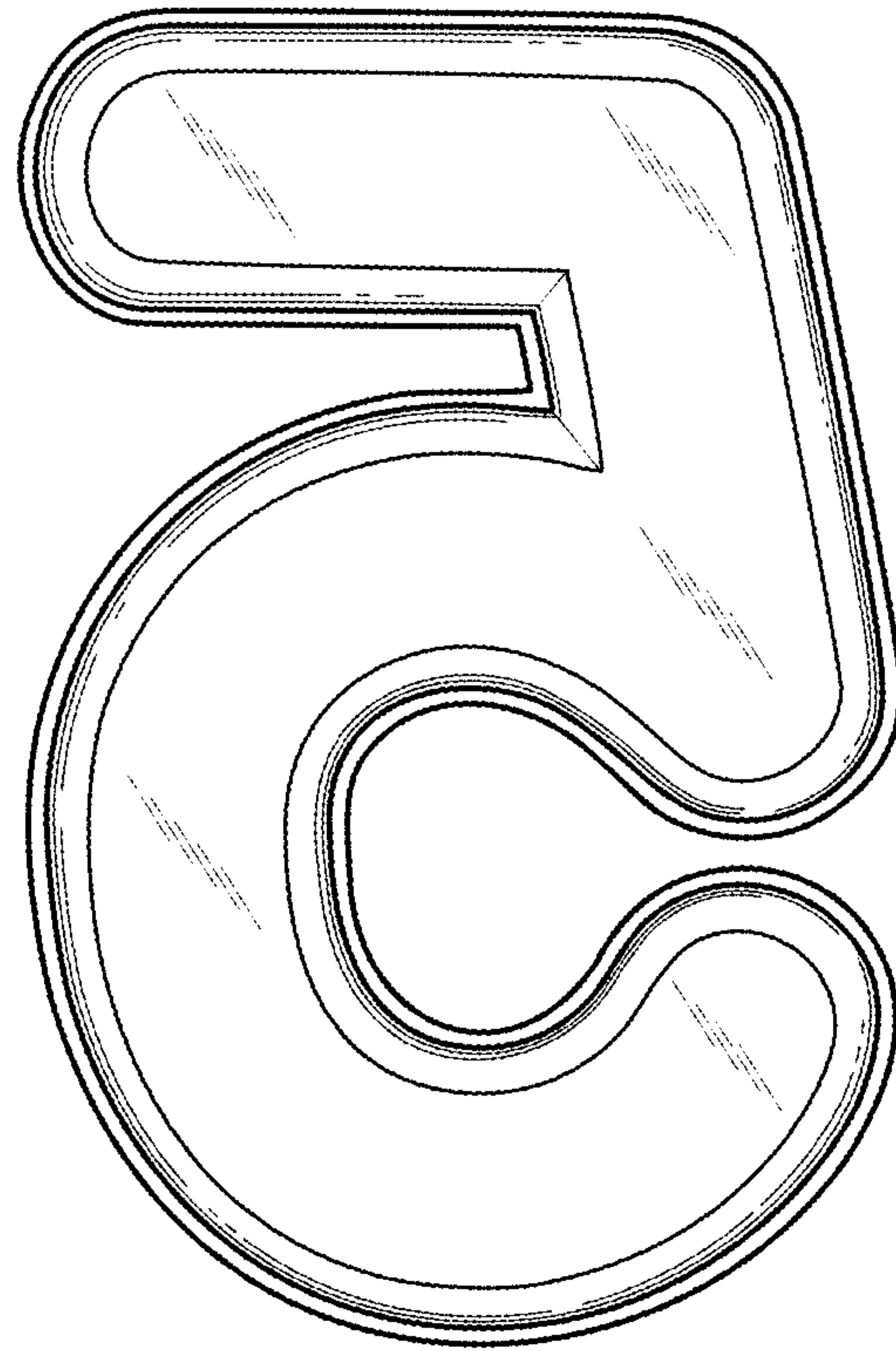

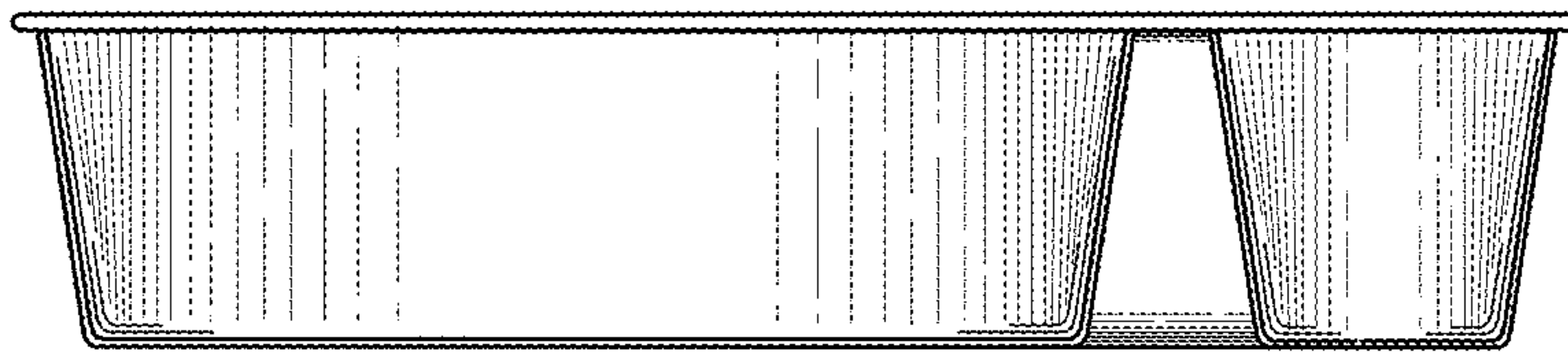

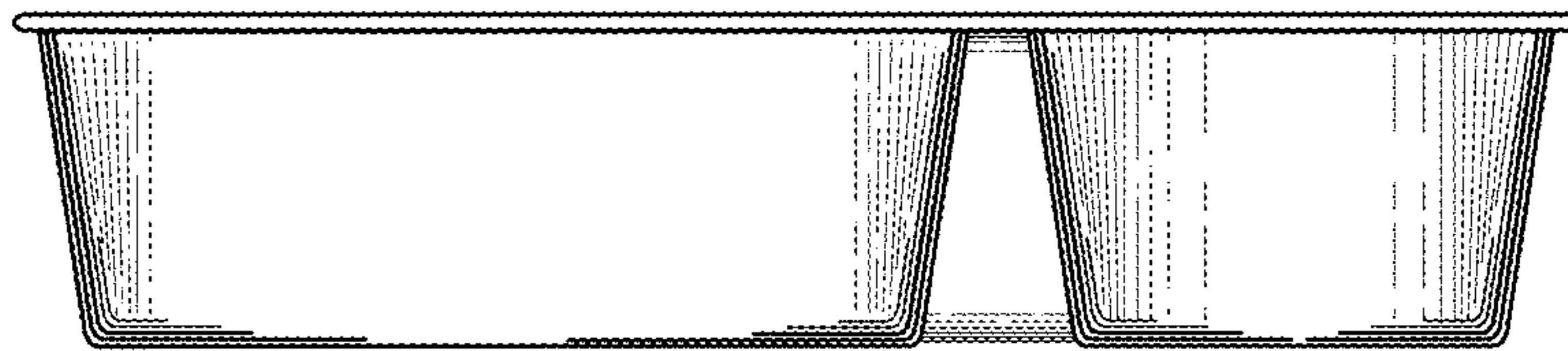

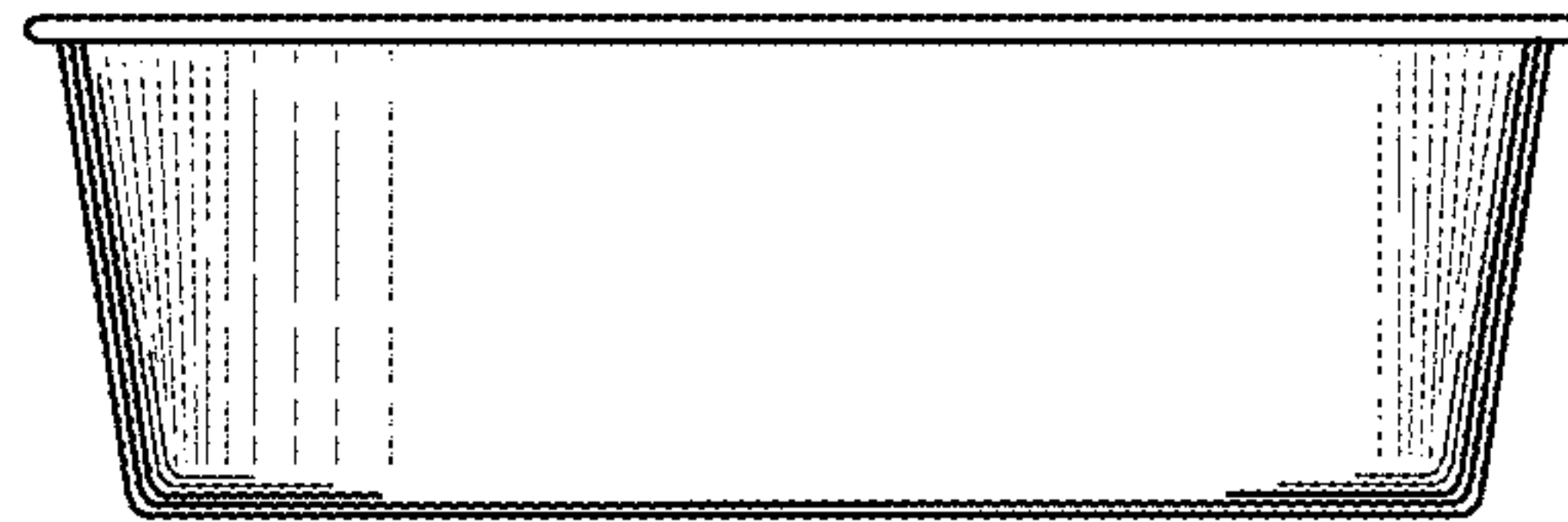

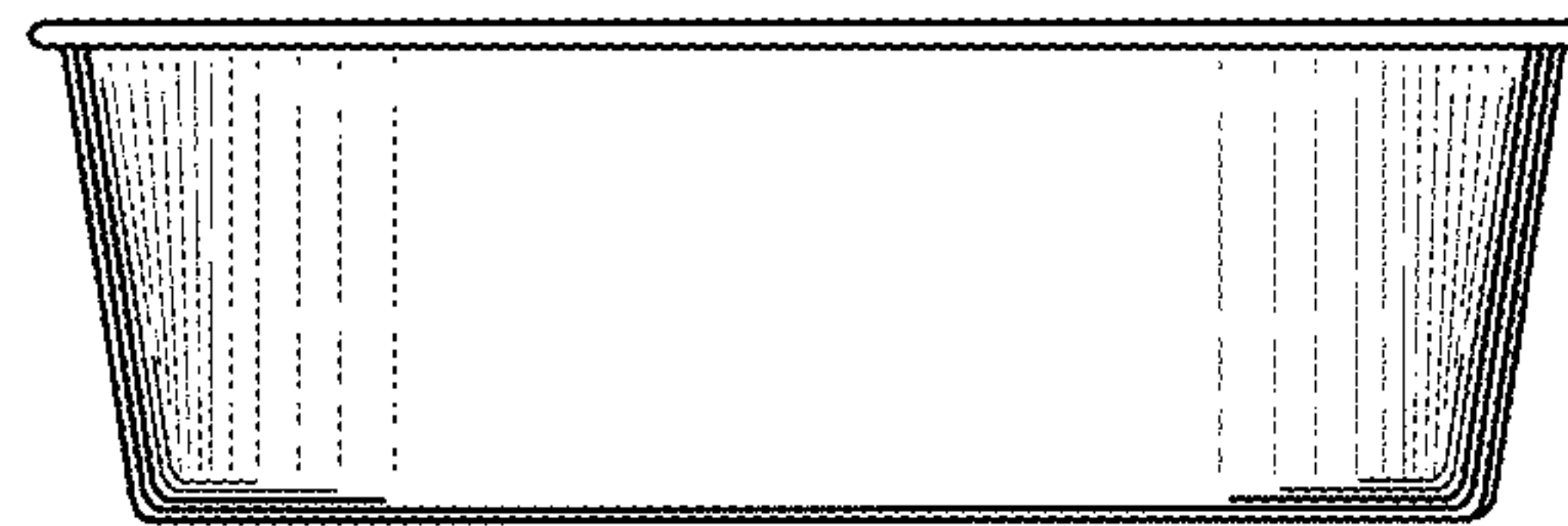
