CLAIM

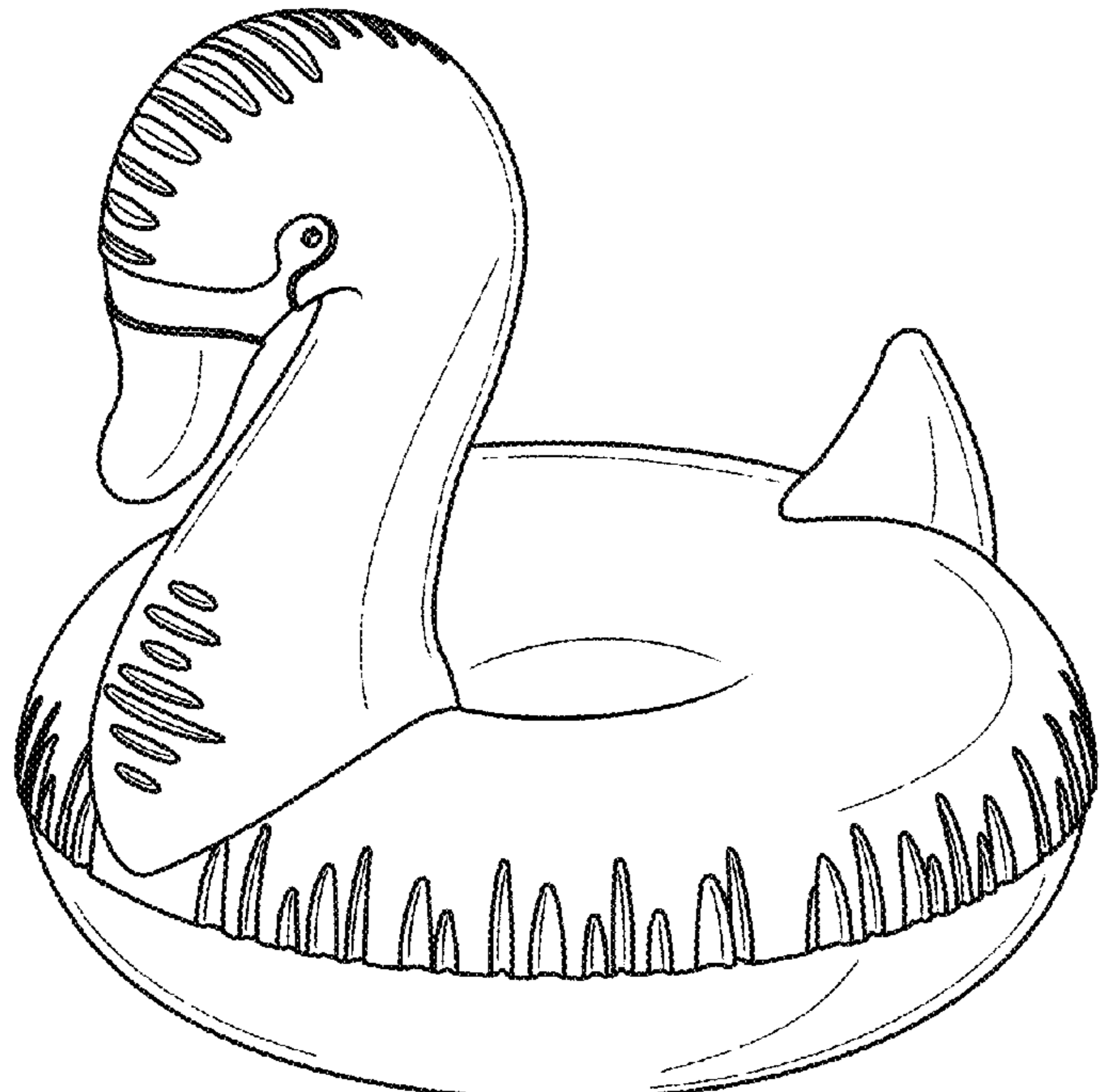
The ornamental design for a tea infuser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tea infuser showing my new design;
FIG. 2 is a left side view thereof;

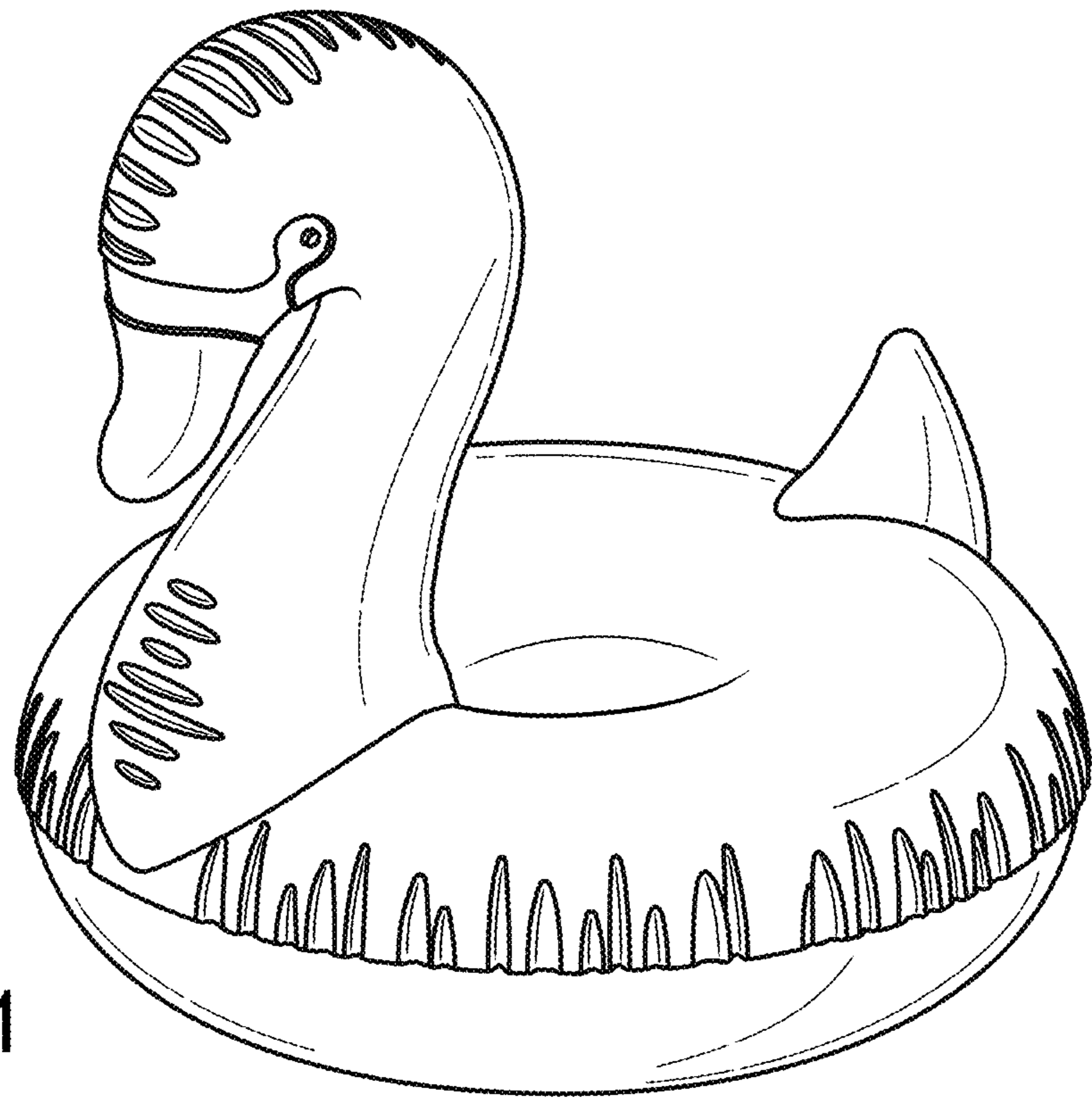

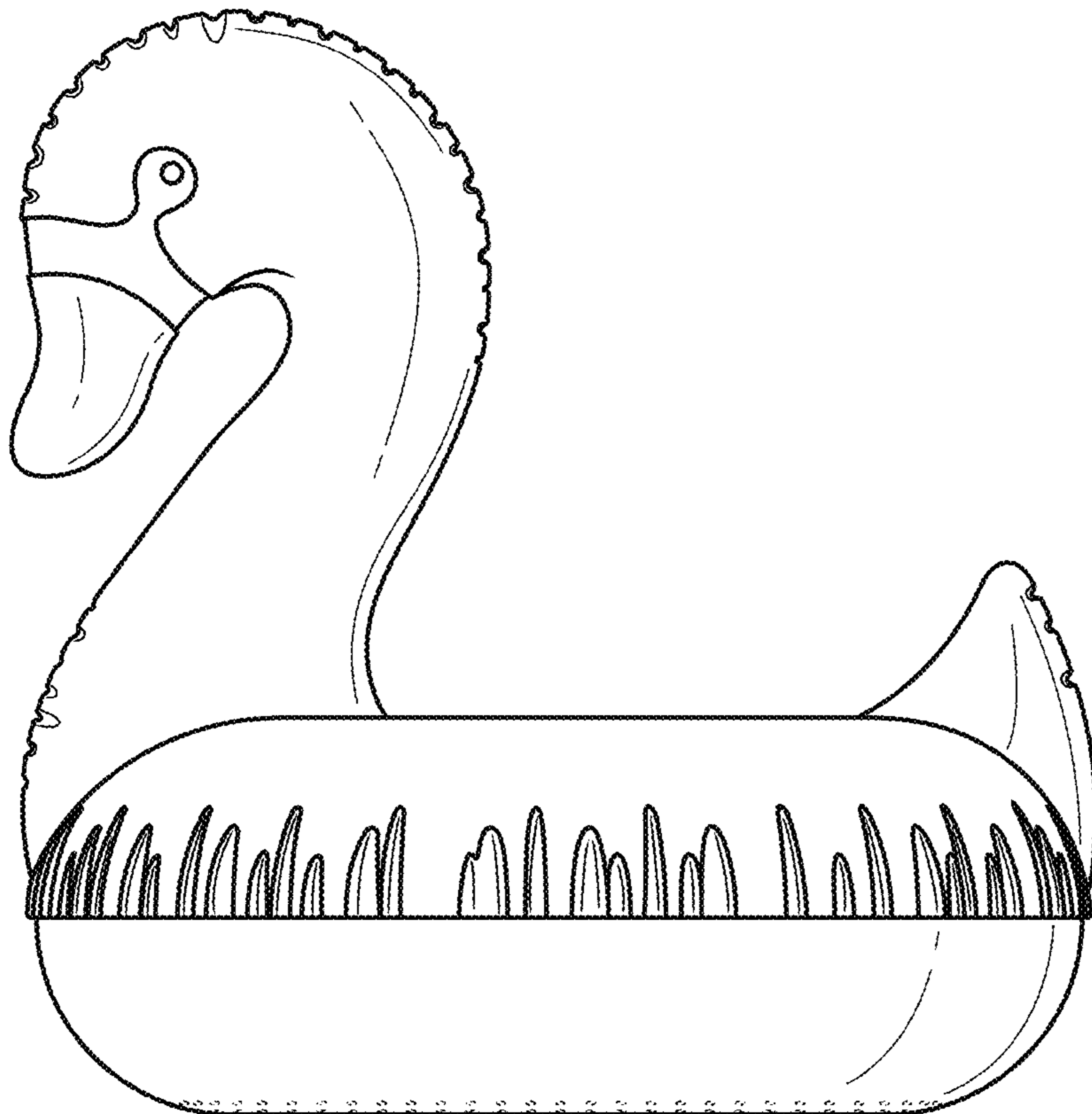

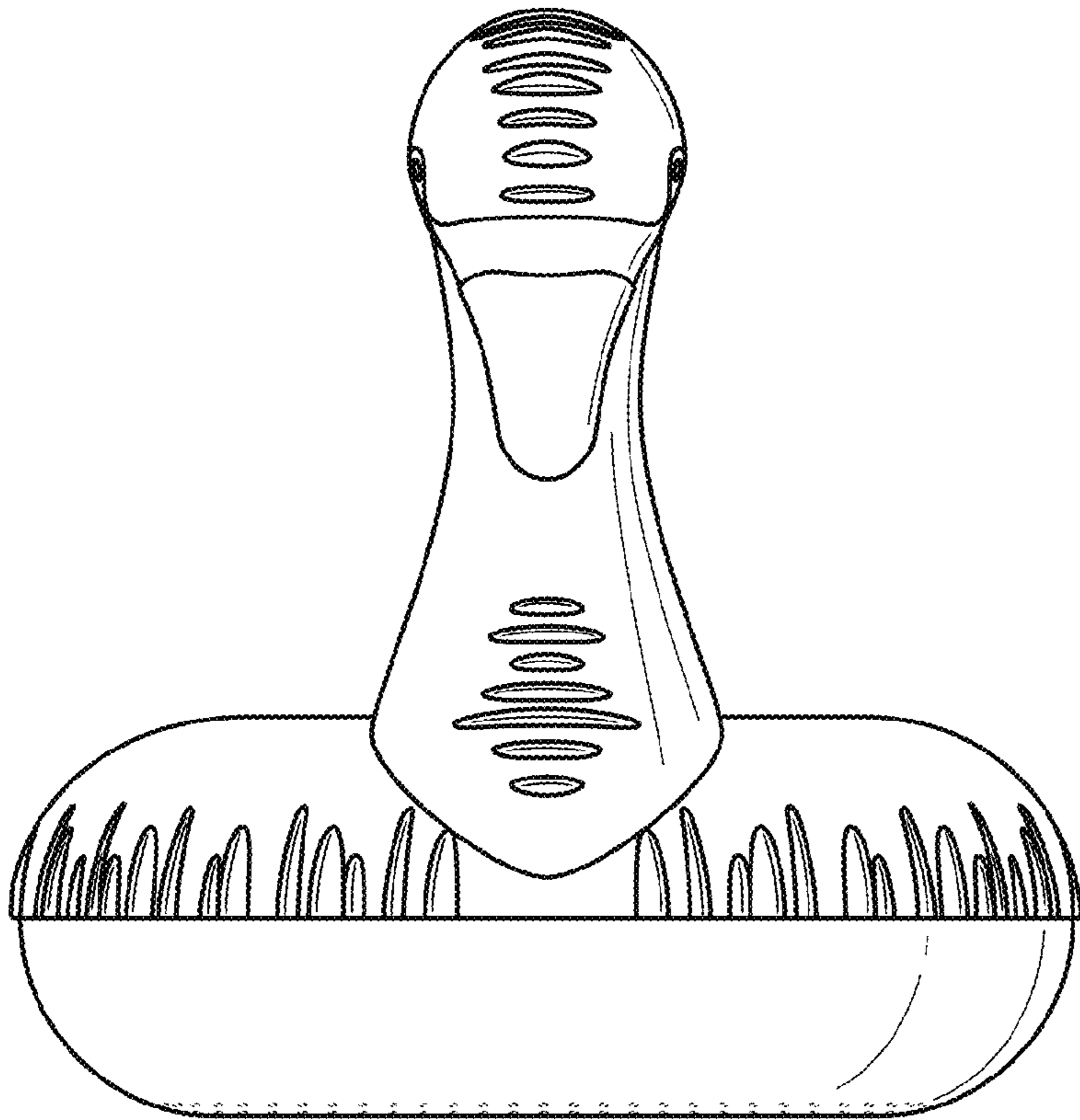

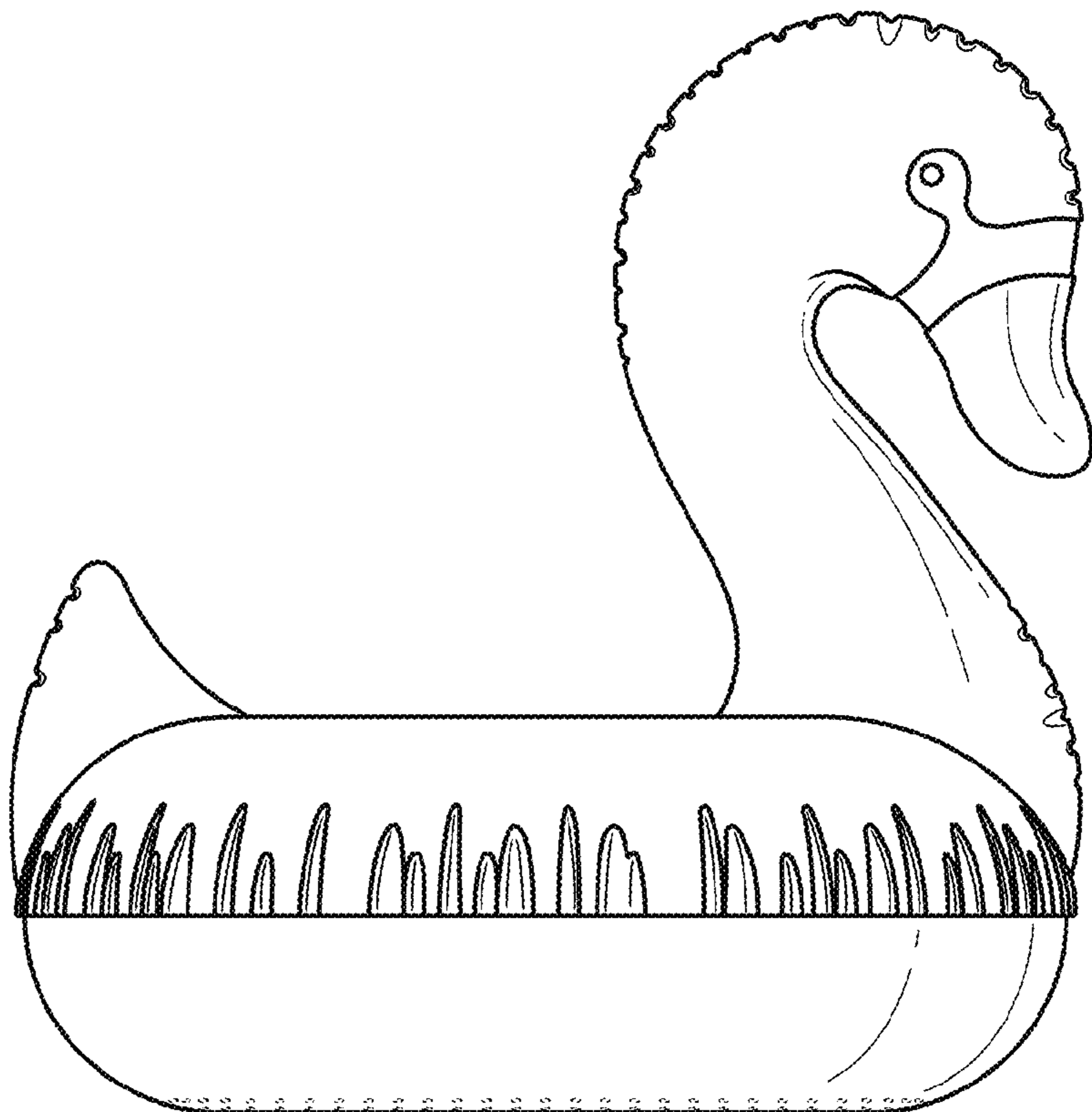

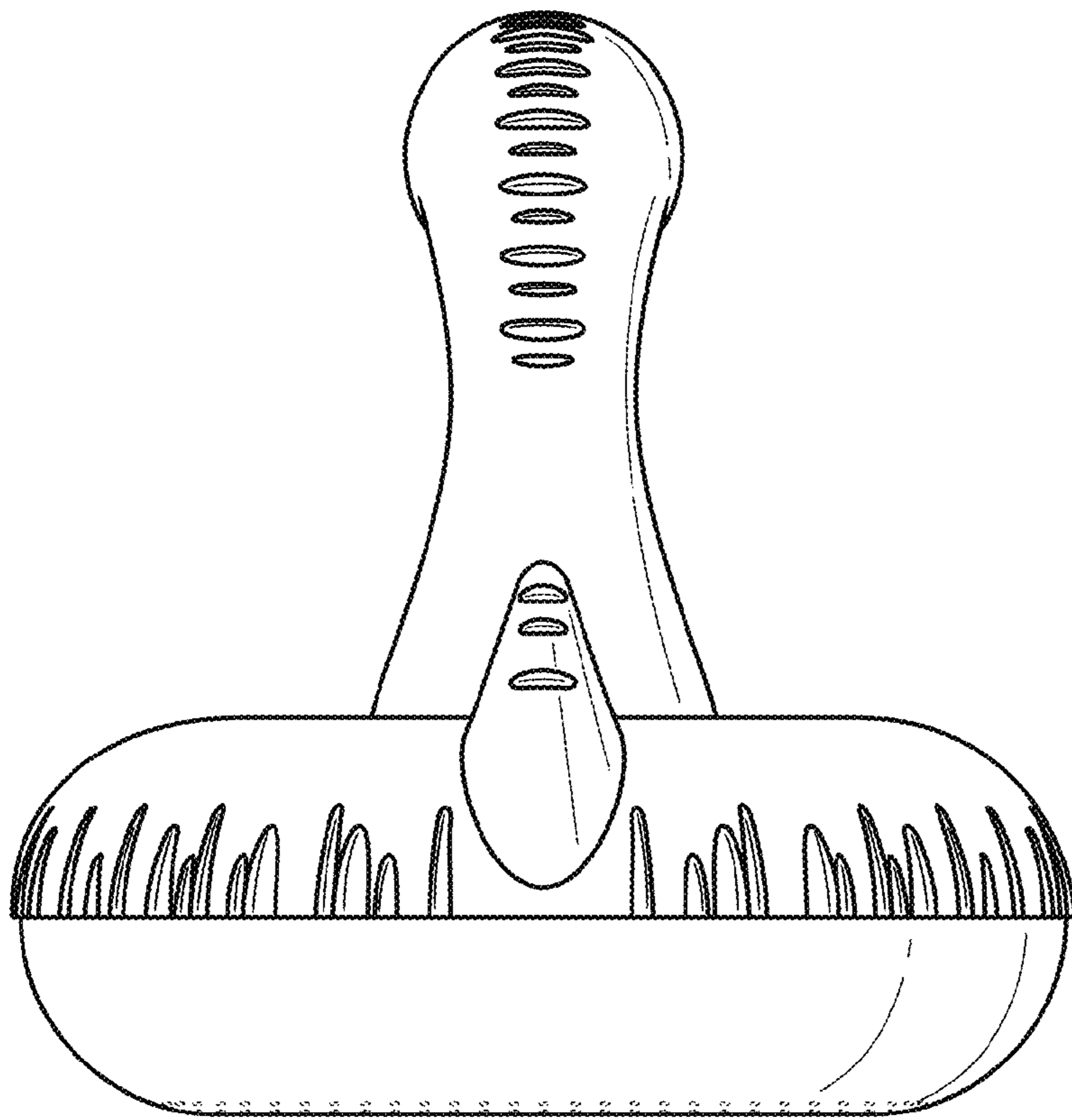

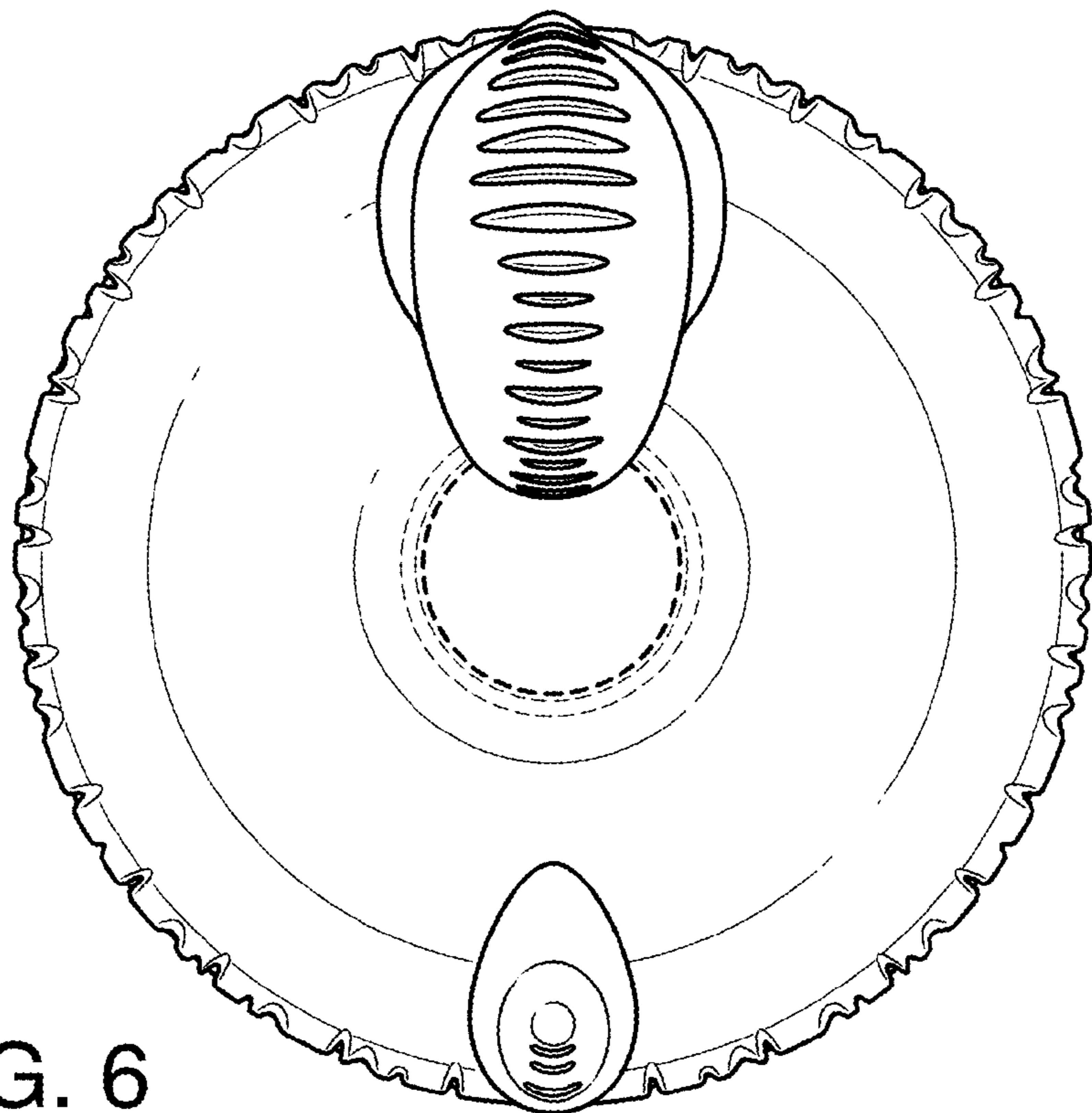

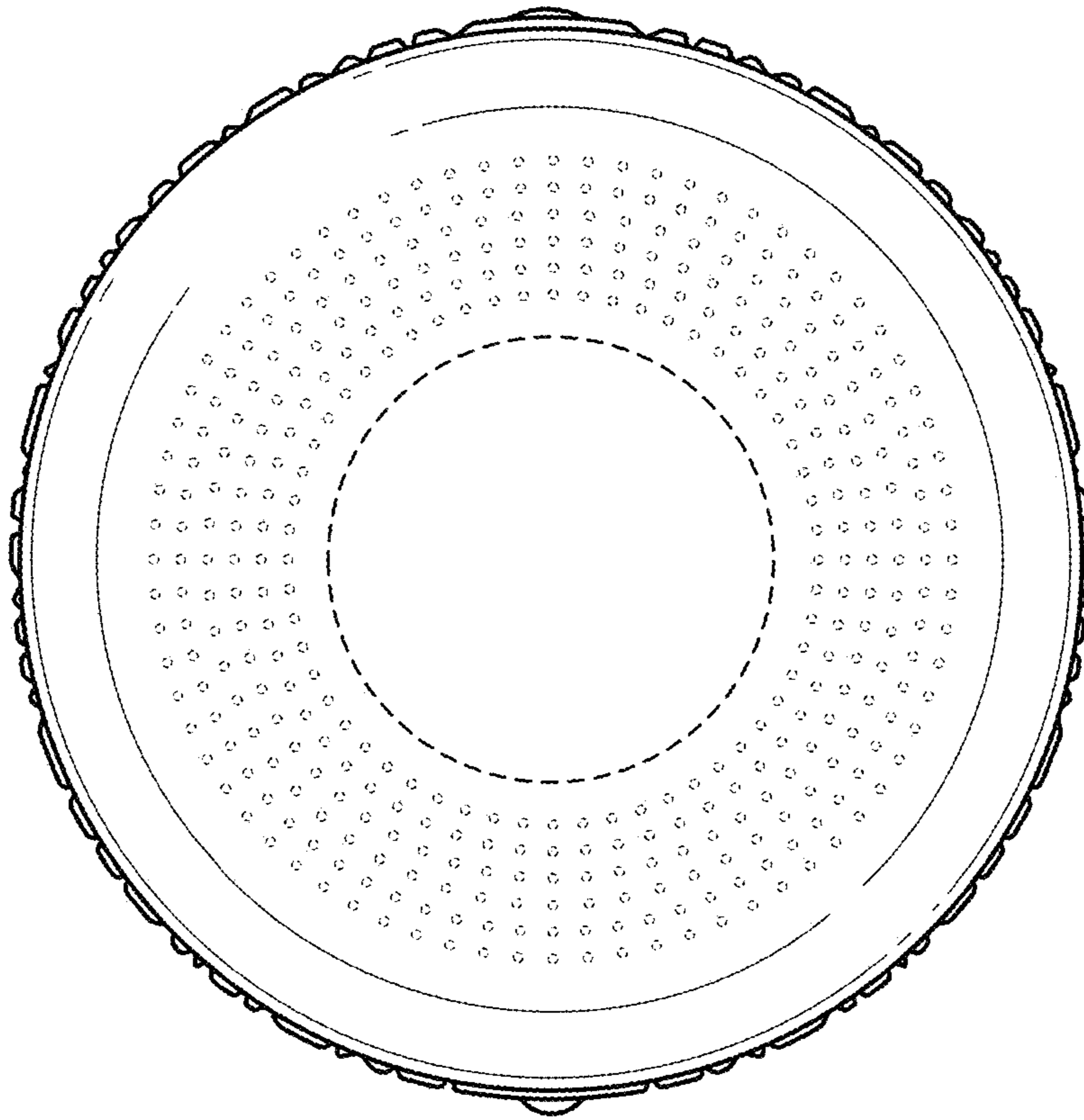
