DESCRIPTION

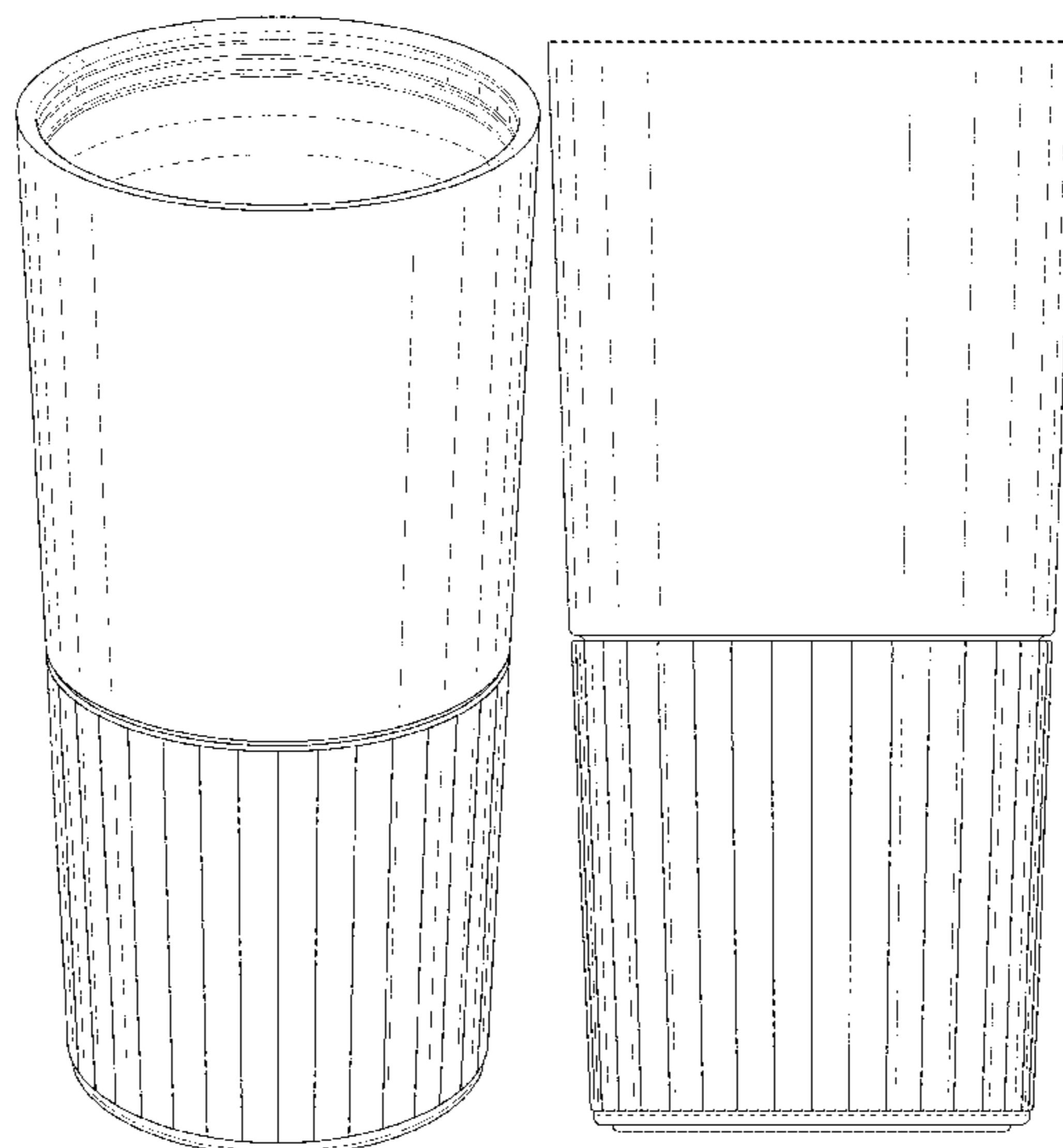
FIG. 1 is a top perspective view of an tumbler beverage container showing my new design.

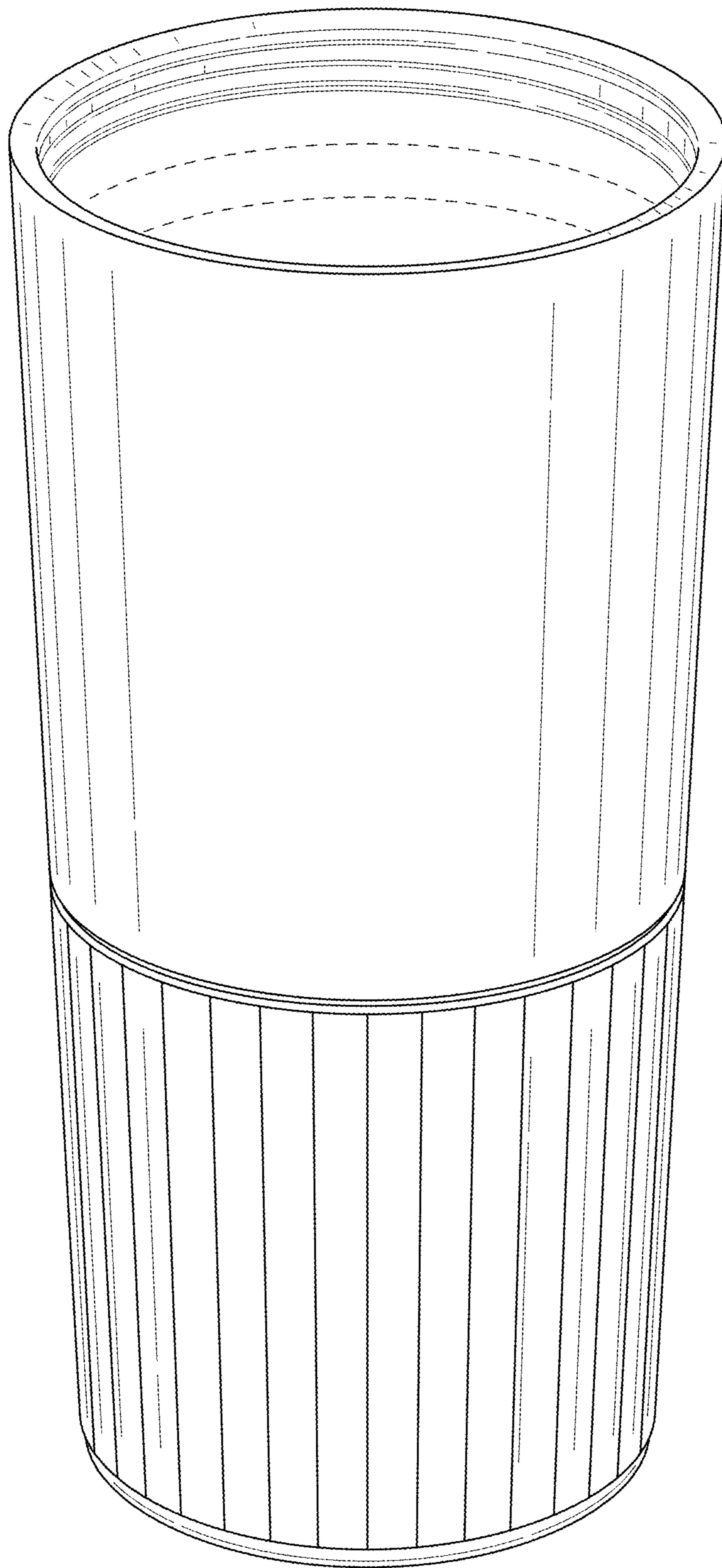

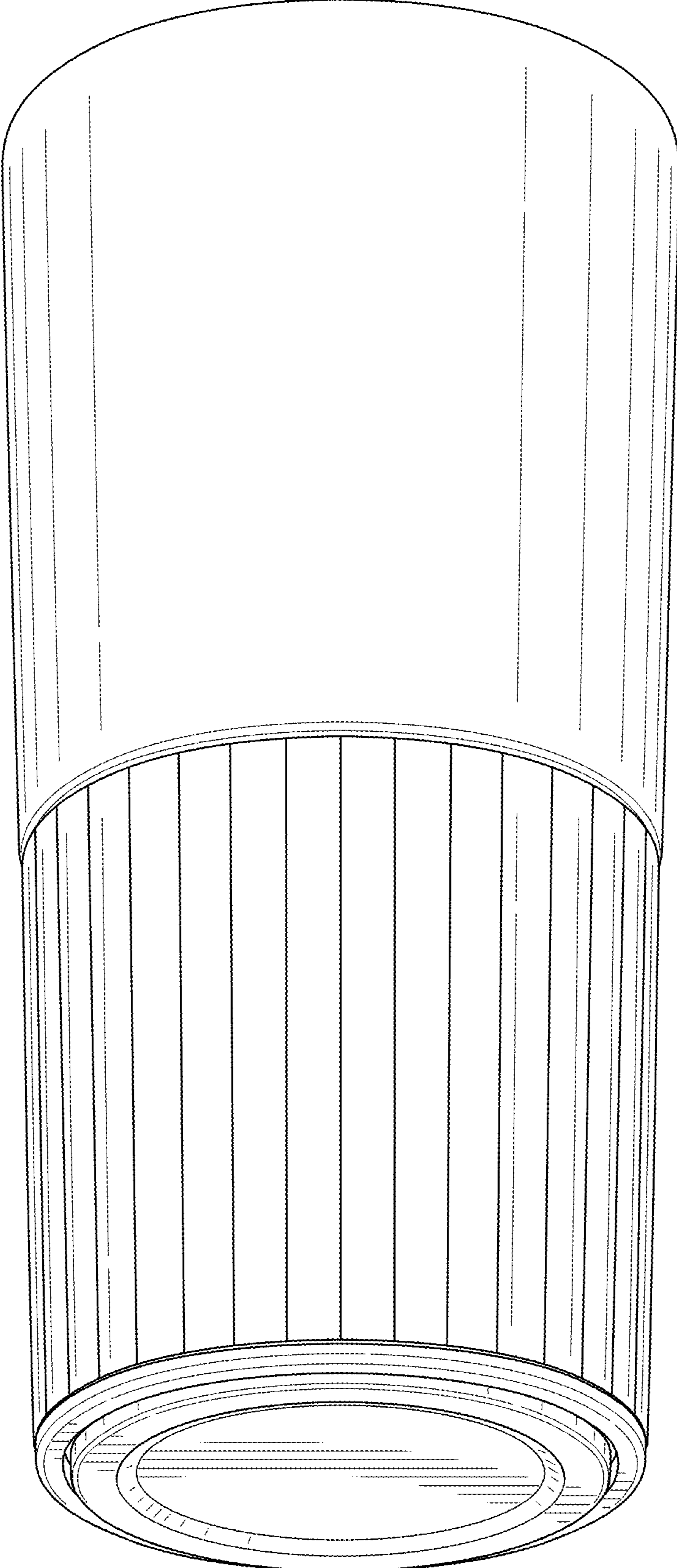

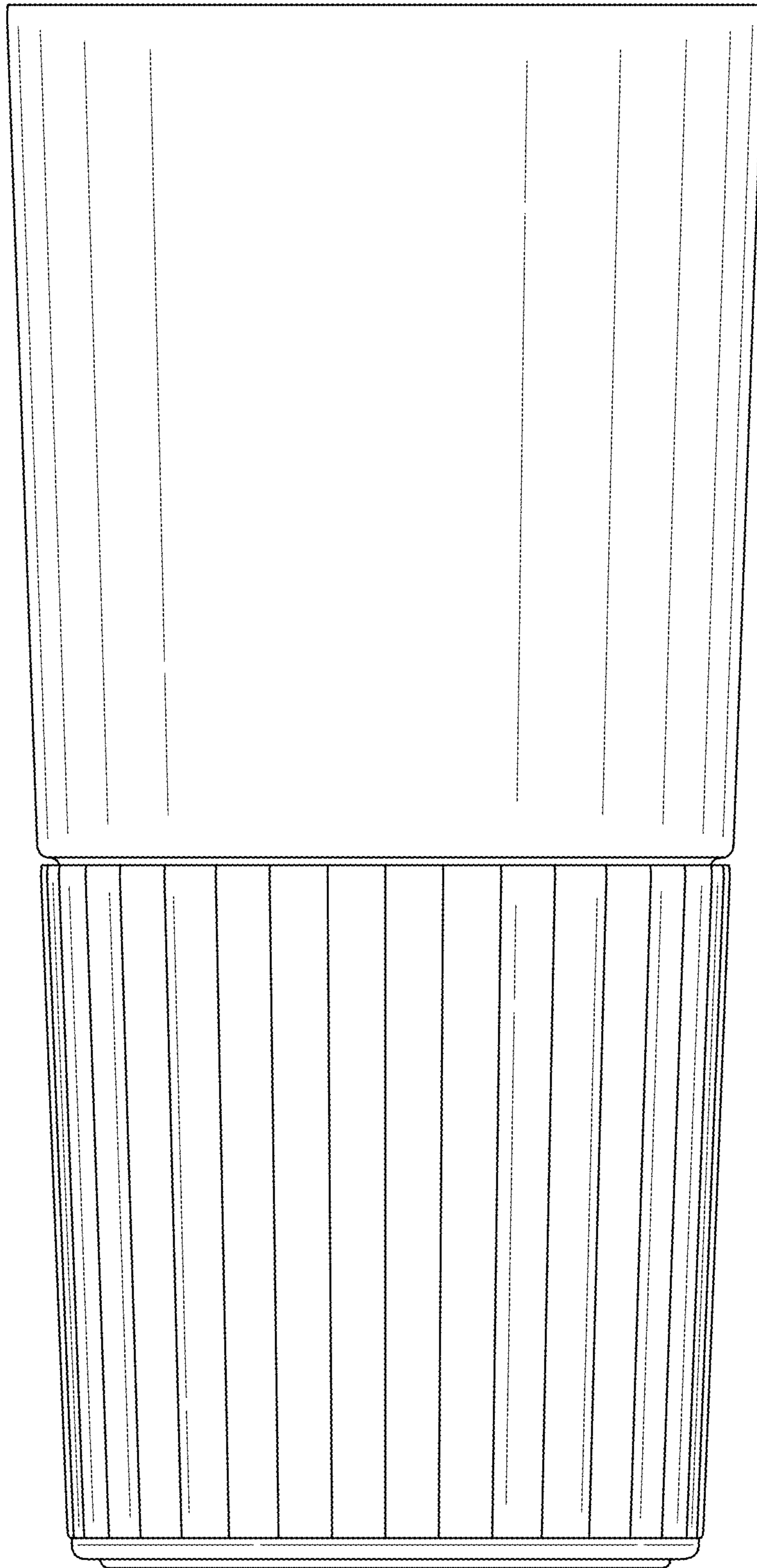

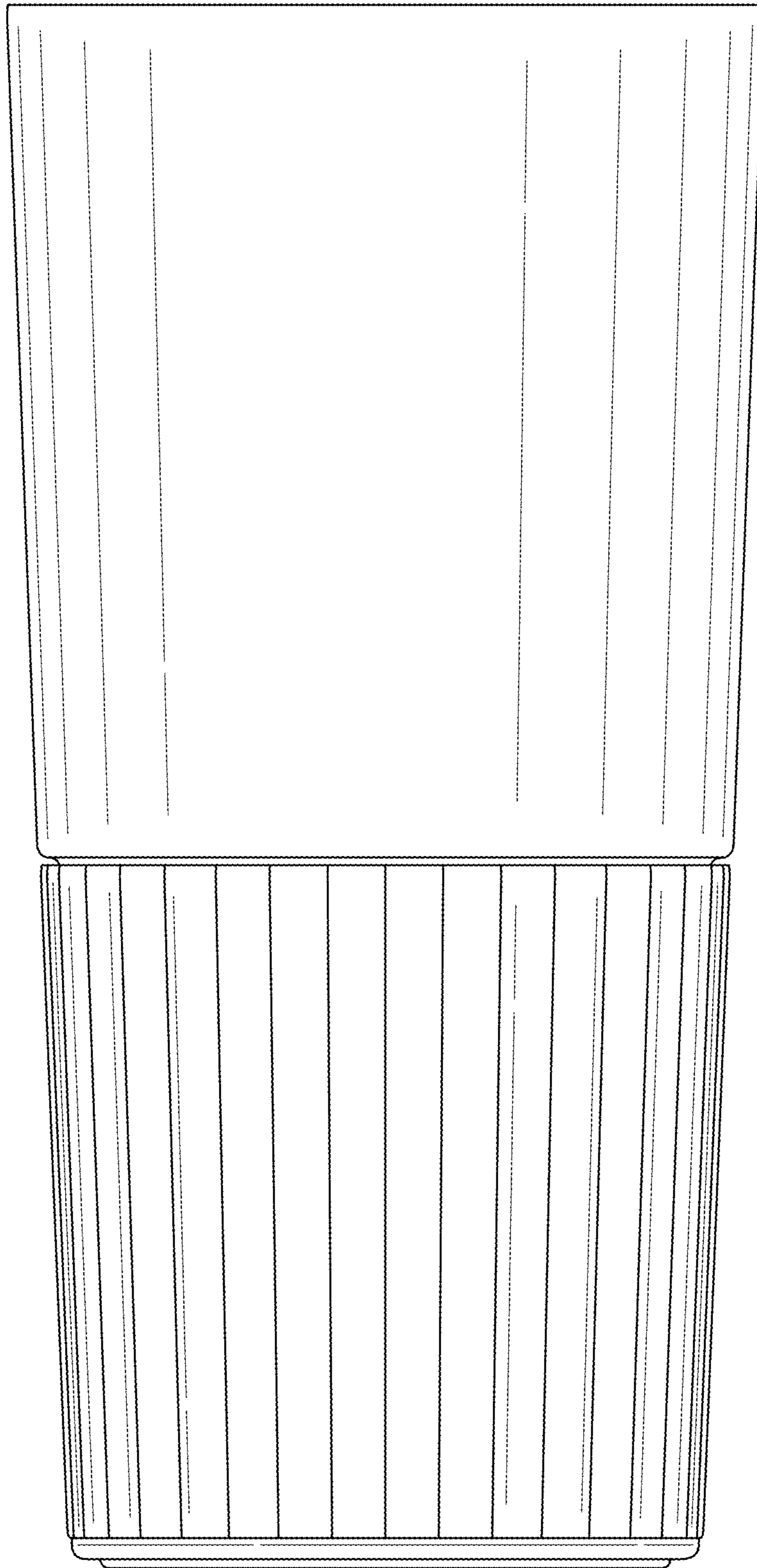

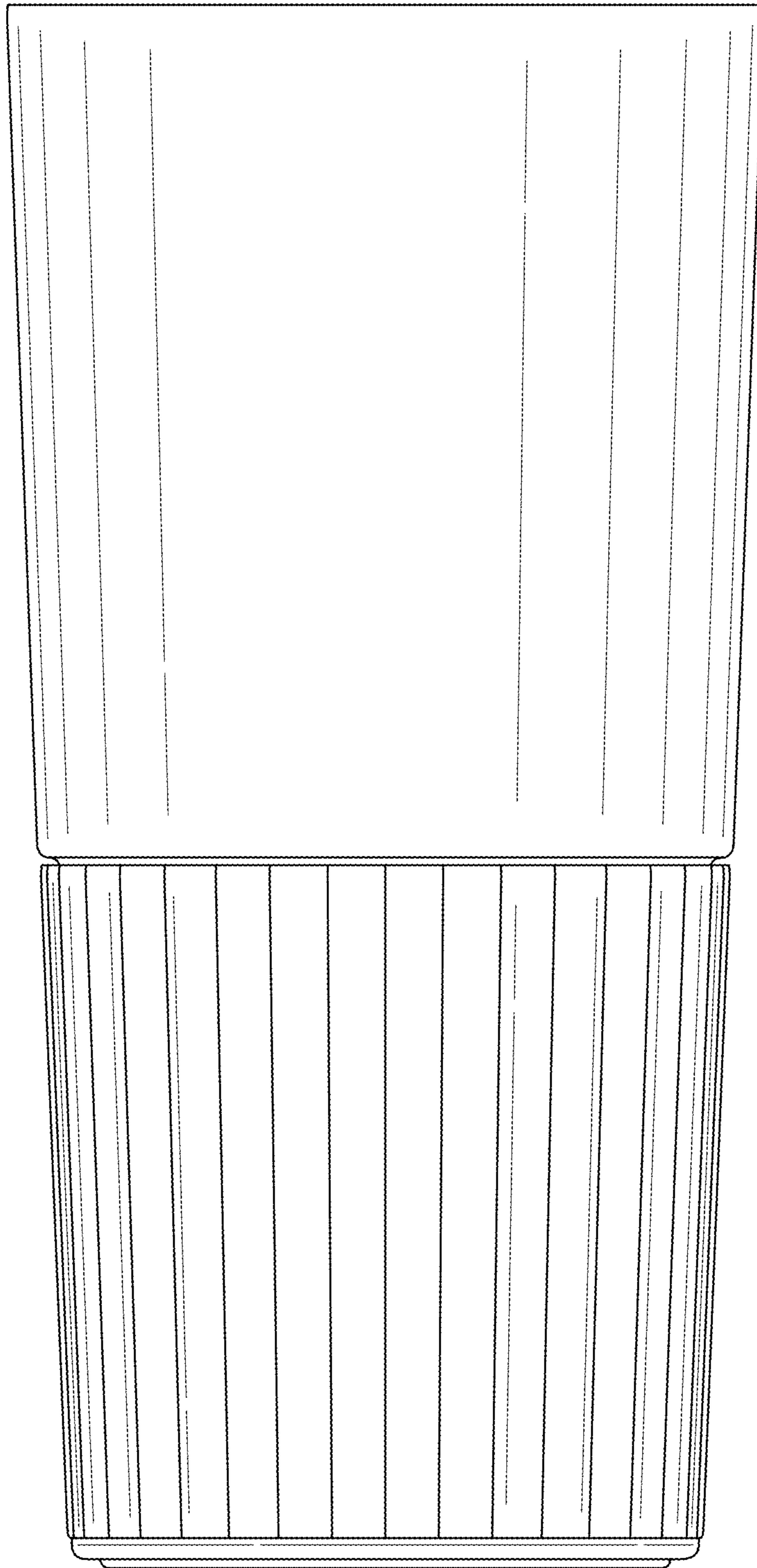

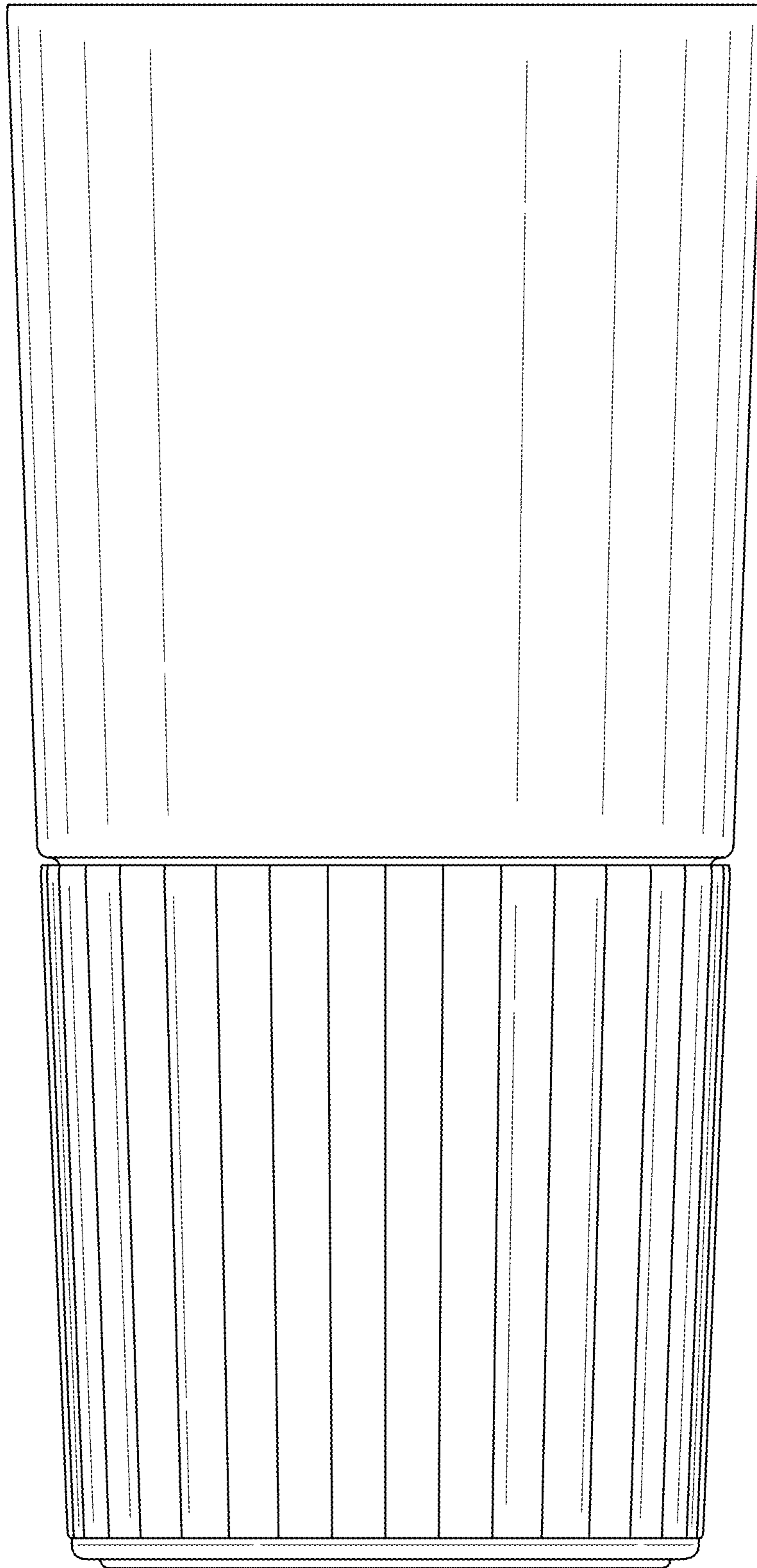

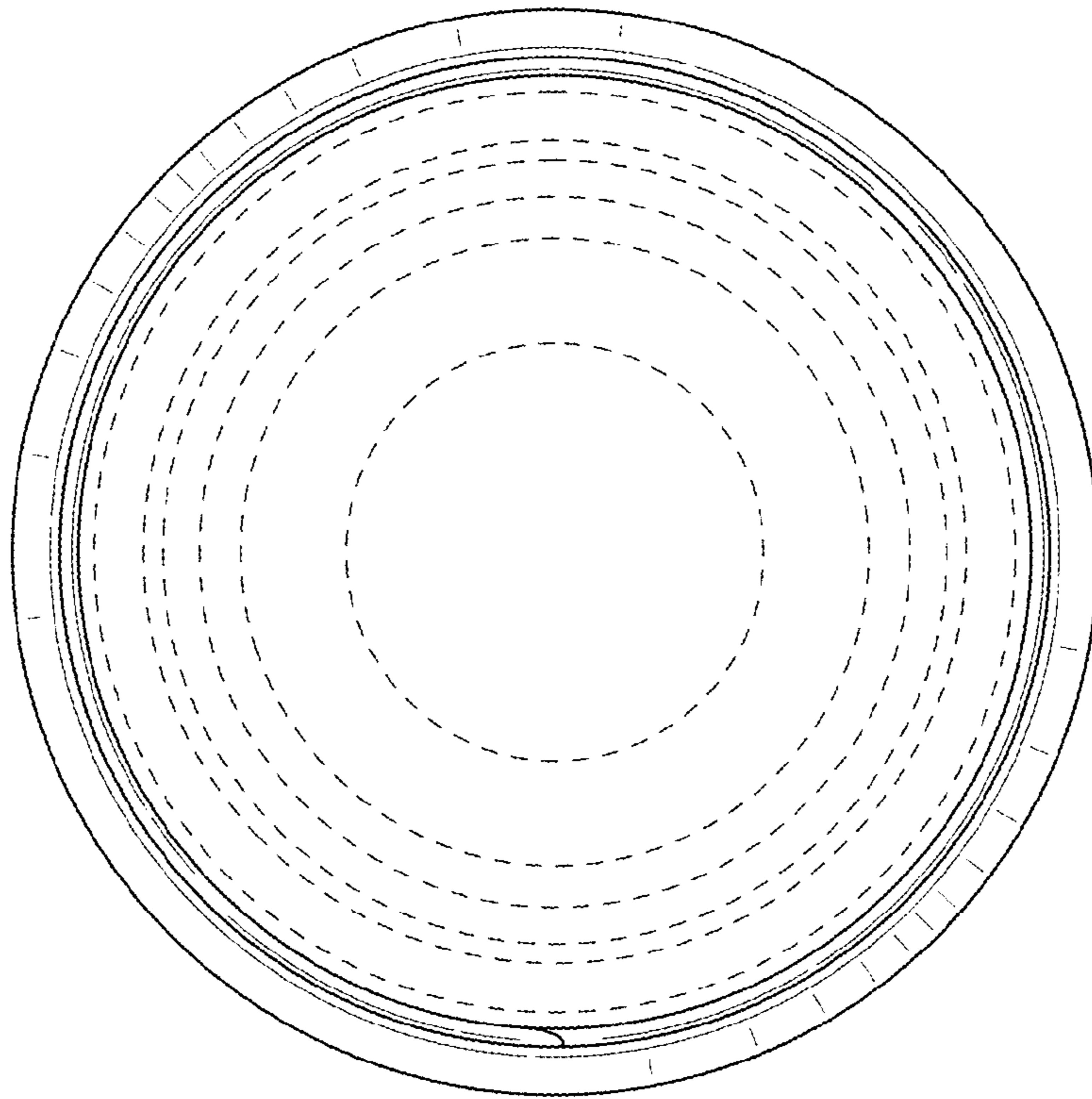

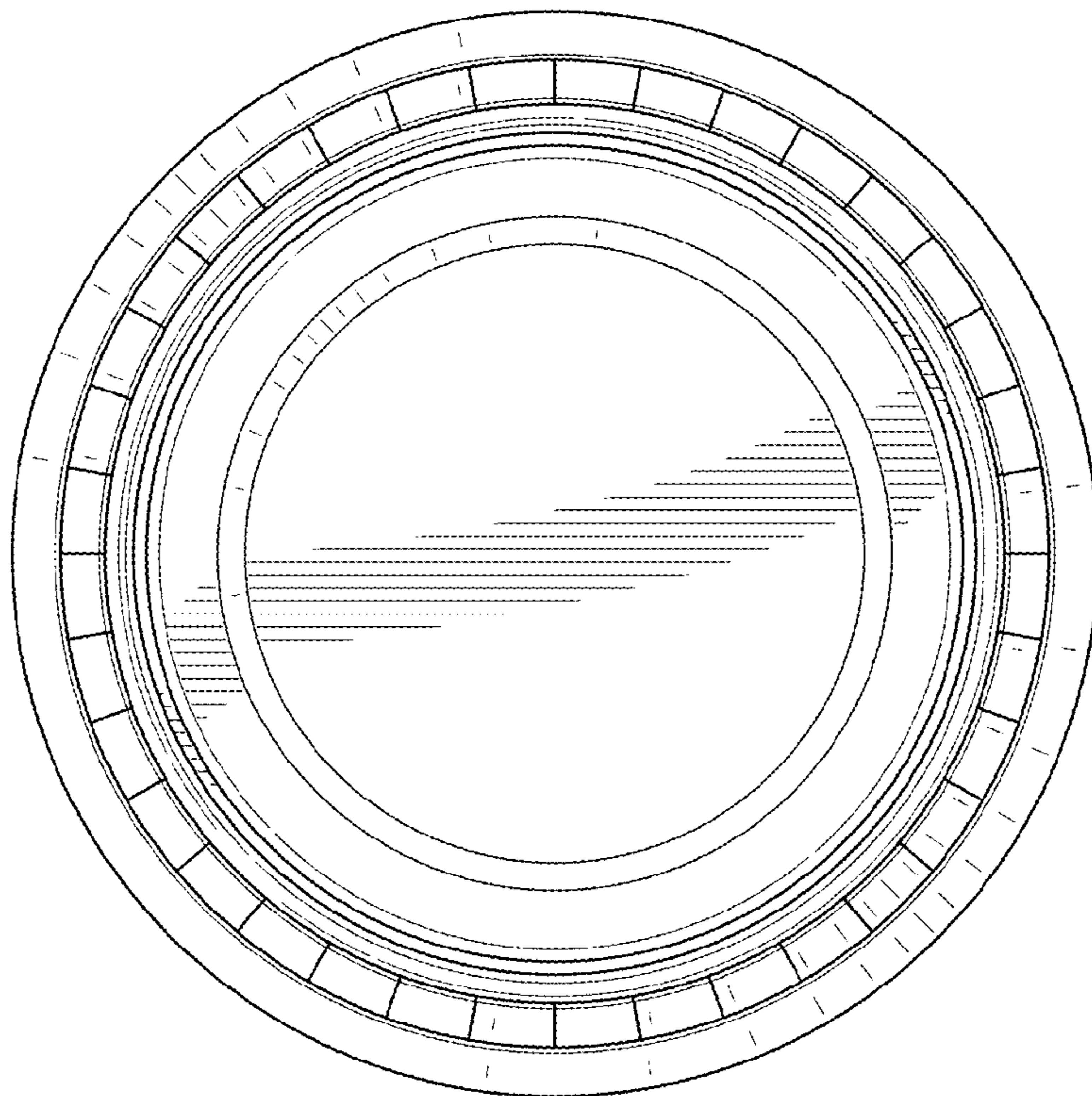
